[57] **CLAIM**

The ornamental design for a router bit case, as shown and described.

**DESCRIPTION**

The broken lines in FIGS. 1–21 are for illustrative purposes only and form no part of the claimed design.

FIG. 1 is a top view of the router bit case showing our new design;

FIG. 2 is a bottom view of the router bit case of FIG. 1;

FIG. 3 is a front view of the router bit case of FIG. 1;

FIG. 4 is a rear view of the router bit case of FIG. 1;

FIG. 5 is a side elevational view of the router bit case of FIG. 1, wherein the opposite side elevational view is a mirror image thereof;

FIG. 6 is a top view of the router bit case of FIG. 1, shown with the cover in an open position;

FIG. 7 is a fragmentary cross section view of the router bit case, taken along line 7—7 of FIG. 6;

FIG. 8 is a fragmentary cross section view of the router bit case, taken along line 8—8 of FIG. 6;

FIG. 9 is a top view of the insertable tray of the router bit case of FIG. 1 shown removed from the router bit case of FIG. 1 for clarity;

FIG. 10 is a top view of the insertable tray of the router bit case of FIG. 1 shown removed from the router bit case of FIG. 1 for clarity and also with mounted router bits shown in broken lines which form no part of the claimed design;

FIG. 11 is a bottom view of a modified embodiment of the upper shell of the router bit case;

FIG. 12 is a top view of the upper shell of the router bit case of FIG. 11;

FIG. 13 is a top view of the lower shell of the router bit case of either FIG. 1 or FIG. 11 showing the insertable tray shown removed from the router bit case of FIG. 1 for clarity;

FIG. 14 is a top view of the modified embodiment of the router bit case;

FIG. 15 is a bottom view of the router bit case of FIG. 14;

FIG. 16 is a front perspective view of the router bit case of FIG. 14;

FIG. 17 is a back perspective view of the router bit case of FIG. 14;

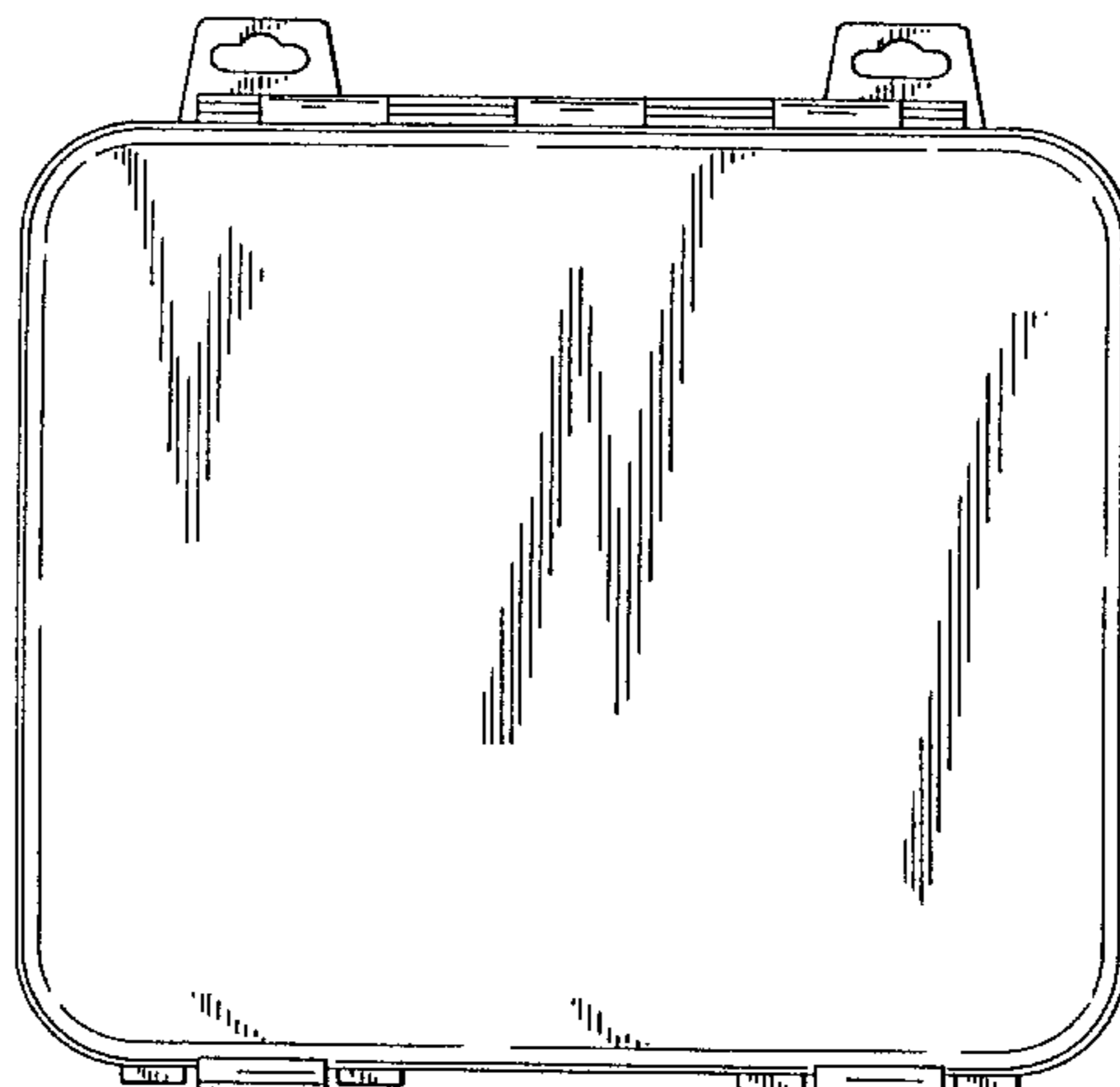
FIG. 18 is a bottom front perspective view of the router bit case of FIG. 14;

FIG. 19 is a top view of the insertable tray of the router bit case of FIG. 14 shown removed from the router bit case of FIG. 14 for clarity;

FIG. 20 is a bottom view of the insertable tray of FIG. 19 shown removed from the router bit case of FIG. 14 for clarity; and,

FIG. 21 is a front perspective view of the insertable tray of FIG. 19 shown removed from the router bit case of FIG. 14 for clarity.

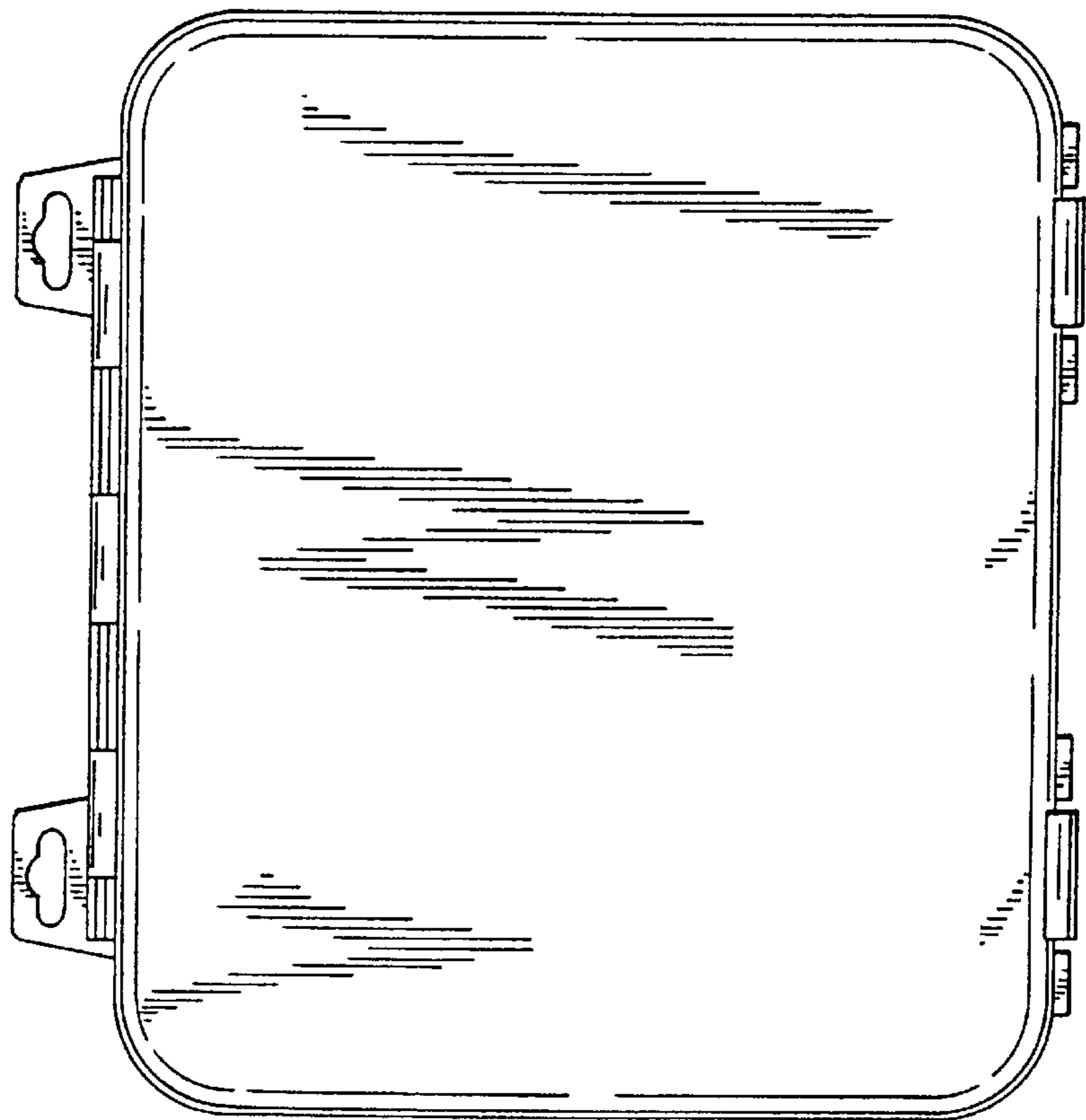

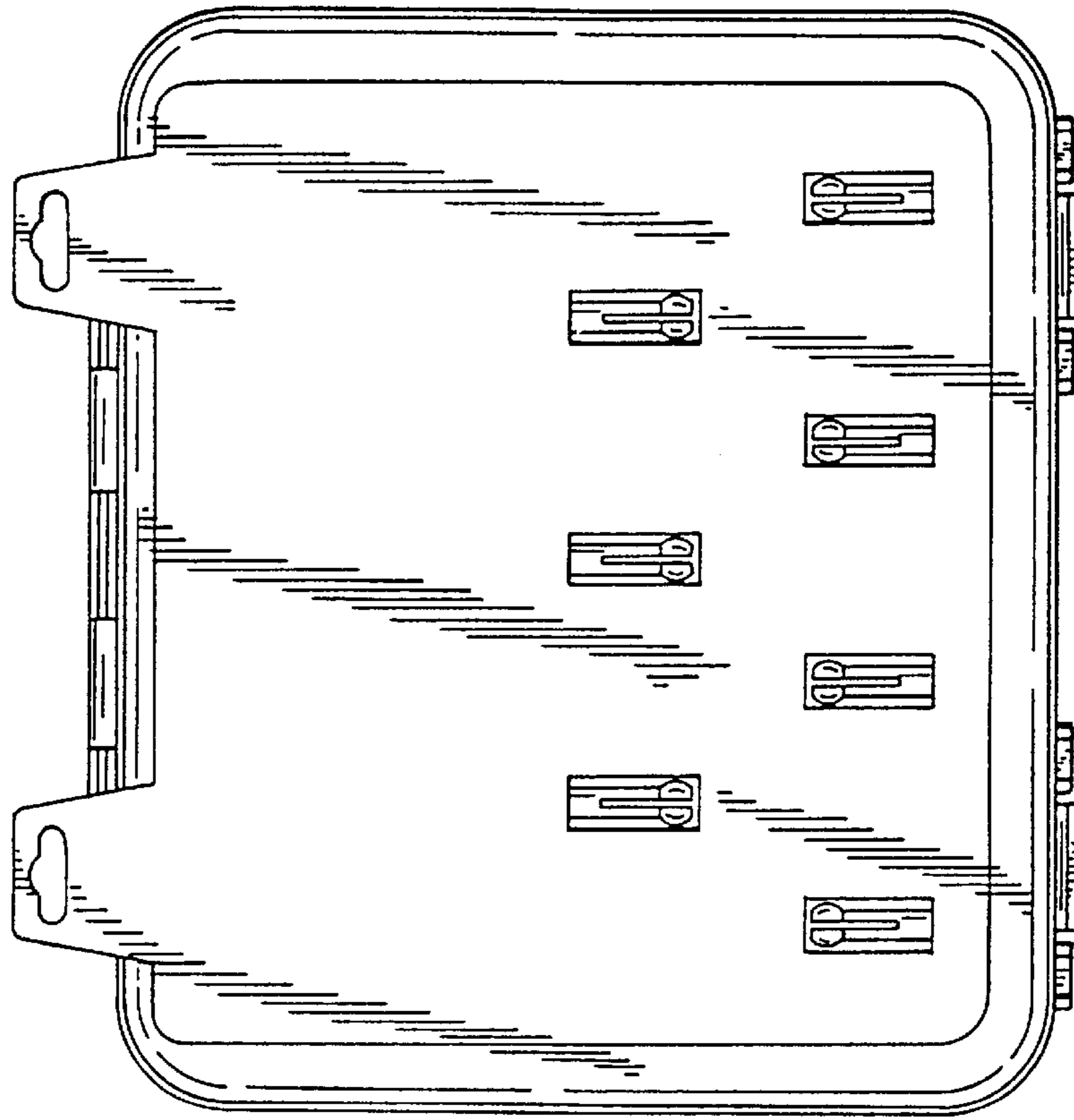

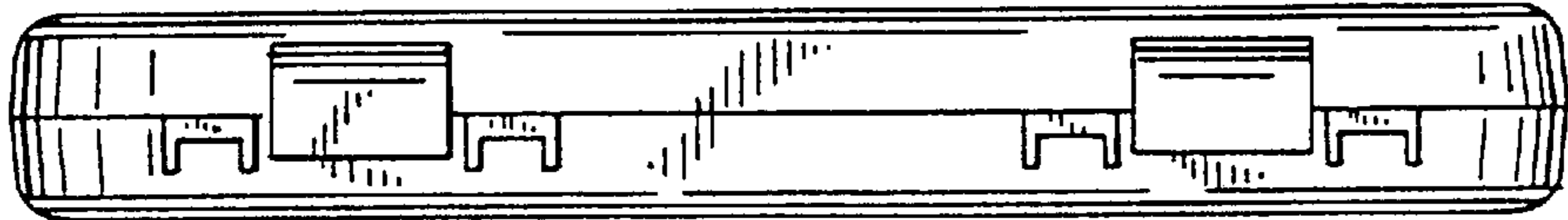

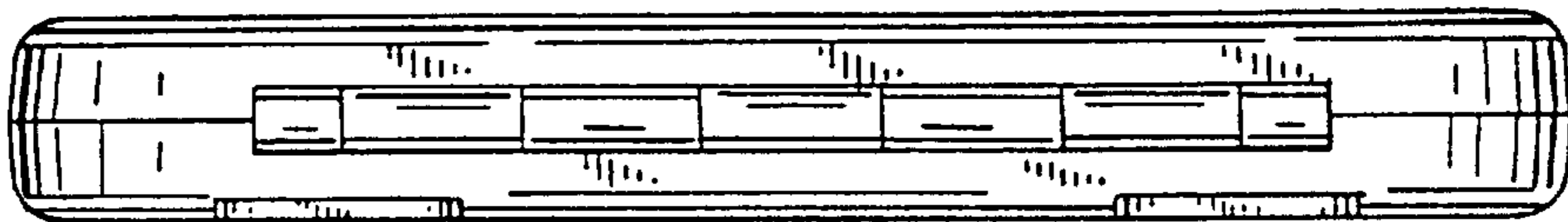

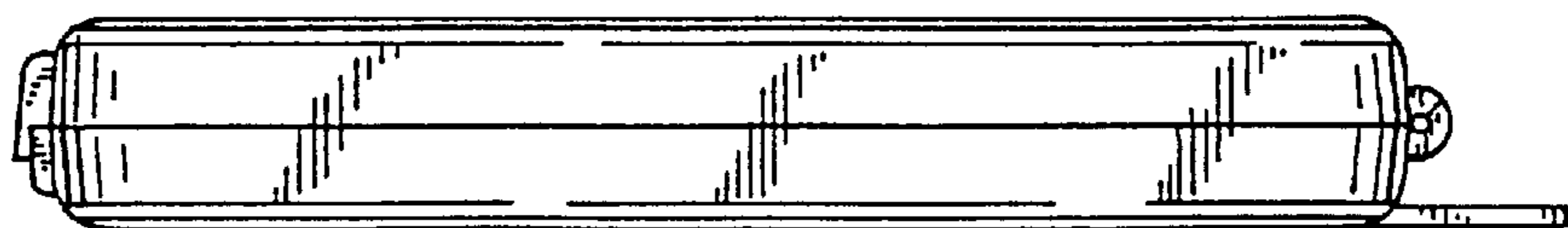

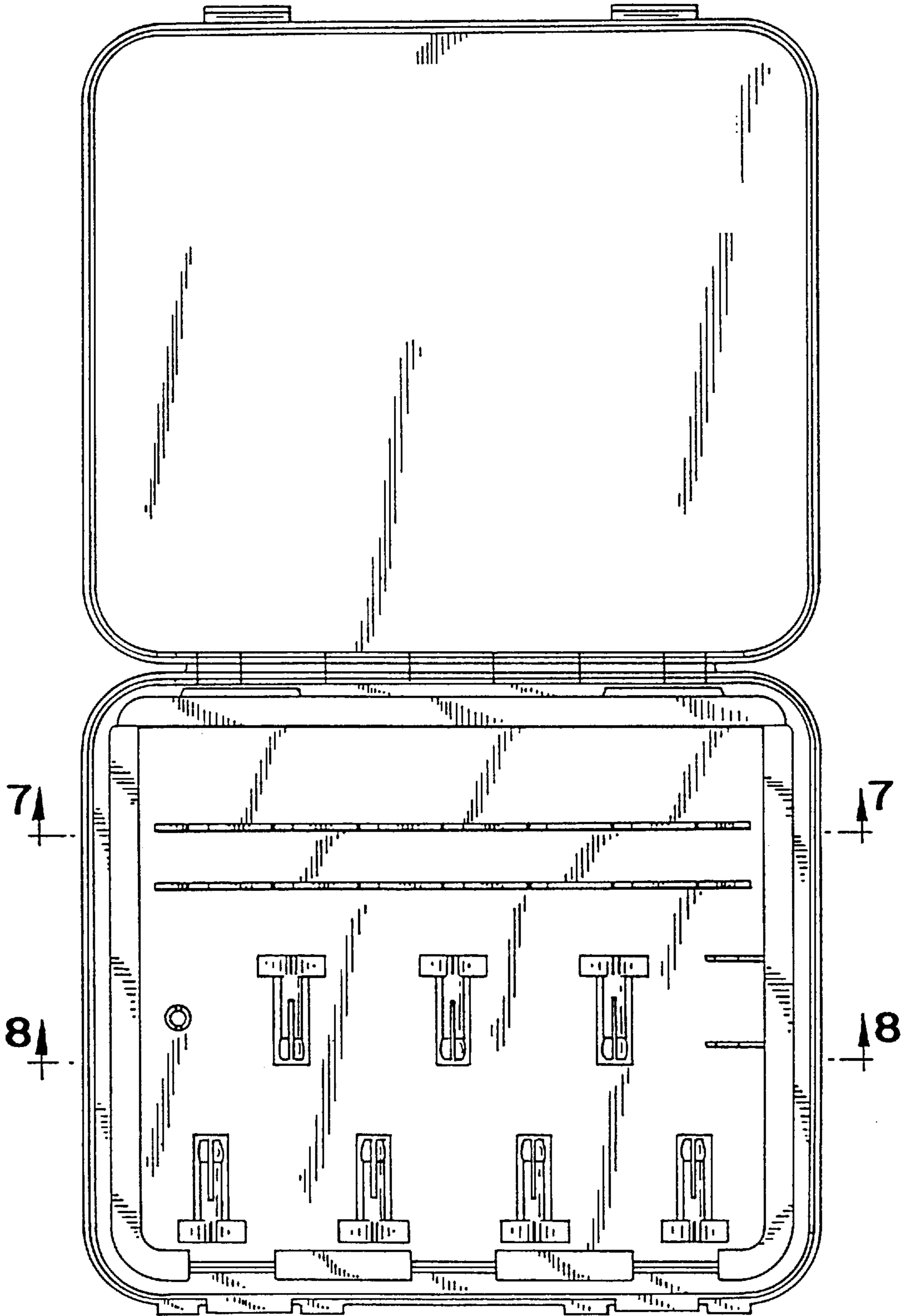

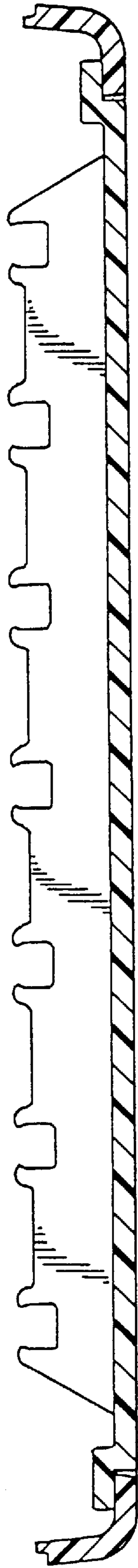

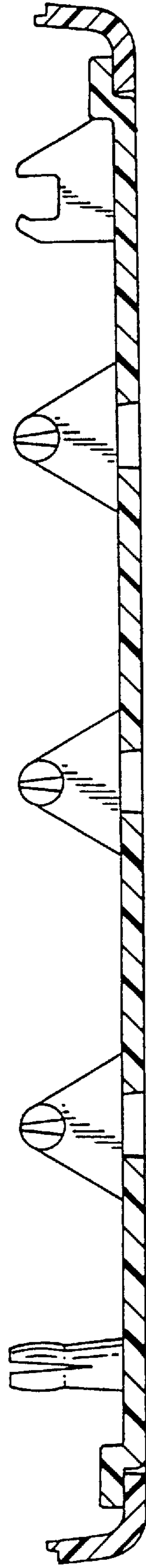

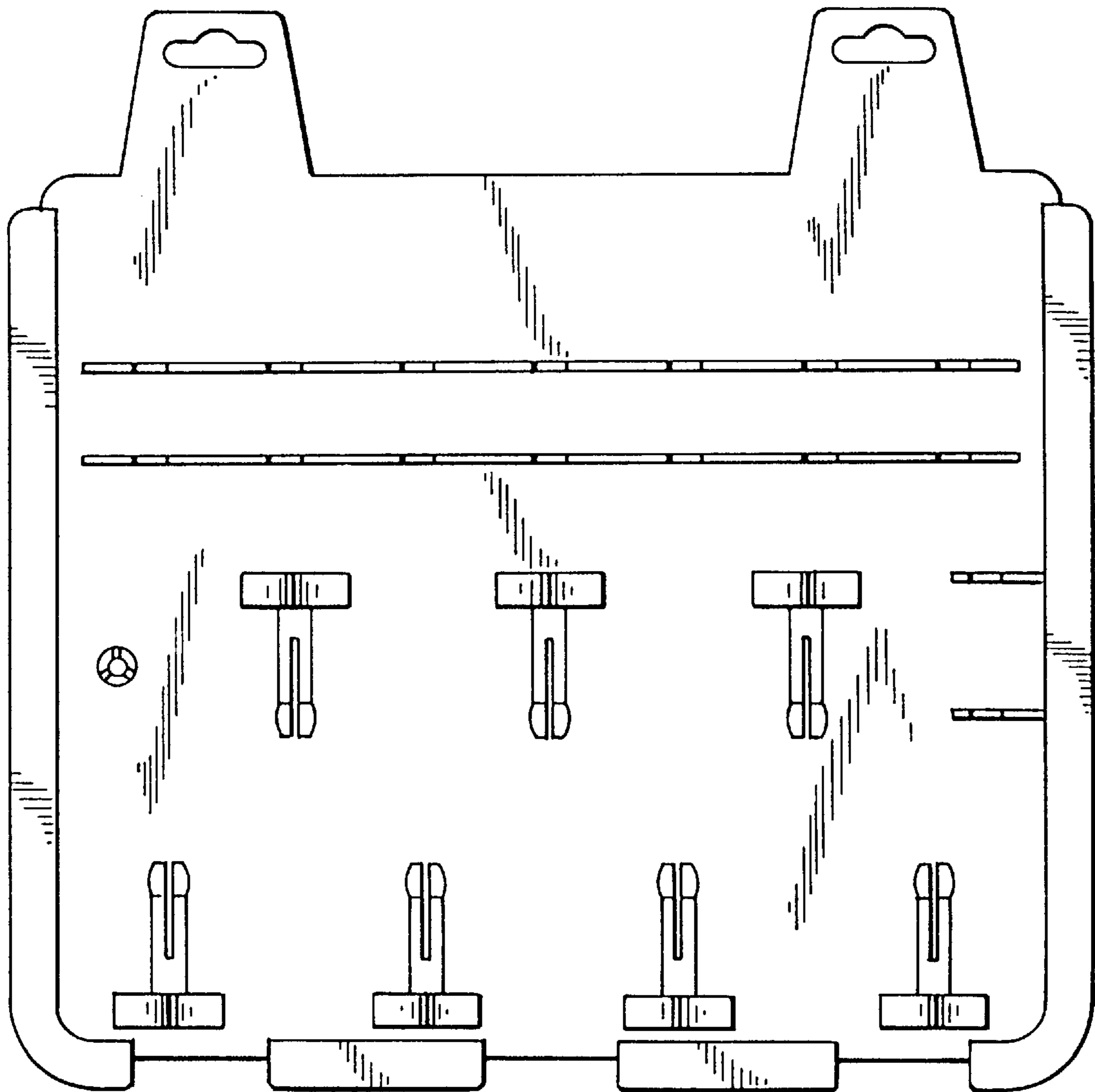

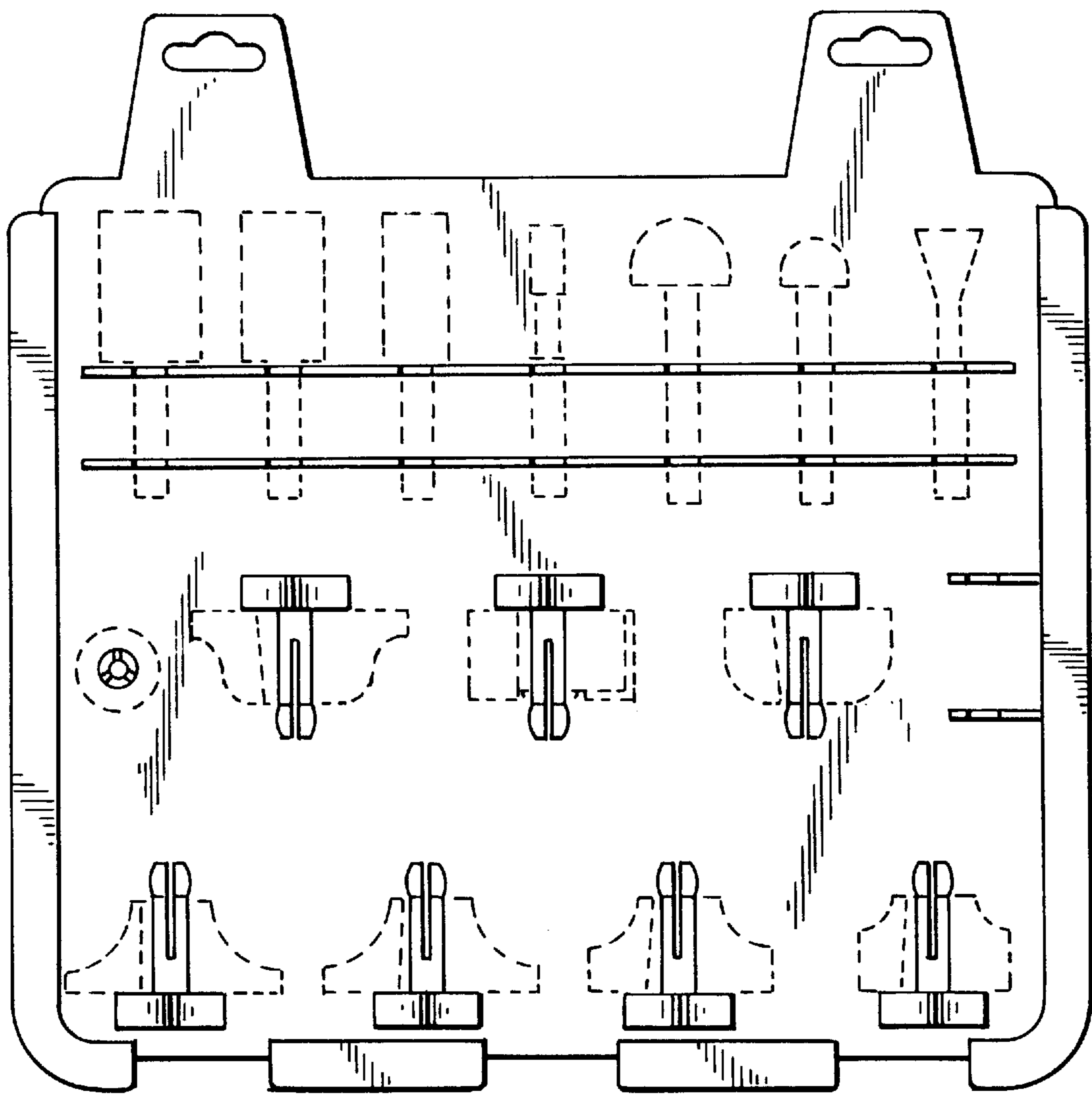

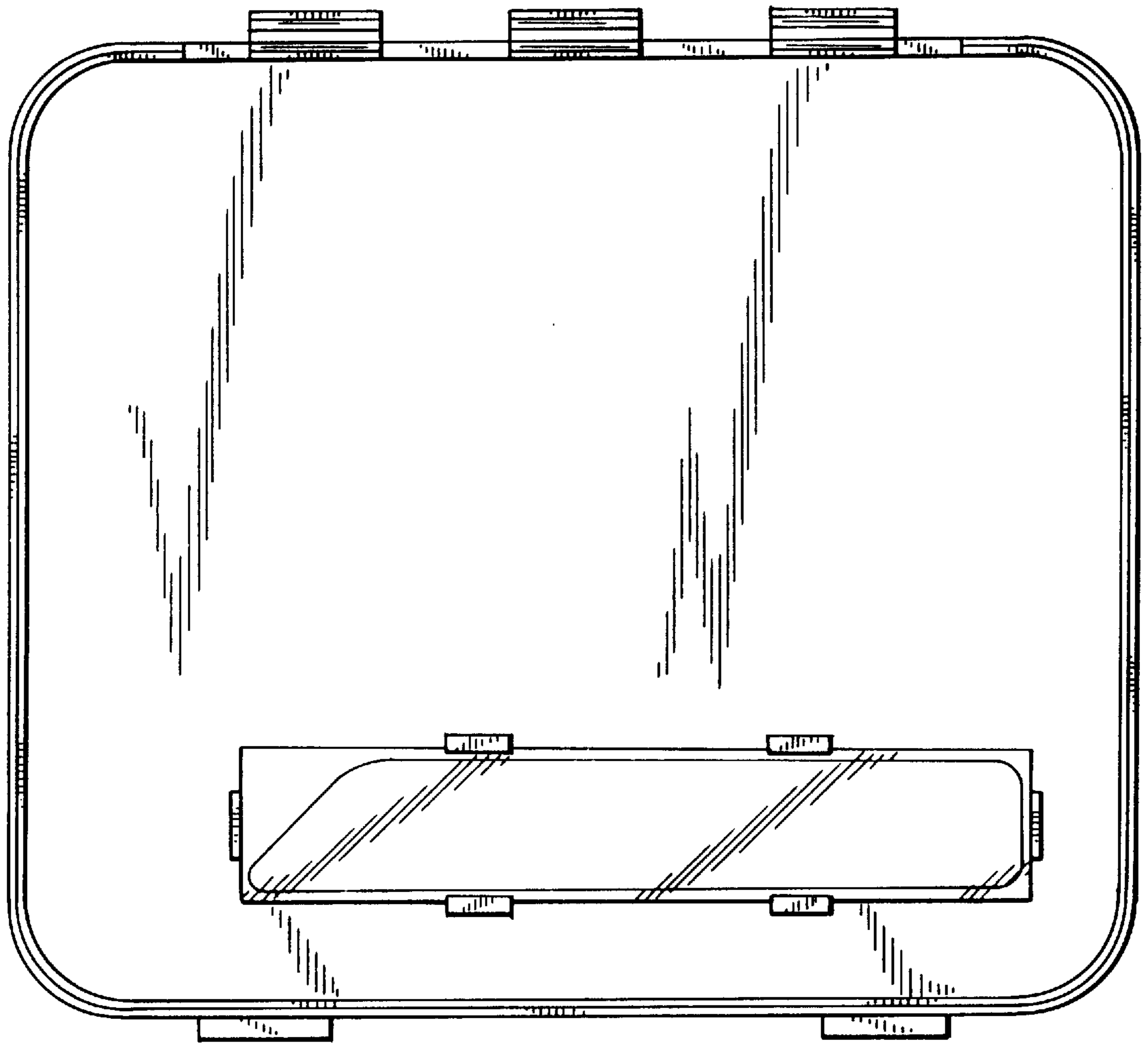

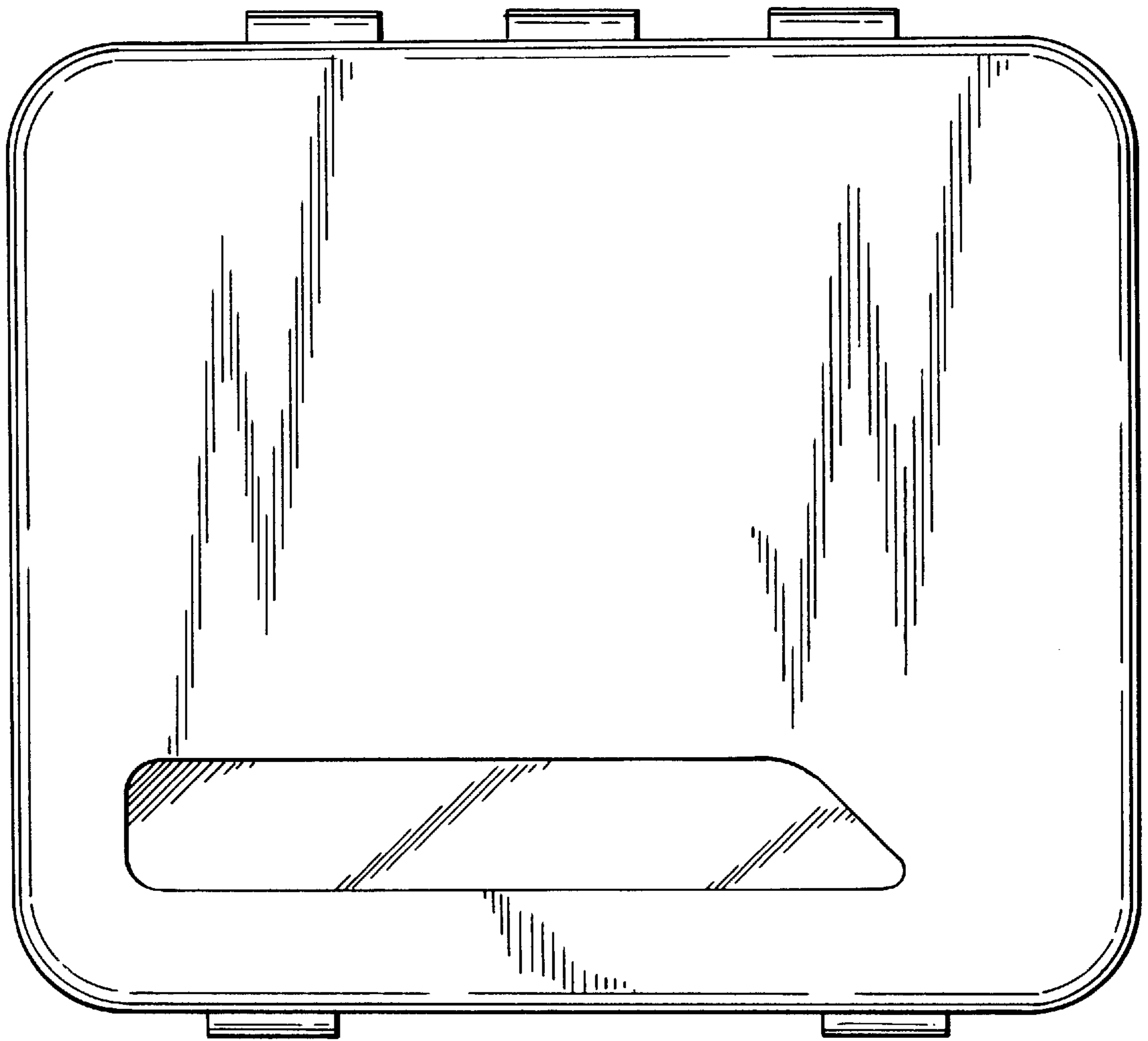

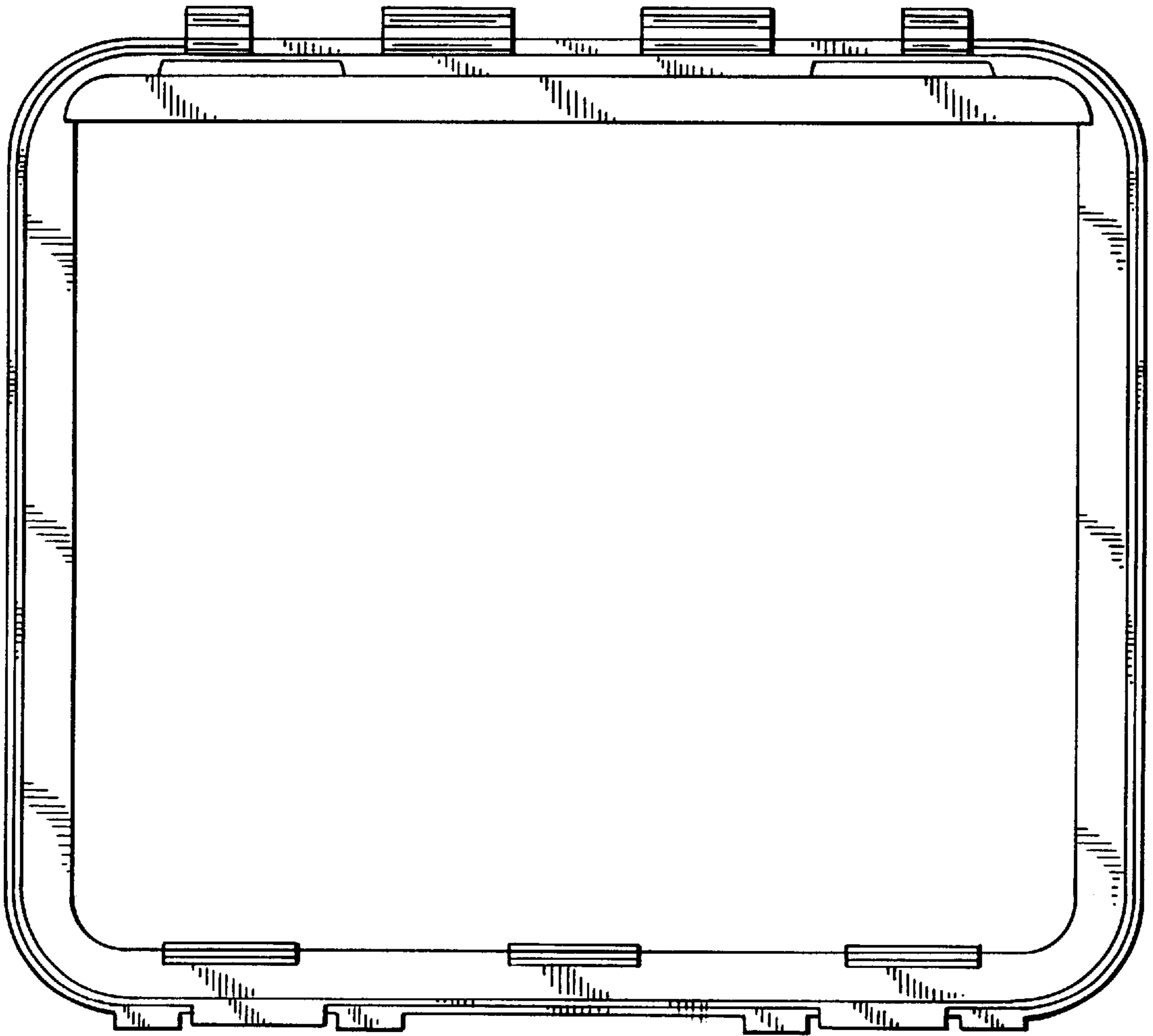

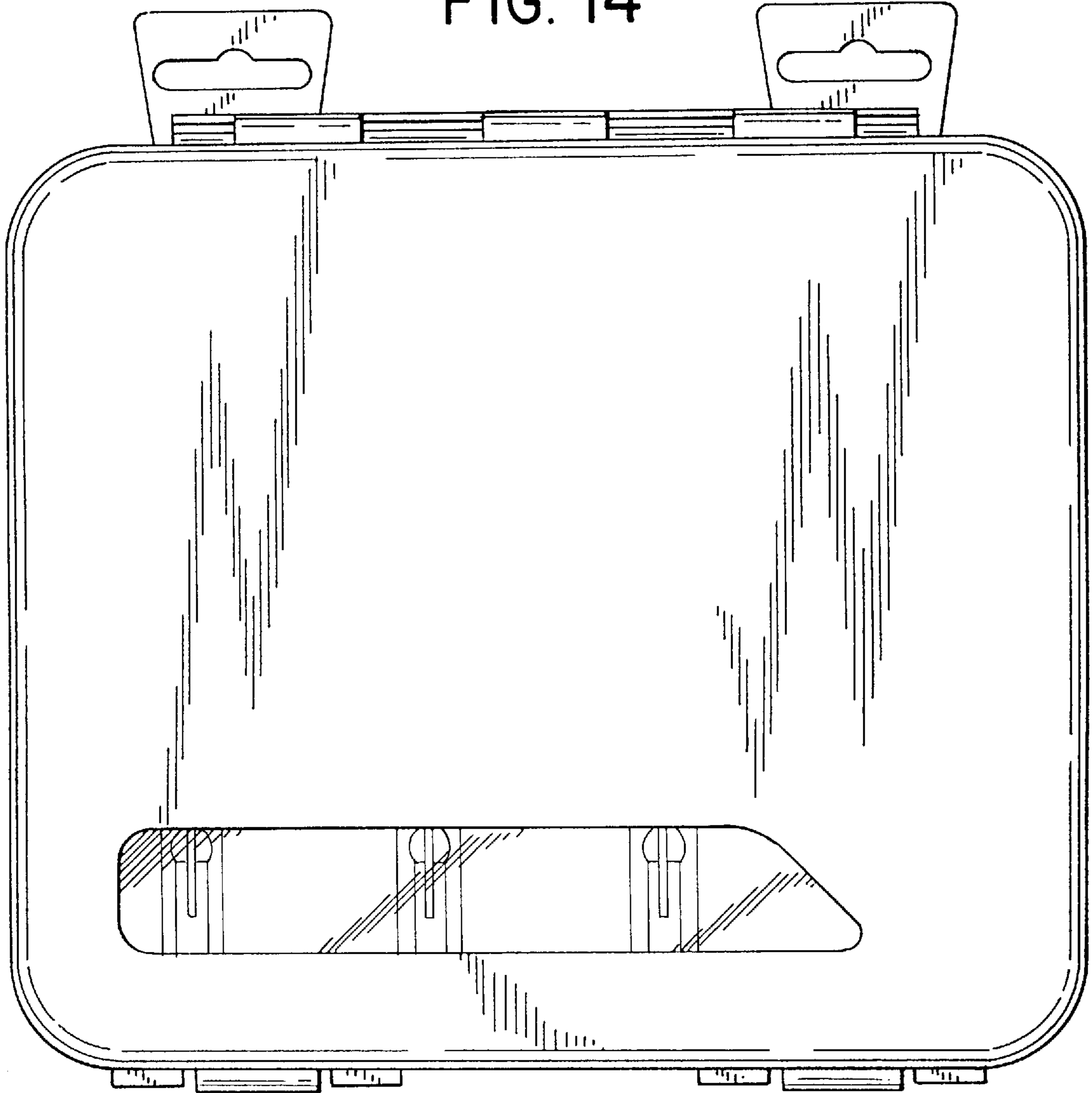

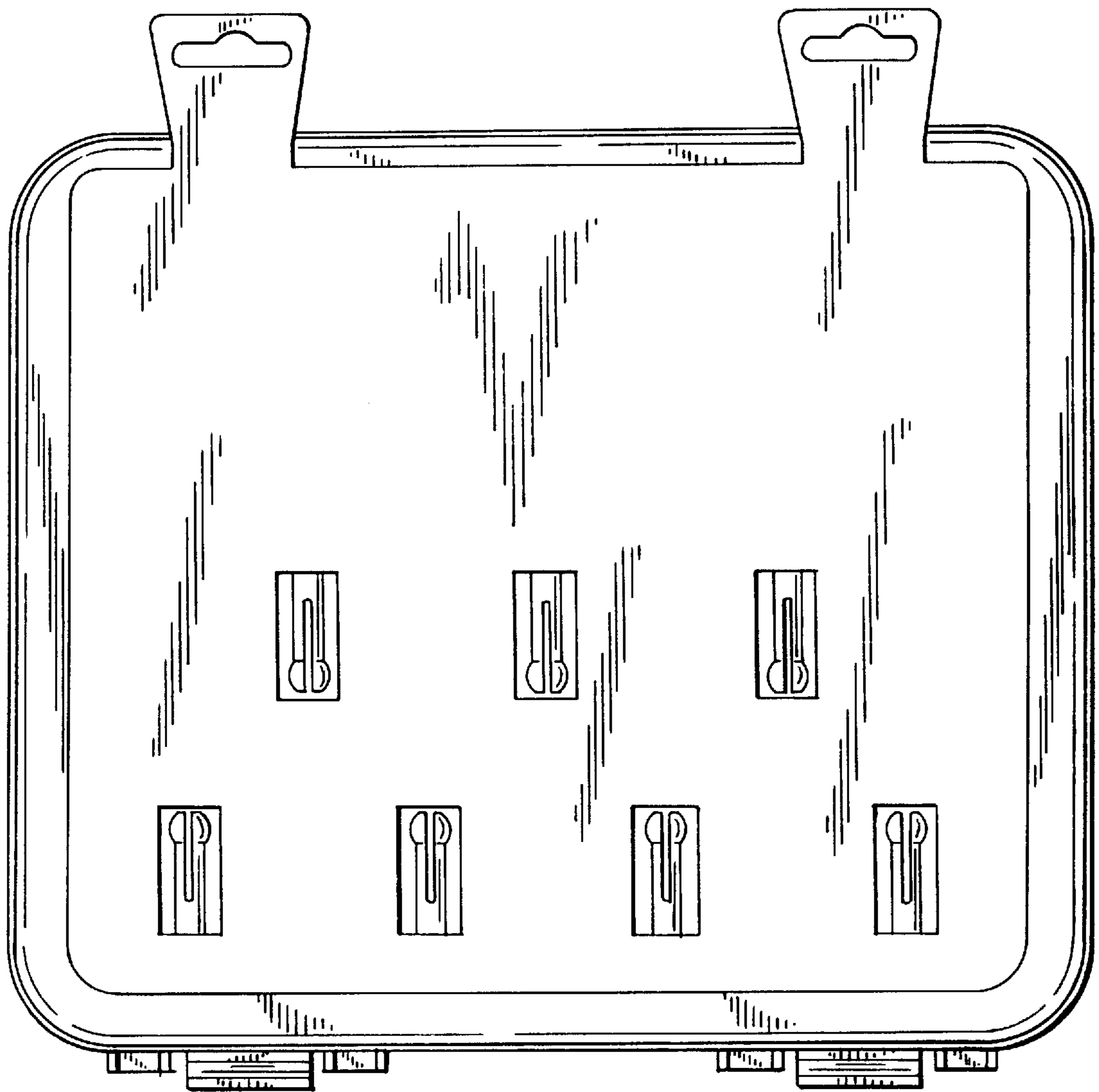

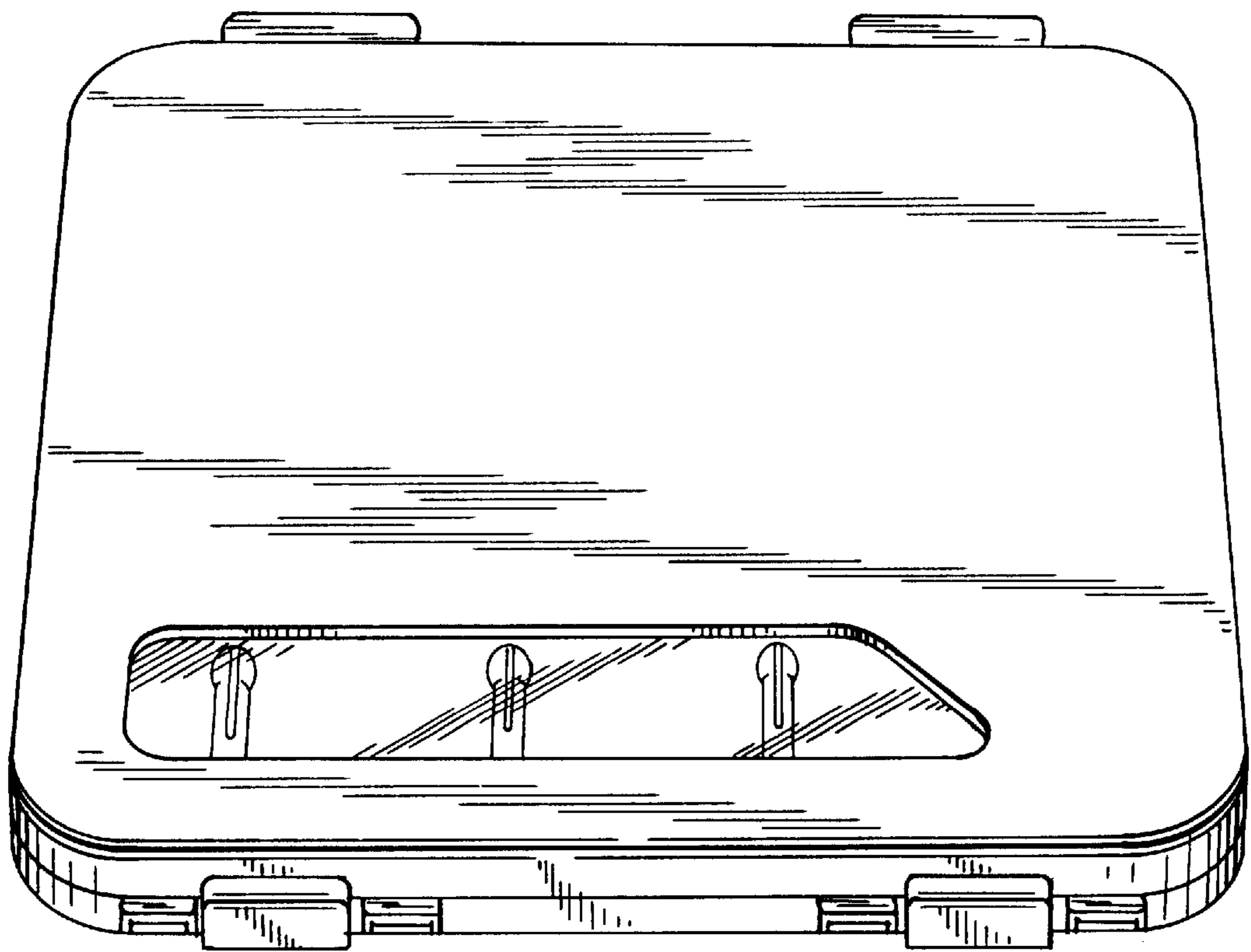

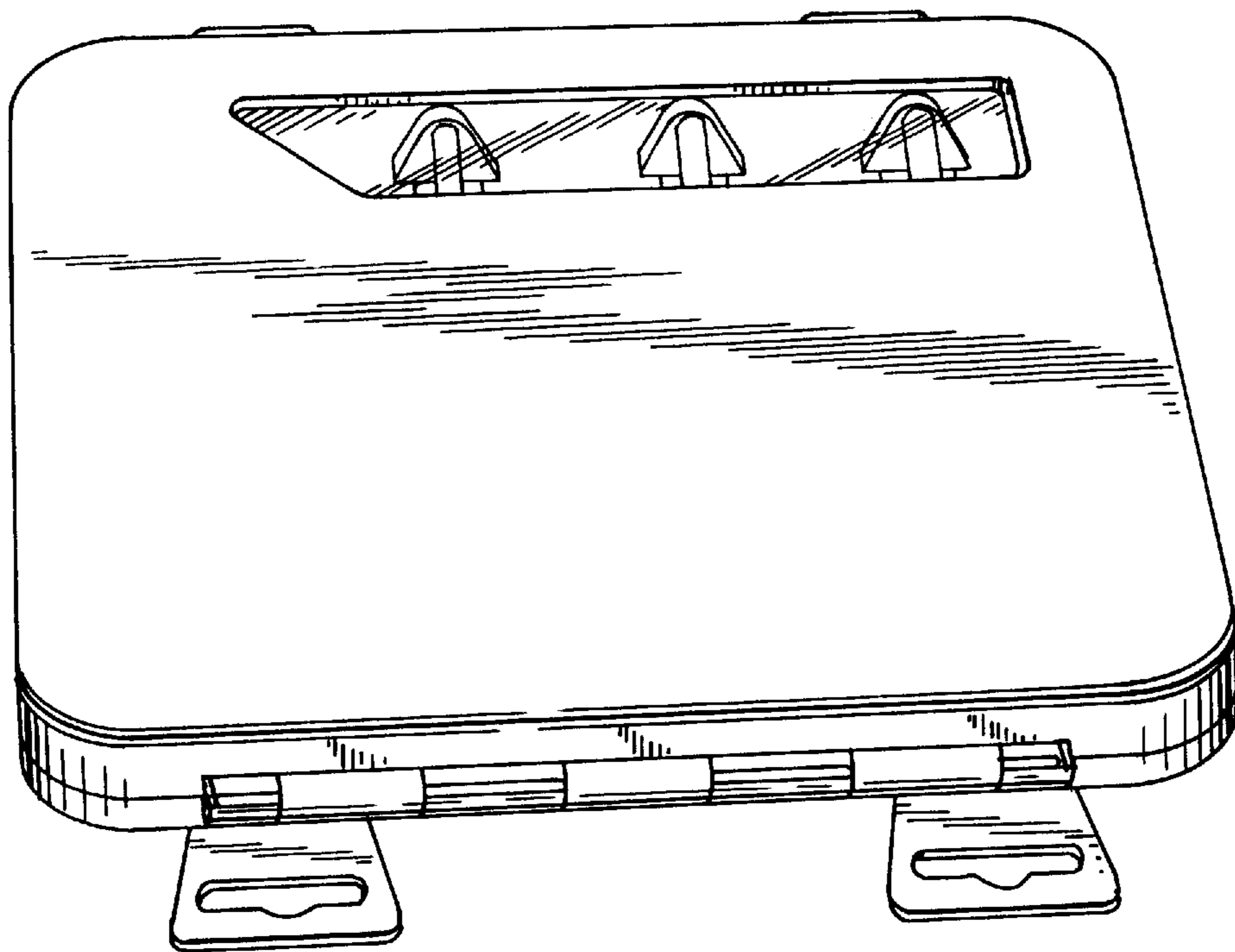

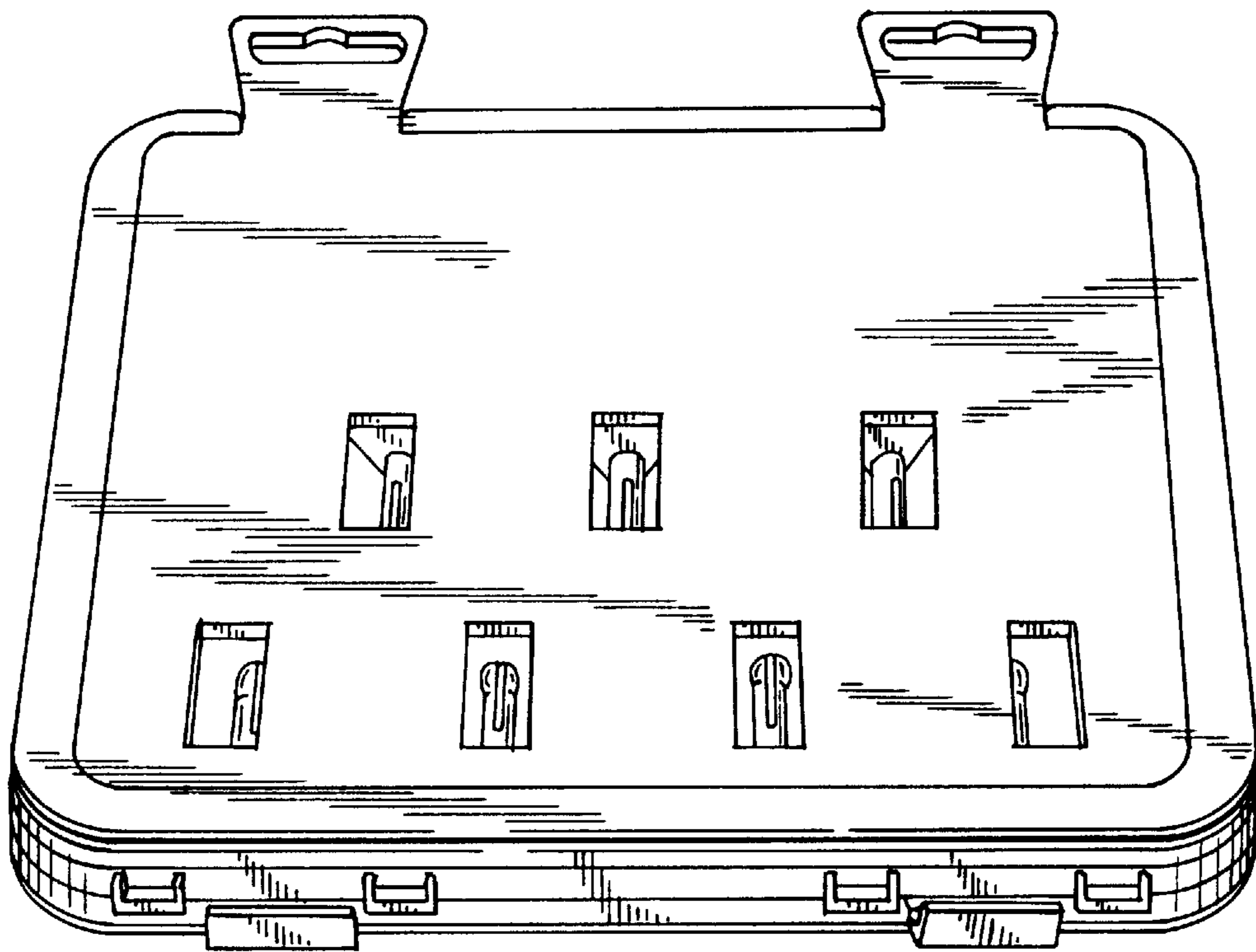

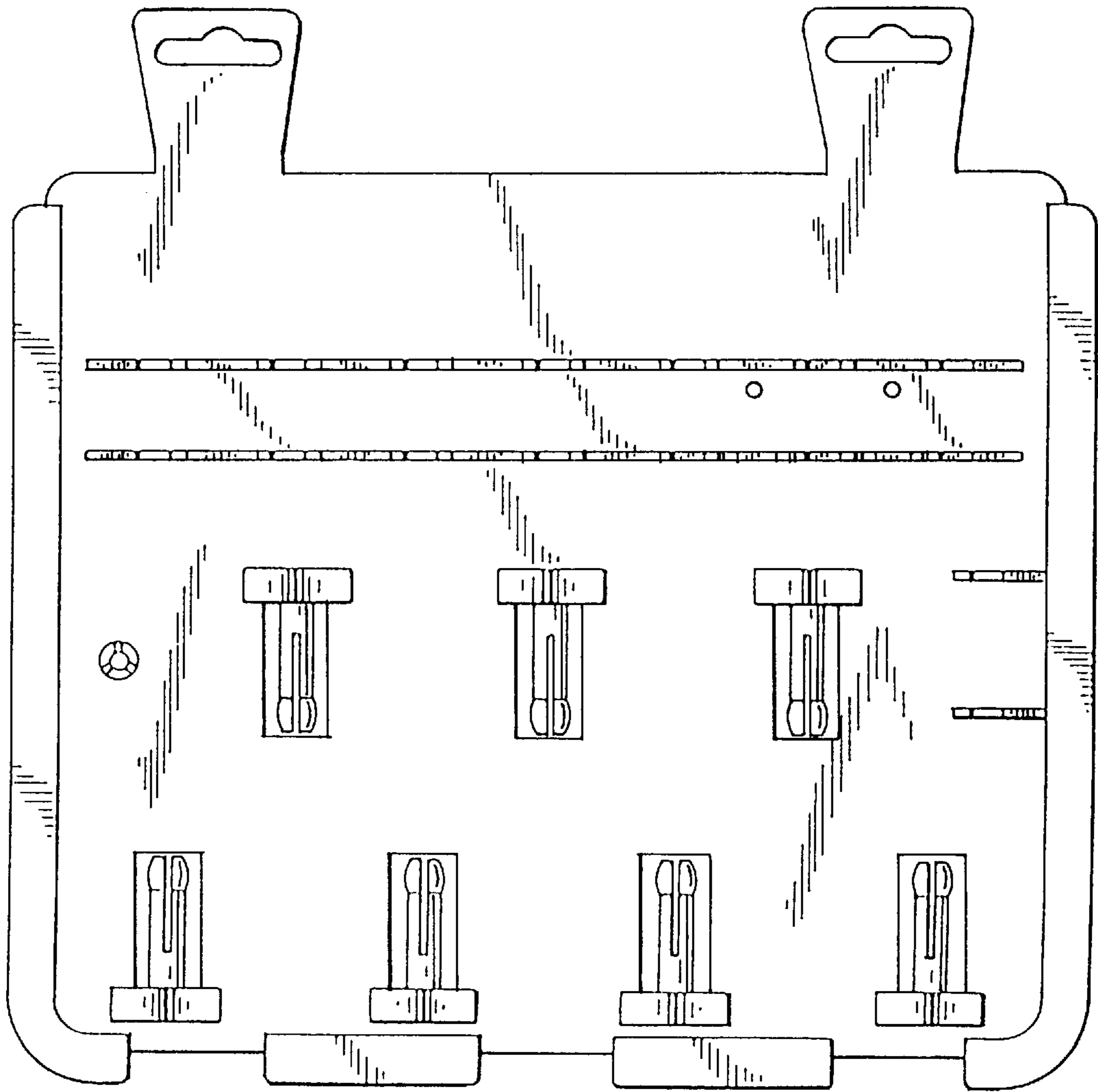

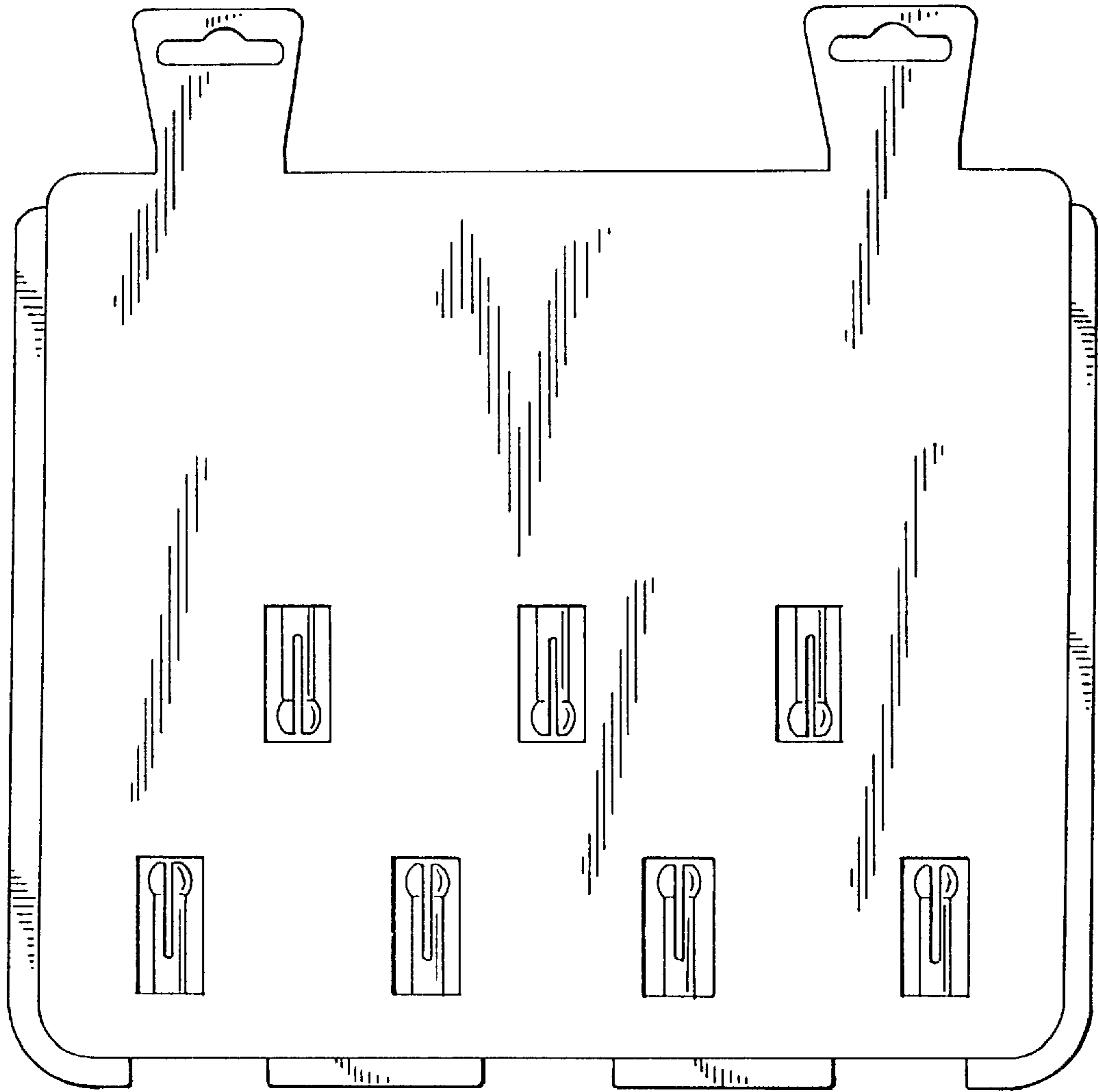
