The ornamental design for a plastic food serving knife, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a plastic food serving knife showing my new design;

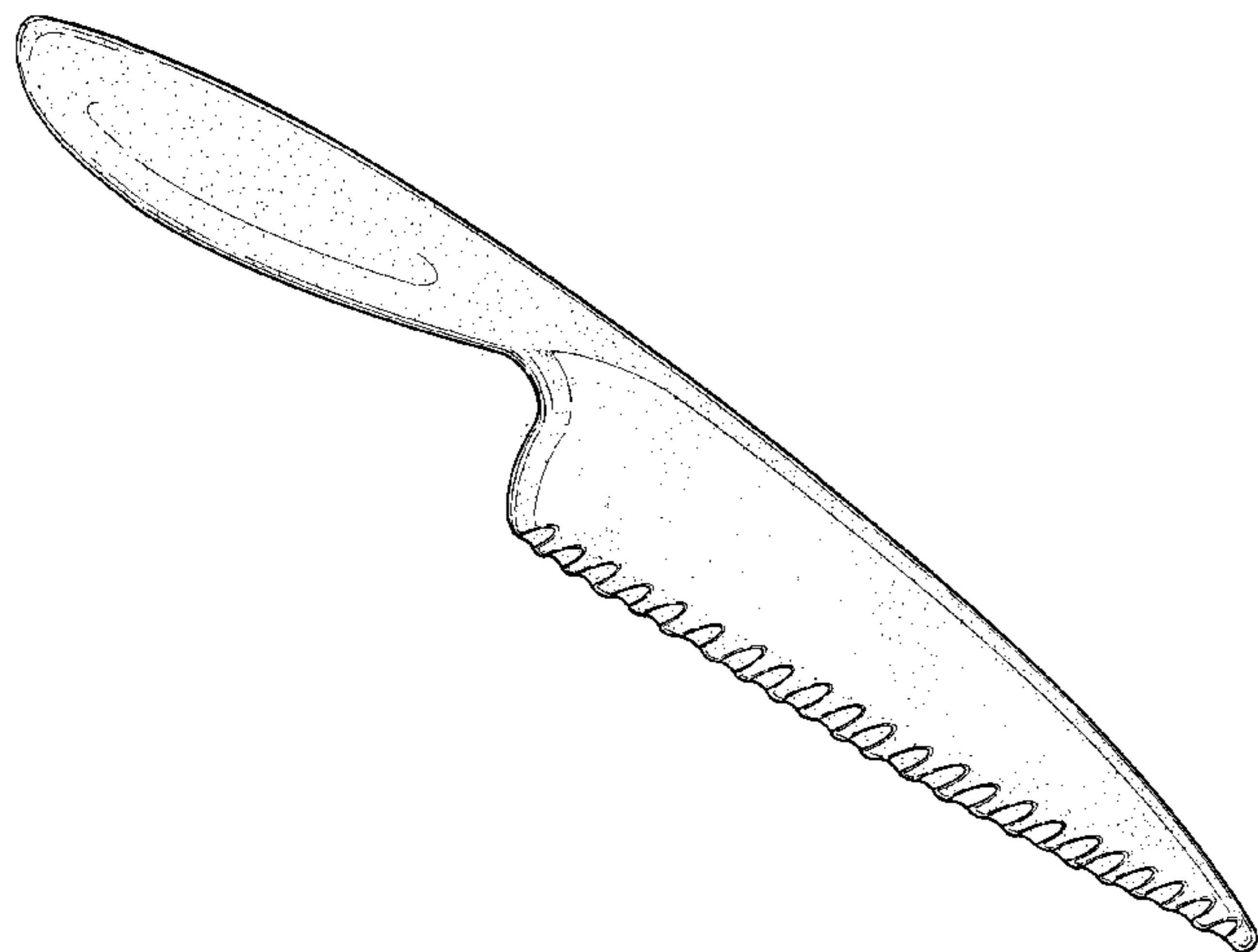


FIG. 2 is a side elevational view of the knife shown in FIG. 1;

FIG. 7 is a front end view of the knife shown in FIGS. 1-6;

FIG. 8 is a perspective view of a second embodiment of the plastic food serving knife shown in FIGS. 1-7;

FIG. 9 is a side view of the knife shown in FIG. 8;

FIG. 10 is a bottom view of the knife shown in FIGS. 8 and 9;

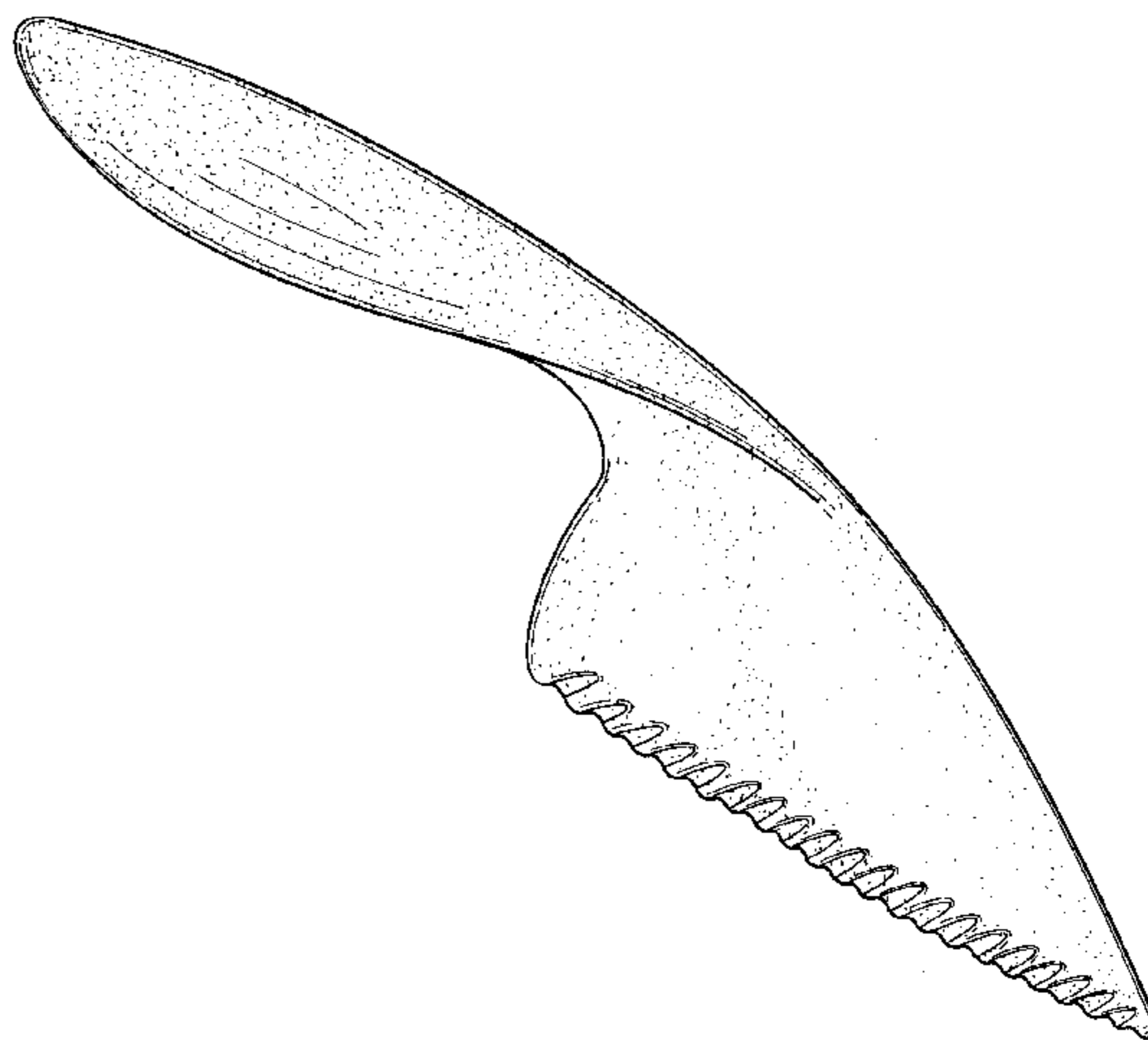
FIG. 11 is a reverse side view of the knife shown in FIGS. 8 and 9;

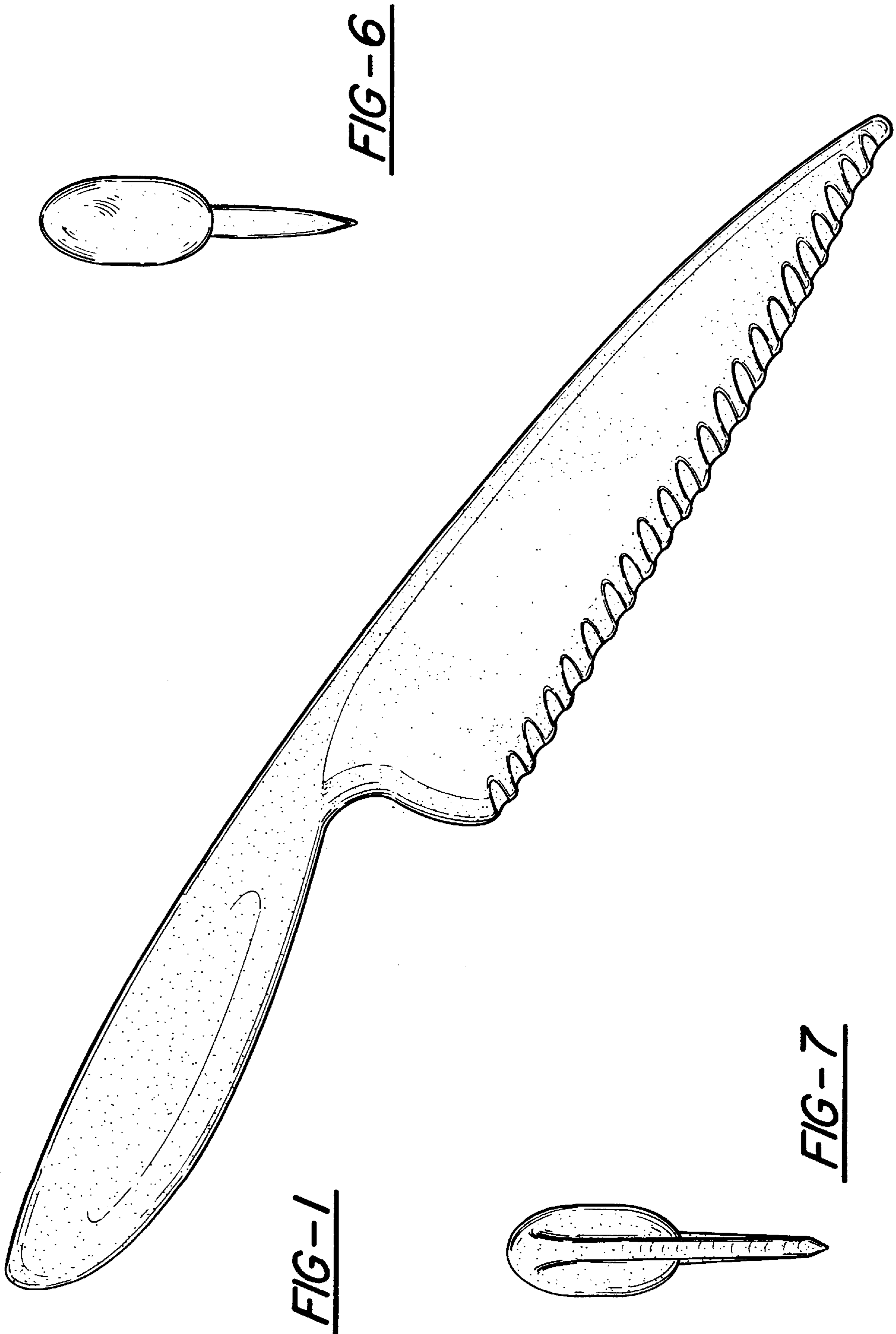

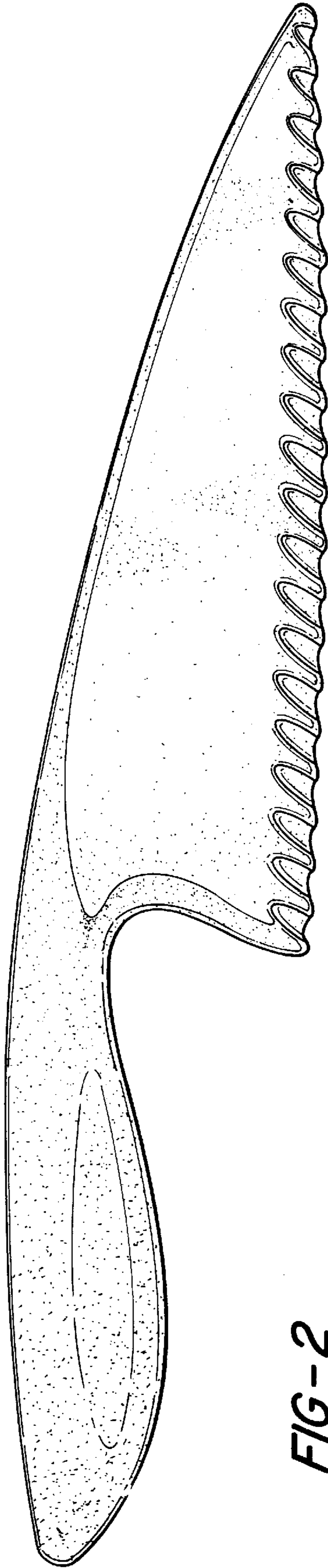

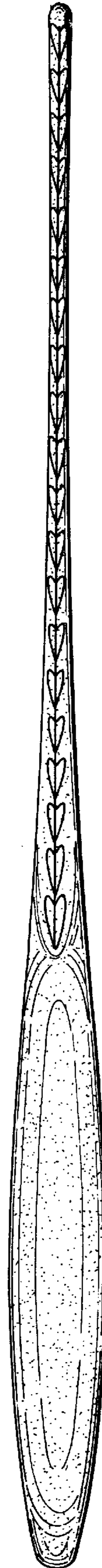

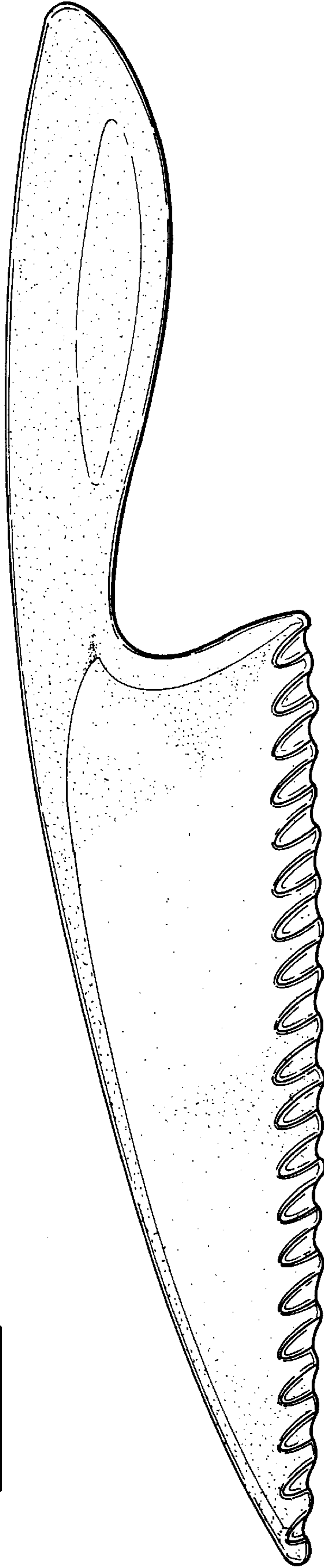
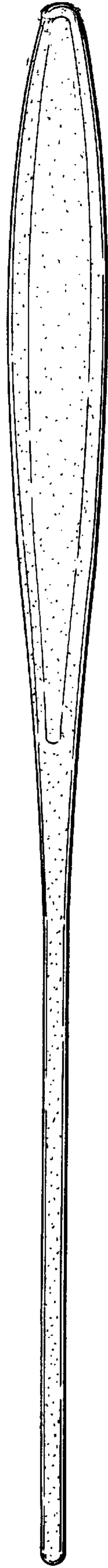

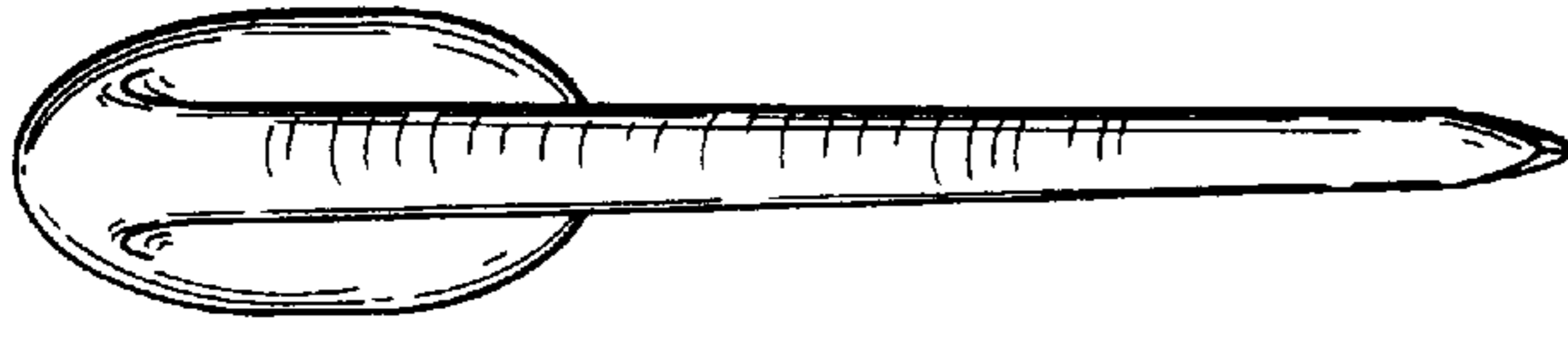

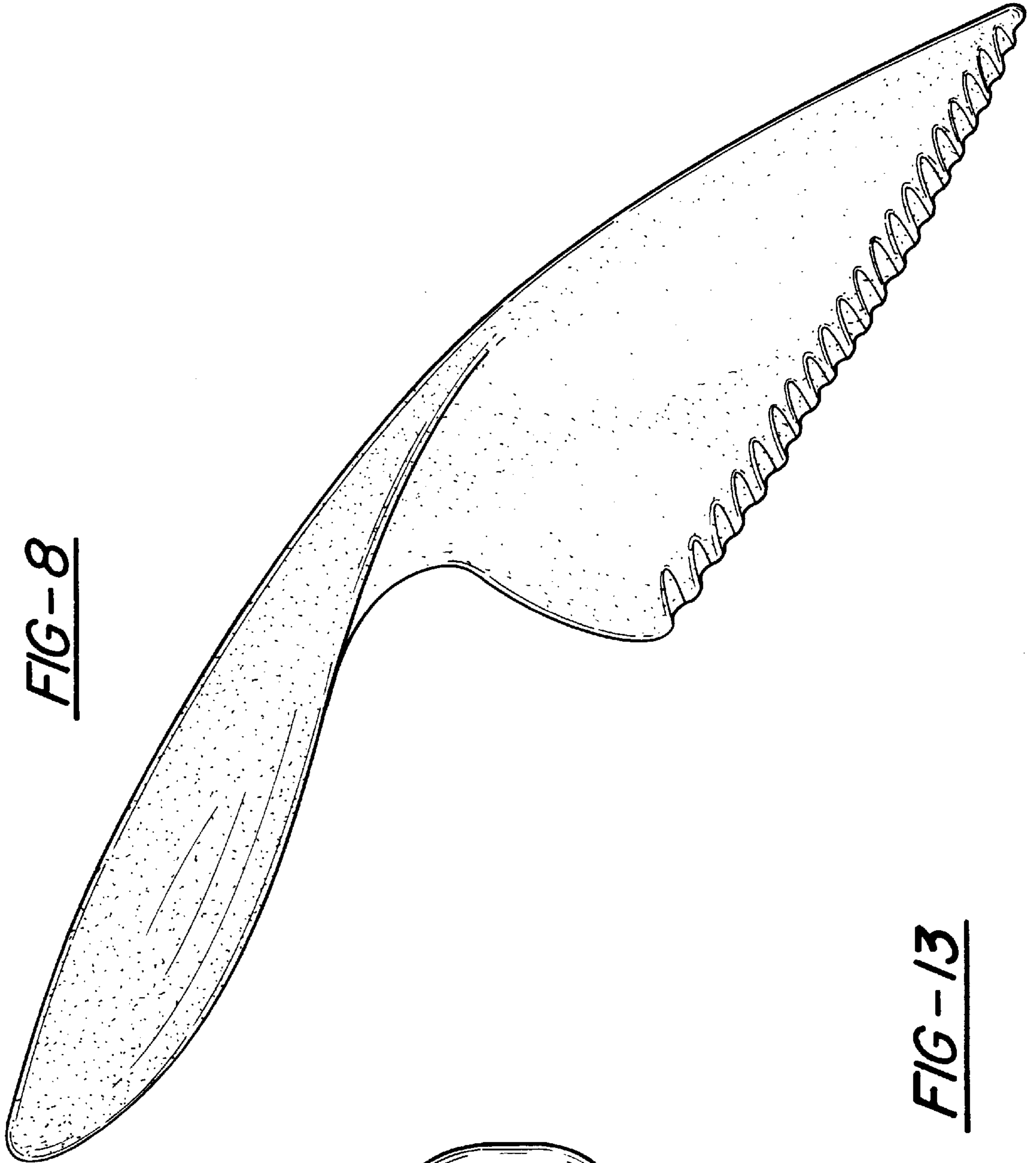

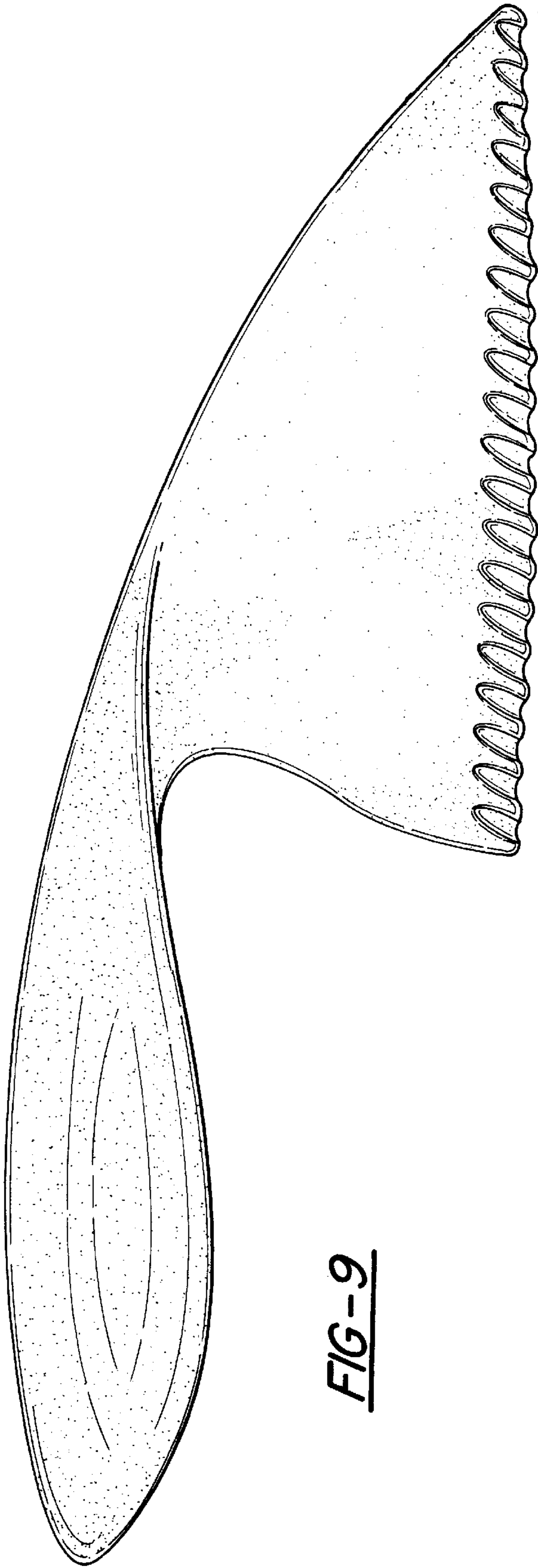

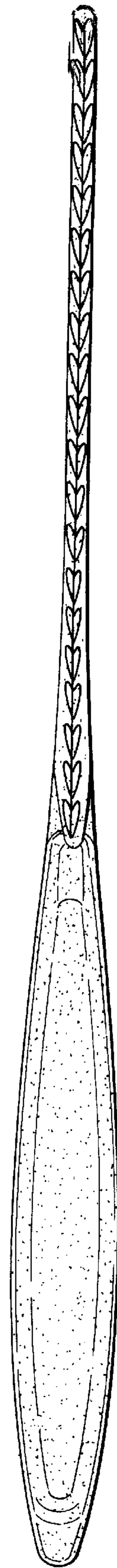

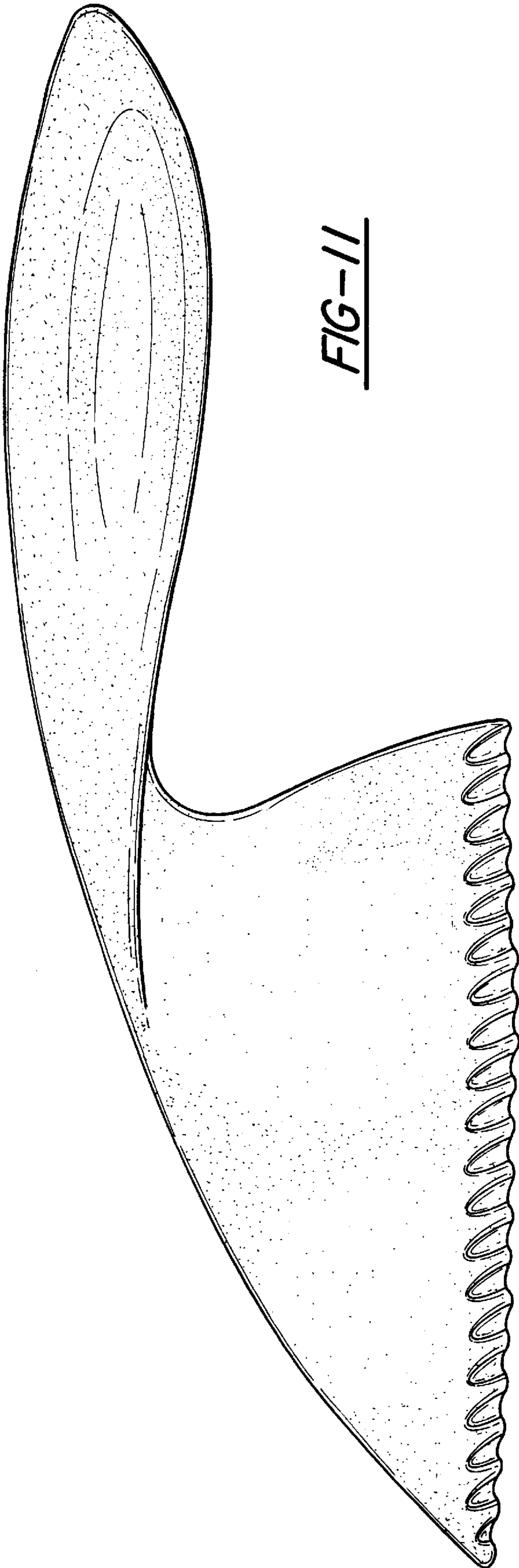

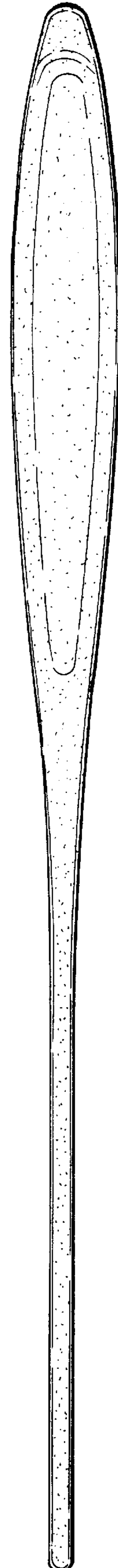
