[57] **CLAIM**

The ornamental design for a shoulder-strap connector for brassieres, lingerie and bathing suits, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a shoulder-strap

connector for brassieres, lingerie and bathing suits showing my new design;

FIG. 2 is a bottom plan view, the top view being a mirror image;

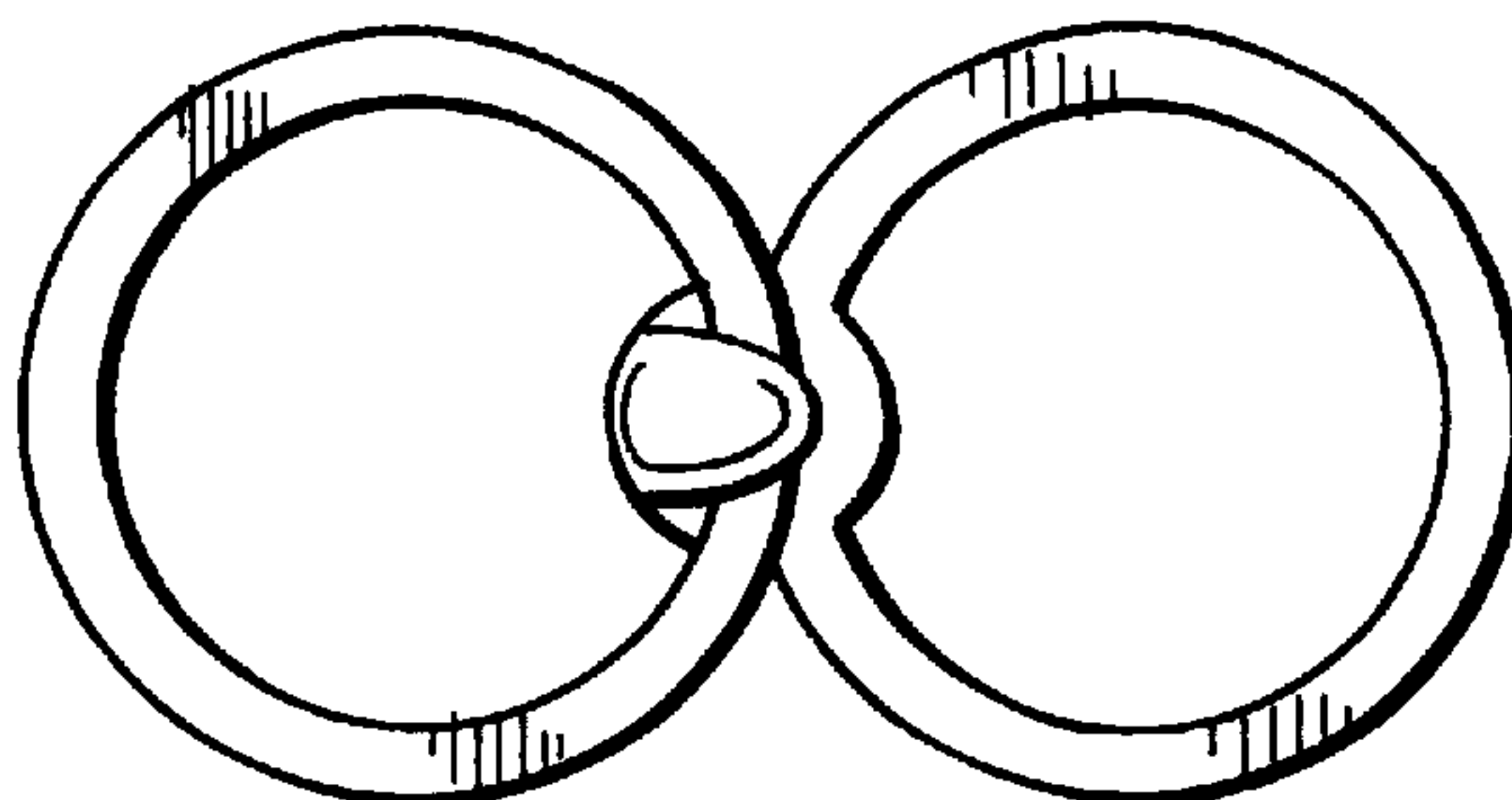

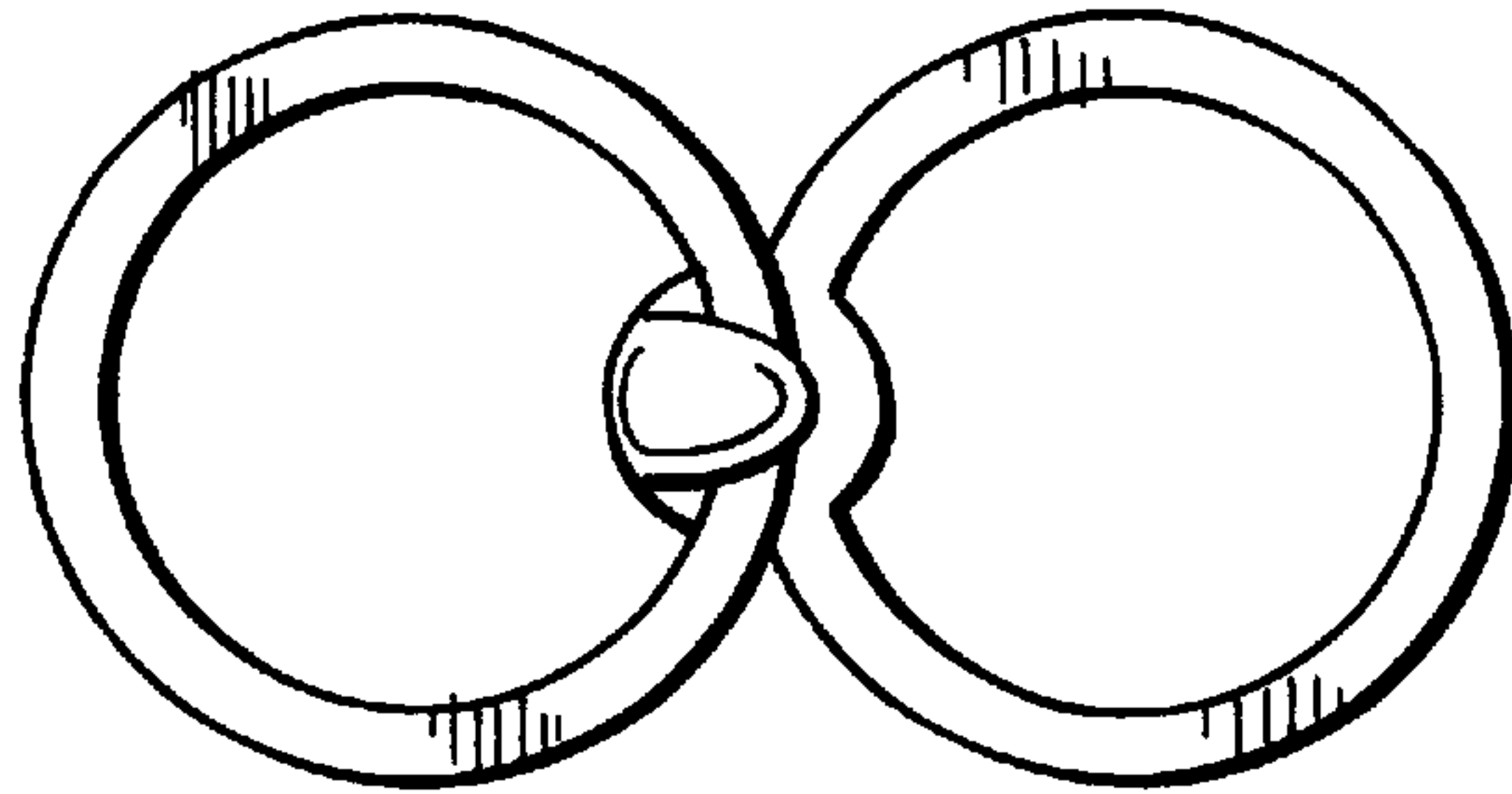

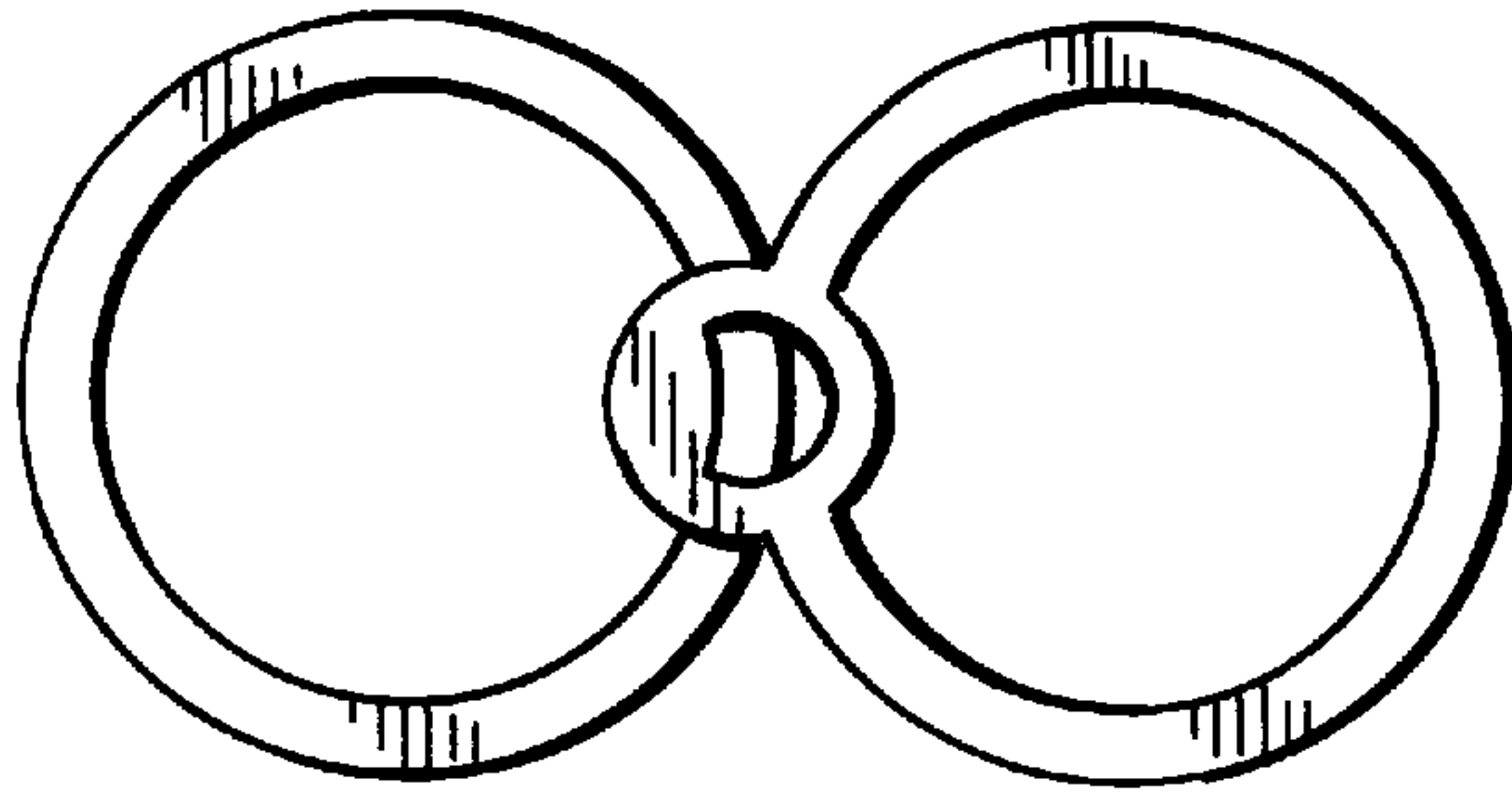

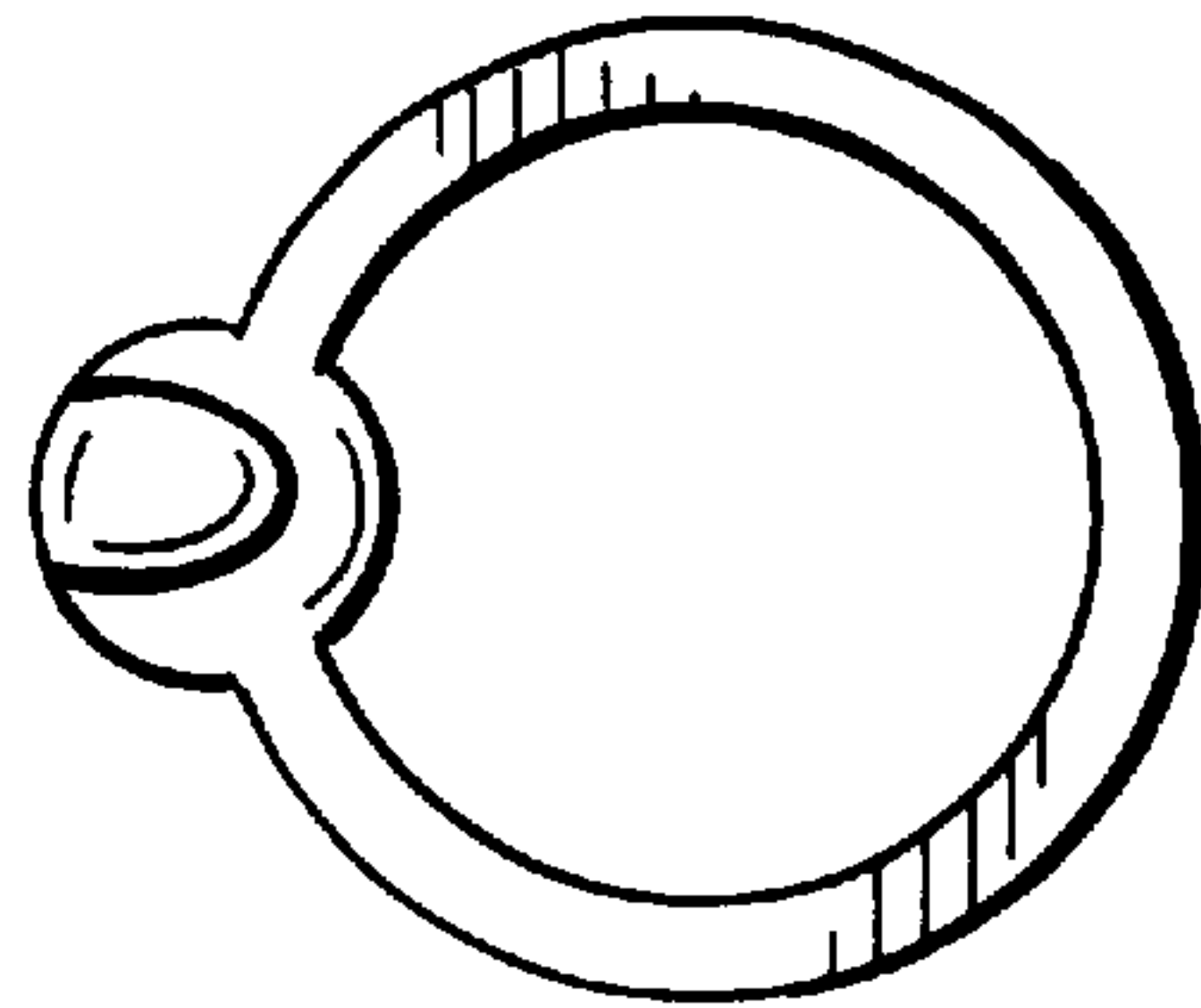
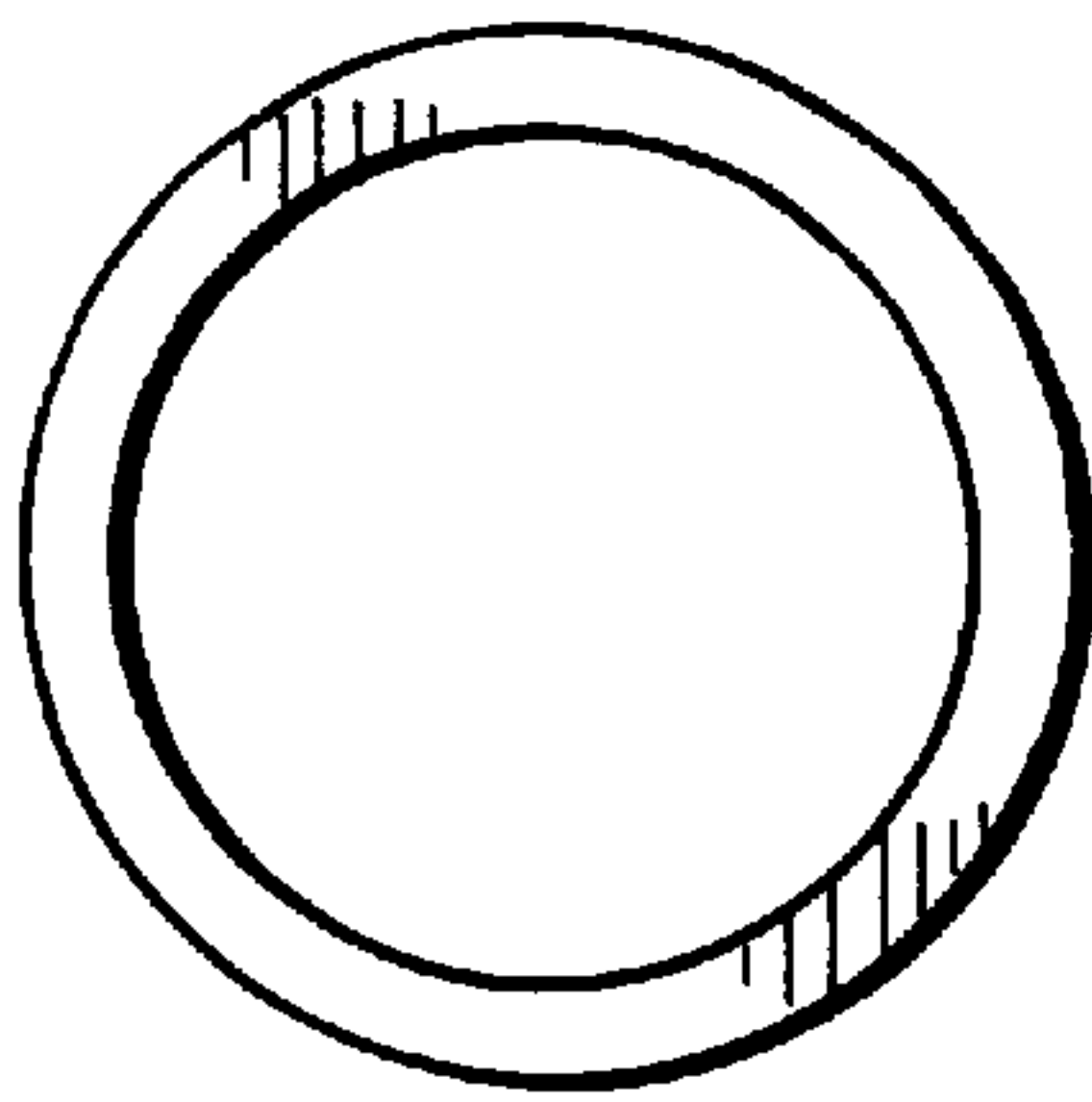

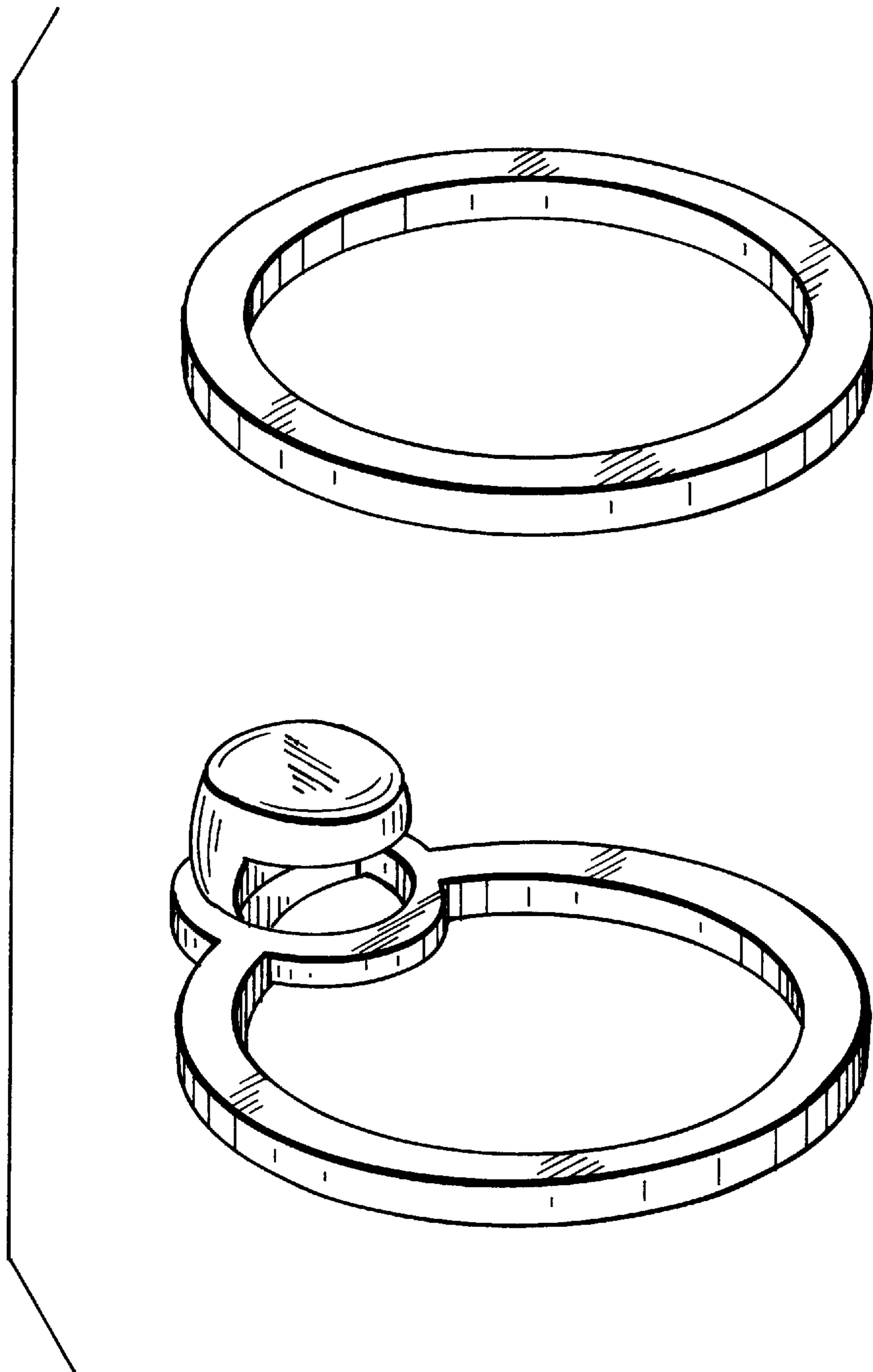

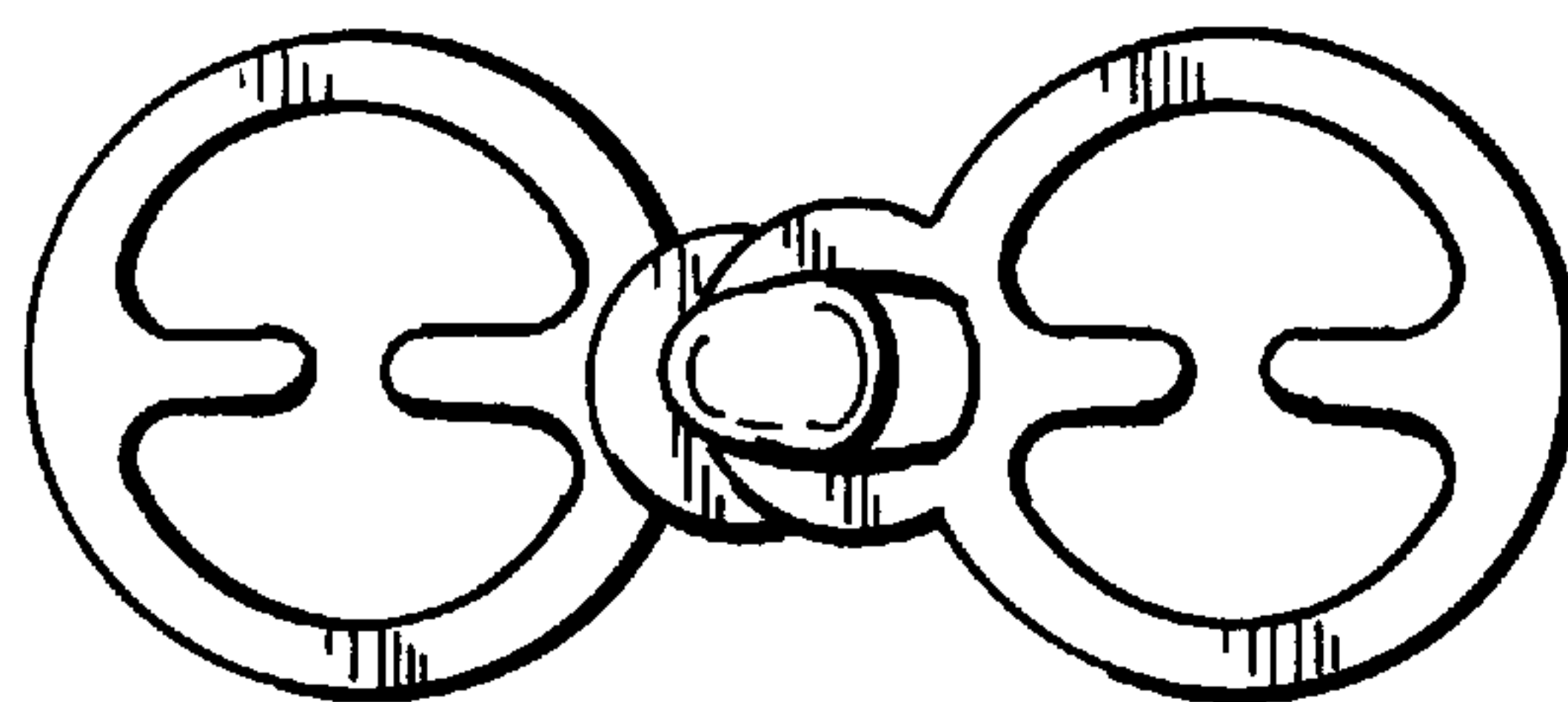

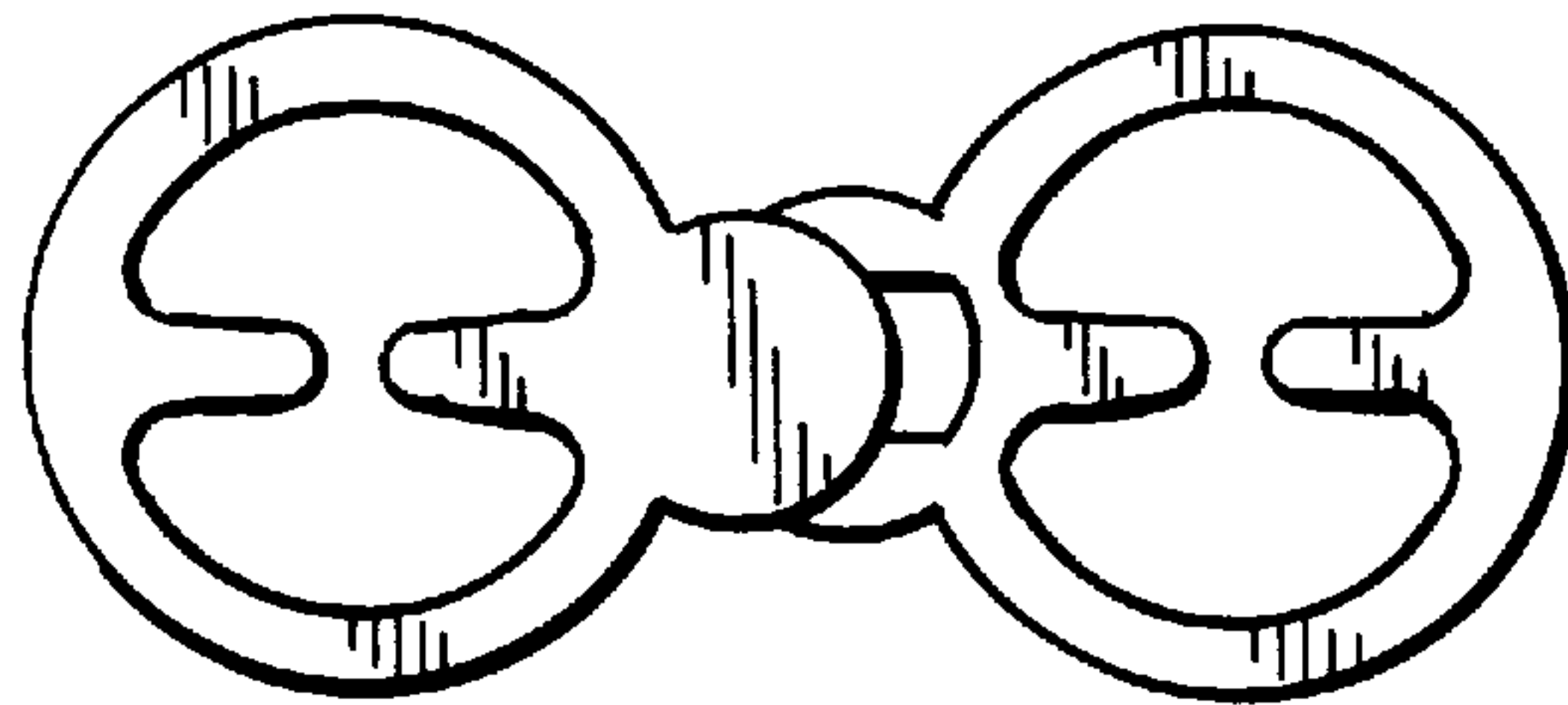

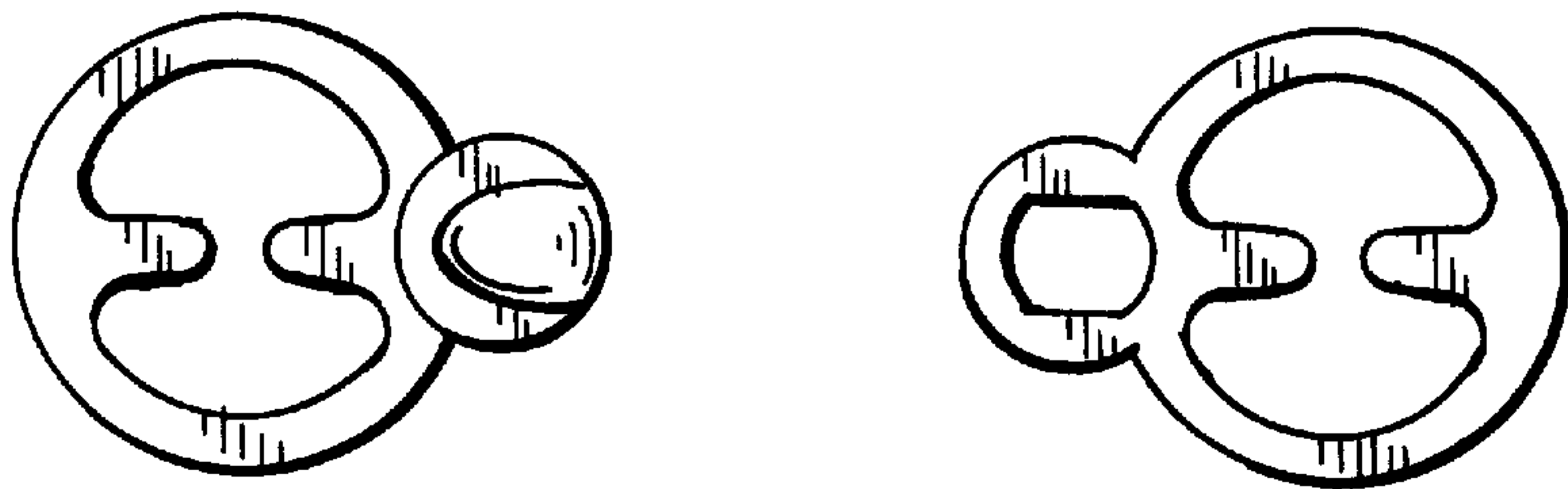

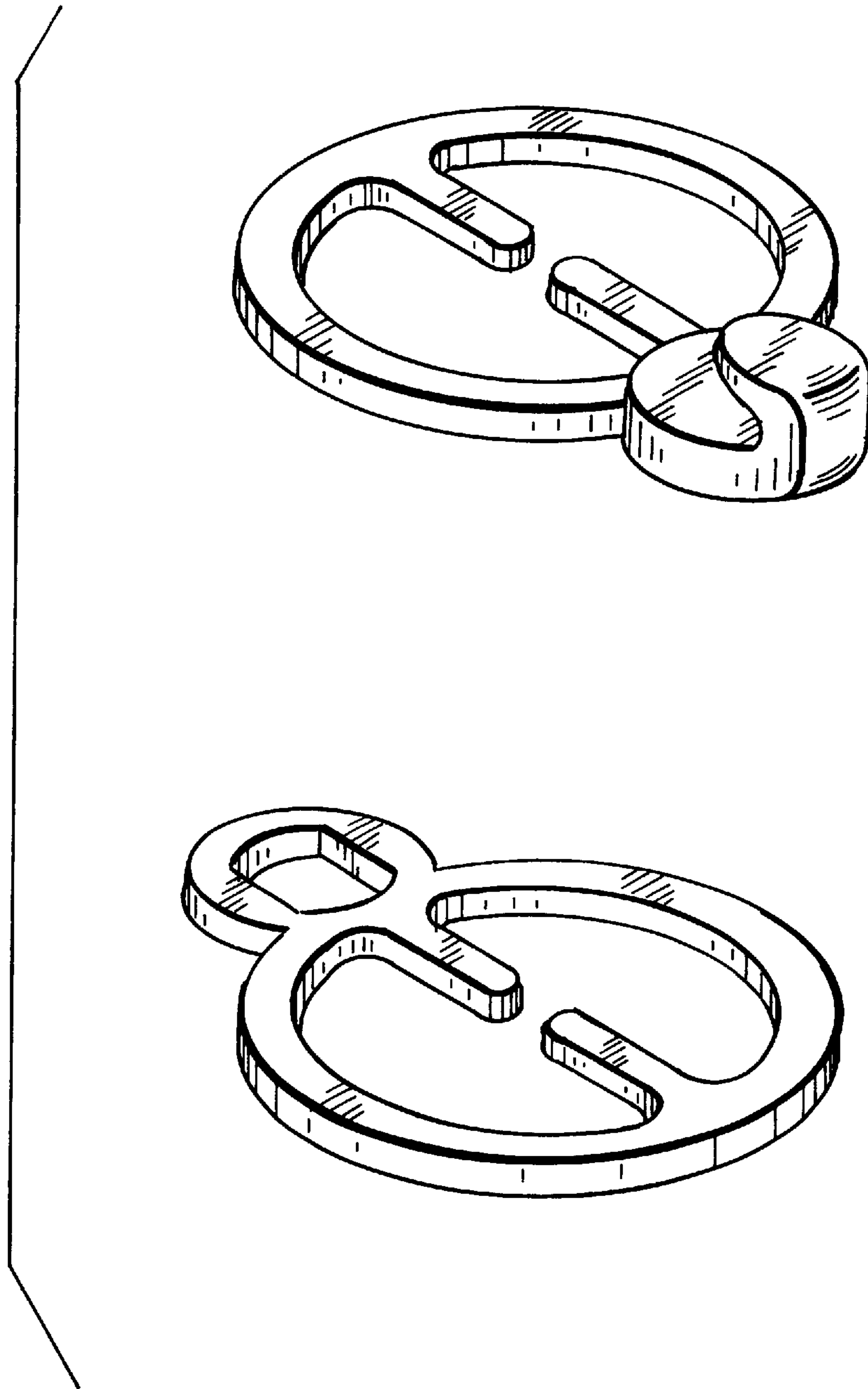
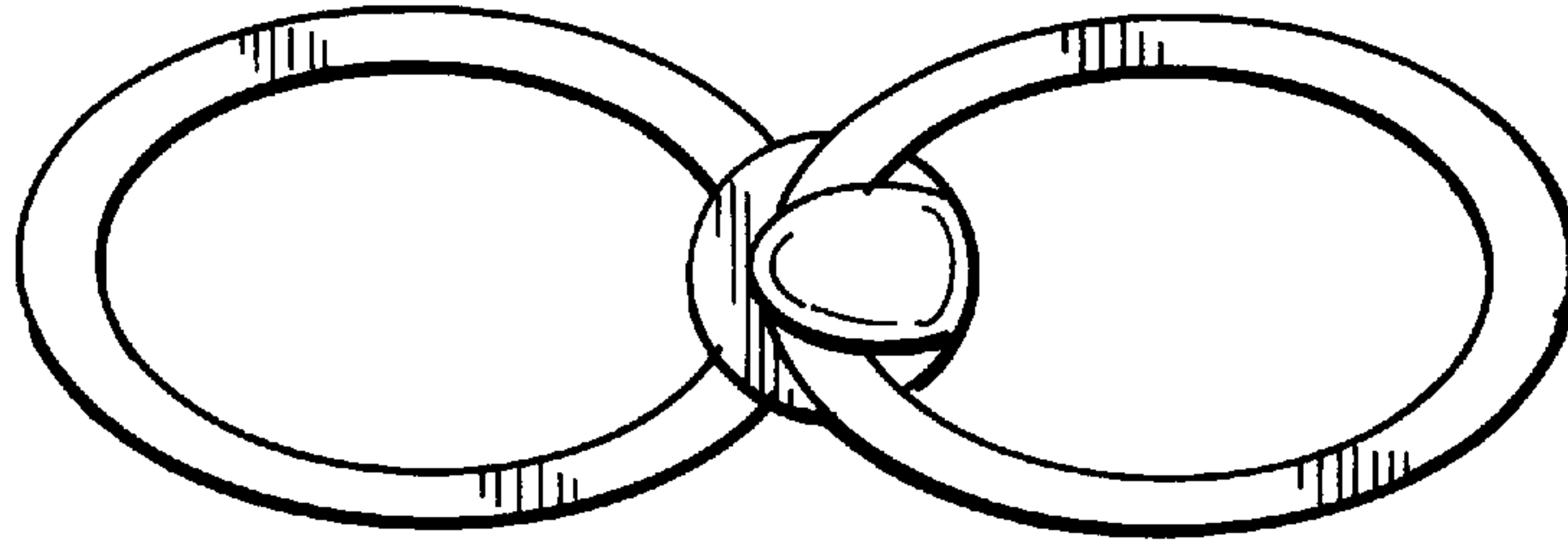


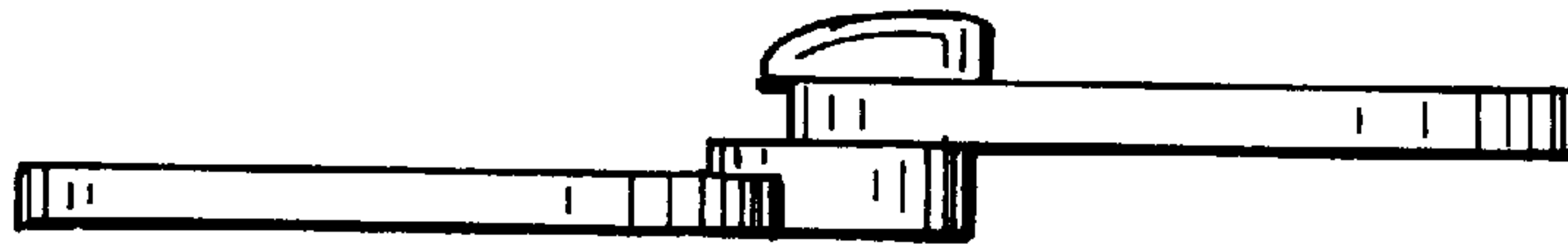

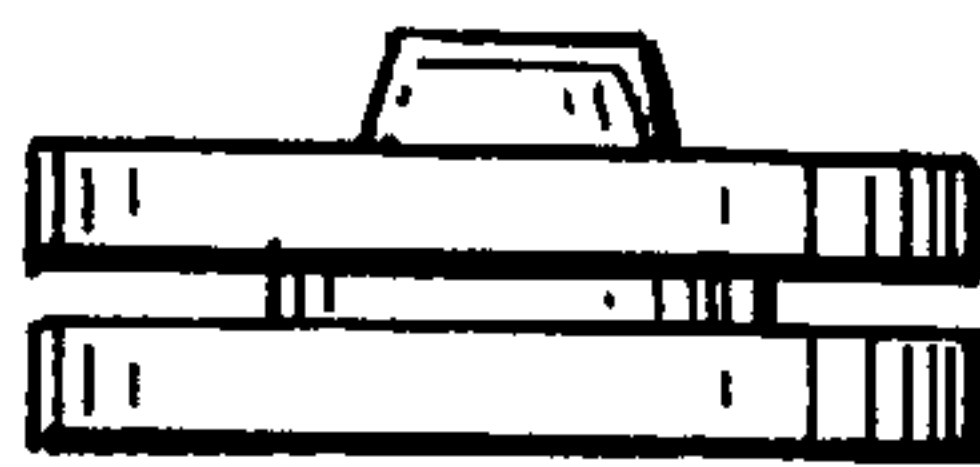

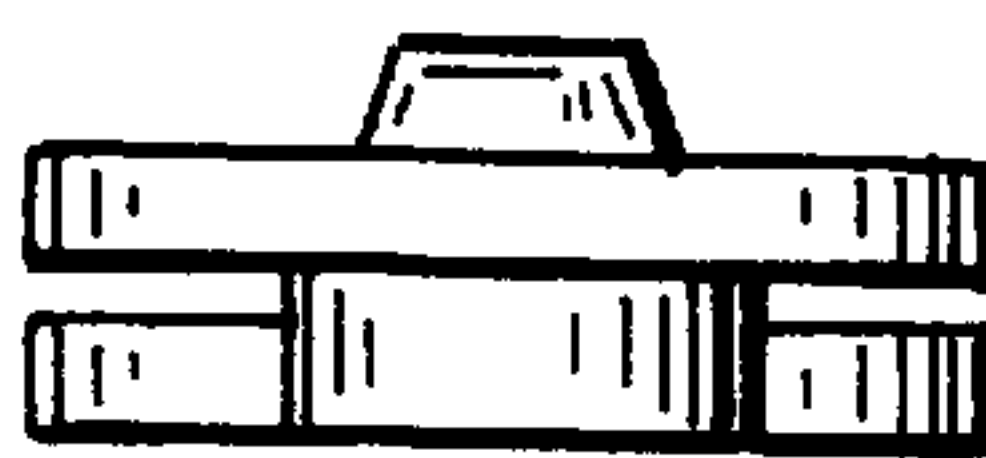

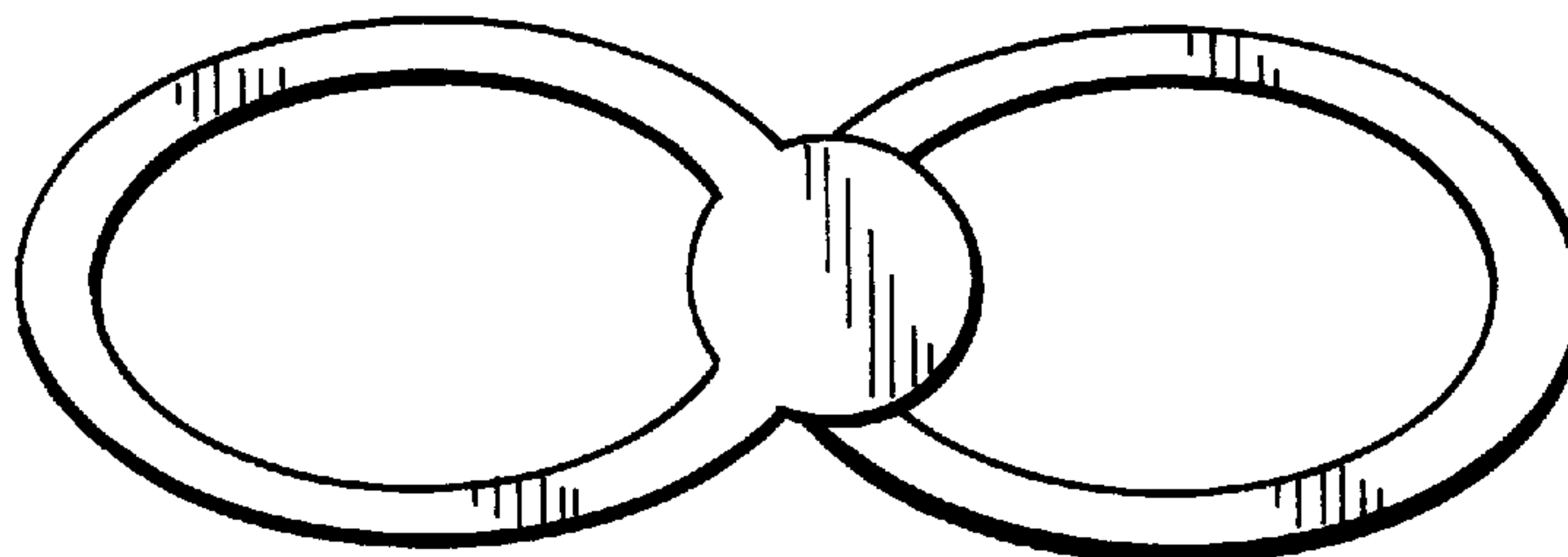

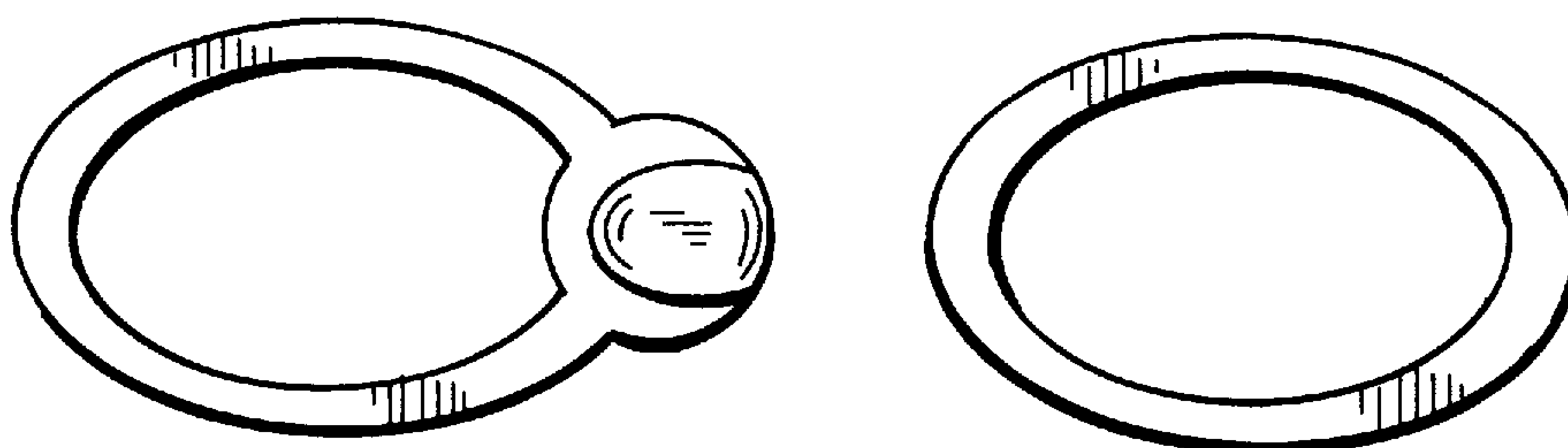

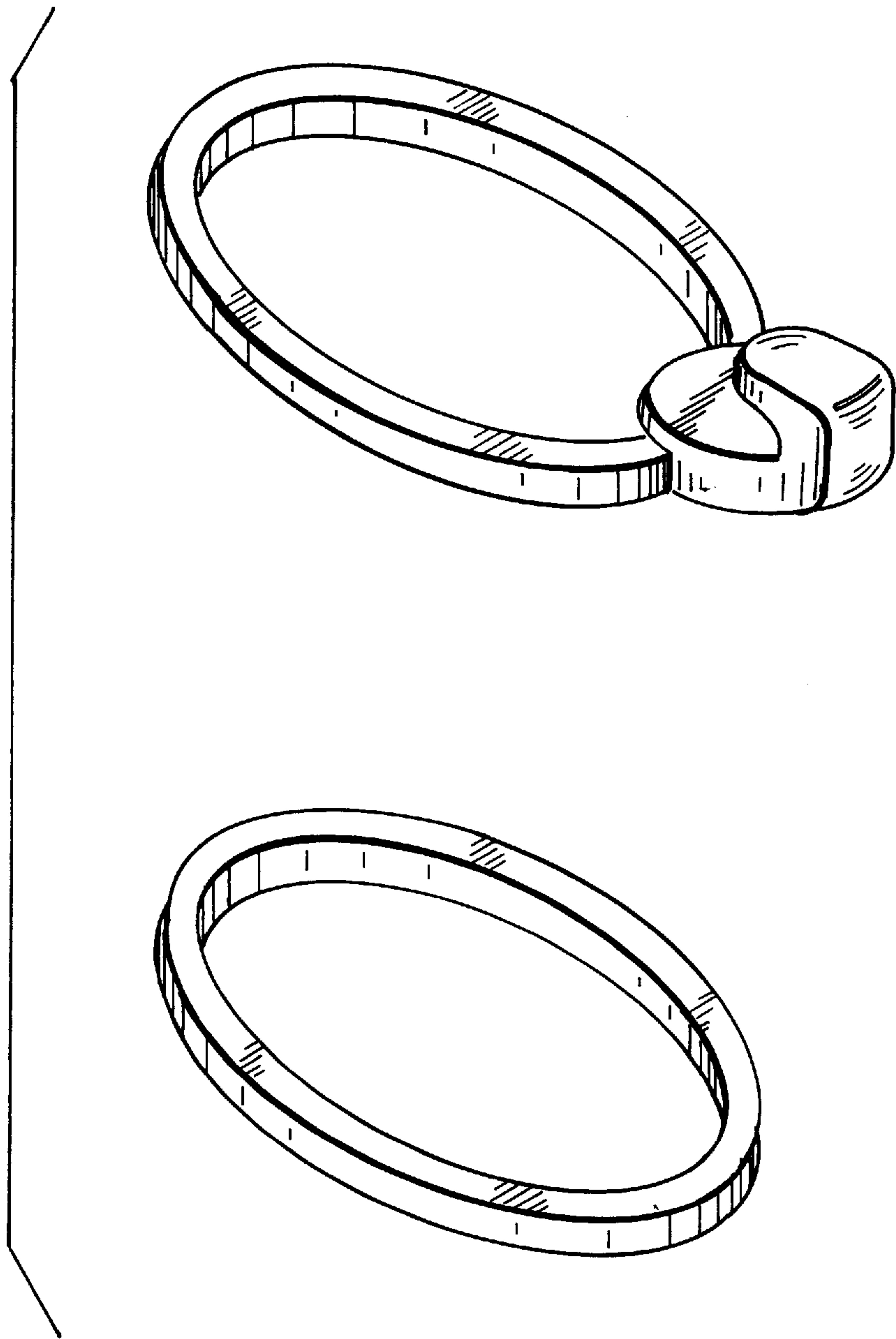
