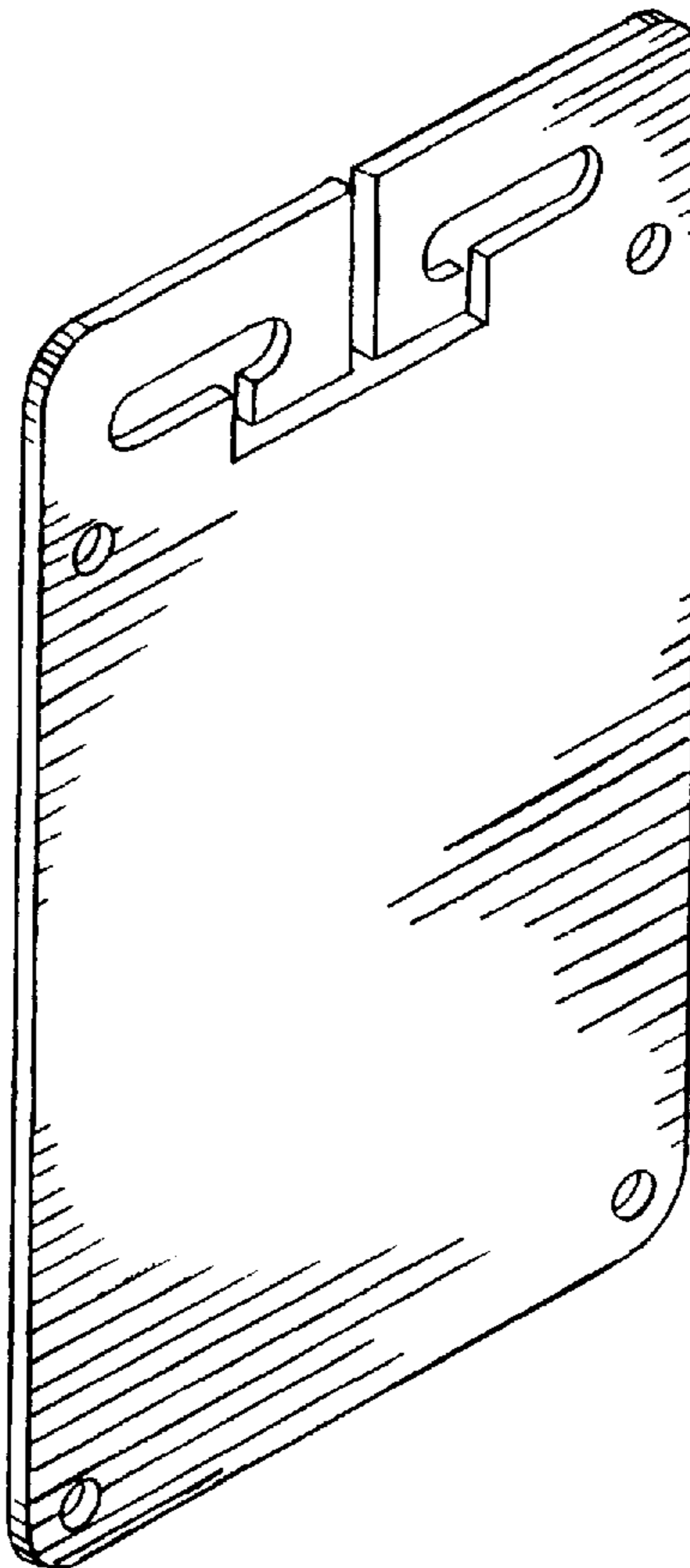
[57] **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of the sign showing the new sign design;
FIG. 2 is a front view thereof;

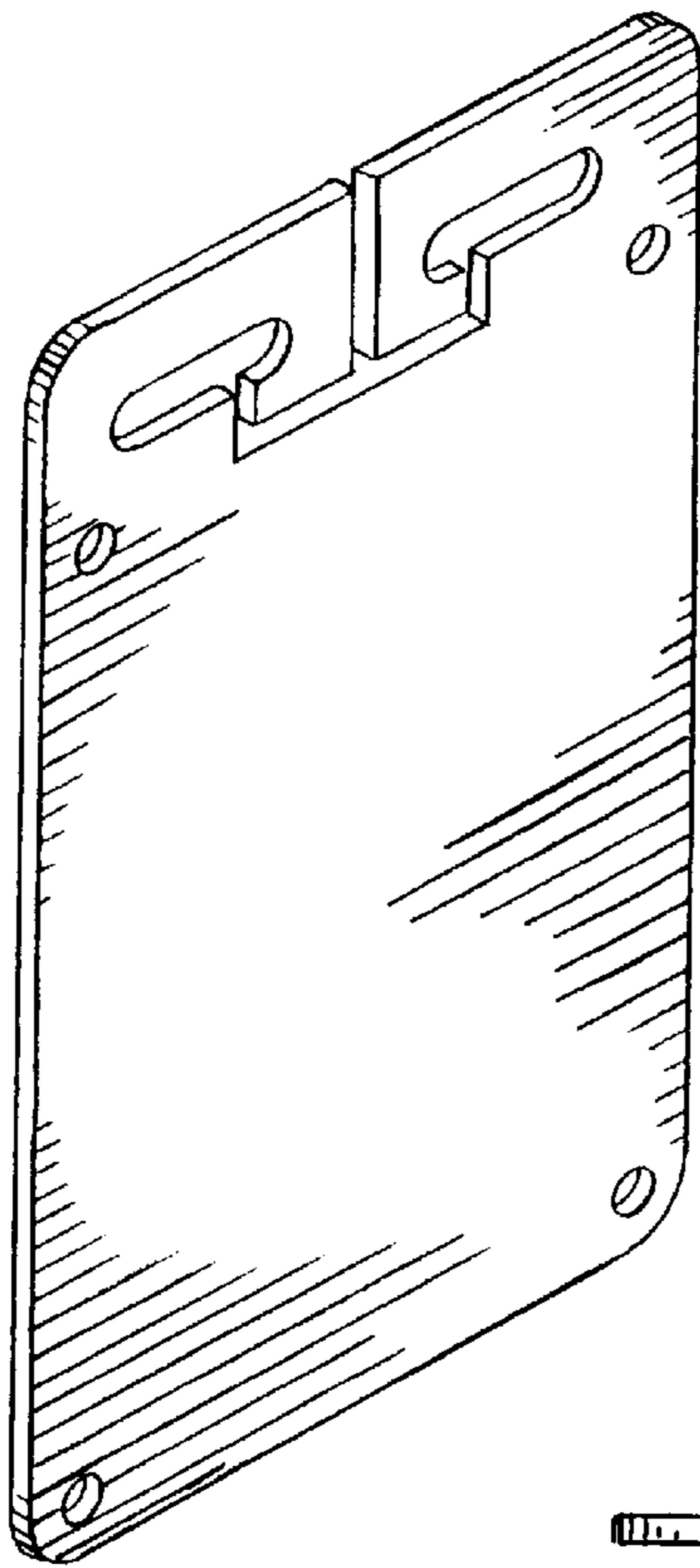

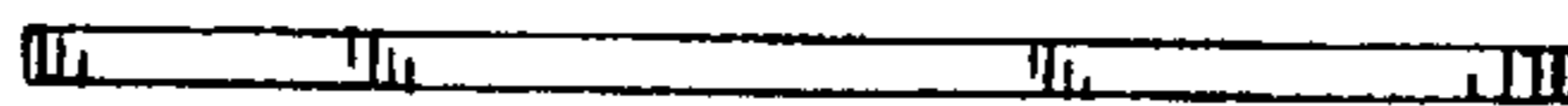
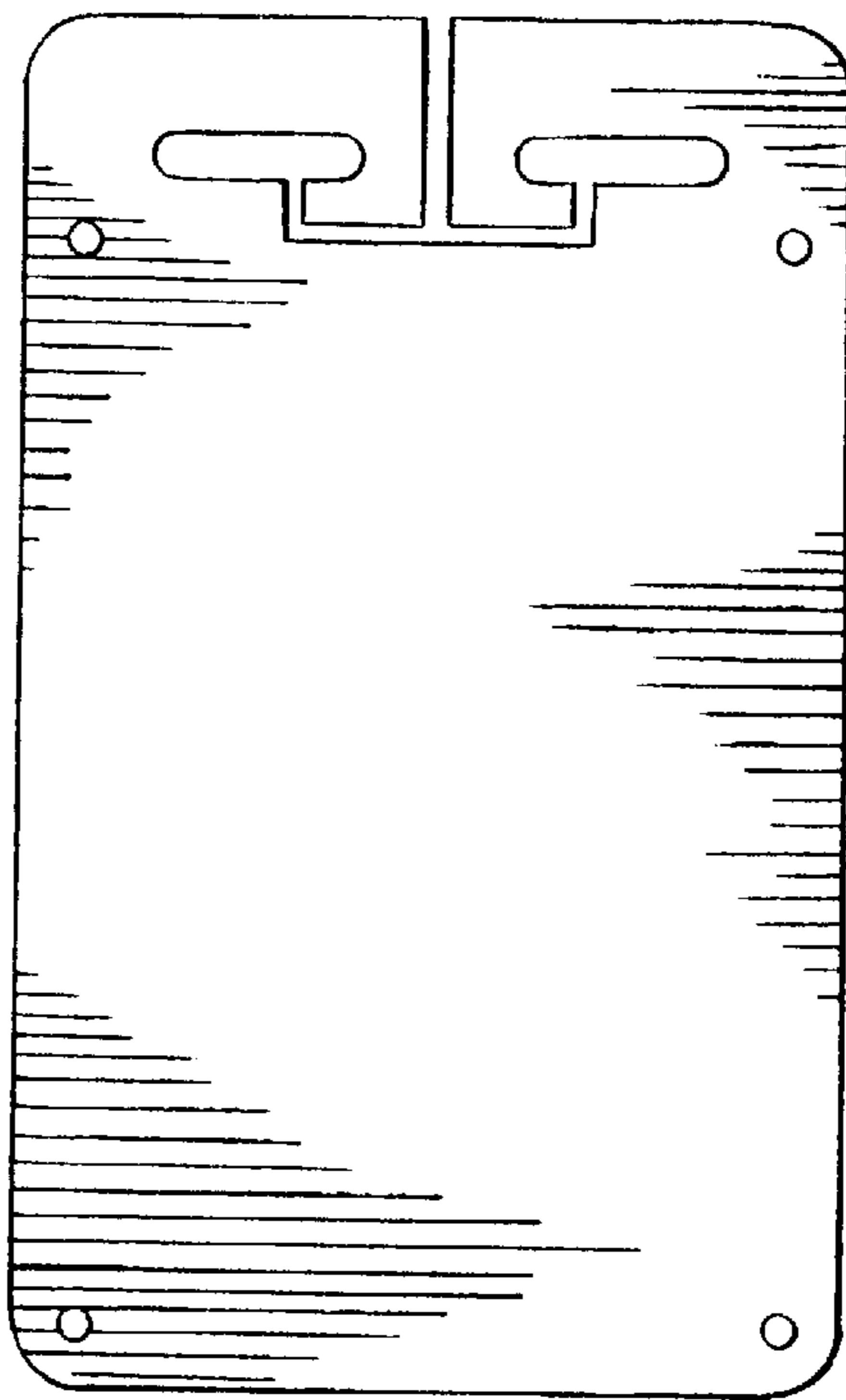
