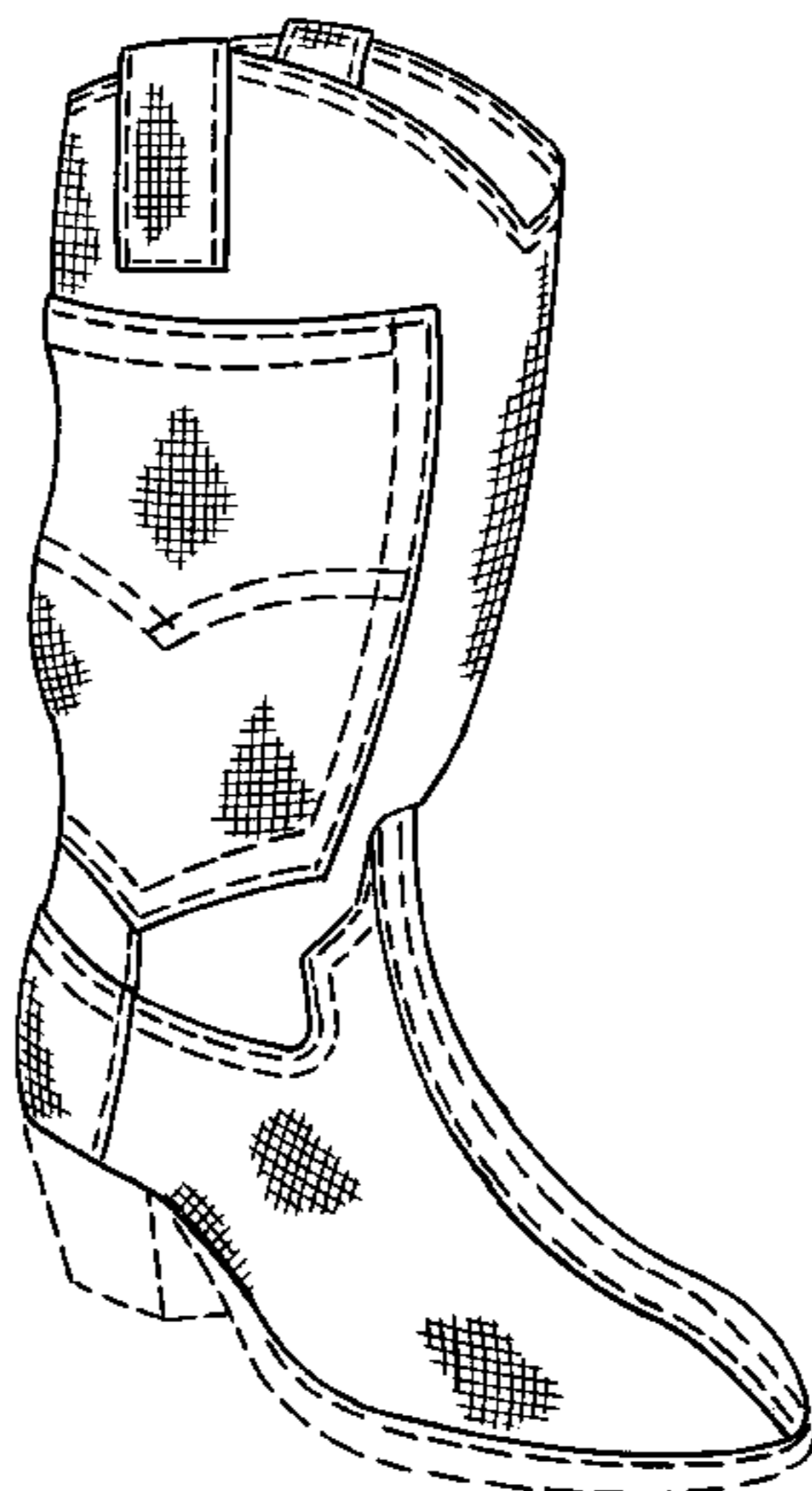
[57] **CLAIM**

FIG. 1 is a right side perspective view of a denim boot upper with side pocket, showing my new design;

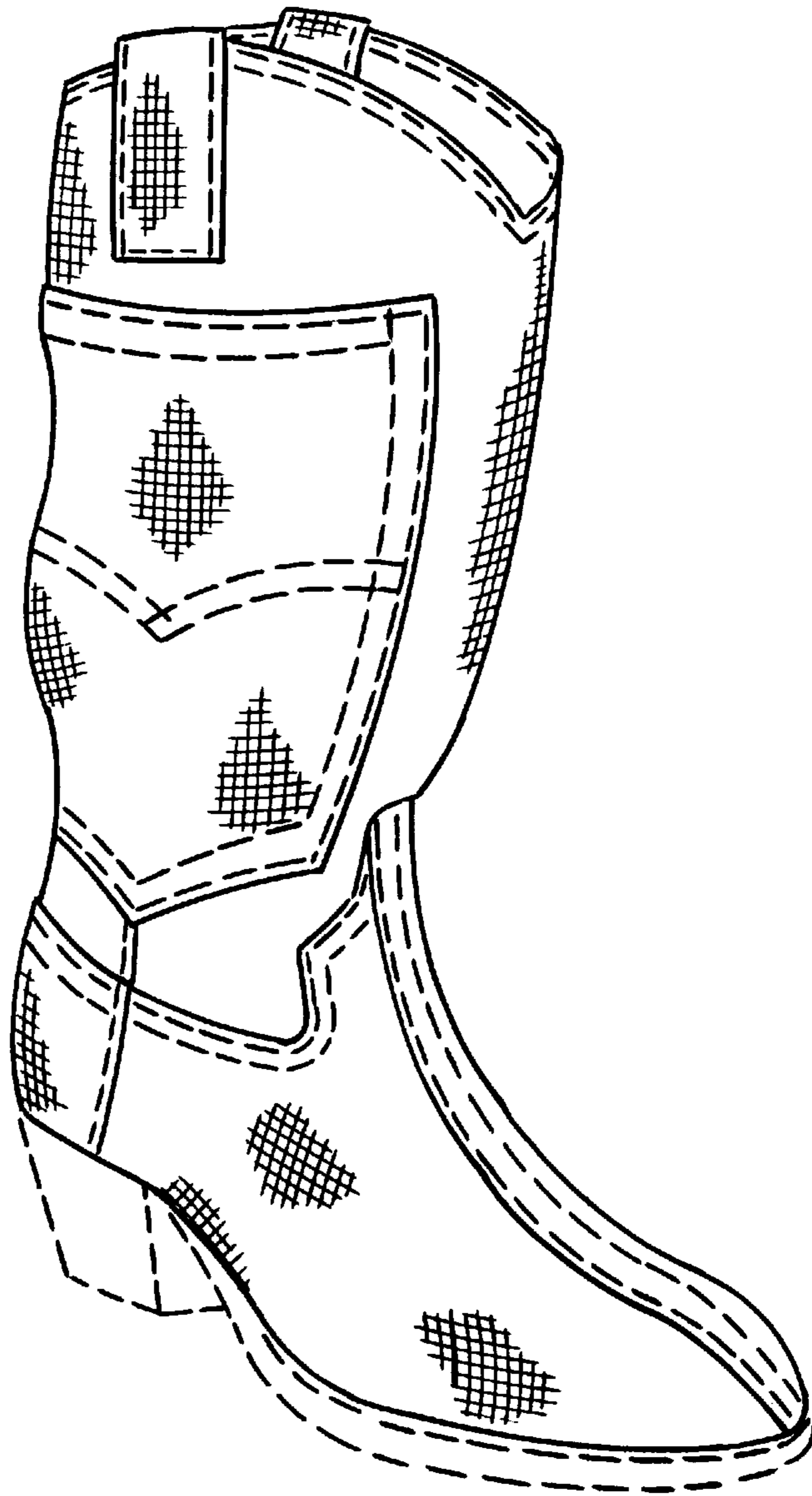

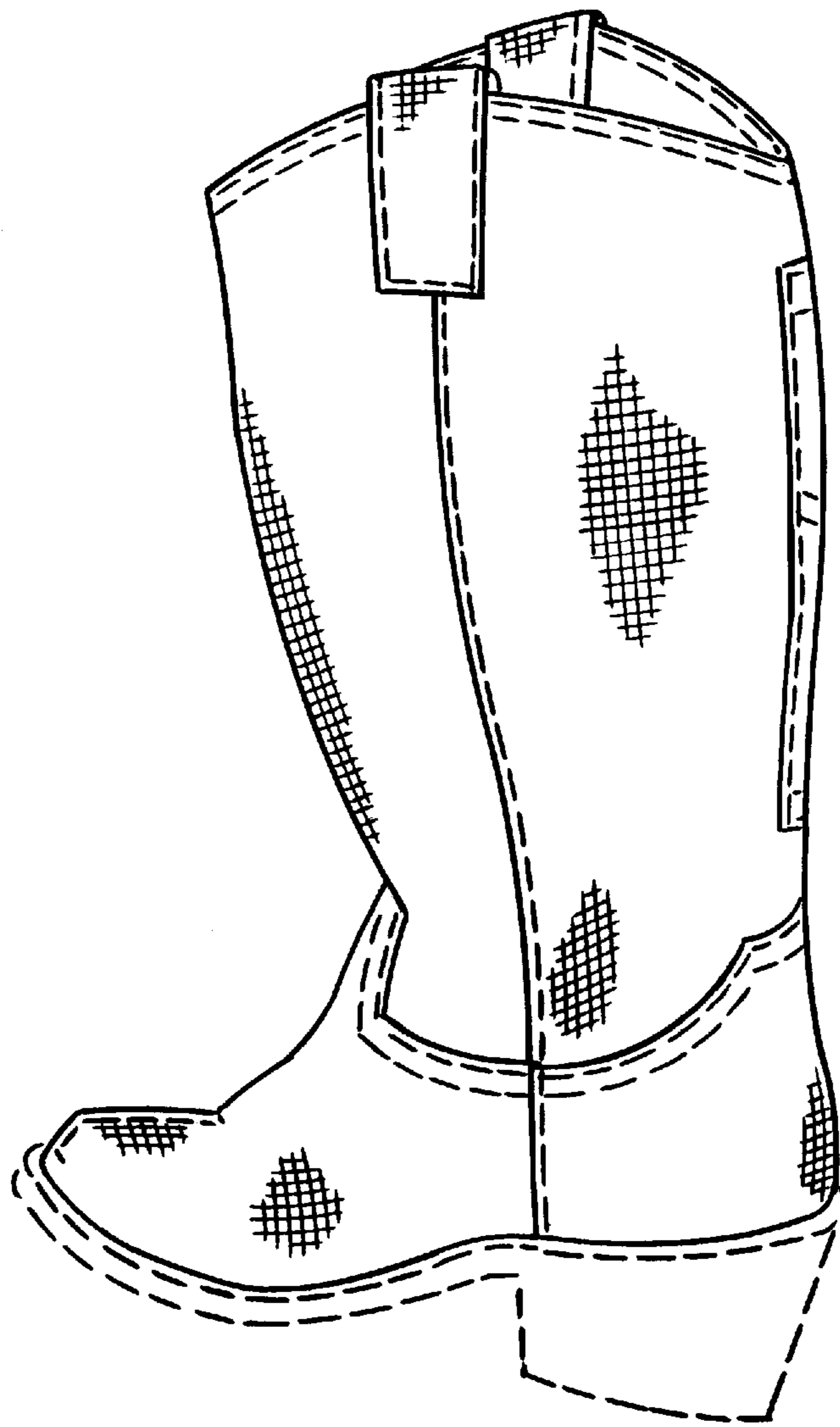

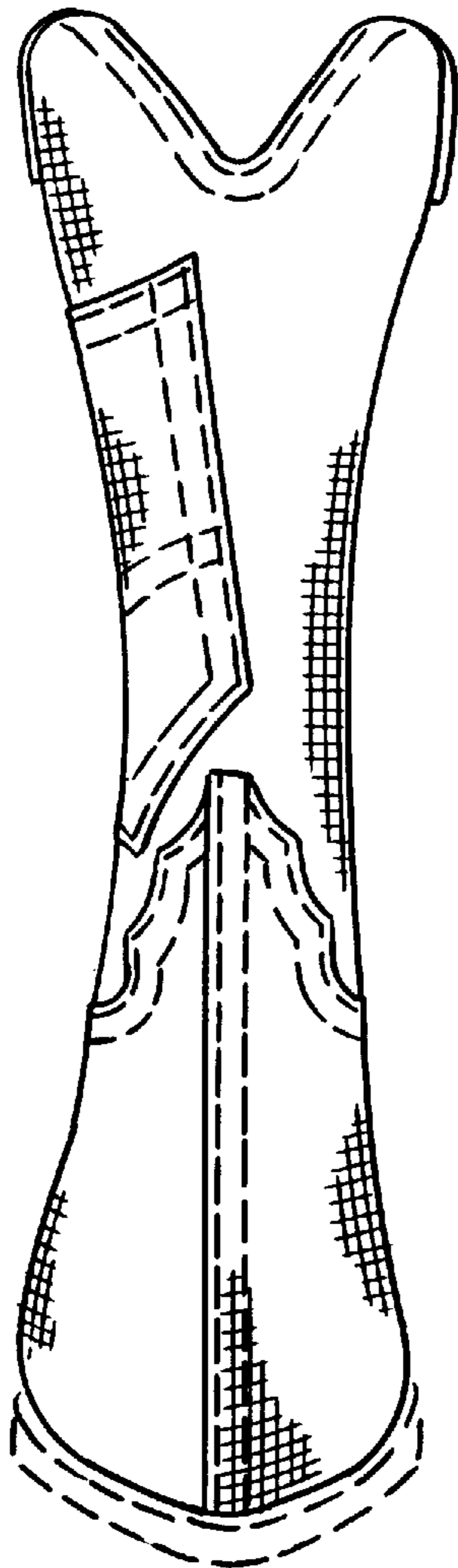
