The ornamental design for a night stand, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a night stand showing my new design;

FIG. 2 is a side elevational view thereof, the opposite side being identical thereto;

FIG. 3 is a top plan view thereof;

FIG. 4 is a front elevational view of a second embodiment of the night stand shown in FIG. 1;

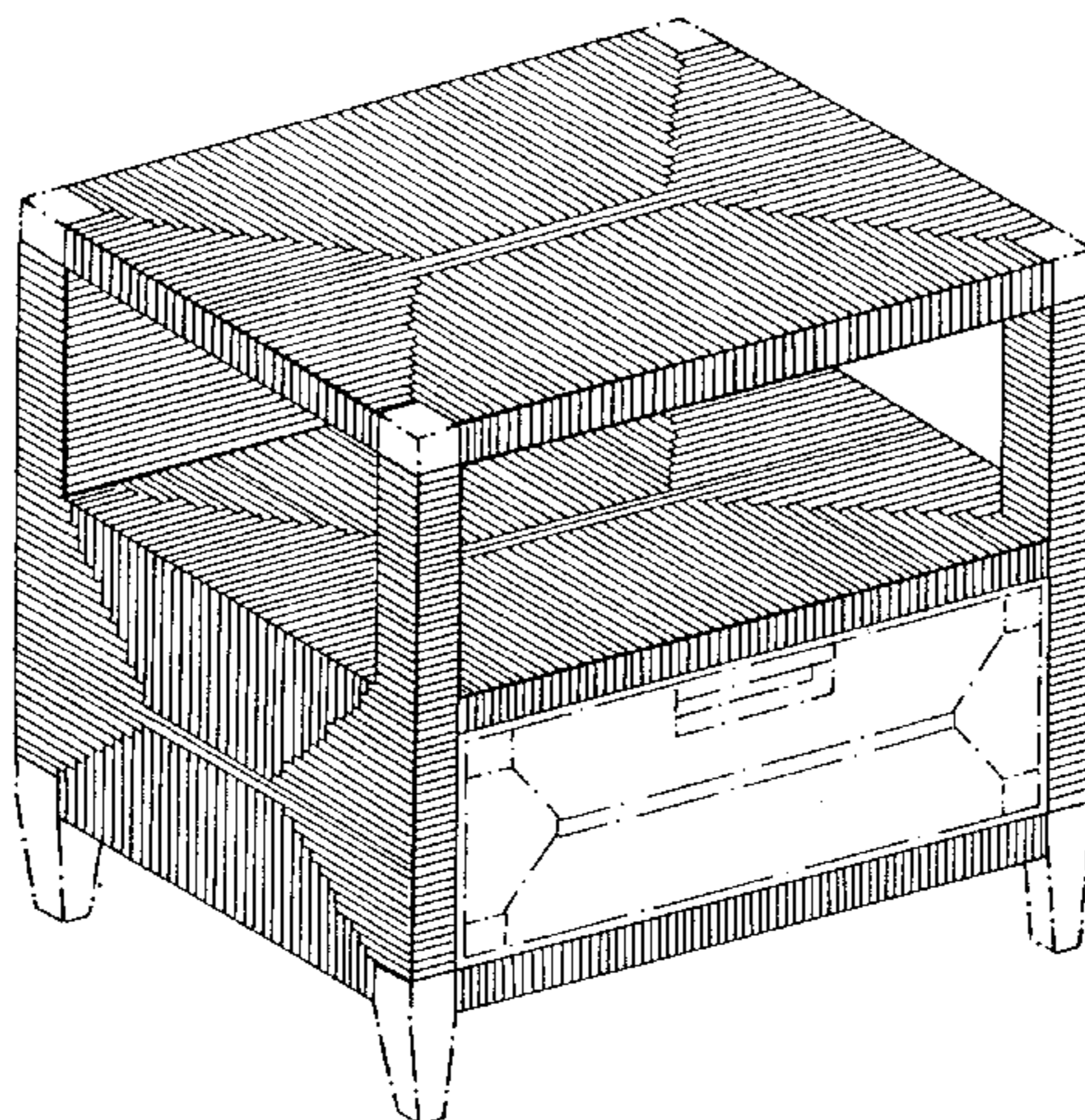
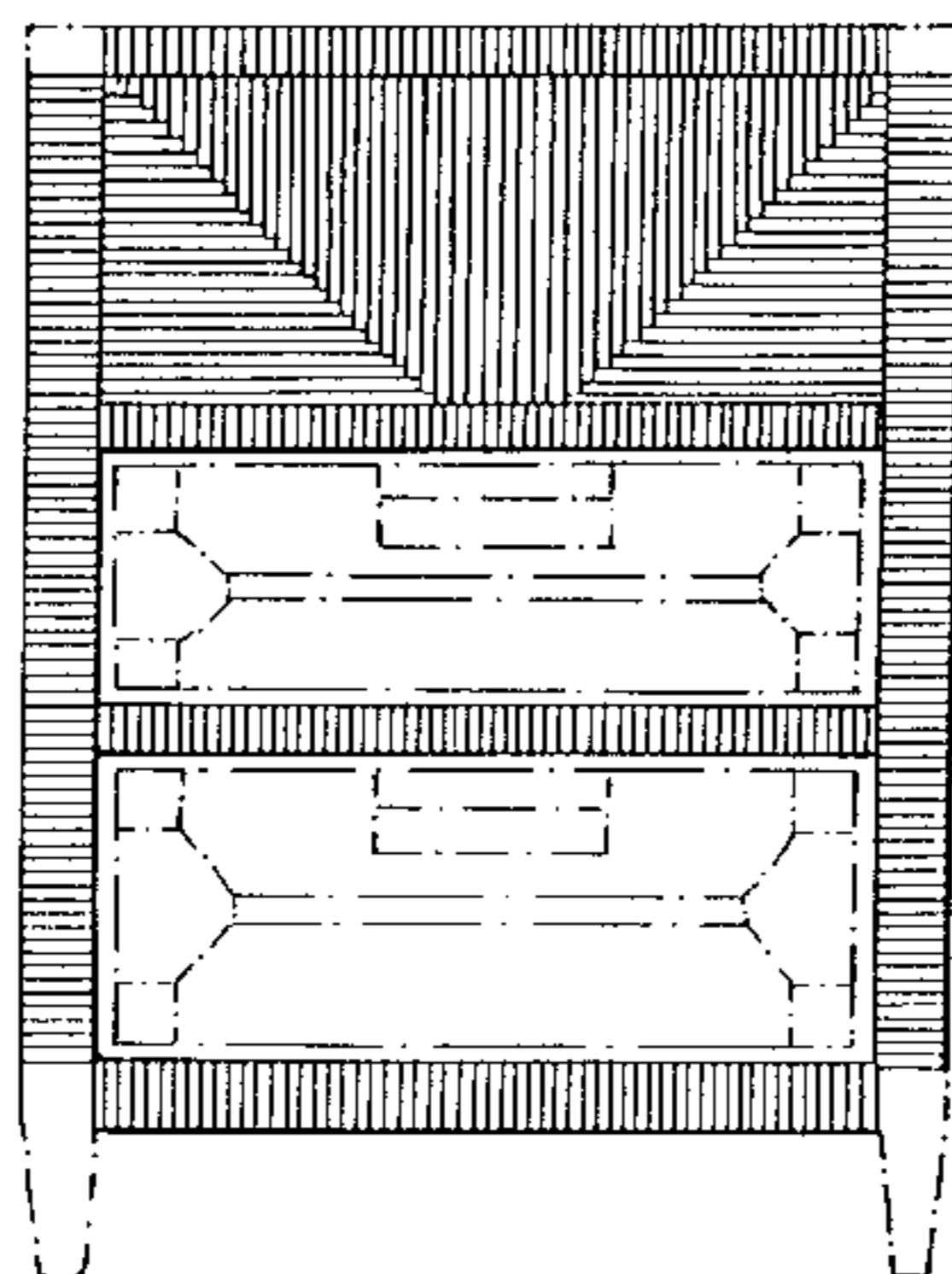
FIG. 5 is a side elevational view thereof, the opposite side being identical thereto;

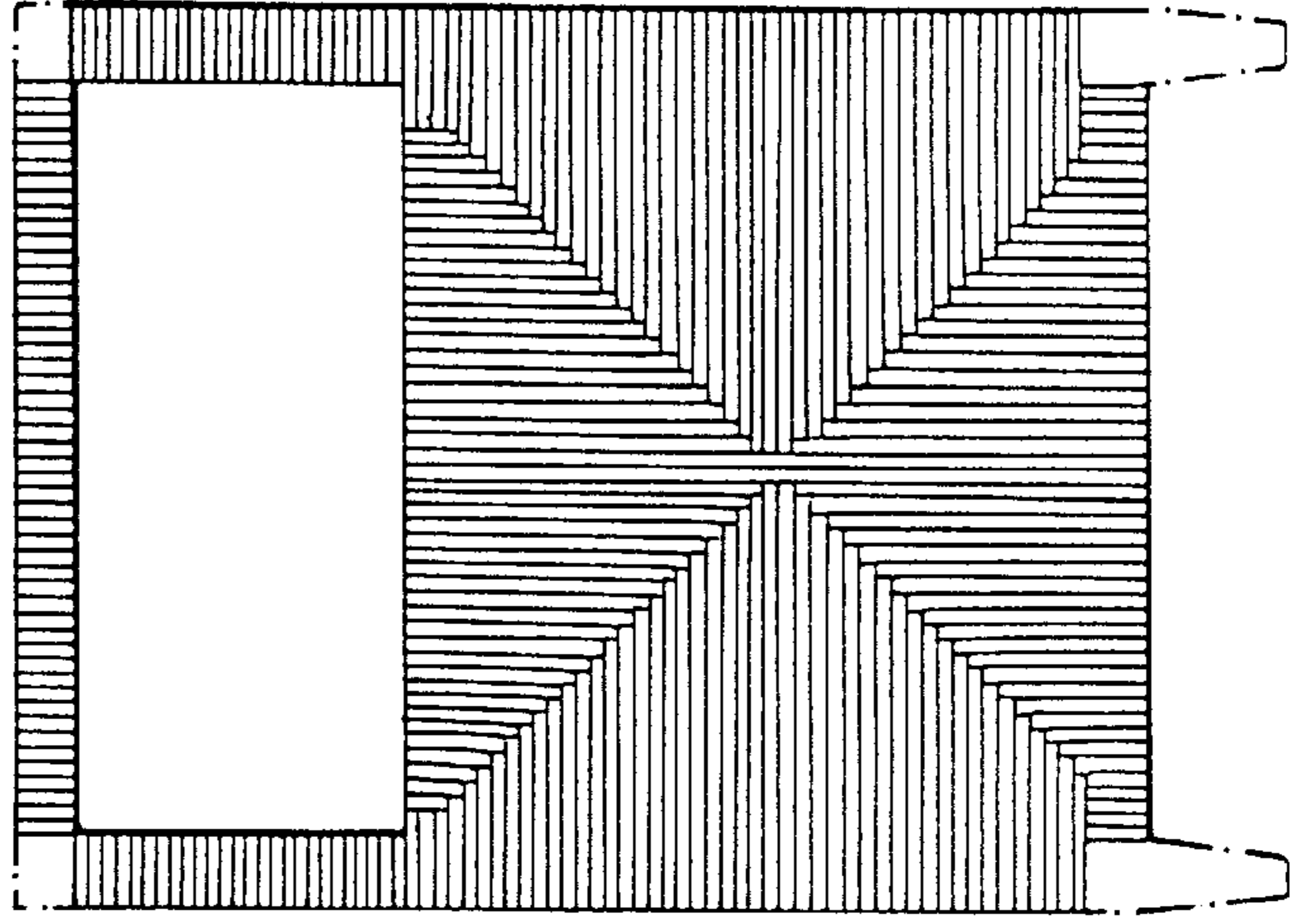

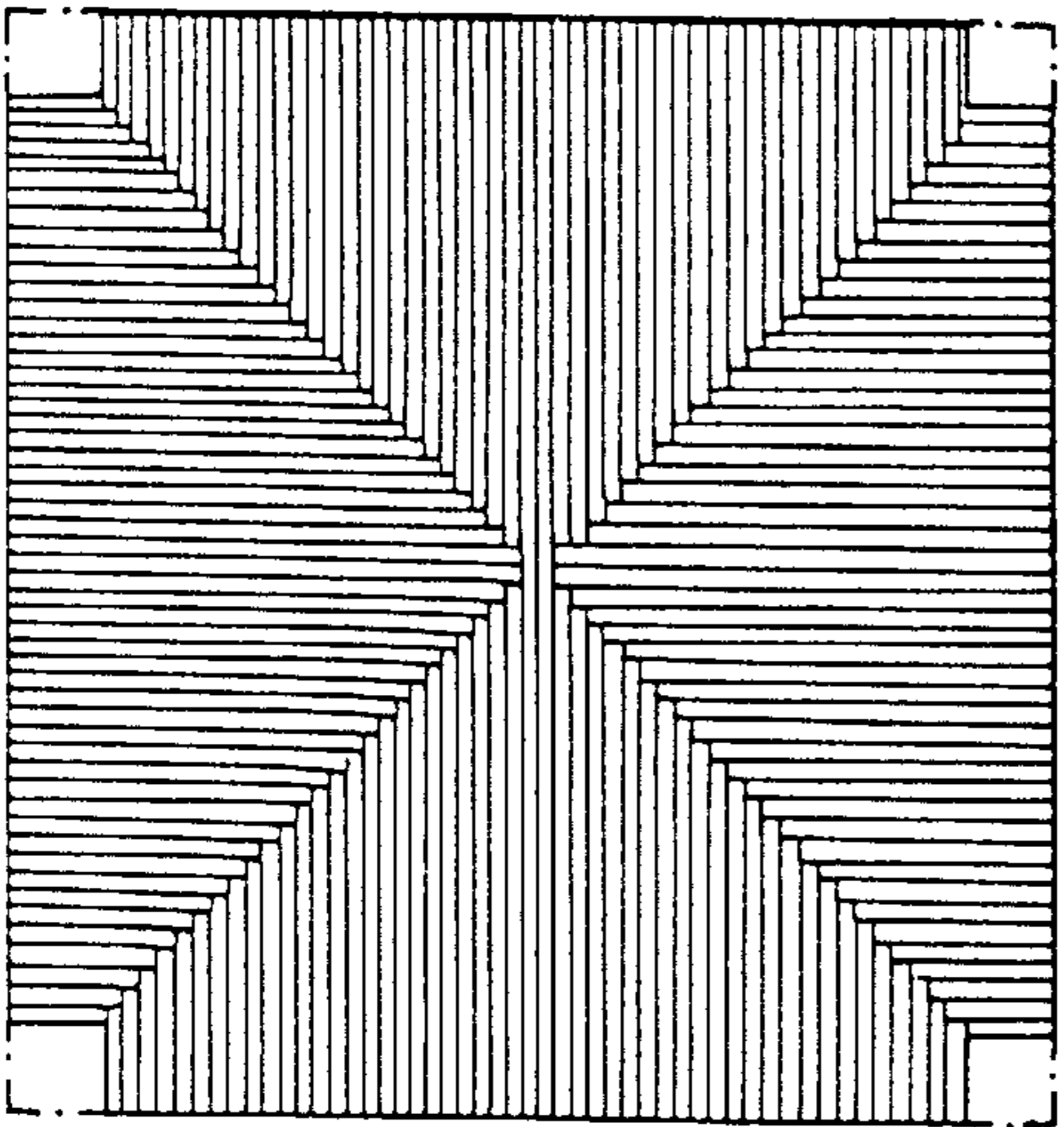

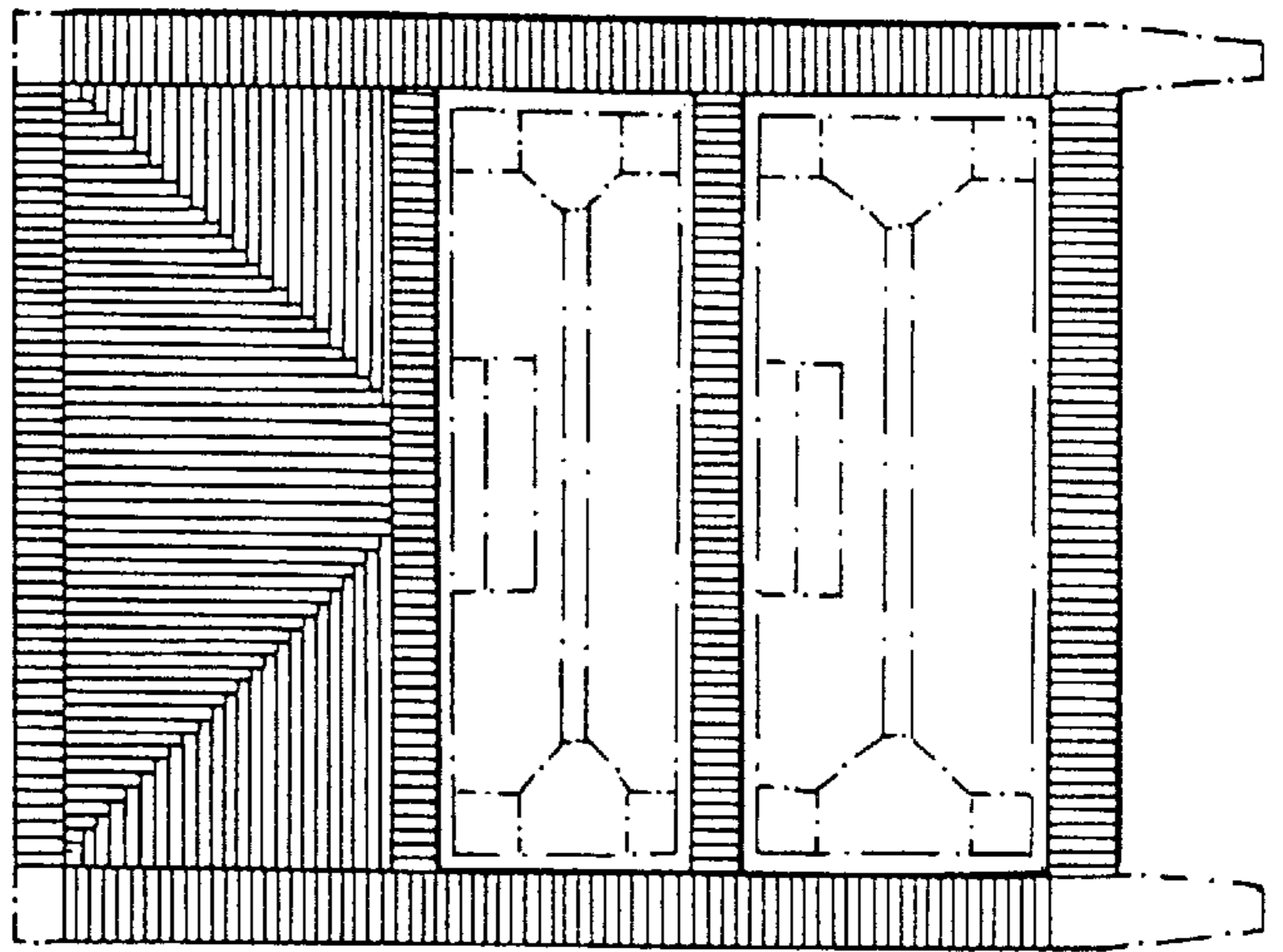

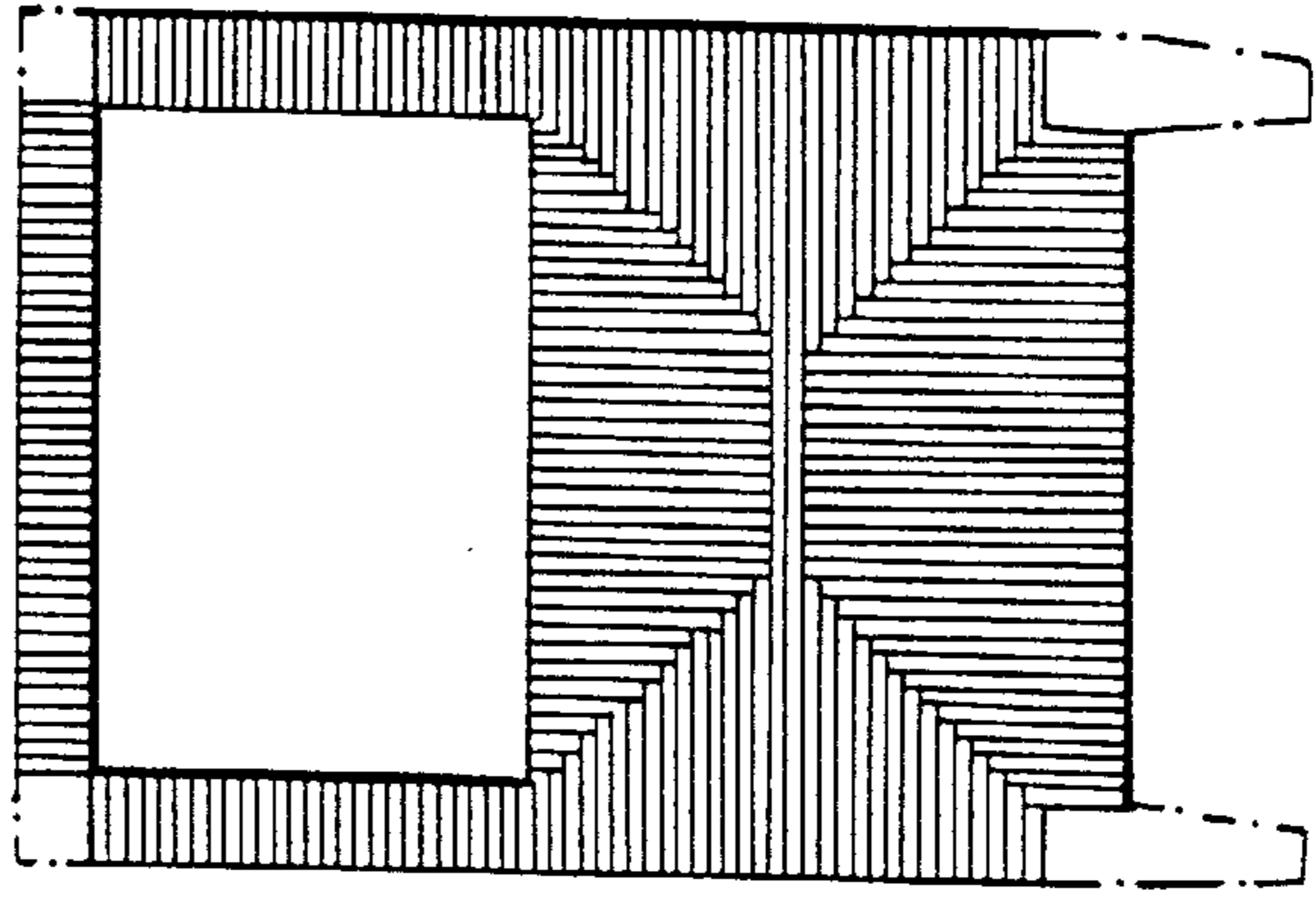

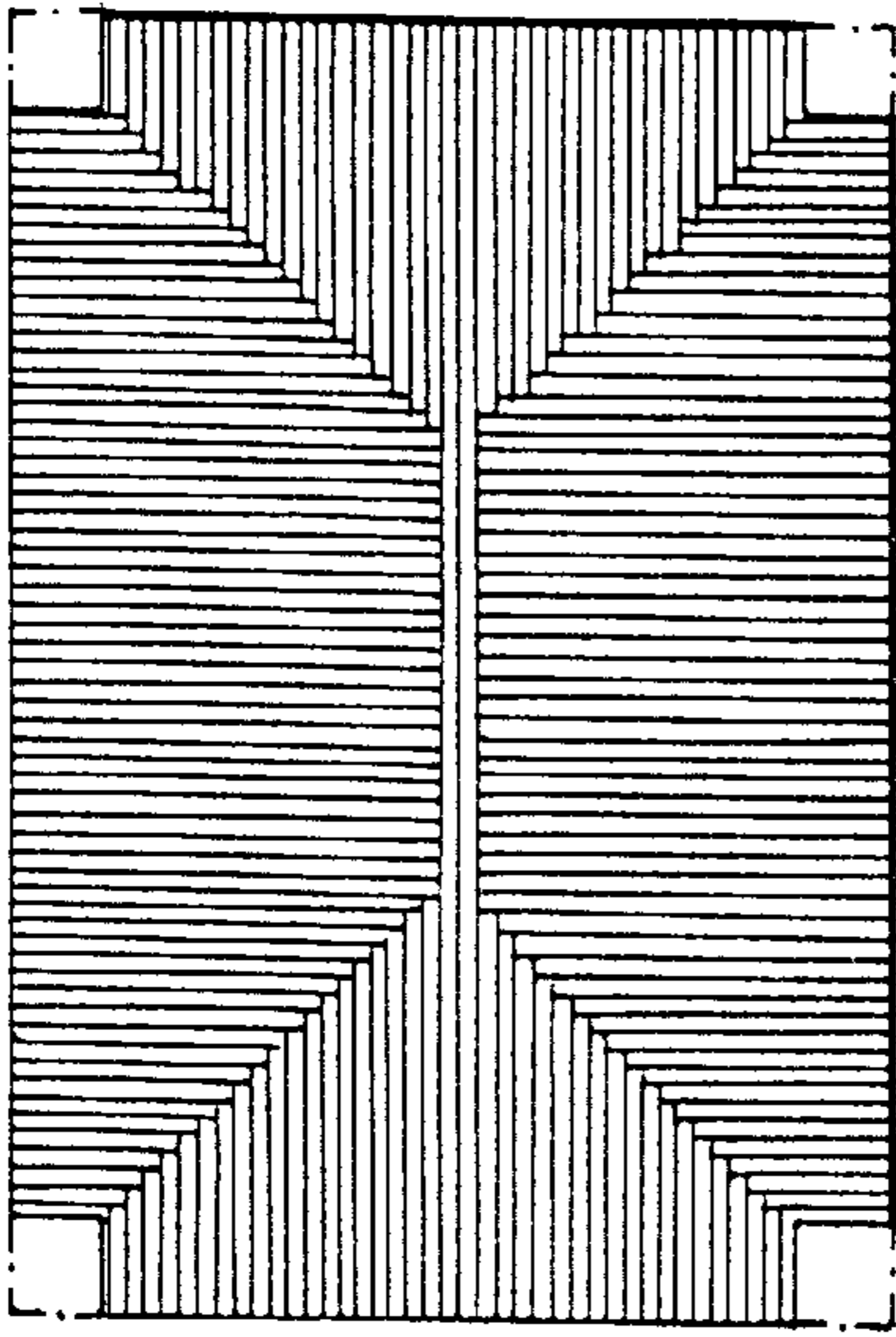

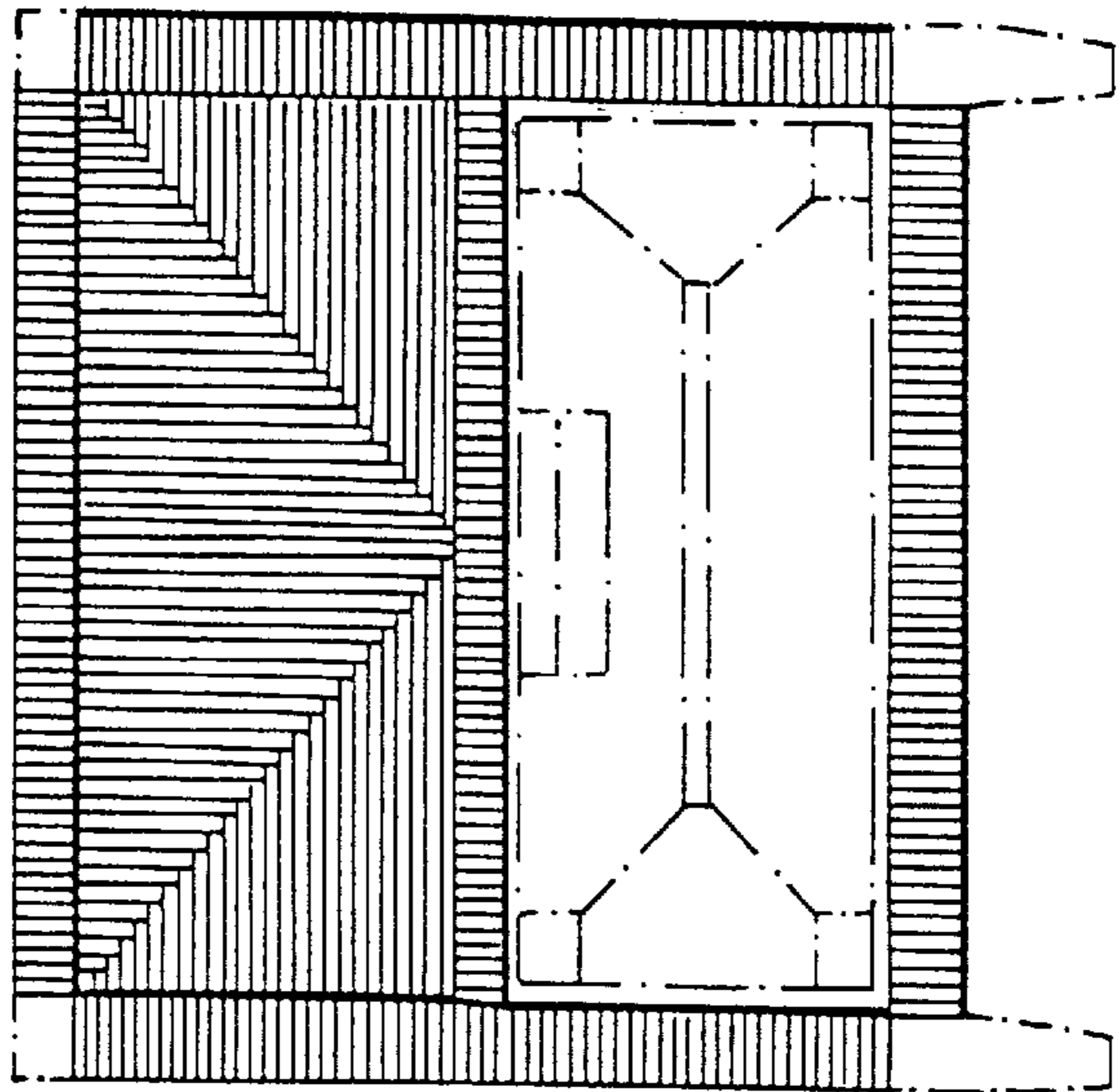

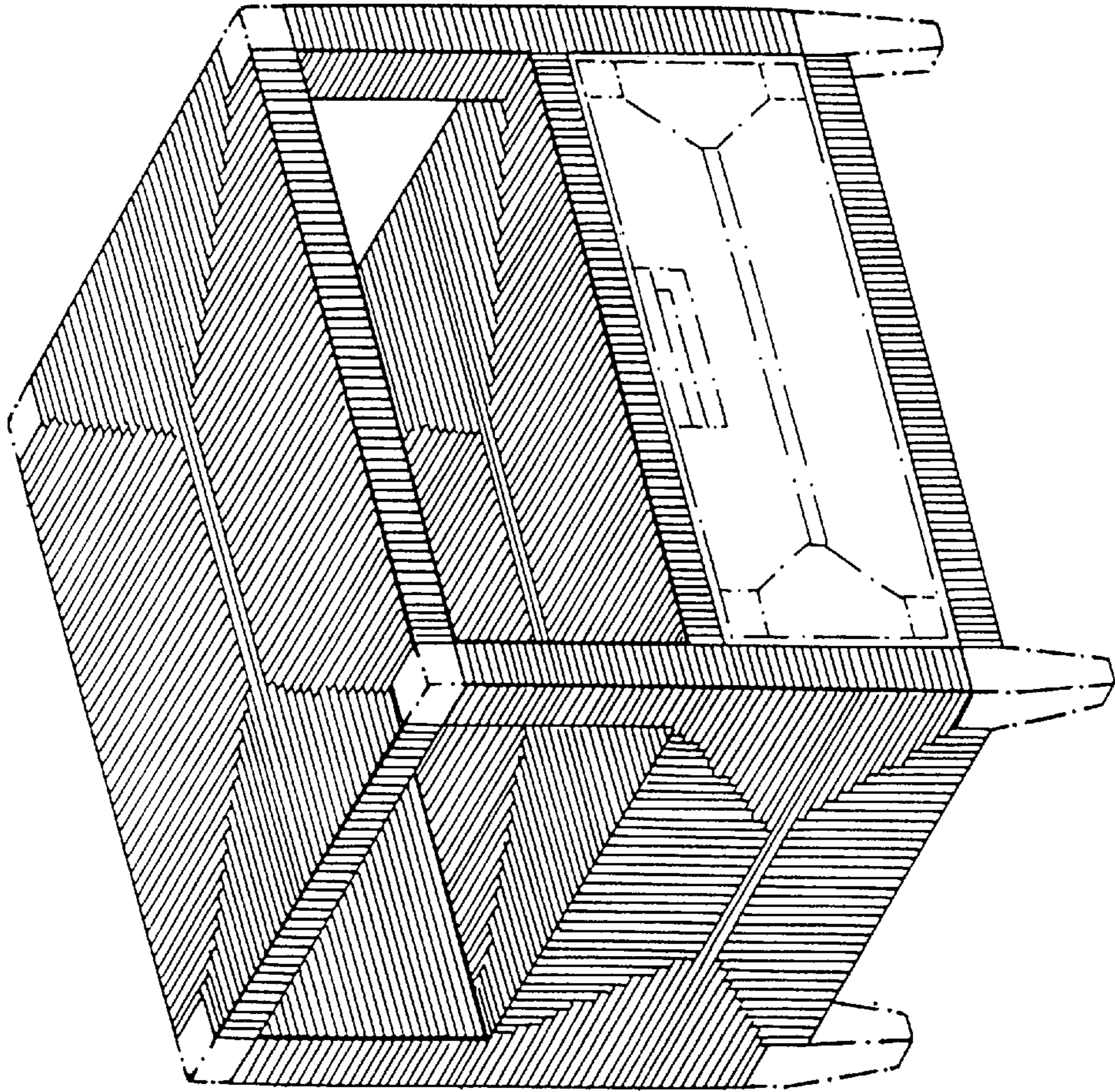
