**DESCRIPTION**

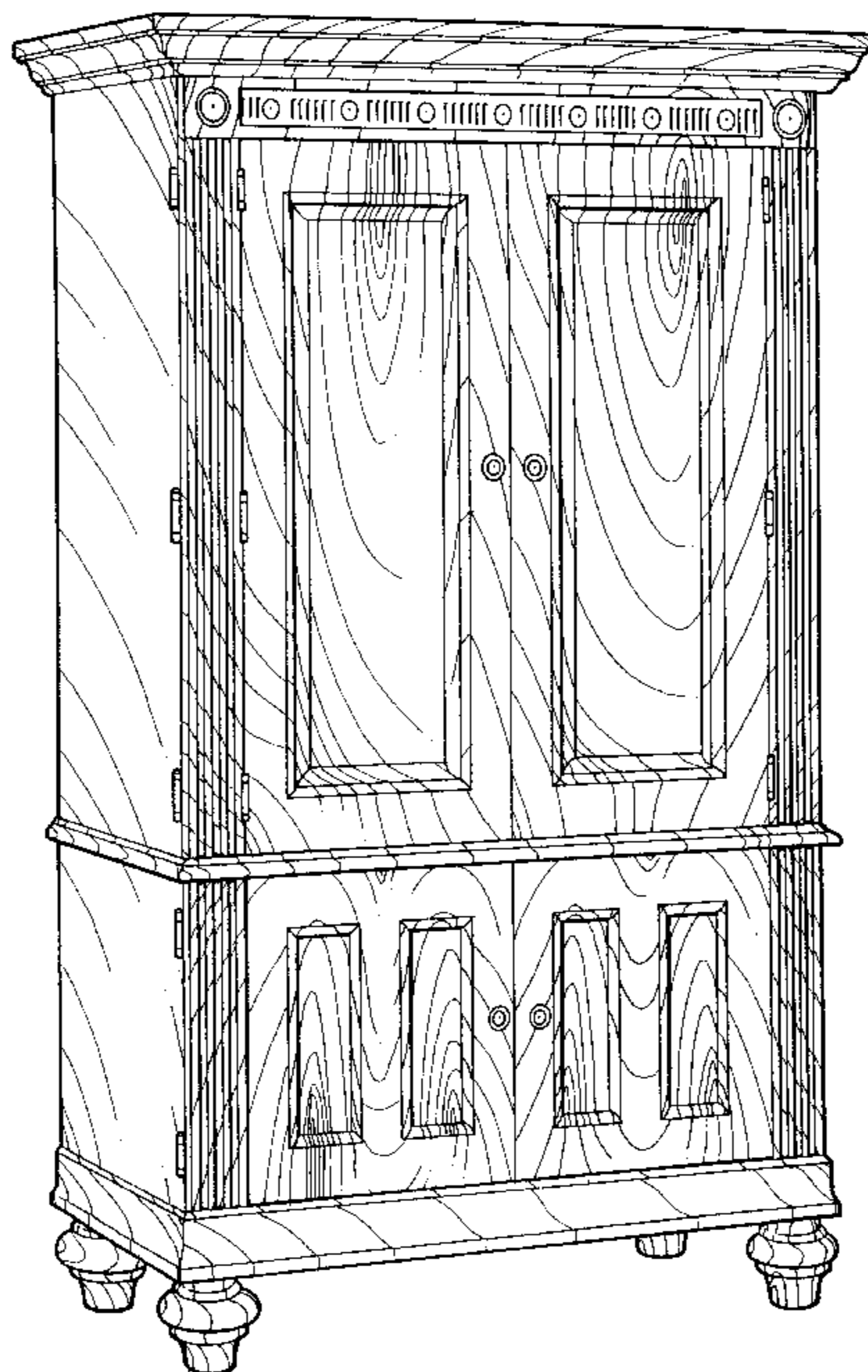
FIG. 1 is a front left perspective view of an entertainment center showing my new design;

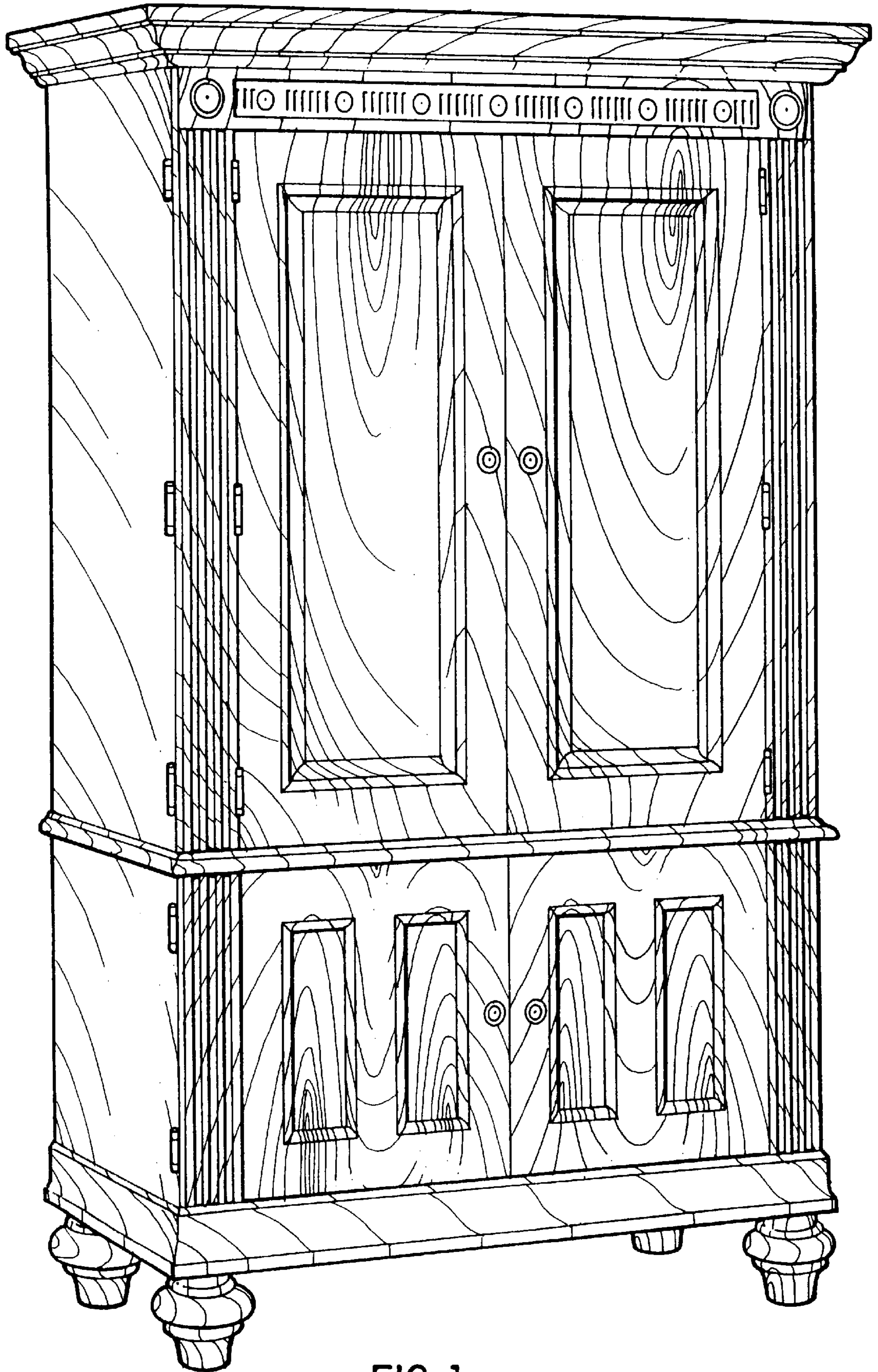

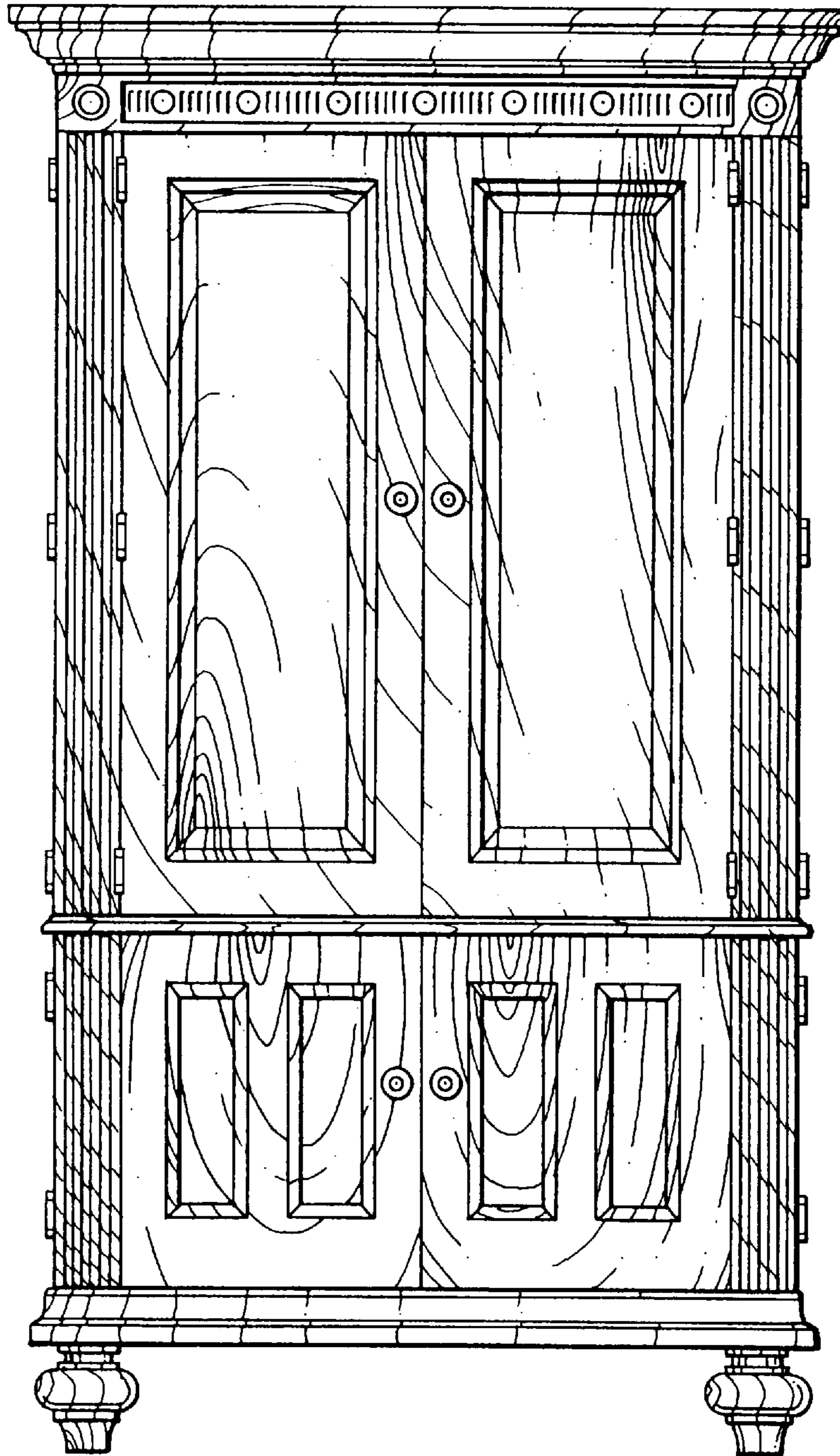

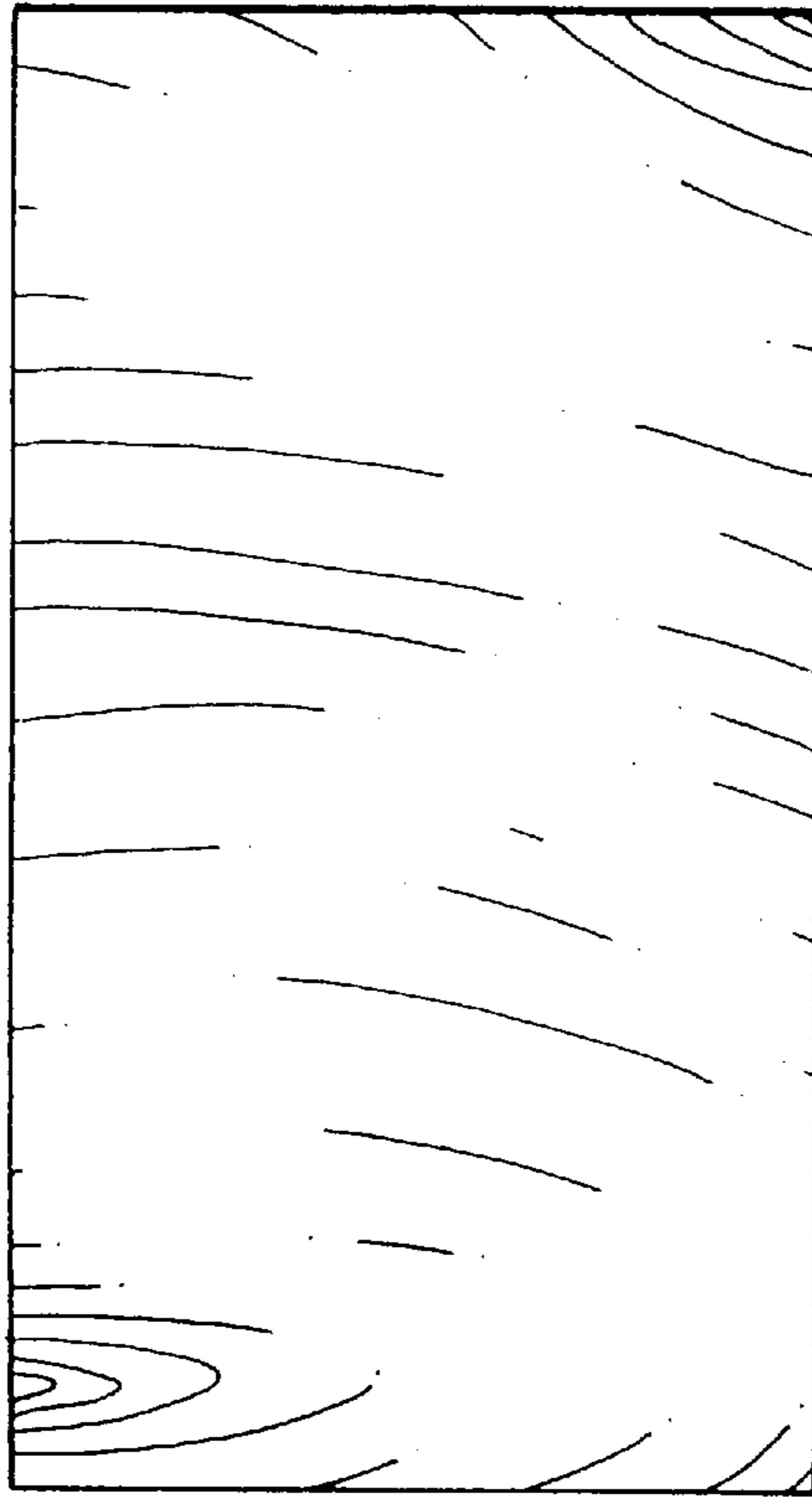

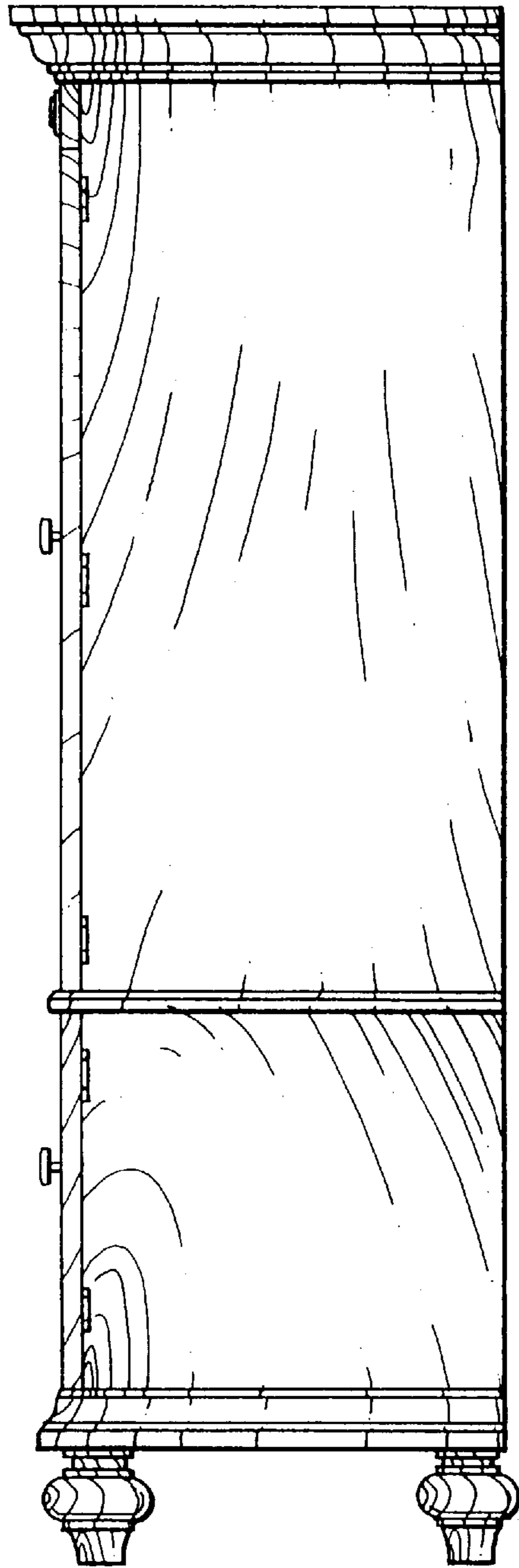
