
[57] CLAIM

The ornamental design for the bottle, as shown and described.

DESCRIPTION

FIG. 1 is a first perspective view of a bottle showing my new design, with an optional cap indicated by the phantom lines; FIG. 2 is a front view of the bottle of FIG. 1; FIG. 3 is a back view of the bottle of FIG. 1, taken from an angle opposite that of FIG. 2; FIG. 4 is a side elevation as seen from the right side of FIG. 2; FIG. 5 is a side elevation as seen from the left side of FIG. 2; FIG. 6 is a top view of the bottle of FIG. 1; and, FIG. 7 is a bottom view of the bottle of FIG. 1. The broken lines showing the cap in FIG. 1 are for illustrative purposes only and do not form part of the claimed design.














