[57] **CLAIM**

The ornamental design for a concrete saw with stabilized carriage and blade control, as shown.

**DESCRIPTION**

FIG. 1 is a right front perspective view of my new saw; FIG. 2 is a left front perspective view; FIG. 3 is an enlarged right side elevational view thereof; FIG. 4 is an enlarged left side elevational view thereof; FIG. 5 is an enlarged front elevational view thereof; FIG. 6 is a bottom plan view; and, FIG. 7 is a top plan view.

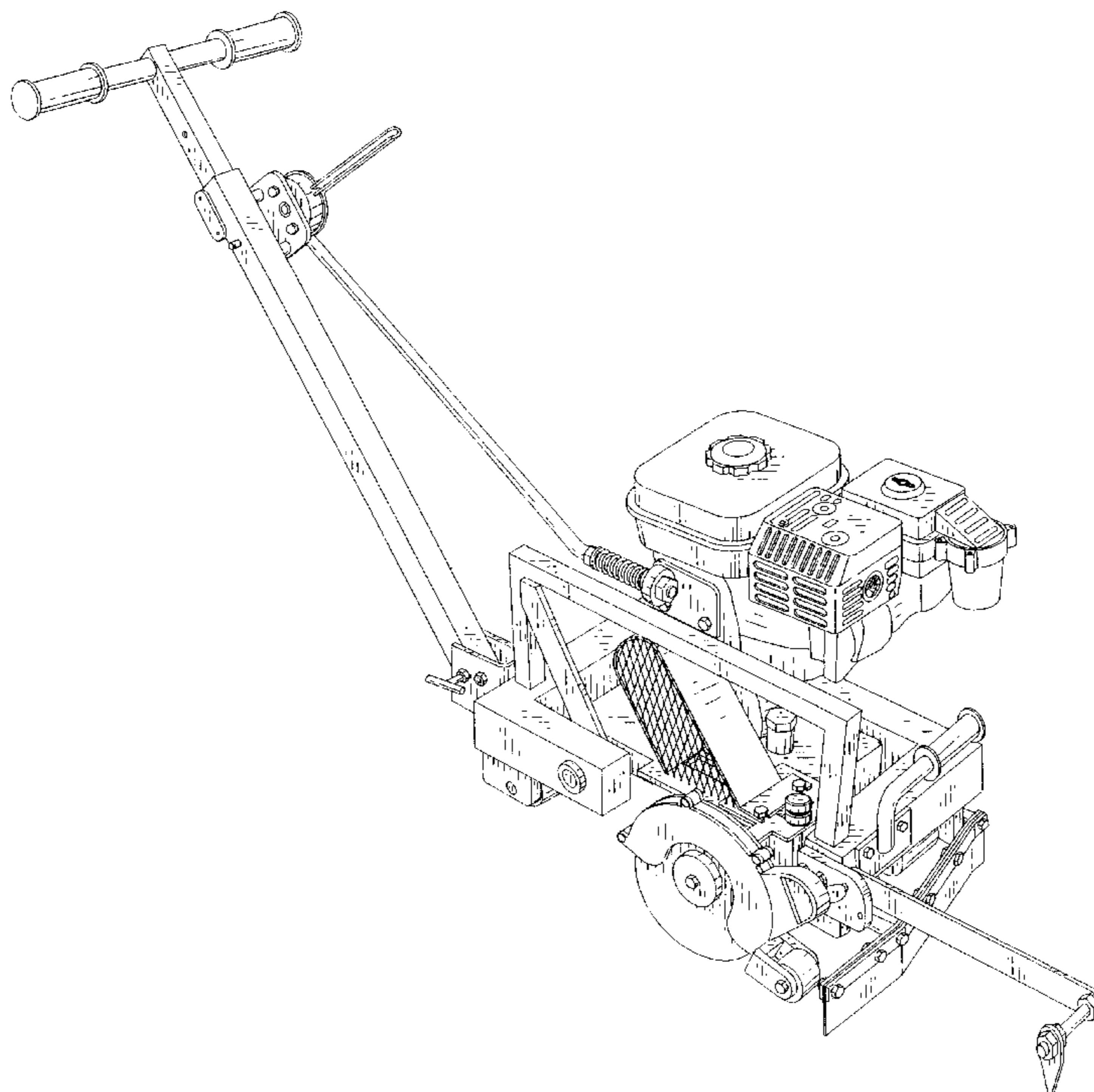

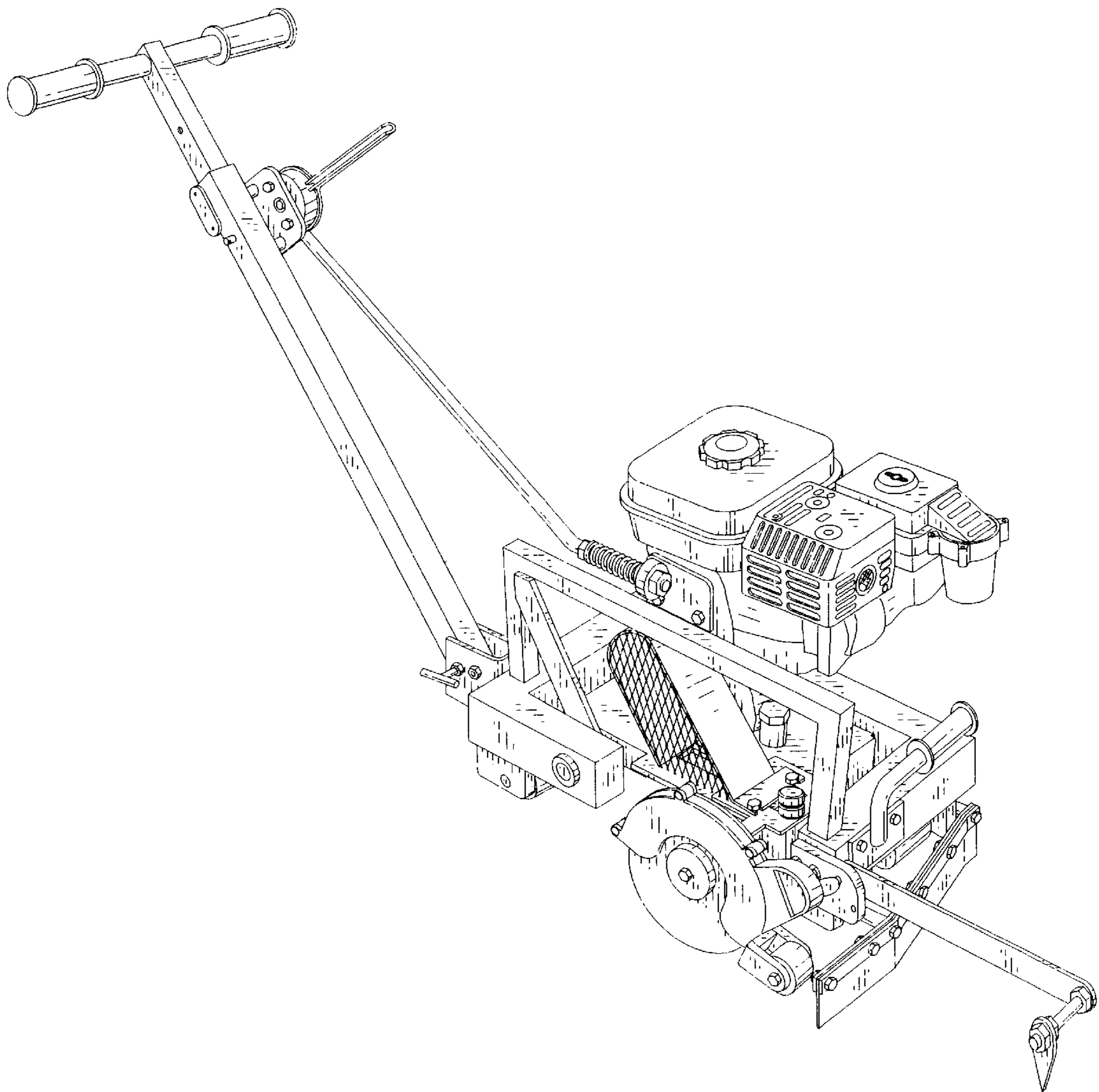

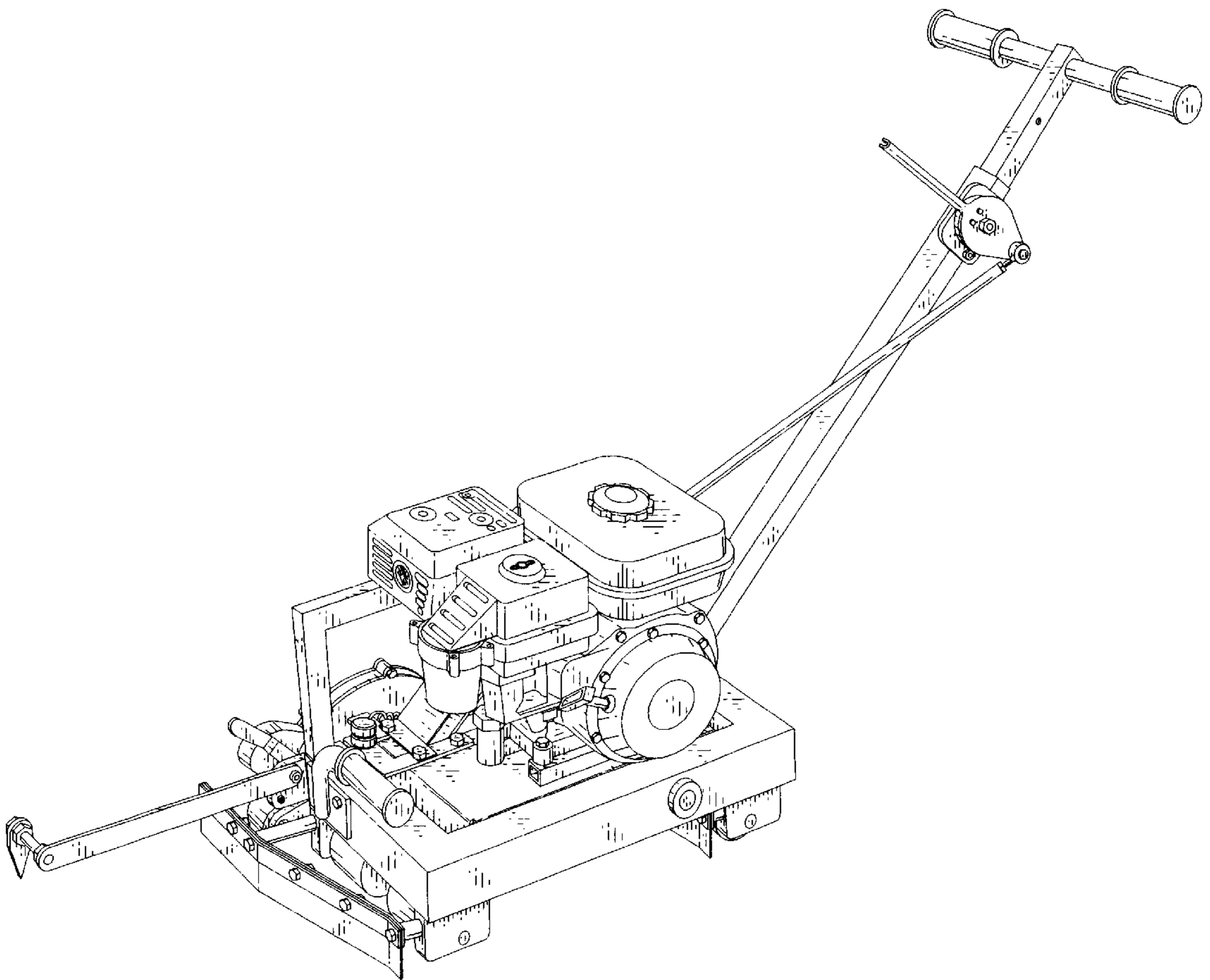
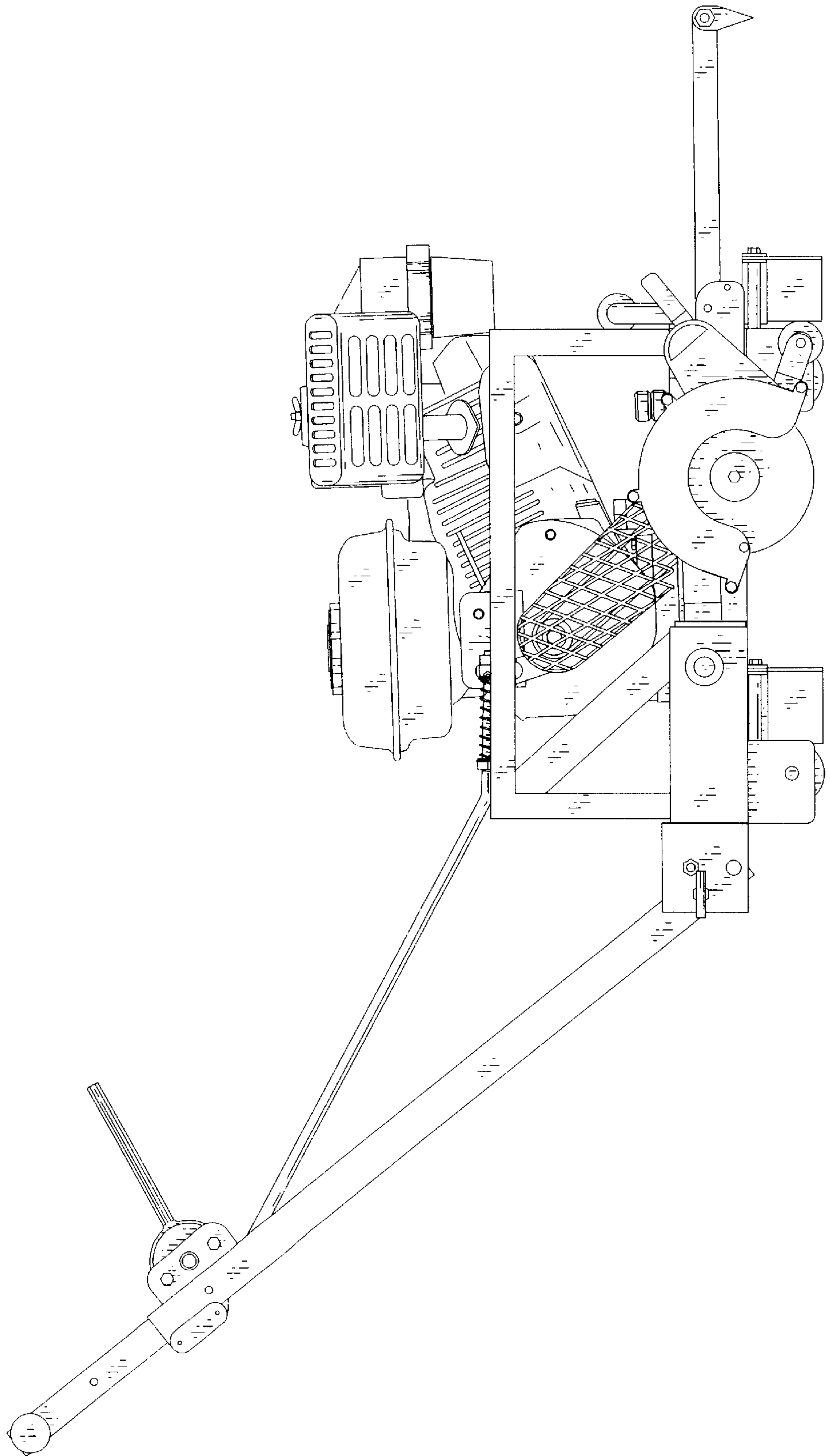

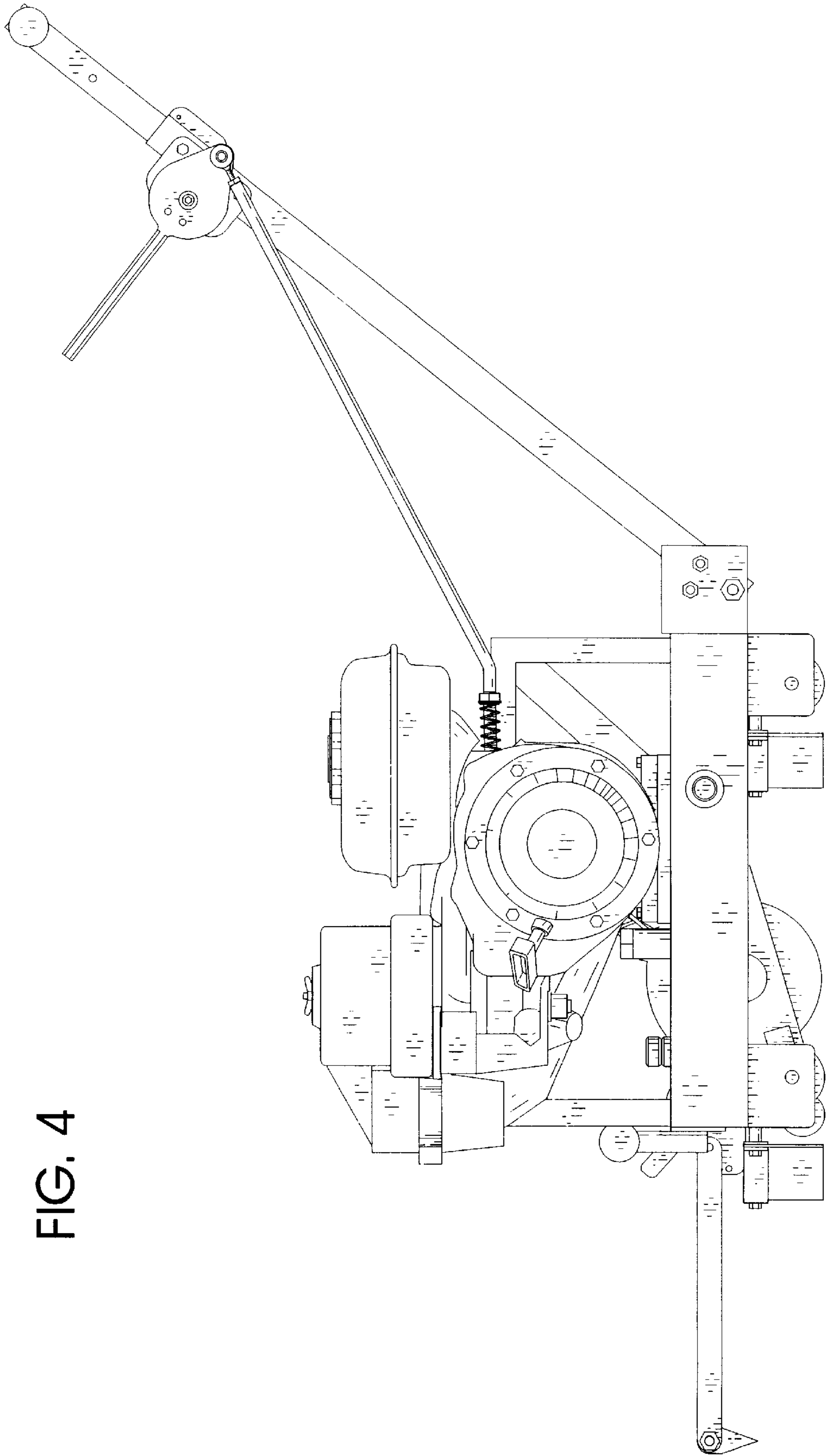

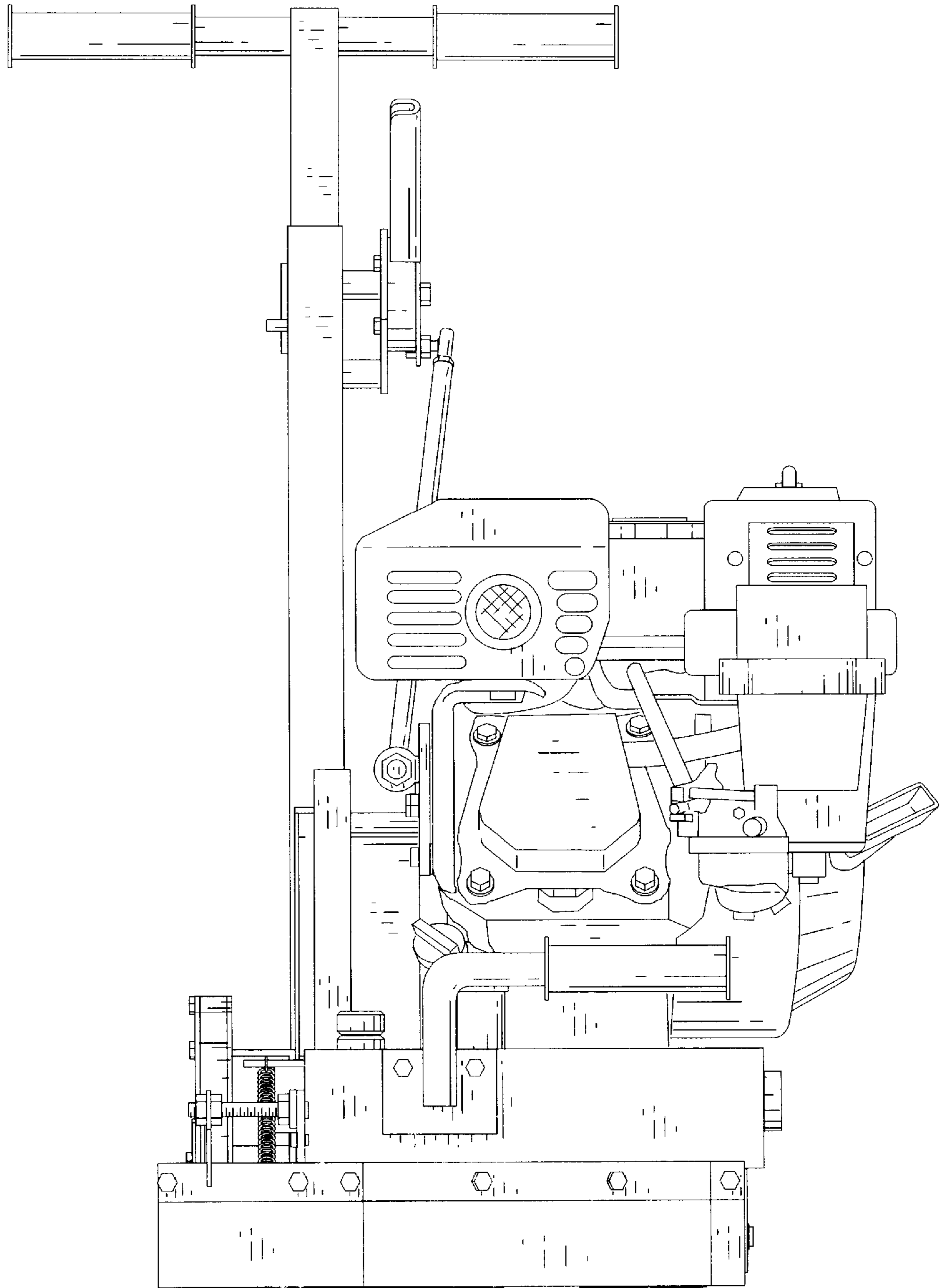

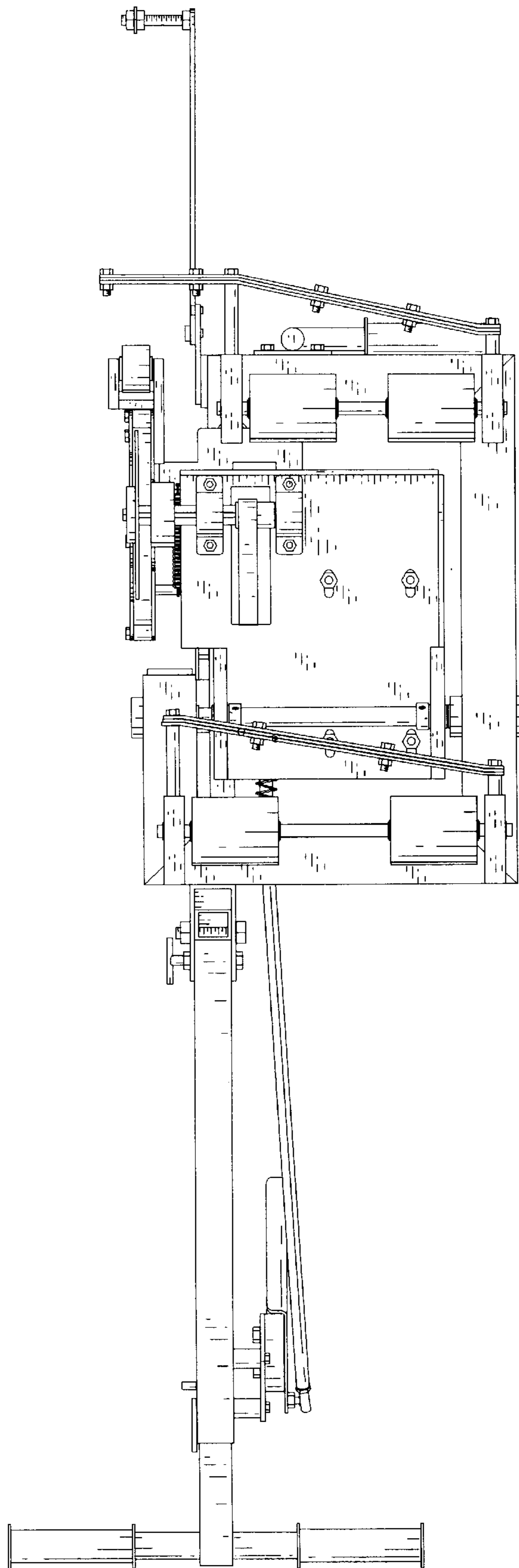
