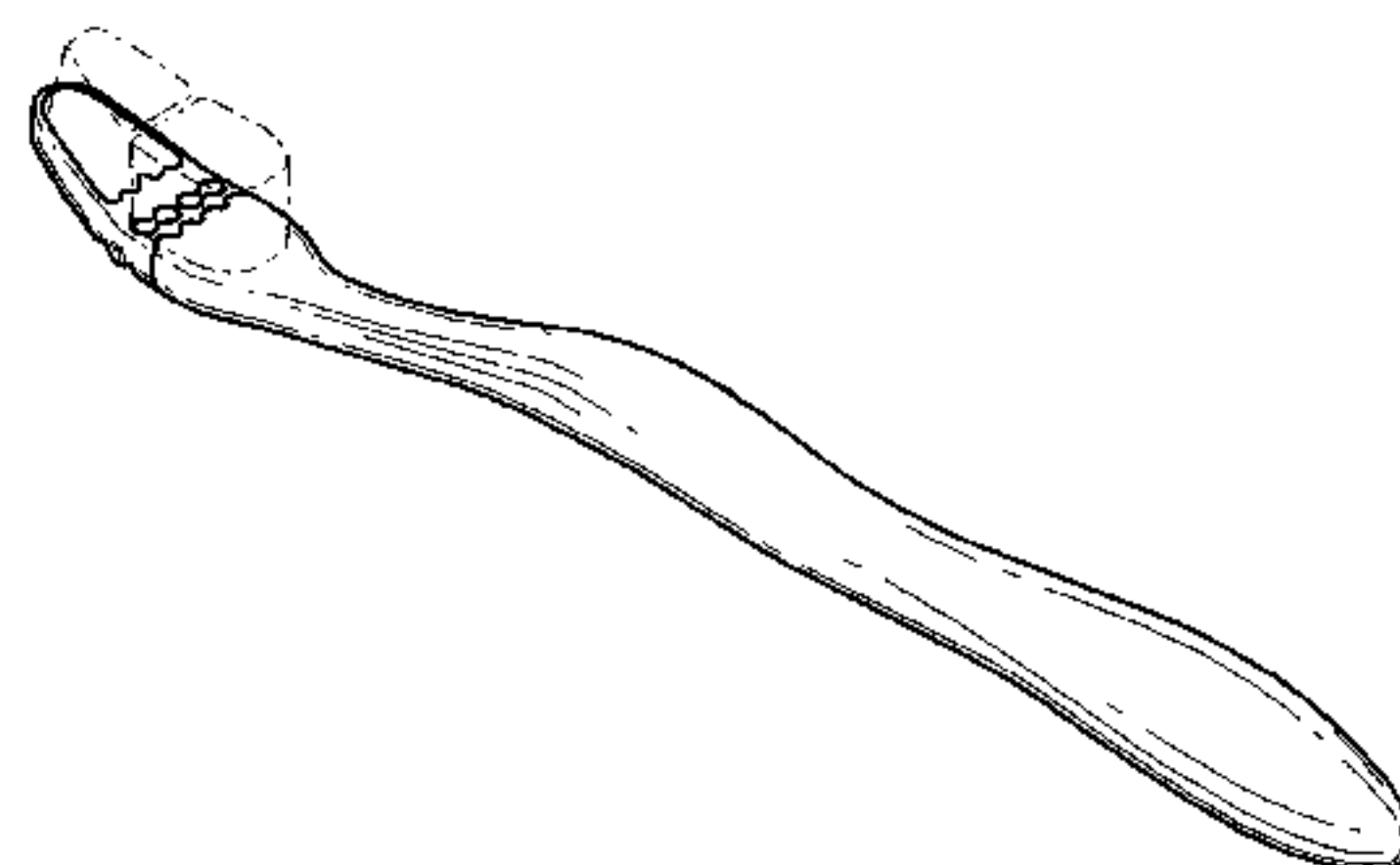
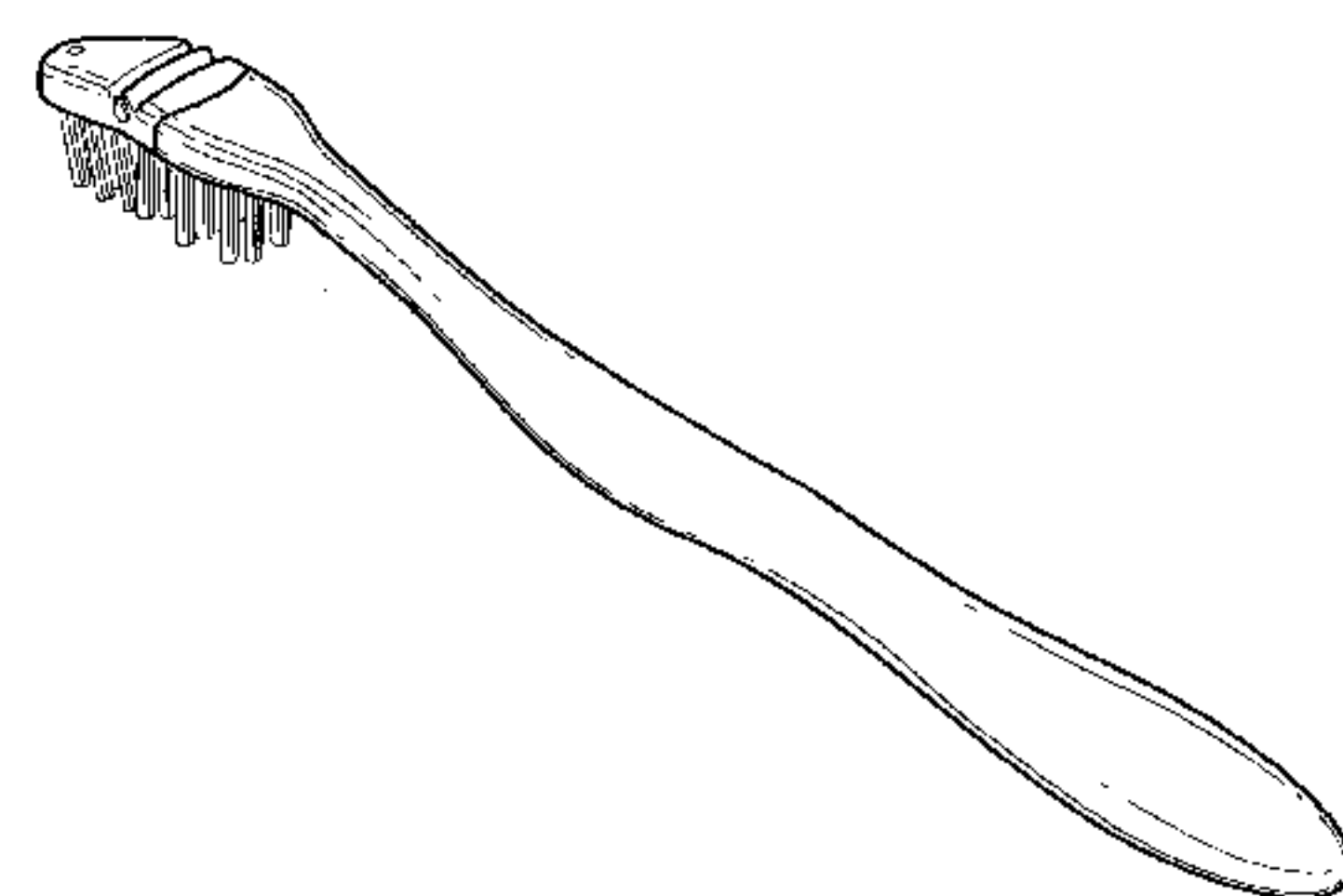
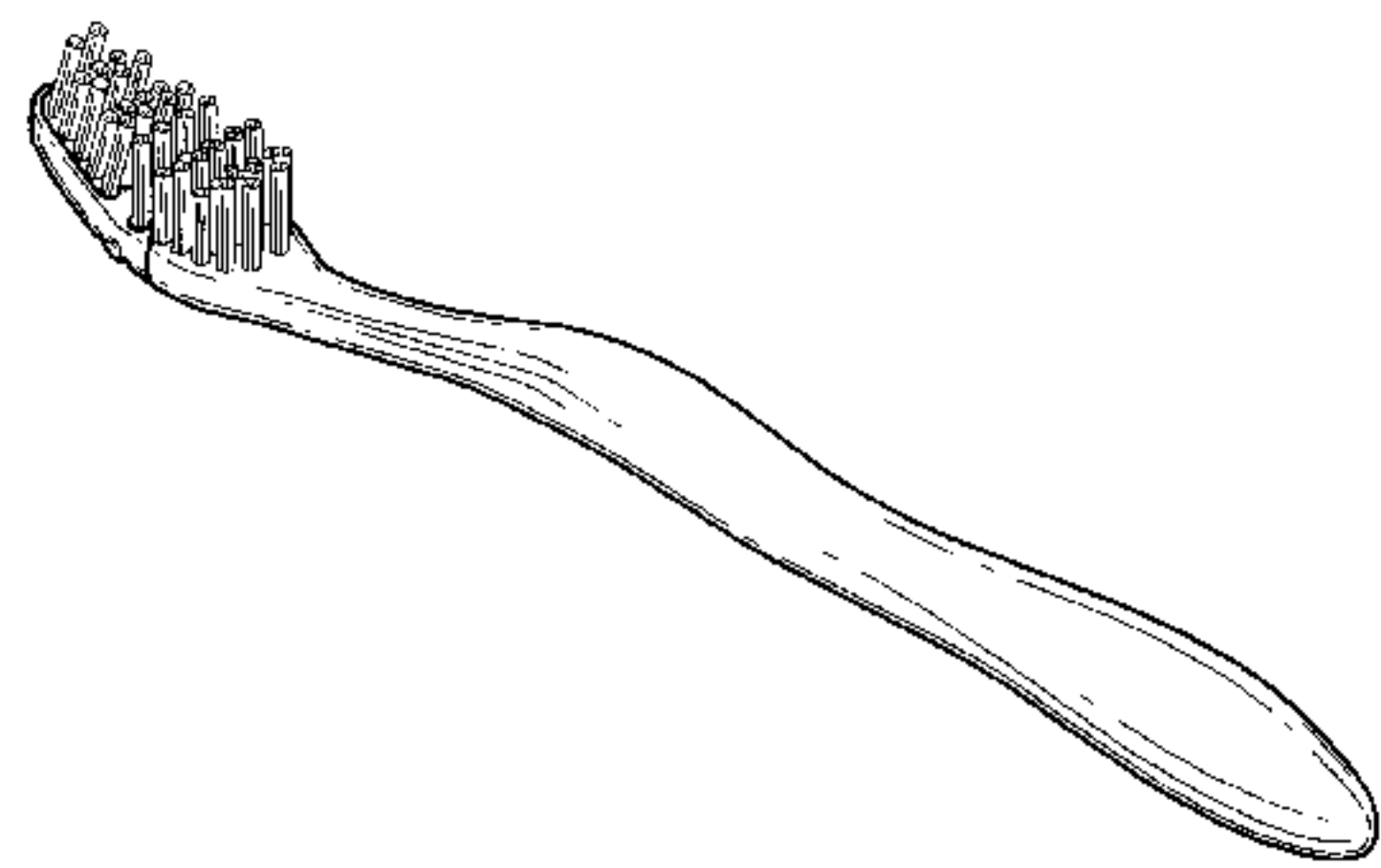

[57] **CLAIM**

The ornamental design for a toothbrush, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of a toothbrush showing my new design;  
 FIG. 2 is a left side elevational view thereof;  
 FIG. 3 is a bottom plan view thereof;  
 FIG. 4 is a right side elevation view thereof;  
 FIG. 5 is an elevational view as seen from the head end thereof;  
 FIG. 6 is an elevational view as seen from the handle end thereof;  
 FIG. 7 is a perspective view thereof from the top of the brush;  
 FIG. 8 is a perspective view thereof from the bottom of the brush;  
 FIG. 9 is a top plan view of a second embodiment of the design shown in FIGS. 1-8;  
 FIG. 10 is a left side elevational view thereof;  
 FIG. 11 is a bottom plan view thereof;  
 FIG. 12 is a right side elevation view thereof;  
 FIG. 13 is an elevational view as seen from the head end thereof;  
 FIG. 14 is an elevational view as seen from the handle end thereof;  
 FIG. 15 is a perspective view thereof from the top of the brush;  
 FIG. 16 is a perspective view thereof from the bottom of the brush;  
 FIG. 17 is a top plan view of a third embodiment showing the toothbrush handle of FIGS. 1-16;  
 FIG. 18 is a left side elevational view thereof;  
 FIG. 19 is a bottom plan view thereof;  
 FIG. 20 is a right side elevation view thereof;  
 FIG. 21 is an elevational view as seen from the head end thereof;  
 FIG. 22 is an elevational view as seen from the handle end thereof;  
 FIG. 23 is a perspective view thereof from the top of the handle; and,  
 FIG. 24 is a perspective view thereof from the bottom of the handle.

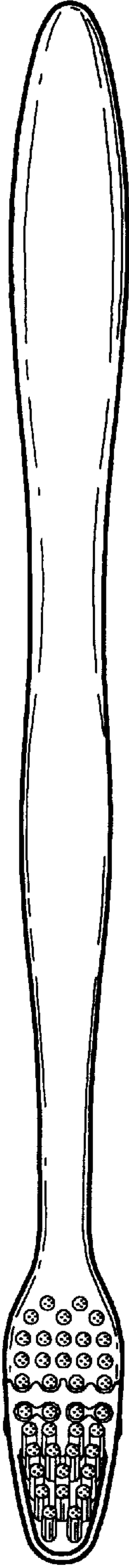

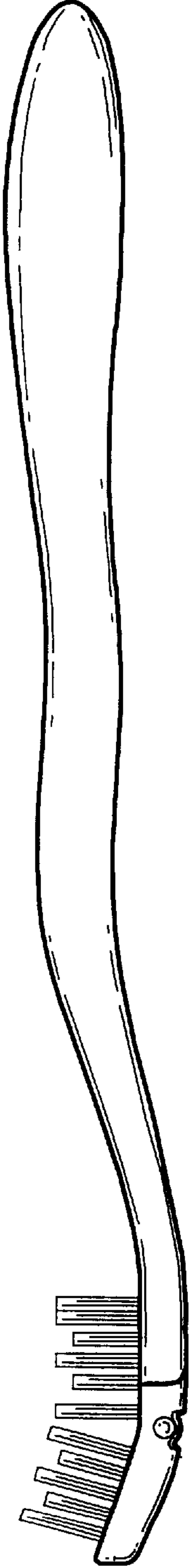

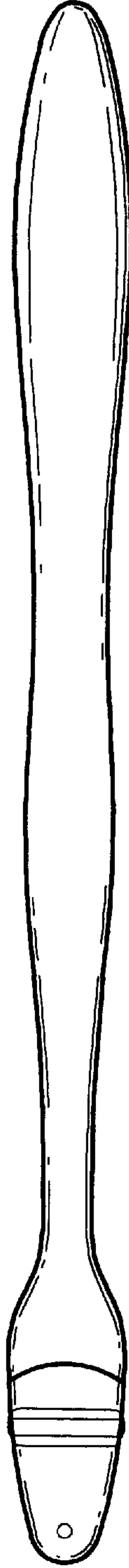

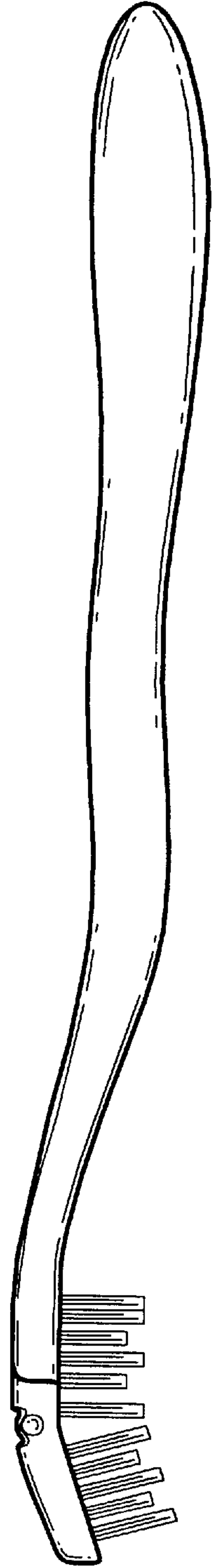

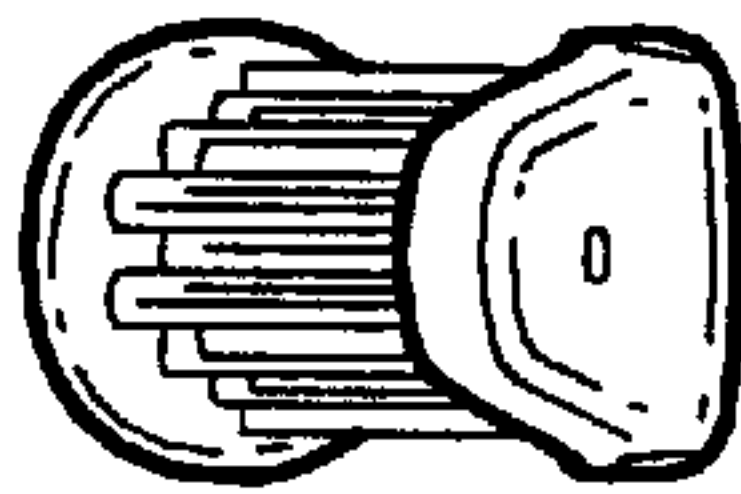
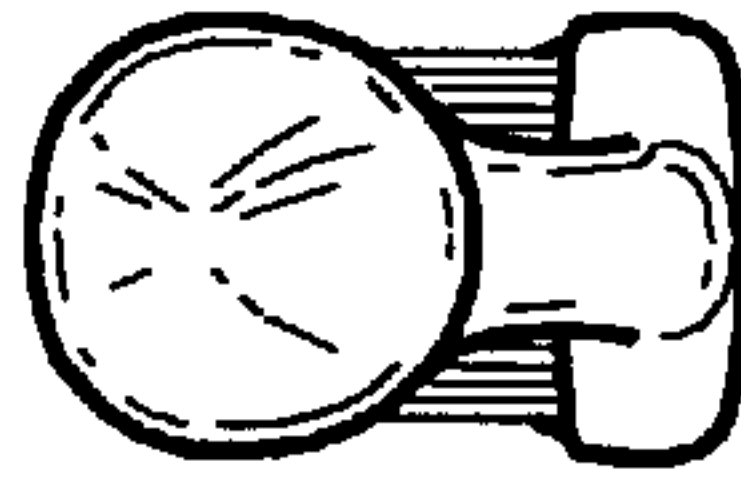

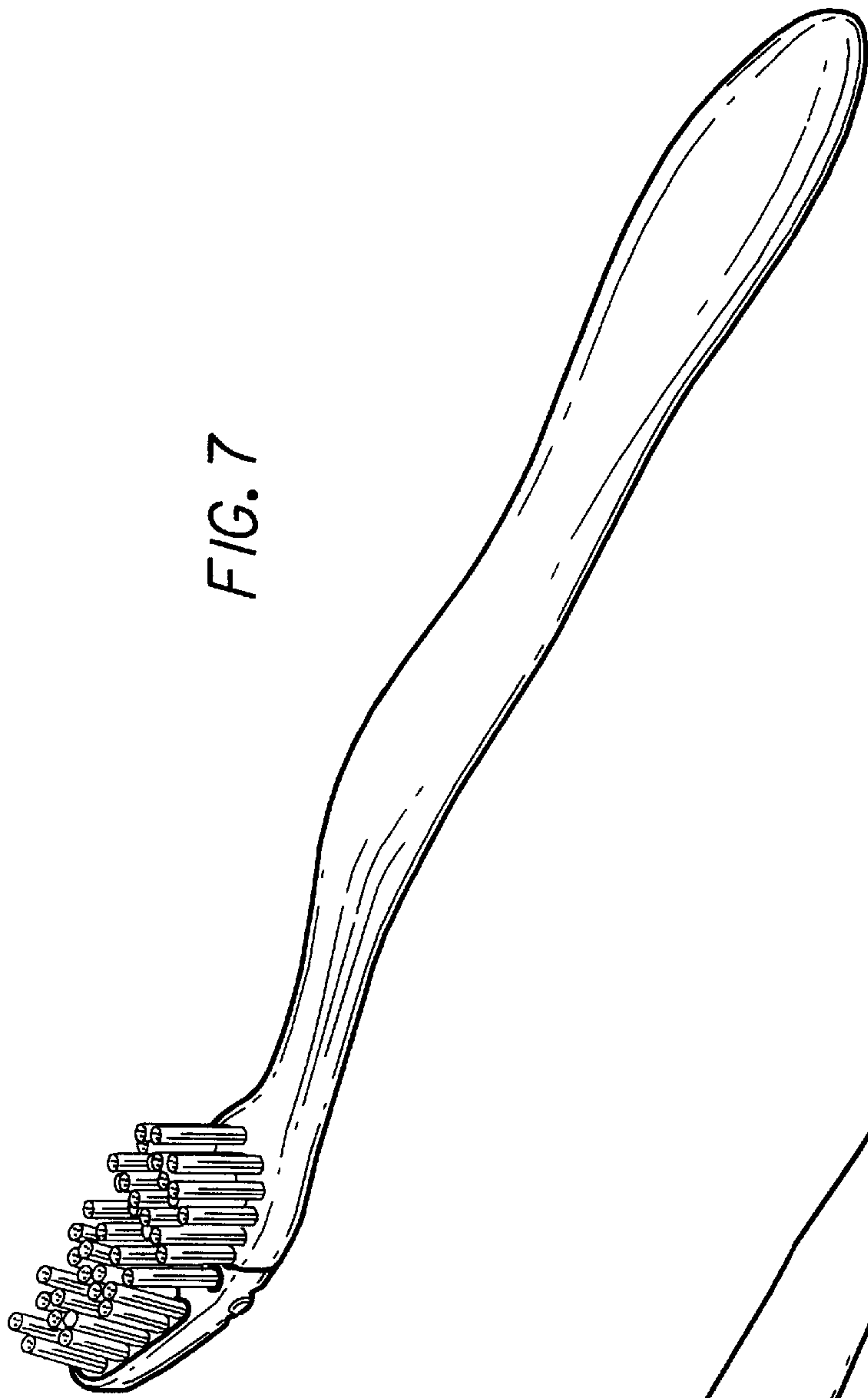

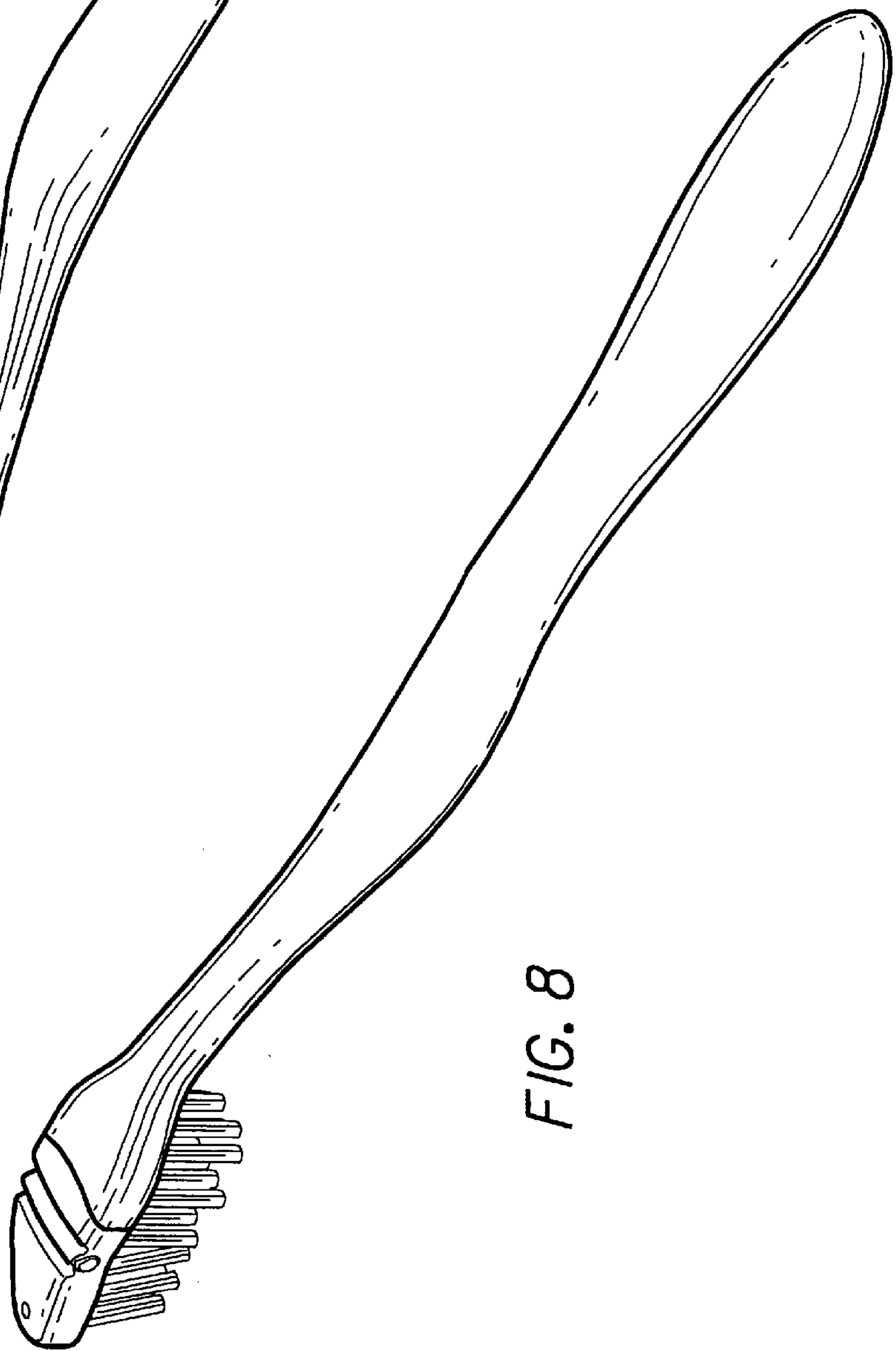

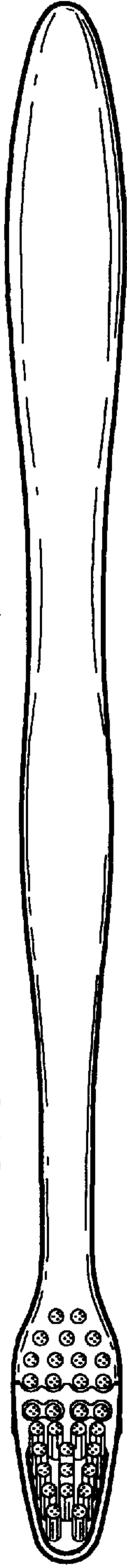

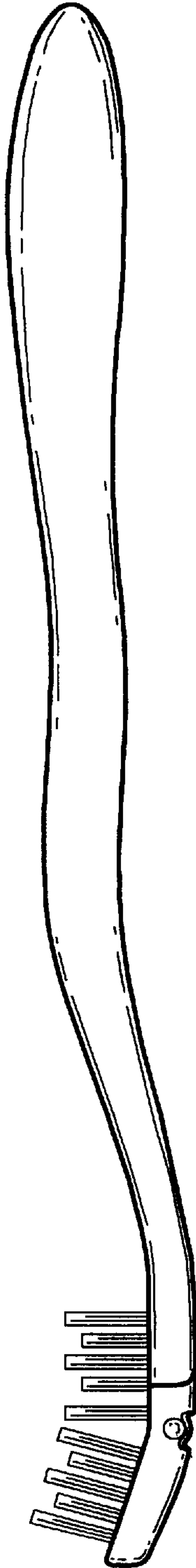

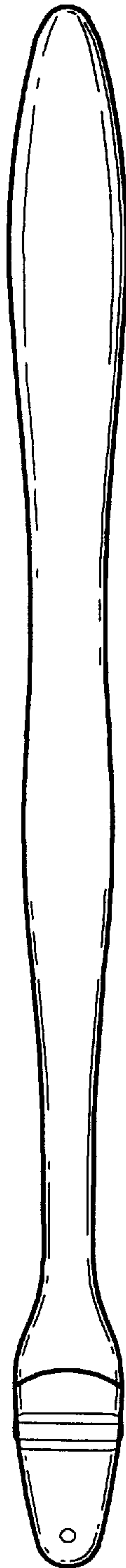

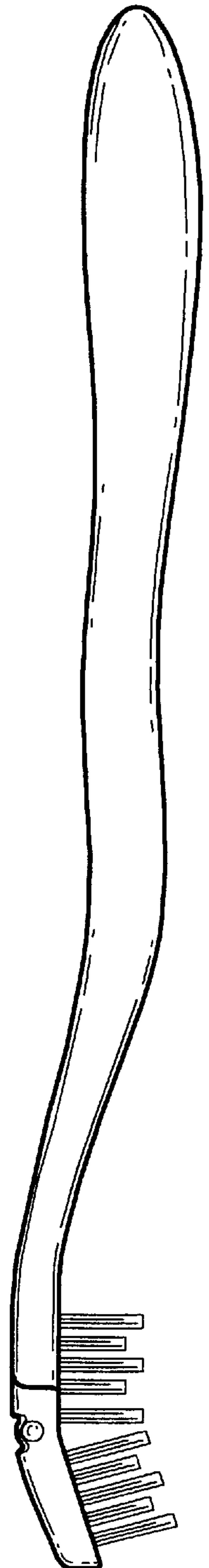

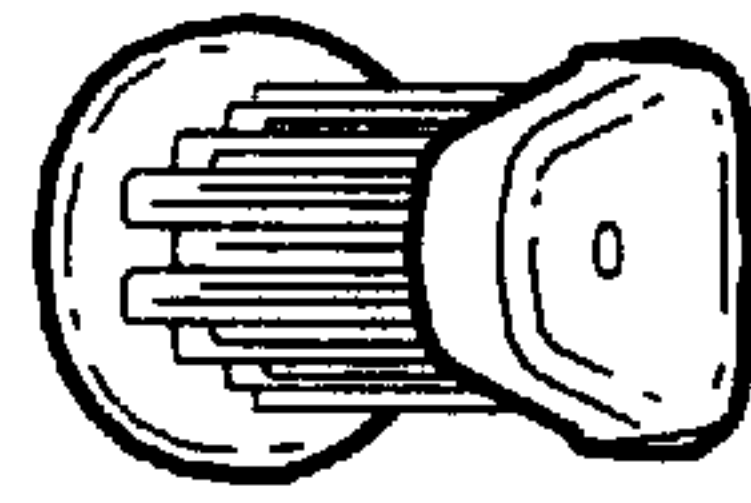
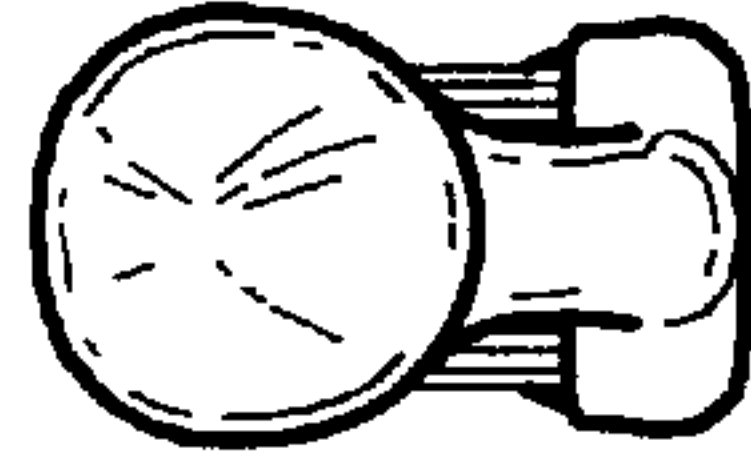

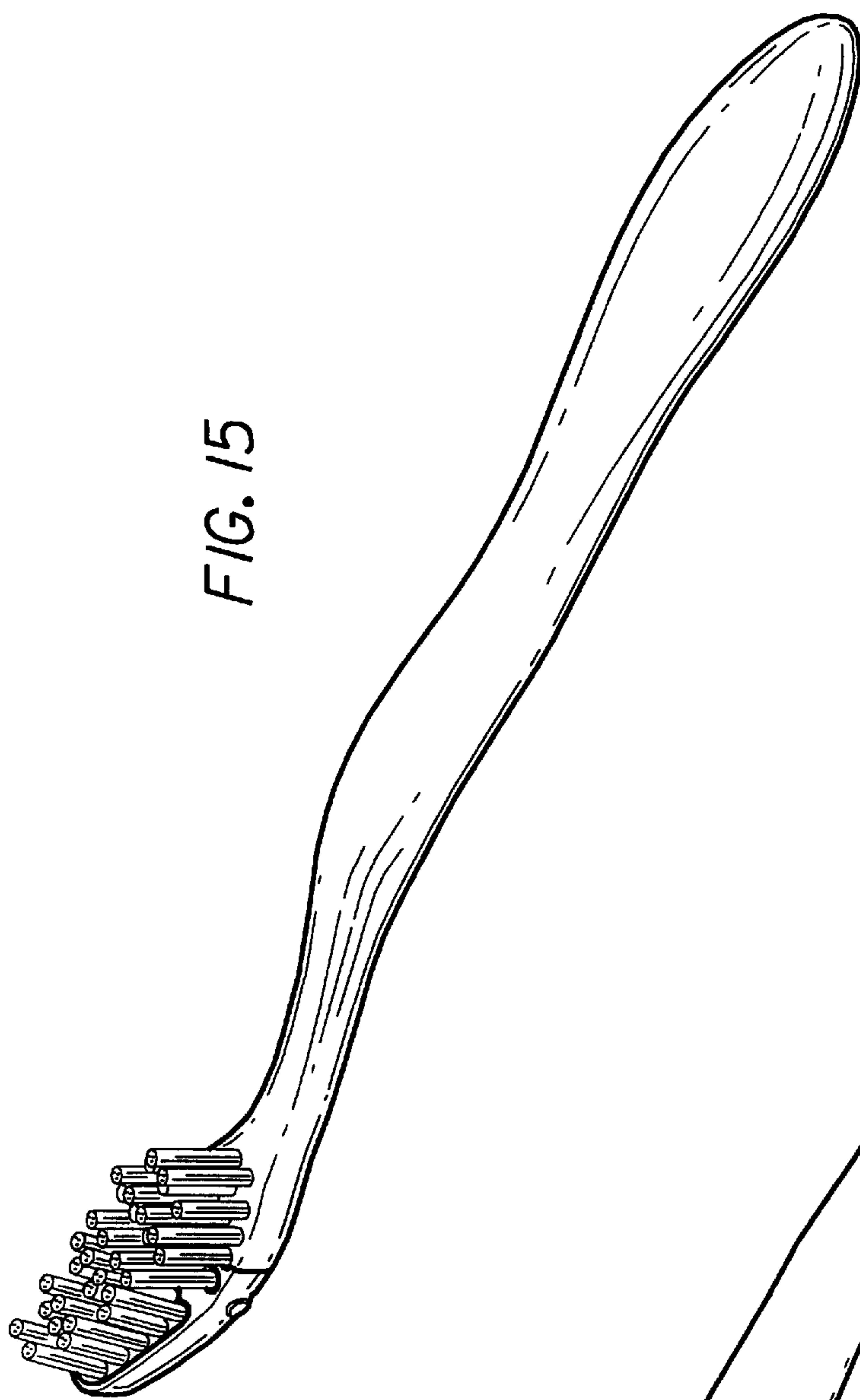

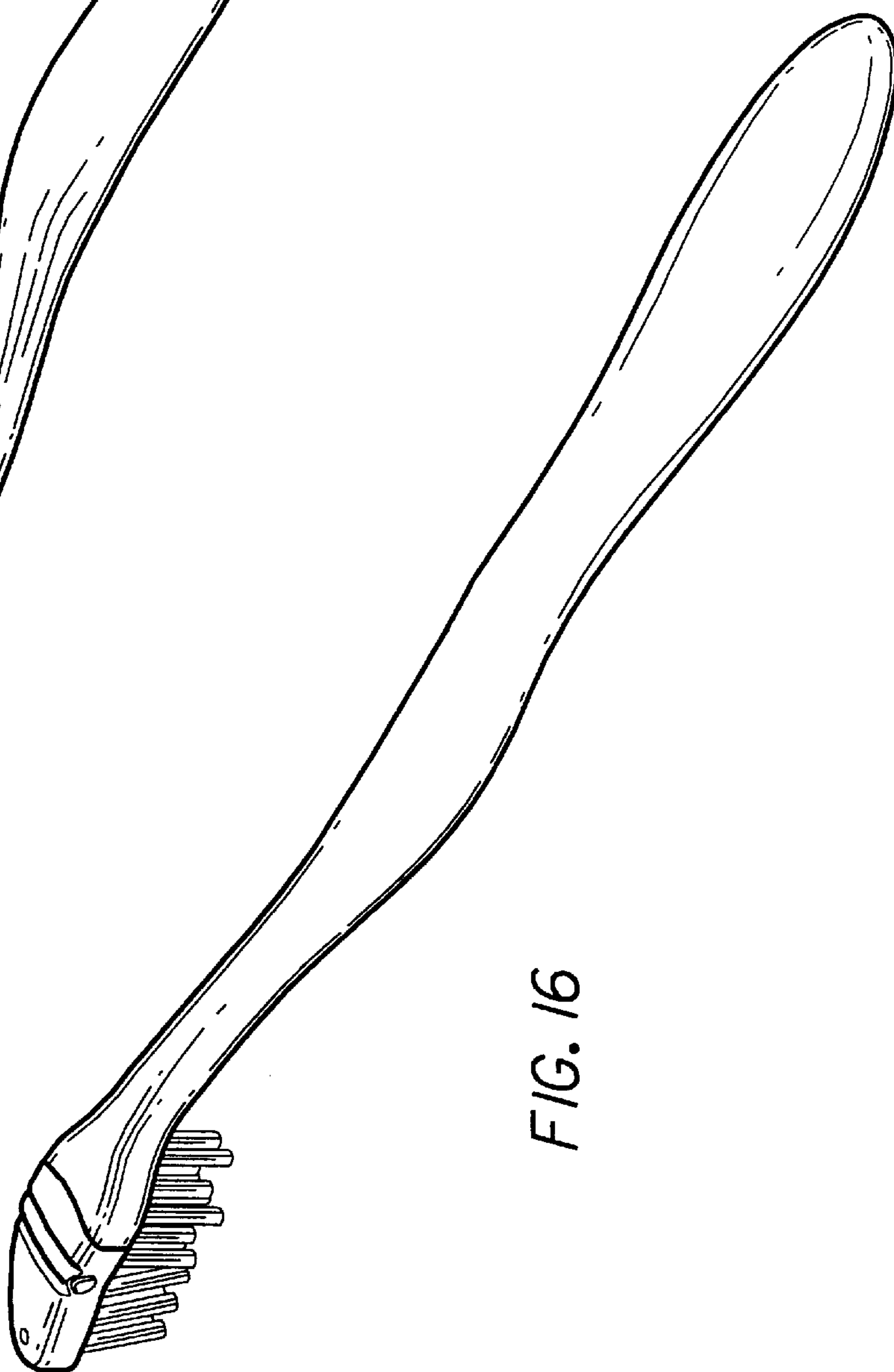

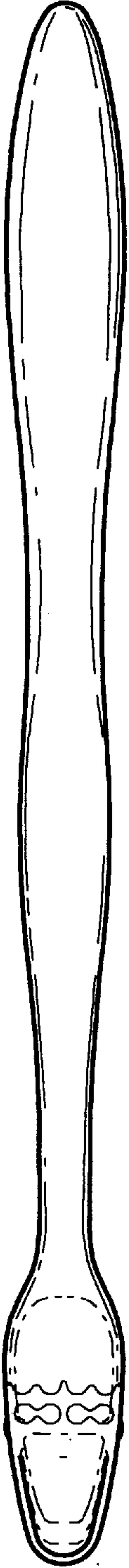

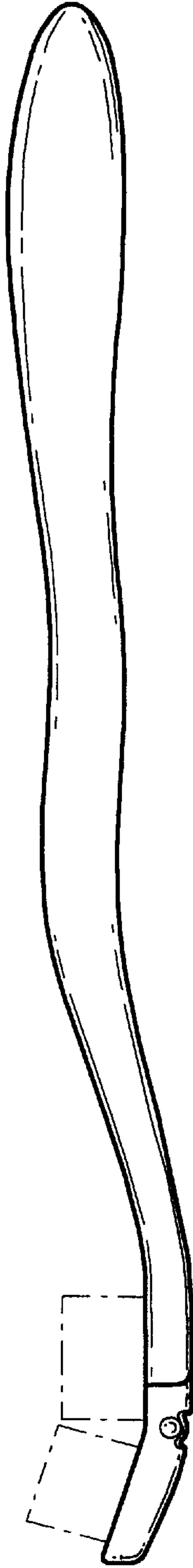

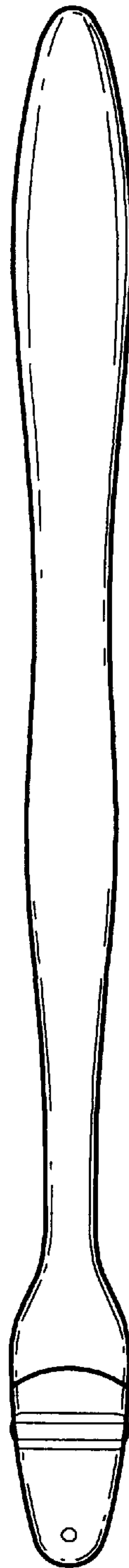

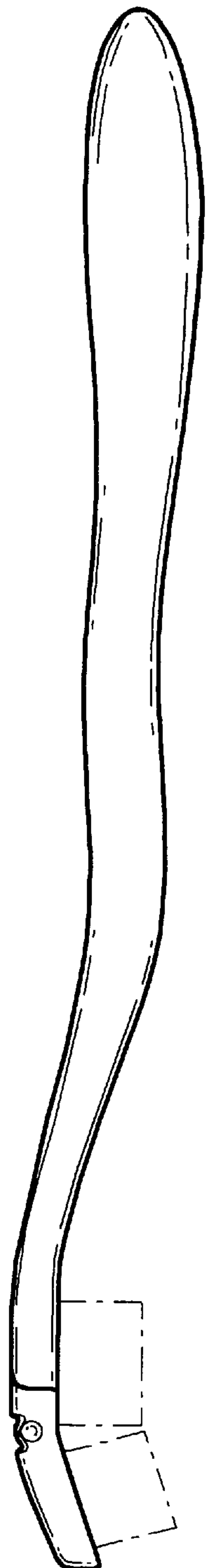

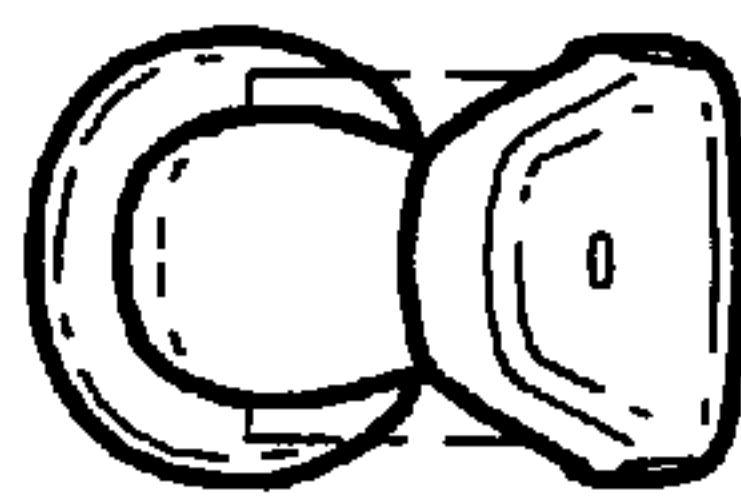
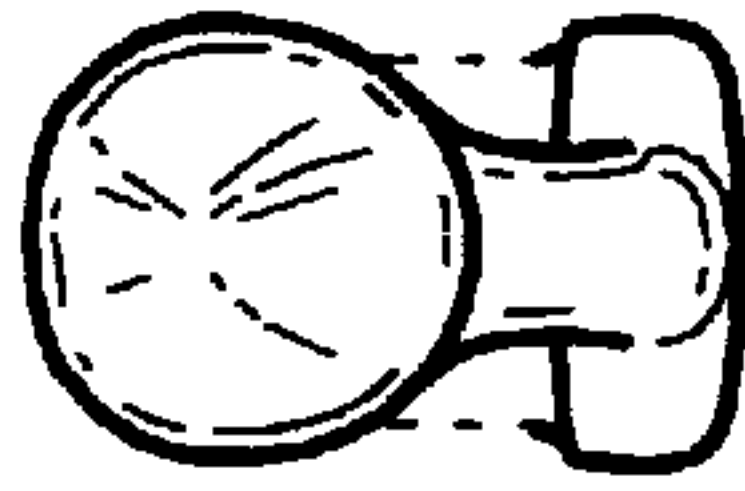

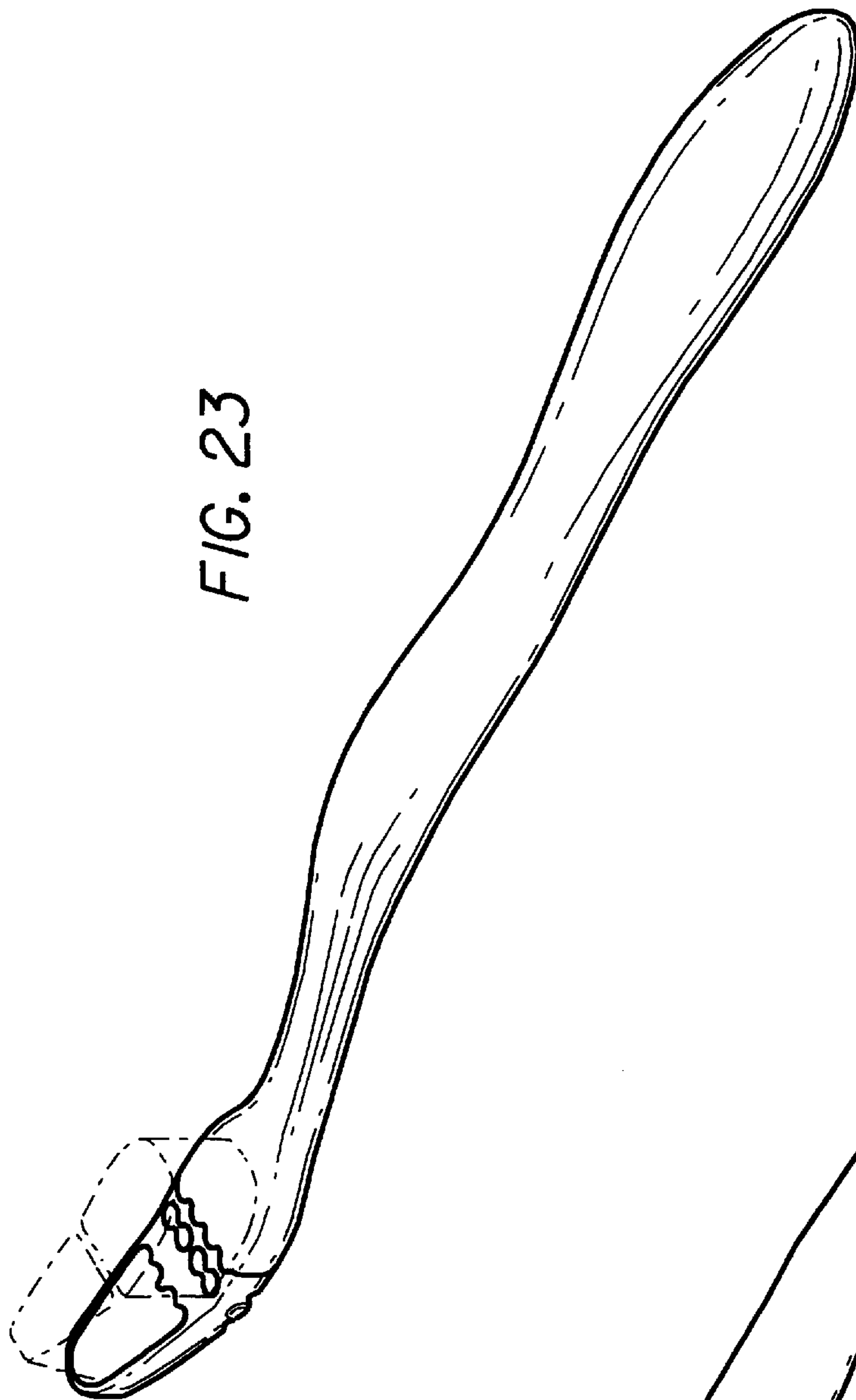

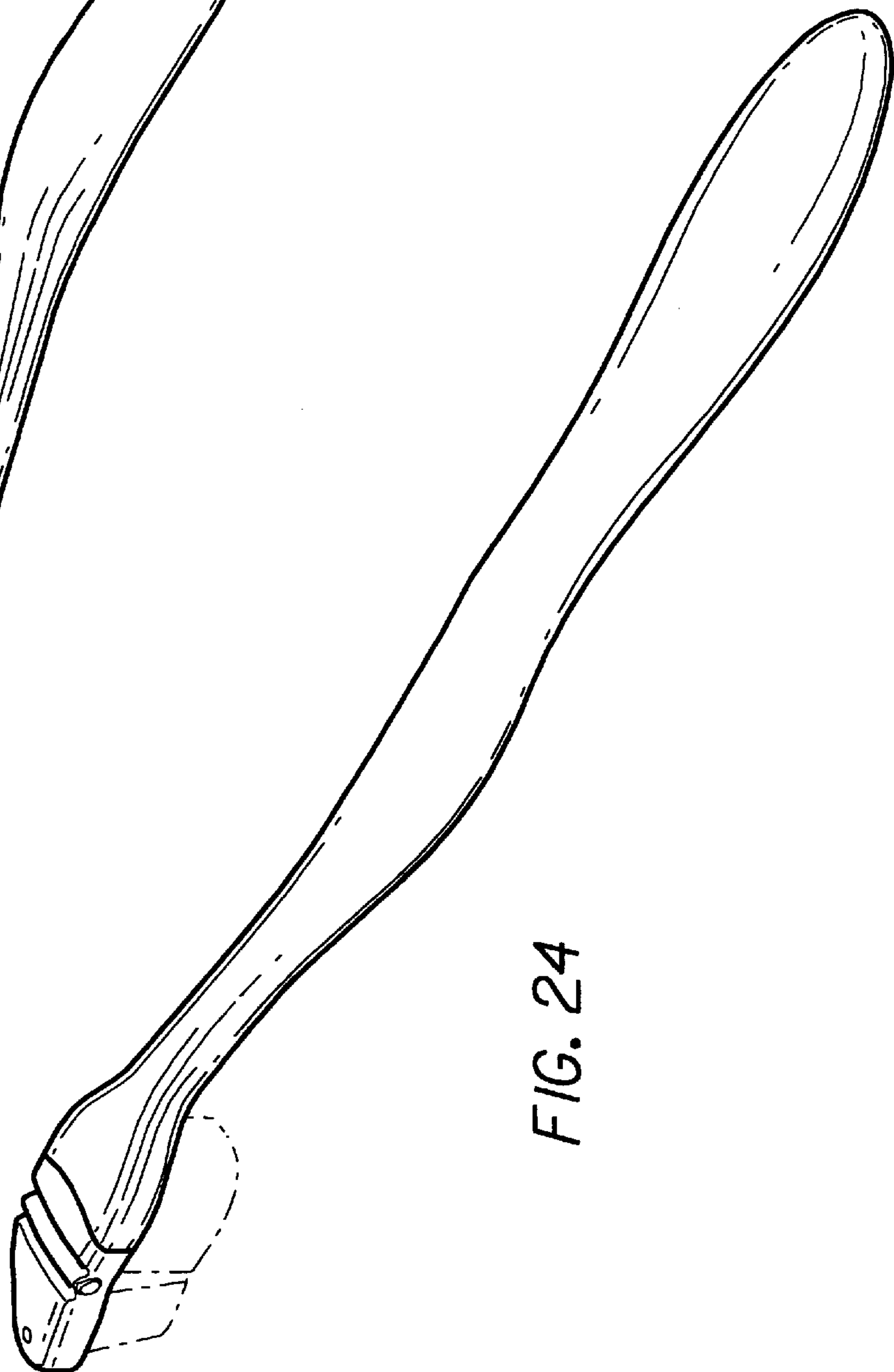
