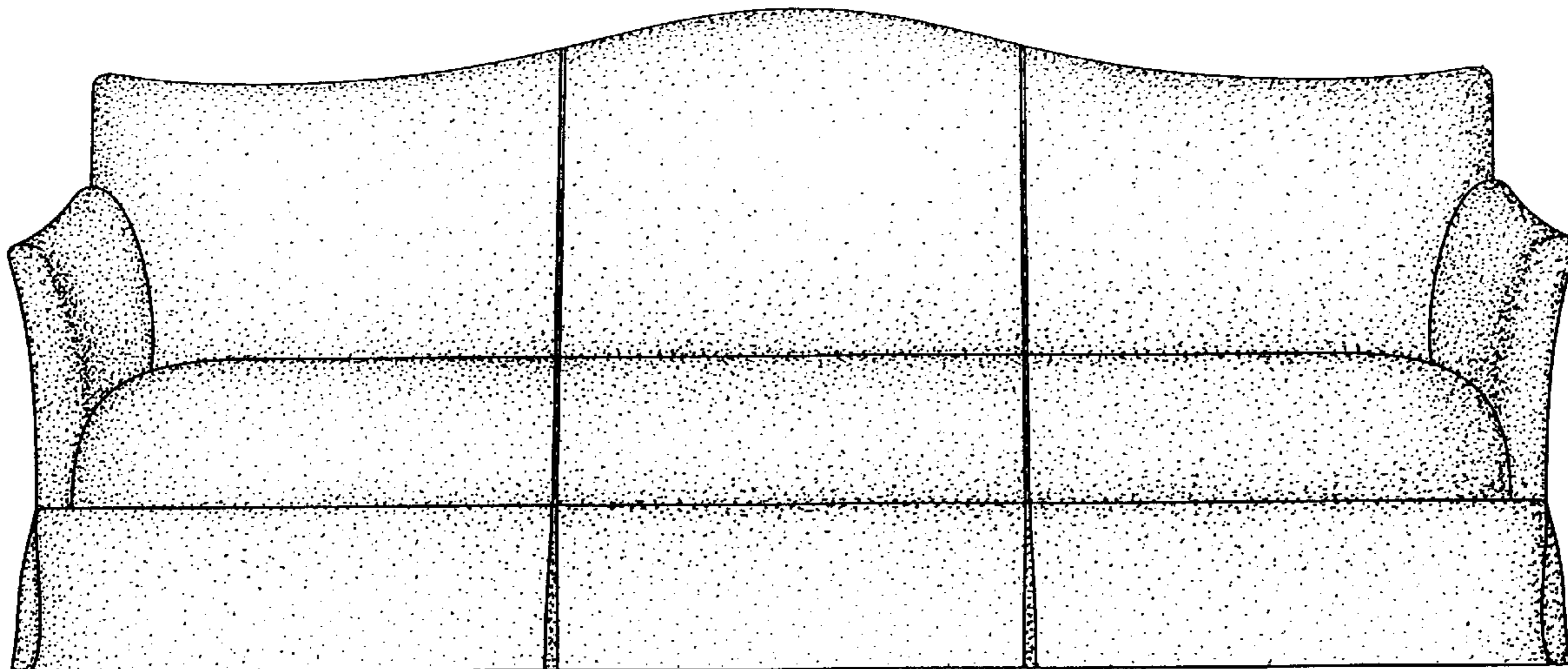
[57] **CLAIM**

The ornamental design for a seat, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of the seat comprising my new design;  
FIG. 2 is a top plan view thereof;  
FIG. 3 is a side elevational view thereof, the opposite side elevational view being a mirror image;  
FIG. 4 is a back elevational view thereof;  
FIG. 5 is a front elevational view of an alternate embodiment of the seat comprising my new design;  
FIG. 6 is a side elevational view of the seat of FIG. 5, the opposite side elevational view being a mirror image;  
FIG. 7 is a back elevational view of the seat of FIG. 5; and,  
FIG. 8 is a top plan view of the seat of FIG. 5.

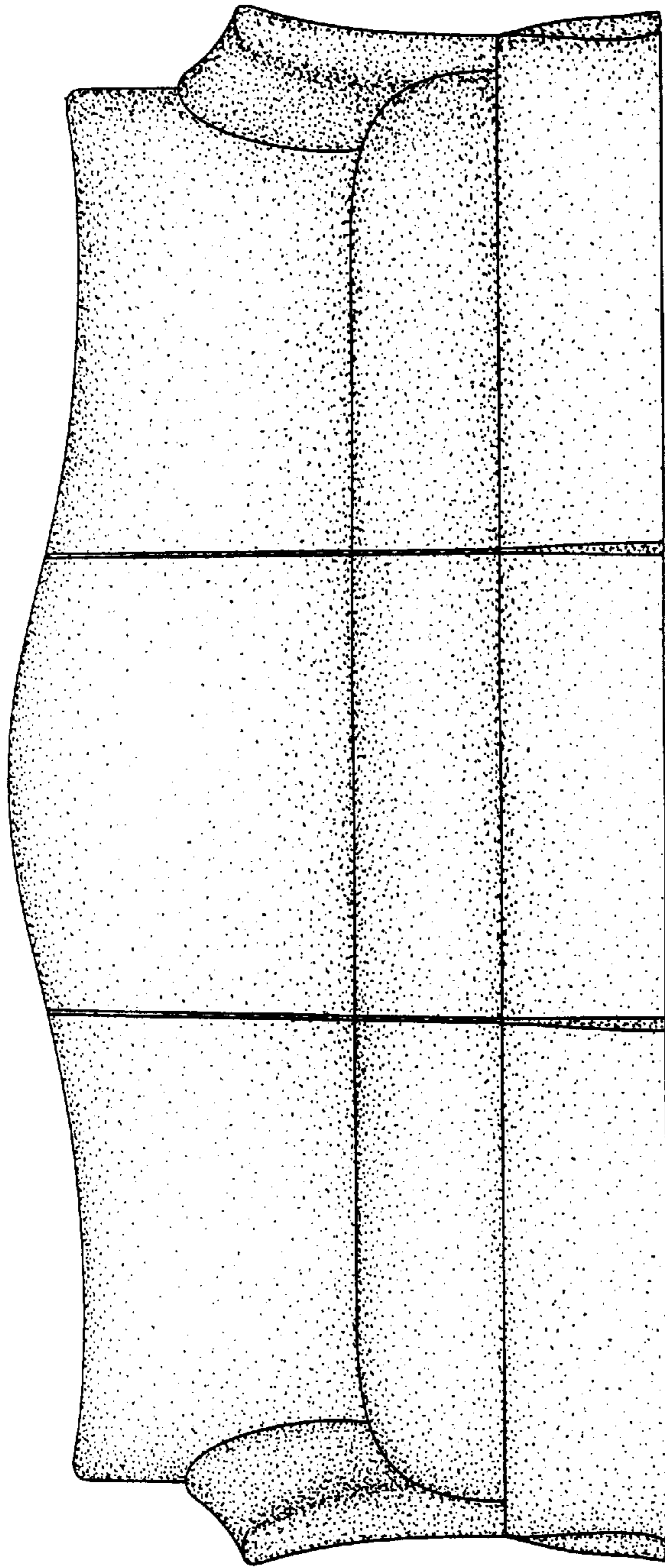

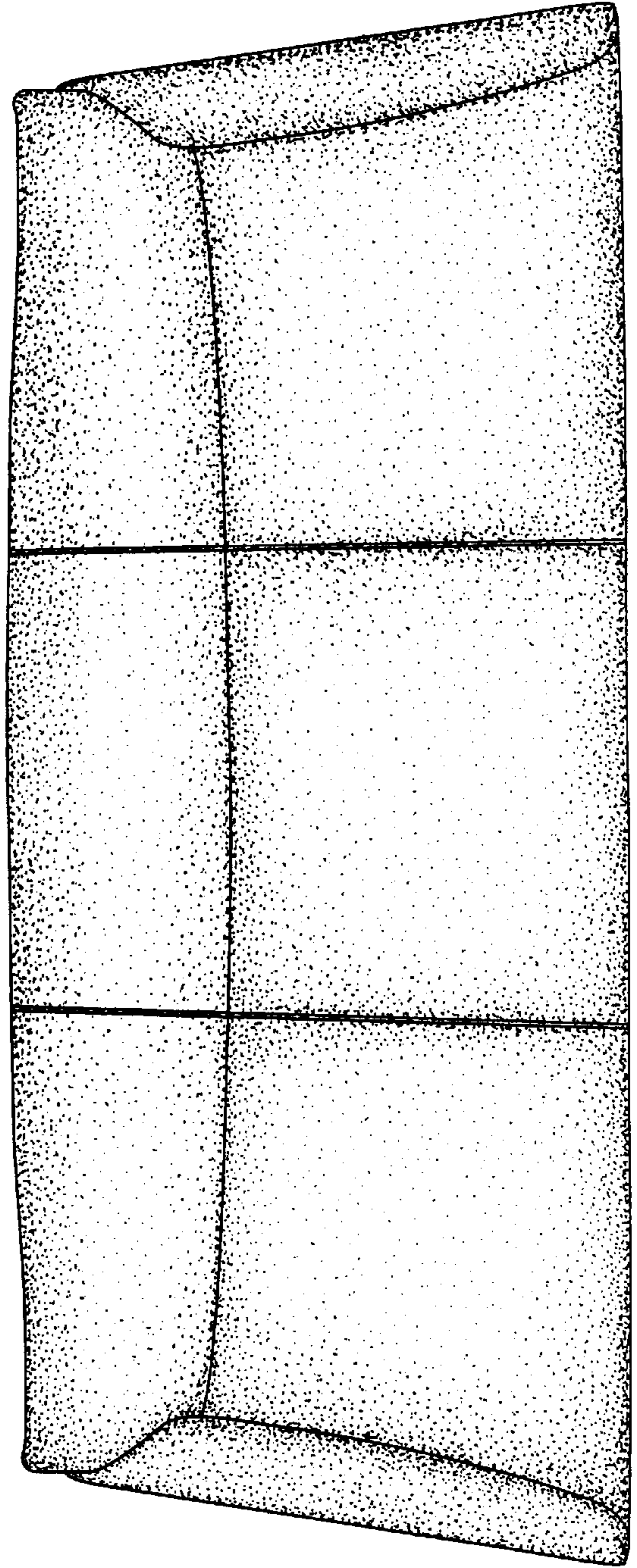

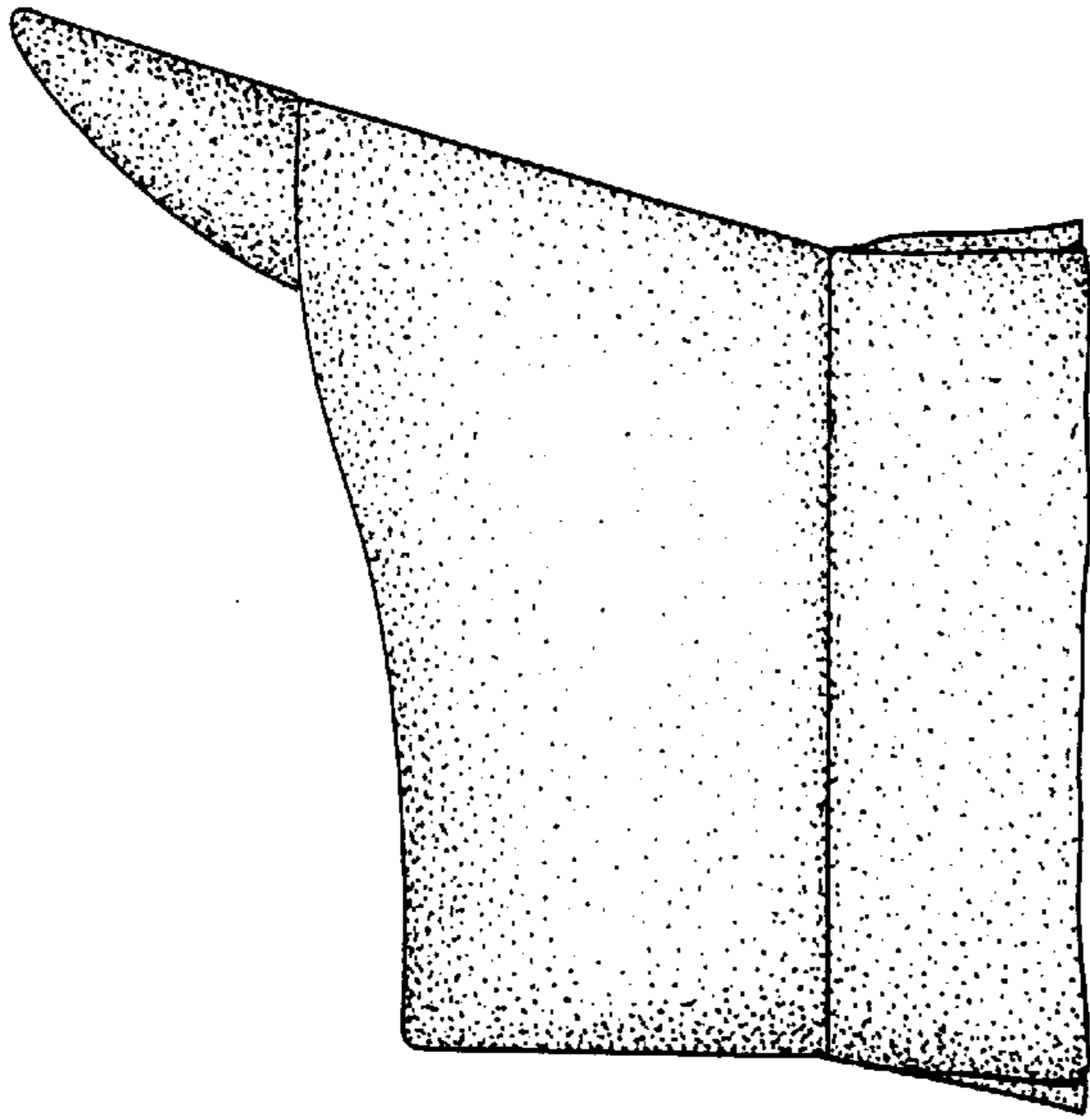

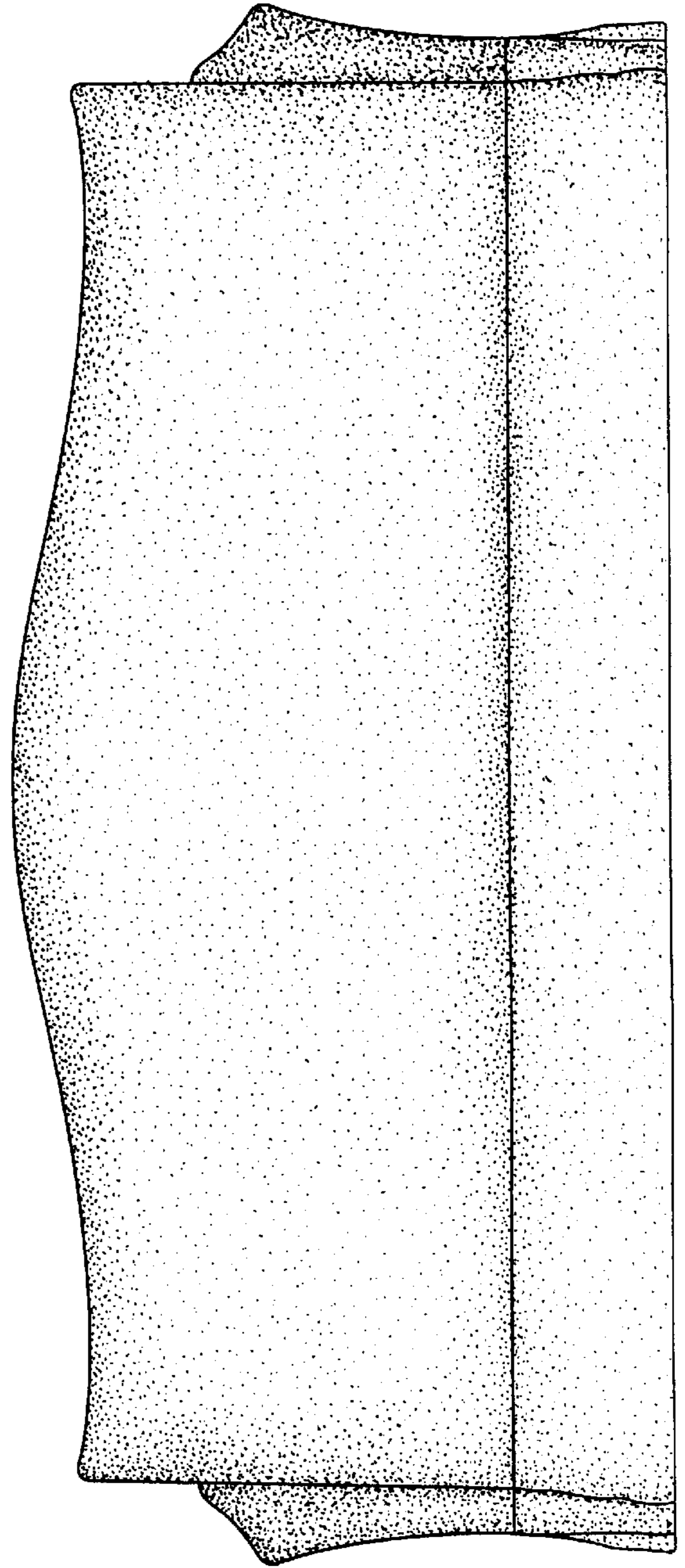

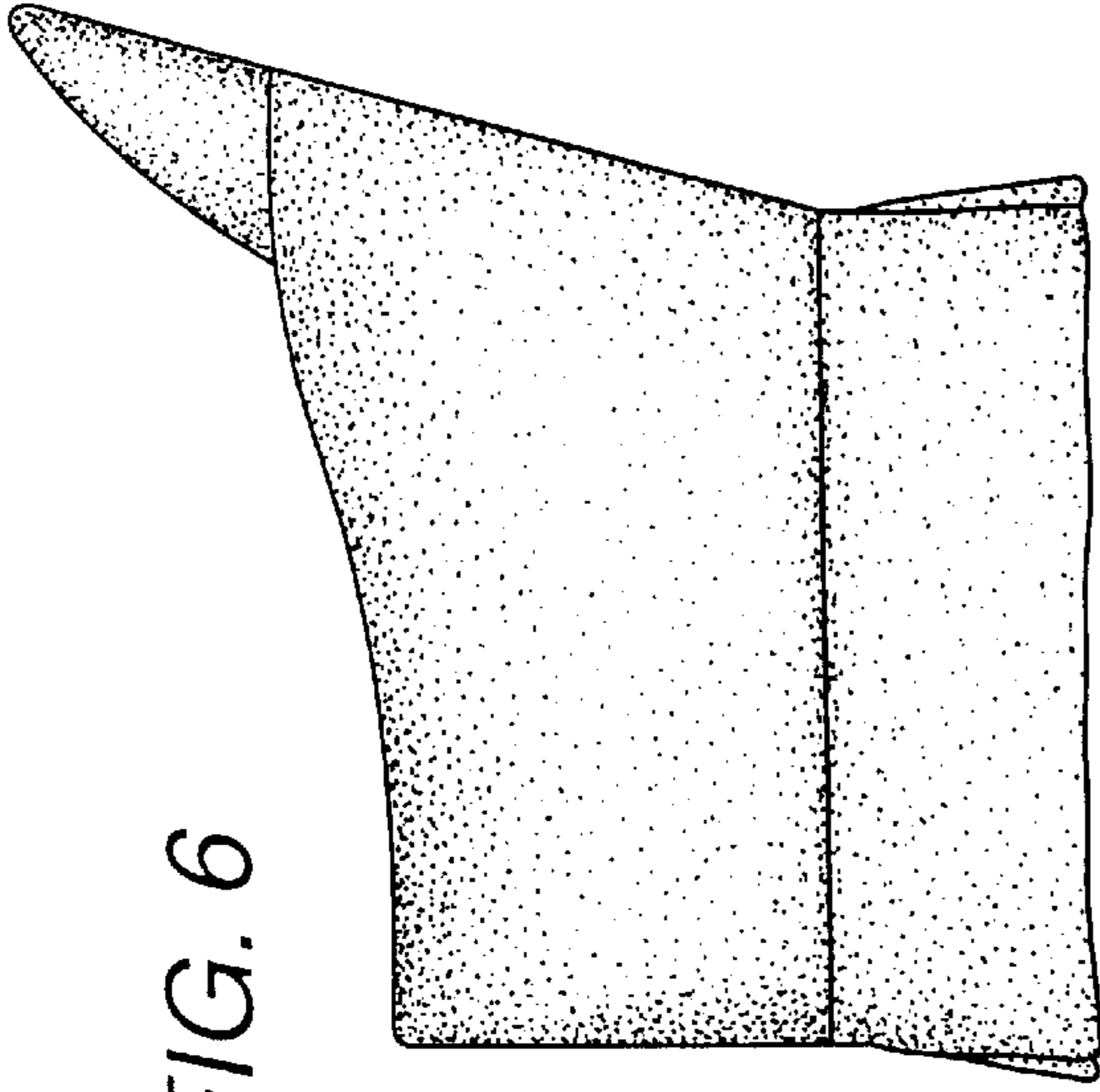

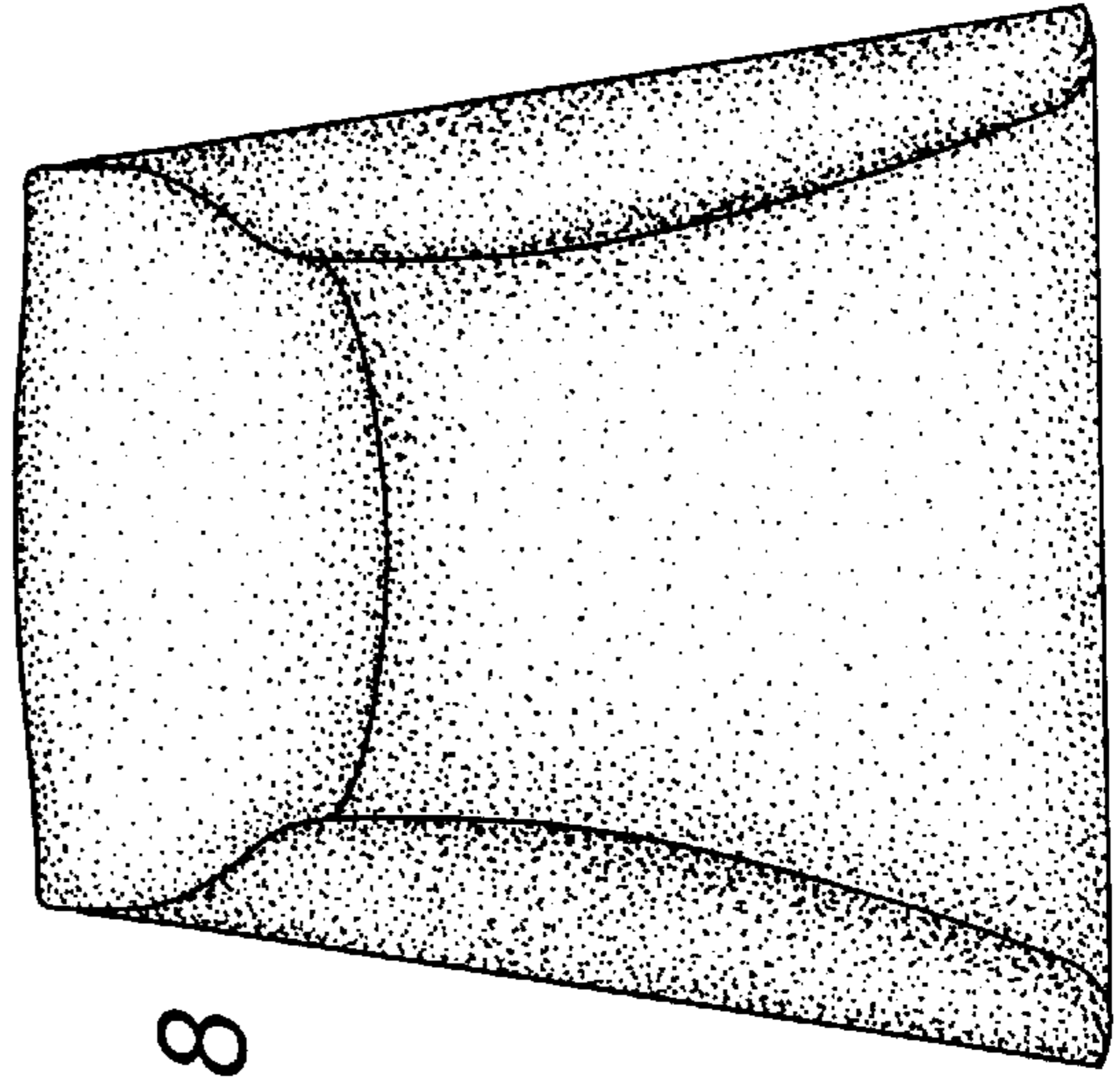

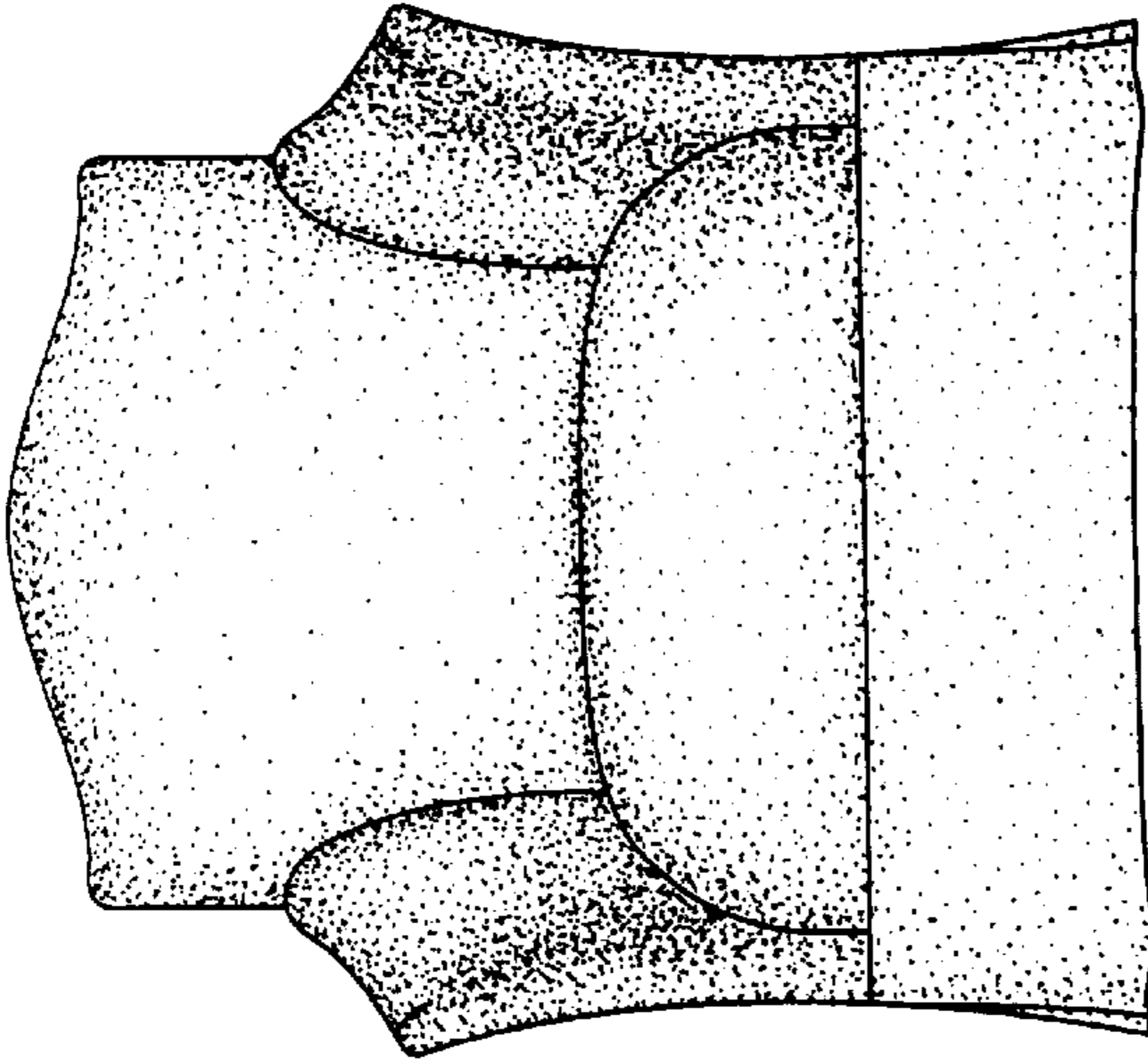

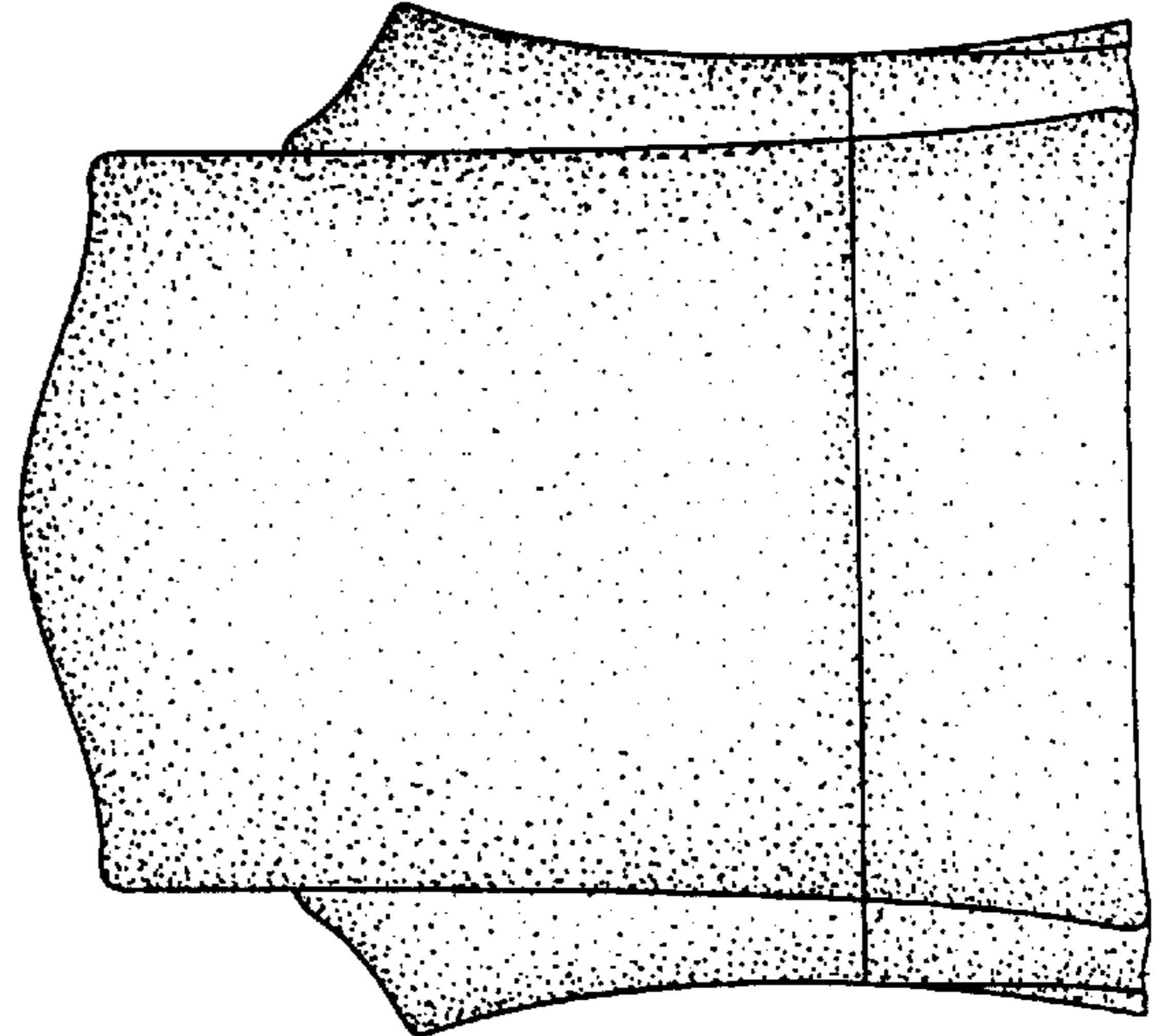
