[57] CLAIM

The ornamental design for a beverage server indicator, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a beverage server indicator showing our new design;

FIG. 2 is a front elevational view of a beverage server indicator;

FIG. 3 is a right side elevational view of the indicator as shown in FIG. 2, left side, top and bottom views are not provided as they are identical to the right side elevational view;

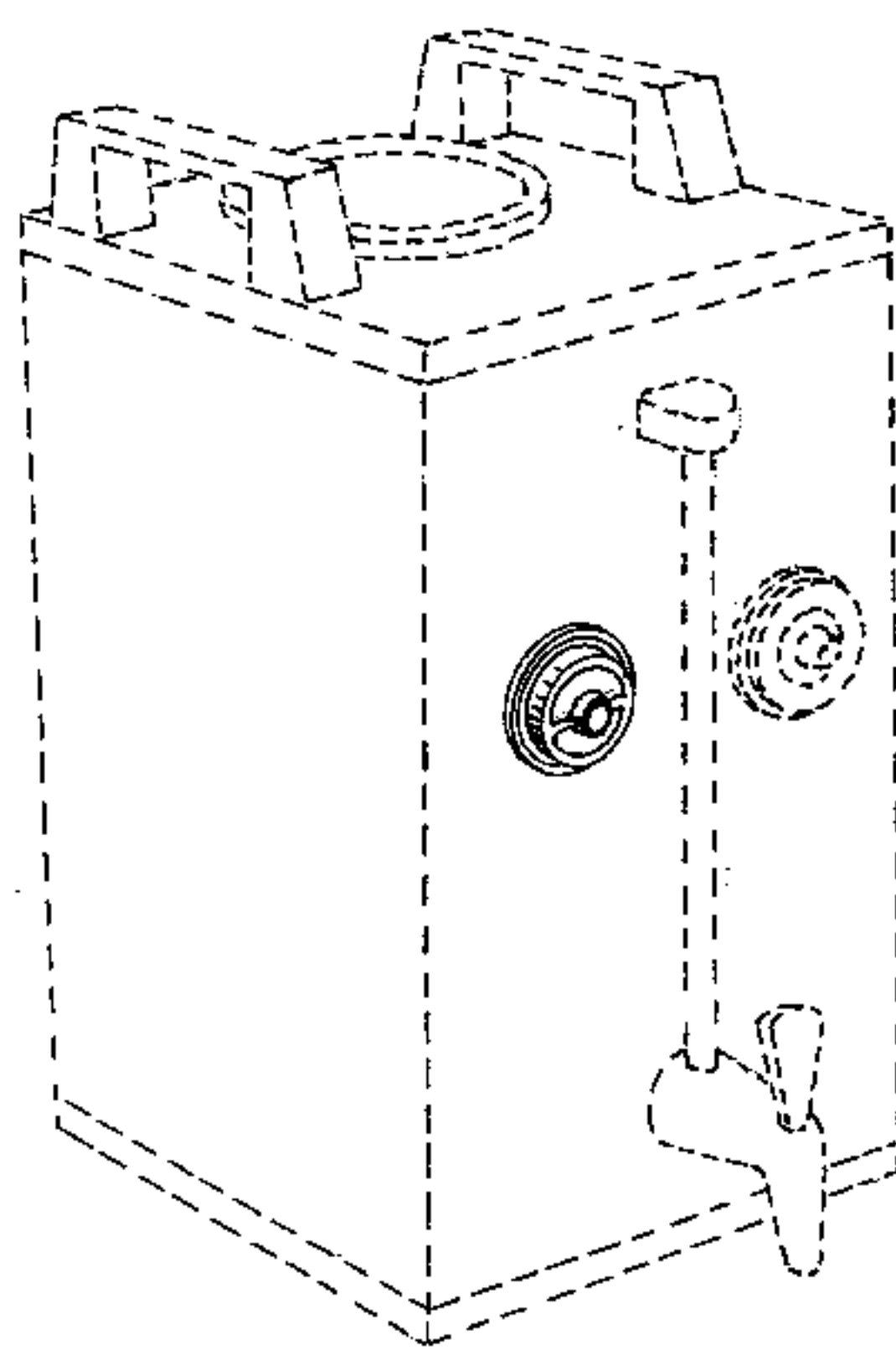
FIG. 4 is a cross-sectional, side elevational view taken along the line 4—4 in FIG. 2 to show detail of the structure not readily apparent from FIGS. 1—3;

FIG. 5 is a front elevation view thereof, rotated to an in use position to conceal the indicia shown in FIG. 2; and,

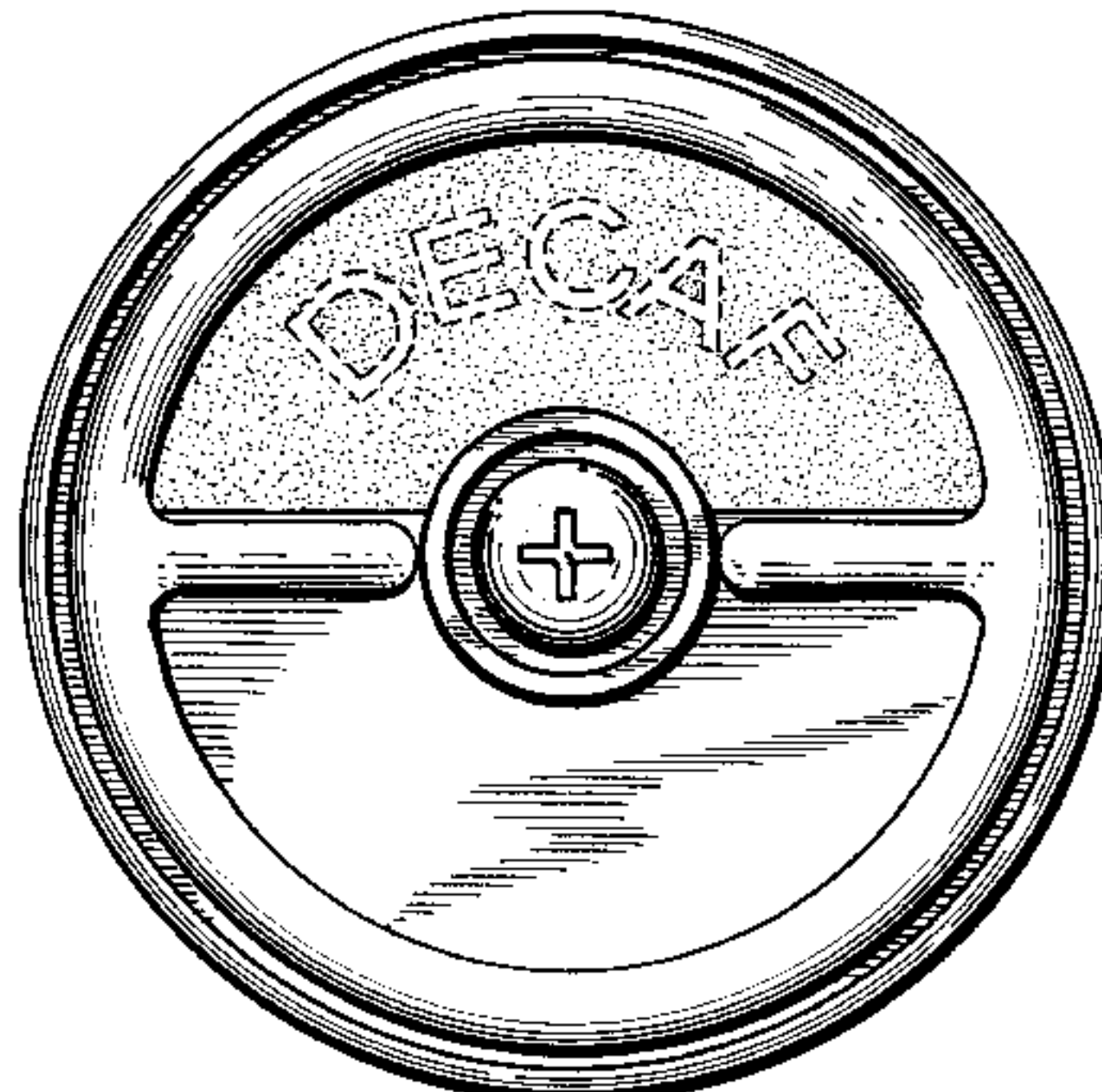
FIG. 6 is a cross-sectional, side elevational view taken along the line 6—6 in FIG. 5 which has been provided to show additional details which are not readily apparent from FIG. 5.

The broken line showing of a beverage server in FIG. 1 and indicia in FIG. 2 is for illustrative purposes only and forms no part of the claimed design.

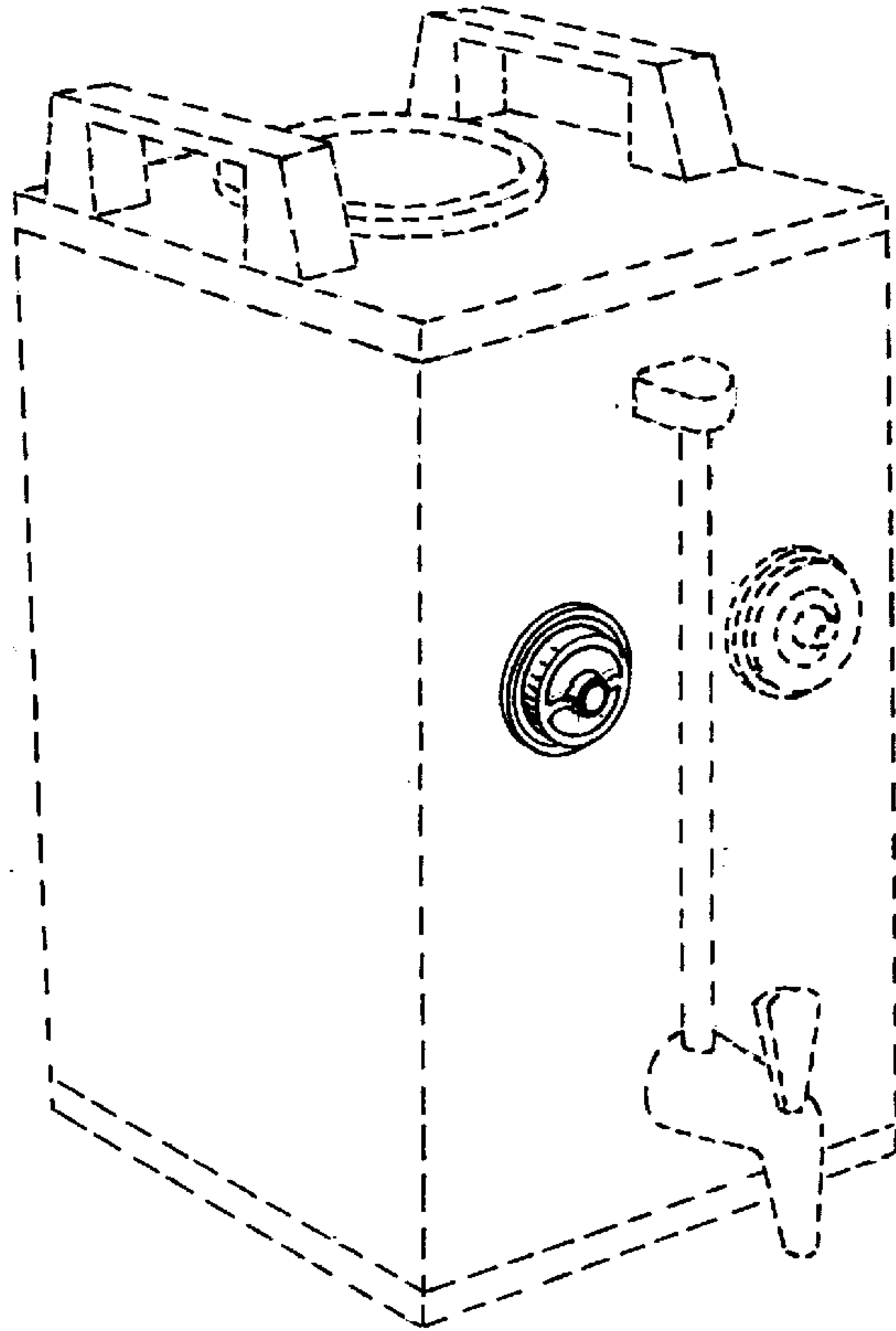

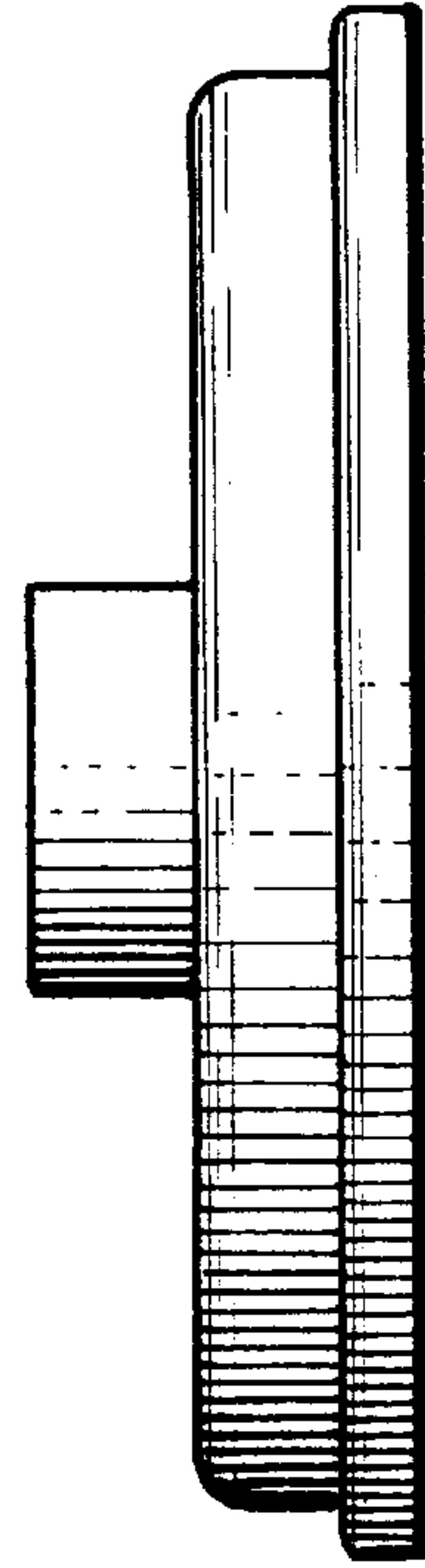

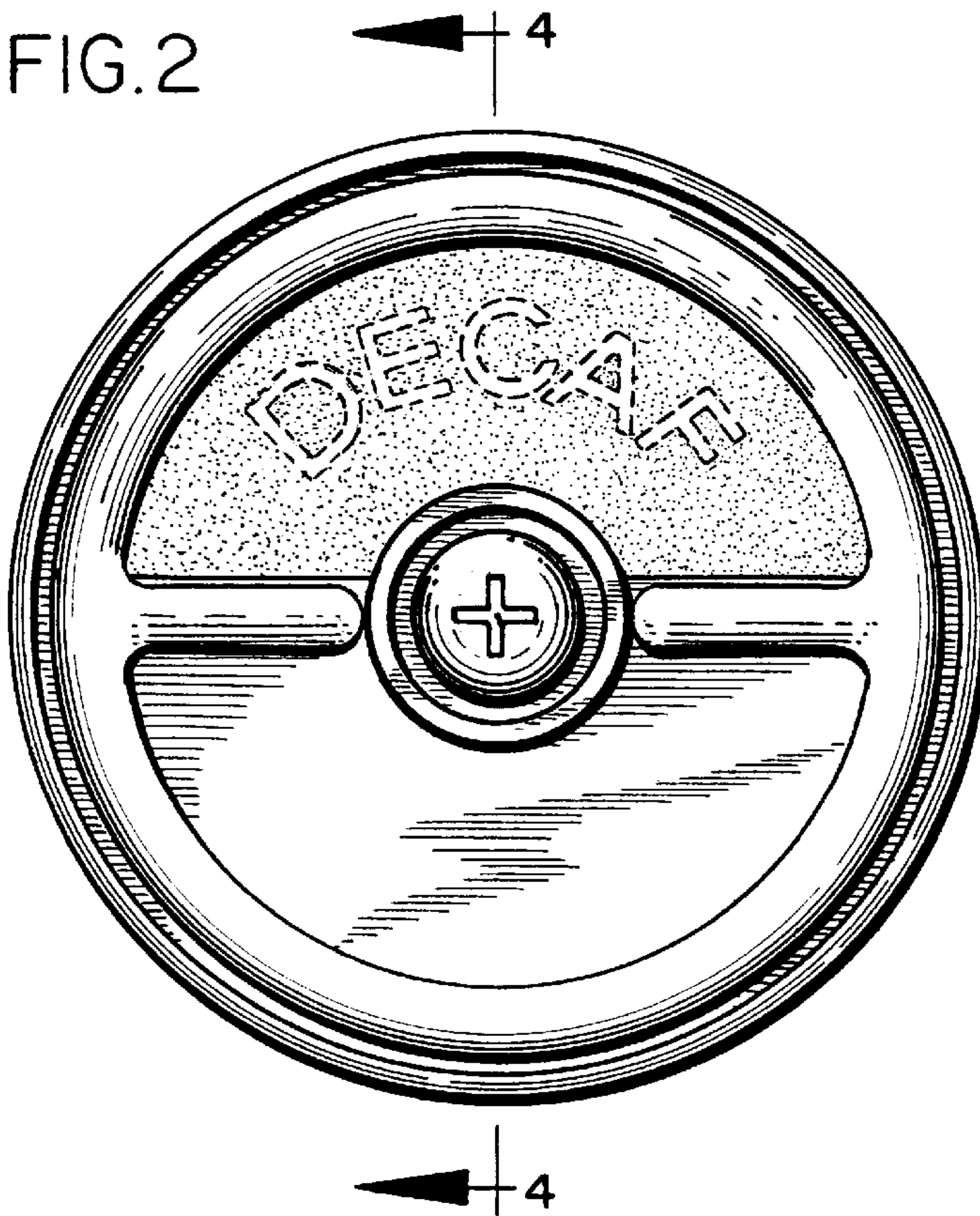

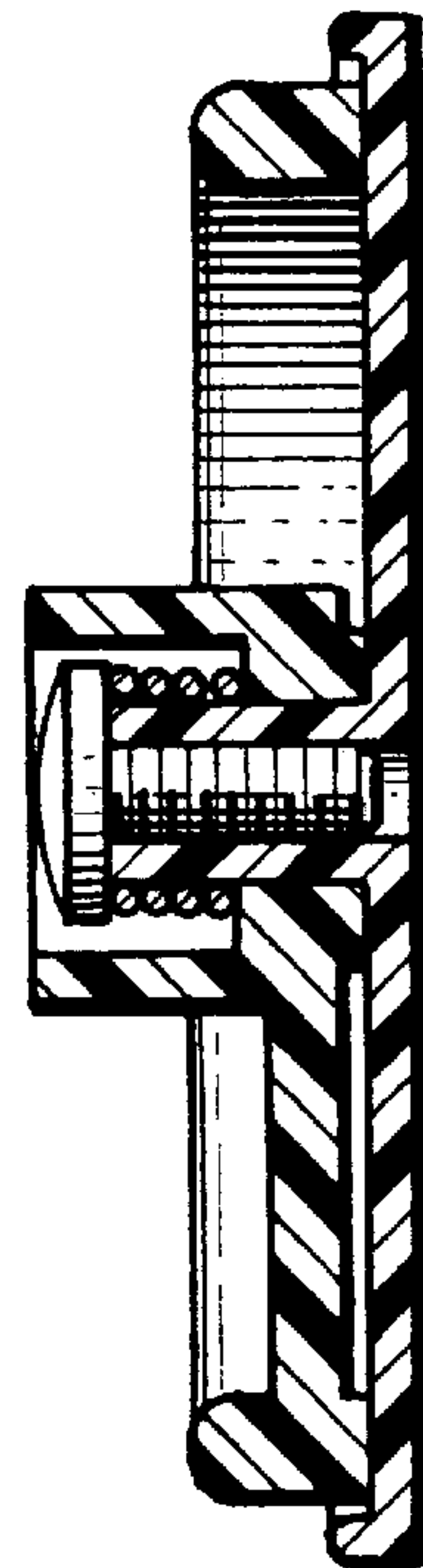

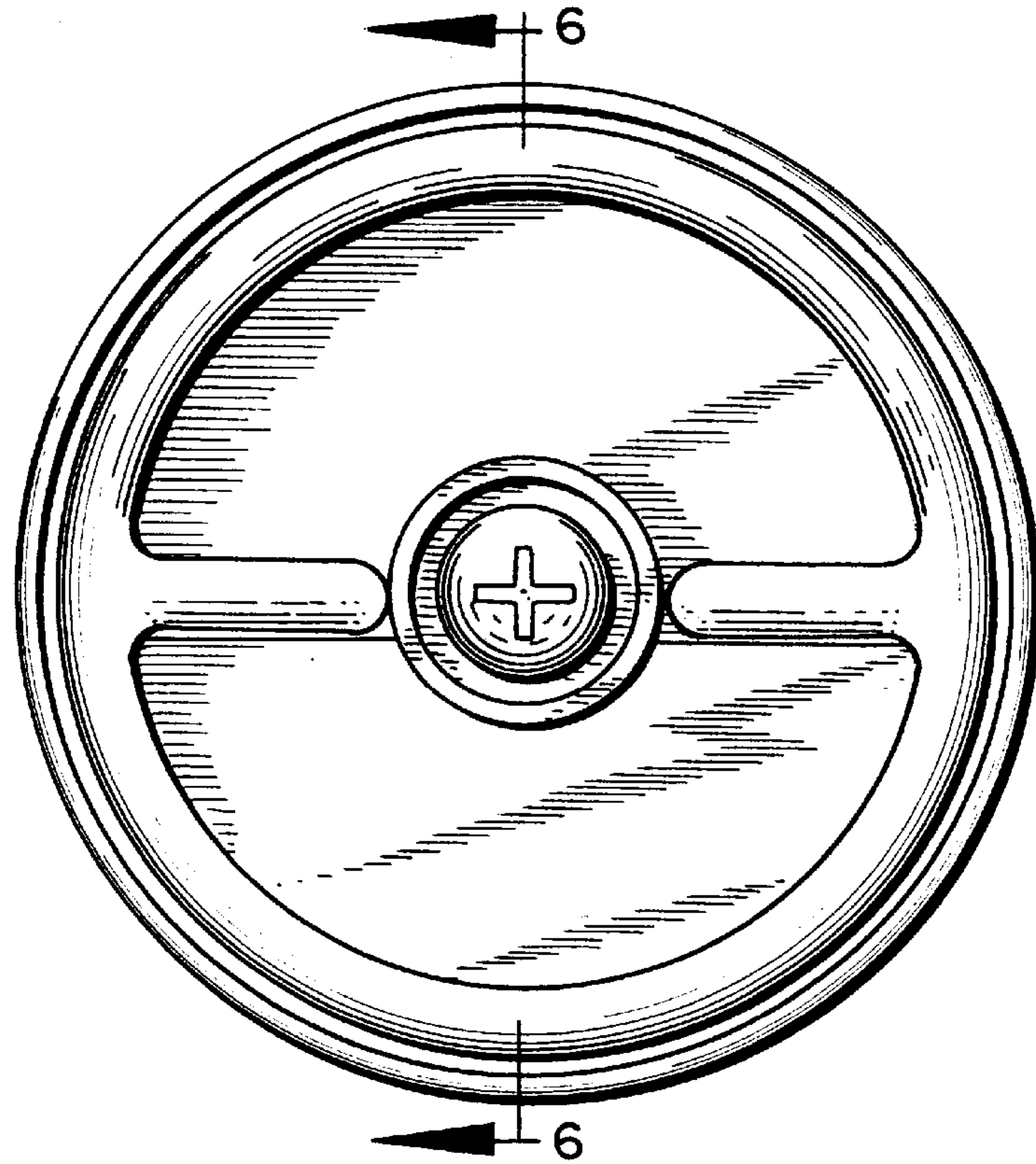
