The ornamental design for a beverage container, as shown and described.

DESCRIPTION

FIG. 1; is a top perspective view of a beverage container showing my new design;
 FIG. 2 is a front elevational view thereof, the rear and side views being identical;
 FIG. 3 is a top plan view thereof;
 FIG. 4 is a bottom plan view thereof;
 FIG. 5 is a top perspective view of a beverage container showing a second embodiment of my new design;
 FIG. 6 is a front elevational view thereof, the rear and side views being identical;
 FIG. 7 is a top plan view thereof; and,
 FIG. 8 is a bottom plan view thereof.

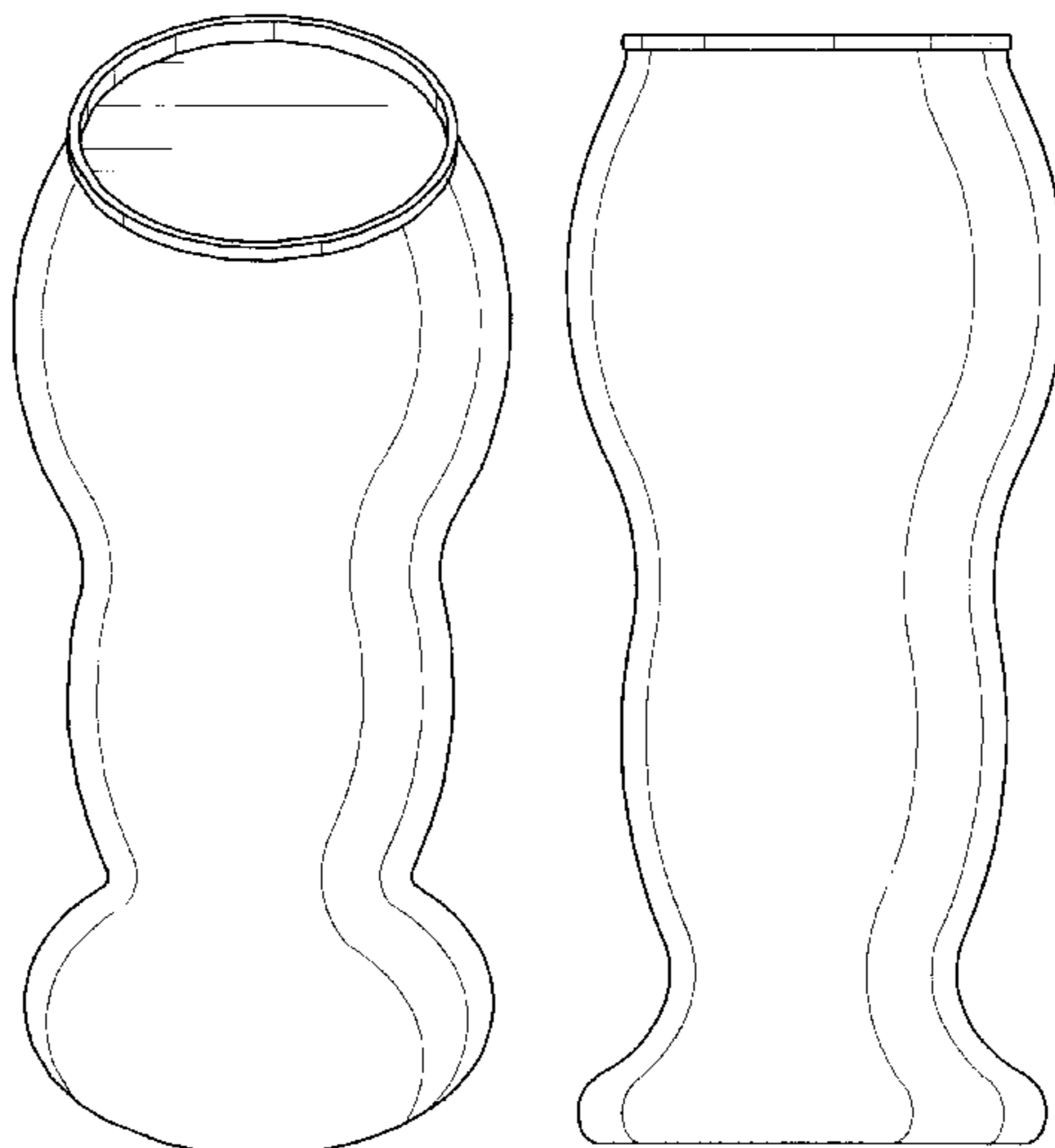

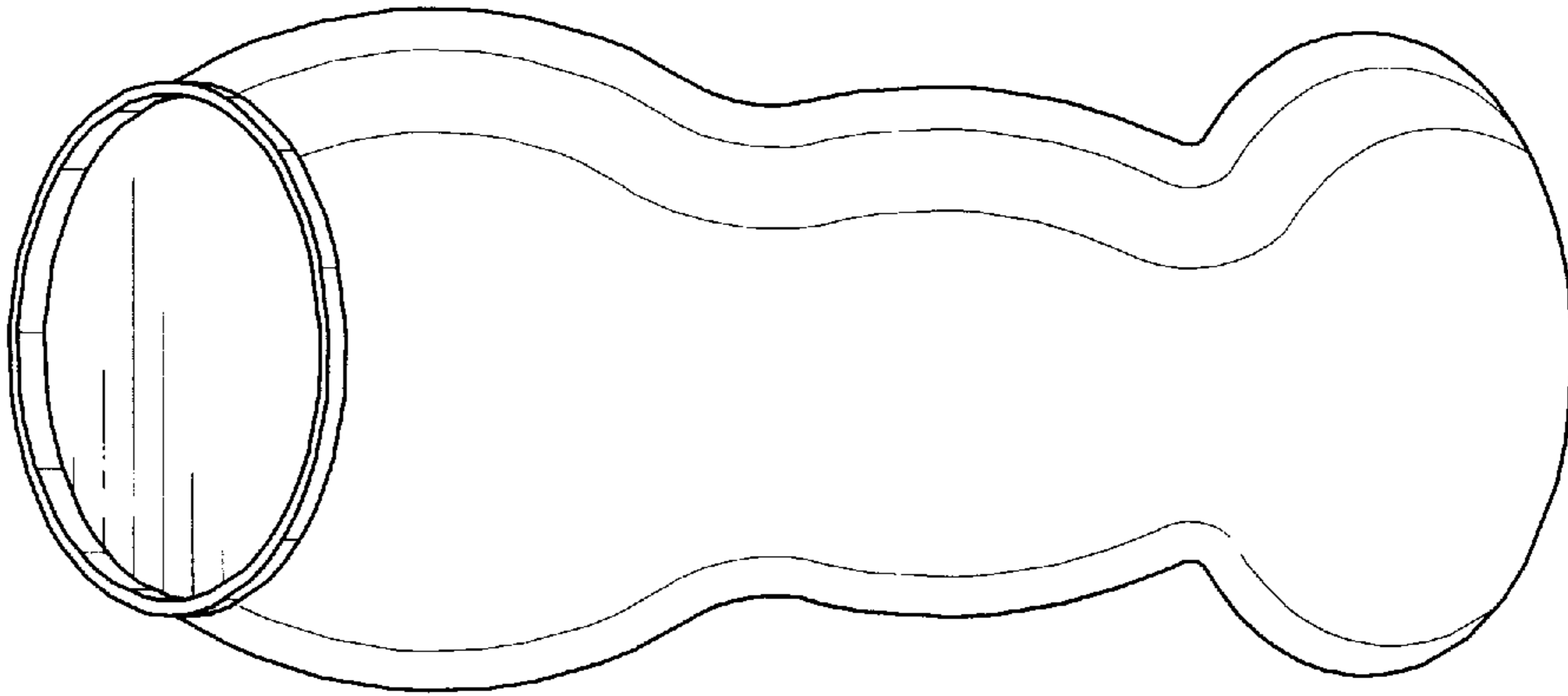

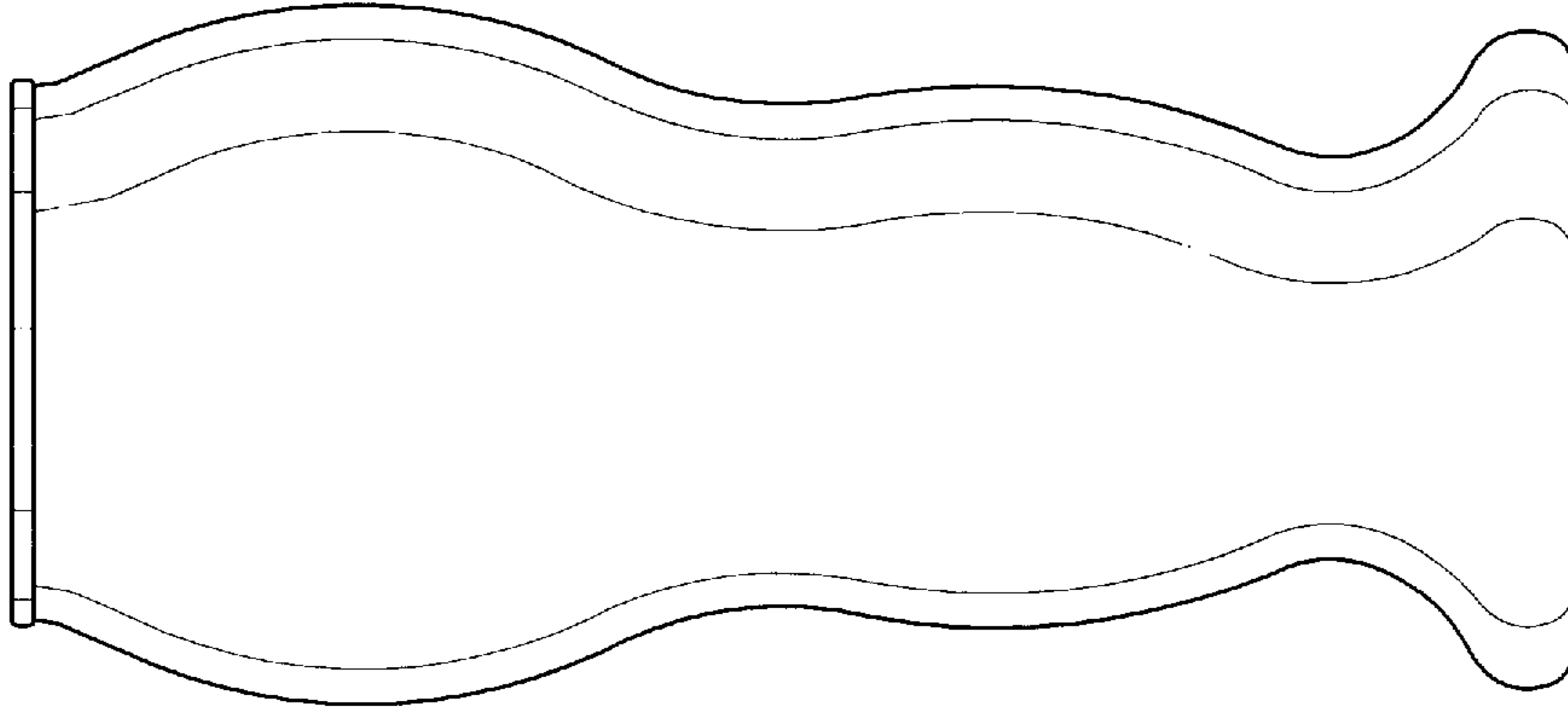

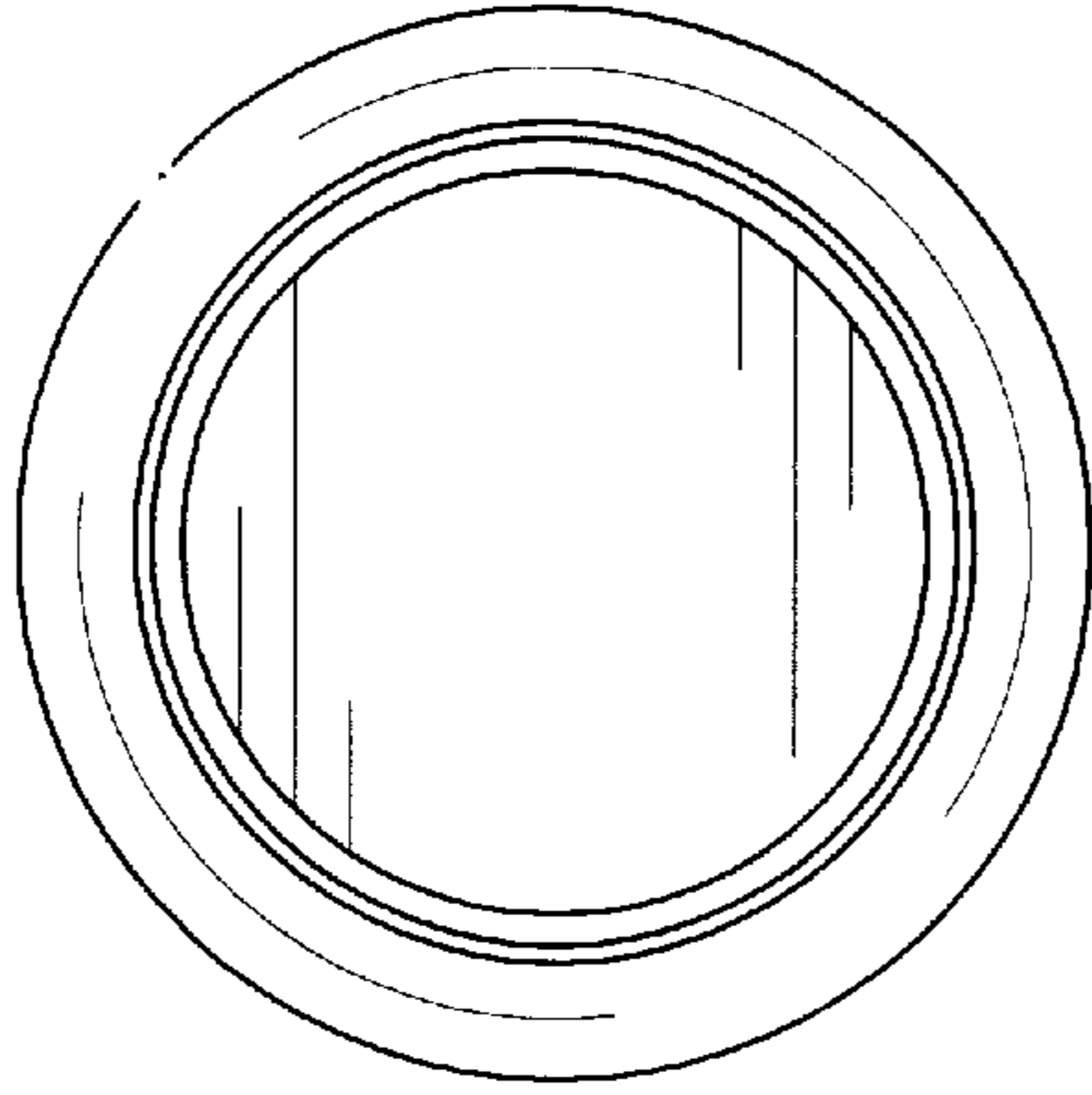

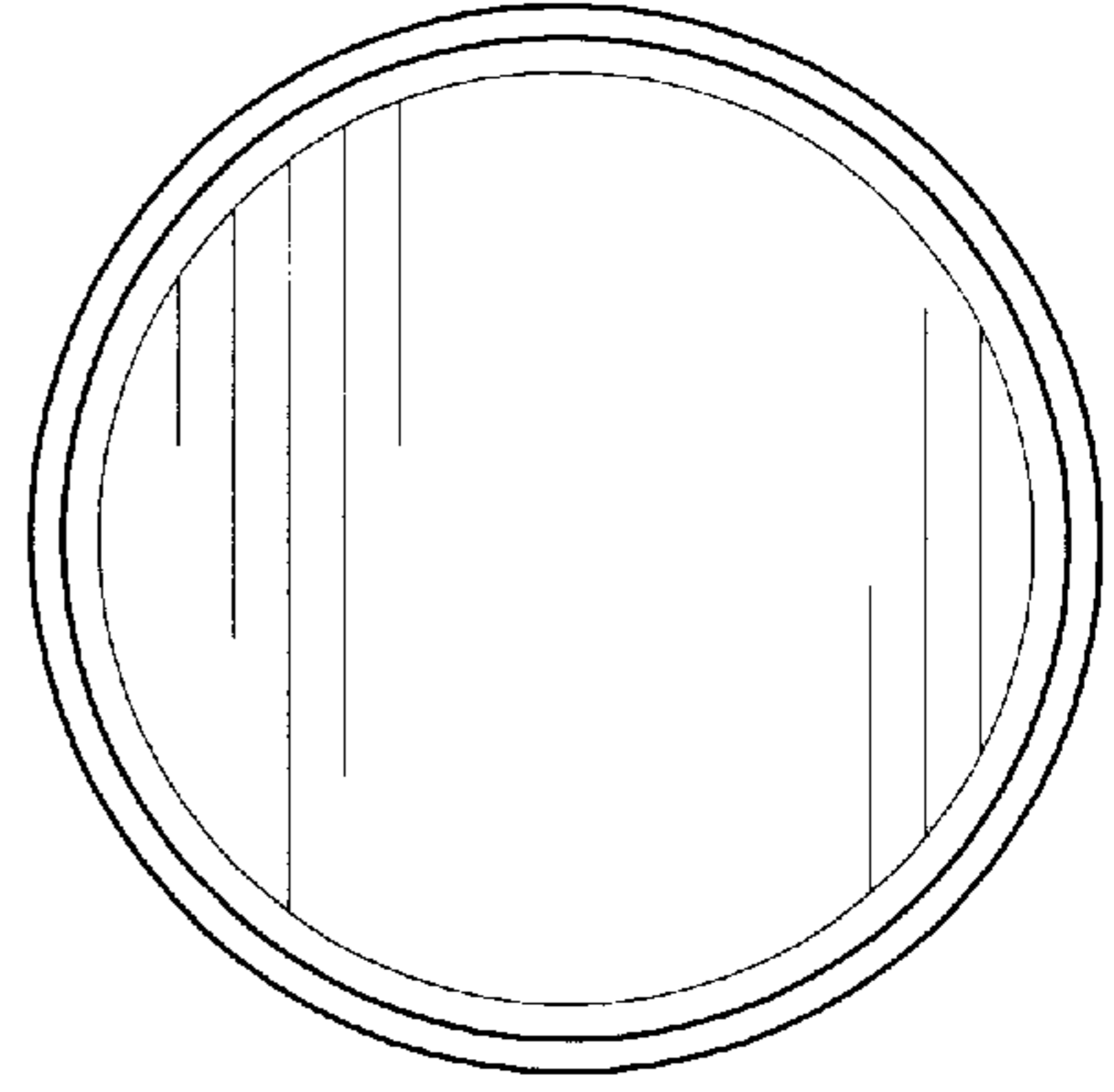

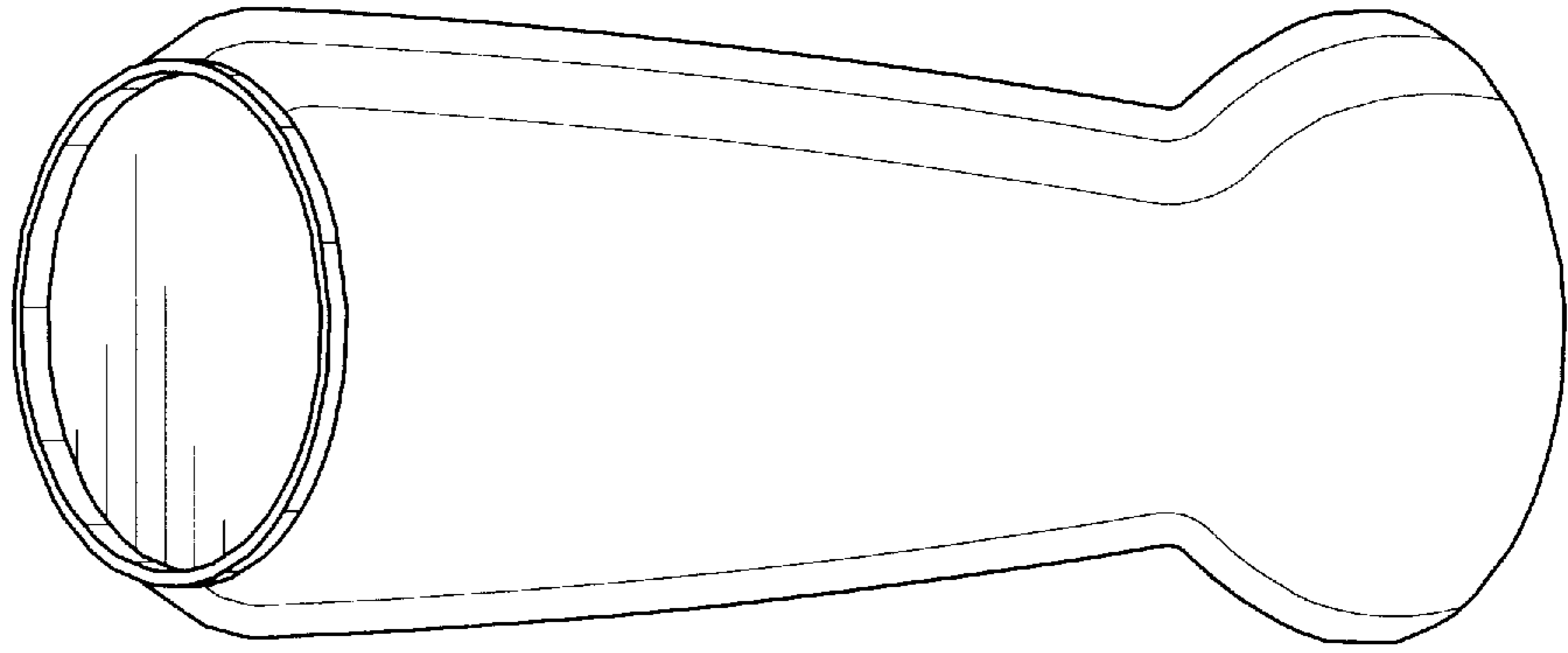

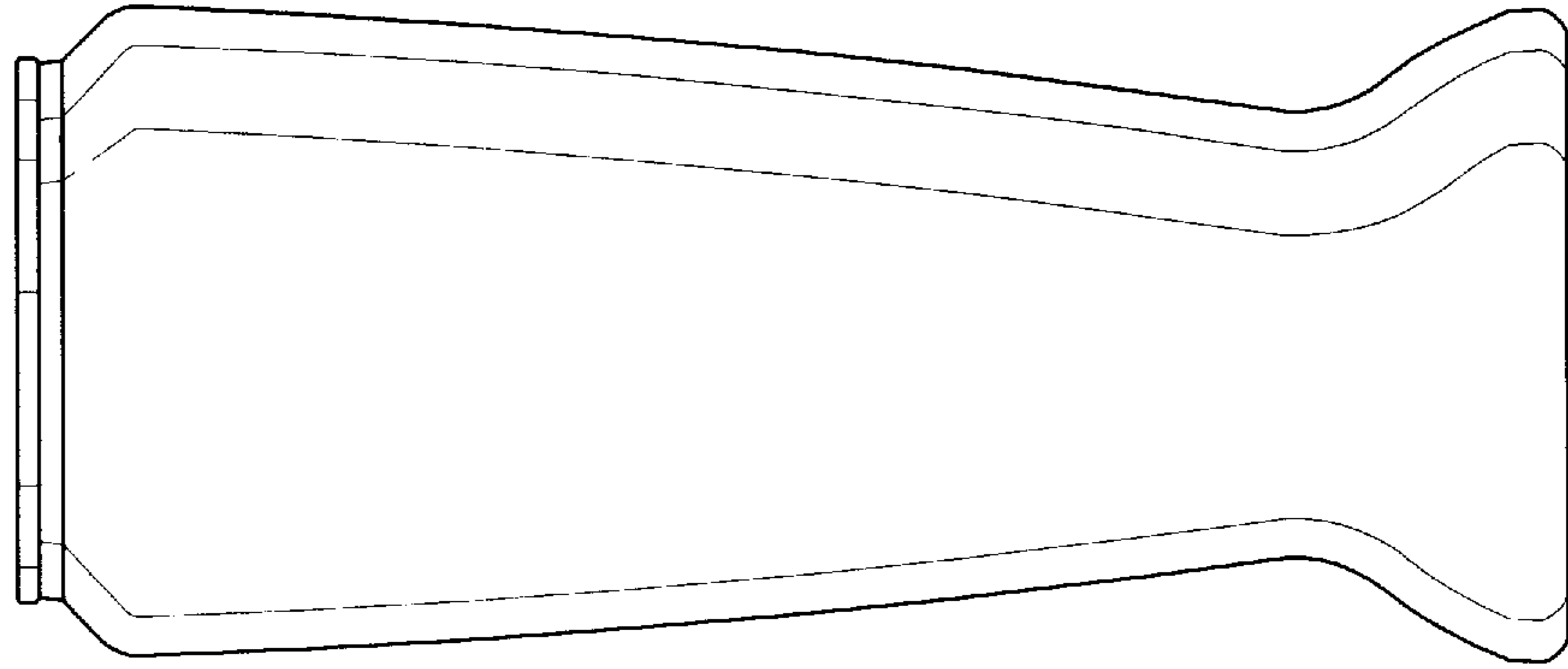

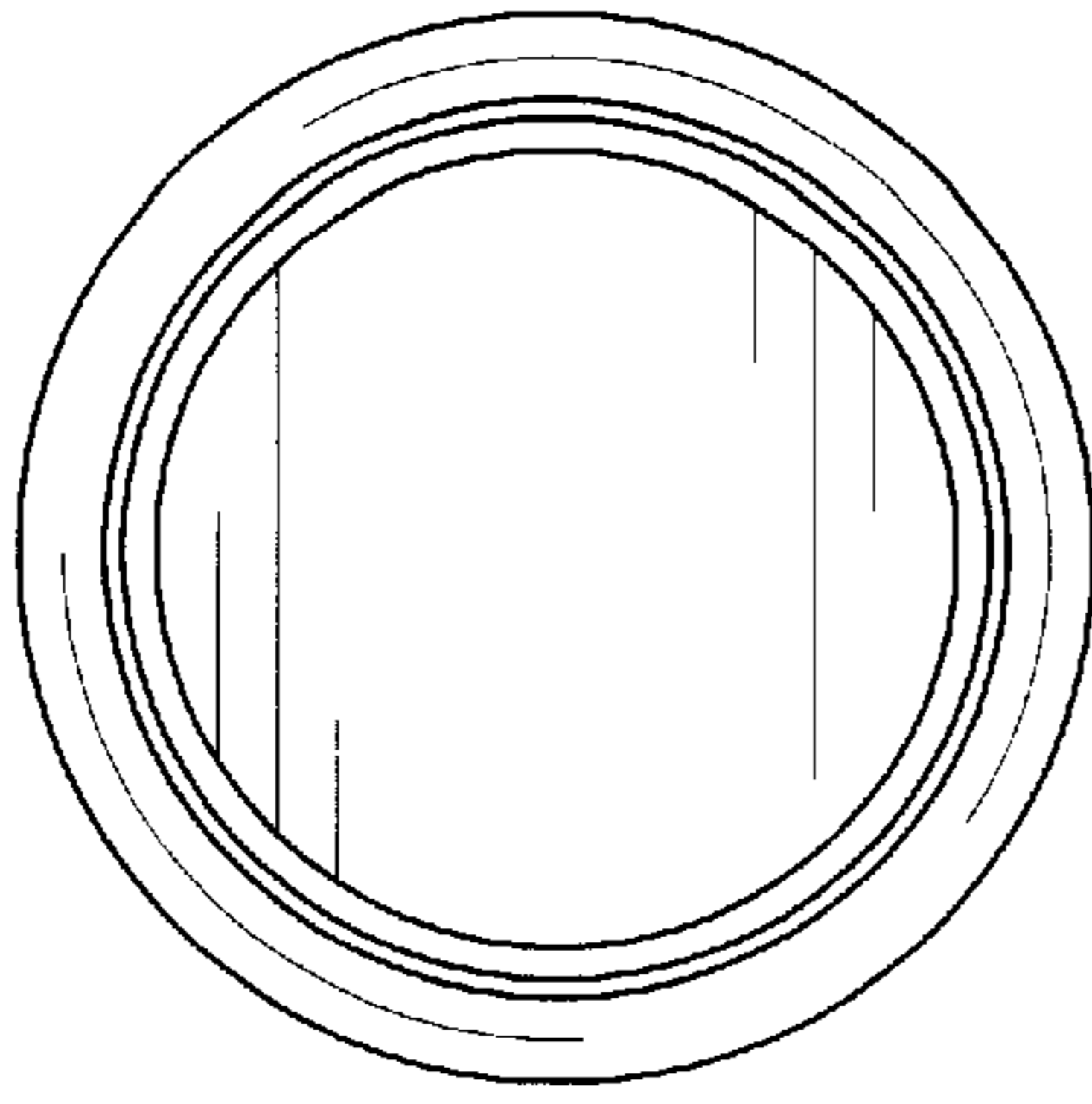
