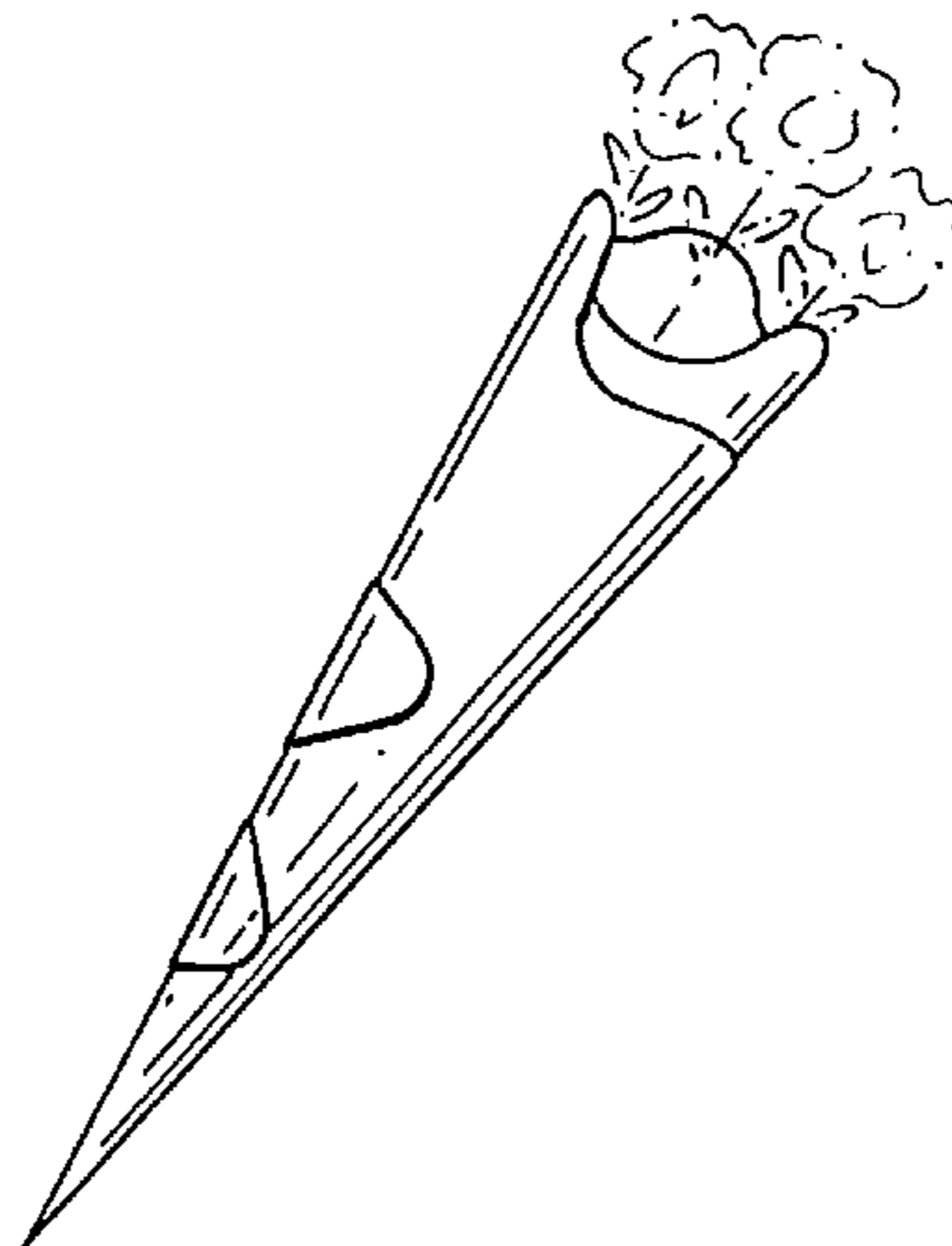
[57] CLAIM

The ornamental design for a floral wrapper, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of our new floral wrapper design; FIG. 2 is a bottom plan view thereof; FIG. 3 is a left side elevational view thereof; FIG. 4 is a right side elevational view thereof; FIG. 5 is an upper end plan view thereof; FIG. 6 is a lower end plan view thereof; and, FIG. 7 is a perspective view thereof. The broken line showing of flowers is for illustrative purposes only and forms no part of the claimed design. The floral wrapper has no substantial thickness.

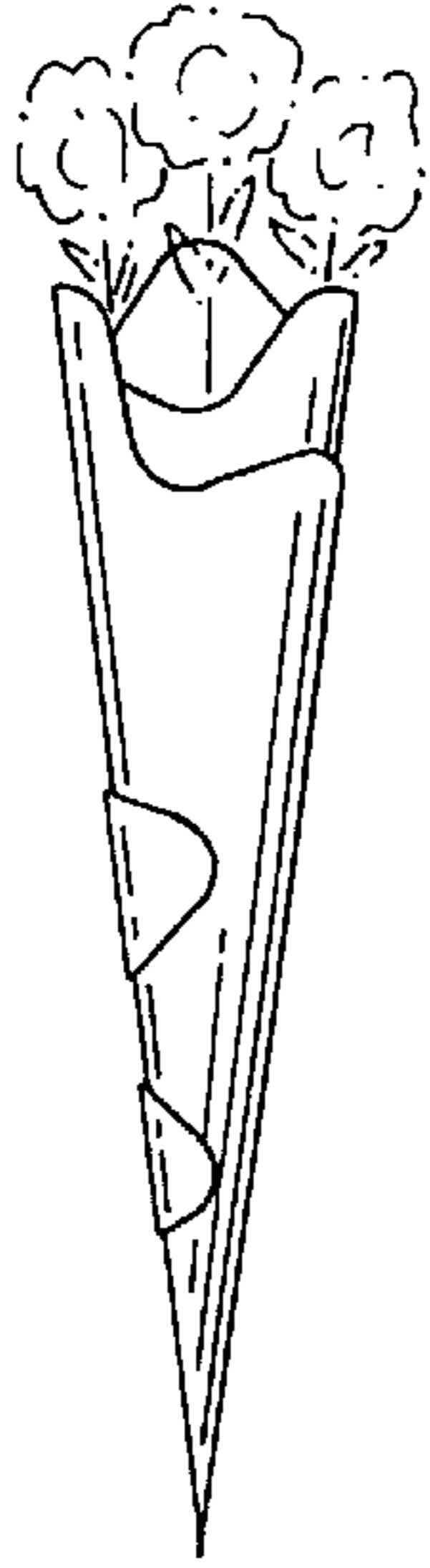

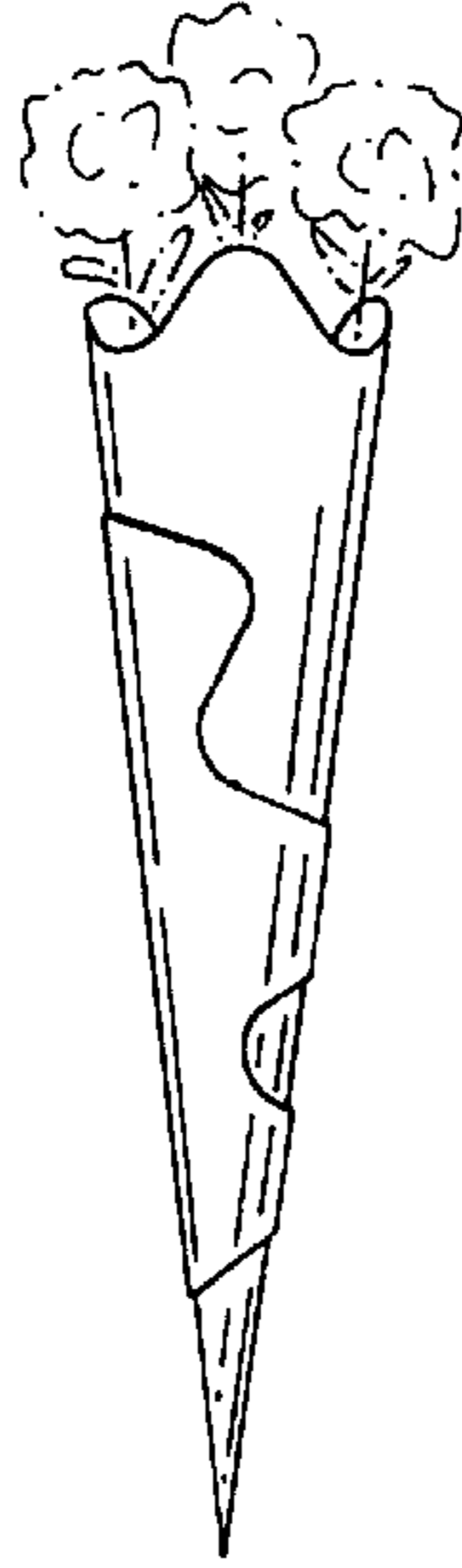

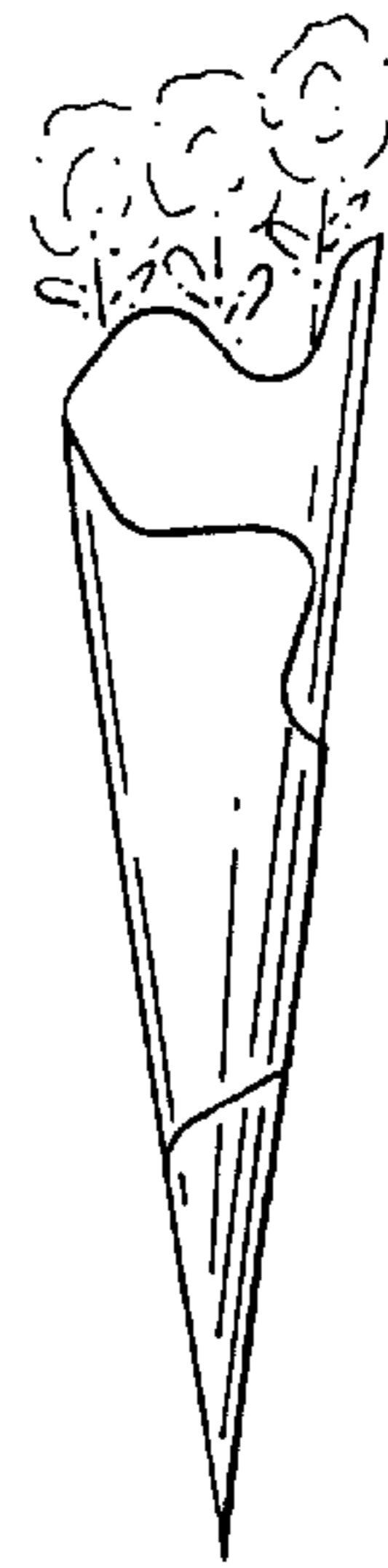

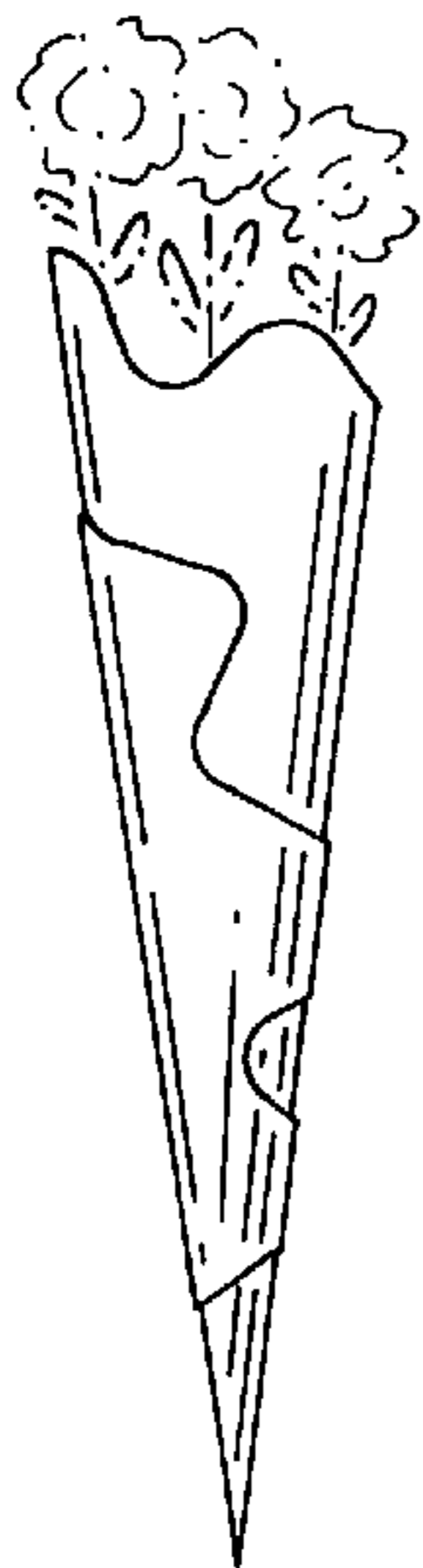
