[57] **CLAIM**

The ornamental design for a portion of a zipper pull, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a portion of a zipper pull

showing my new design, the bottom plan view being the same;

FIG. 2 is a right side elevational view, the left side being the same;

FIG. 3 is a right end elevational view;

FIG. 4 is a left end elevational view;

FIG. 5 is a top plan view of a portion of a zipper pull showing a second embodiment of my new design, the bottom plan view being the same;

FIG. 6 is a right side elevational view of FIG. 5, the left side being the same;

FIG. 7 is a right end elevational view of FIG. 5;

FIG. 8 is a left end elevational view of FIG. 5;

FIG. 9 is a top plan view of a portion of a zipper pull showing a third embodiment of my new design, the bottom plan view being the same;

FIG. 10 is a right side elevational view of FIG. 9, the left side elevational view being the same;

FIG. 11 is a right end elevational view of FIG. 9; and,

FIG. 12 is a left end elevational view of FIG. 9. The broken line showing of a zipper pull, in FIGS. 1–12, is for illustrative purposes only and forms no part of the claimed design.

The broken lines shown in FIGS. 1–12 of the drawings are for illustrative purposes only and the subject matter depicted thereby constitutes no part of the claimed design.

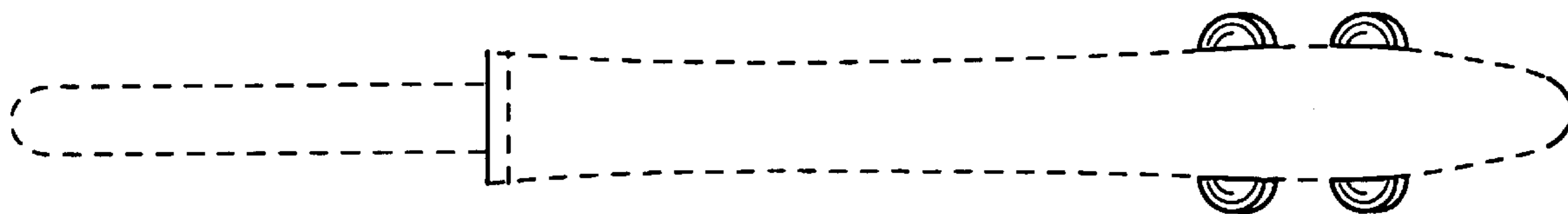

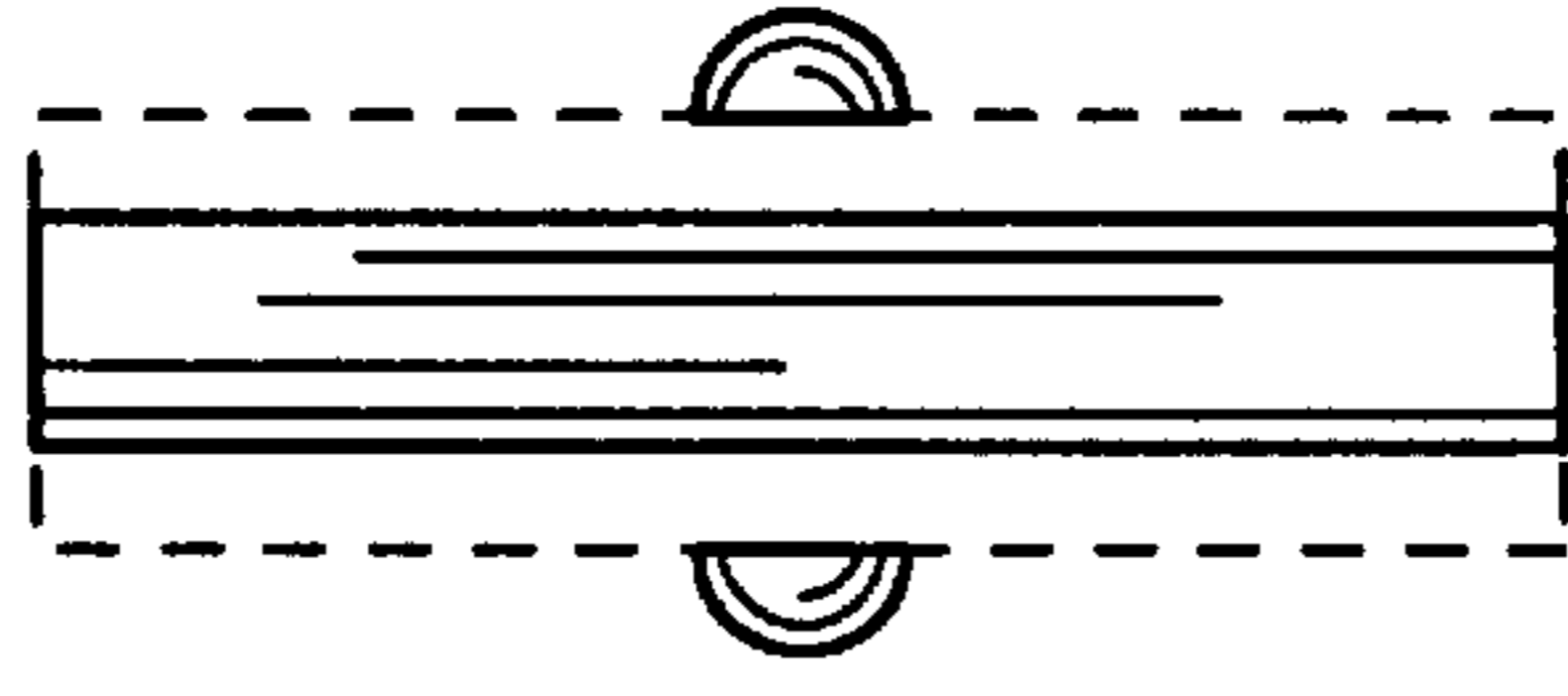

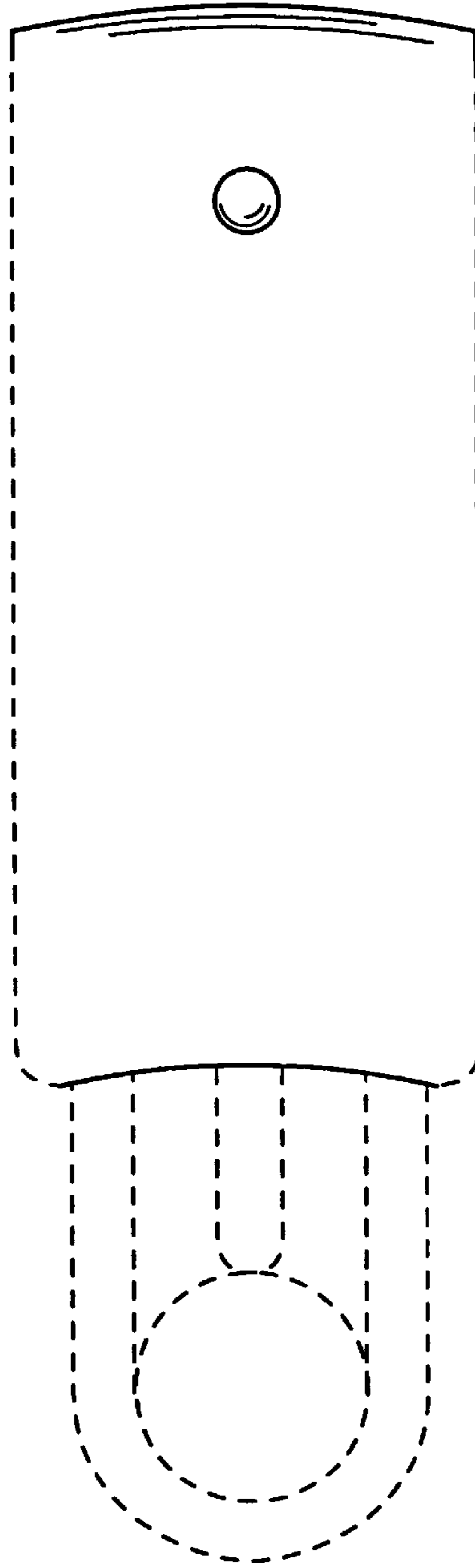

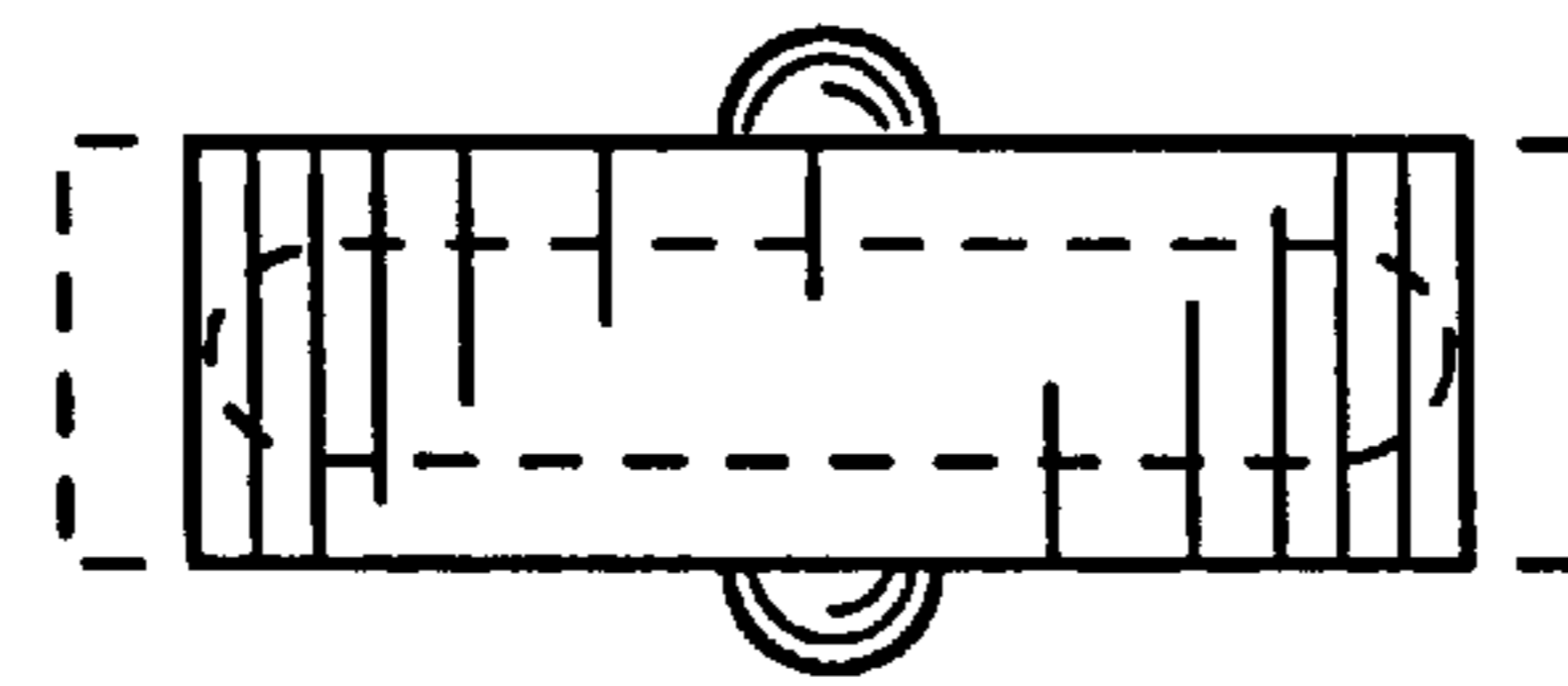

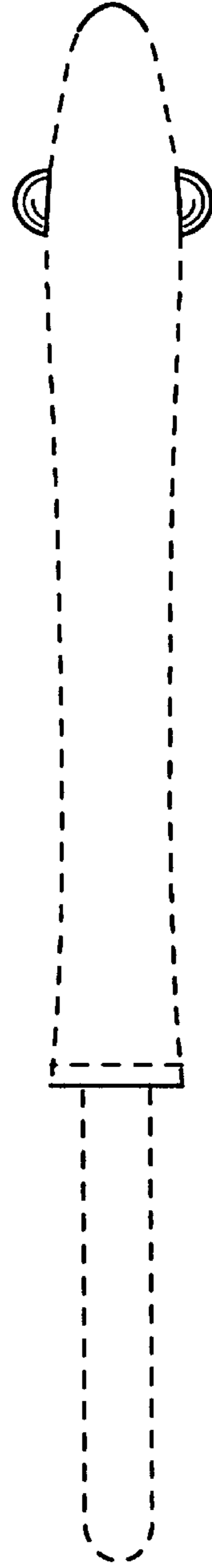

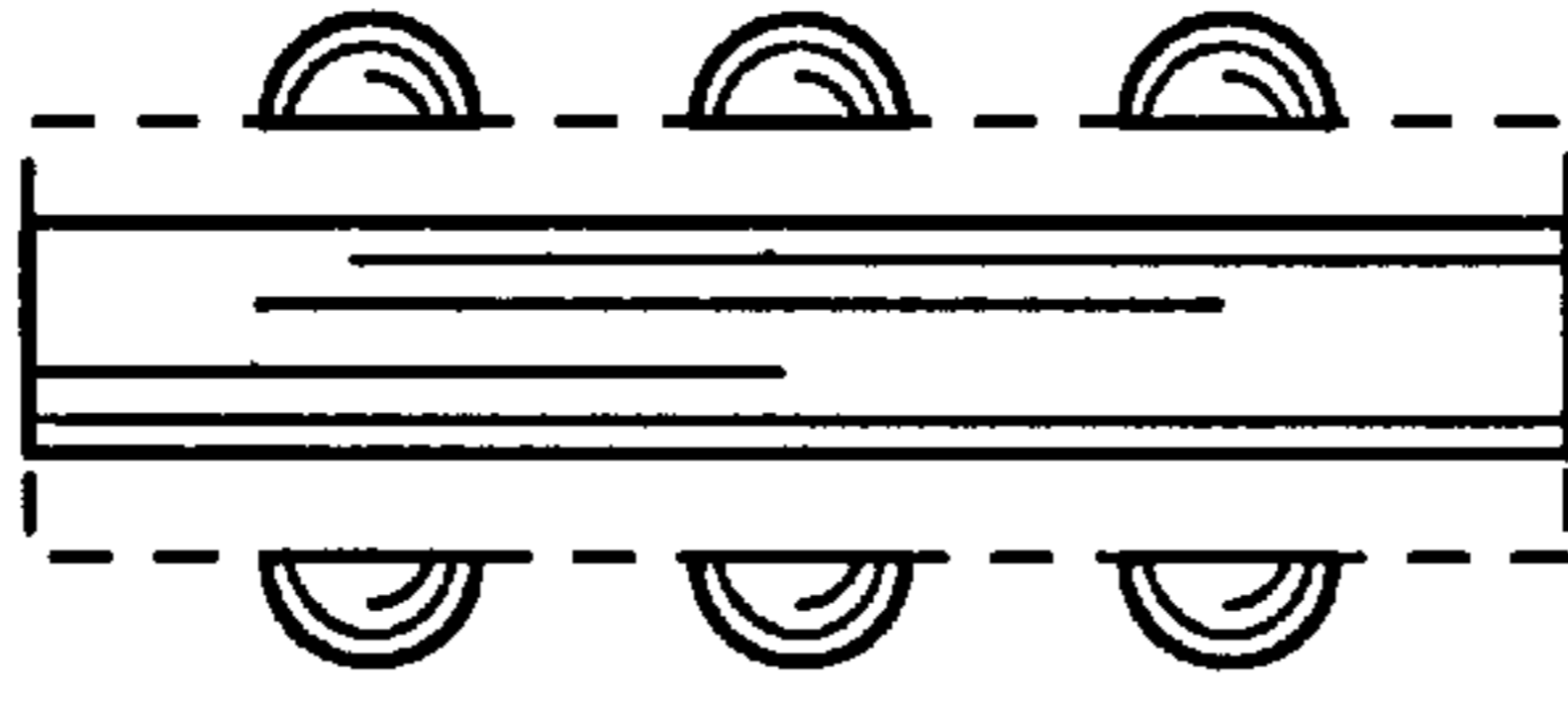

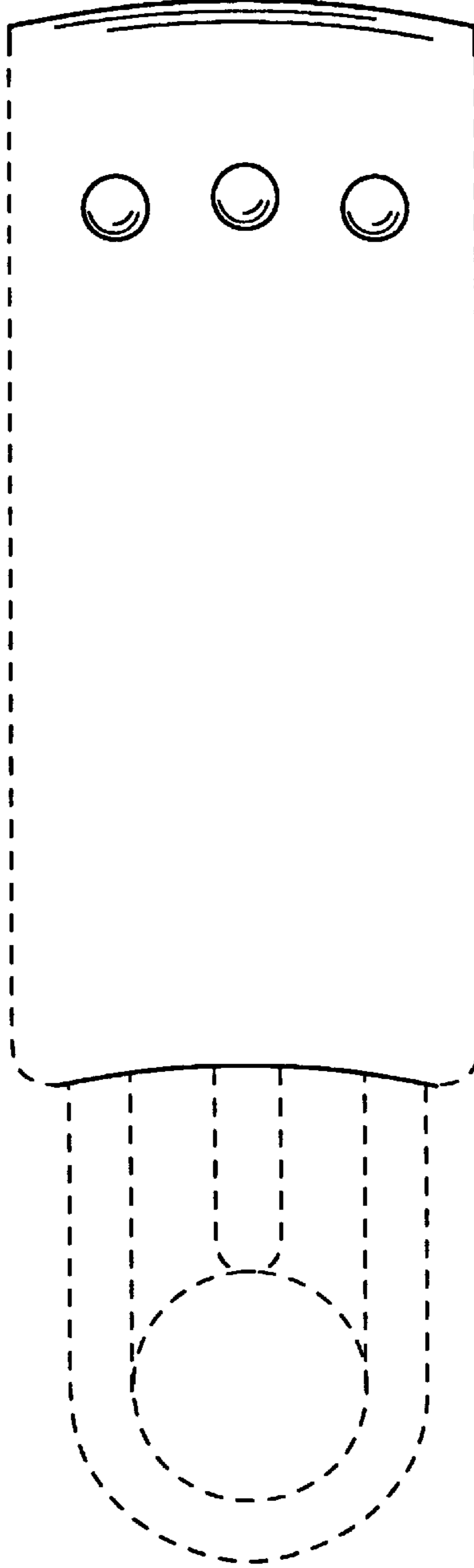

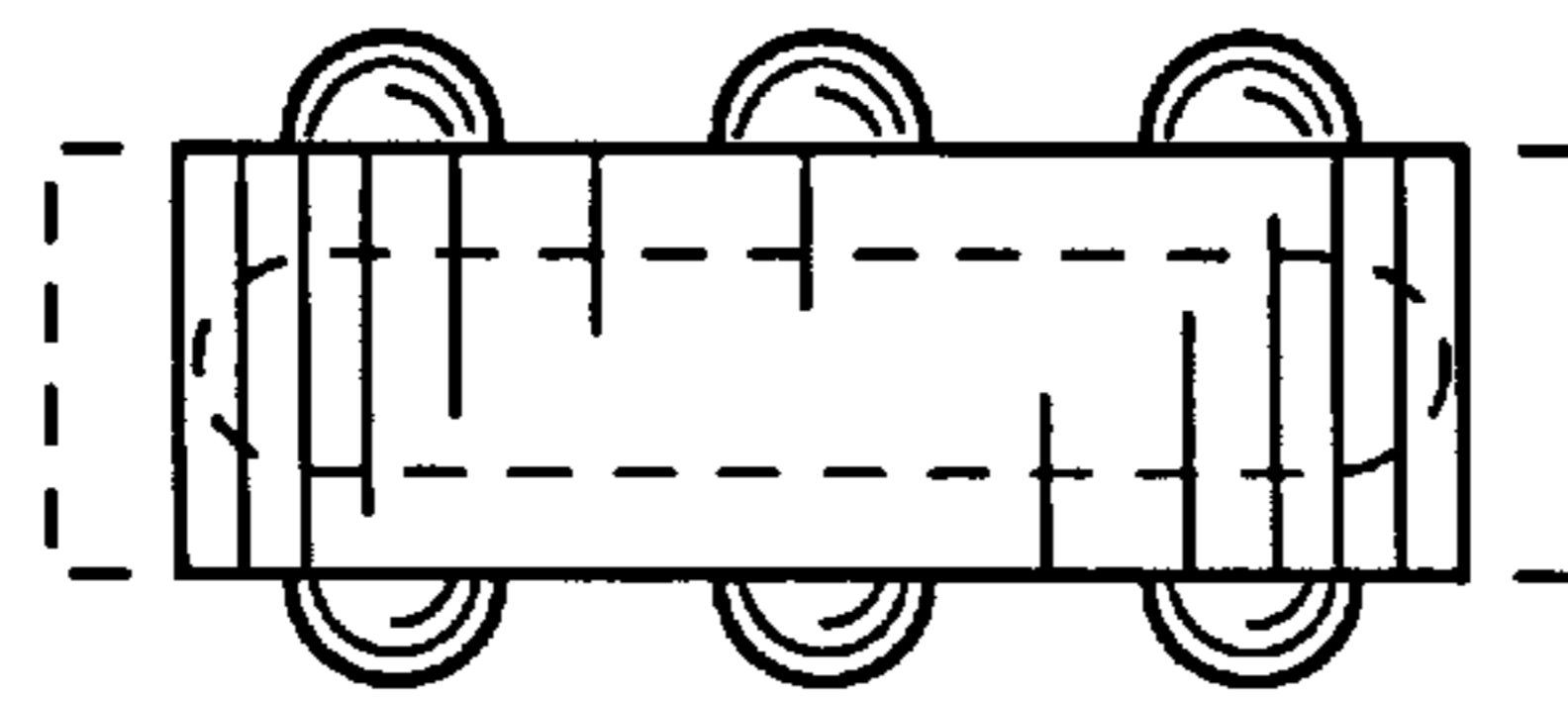

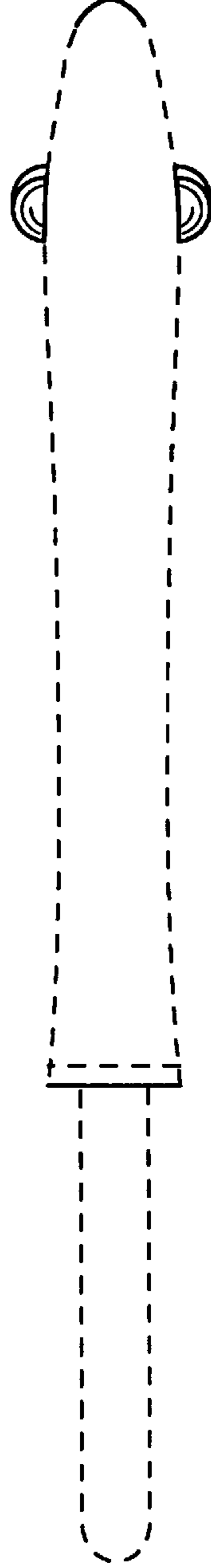

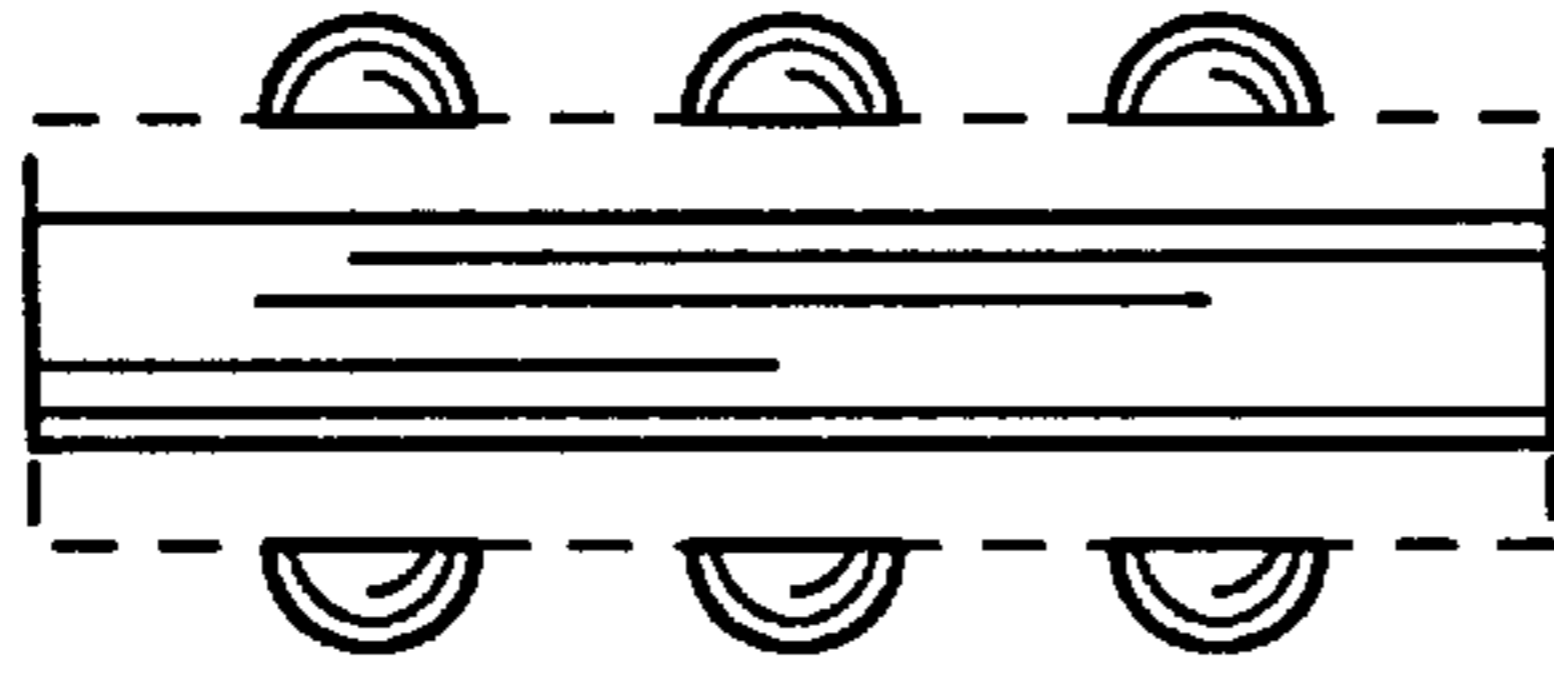

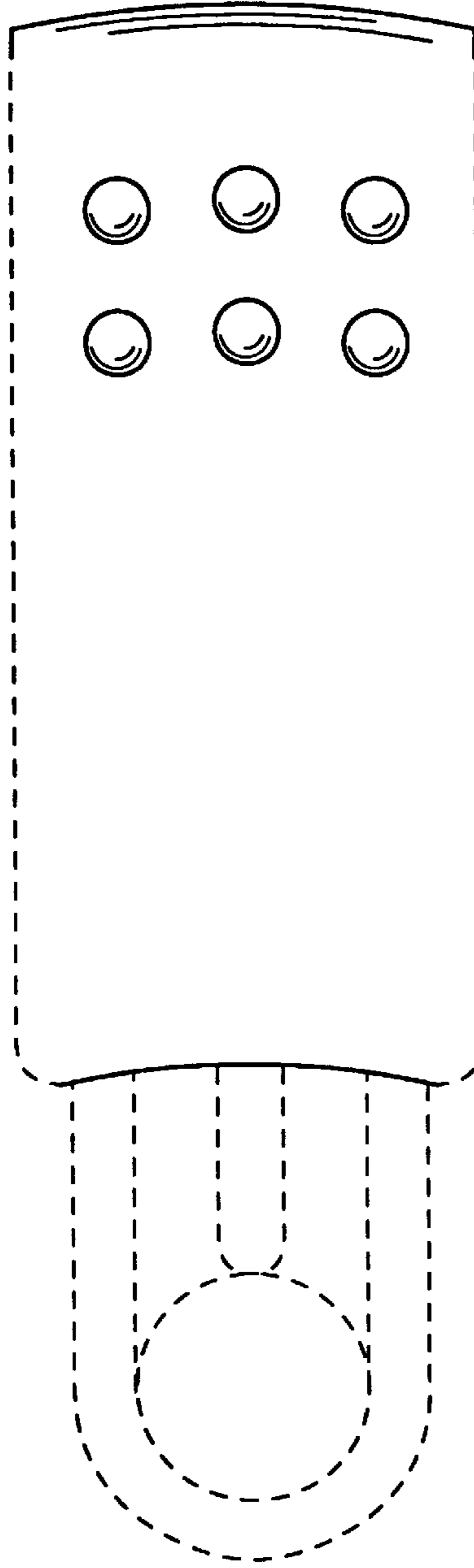

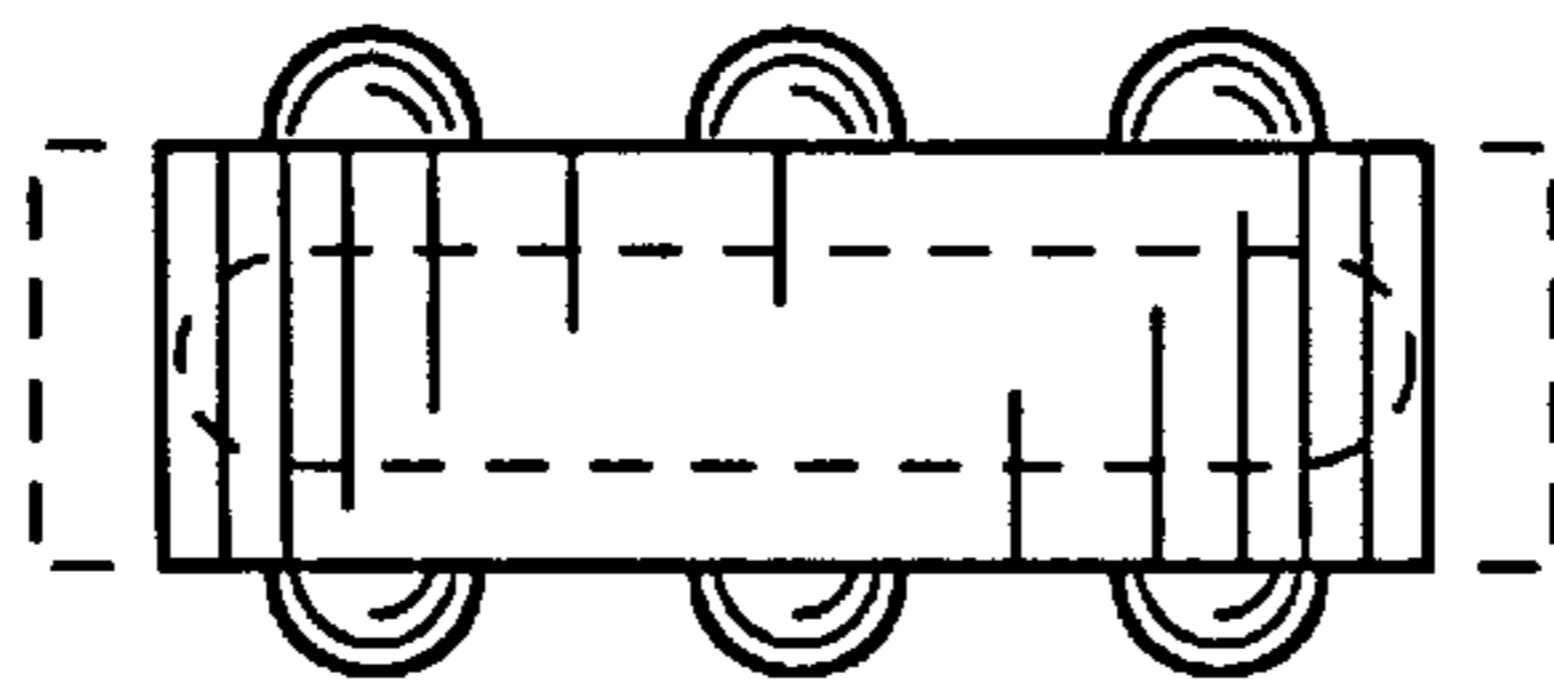
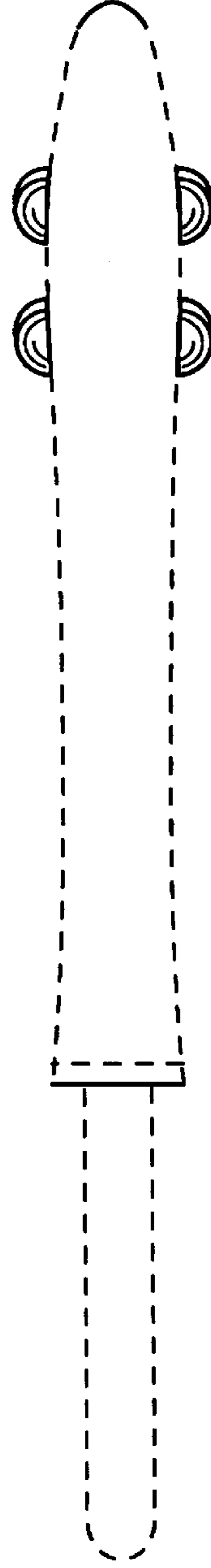
