The ornamental design for a walker frame with bottom slide members, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a walker frame with bottom slide members showing my new design;

FIG. 2 is a top plan view of a second embodiment of the walker frame with bottom slide members;

FIG. 3 is a left side elevational view of FIG. 2;

FIG. 4 is a front elevational view of FIG. 2;

FIG. 5 is a right side elevational view of FIG. 2;

FIG. 6 is an enlarged view of a bottom slide member of the walker frame;

FIG. 7 is a bottom plan view of FIG. 2;

FIG. 8 is a rear elevational view of FIG. 2;

FIG. 9 is a top plan view of FIG. 1;

FIG. 10 is a left side elevational view of FIG. 1;

FIG. 11 is a front elevational view of FIG. 1;

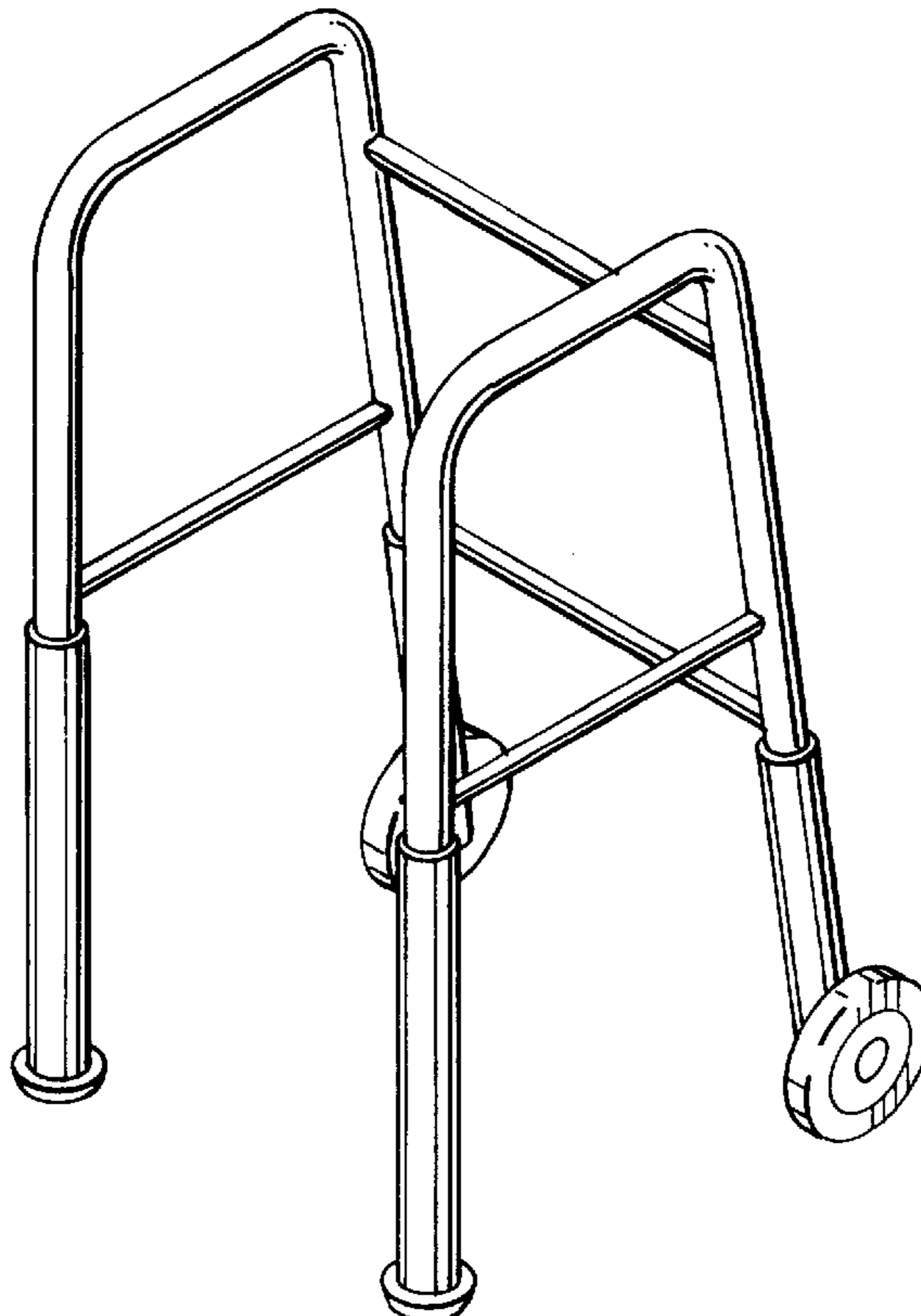

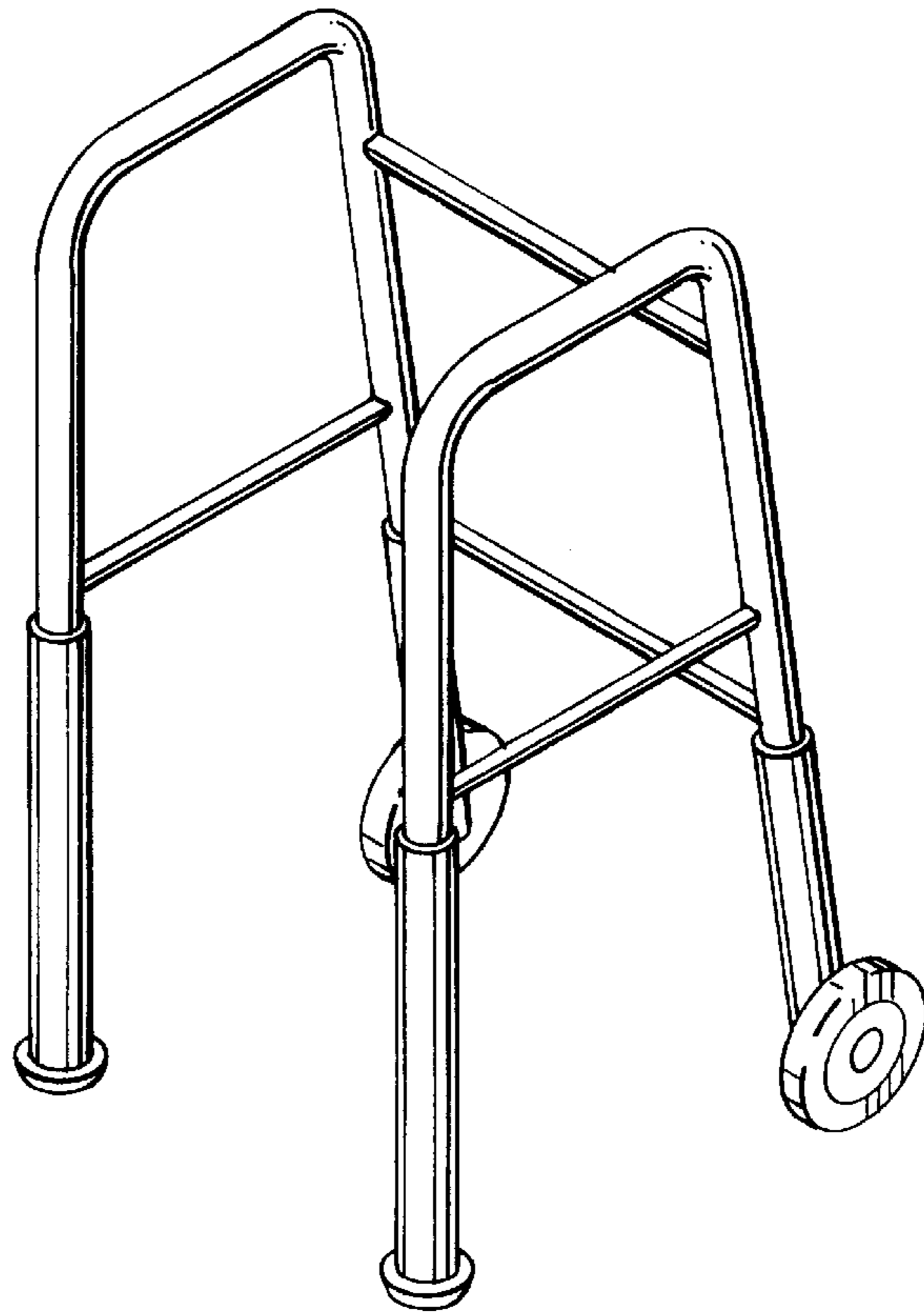

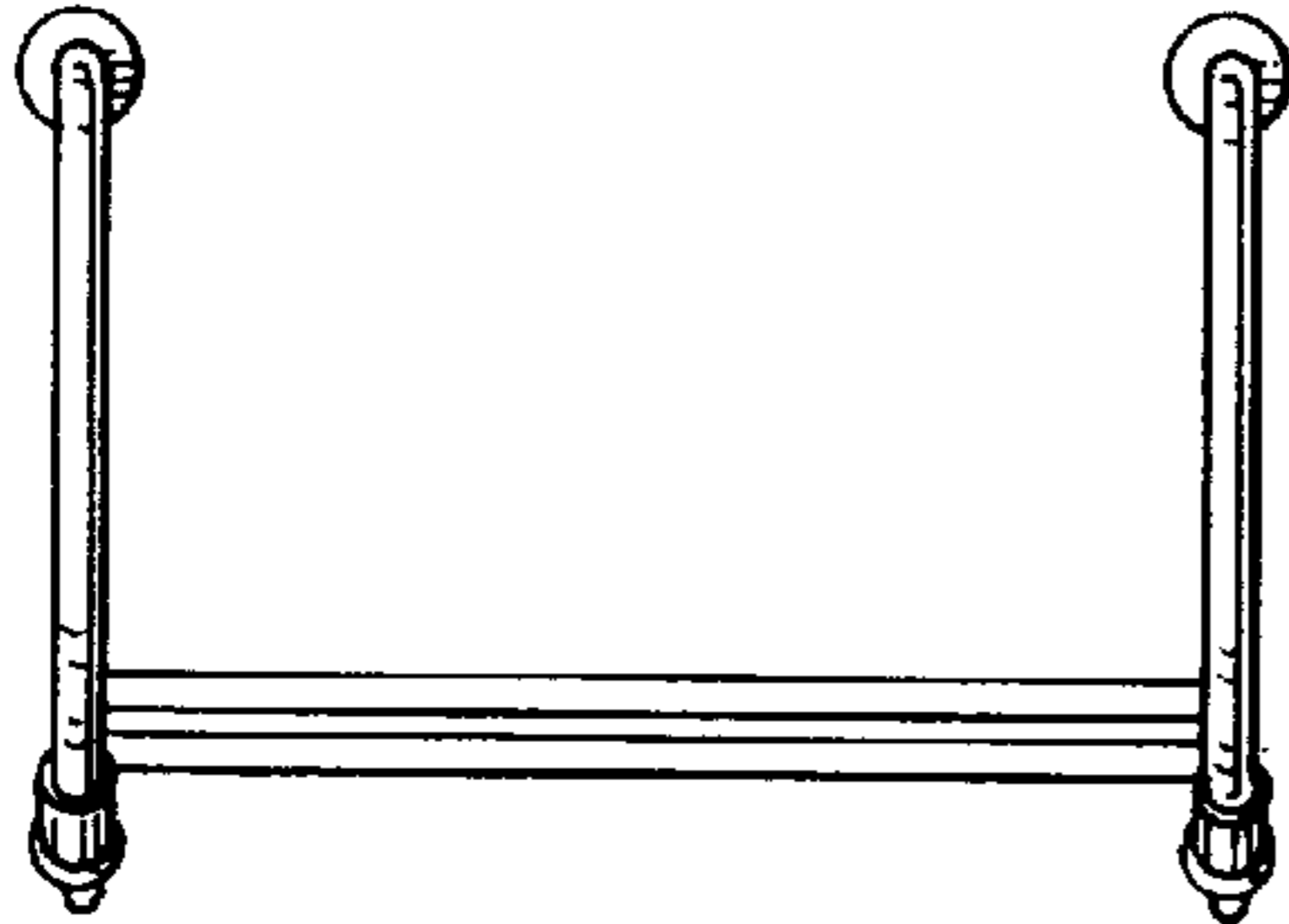

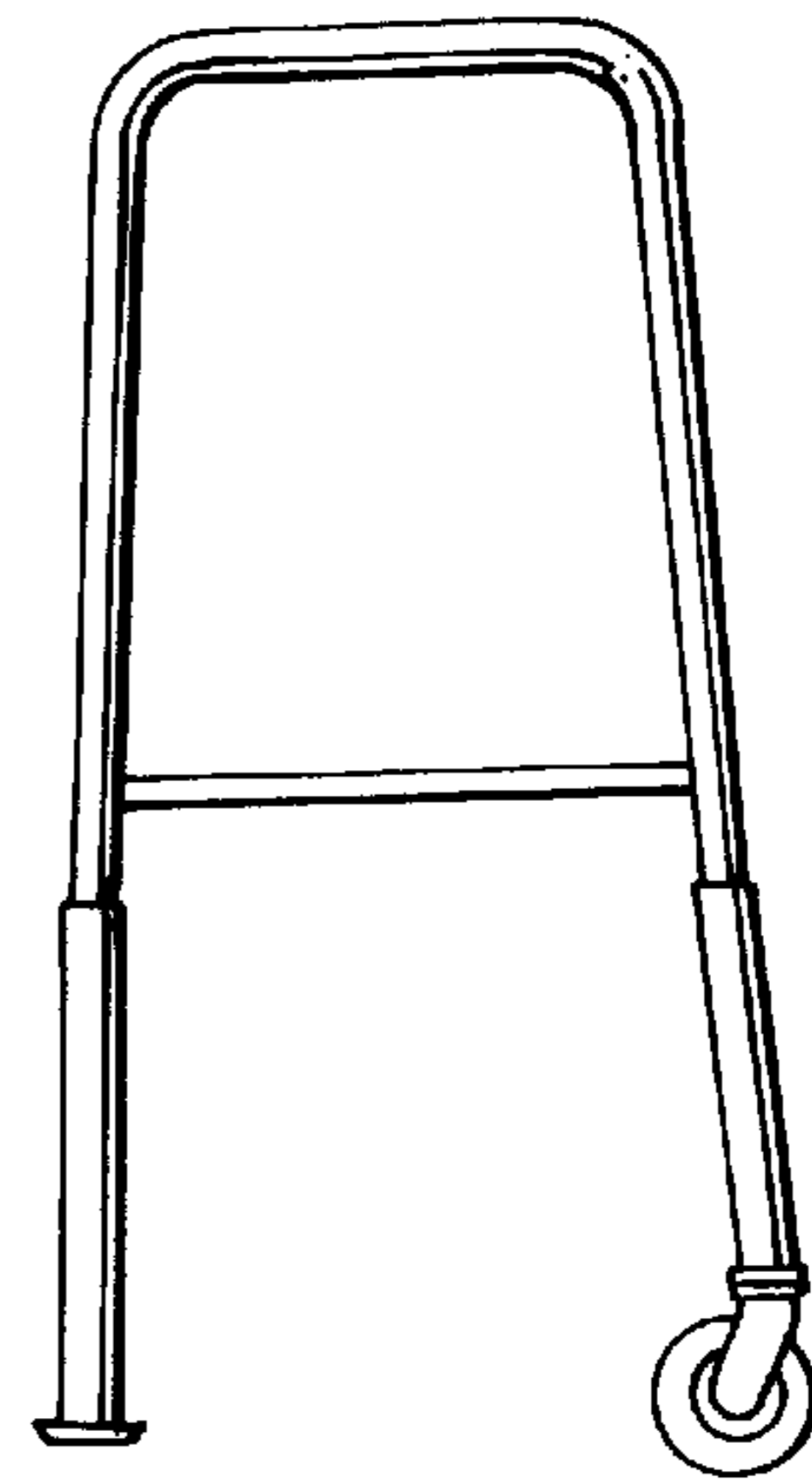

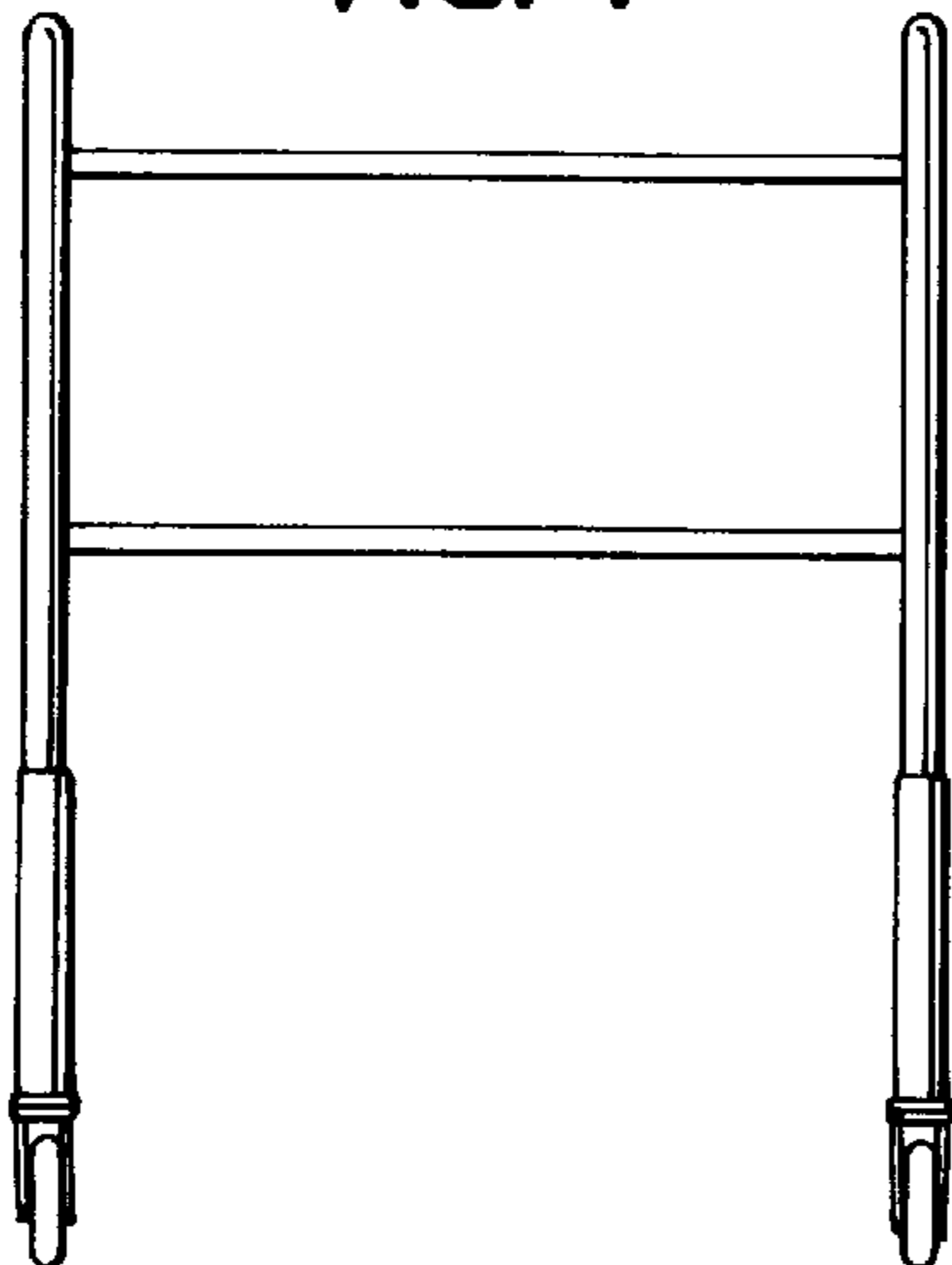

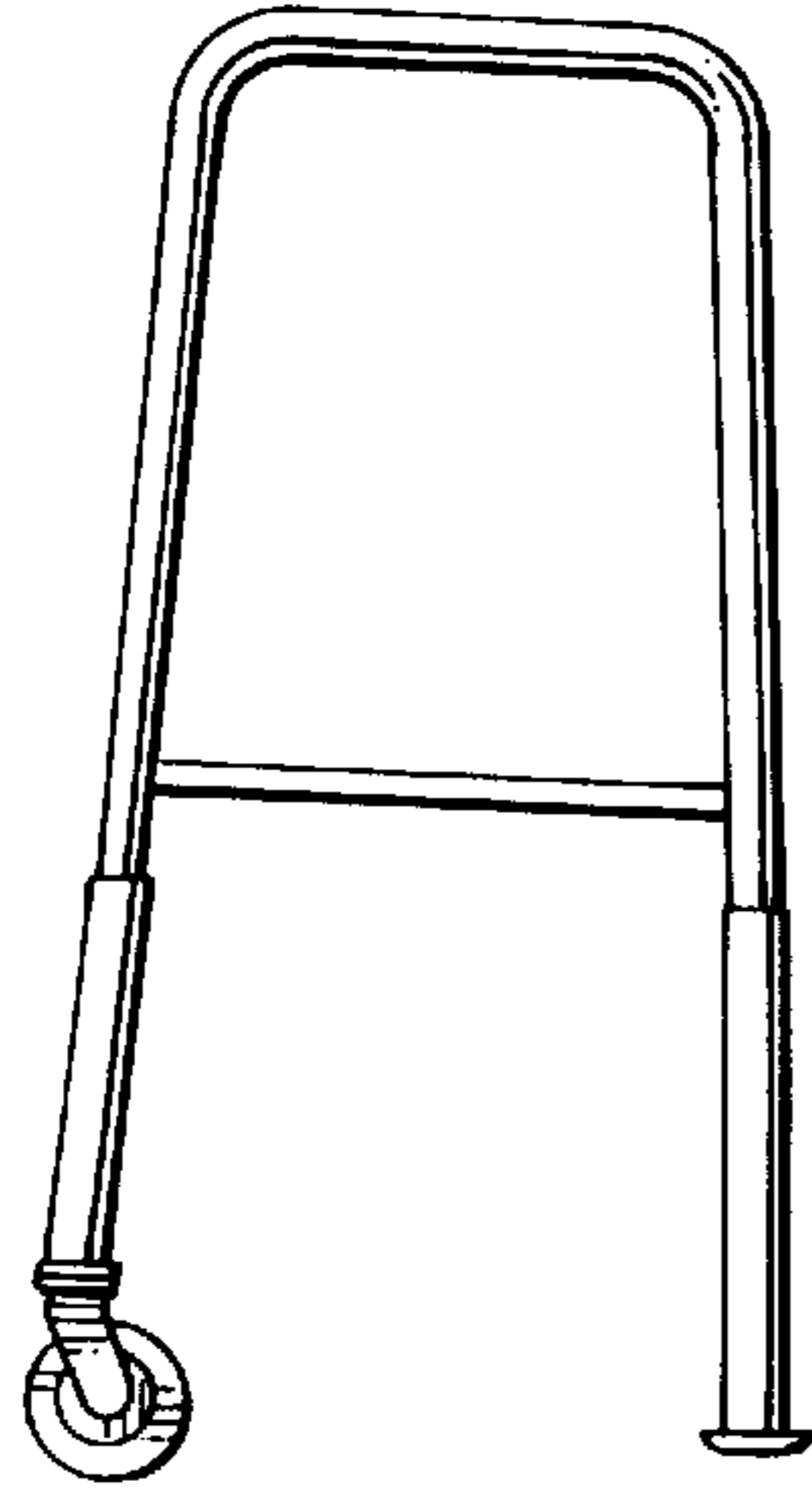

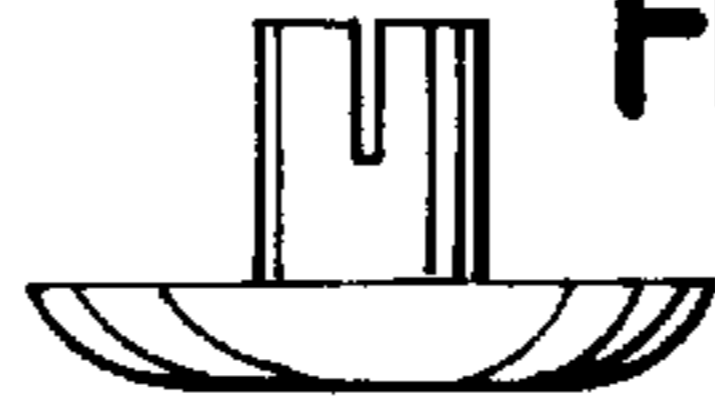

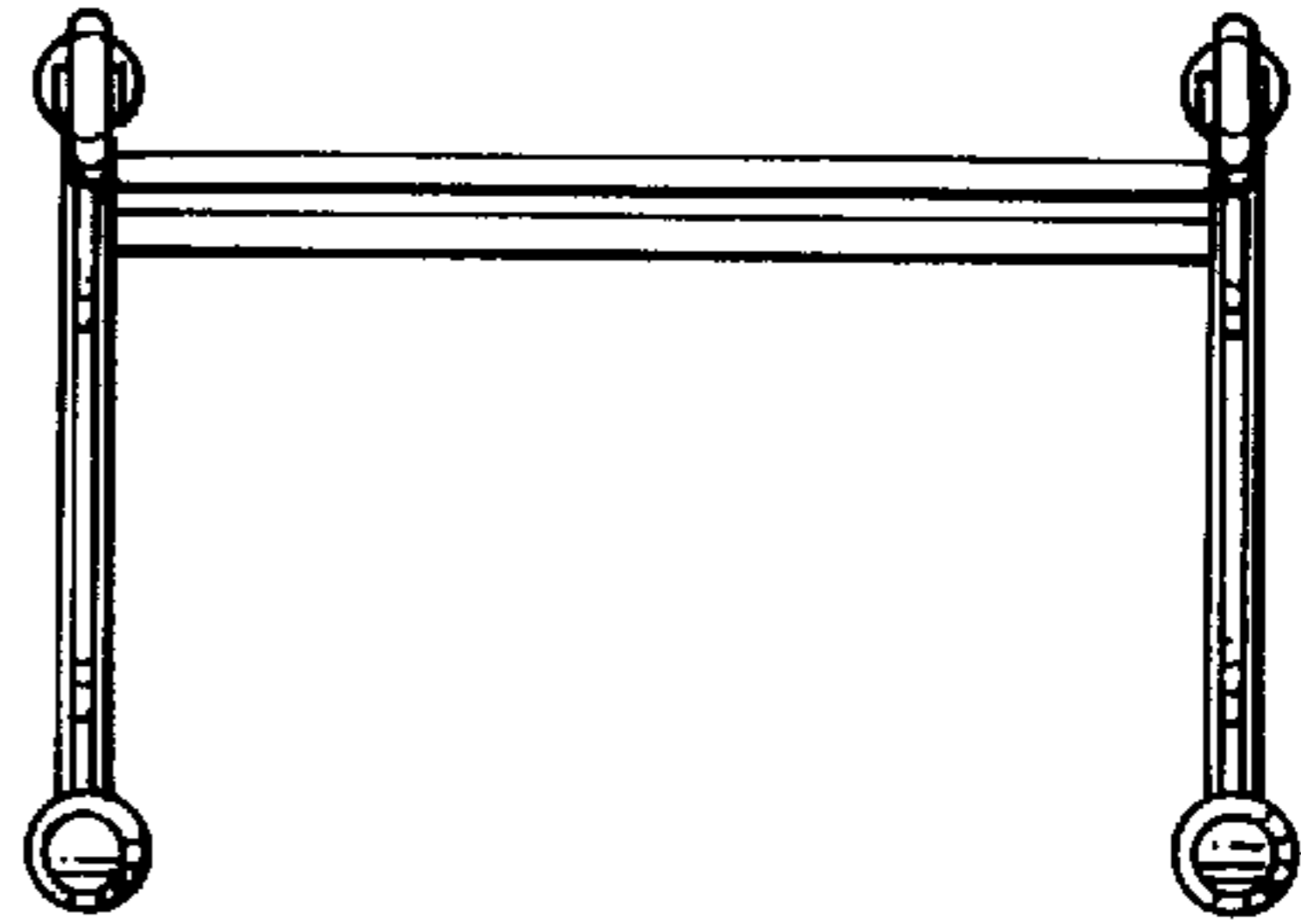

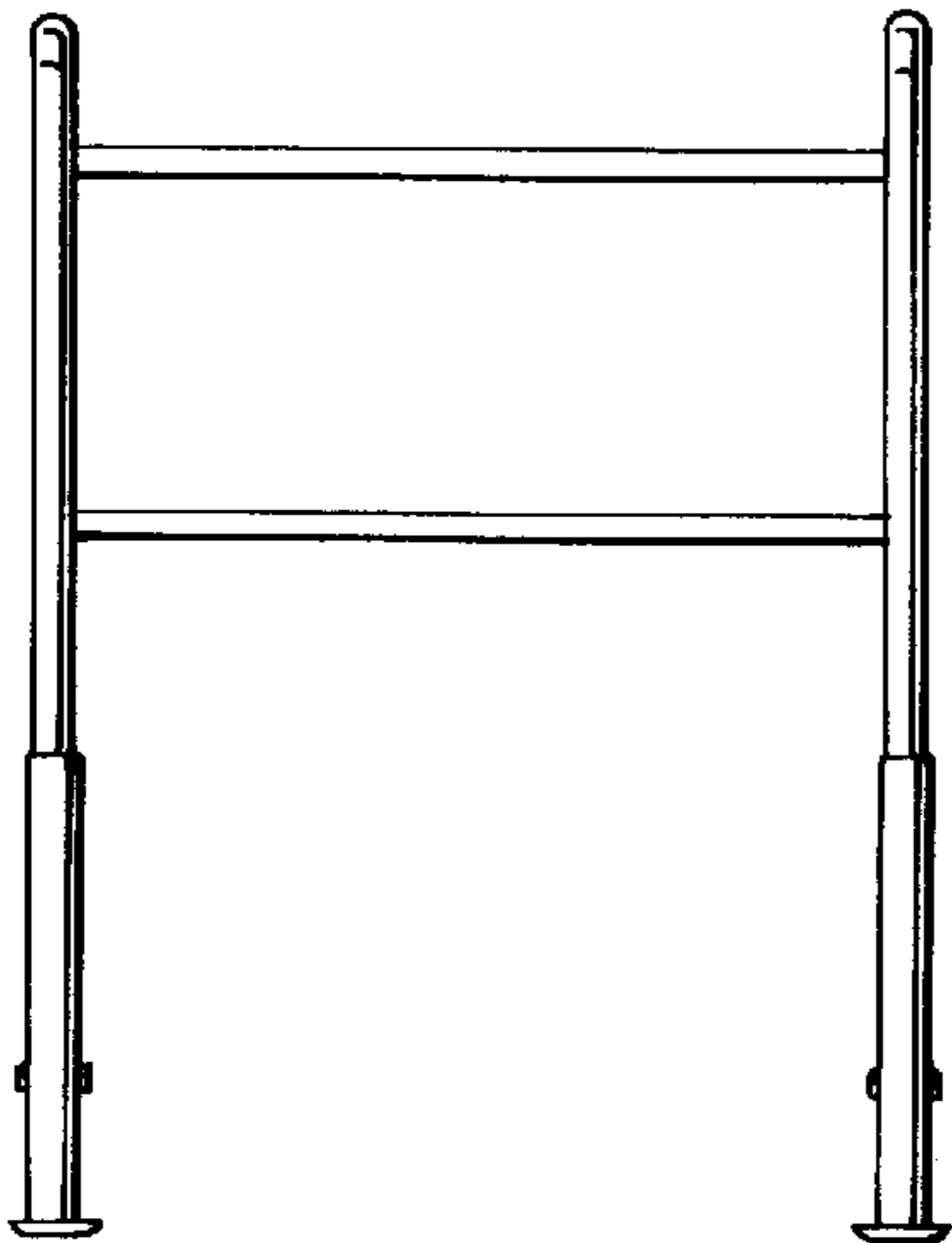

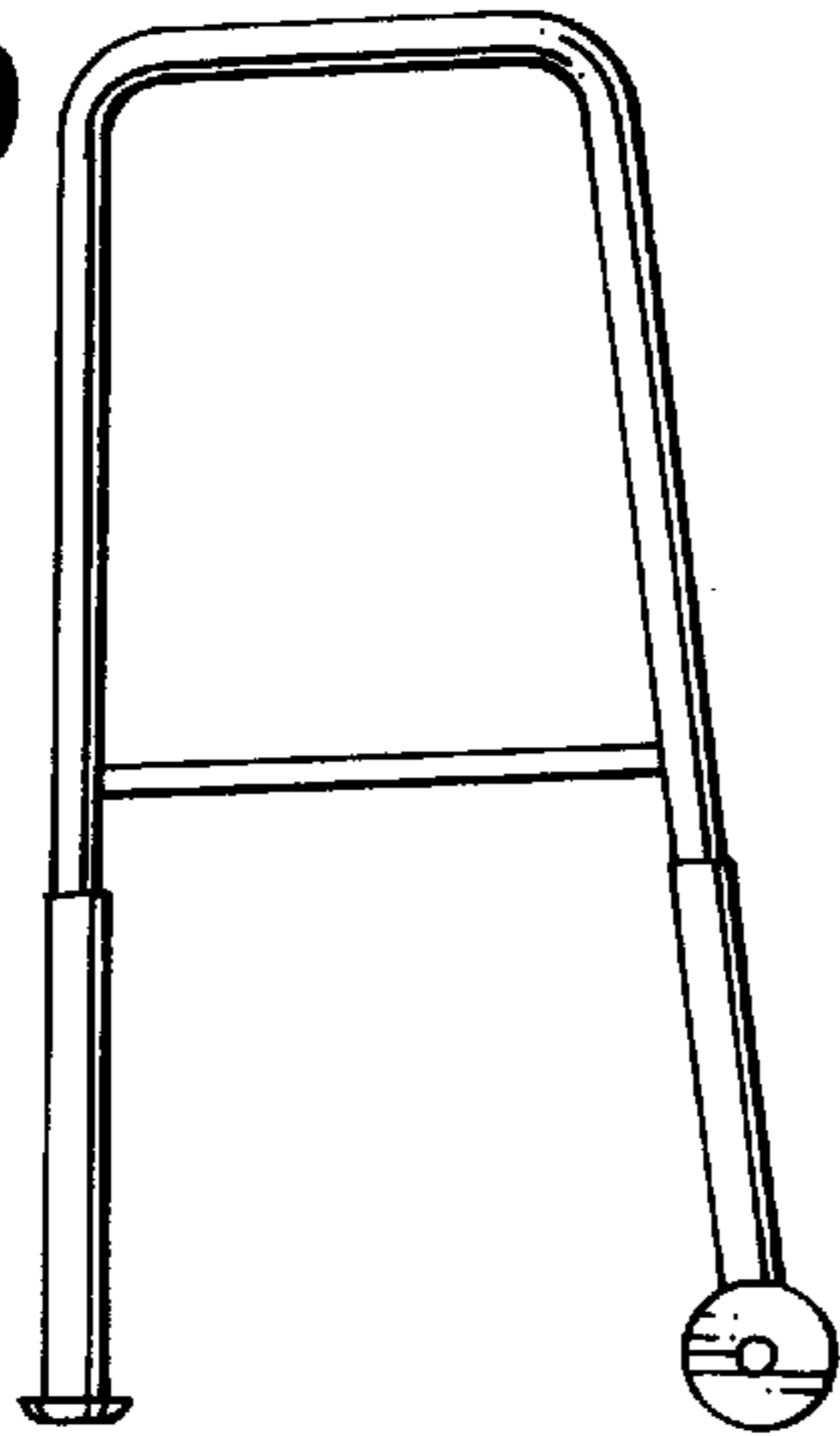

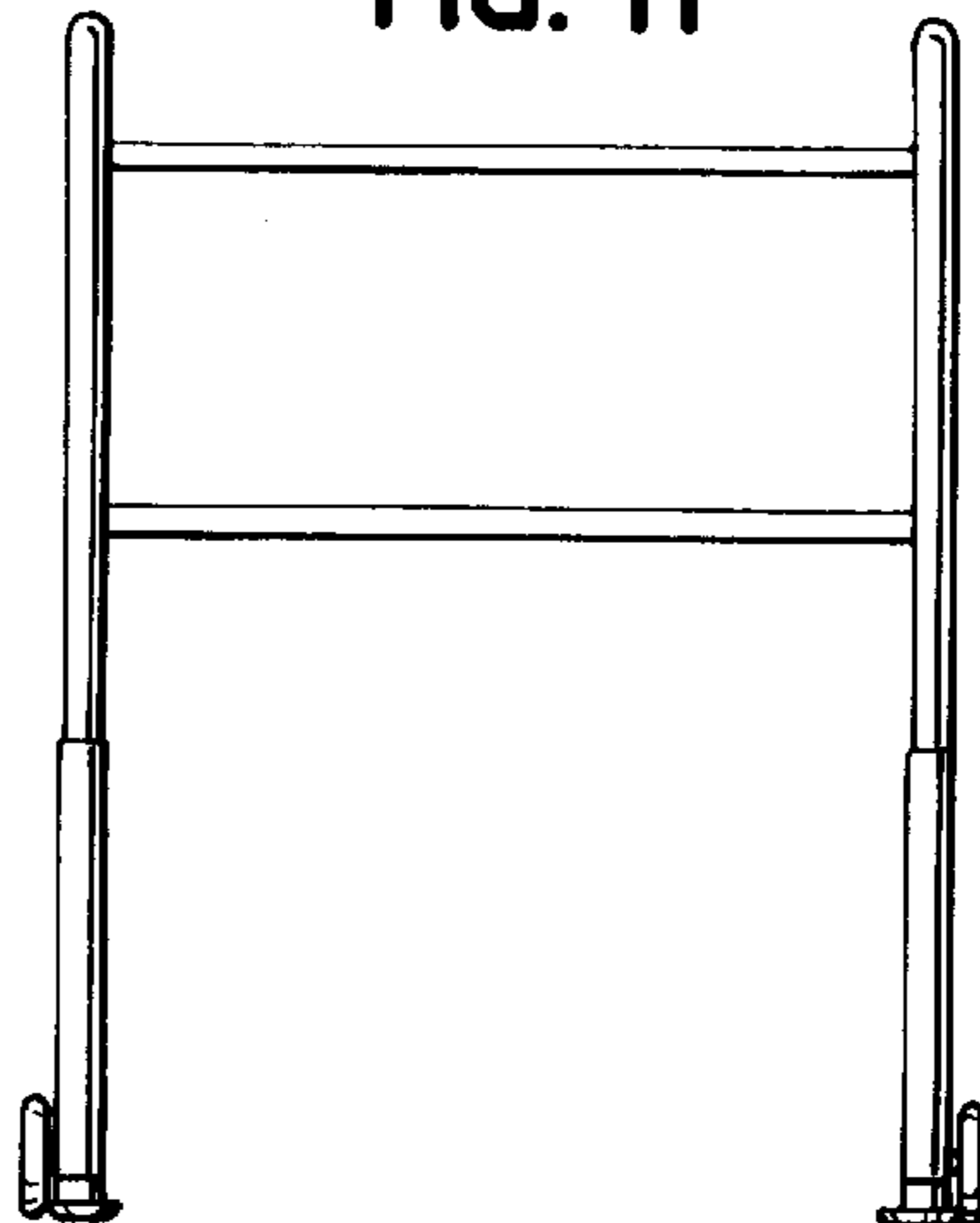

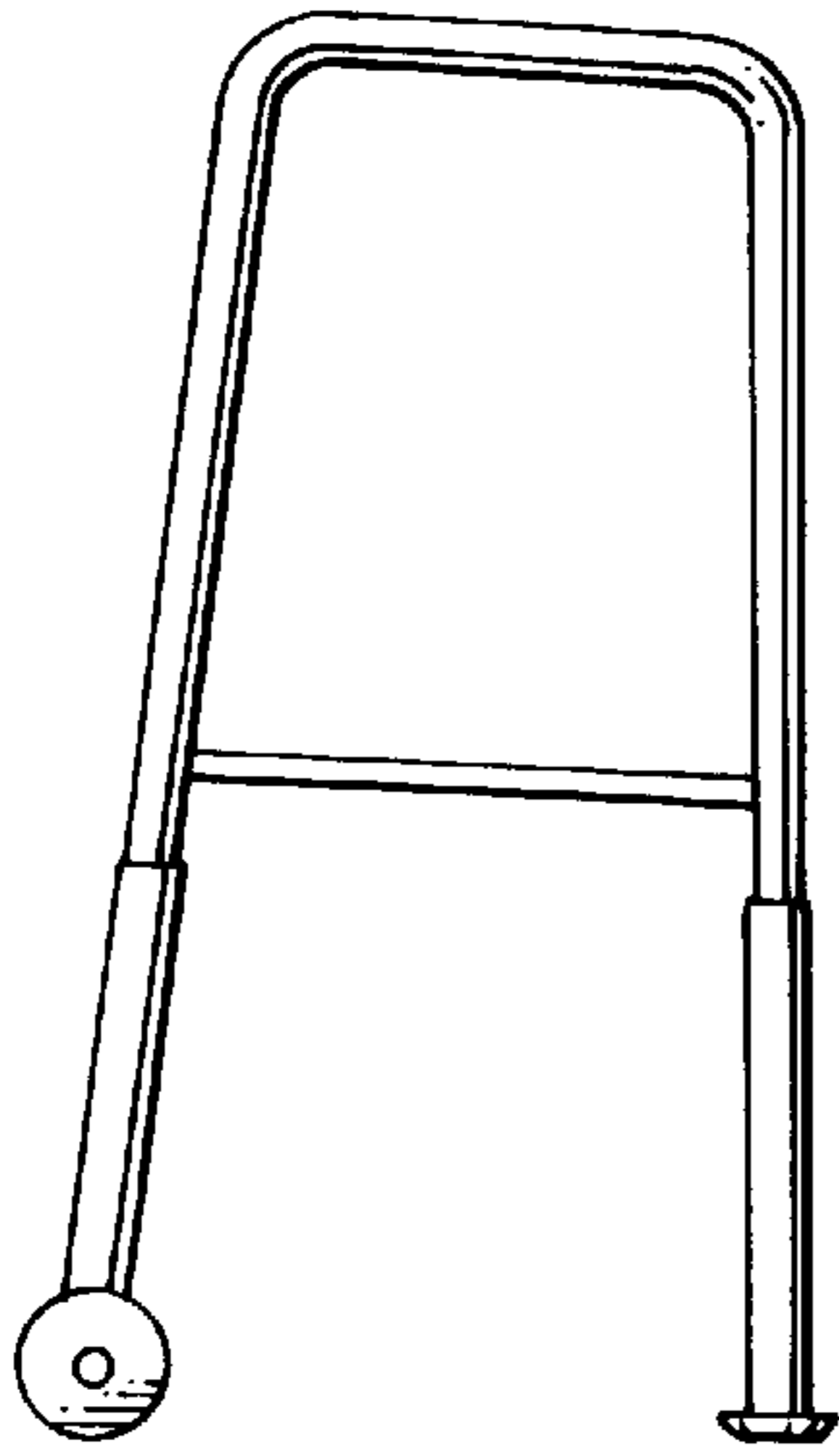

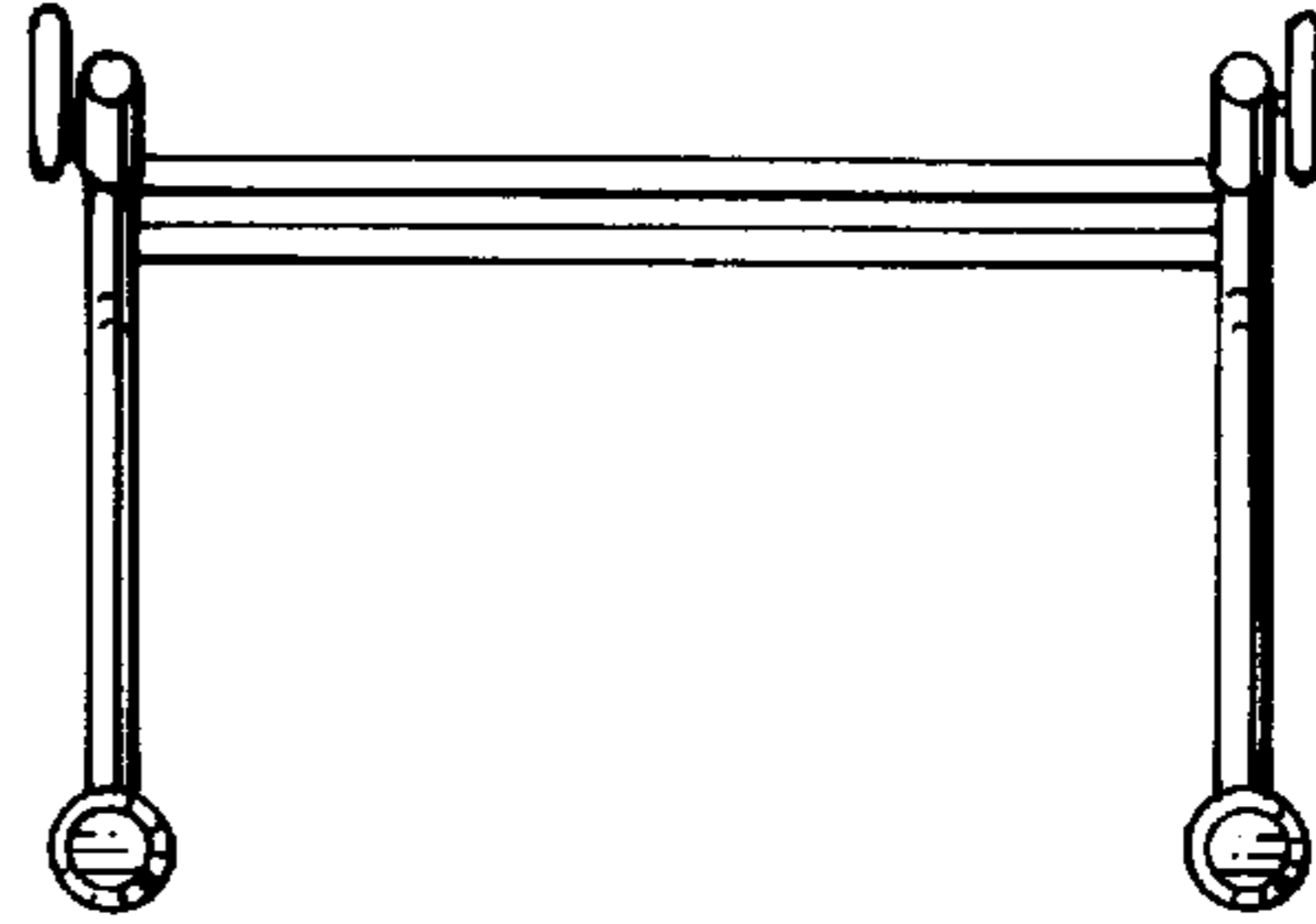

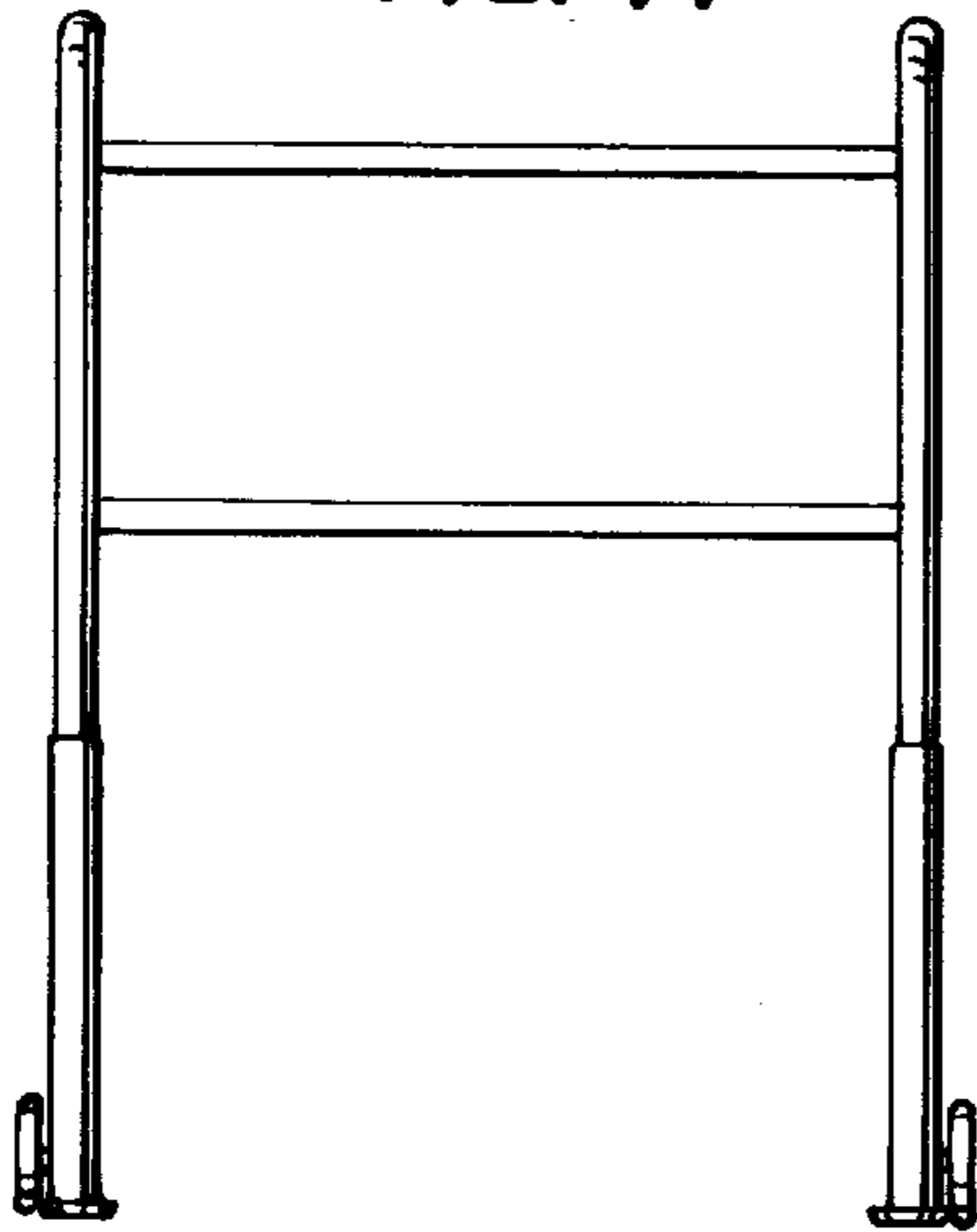

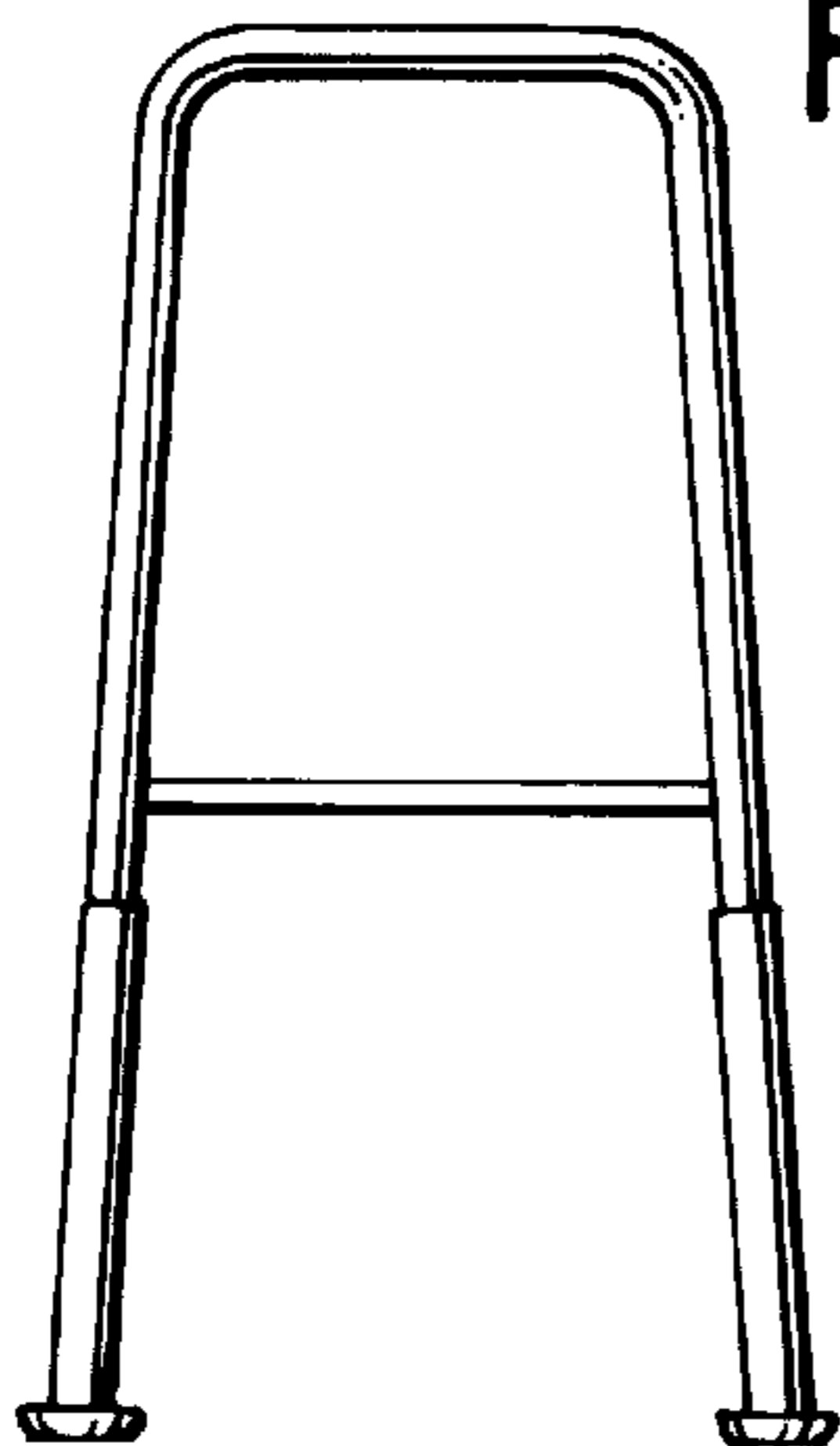

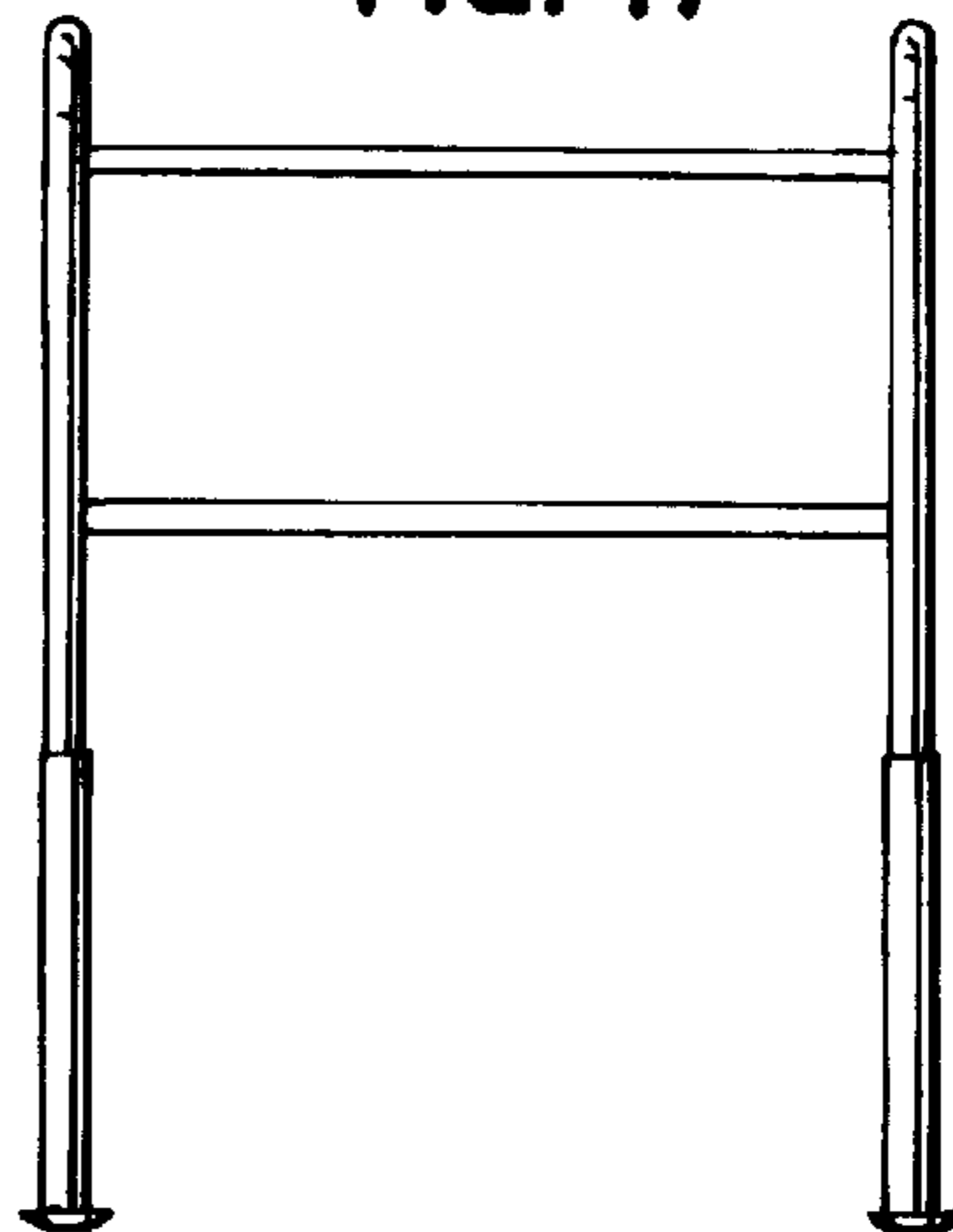

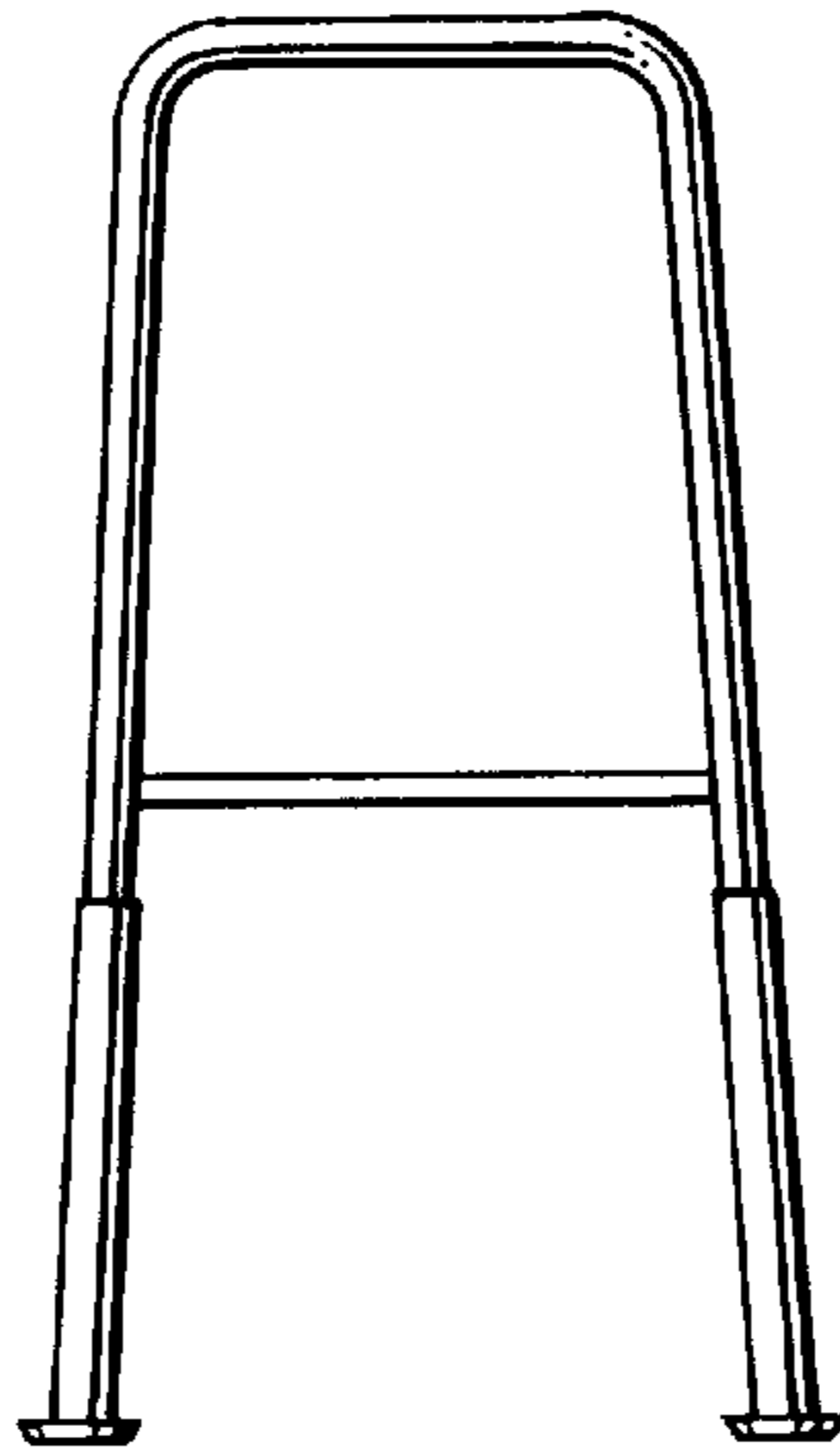

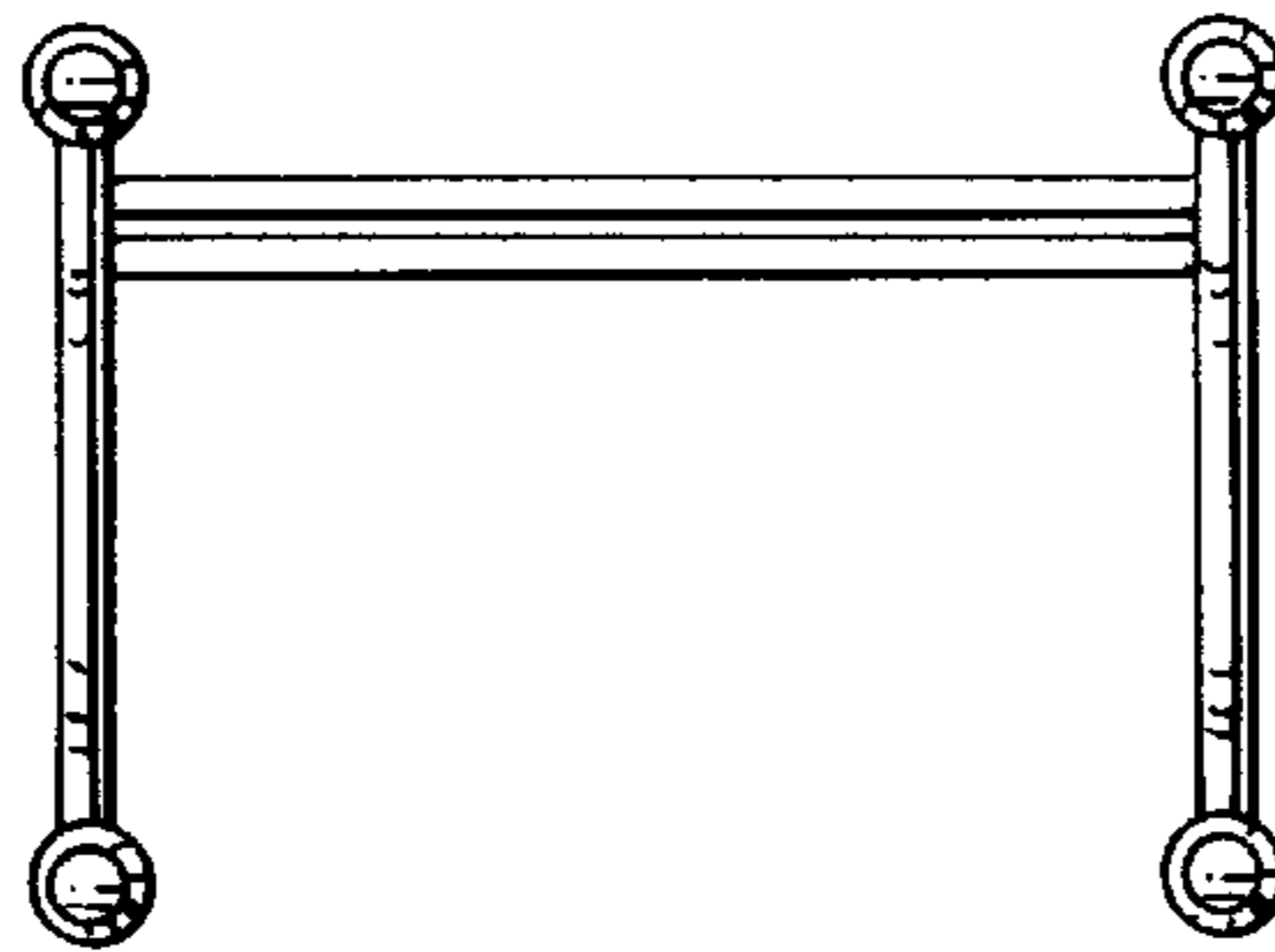
