[57] **CLAIM**

I claim the ornamental design for a forecourt fuel pump, as shown and described.

**DESCRIPTION**

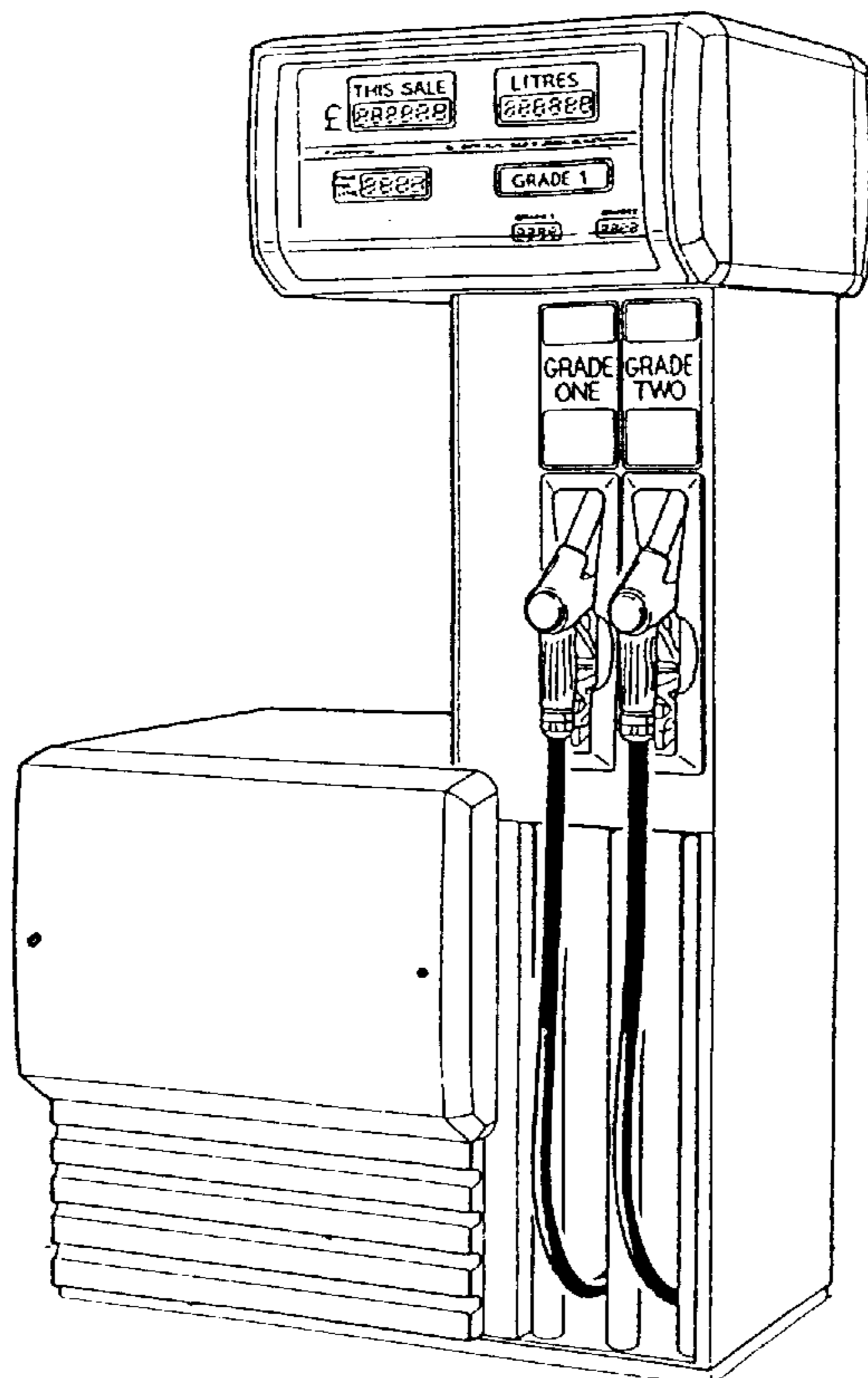

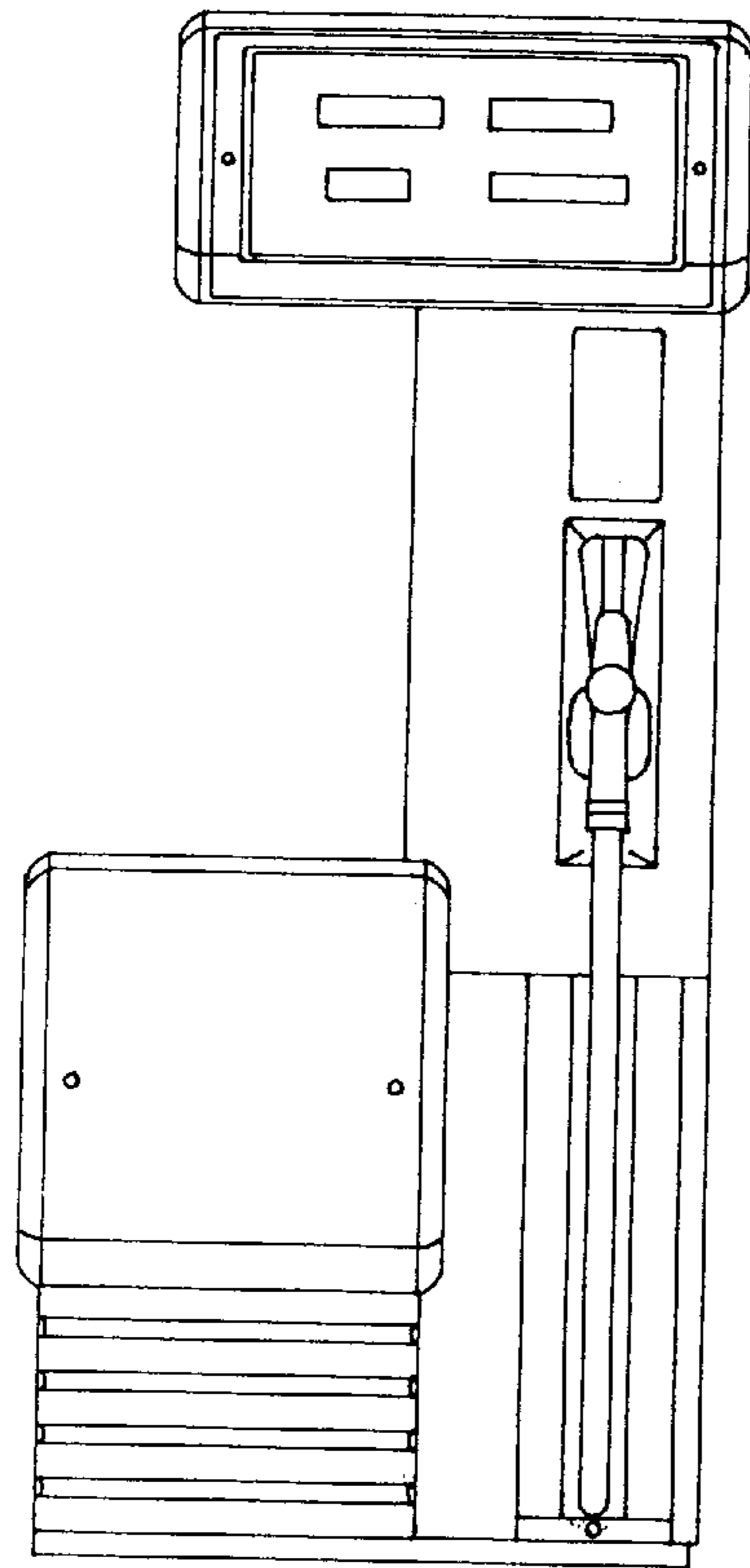

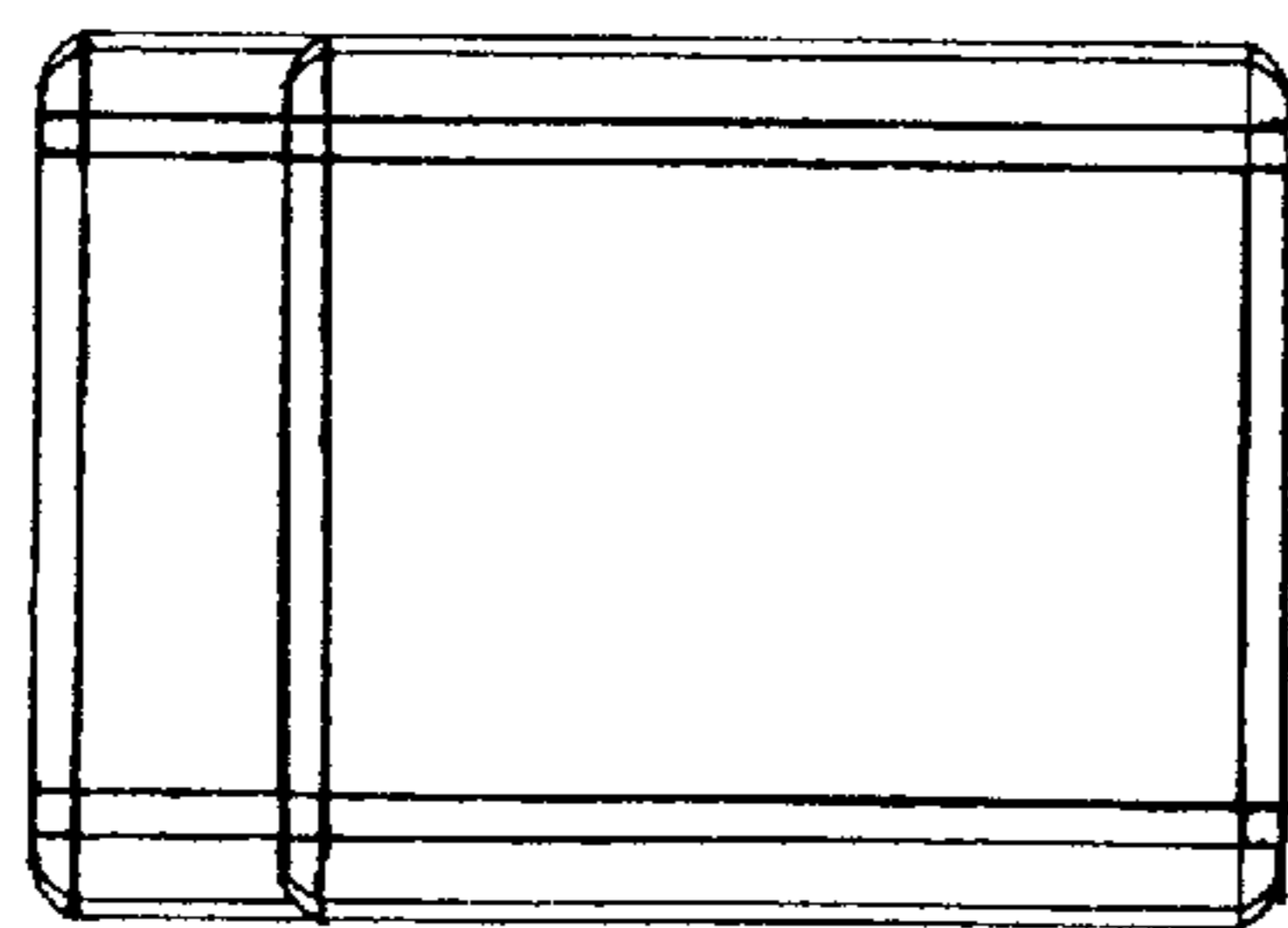
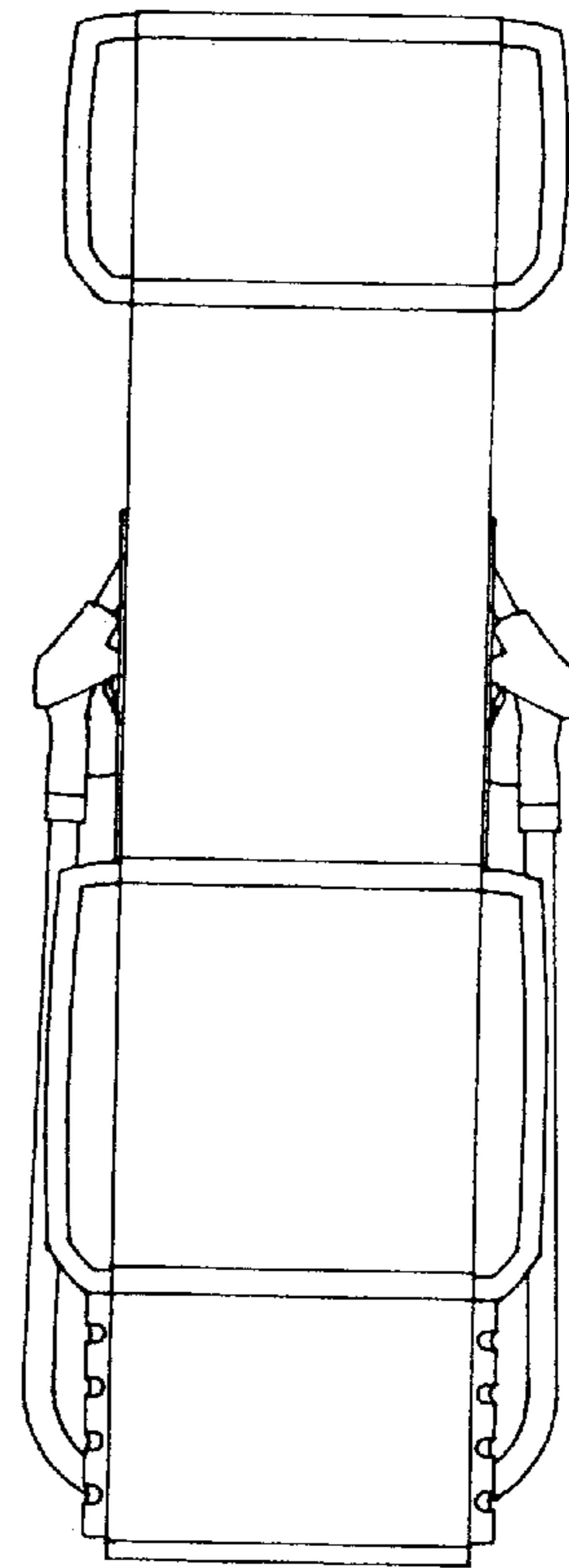

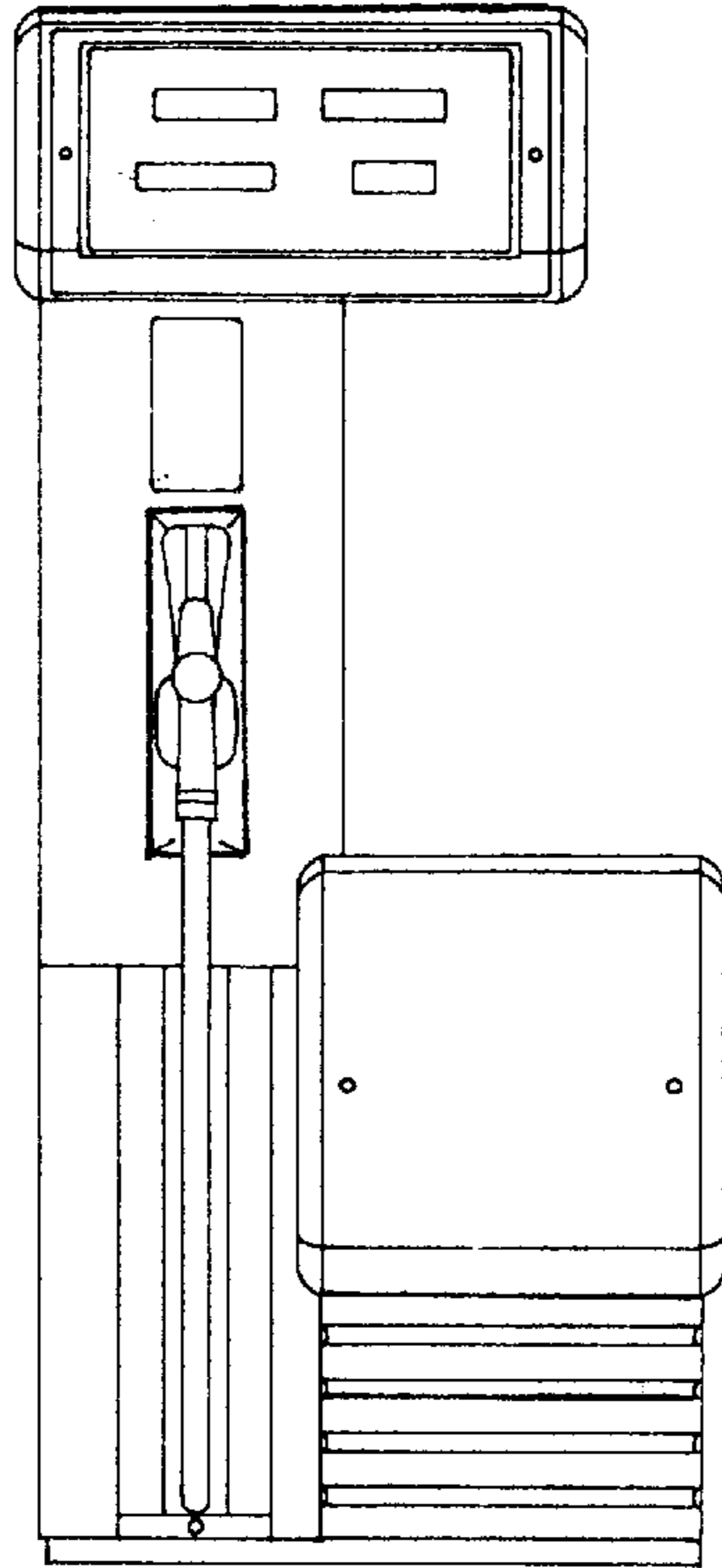

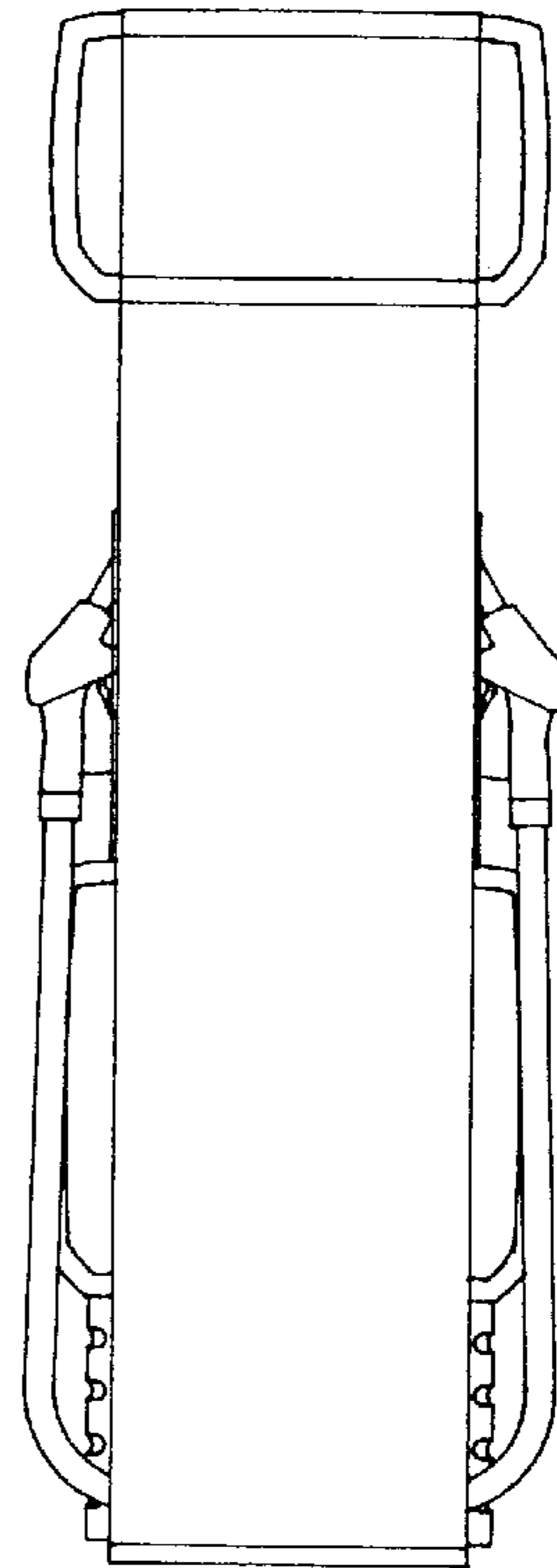

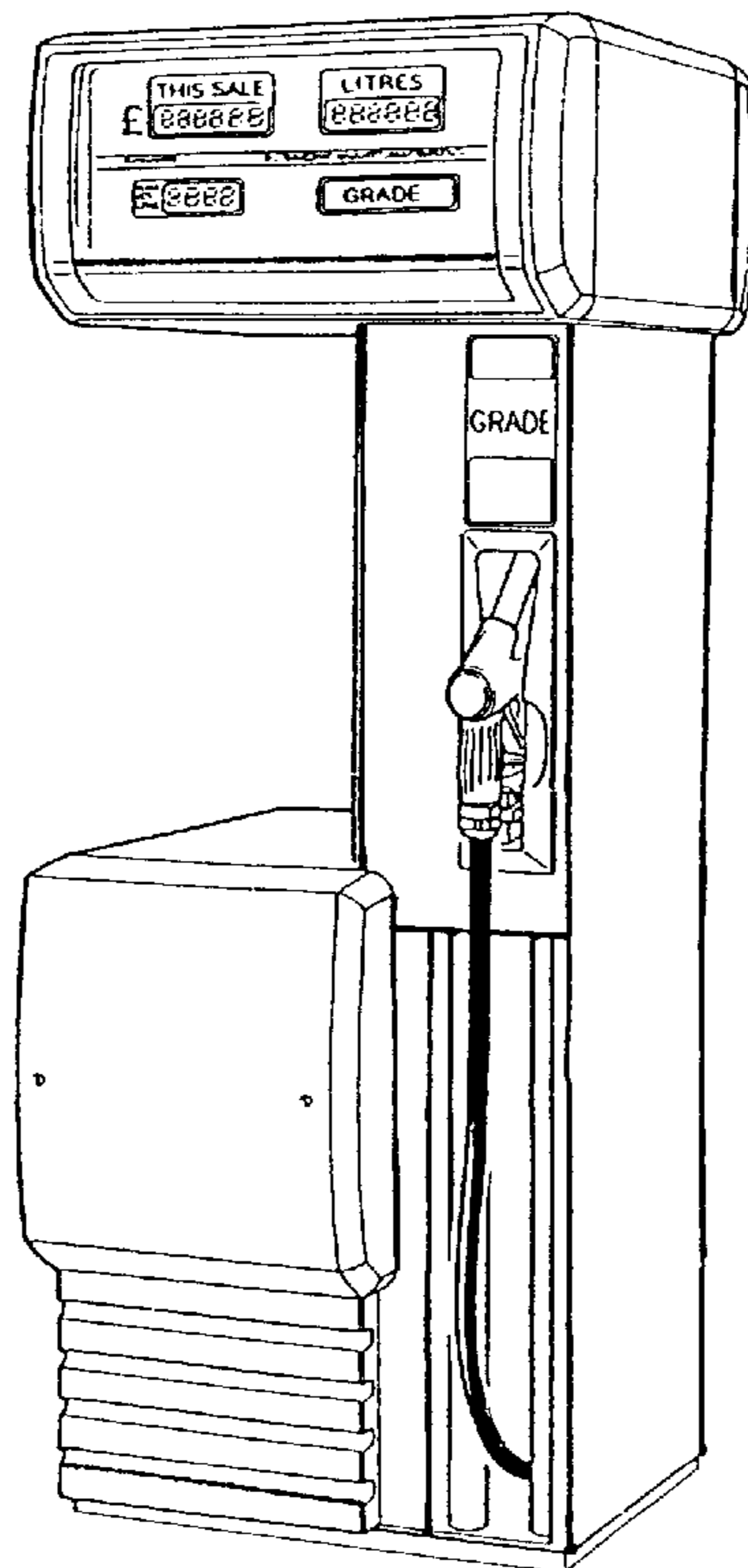

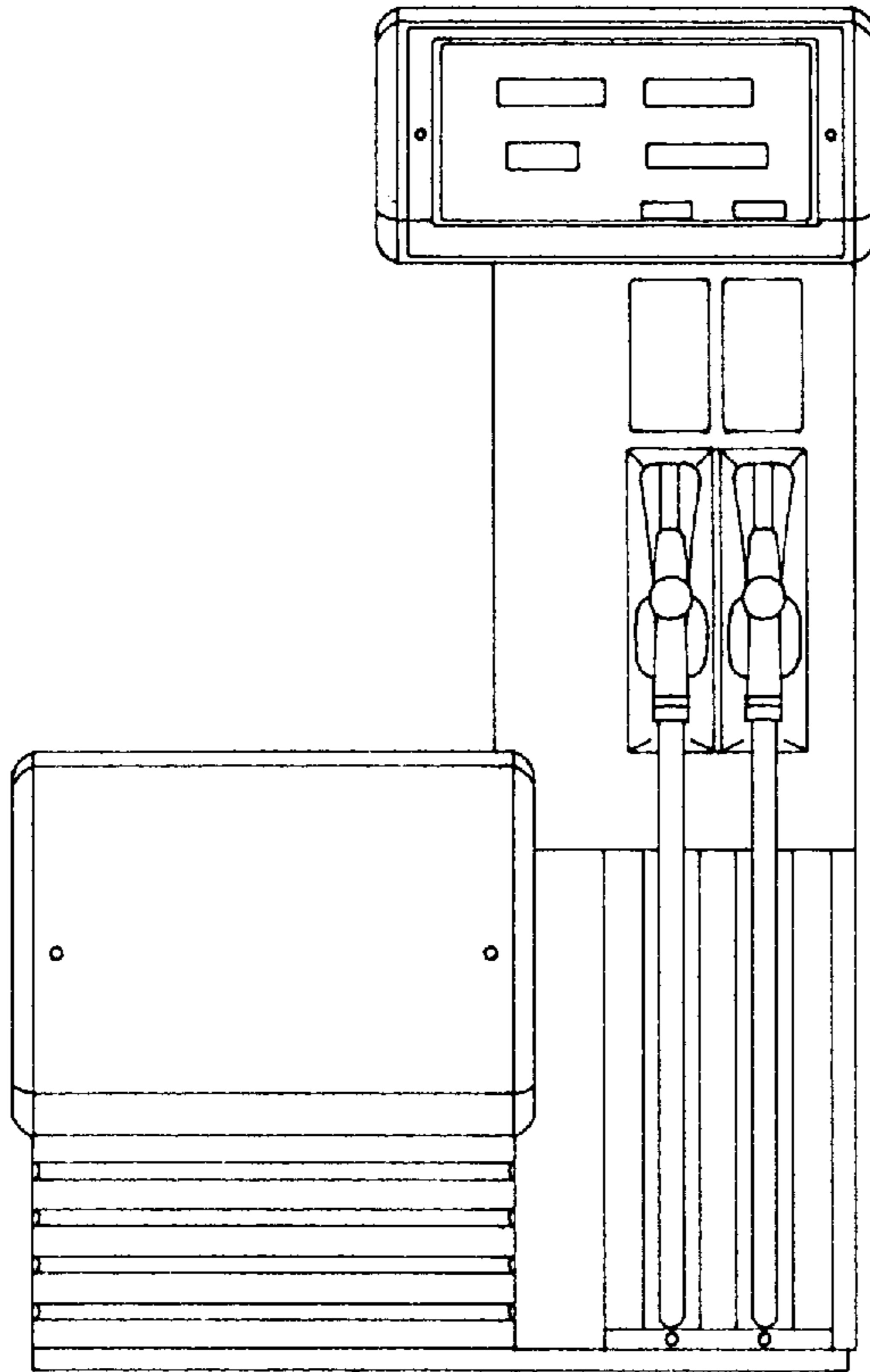

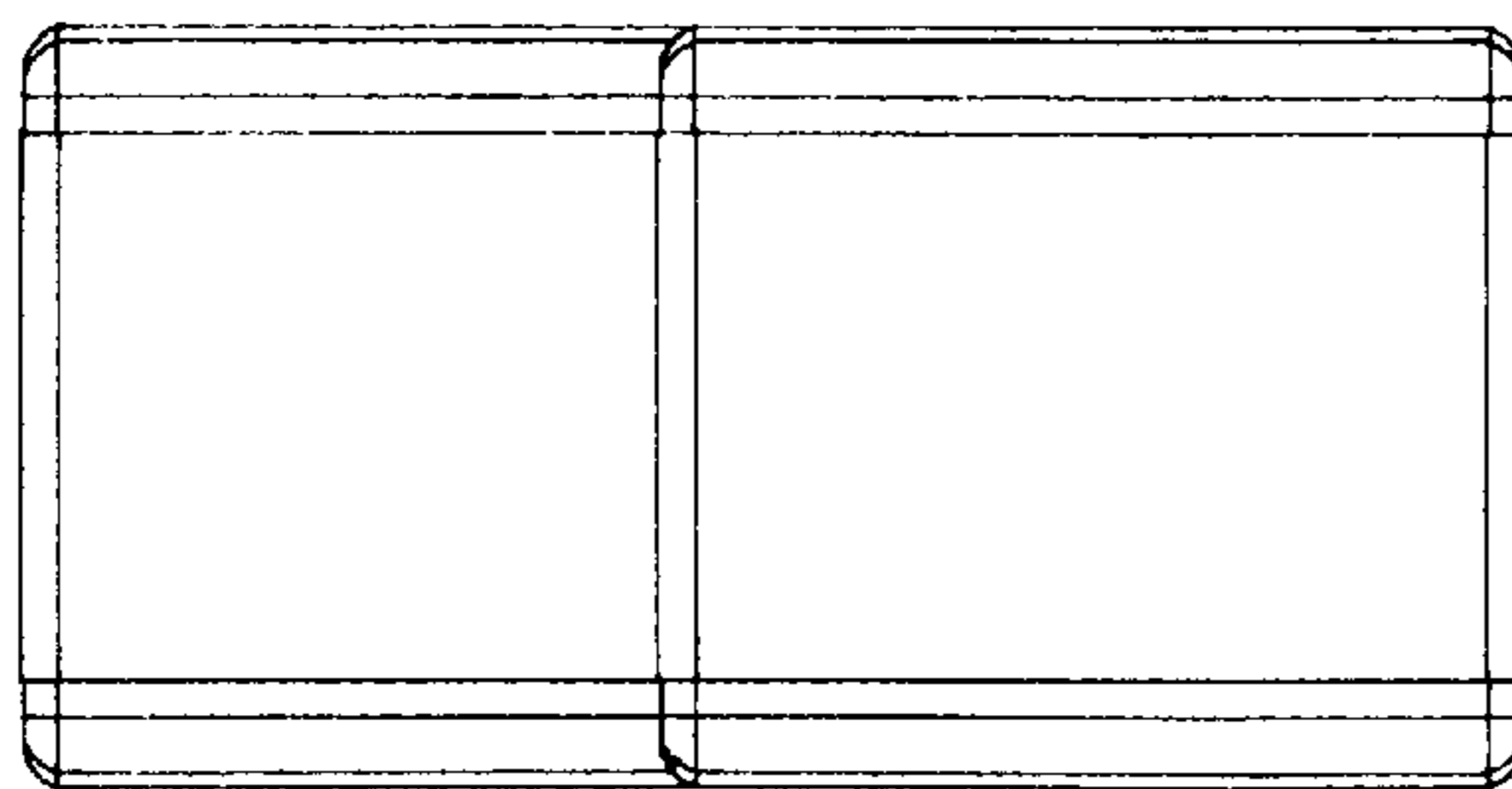
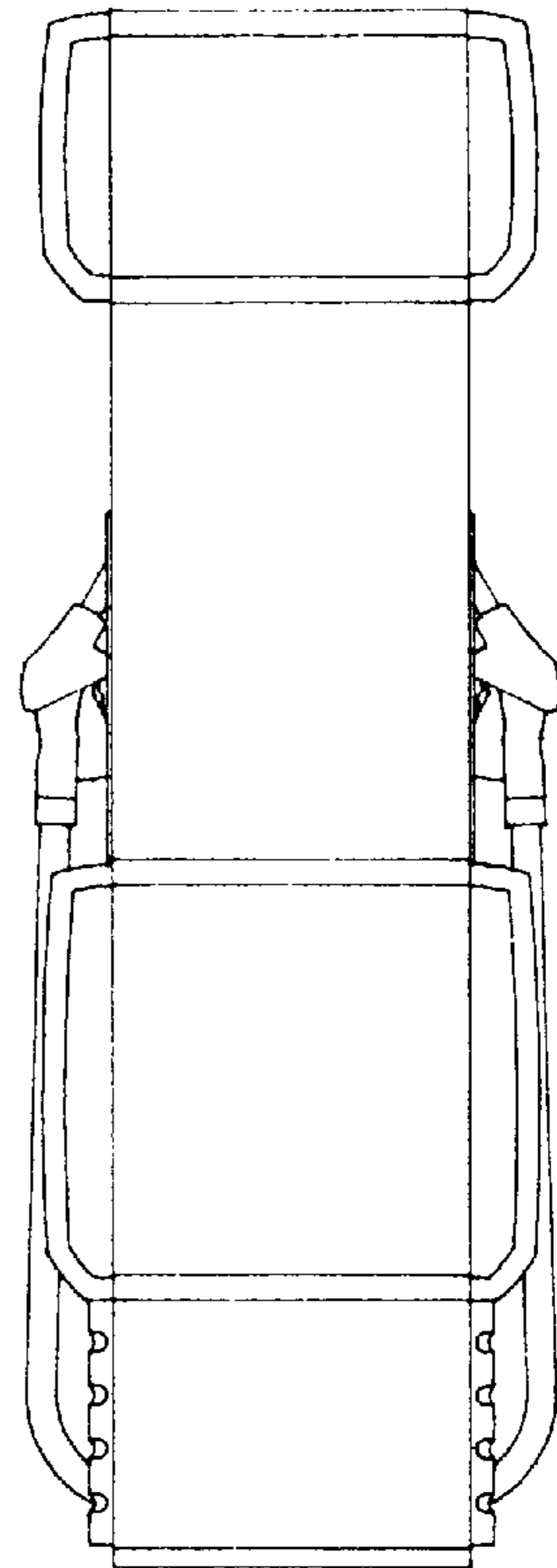

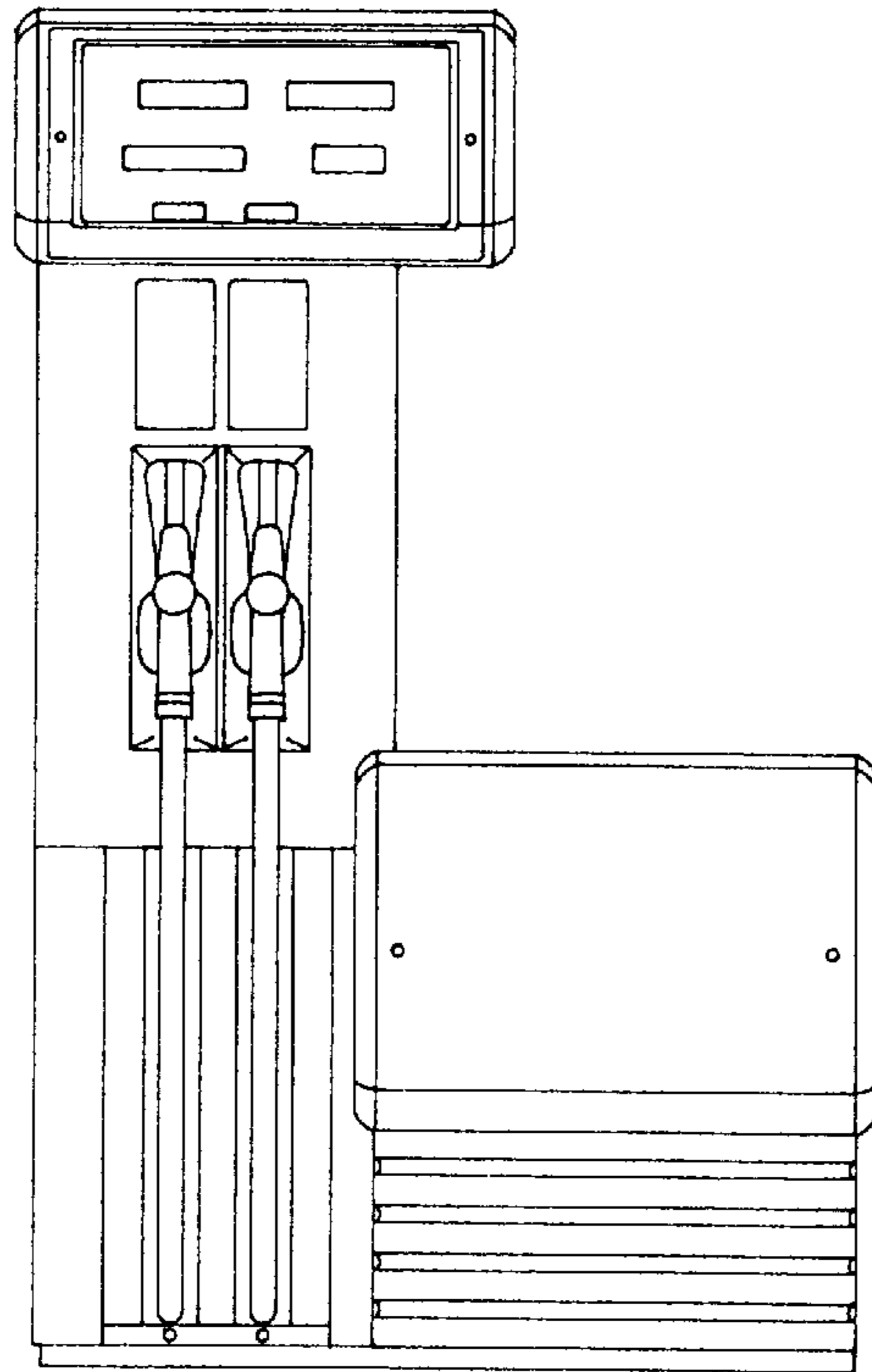

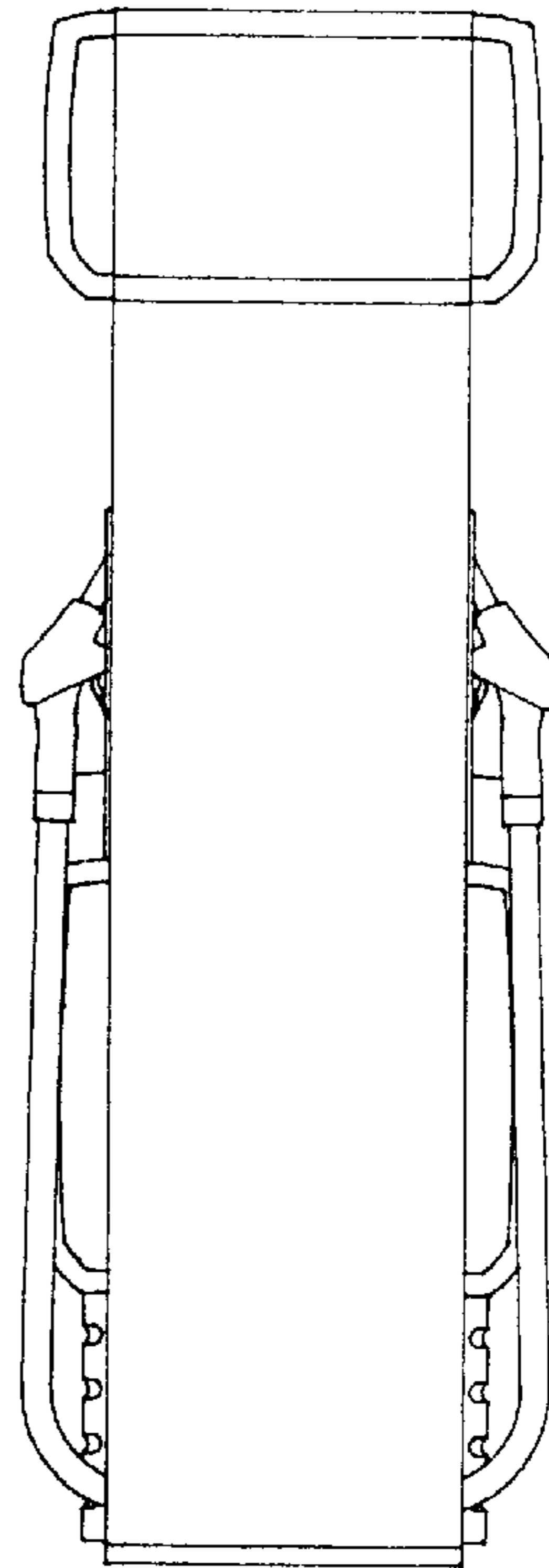

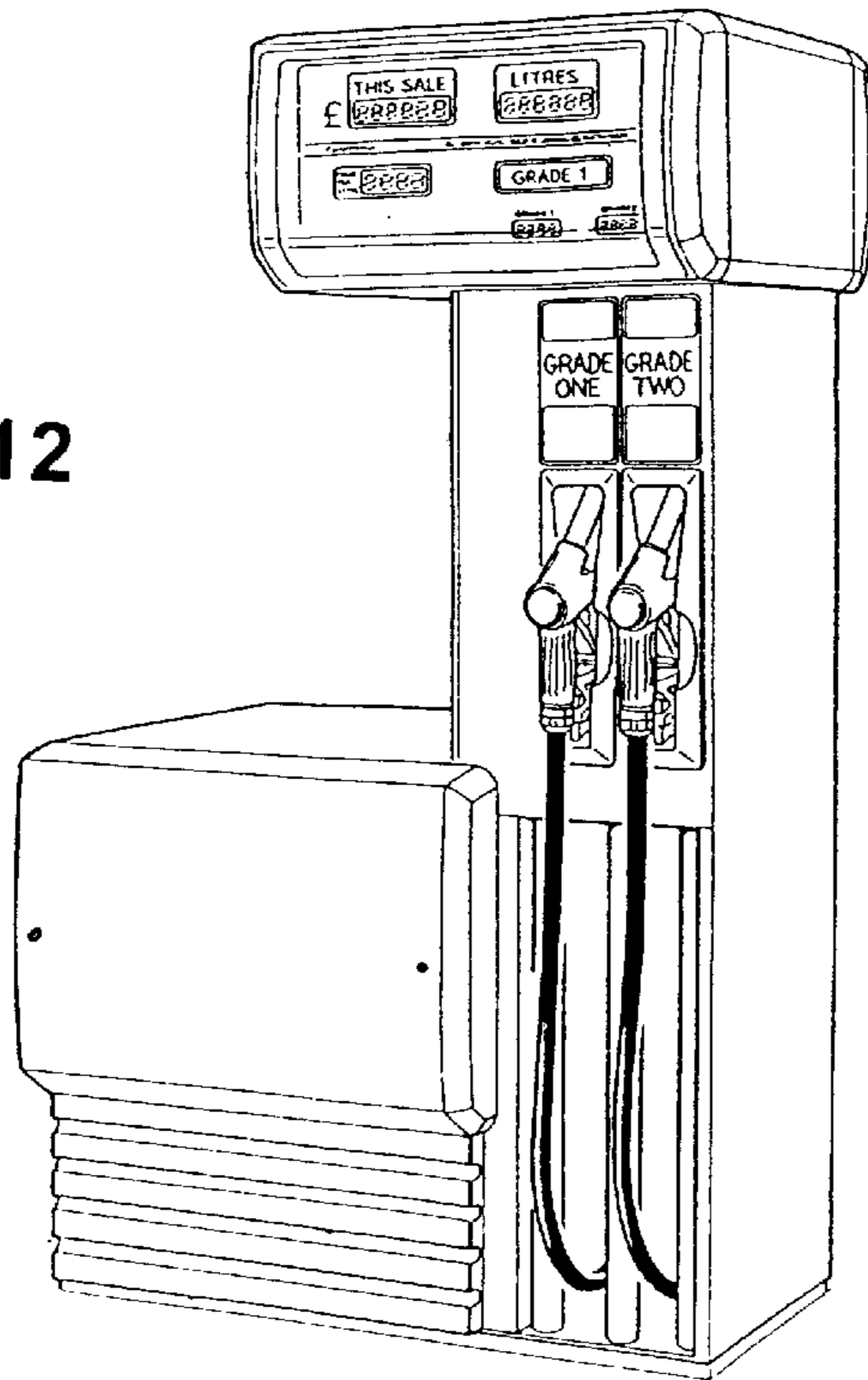

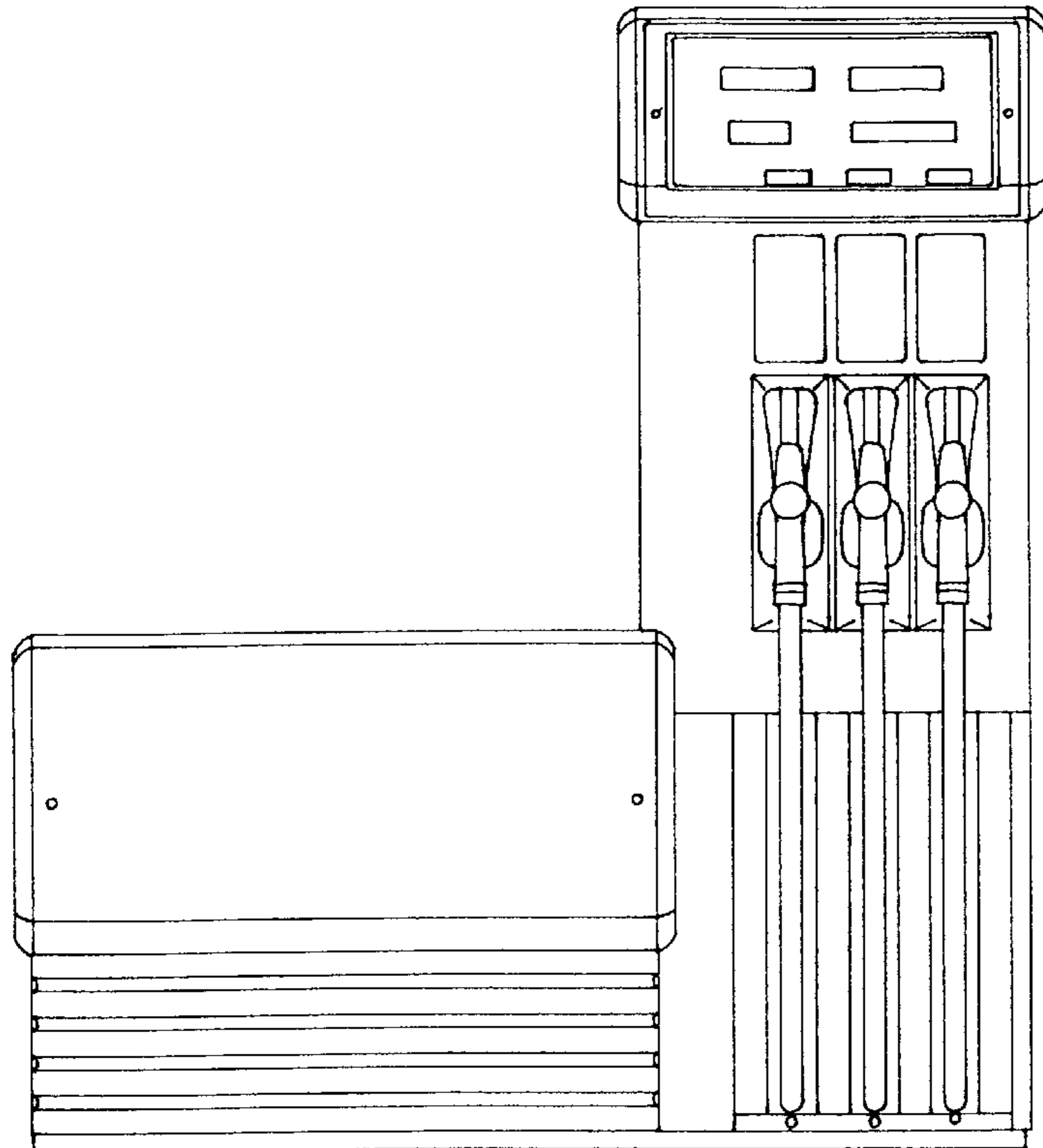

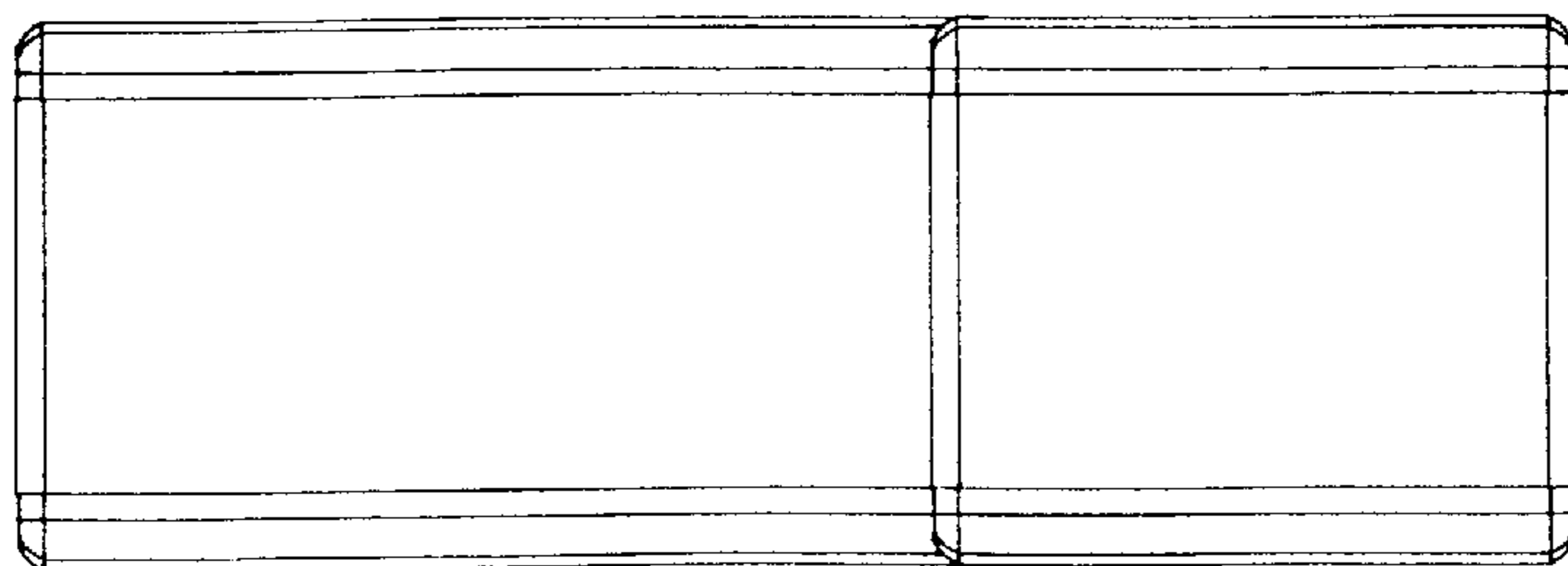
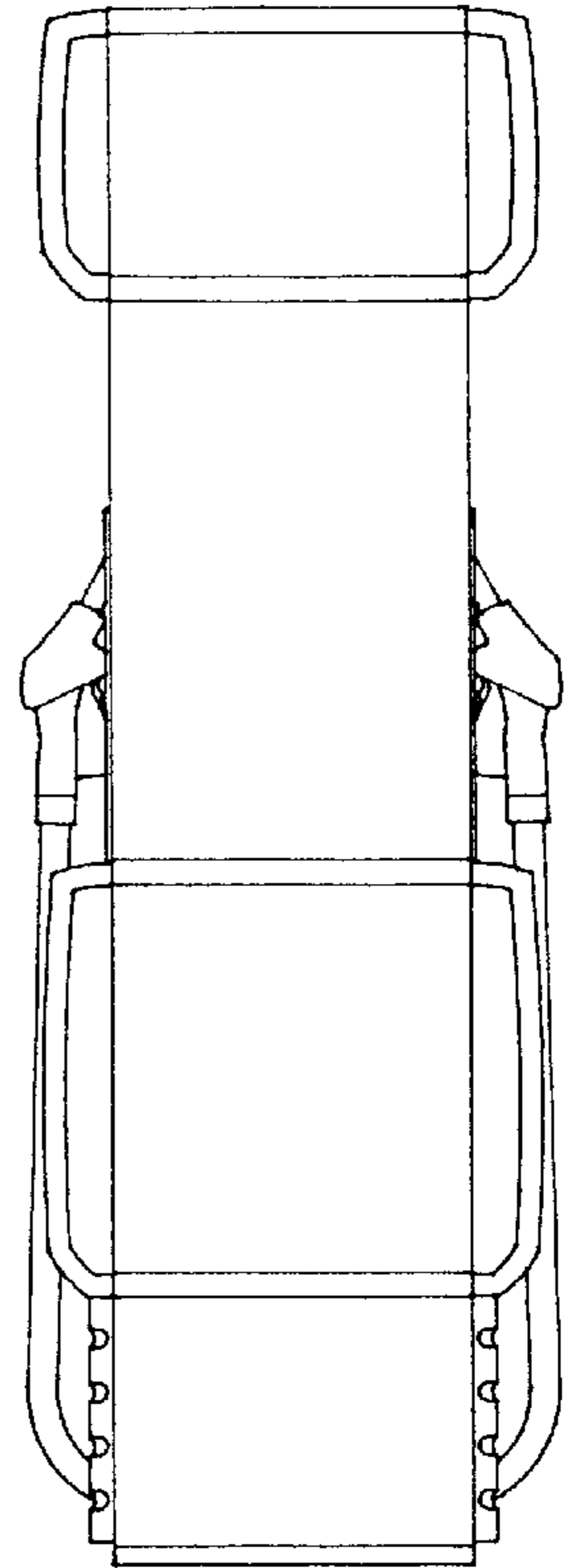

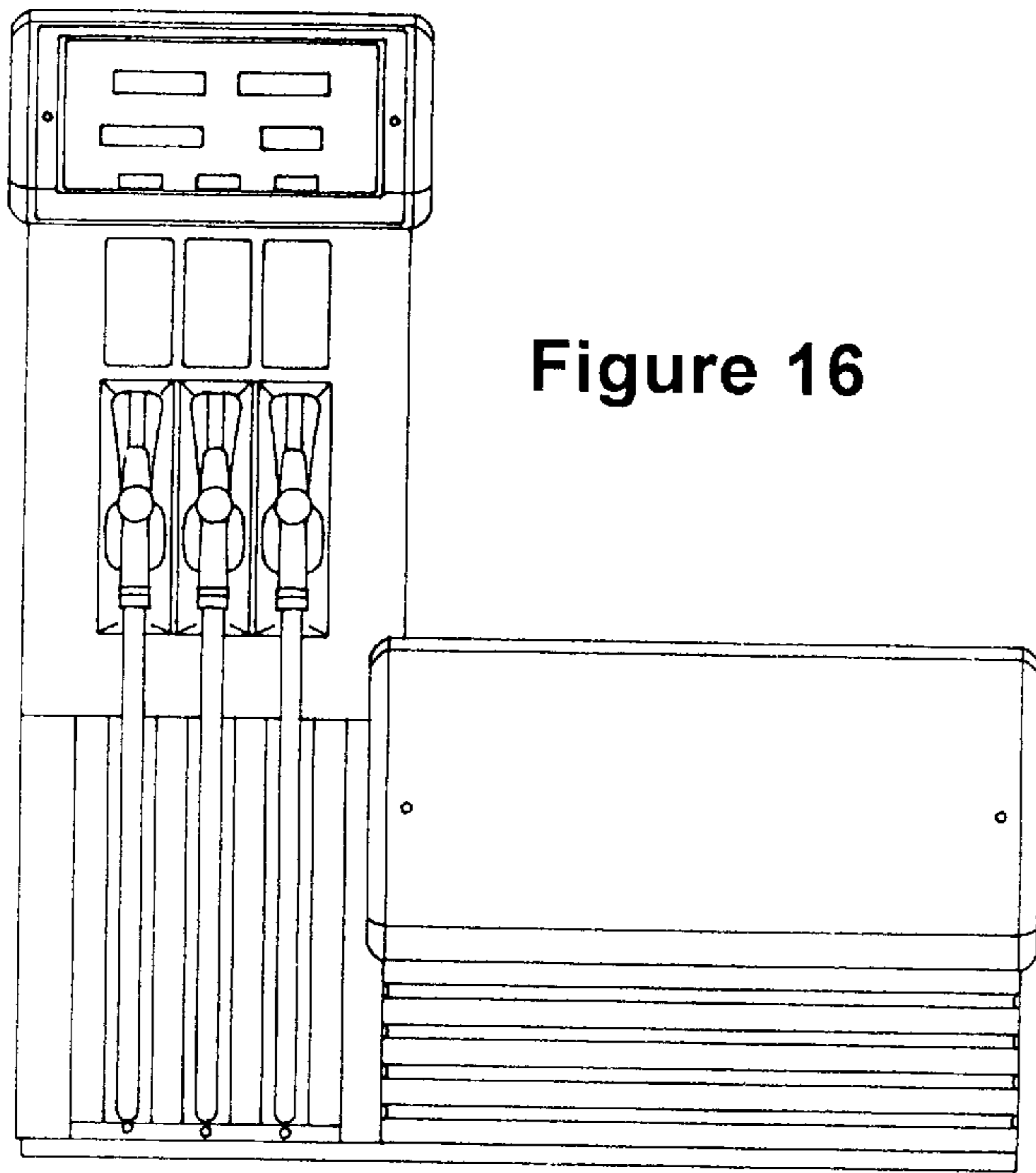

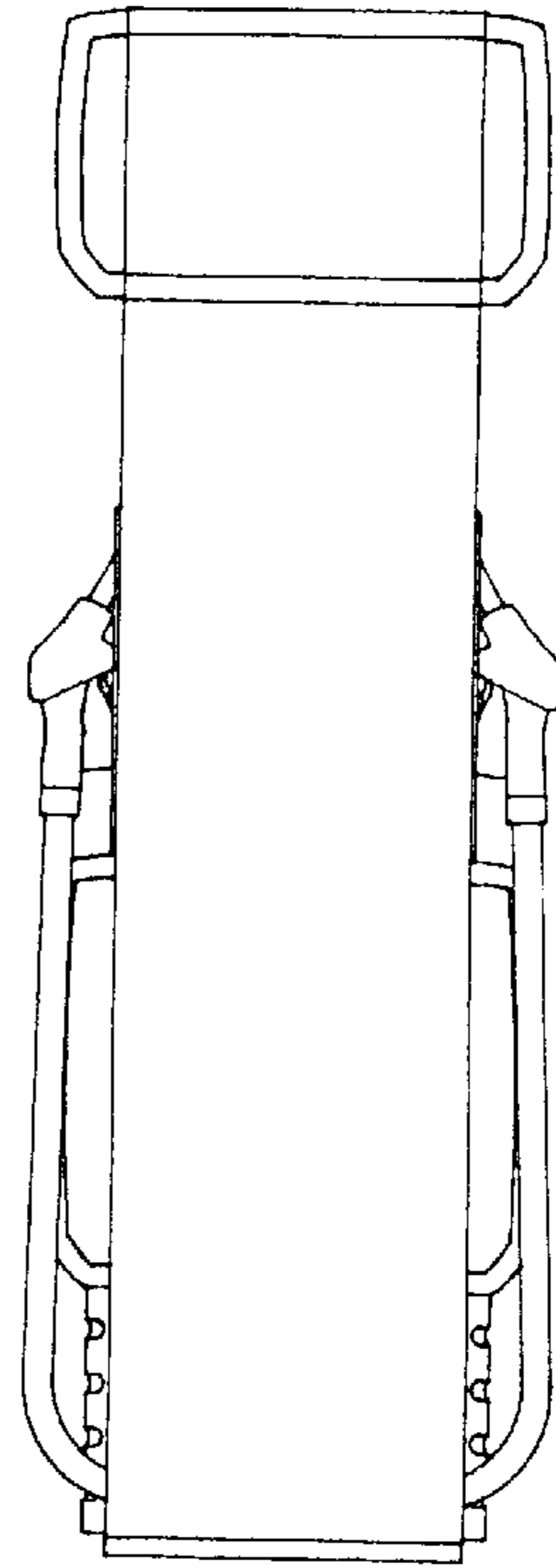

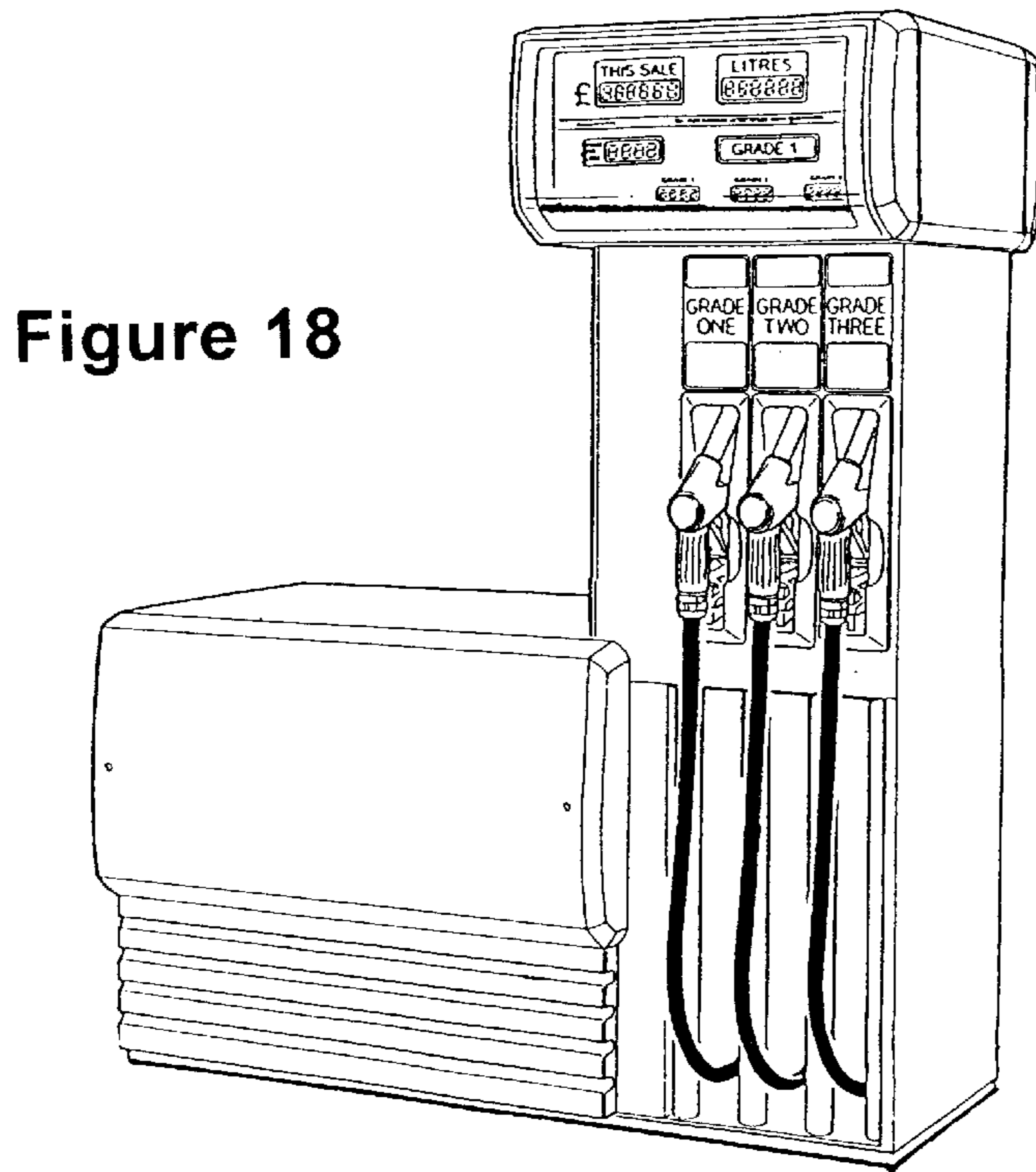
