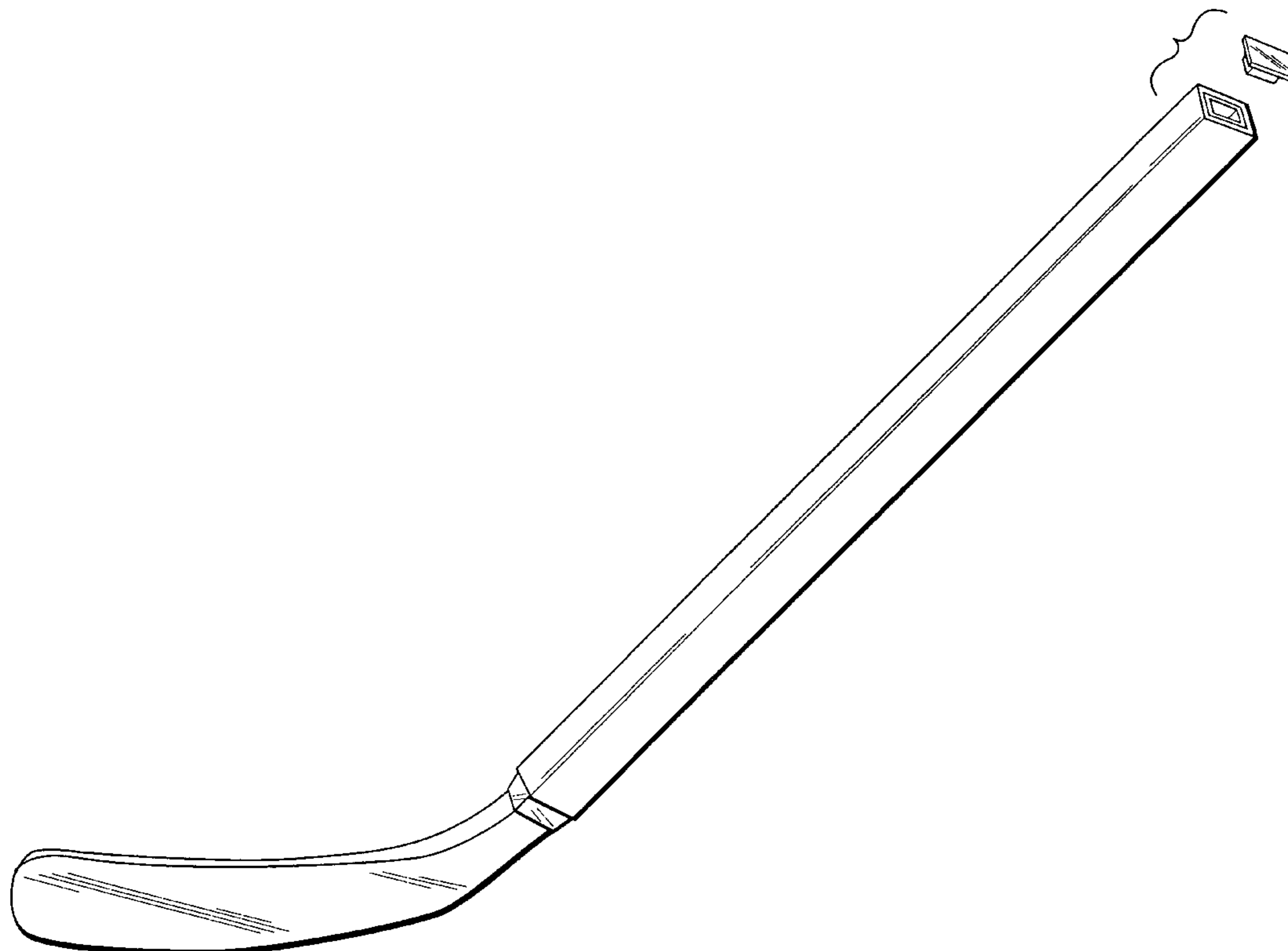
[57] **CLAIM**

The ornamental design for a hockey stick having an elastomeric sleeve about an aluminum shaft, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a hockey stick having an elastomeric sleeve about an aluminum shaft showing my new design;  
FIG. 2 is a top view thereof;  
FIG. 3 is a left elevational view thereof, the right side being a mirror image thereof;  
FIG. 4 is a bottom view thereof;  
FIG. 5 is a rear elevational view thereof; and,  
FIG. 6 is a perspective view thereof.

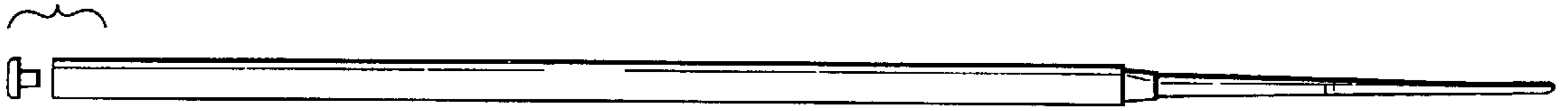

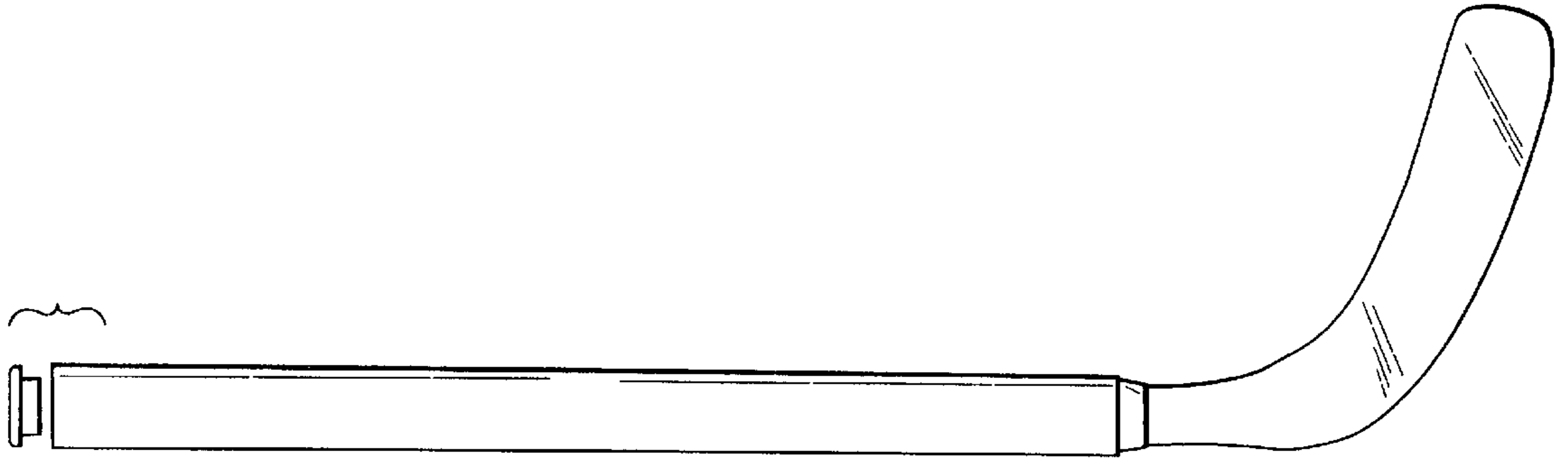

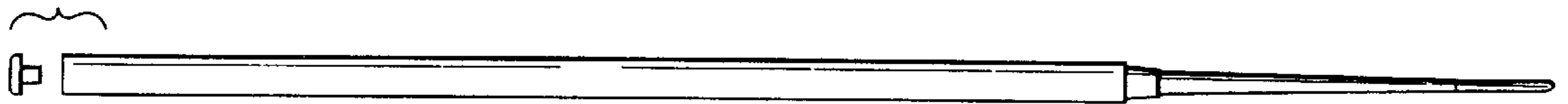
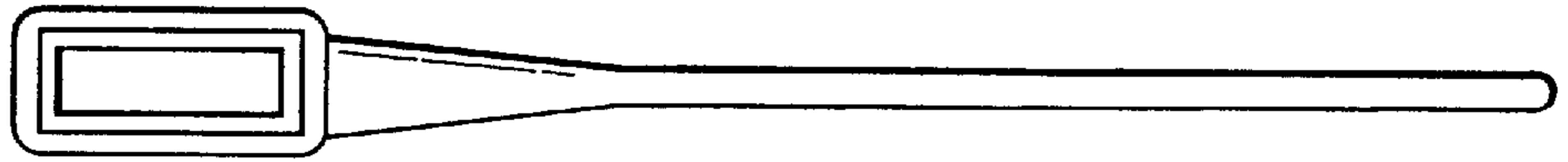

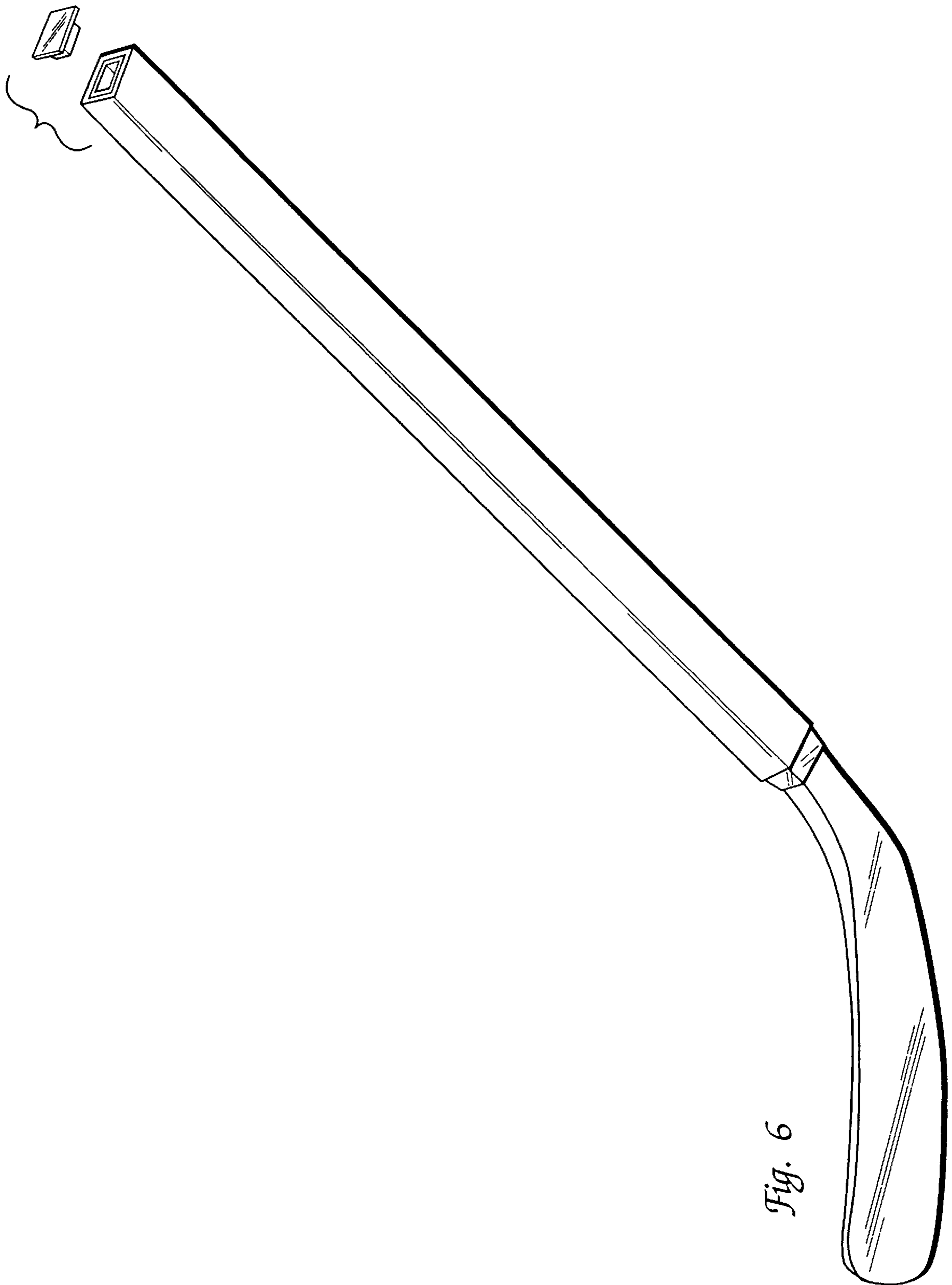
