The ornamental design for a faucet handle, as shown and described.

**DESCRIPTION**

FIG. 1 a perspective view of a faucet handle showing our new design;  
FIG. 2 is bottom plan view thereof;  
FIG. 3 is a top plan view thereof;  
FIG. 4 is a left side elevational view thereof, the right side being a mirror image of the left side;  
FIG. 5 is a front elevational view thereof;  
FIG. 6 is a rear elevational view thereof;  
FIG. 7 is a perspective view of a faucet handle showing another embodiment of our new design;  
FIG. 8 is a bottom plan view of FIG. 7;  
FIG. 9 is a top plan view of FIG. 7;  
FIG. 10 is a left side elevational view of FIG. 7, the right side being a mirror image of the left side;  
FIG. 11 is a front elevational view of FIG. 7; and,  
FIG. 12 is a rear elevational view of FIG. 7.

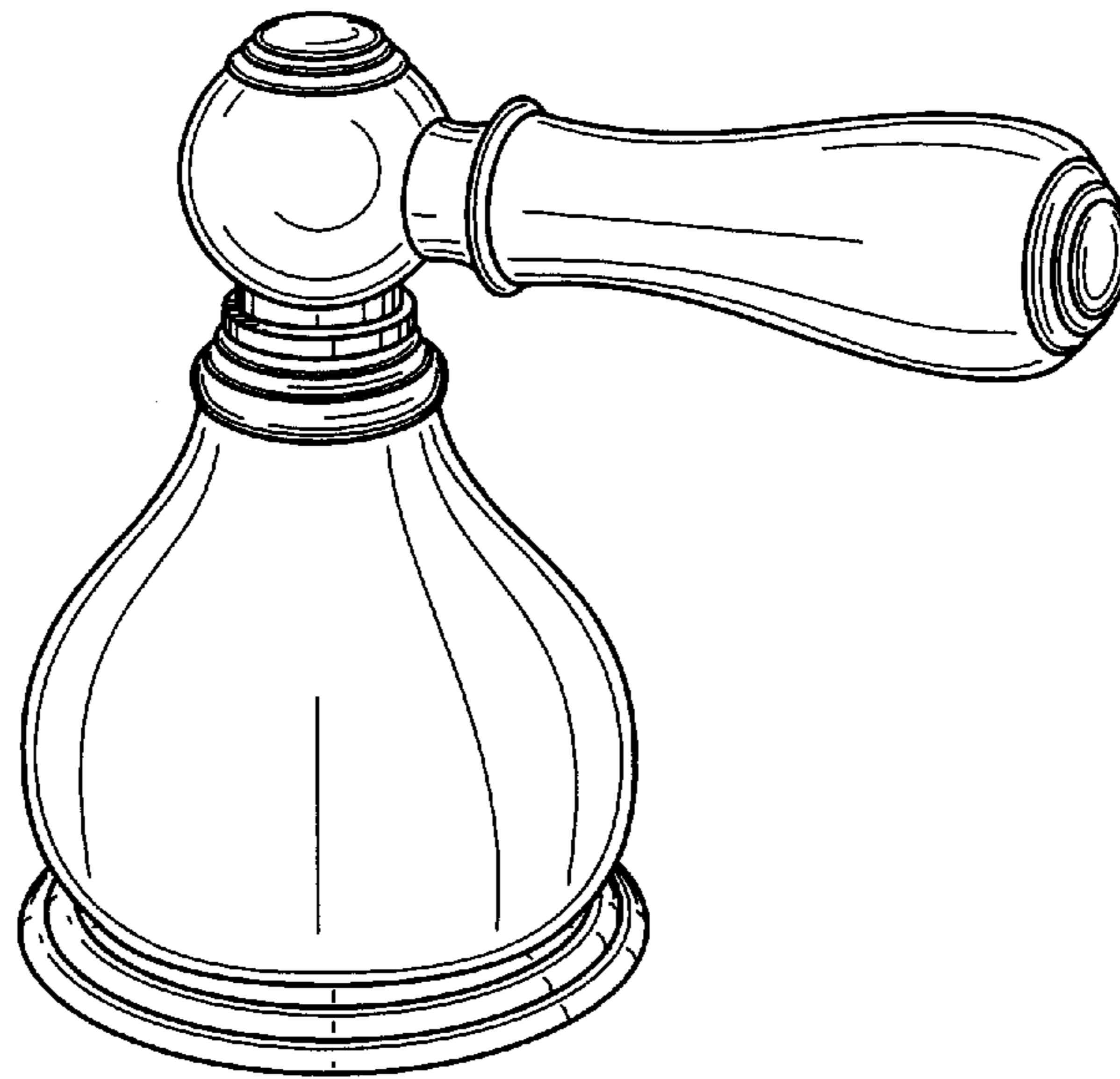

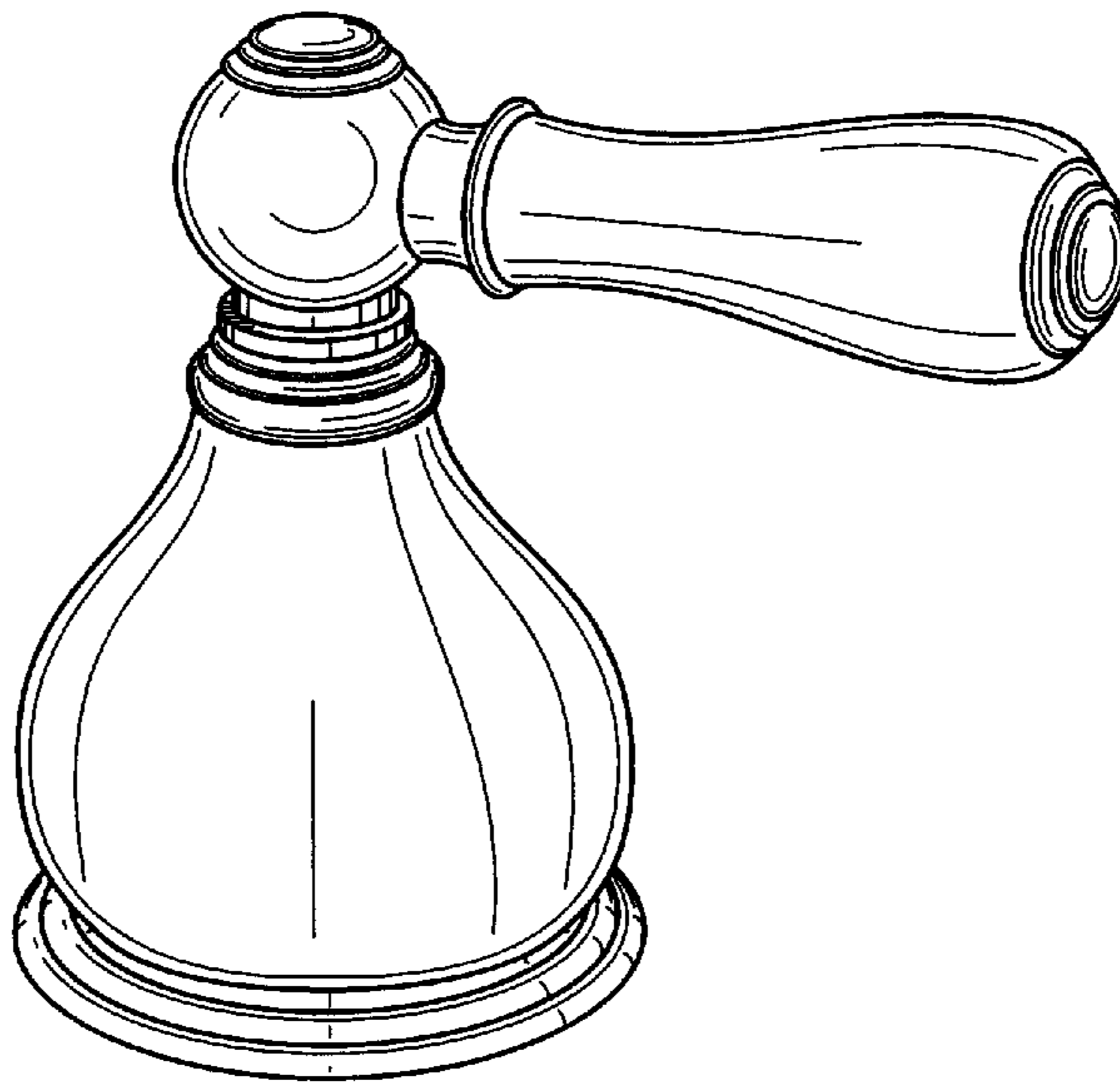

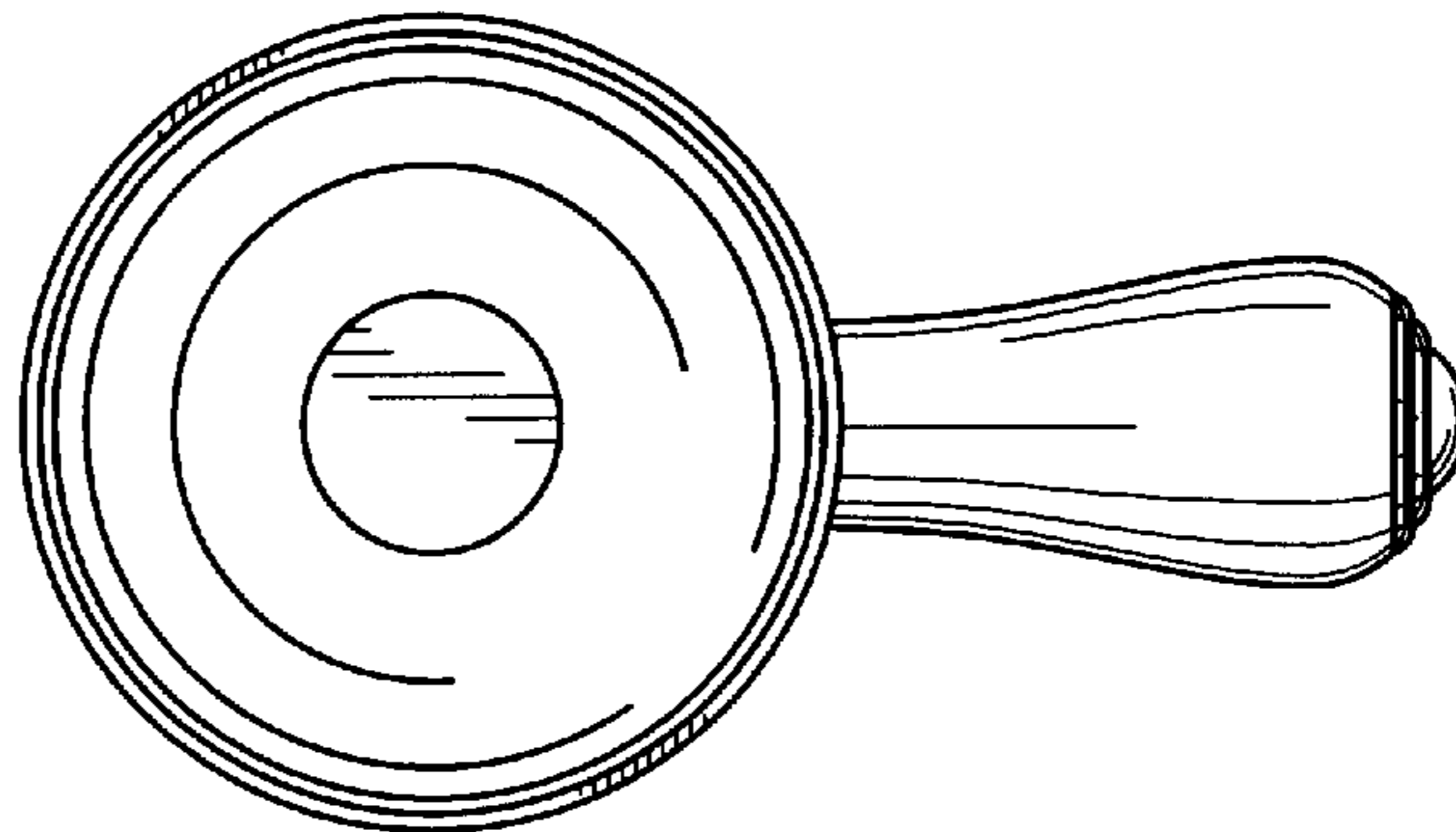

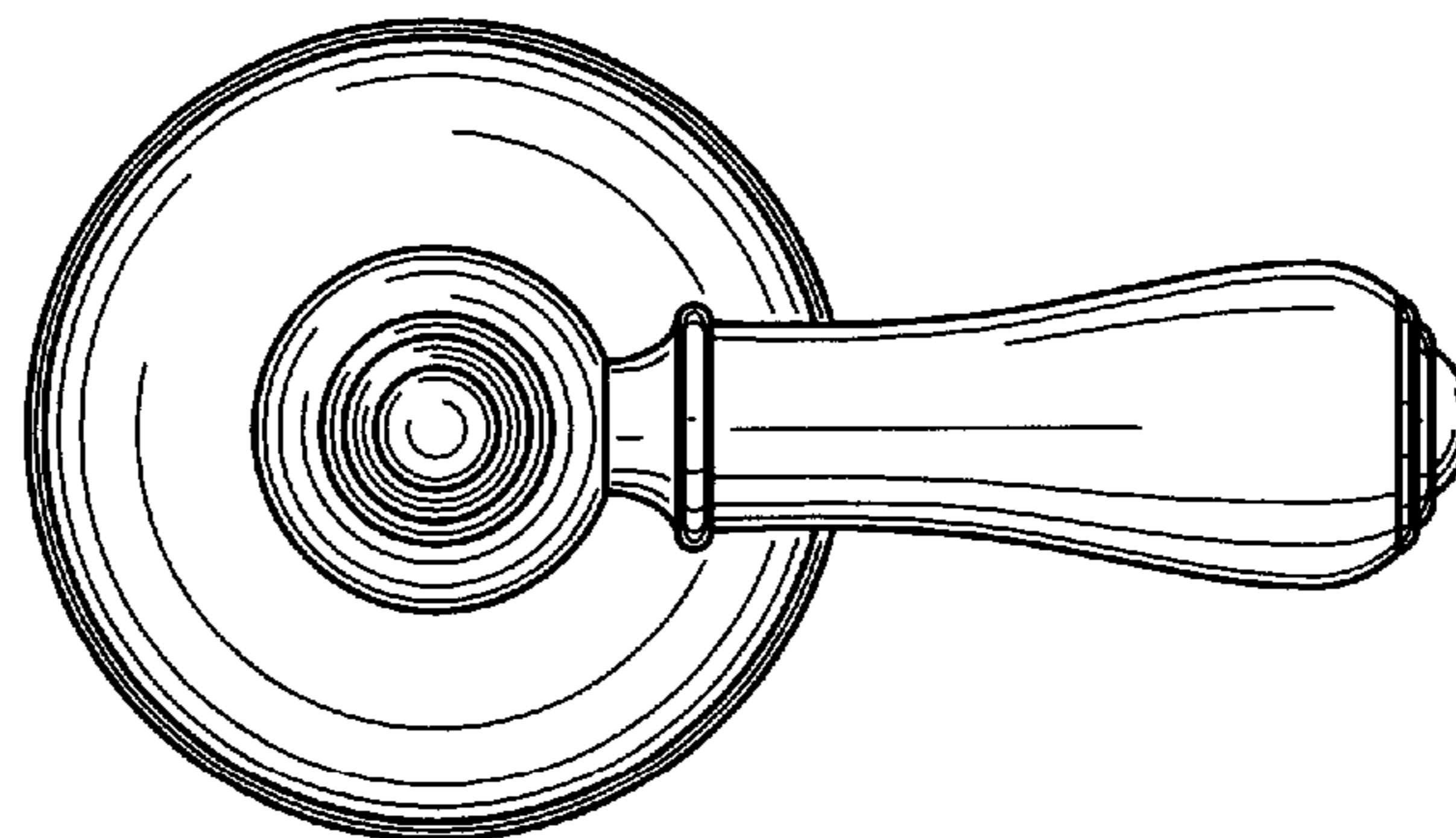

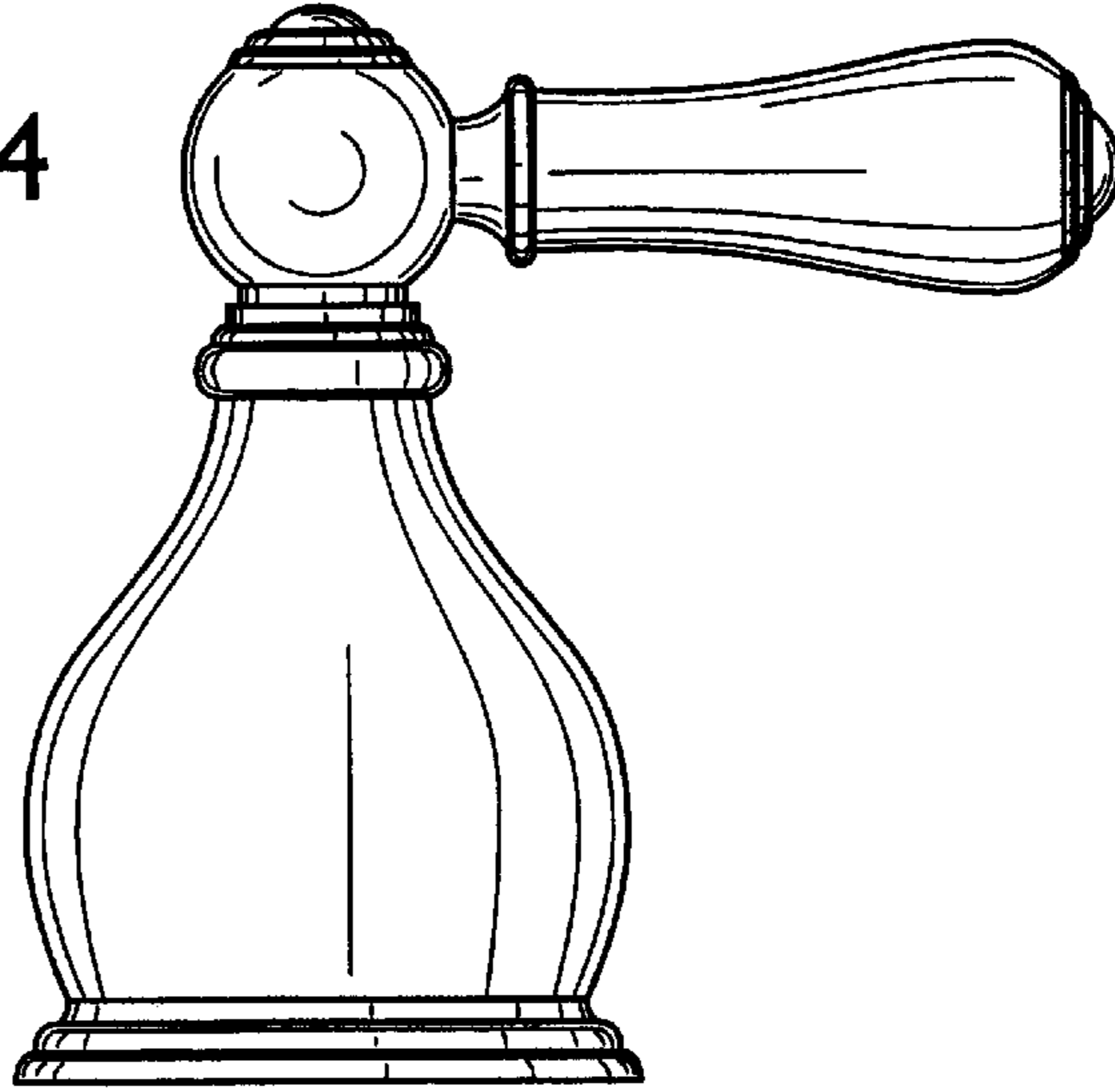

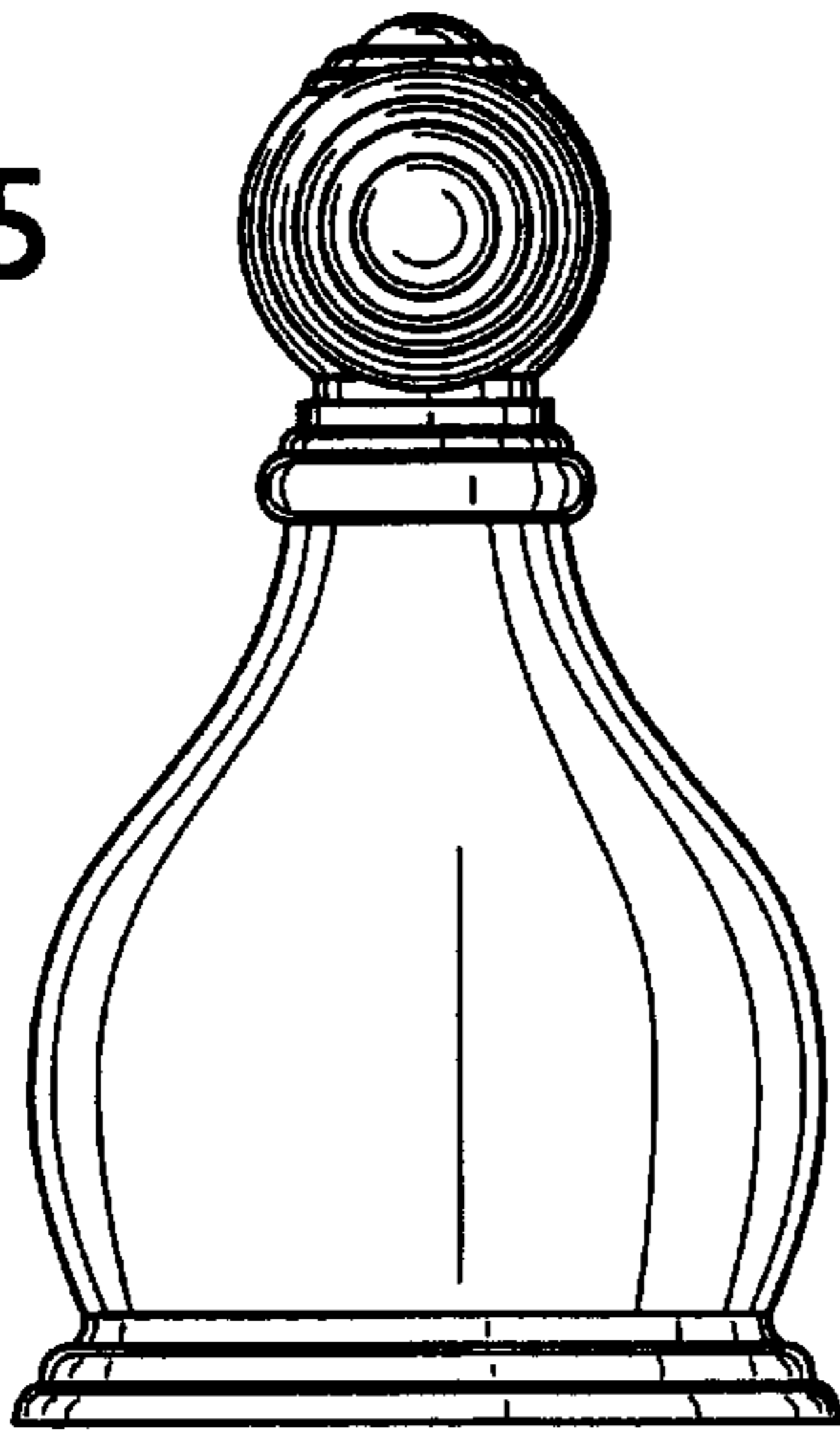

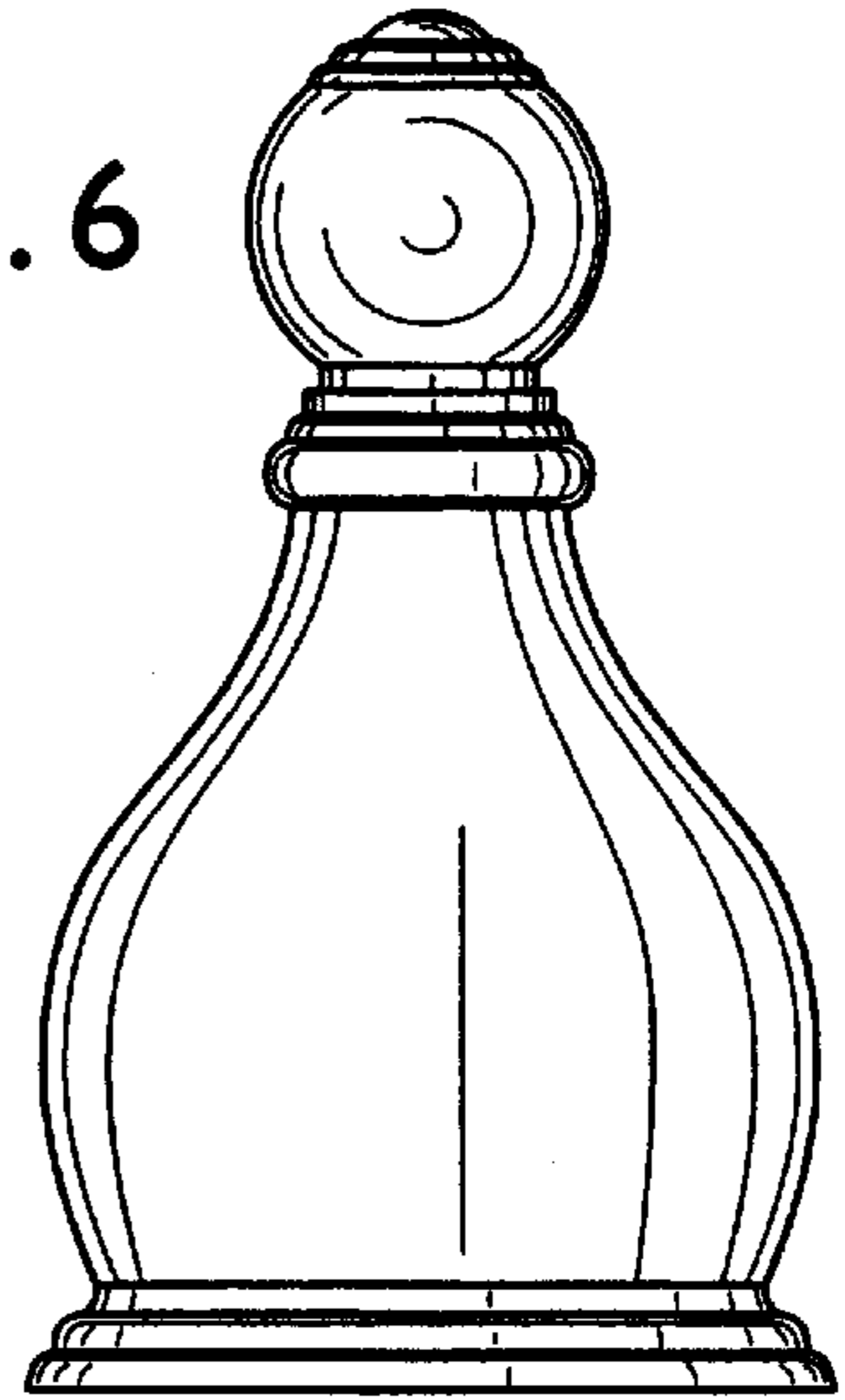

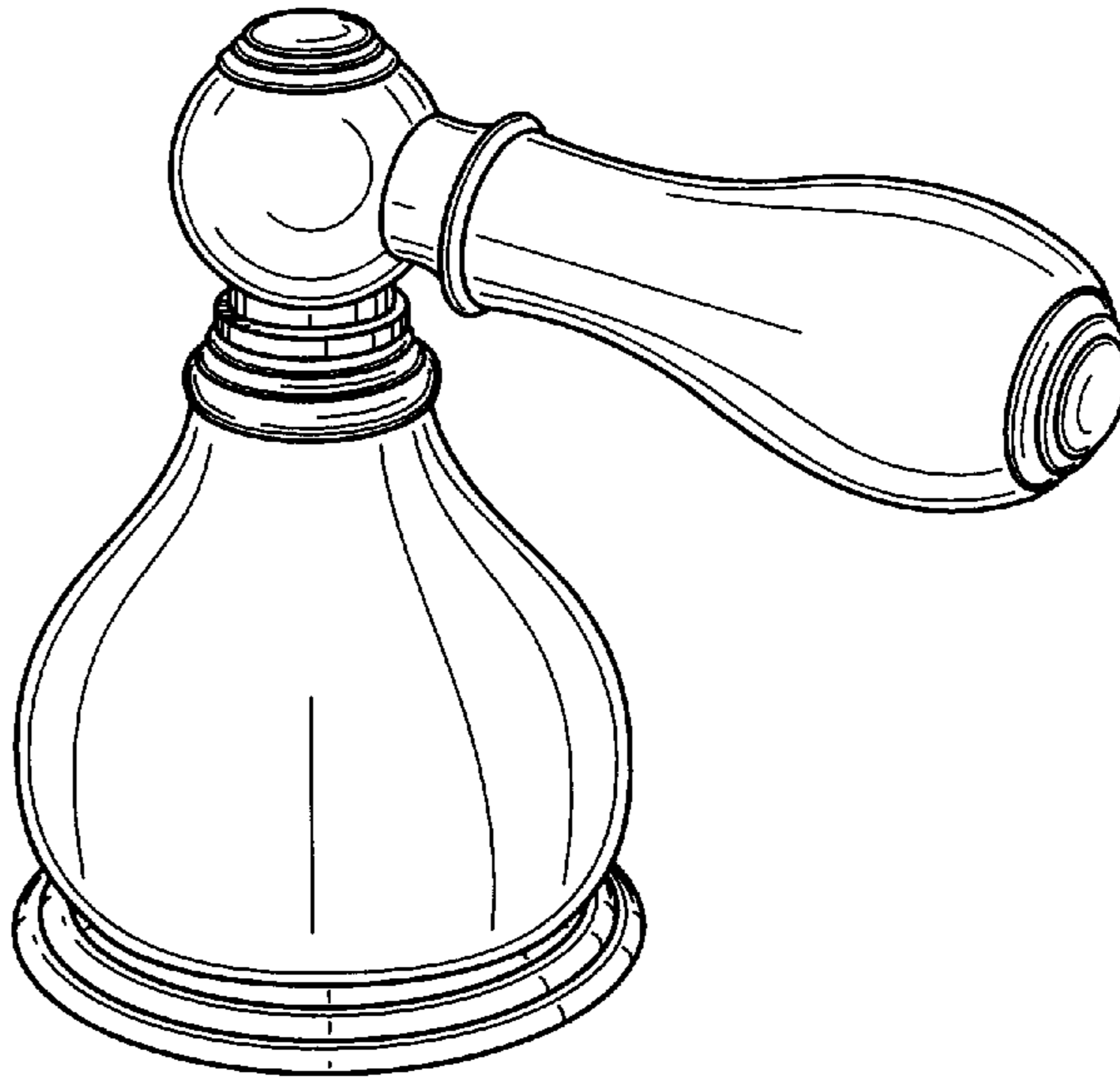

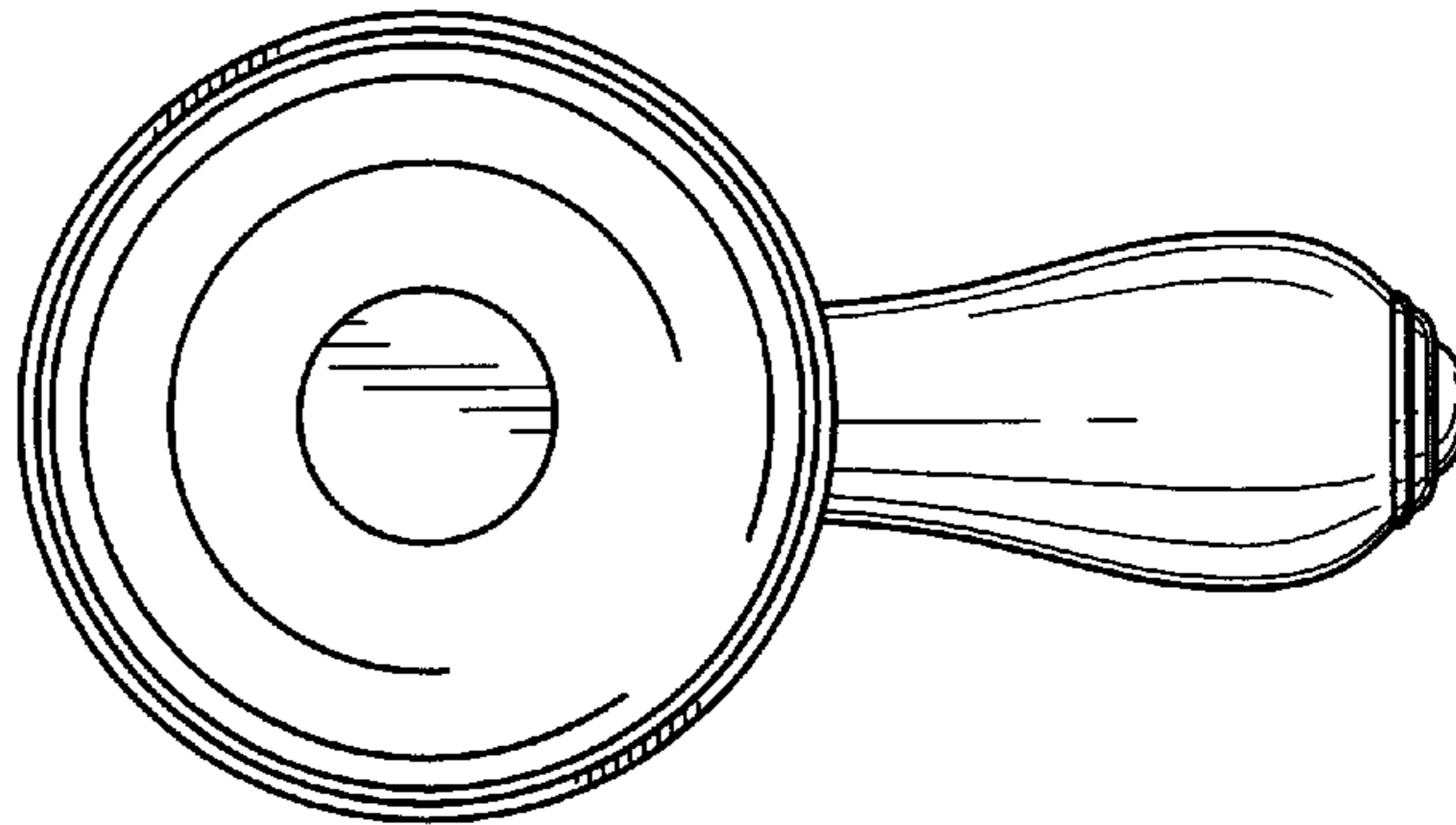

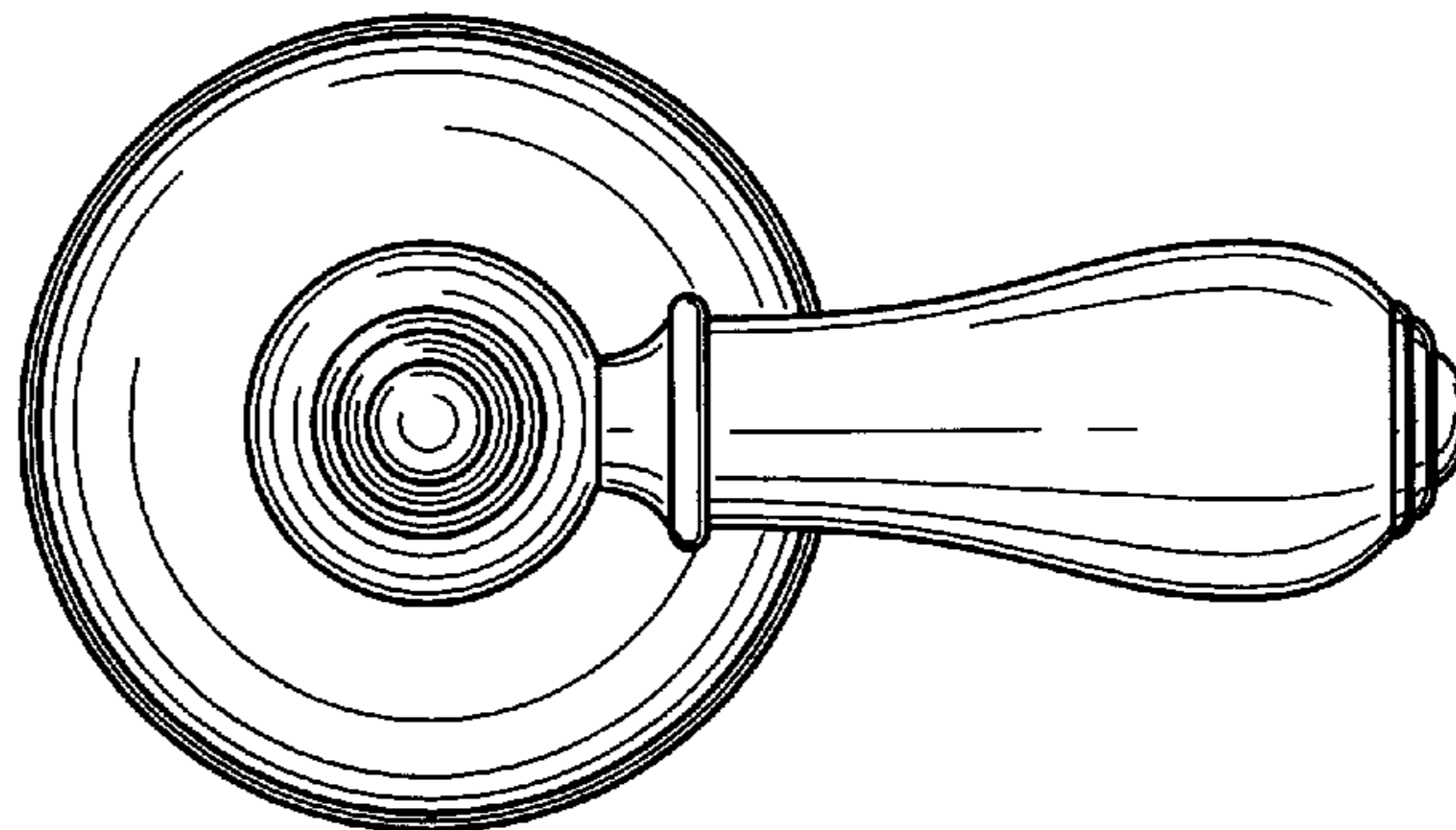

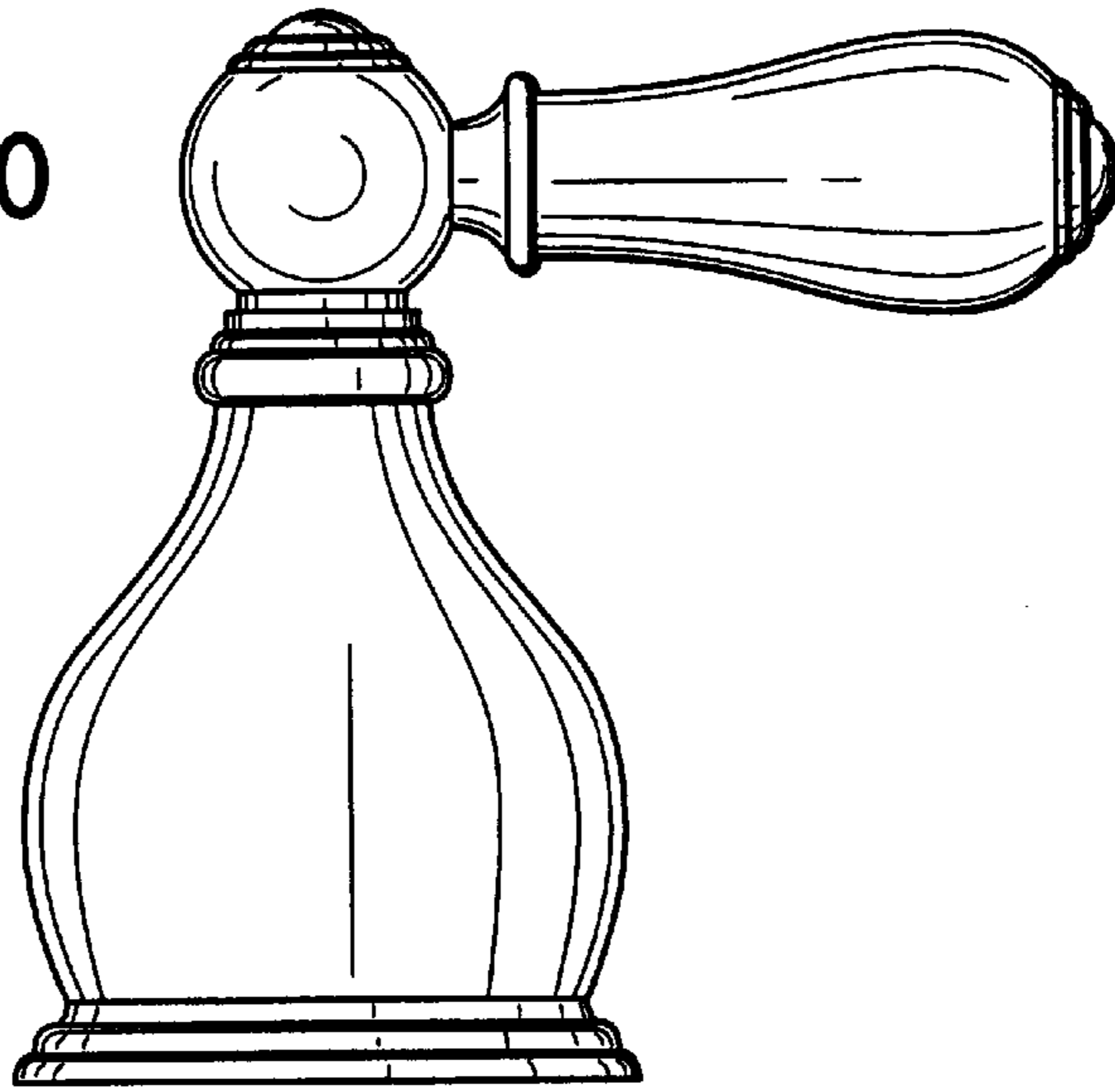

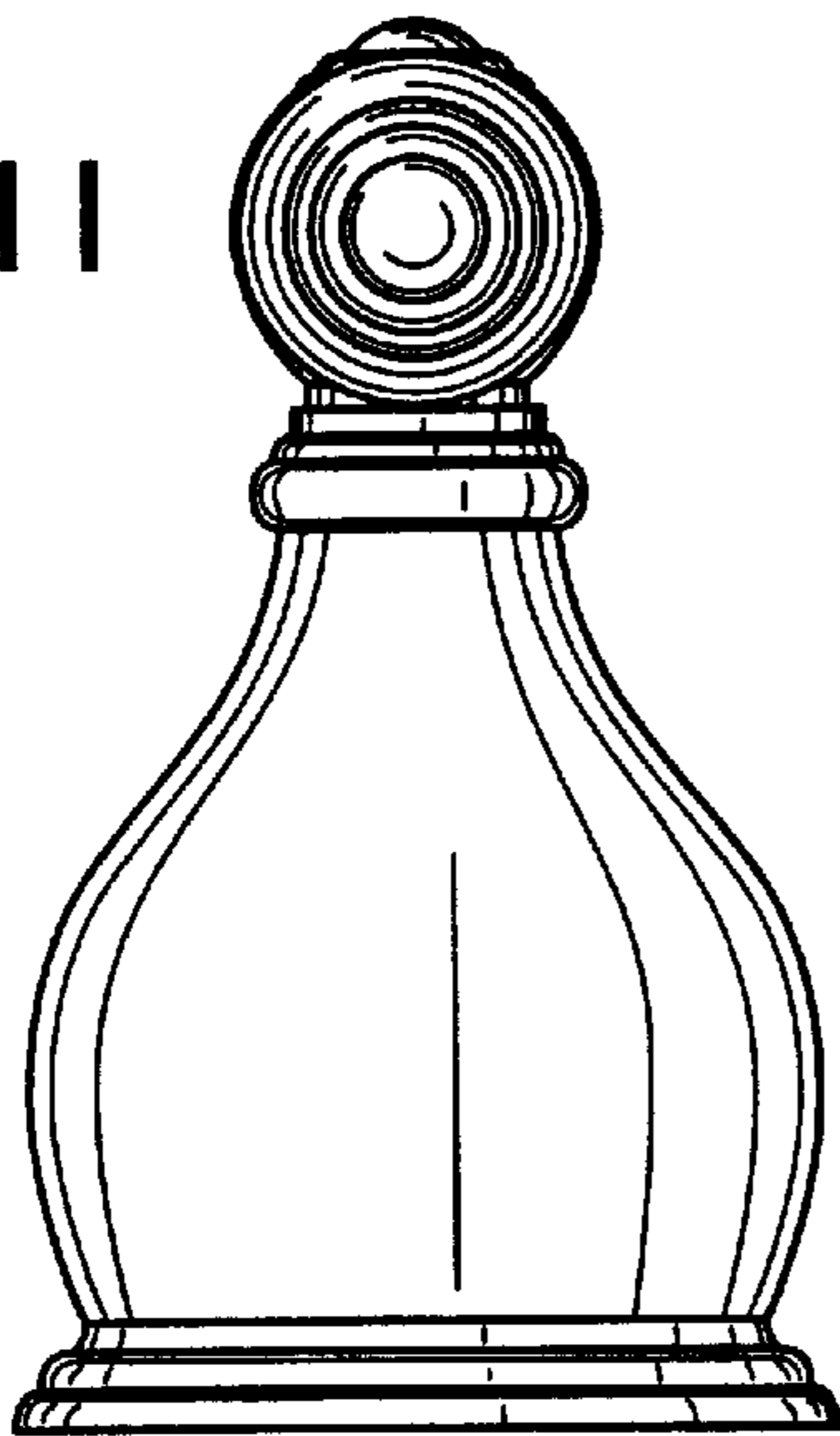
