[57] **CLAIM**

The ornamental design for a child's drinking bottle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a child's drinking bottle, showing my new design;

FIG. 2 is a front elevational view thereof, with the rear elevational view being substantially a mirror image thereof;

FIG. 3 is an end elevational view thereof;

FIG. 4 is an opposite end elevational view thereof;

FIG. 5 is a top plan view thereof;

FIG. 6 is a bottom plan view thereof;

FIG. 7 is a perspective view of a second embodiment of the child's drinking bottle;

FIG. 8 is a front elevational view thereof, with the rear elevational view being substantially a mirror image thereof;

FIG. 9 is an end elevational view thereof;

FIG. 10 is an opposite end elevational view thereof;

FIG. 11 is a top plan view thereof;

FIG. 12 is a bottom plan view thereof;

FIG. 13 is a perspective view of a third embodiment of the child's drinking bottle;

FIG. 14 is a front elevational view thereof, with the rear elevational view being substantially a mirror image thereof;

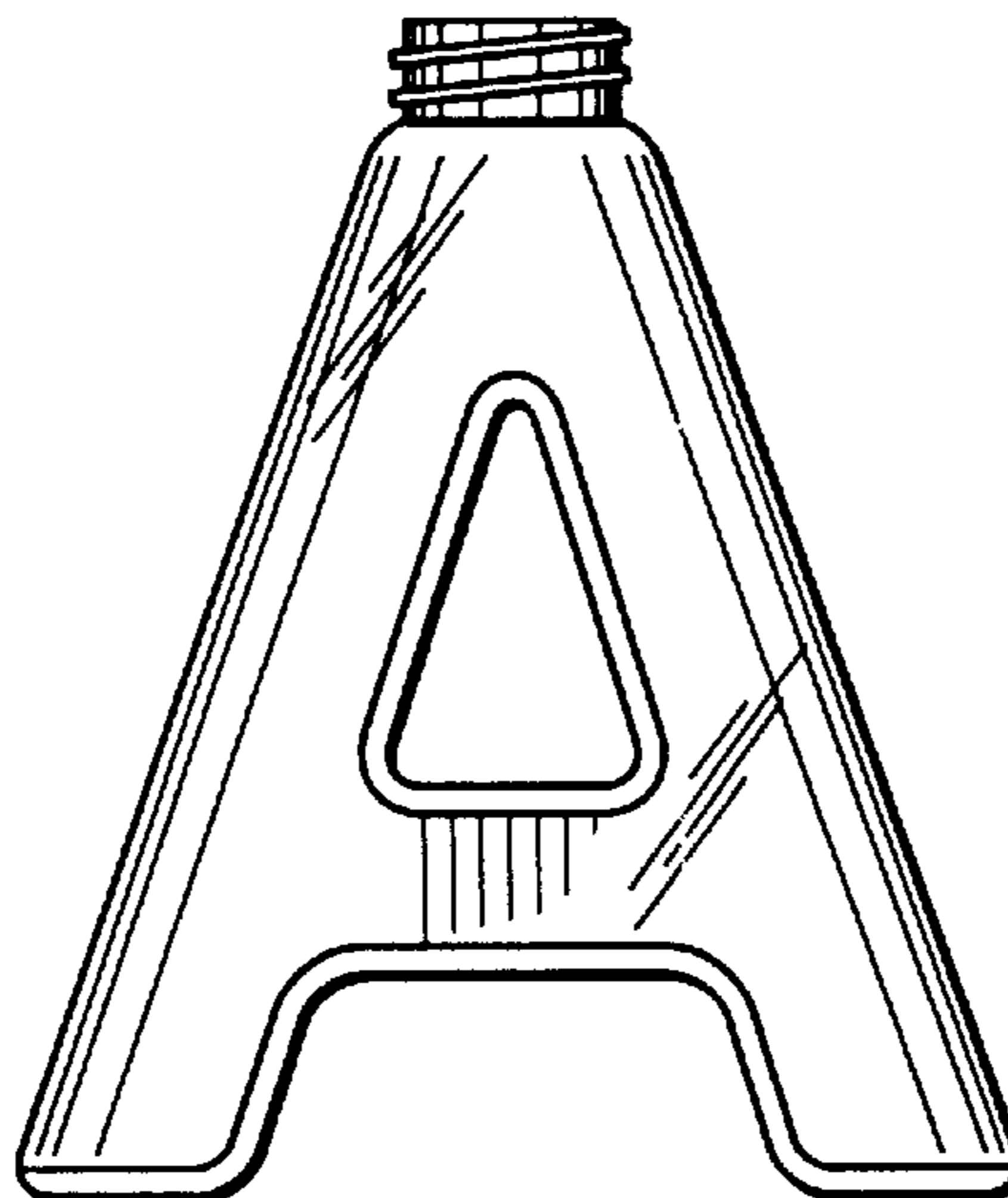
FIG. 15 is an end elevational view thereof;

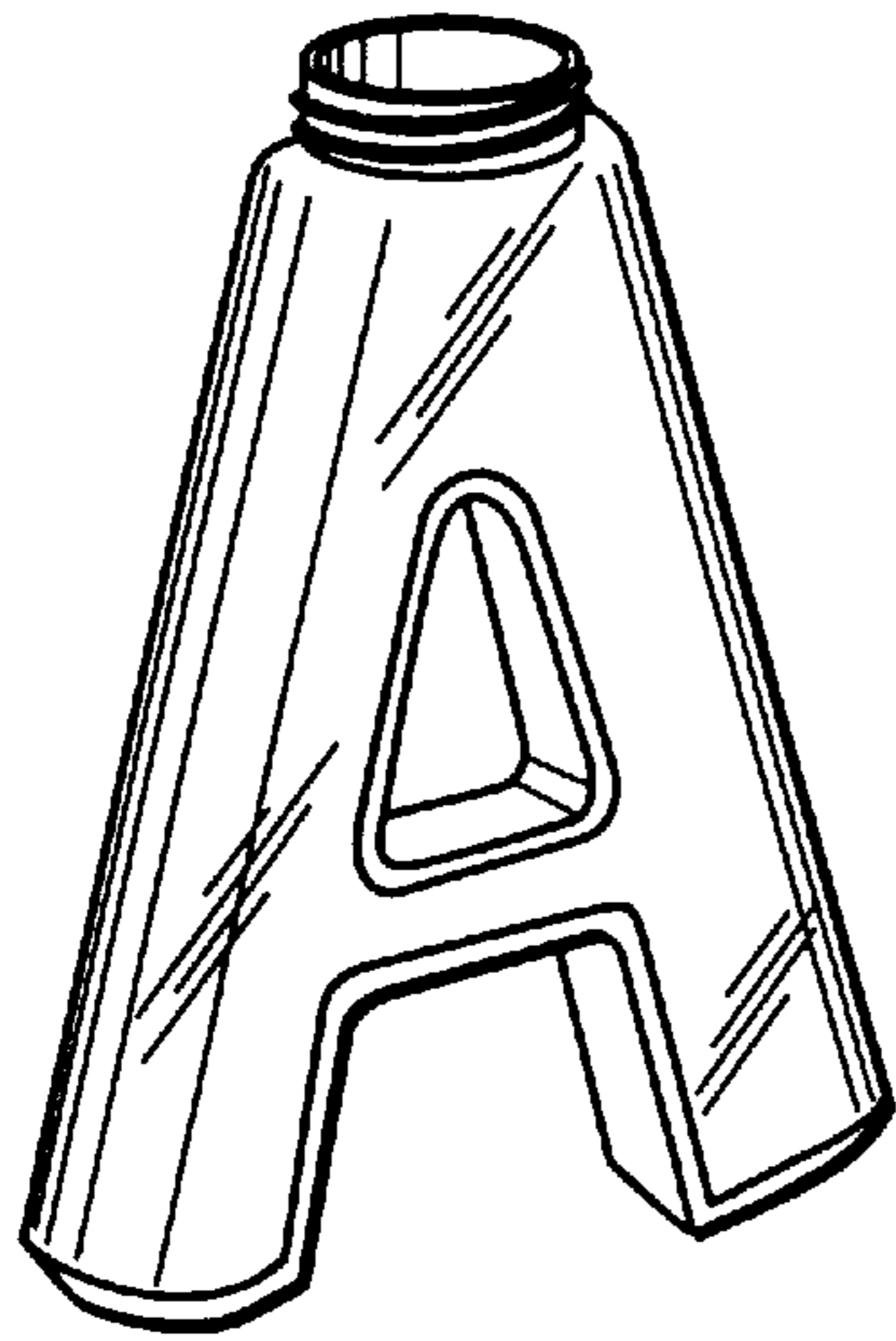

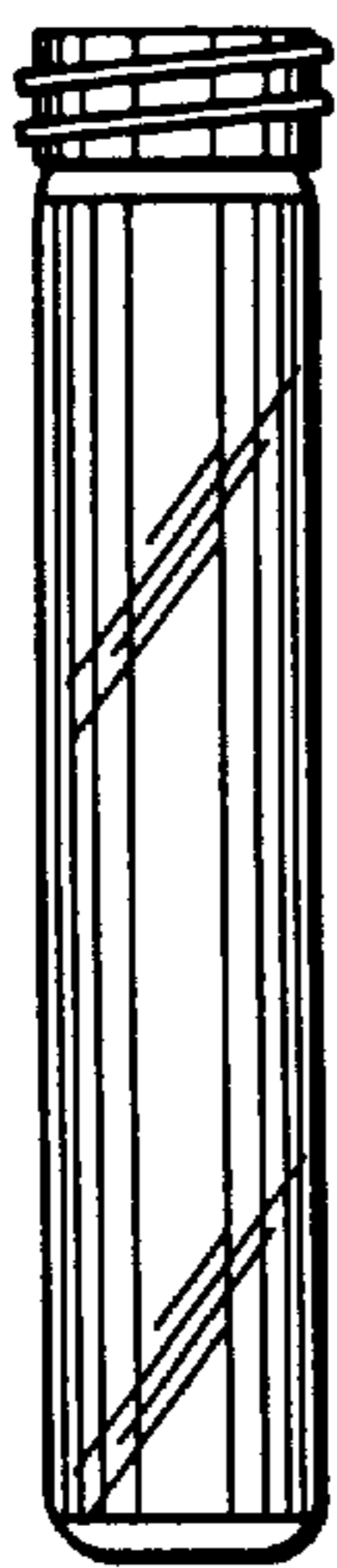

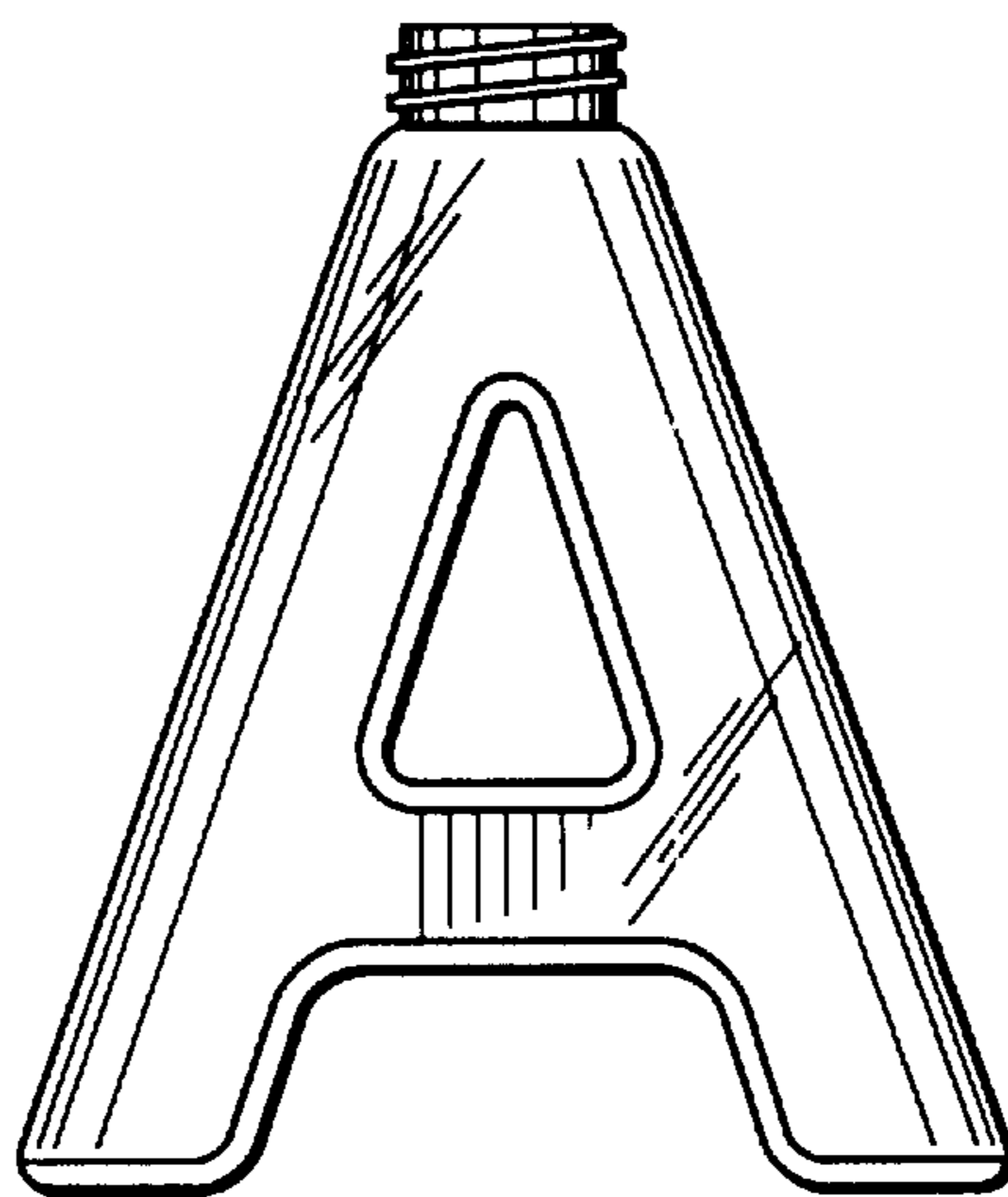

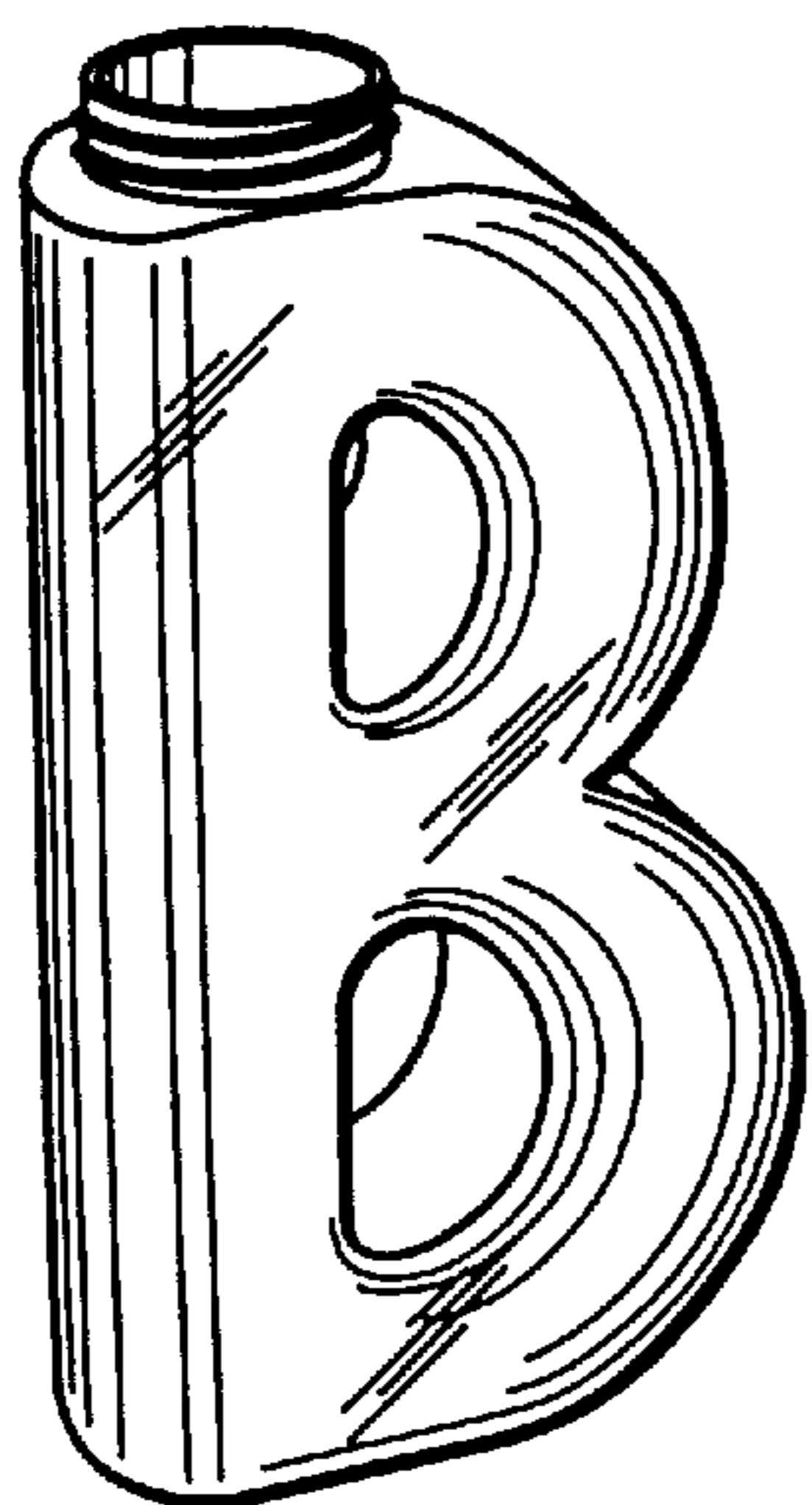

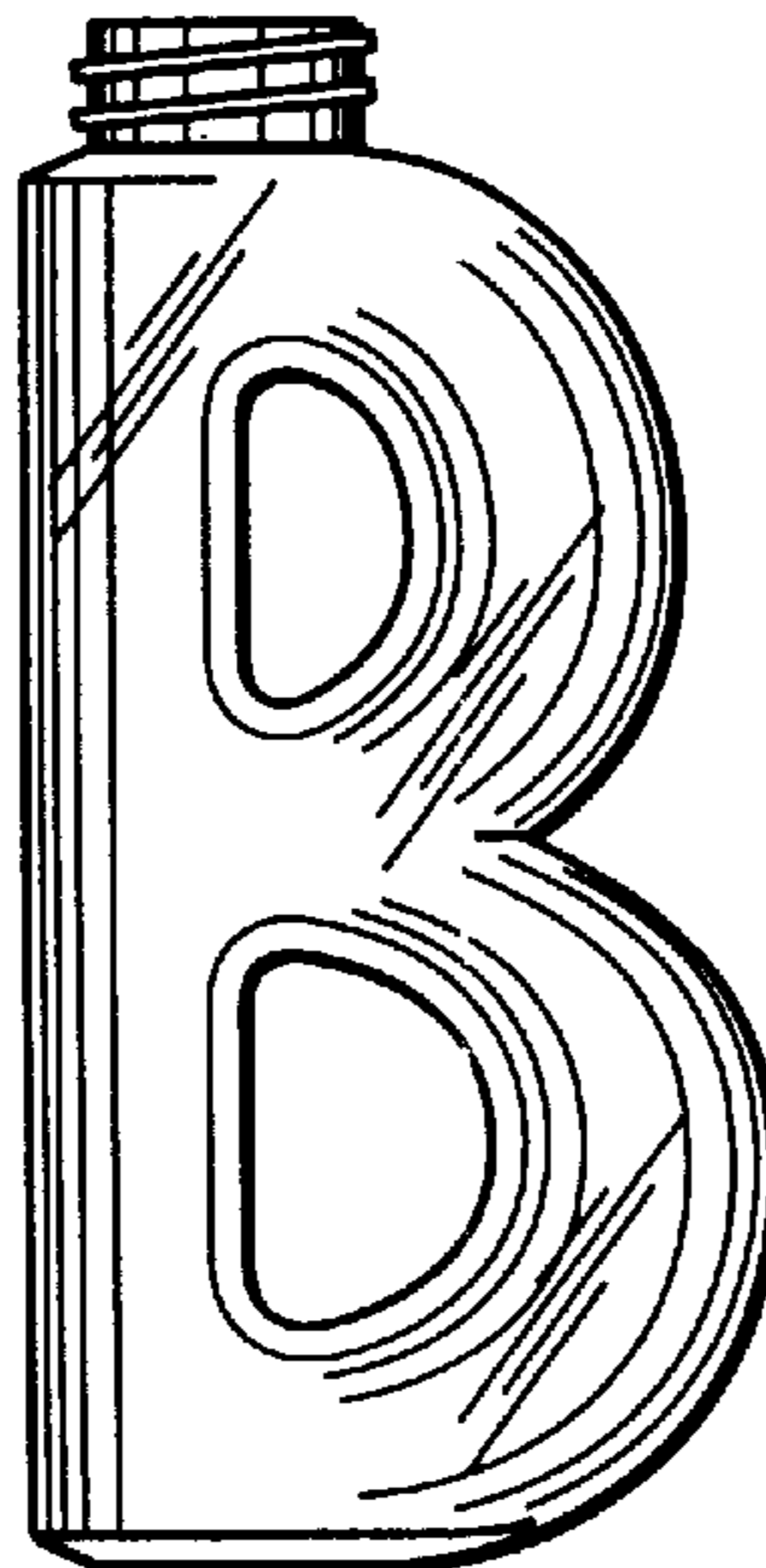

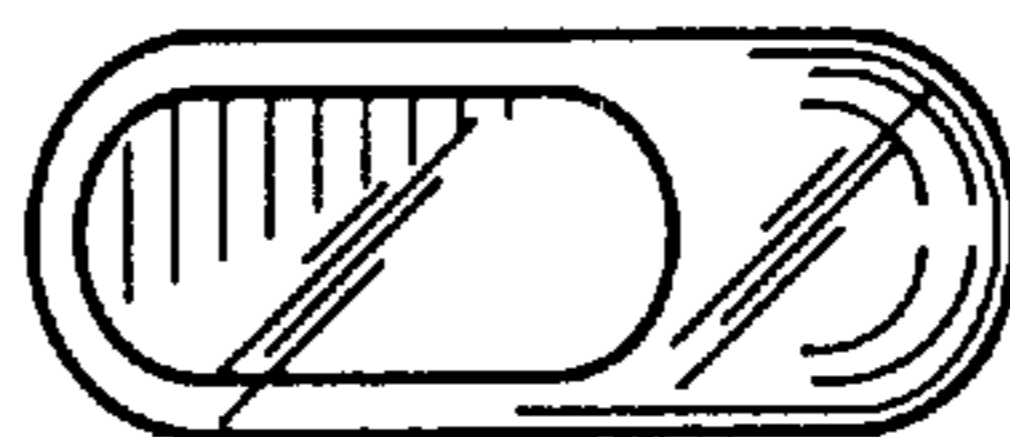

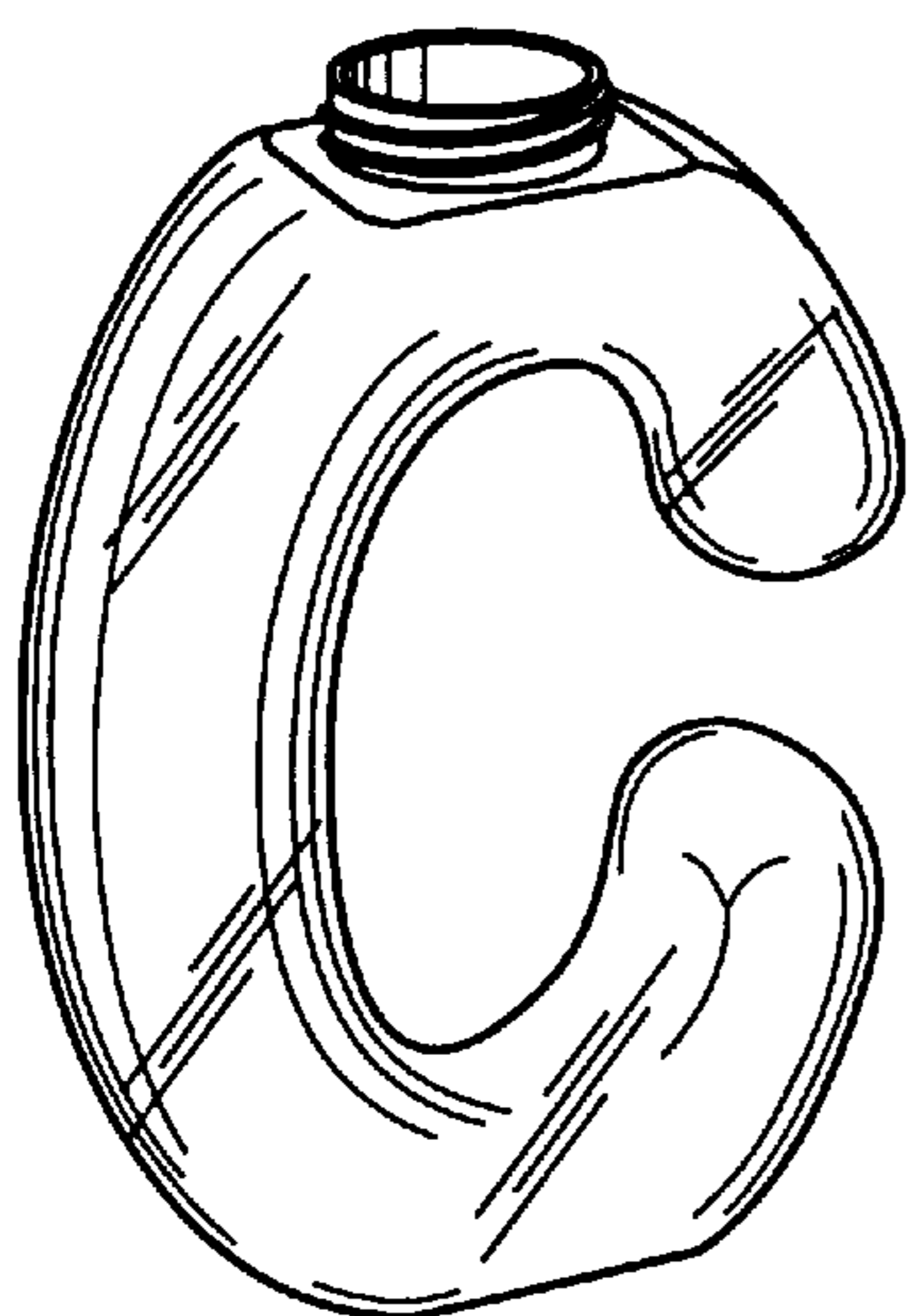

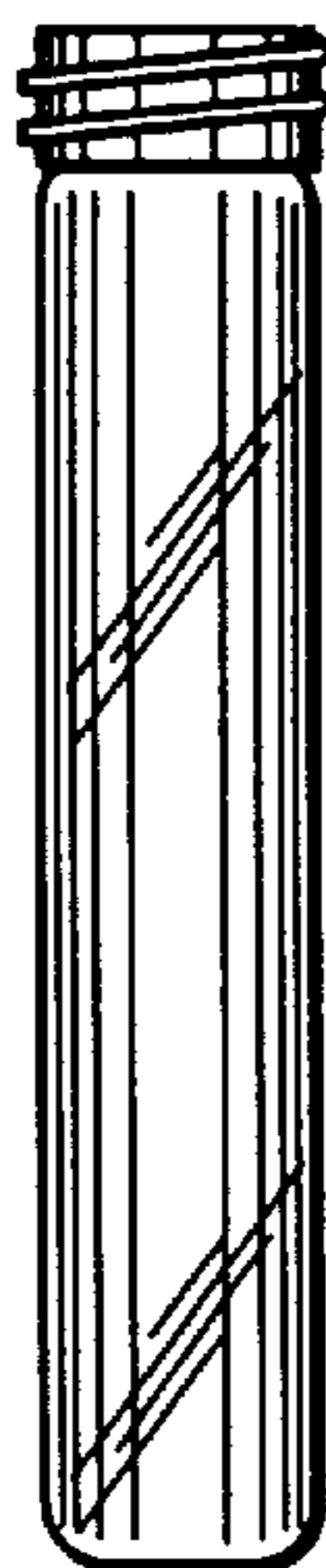

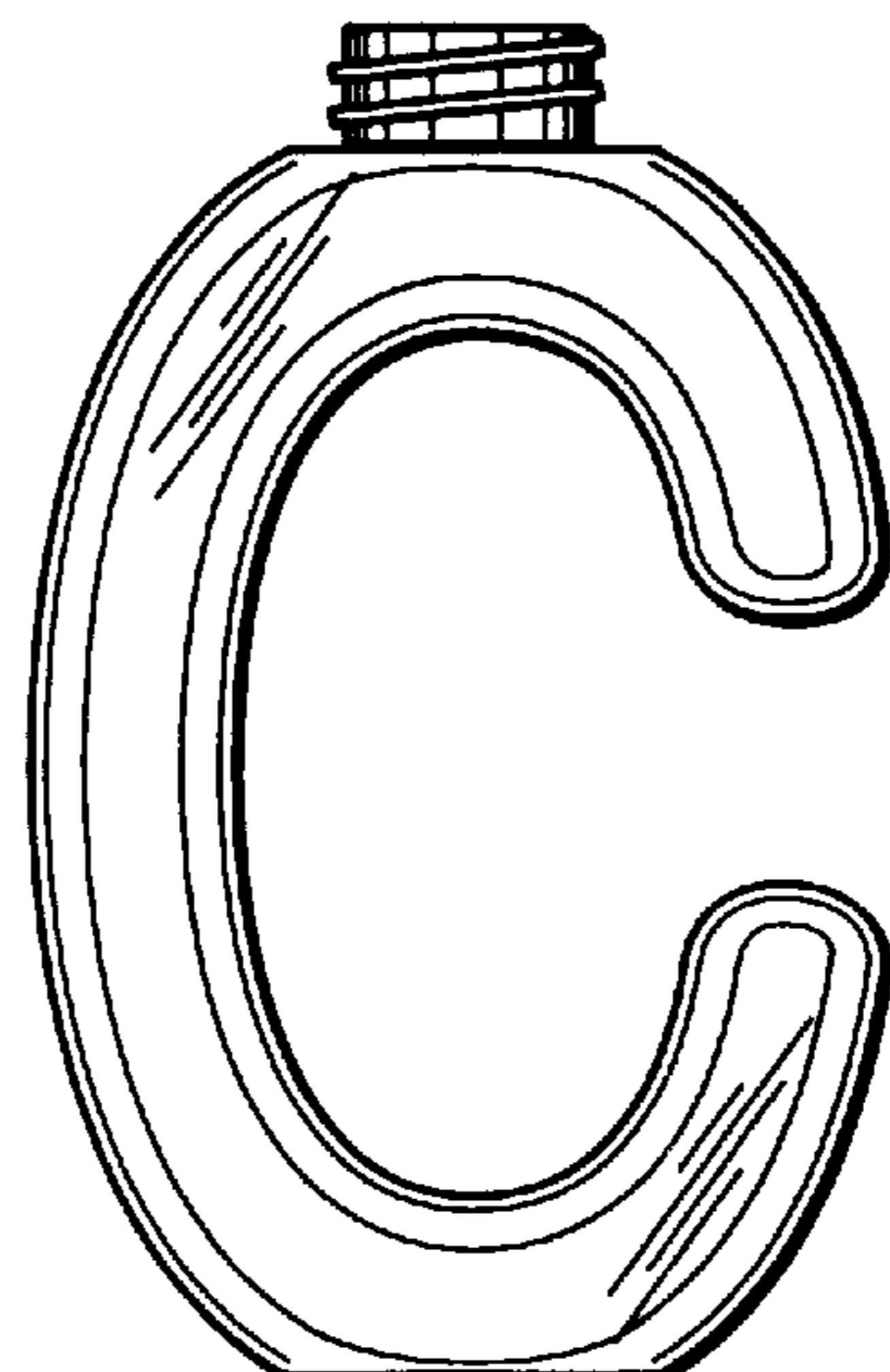
