FIG. 5 is a bottom view thereof in a closed bag position;

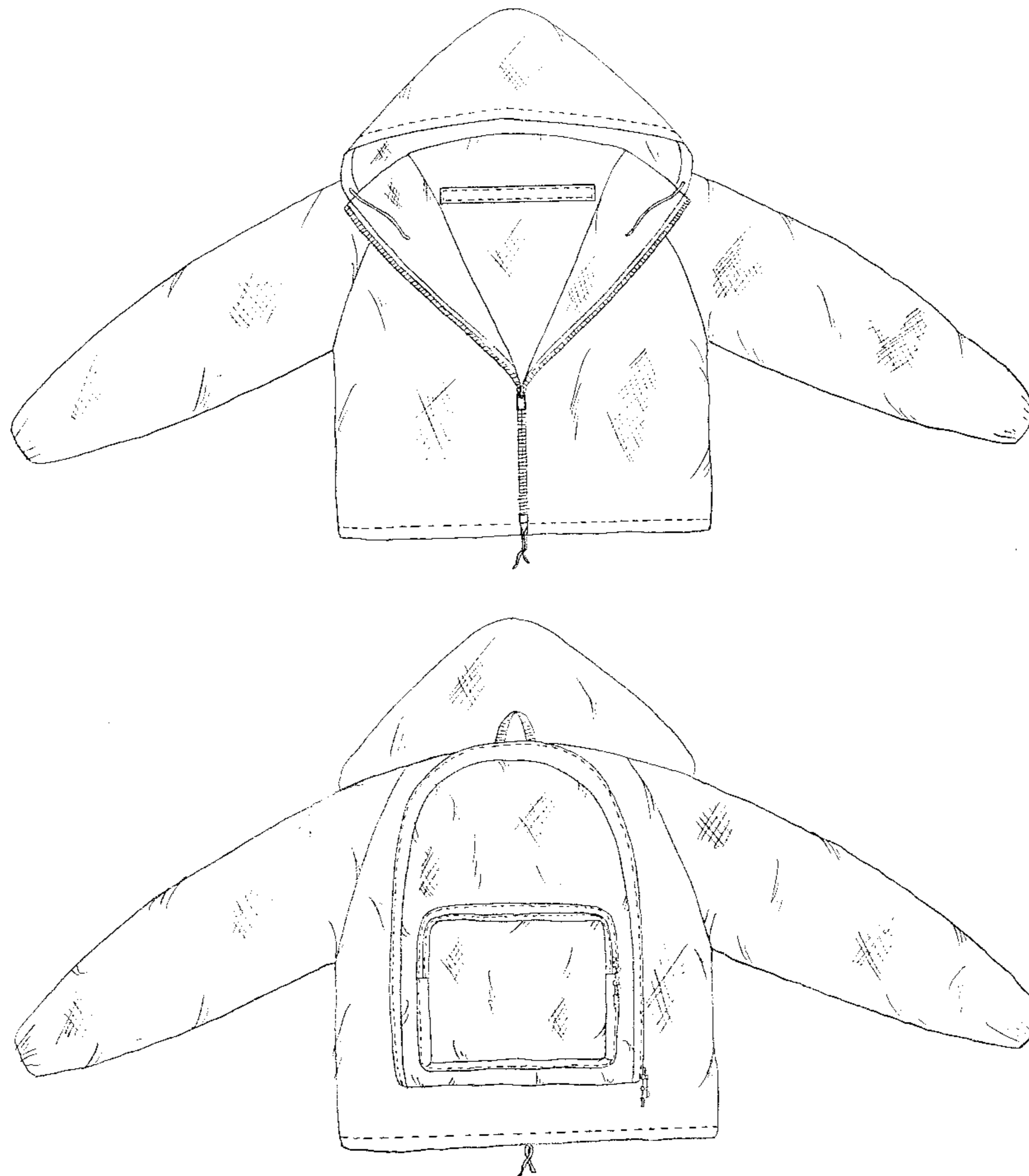
FIG. 6 is a rear view thereof in a closed bag position;

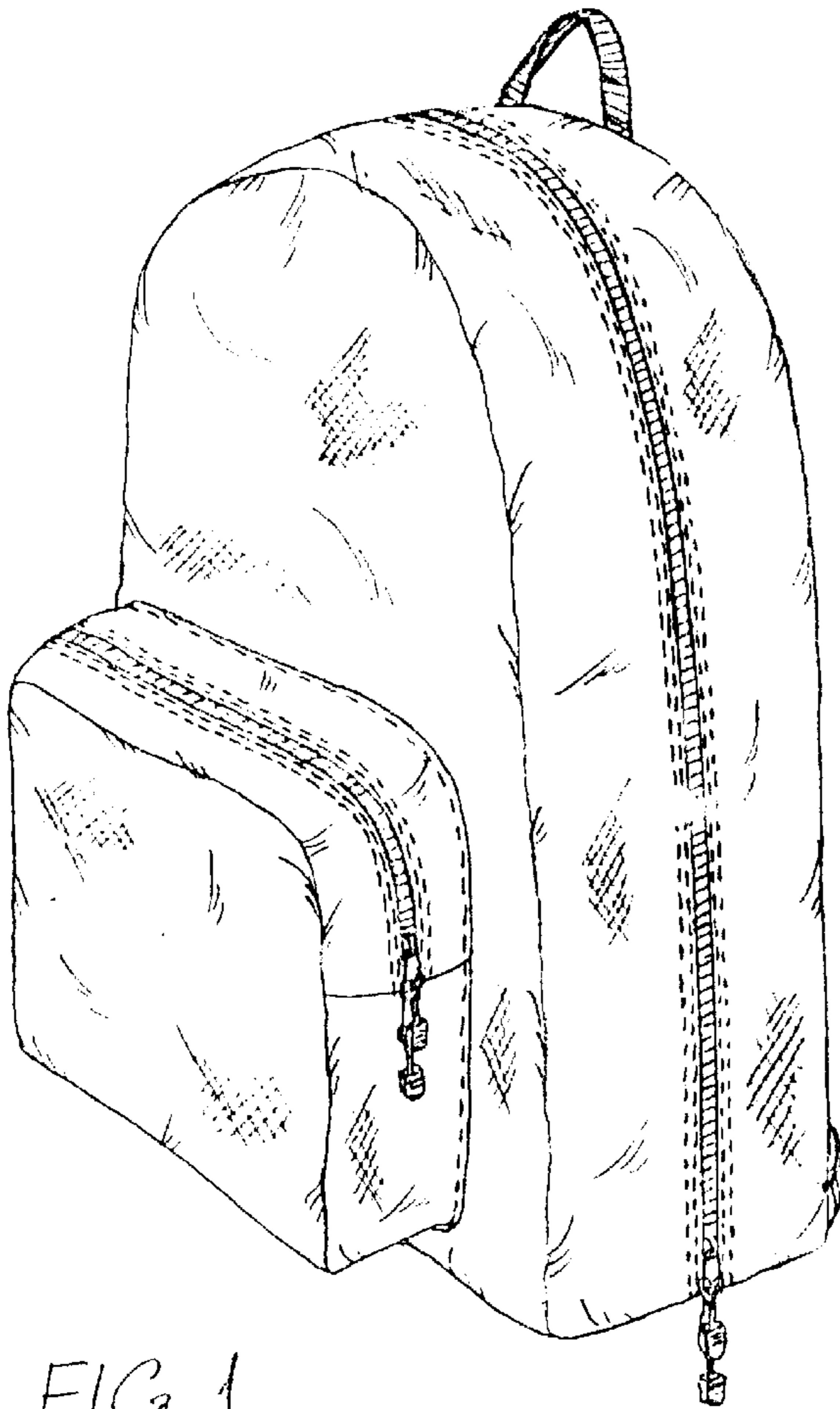

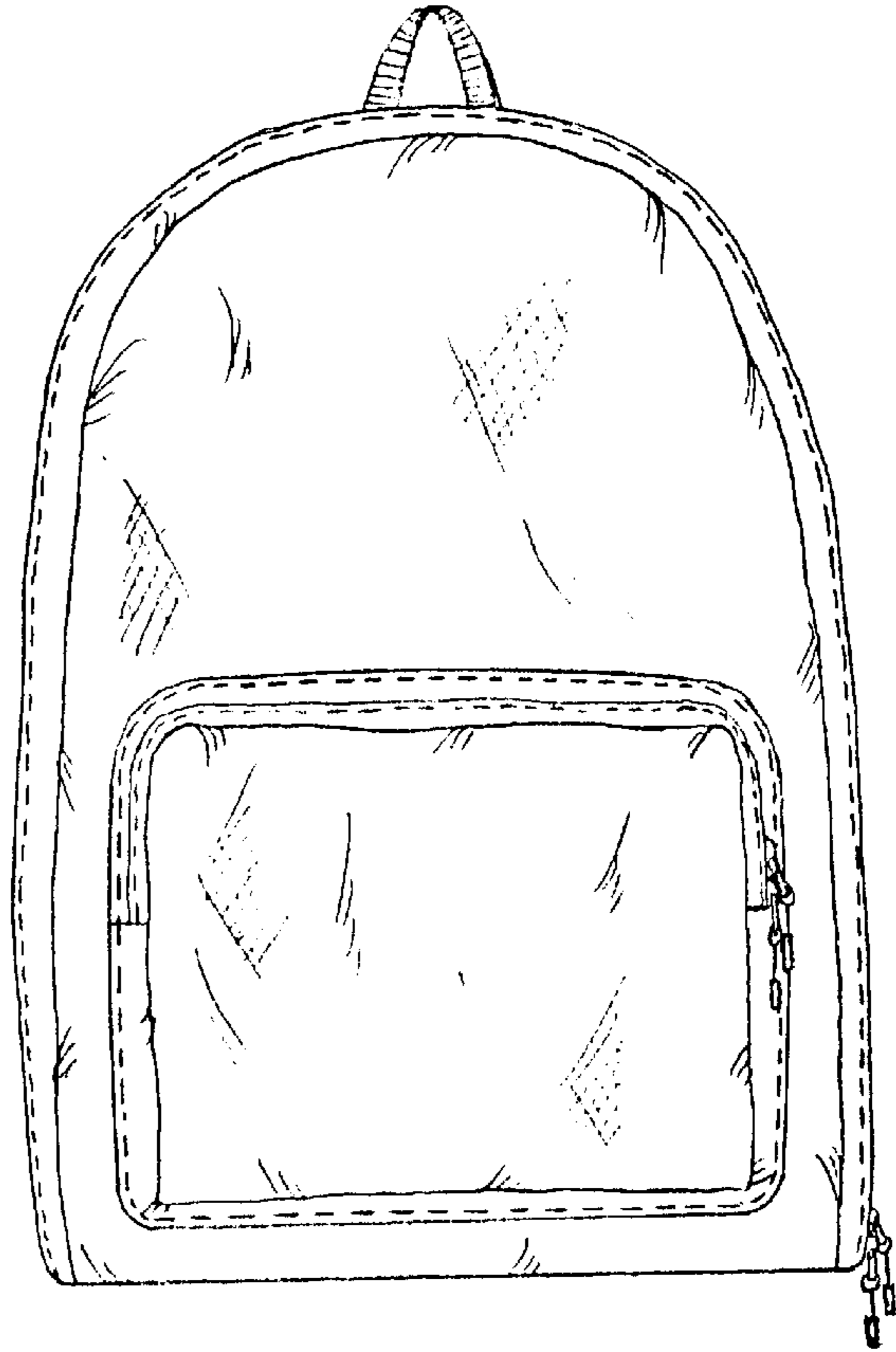

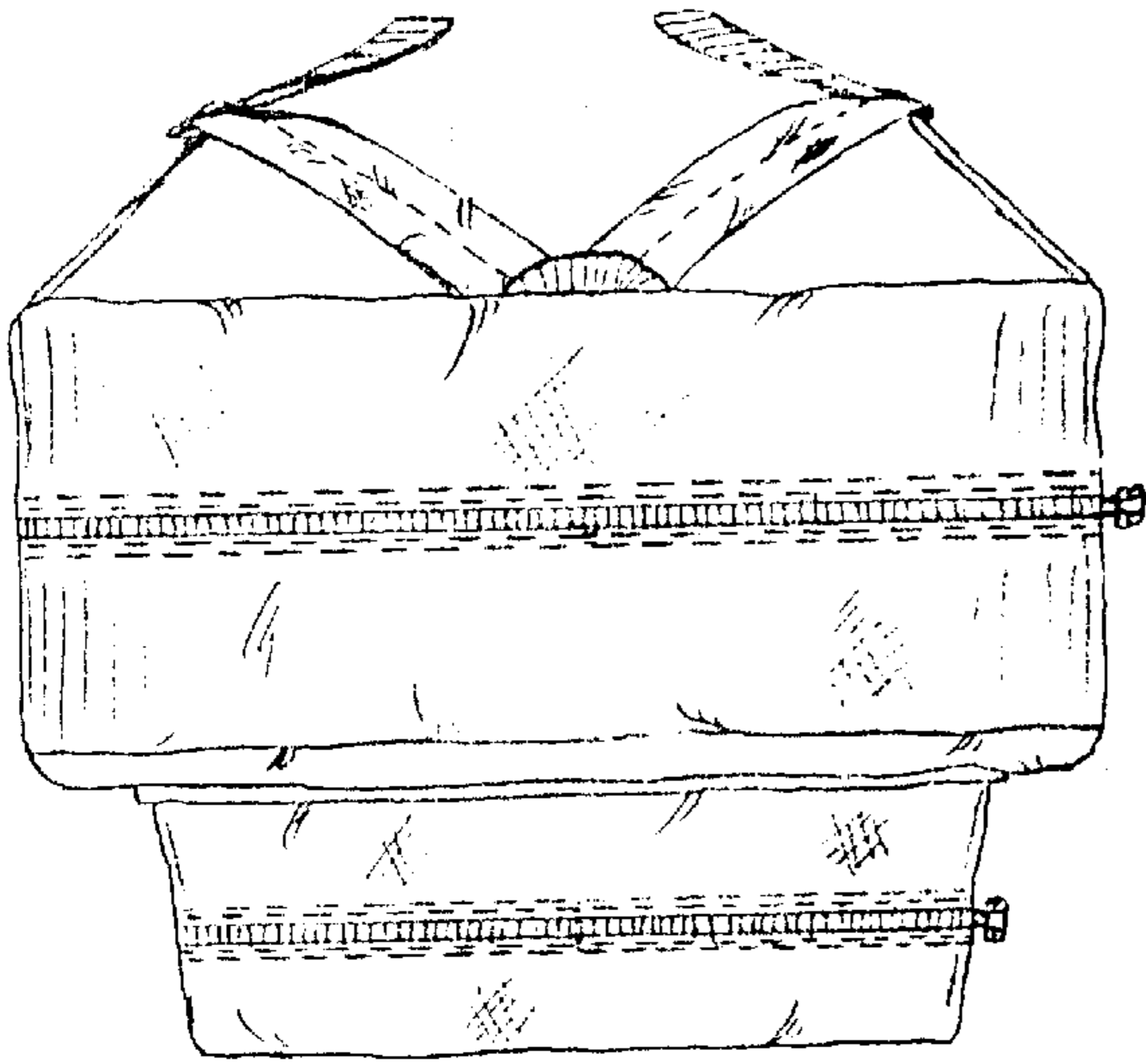

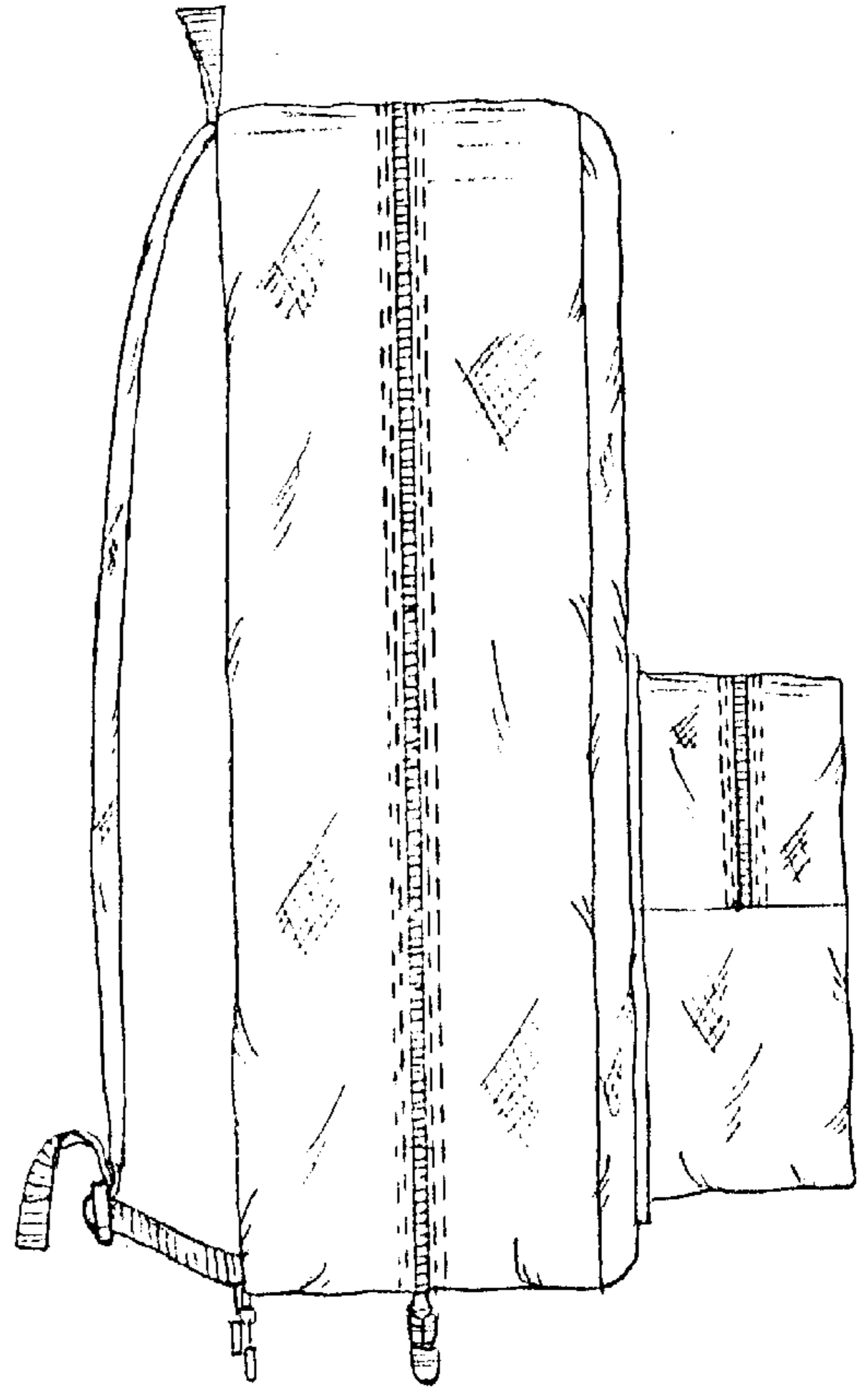

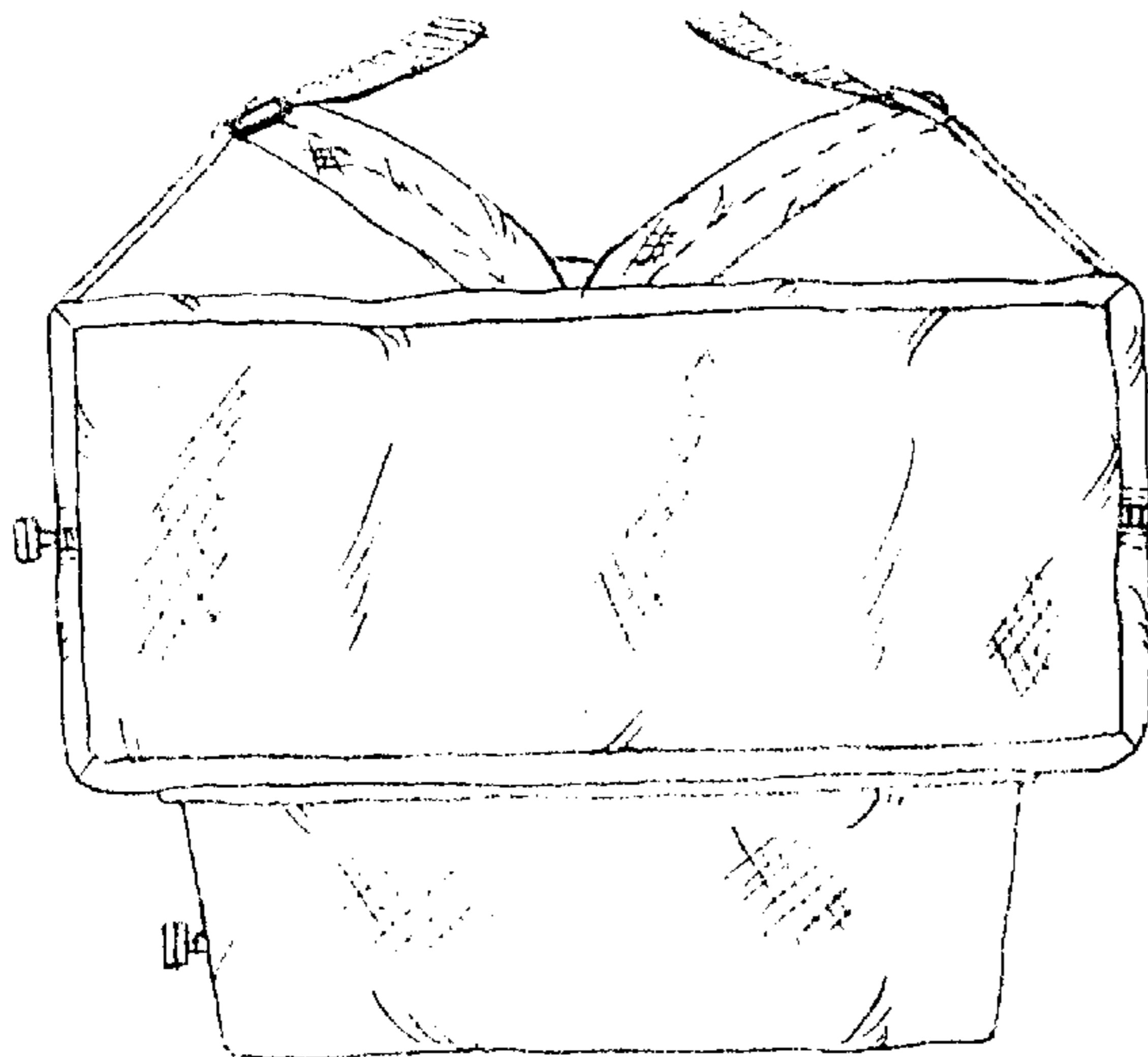

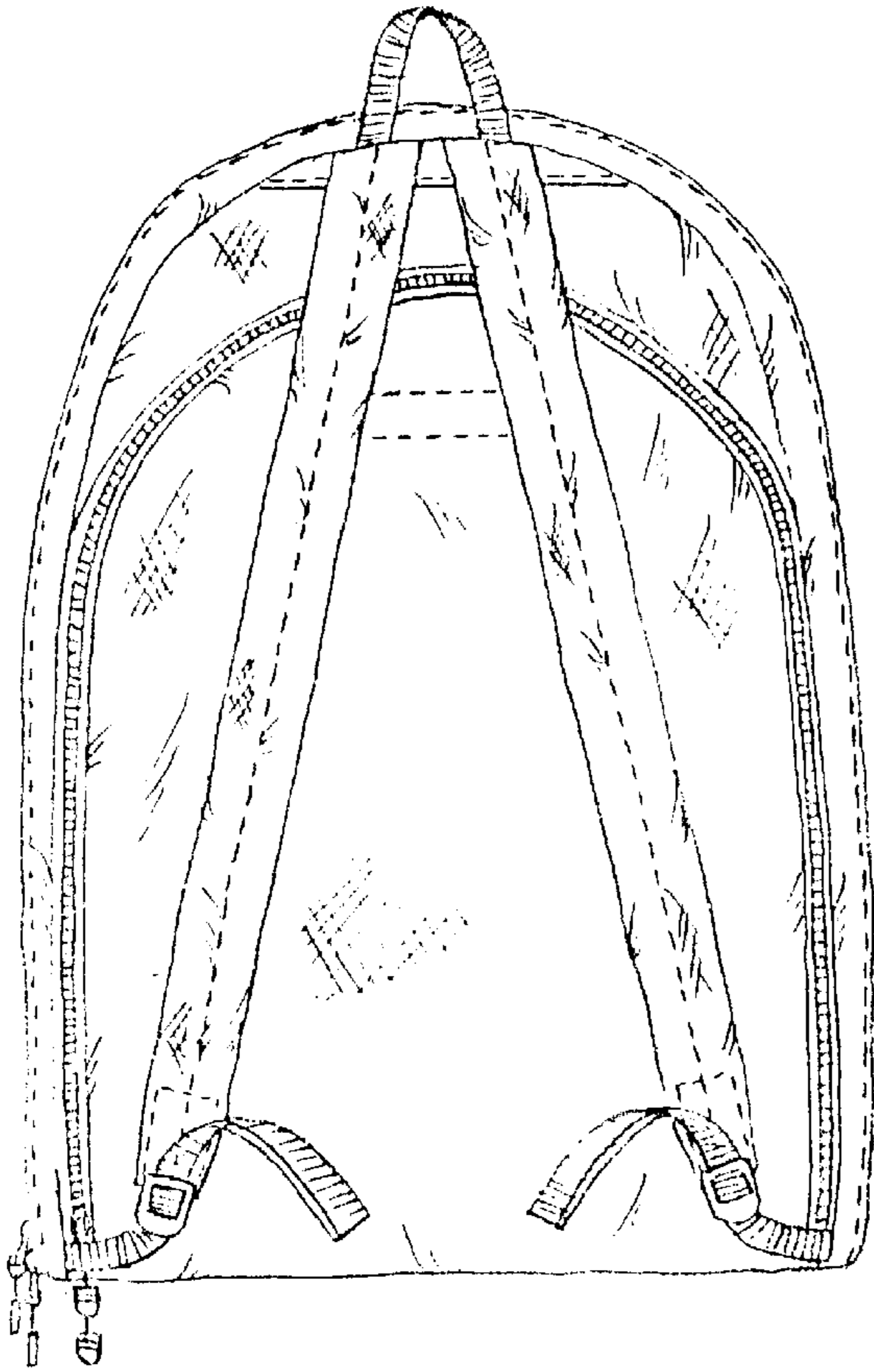

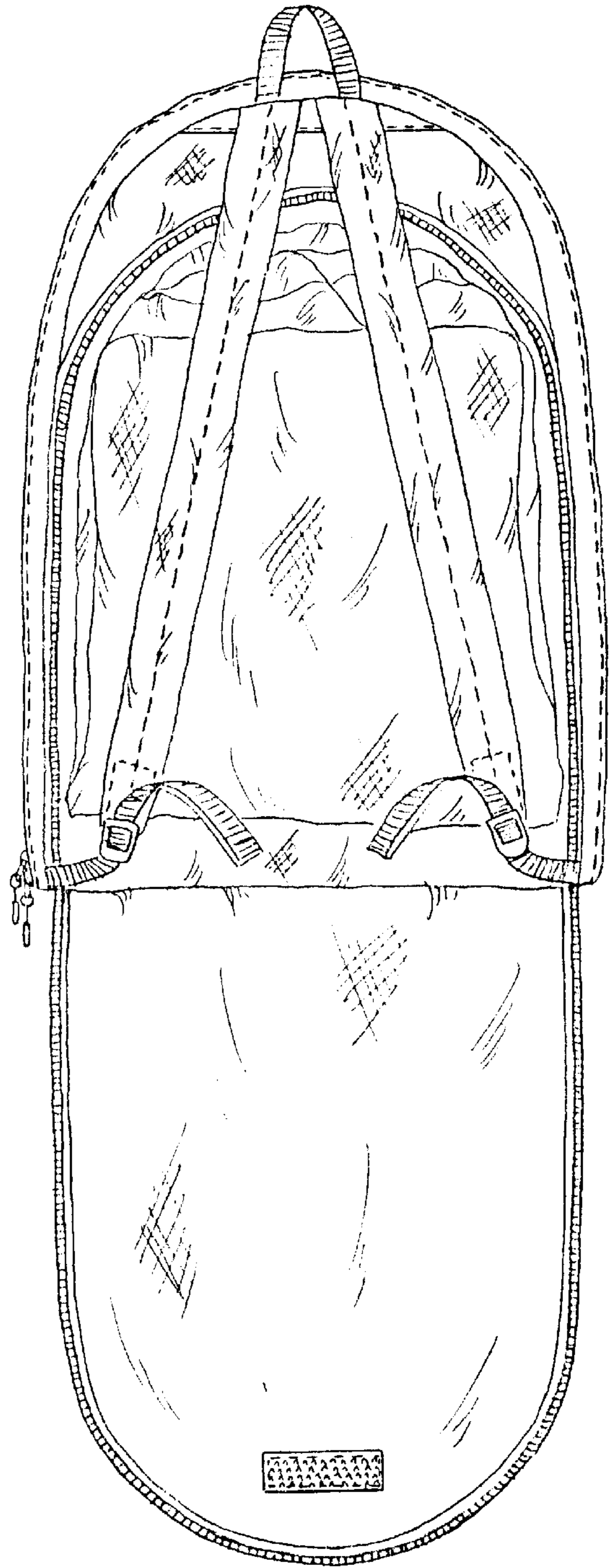
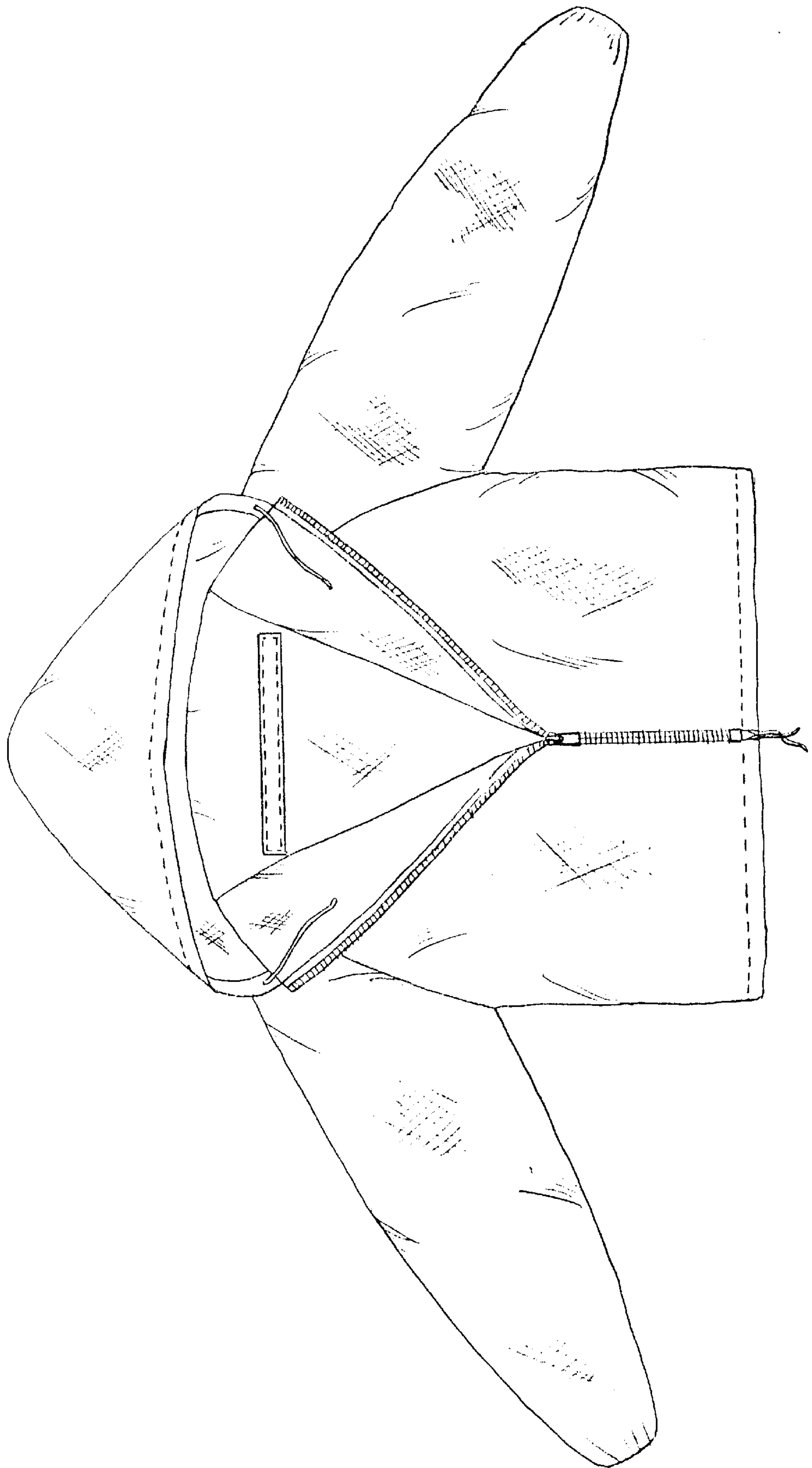

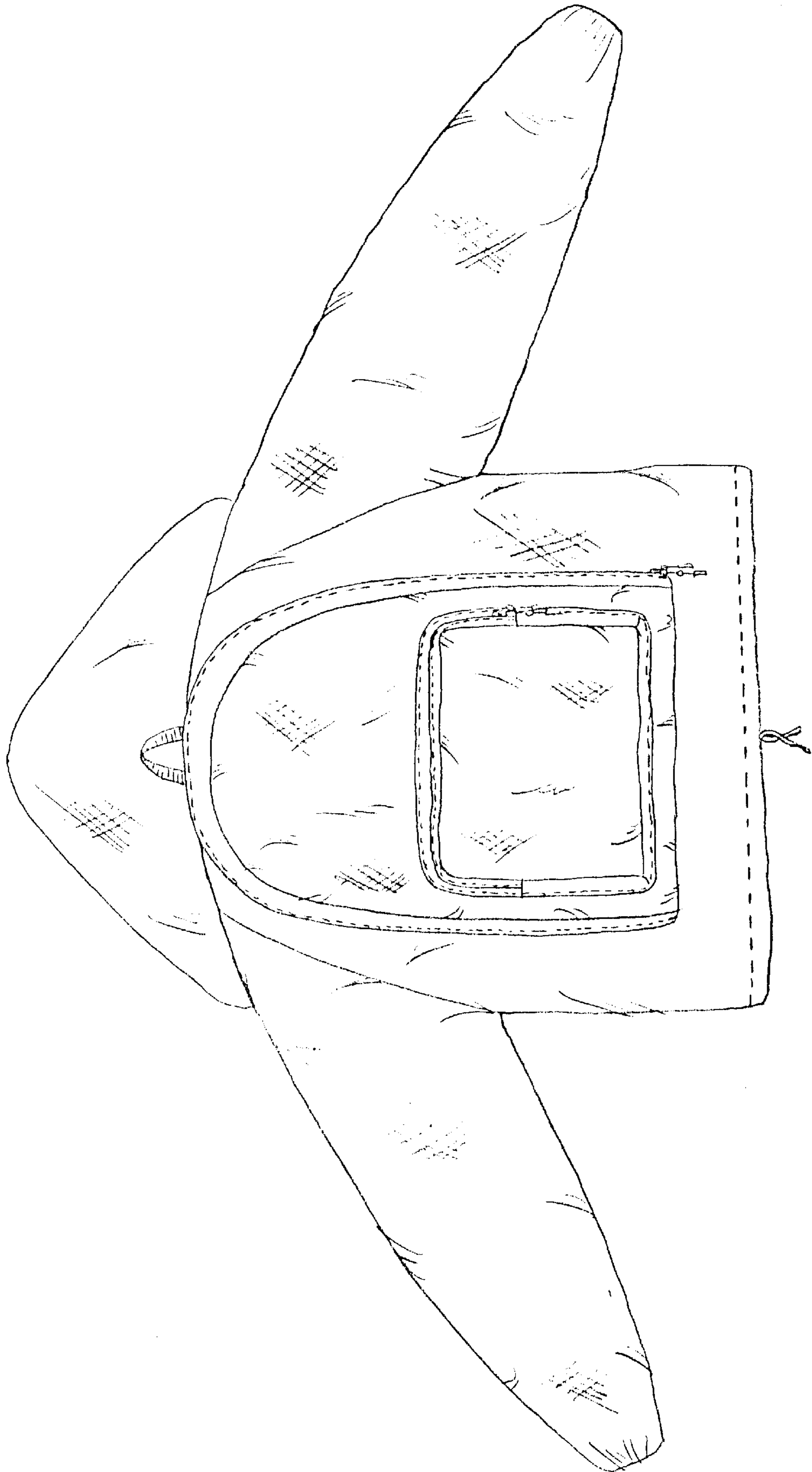
