[57] **CLAIM**

The ornamental design for a portion of a shoe upper, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a portion of a shoe upper in accordance with a first embodiment of my new design;

FIG. 2 is a side elevational view of the portion of a shoe upper of FIG. 1;

FIG. 3 is a front elevational view of the portion of a shoe upper of FIG. 1;

FIG. 4 is a top plan view of the portion of a shoe upper of FIG. 1;

FIG. 5 is a perspective view of a portion of a shoe upper in accordance with a second embodiment of my new design;

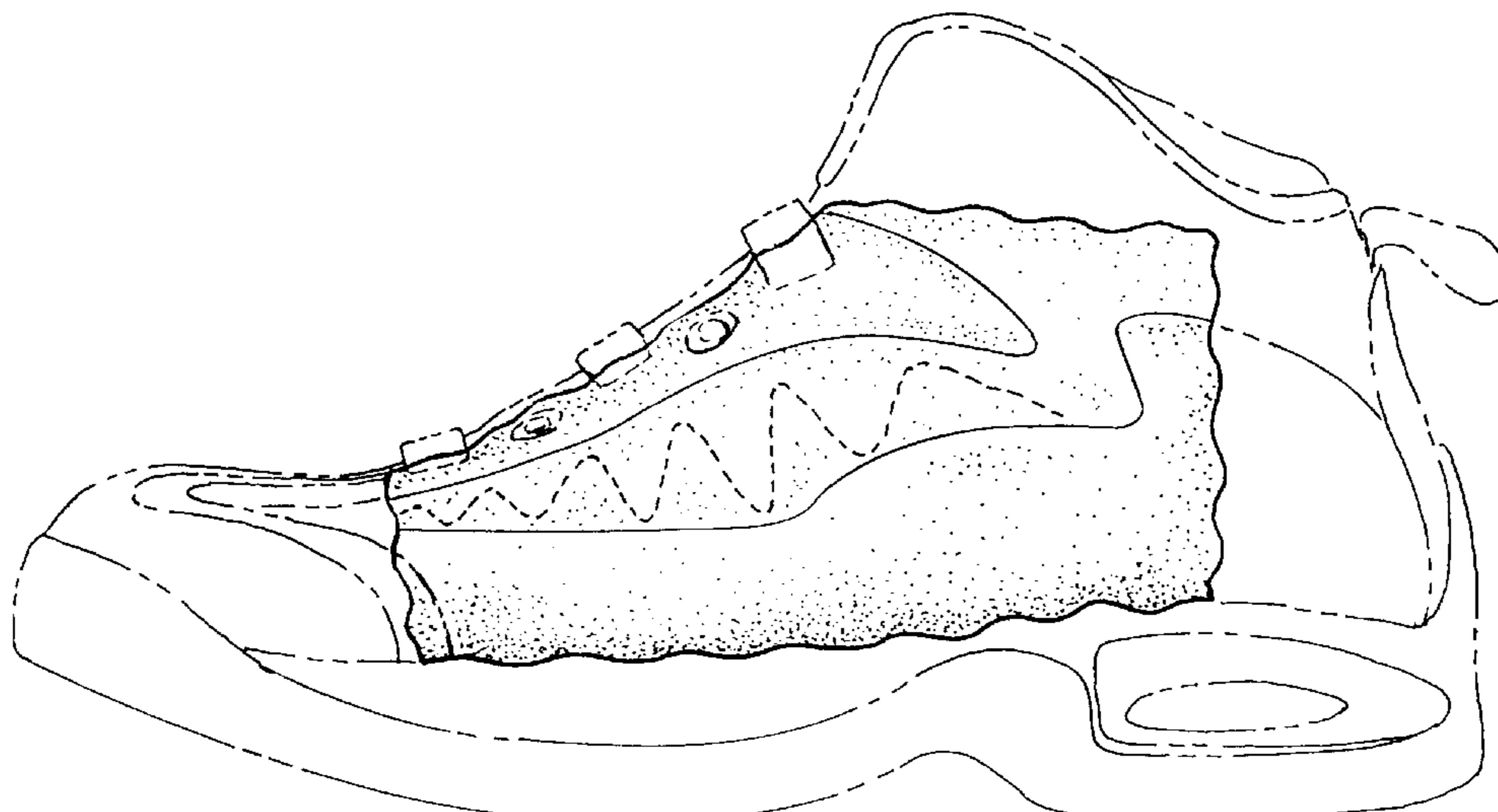
FIG. 6 is a side elevational view of the portion of a shoe upper of FIG. 5;

FIG. 7 is a front elevational view of the portion of a shoe upper of FIG. 5; and,

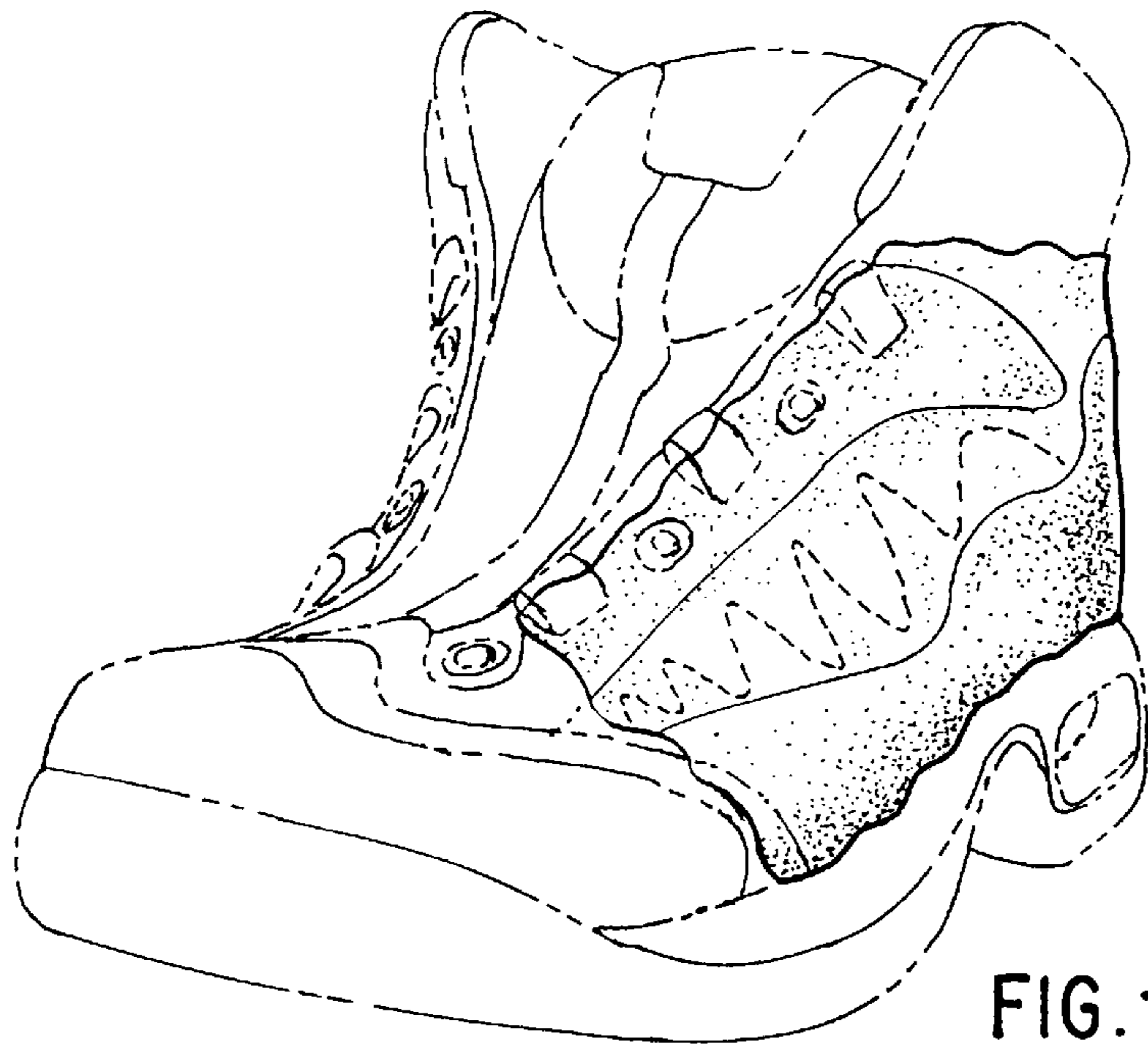

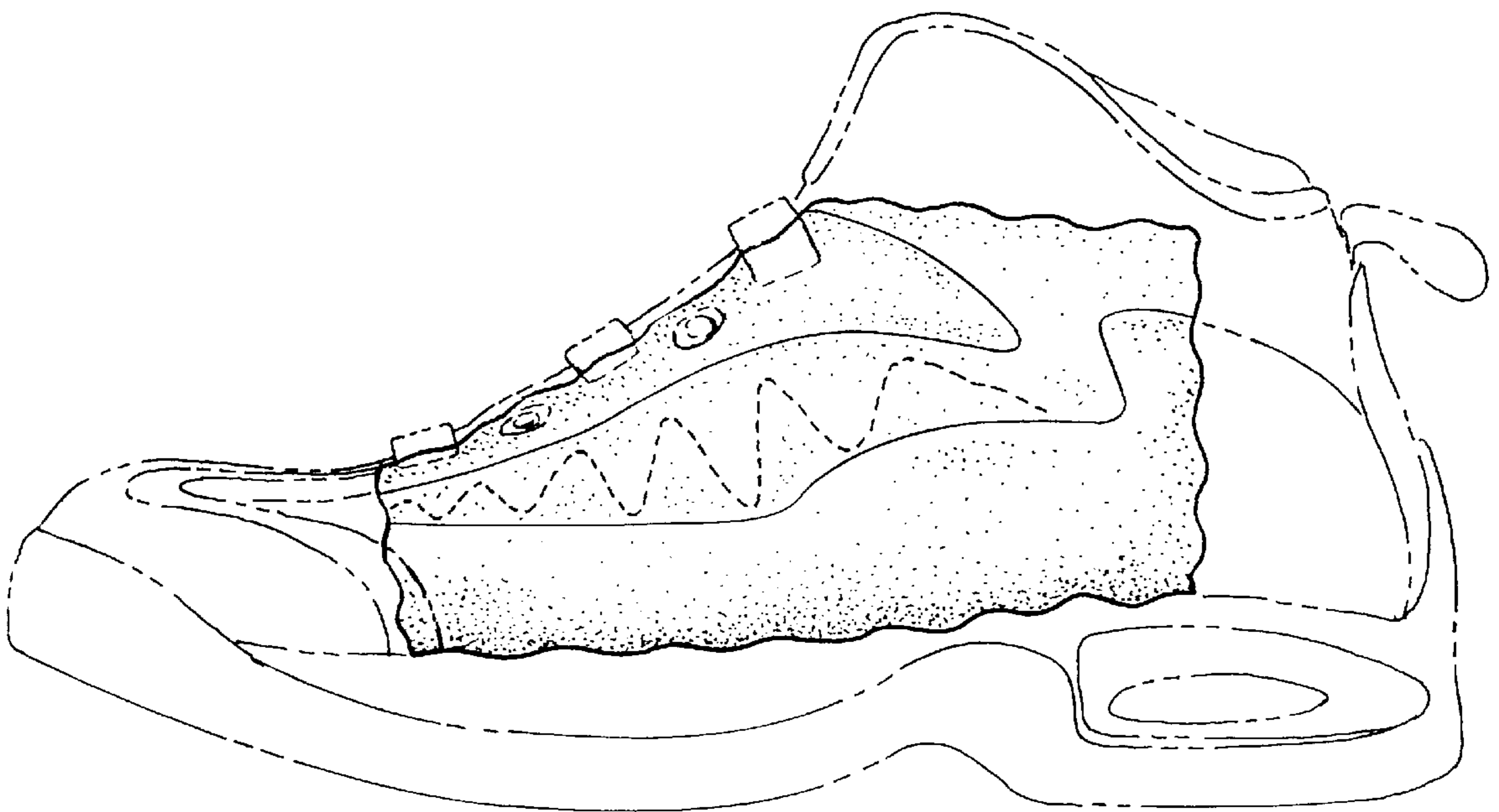

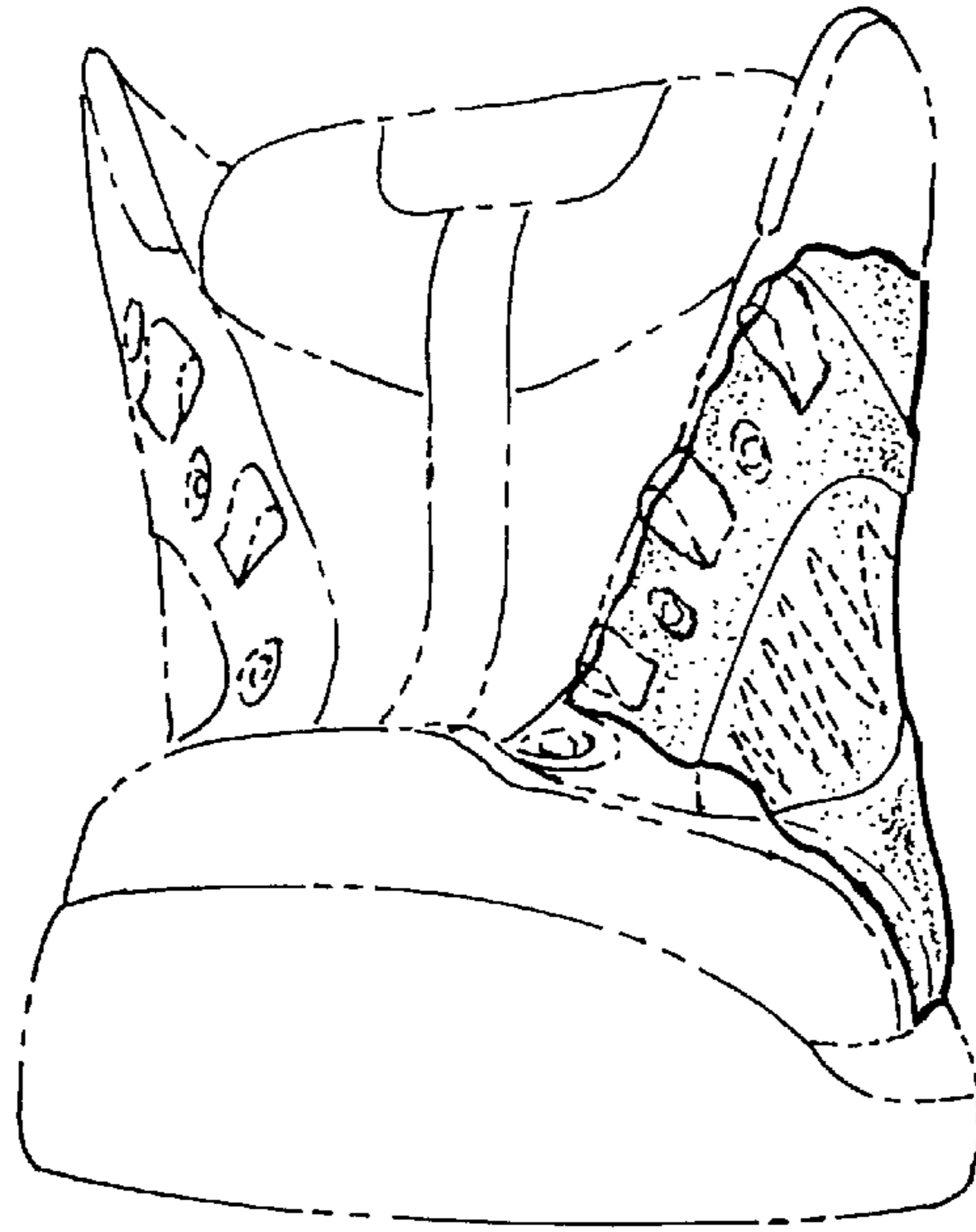

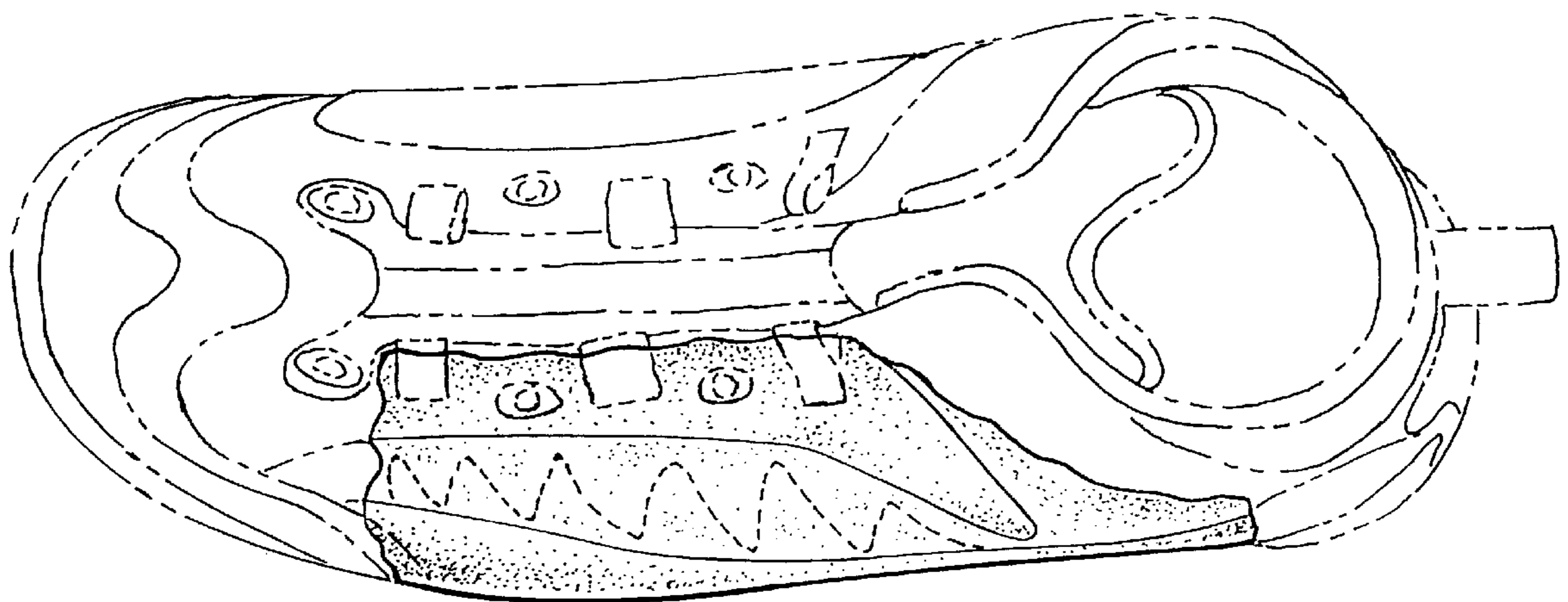

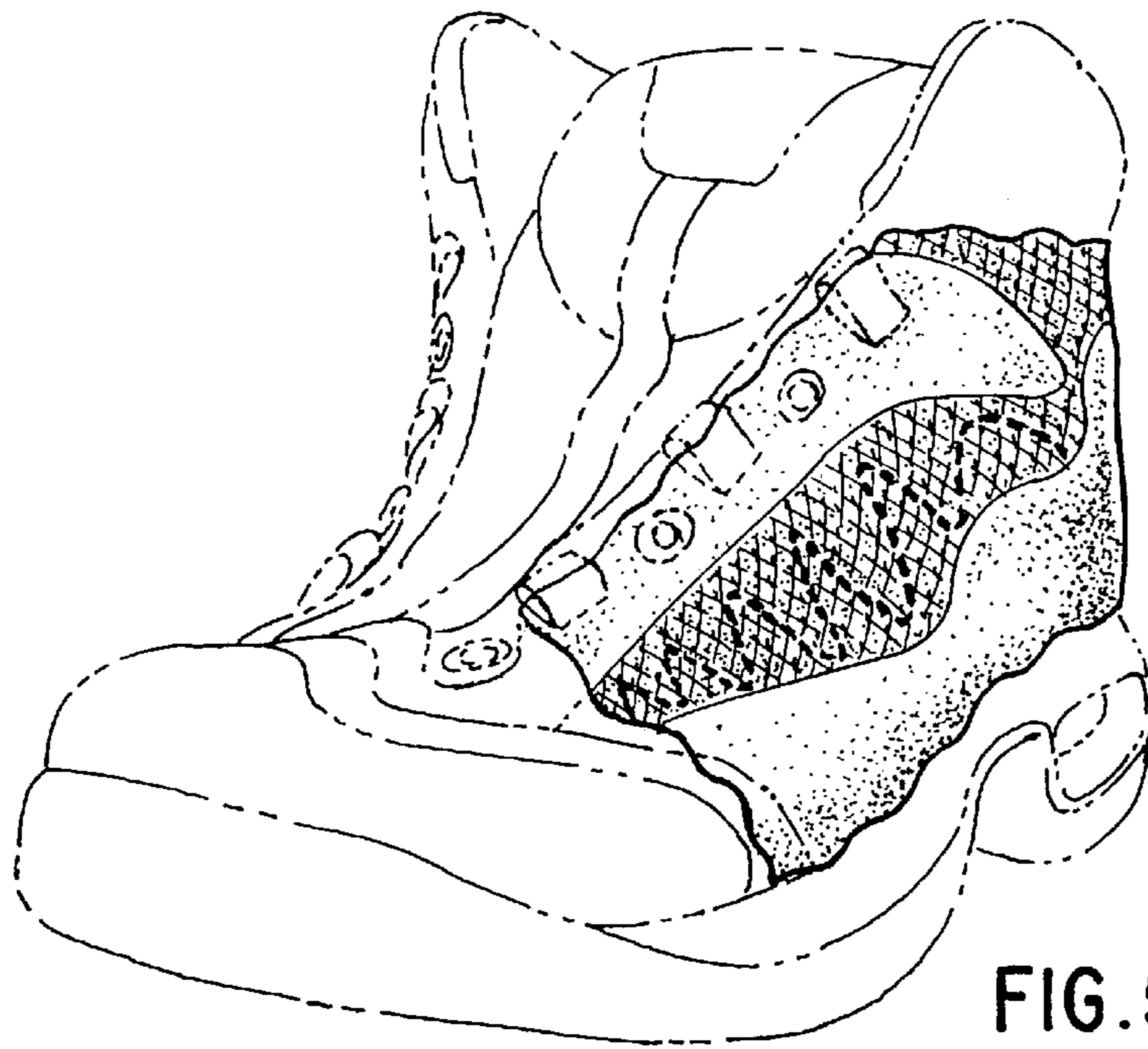

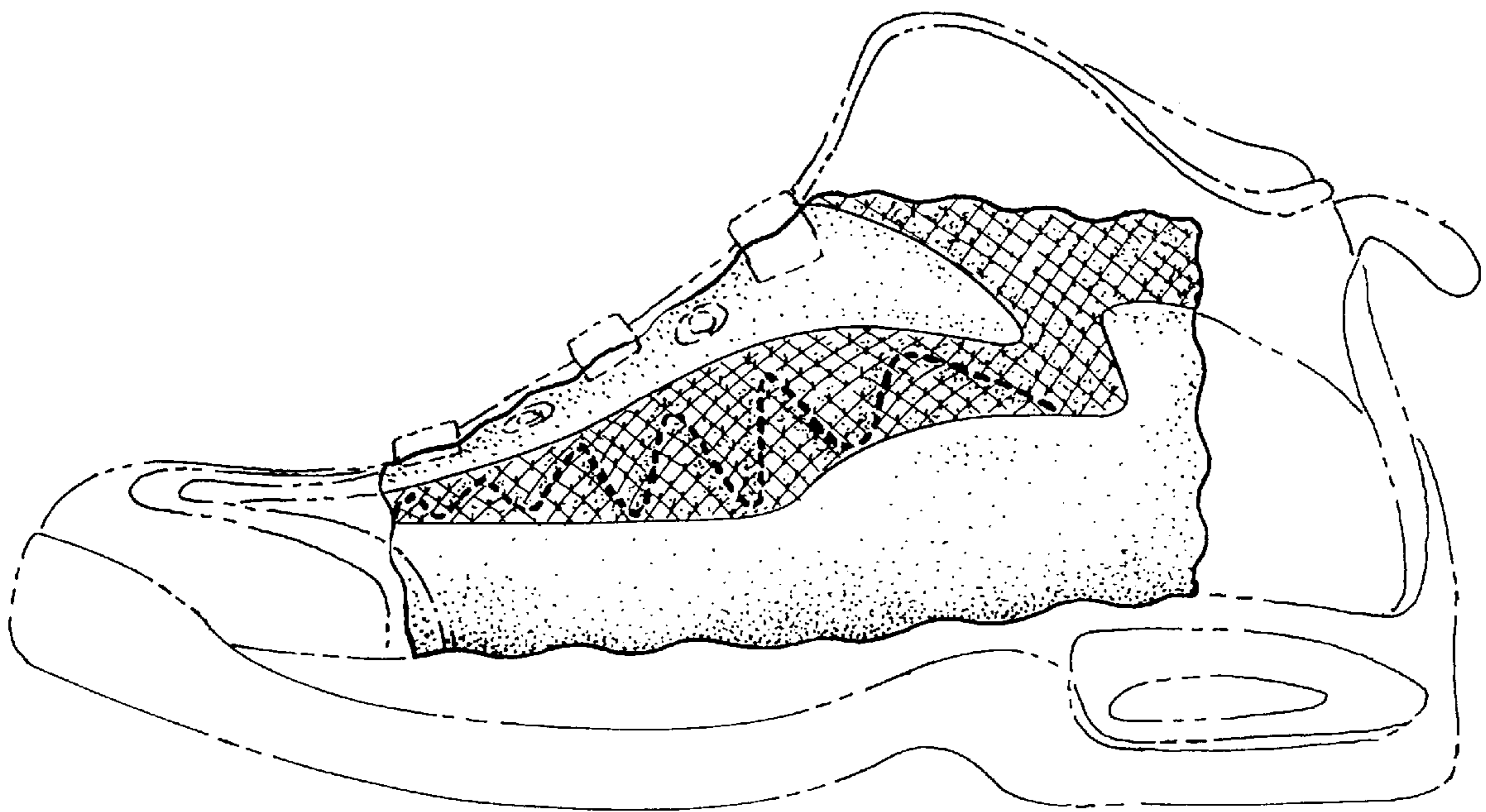

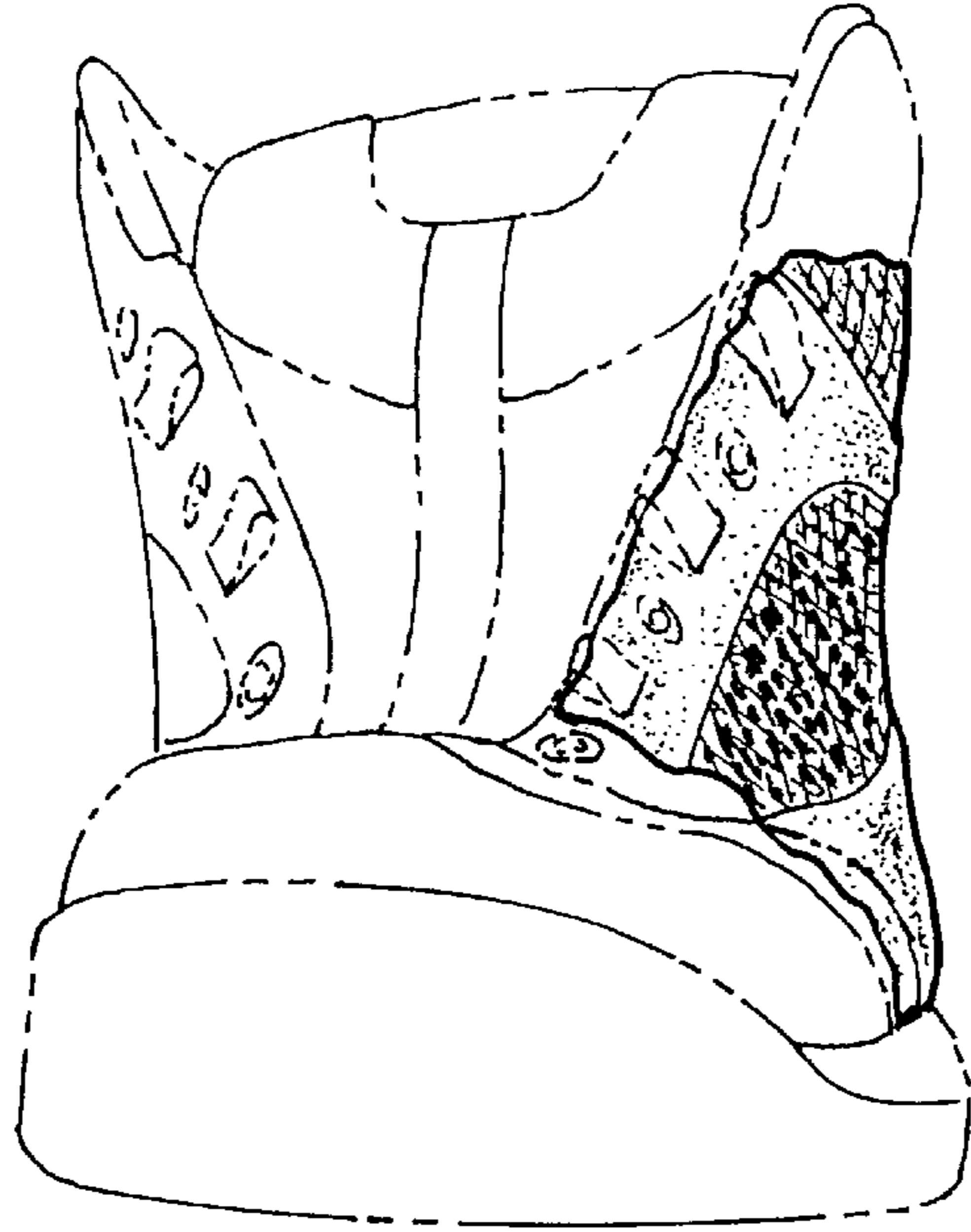

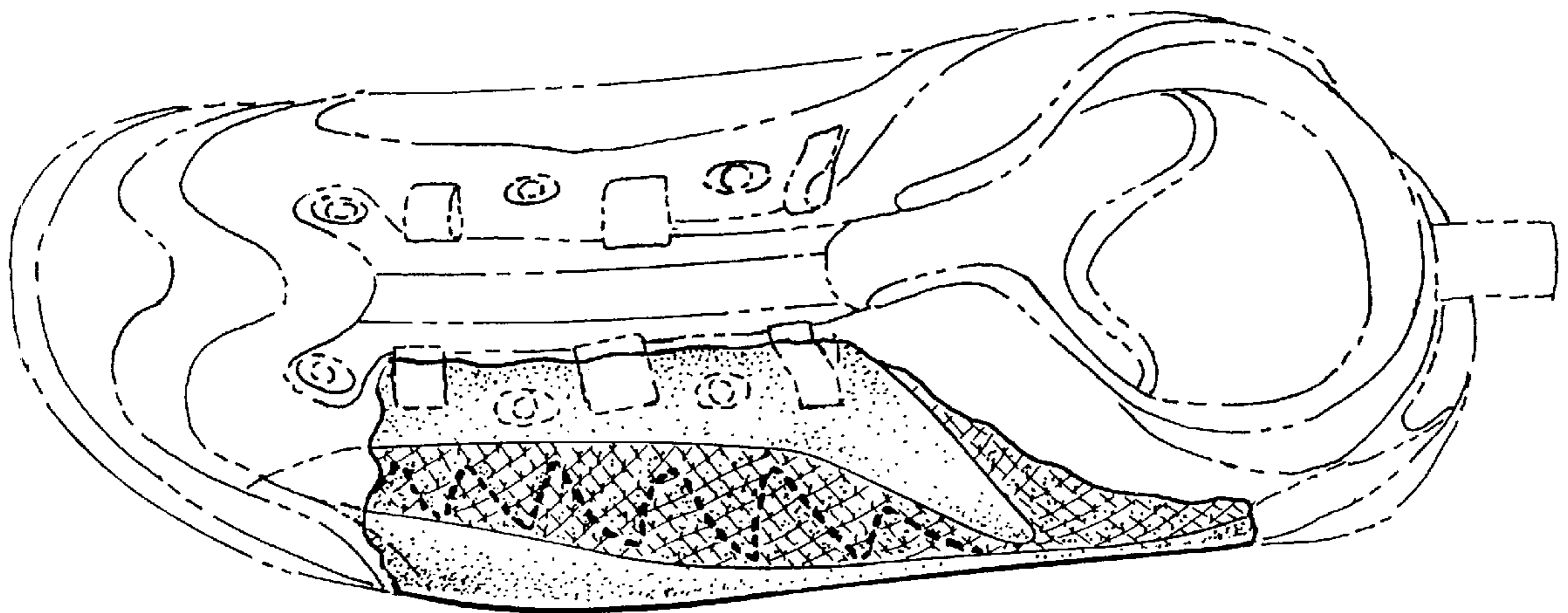
