[57] CLAIM

The ornamental design for a multi-use handle and tool attachments, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a multi-use handle and

tool attachments with the handle shown separately for clarity of illustration only;

FIG. 2 is a right side elevational view of a multi-use handle without a tool attachment;

FIG. 3 is a back elevational view of a multi-use handle without a tool attachment;

FIG. 4 is a left side elevational view of a multi-use handle without a tool attachment;

FIG. 5 is a top plan view thereof;

FIG. 6 is a bottom plan view thereof;

FIG. 7 is a front elevational view of a magnifying tool attachment shown separately for clarity of illustration only;

FIG. 8 is a right side elevational view of a magnifying tool attachment;

FIG. 9 is a back elevational view of a magnifying tool attachment;

FIG. 10 is a left side elevational view of a magnifying tool attachment;

FIG. 11 is a top plan view thereof;

FIG. 12 is a bottom plan view thereof;

FIG. 13 is a front elevational view of a magnetic tool attachment shown separately for clarity of illustration only the undisclosed rear and side views are a mirror image to the front;

FIG. 14 is a bottom plan view thereof;

FIG. 15 is a top plan view thereof;

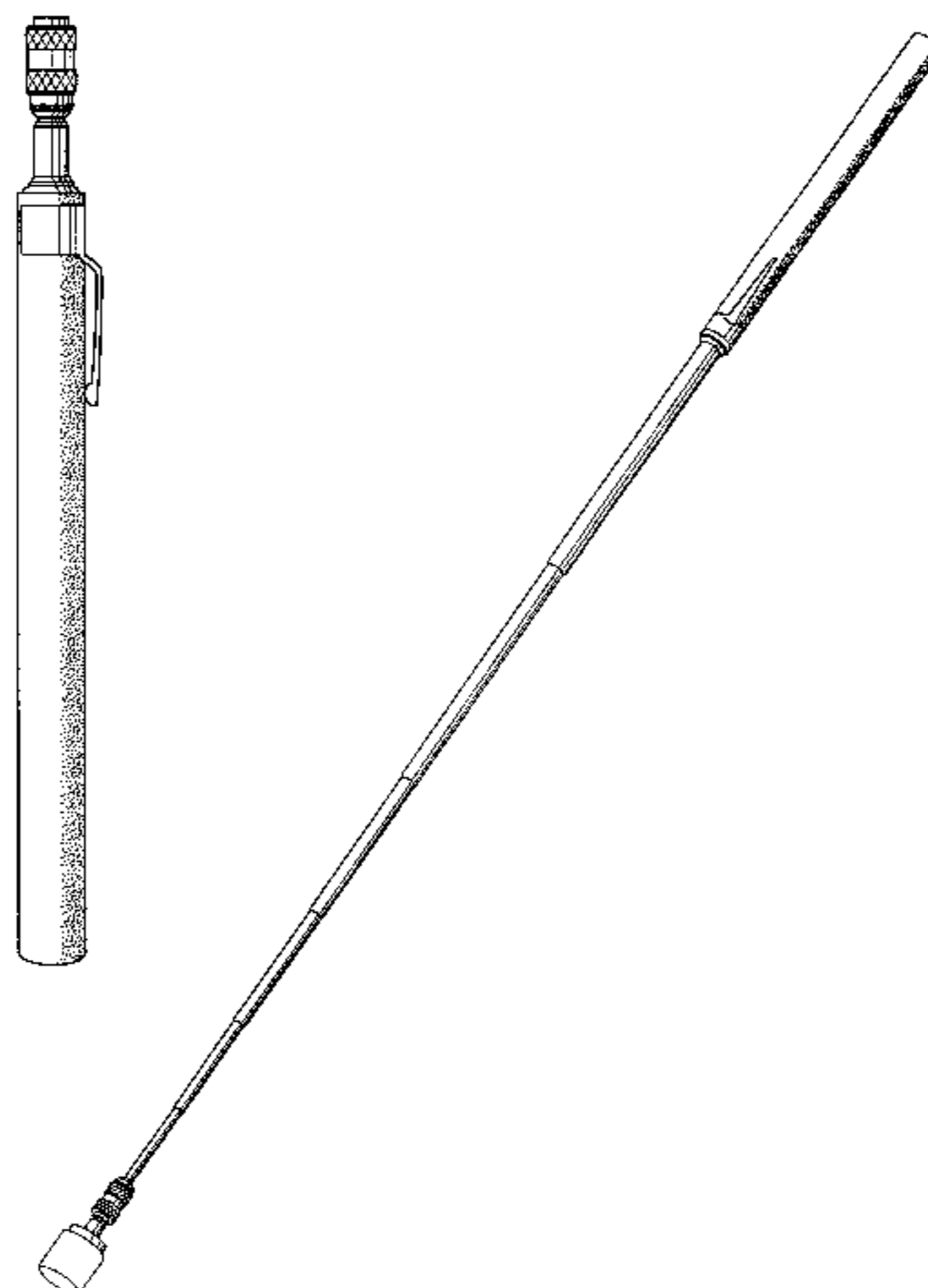
FIG. 16 is a front elevational view of another magnetic tool attachment shown separately for clarity of illustration only the undisclosed rear and side views are a mirror image to the front;

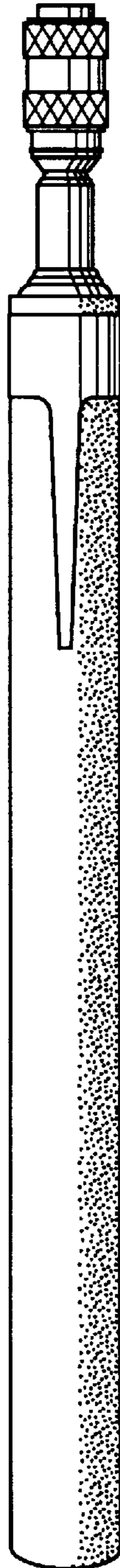

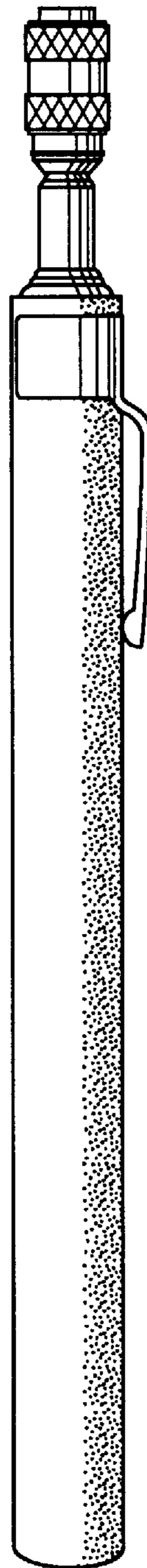

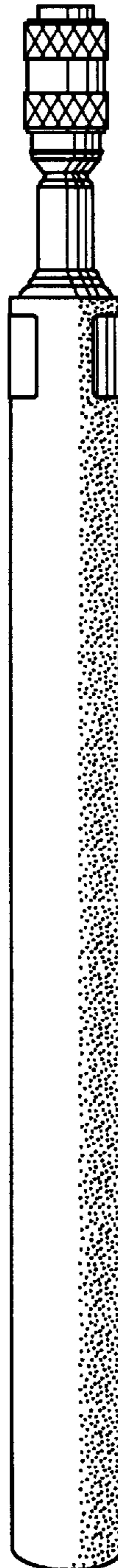

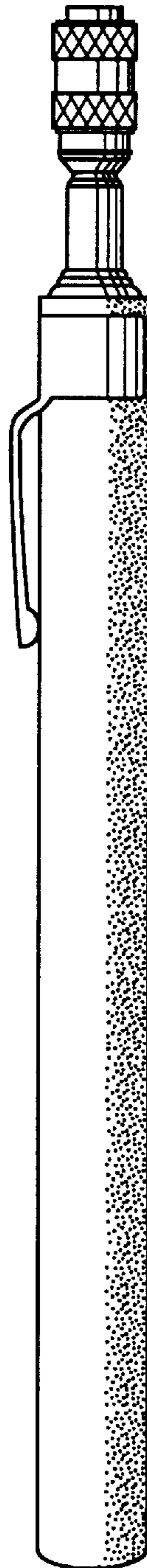

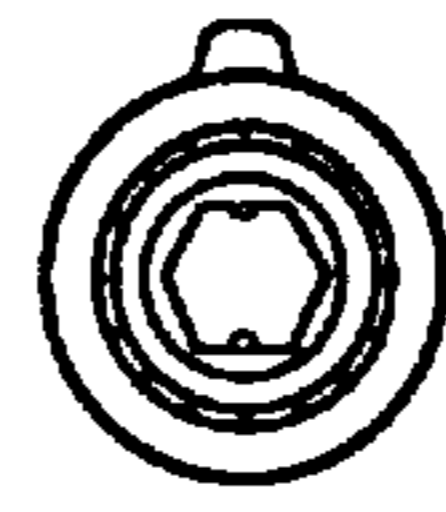

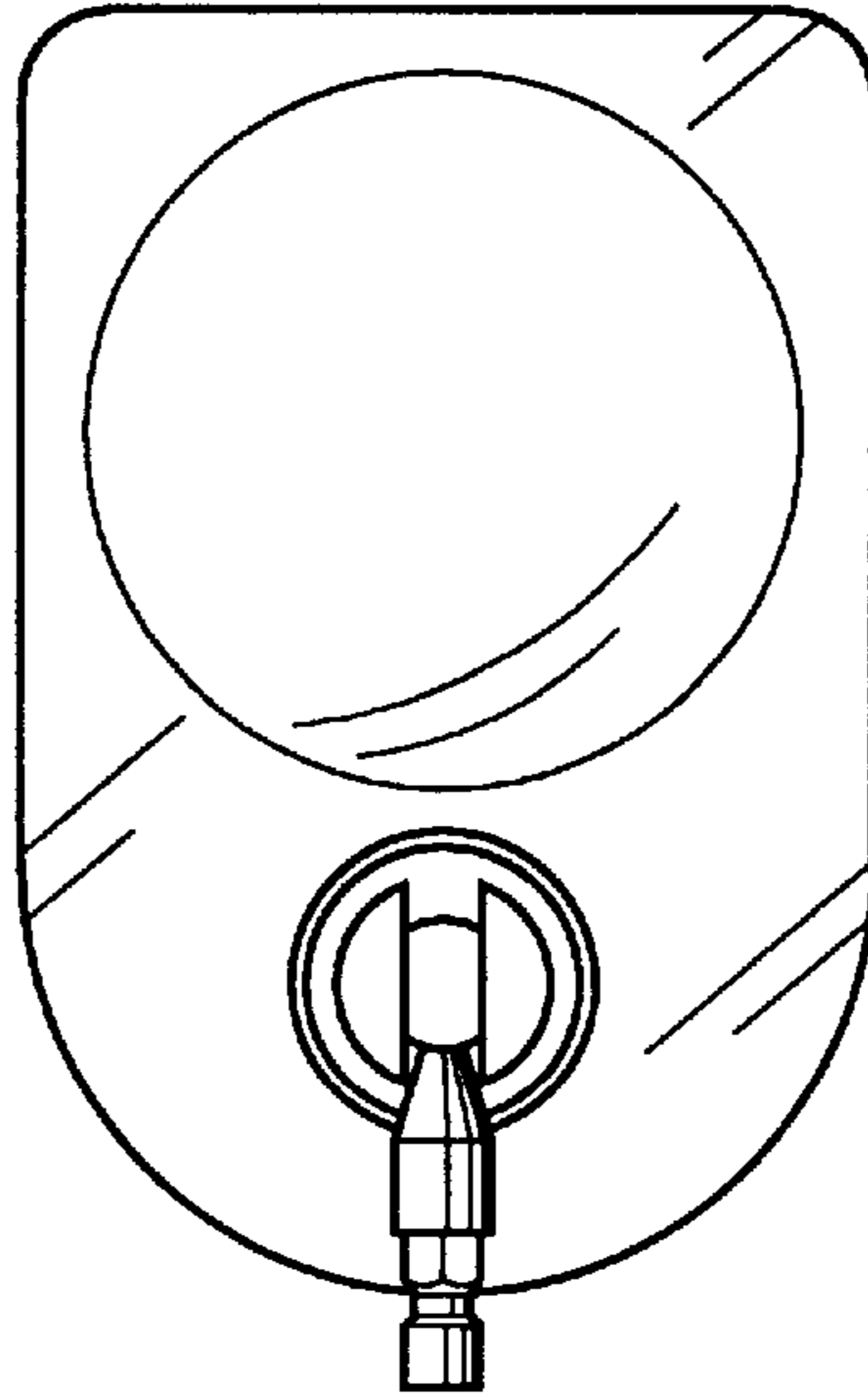

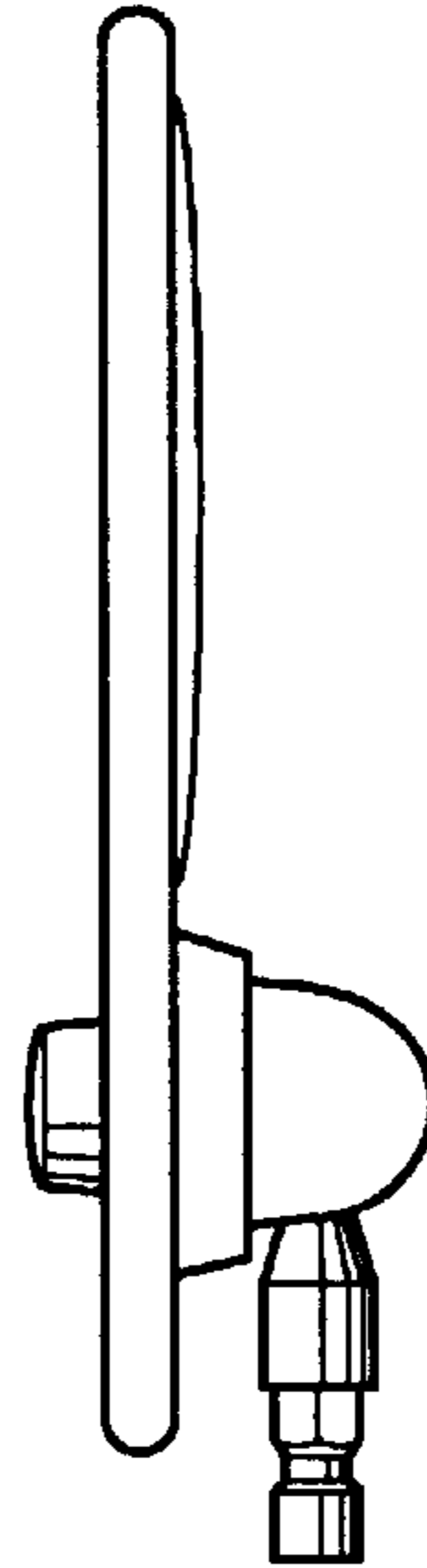

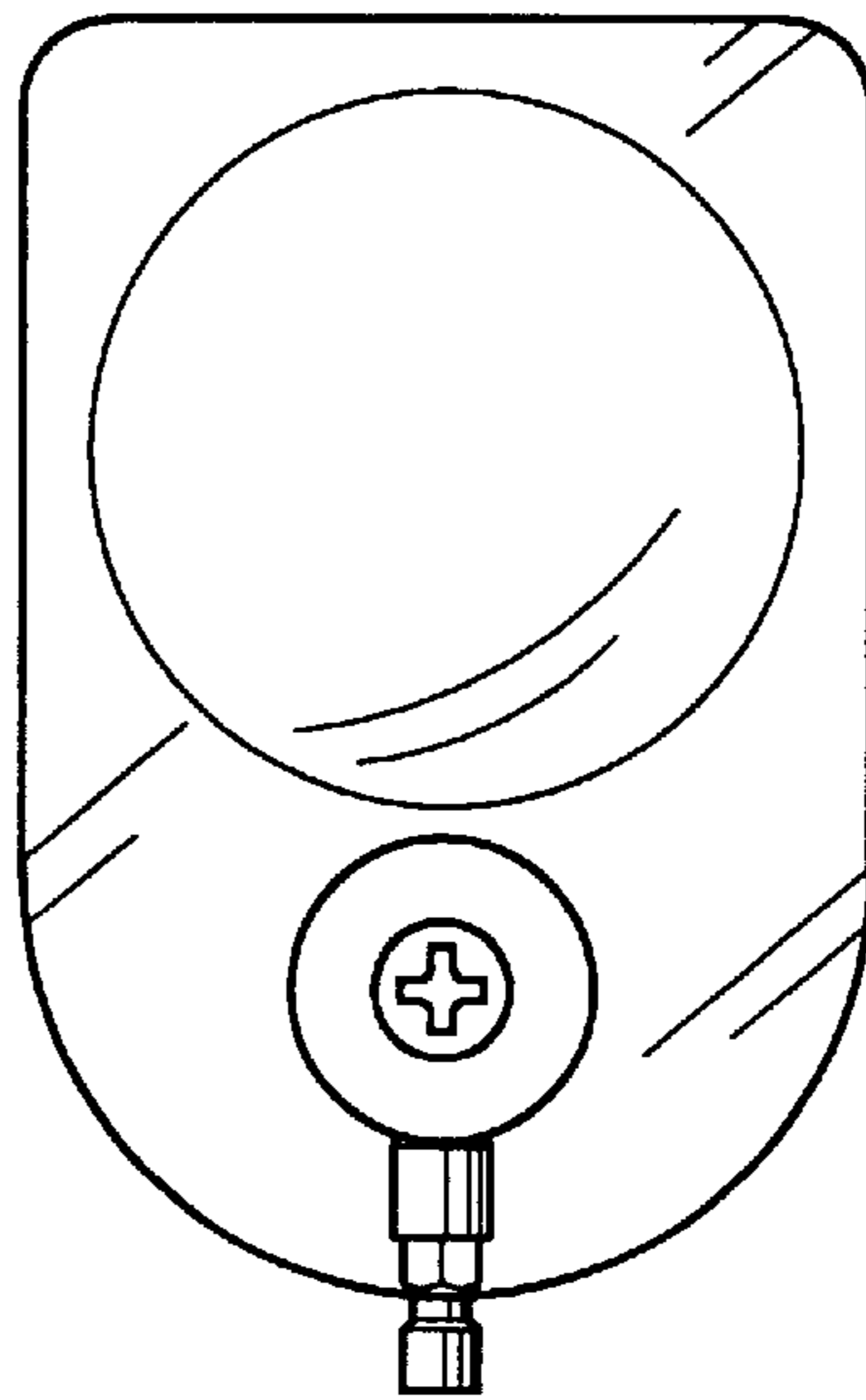

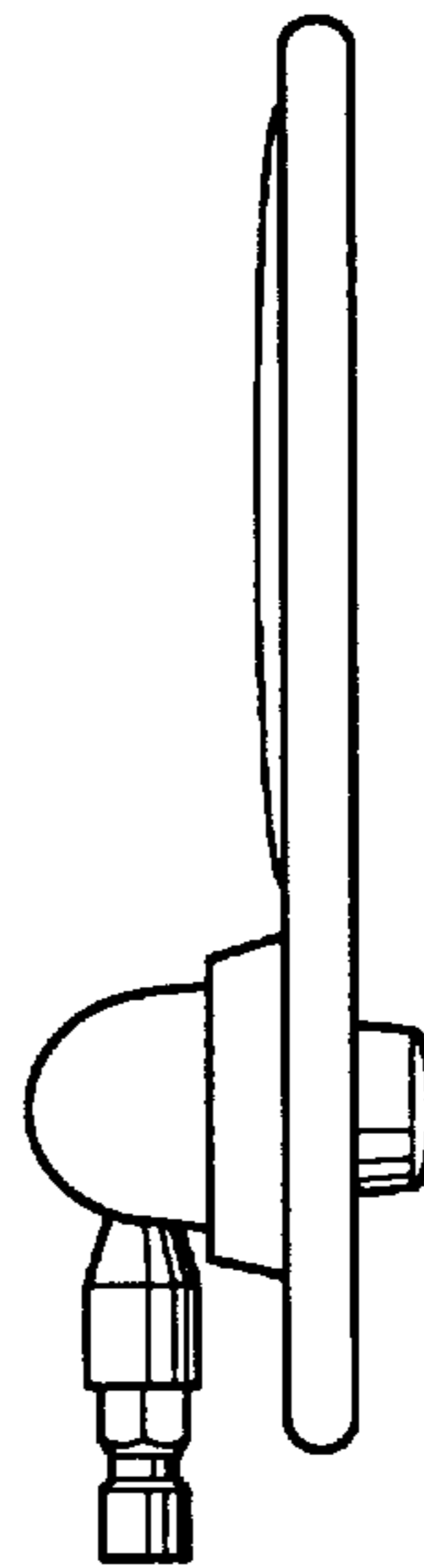

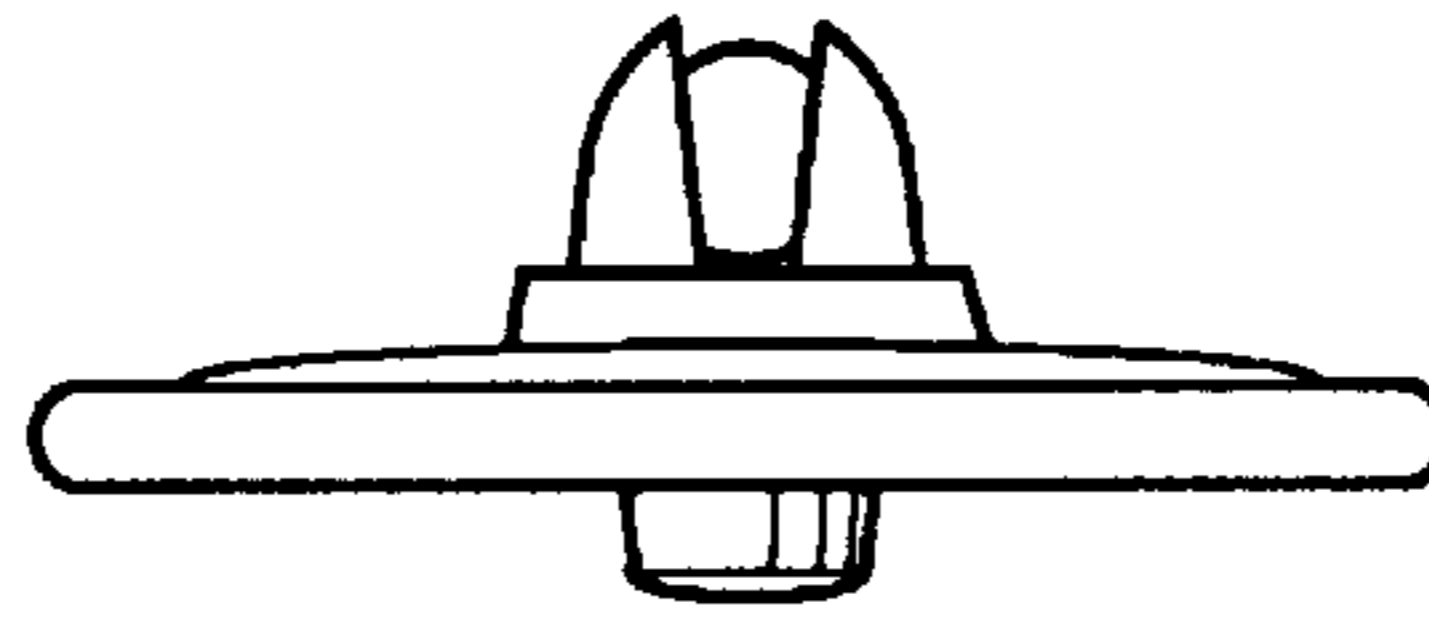

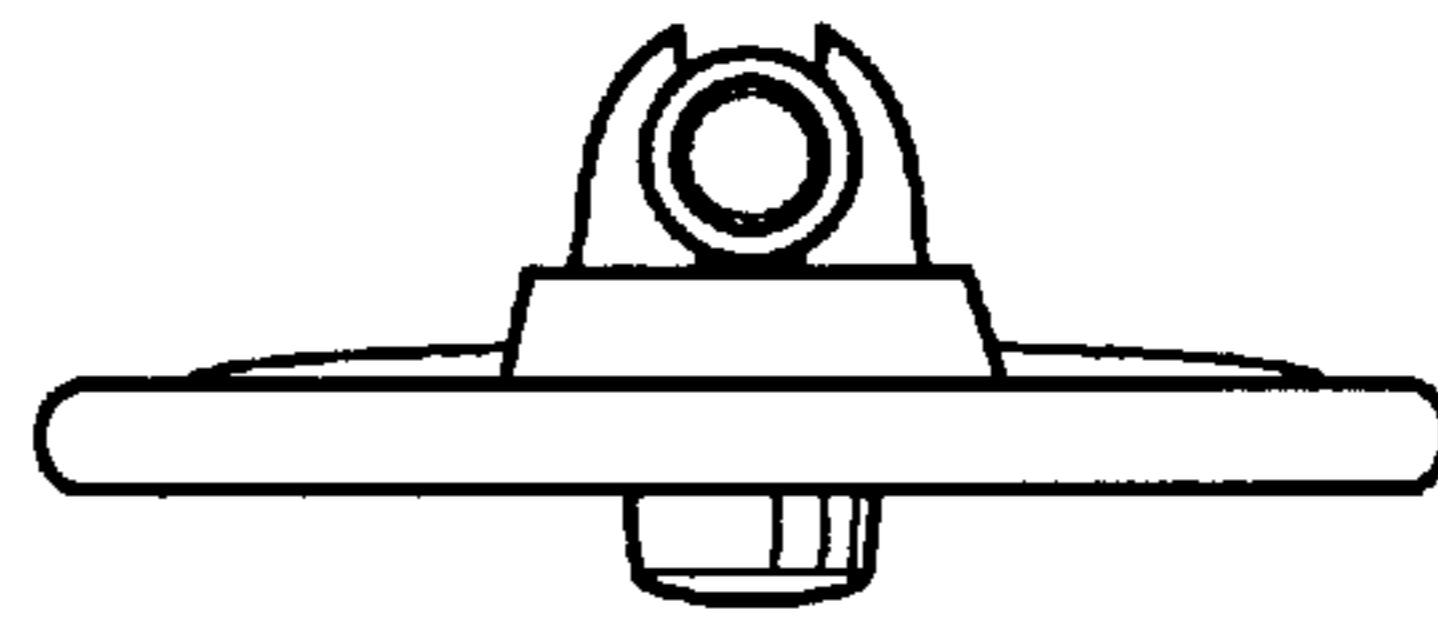

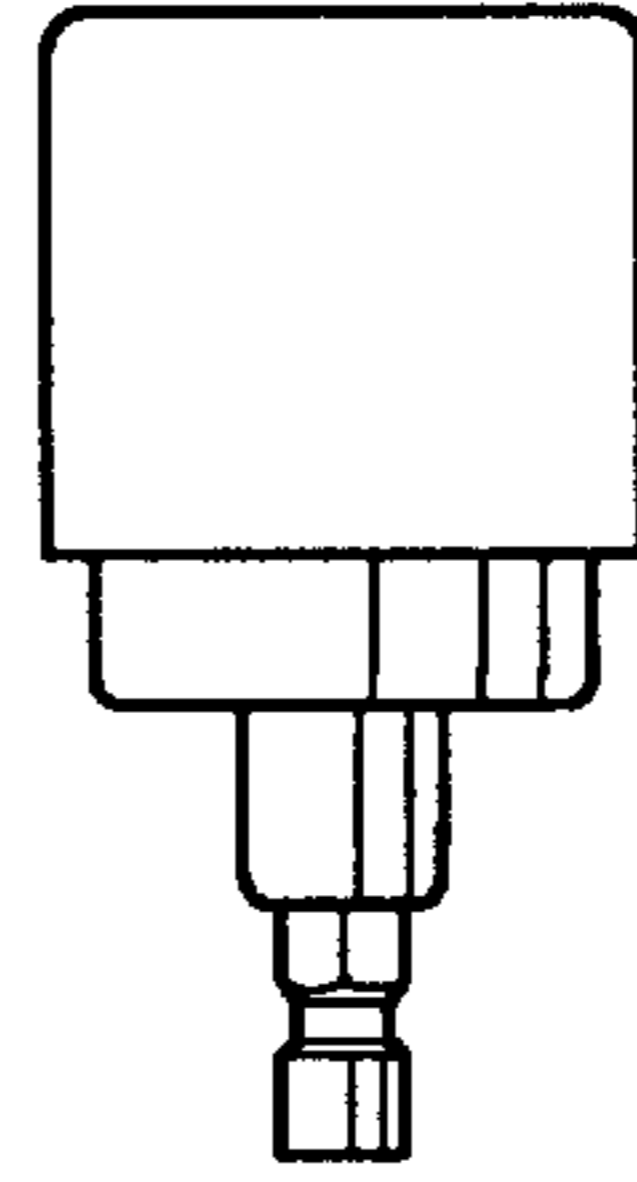

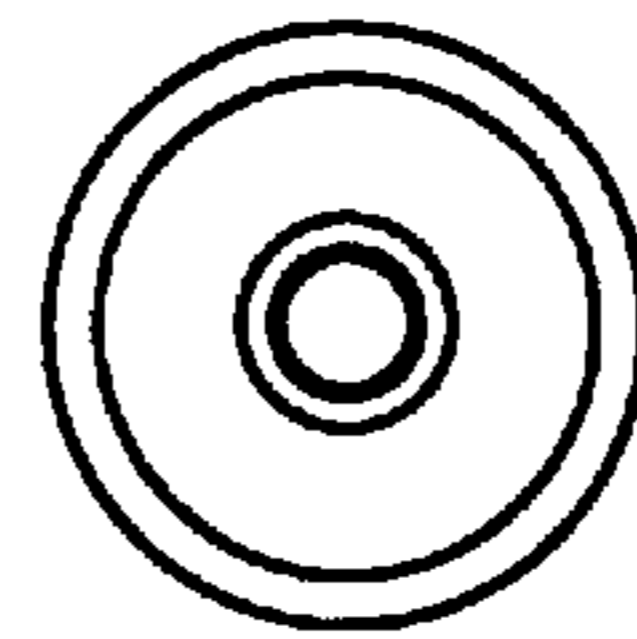

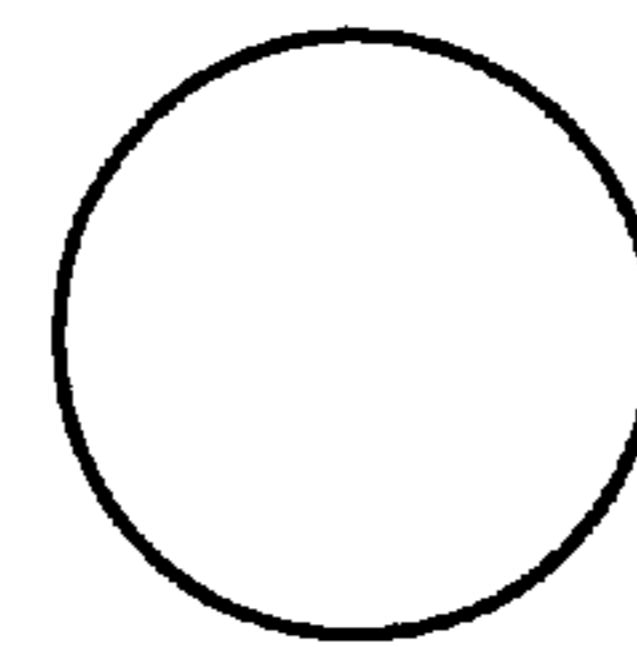

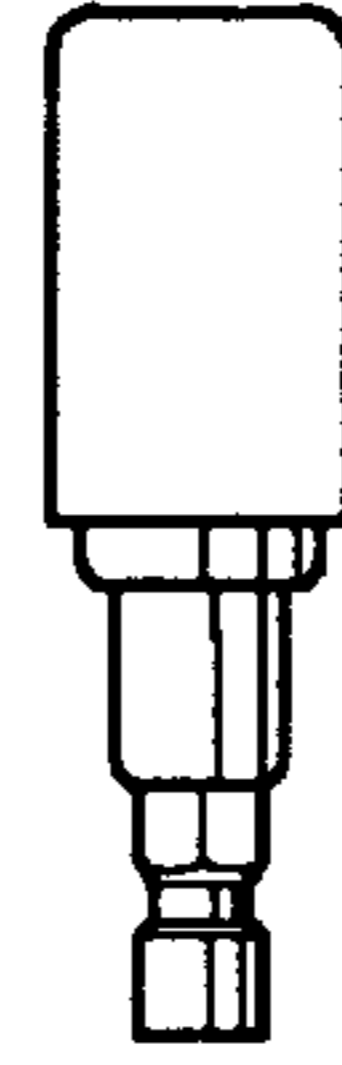

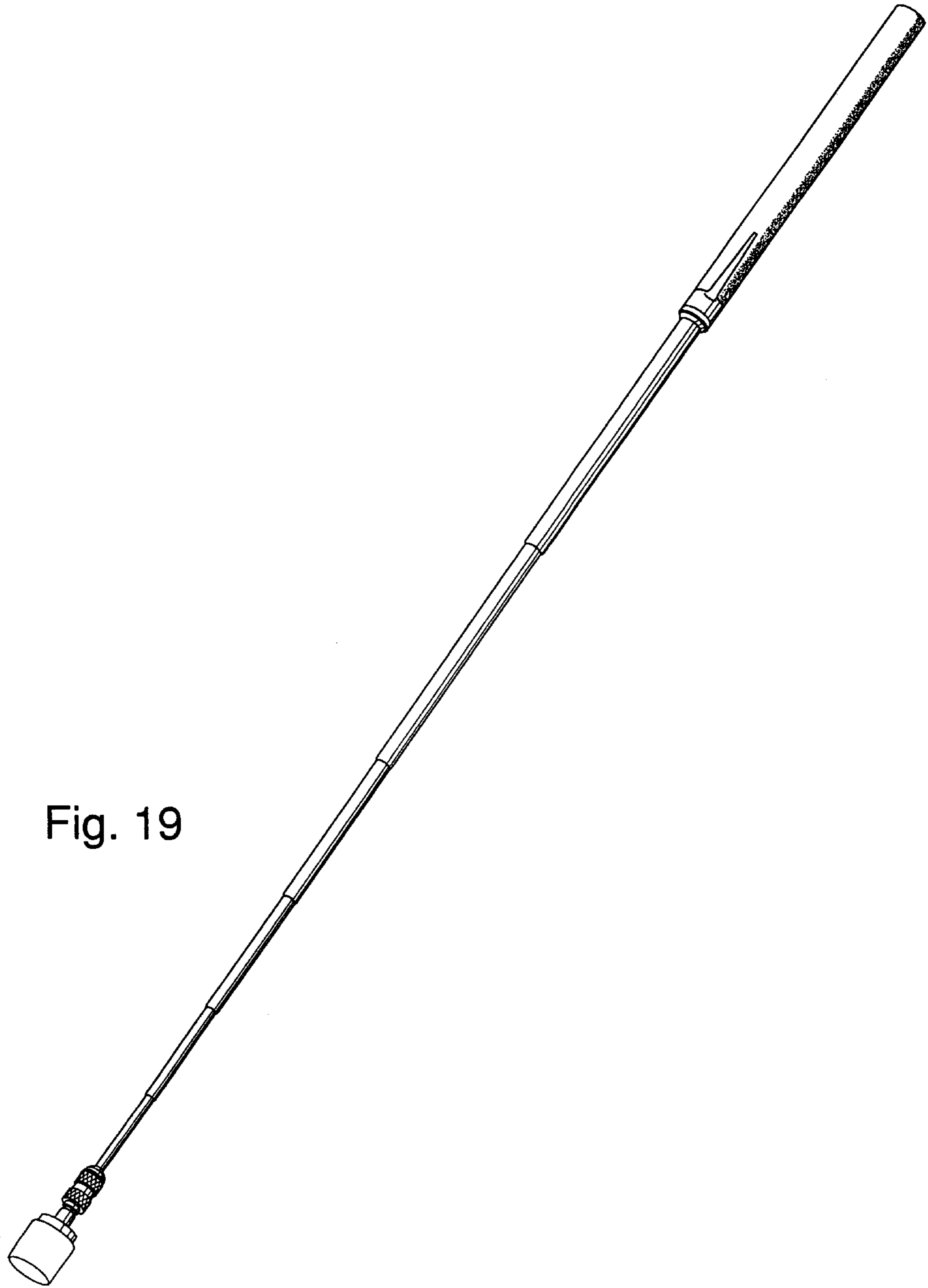
