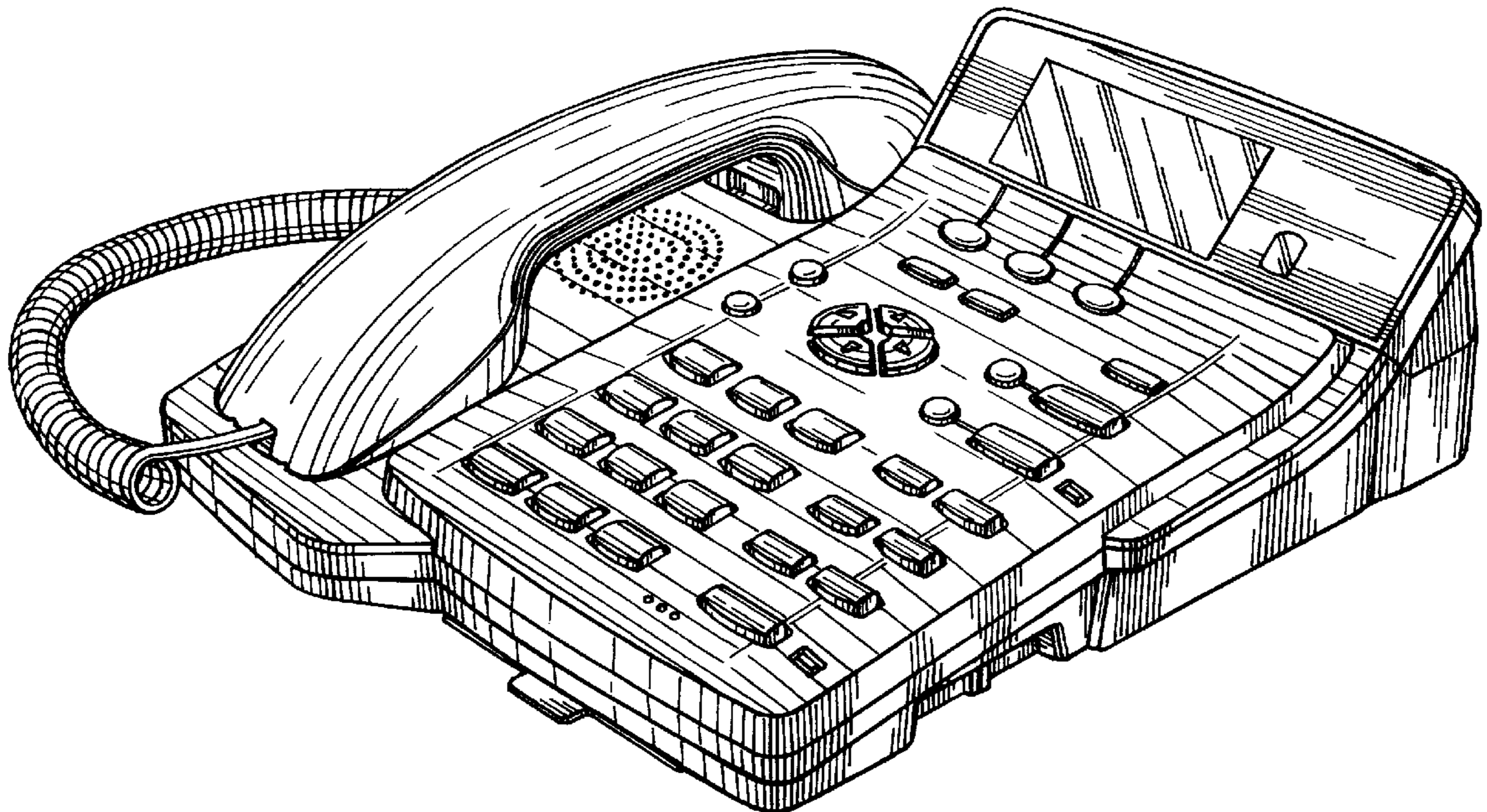

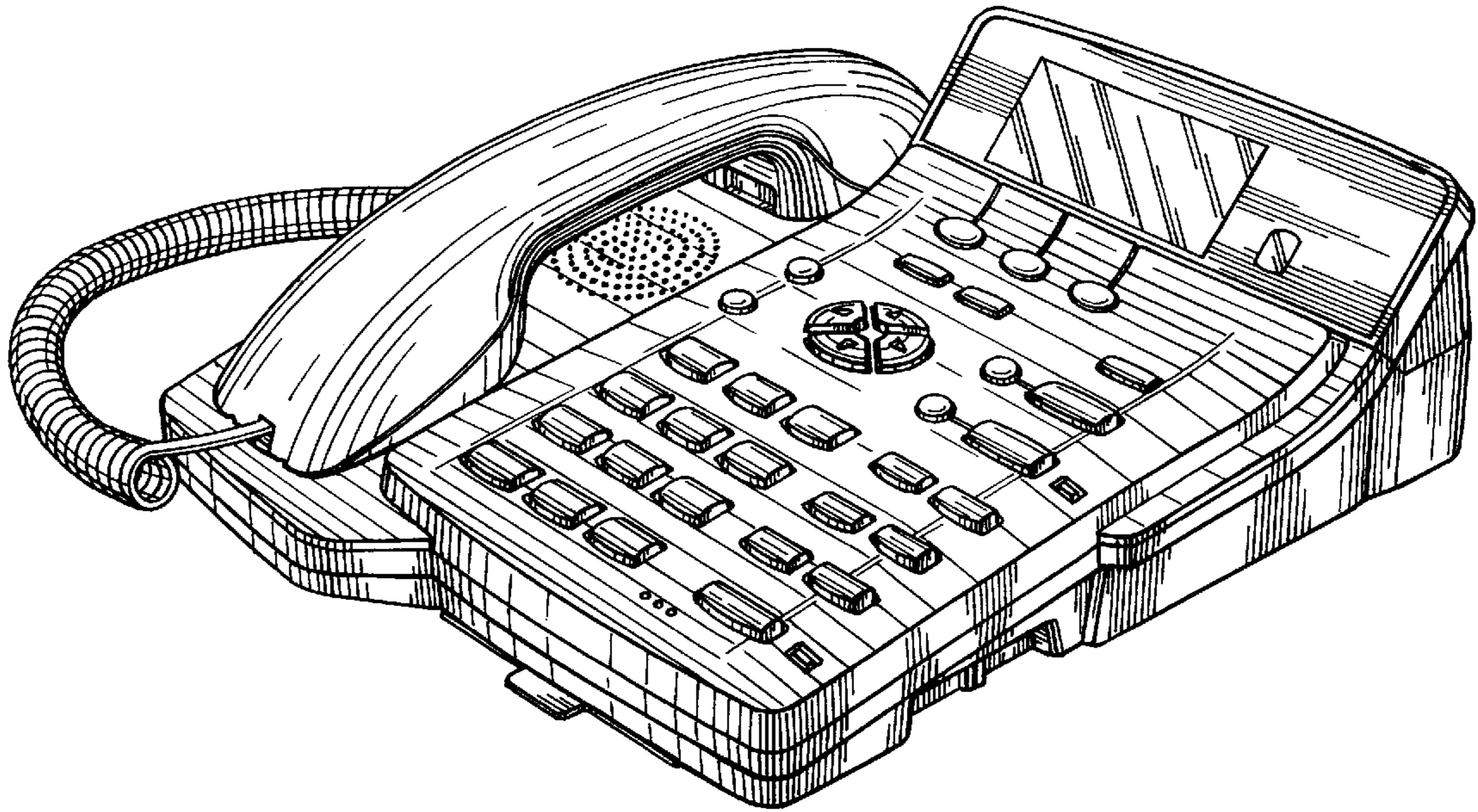
The ornamental design for a telephone with digital display, as shown and described.

**DESCRIPTION**

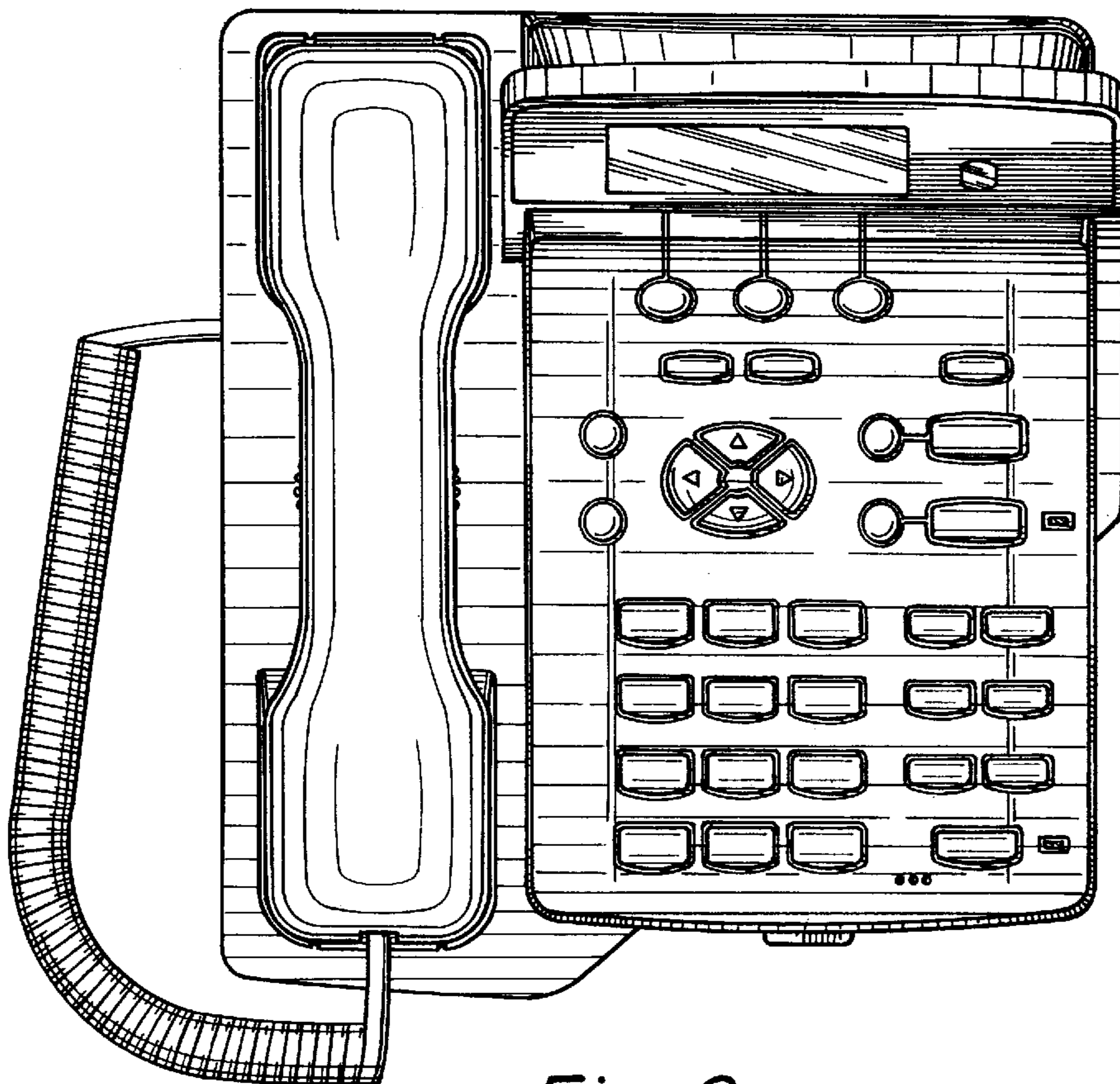
FIG. 1 is a front, top, right side perspective view of a telephone with digital display showing the new design; FIG. 2 is a top plan view thereof; FIG. 3 is a left side elevational view thereof; FIG. 4 is a right side elevational view thereof; FIG. 5 is a front elevational view thereof; FIG. 6 is a rear elevational view thereof; FIG. 7 is a bottom plan view thereof; and, FIG. 8 is a top plan view thereof showing a handset removed from a base unit.

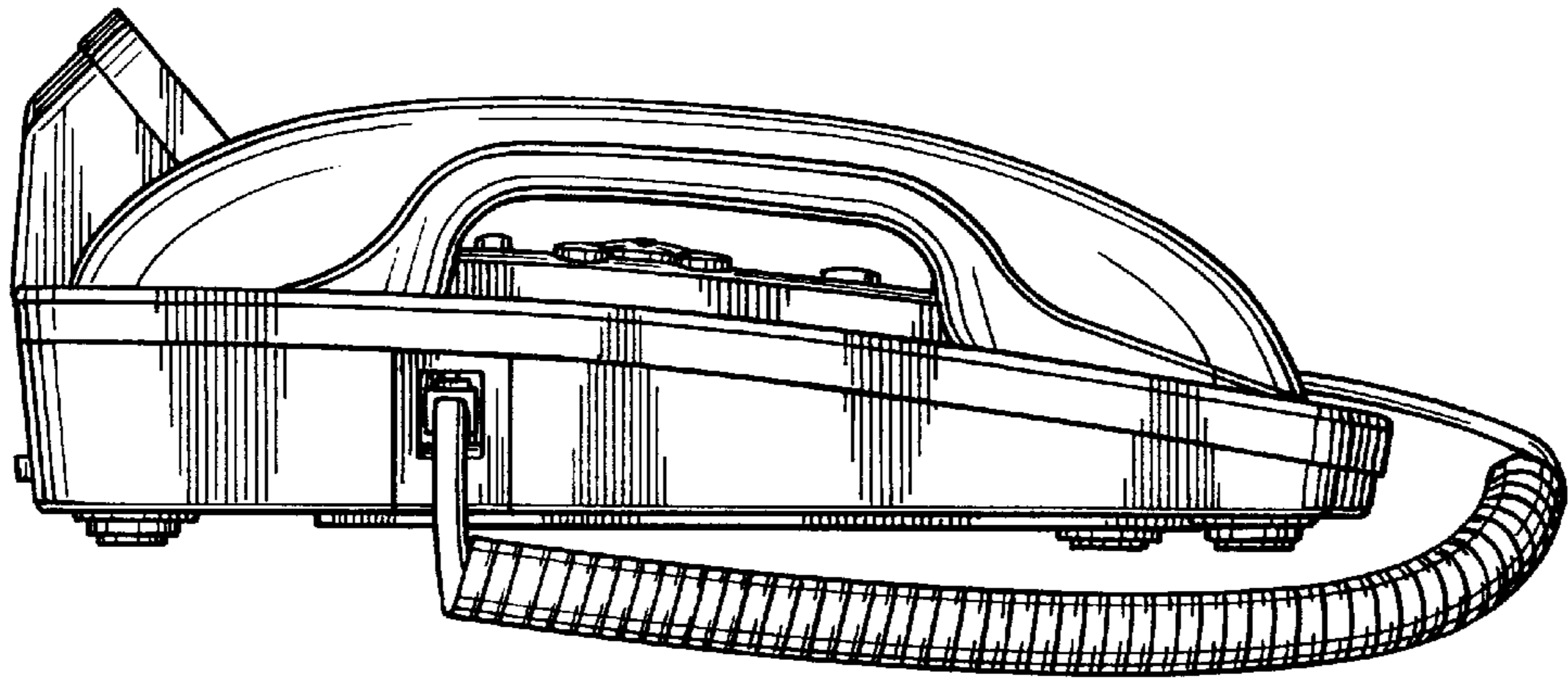




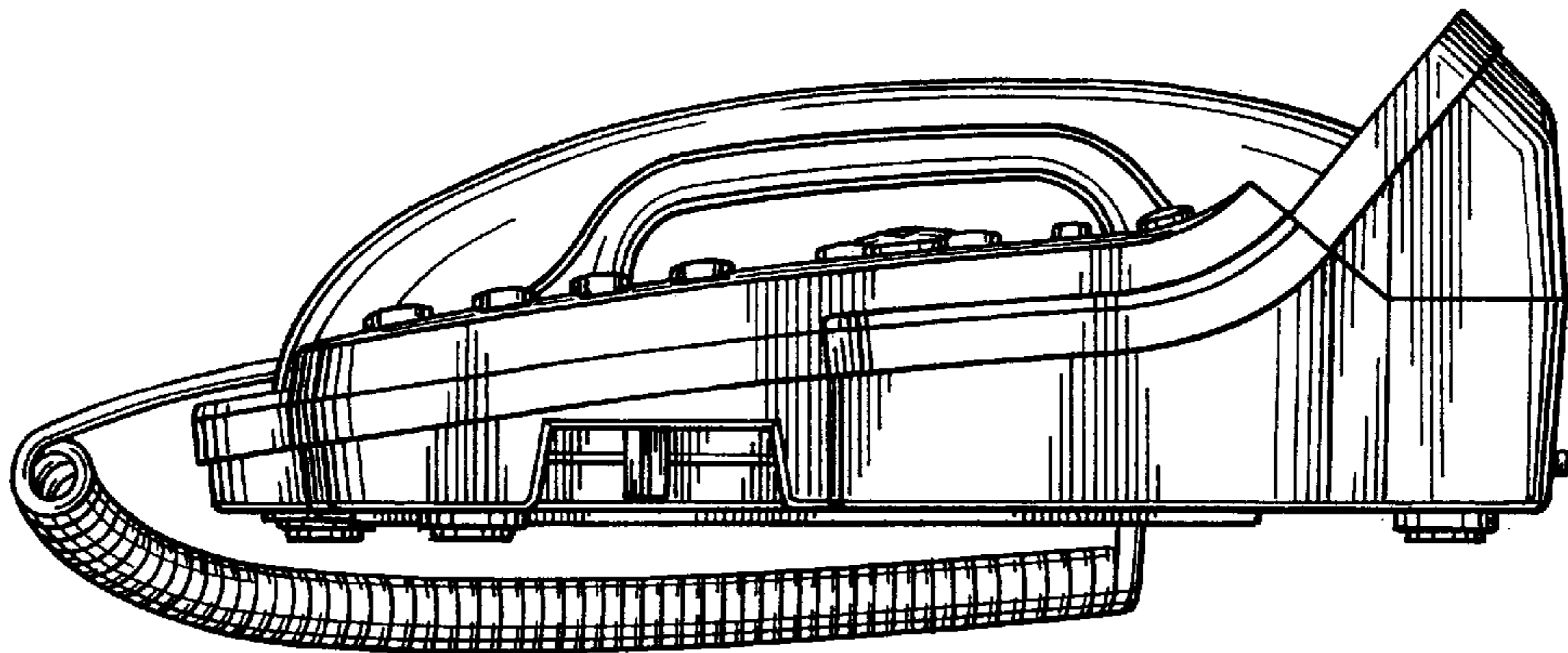

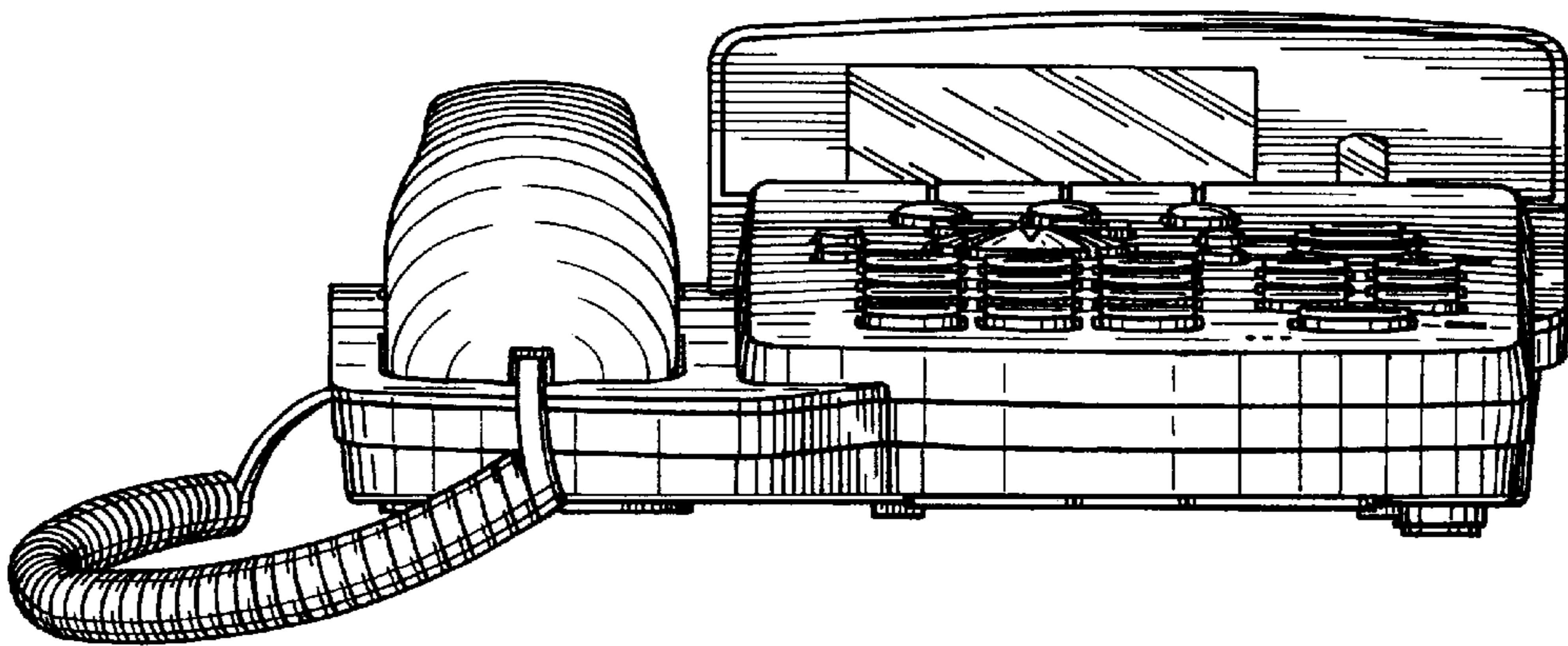

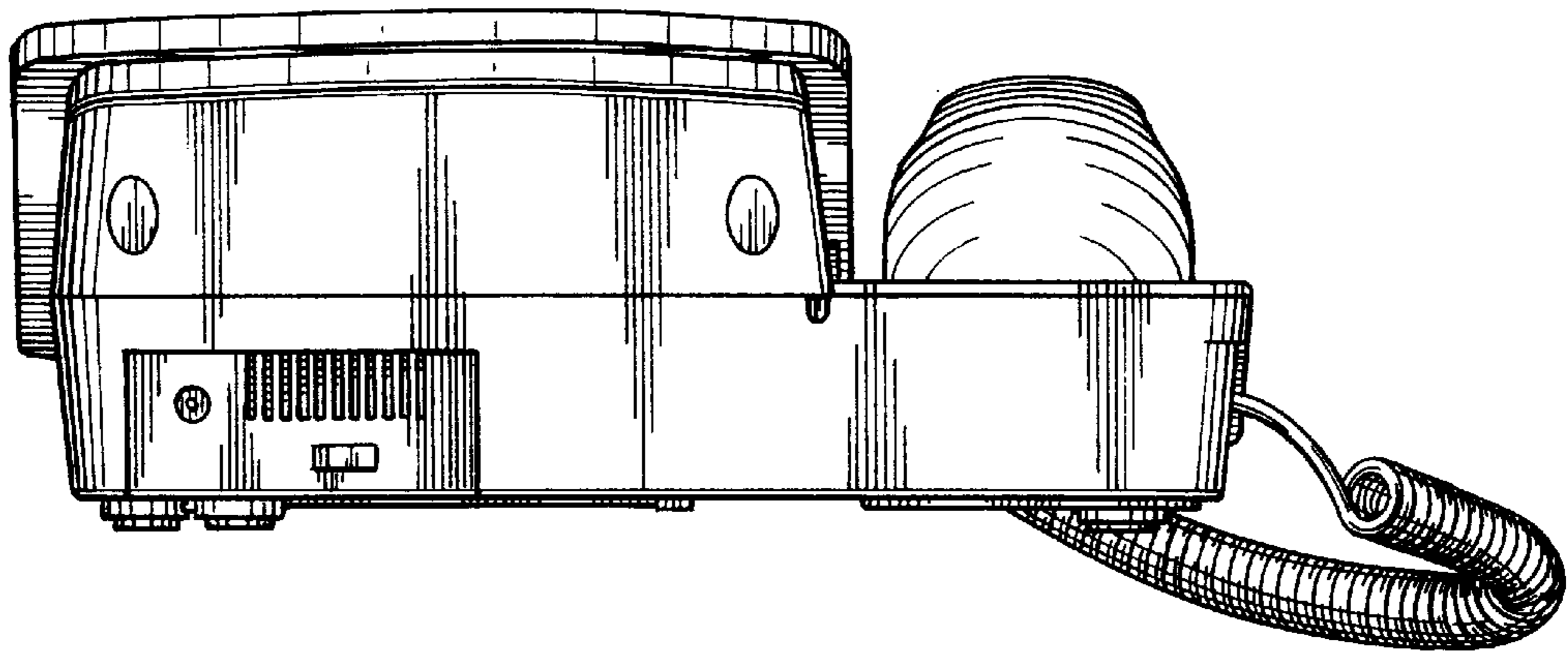

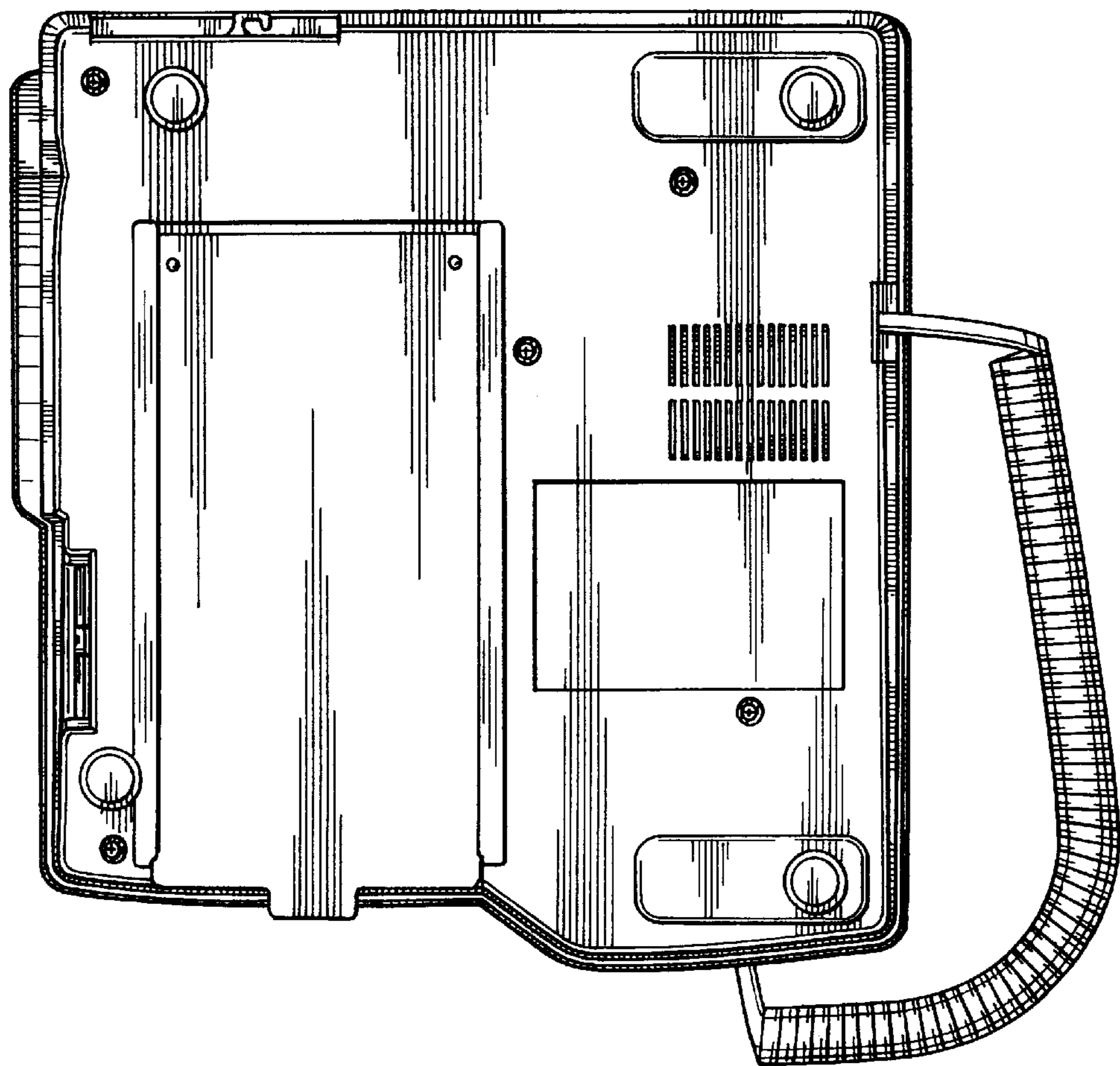

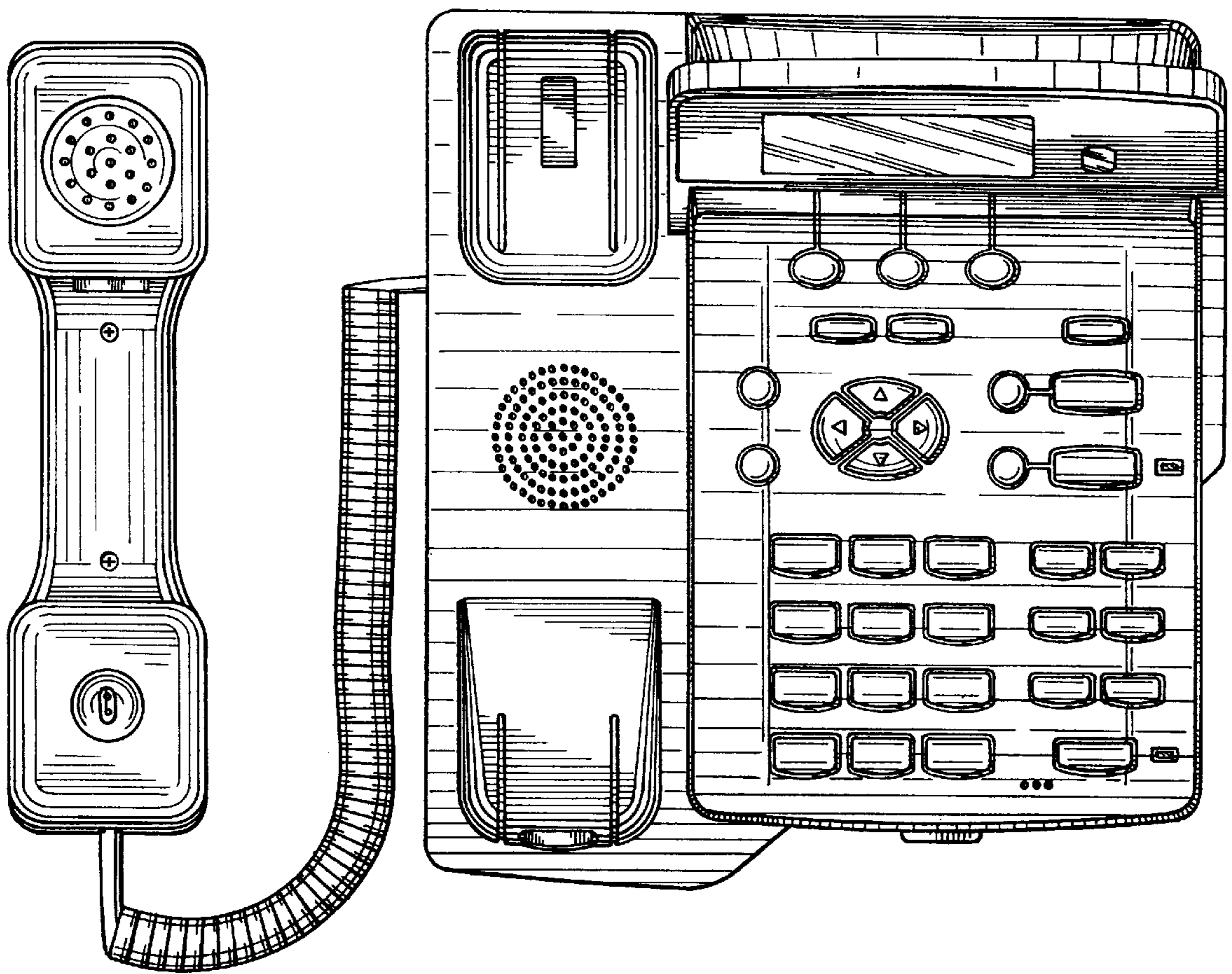
