[57] **CLAIM**

I claim the ornamental design for a putter head, as shown and described.

DESCRIPTION

FIG. 1 is a top view of a putter head showing my new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear or back view thereof;
FIG. 4 is a bottom view thereof;
FIG. 5 is a side or edge view thereof;
FIG. 6 is a side or edge view thereof located on the opposite side of the side or edge view of FIG. 5;
FIG. 7 is a cross sectional view of the putter head taken at section 7—7 shown in FIG. 3;
FIG. 8 is a top view of an alternative embodiment of the putter head showing my new design;
FIG. 9 is a front view thereof;
FIG. 10 is a rear or back view thereof;
FIG. 11 is a bottom view thereof;
FIG. 12 is a side or edge view thereof;
FIG. 13 is a side or edge view thereof located on the opposite side of the side or edge view of FIG. 12; and,
FIG. 14 is a cross sectional view of an alternative embodiment of the putter head taken at section 14—14 shown in FIG. 10.

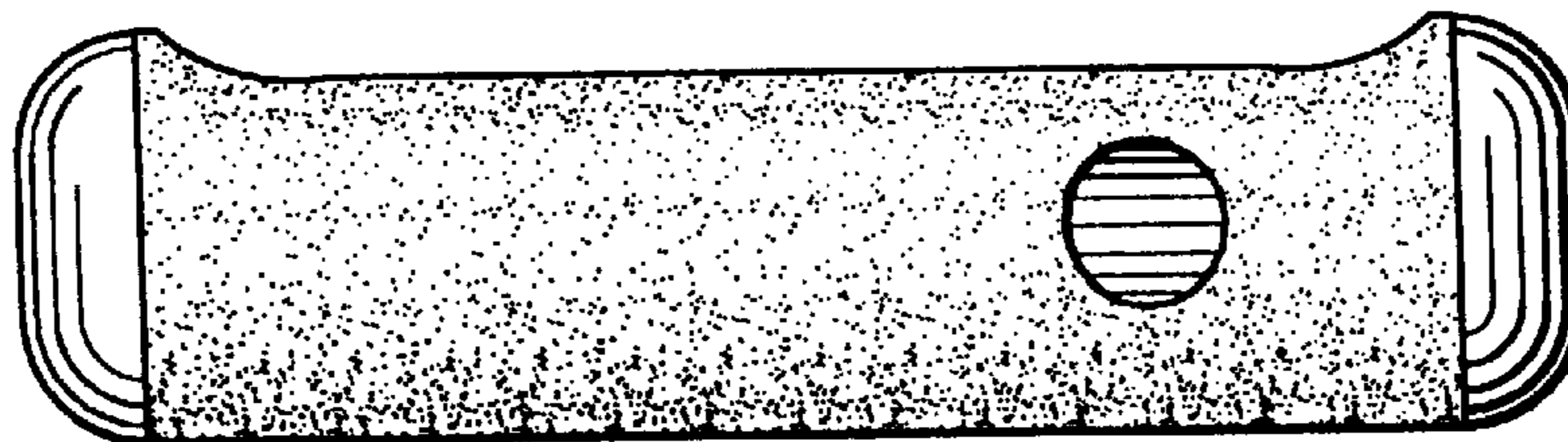

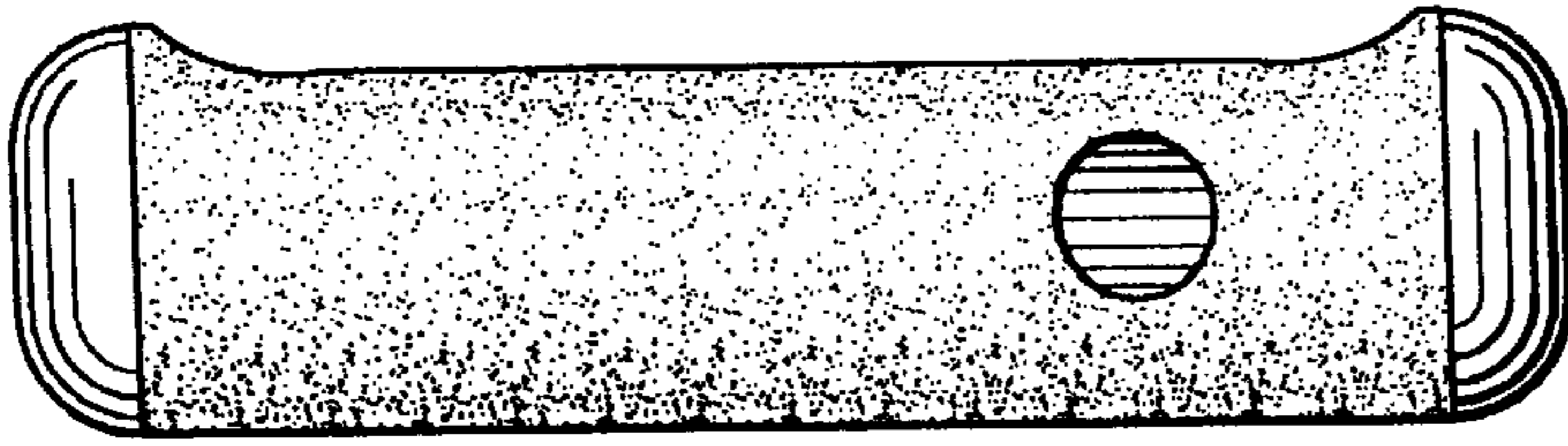

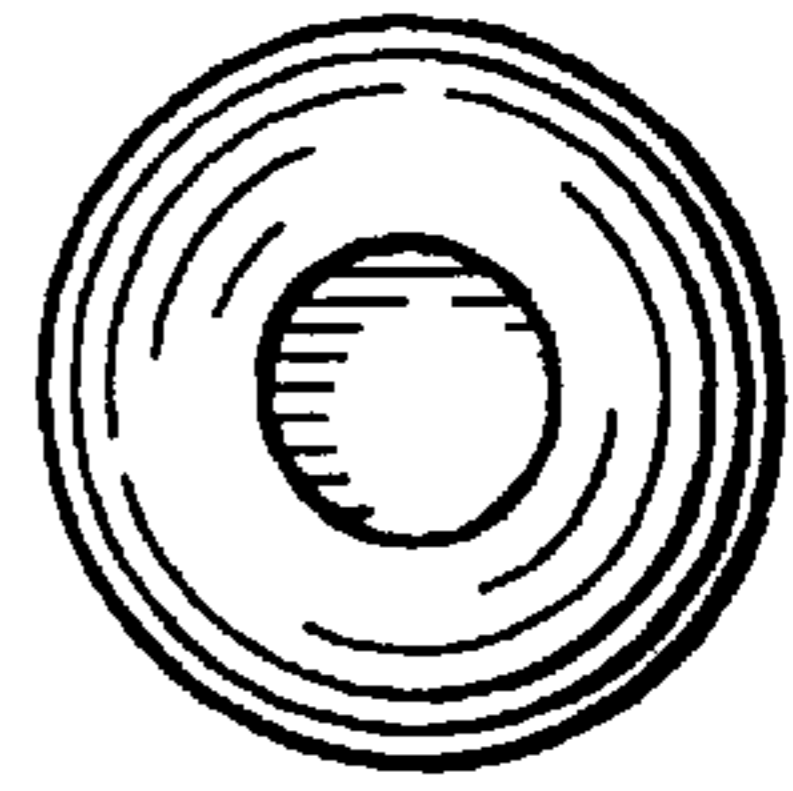

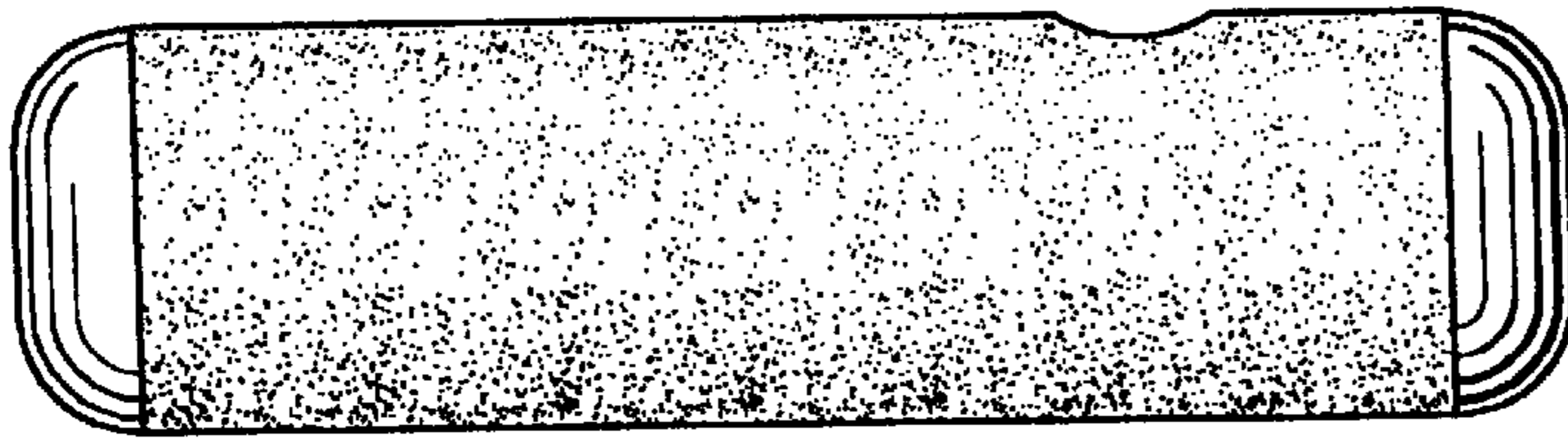

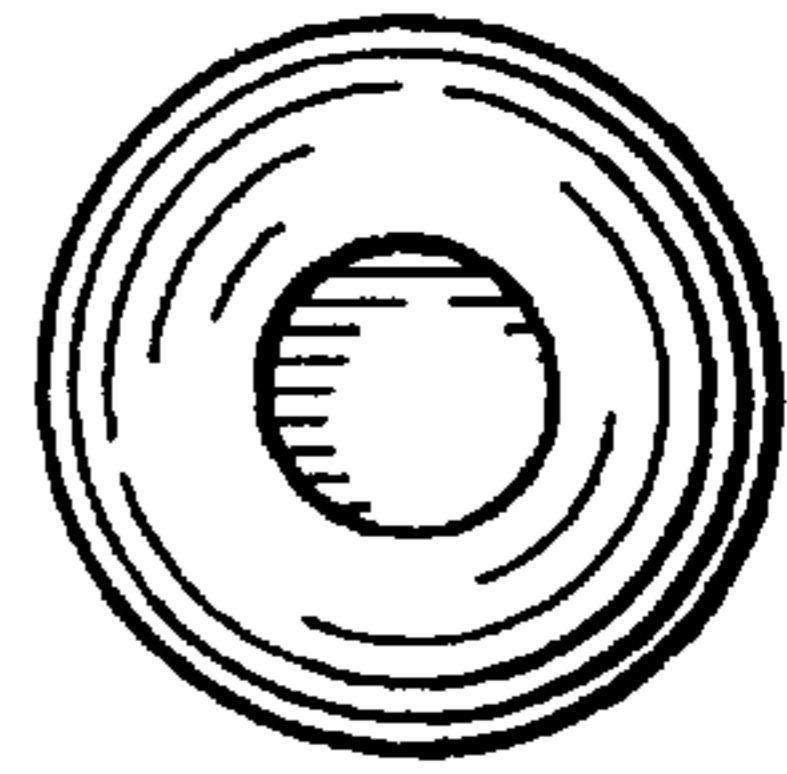

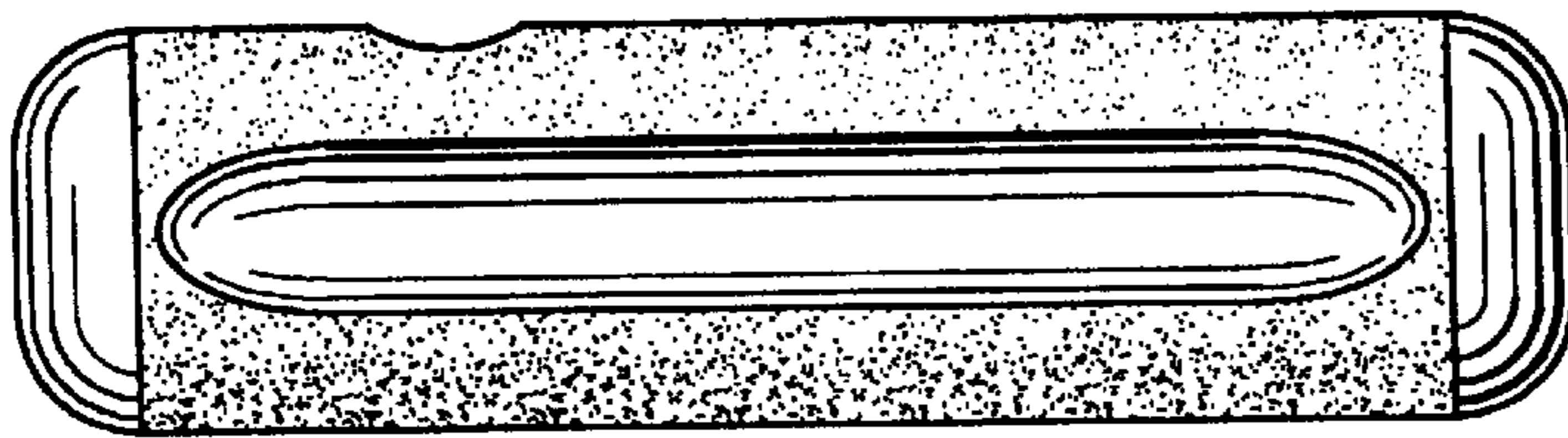
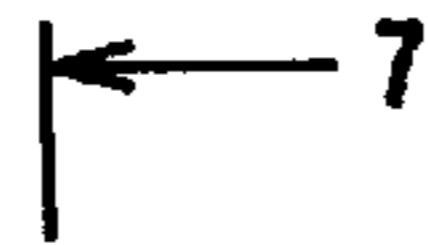

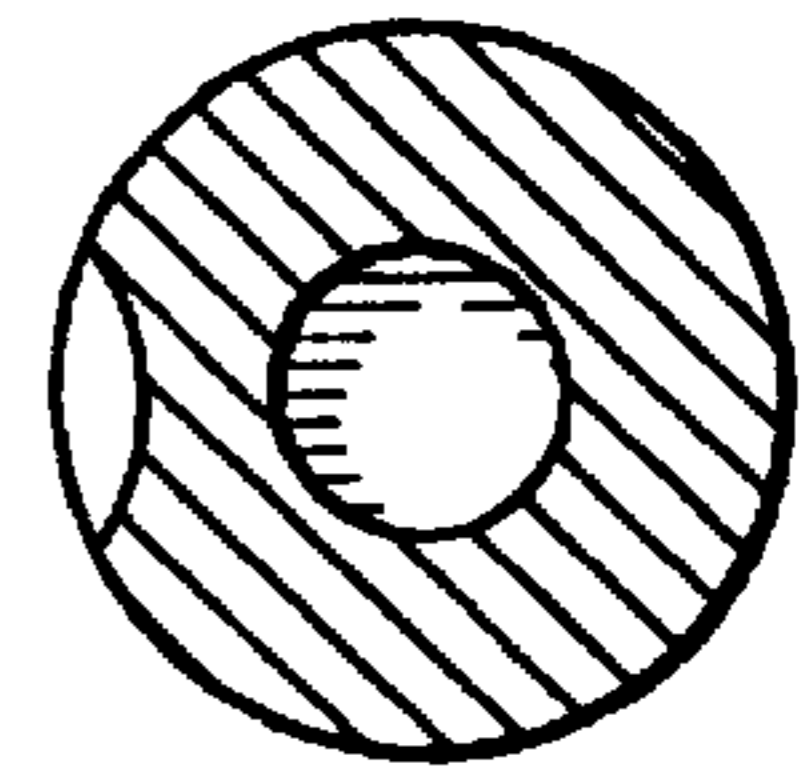

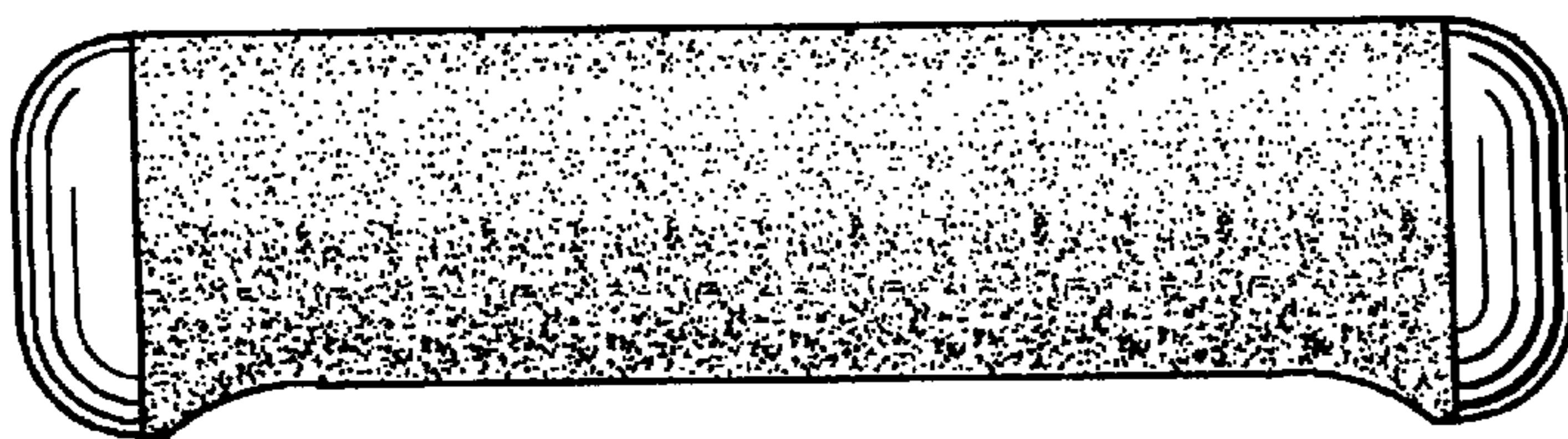

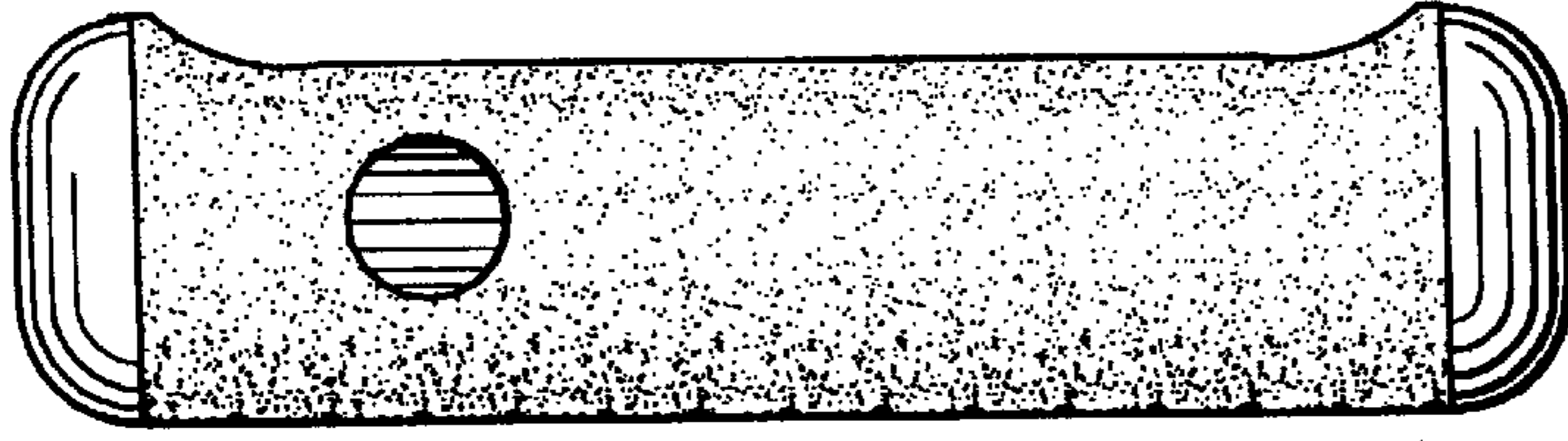

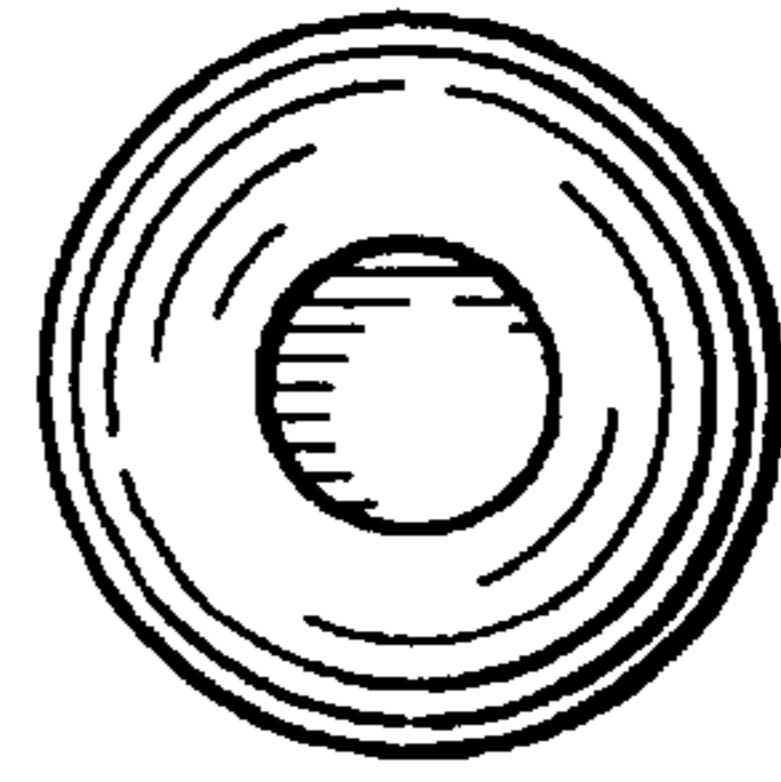

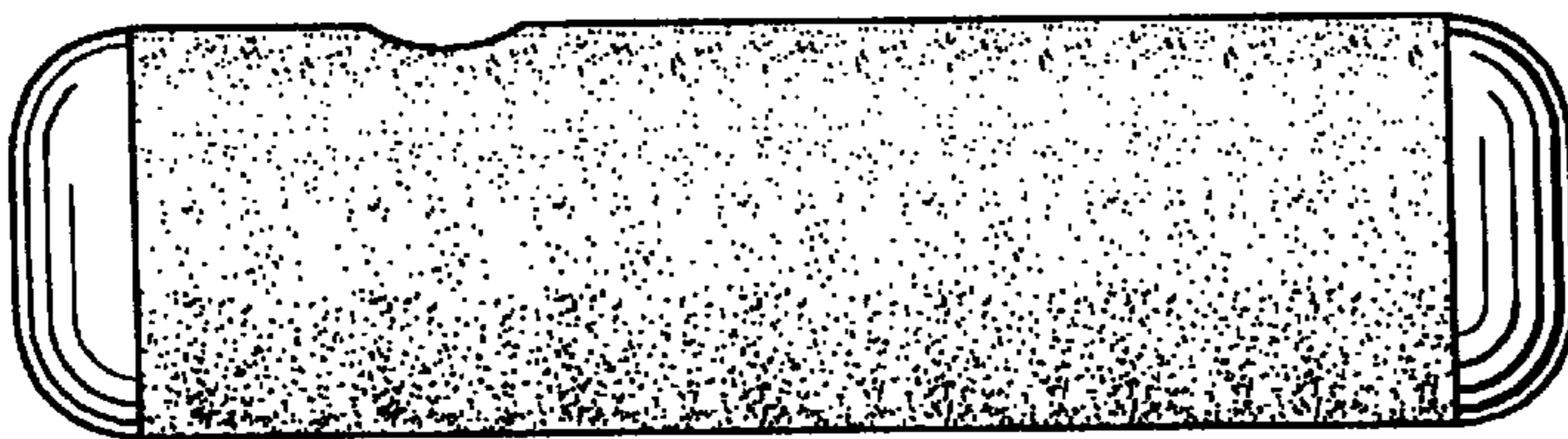

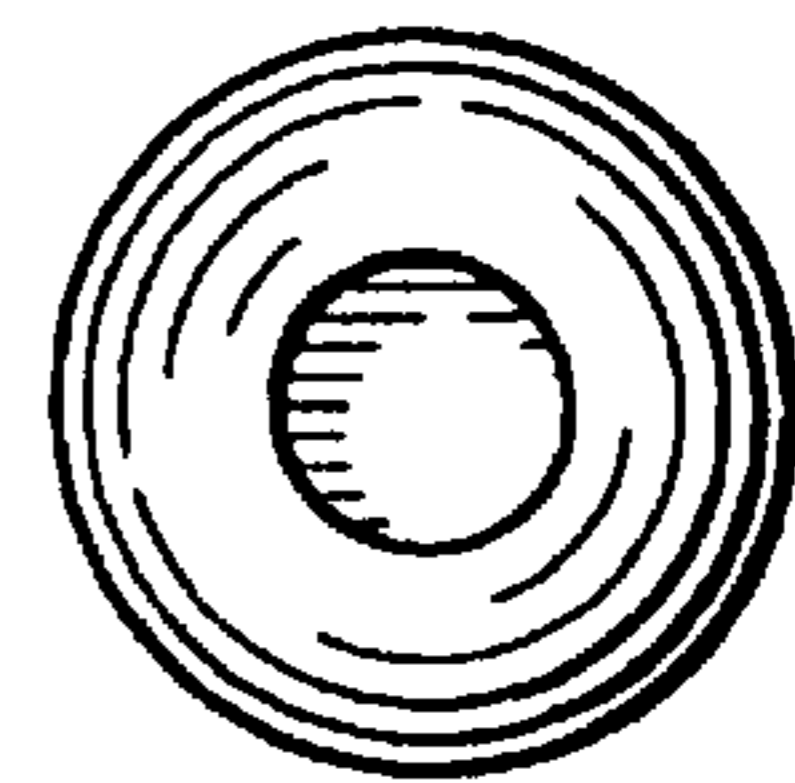

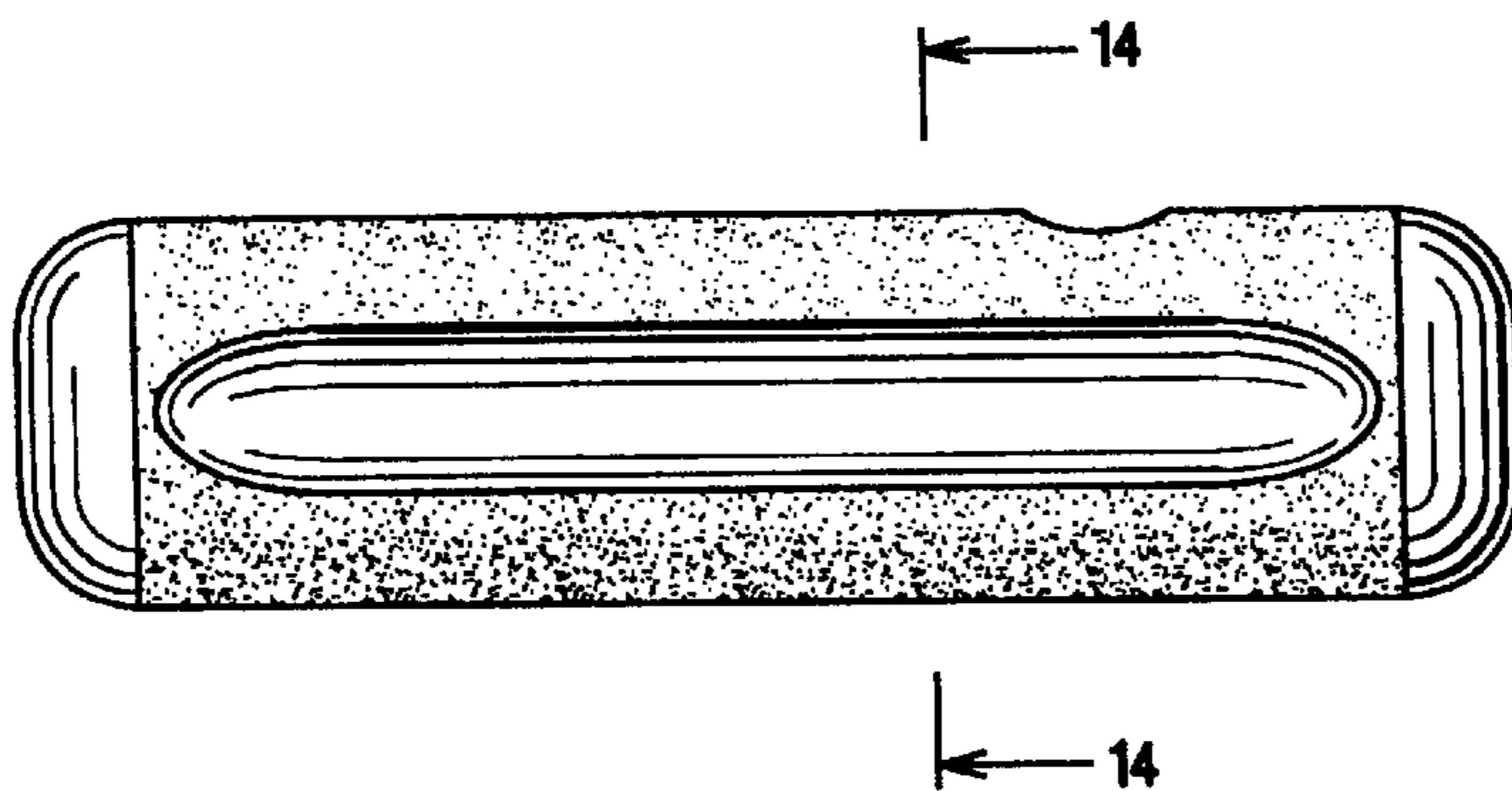

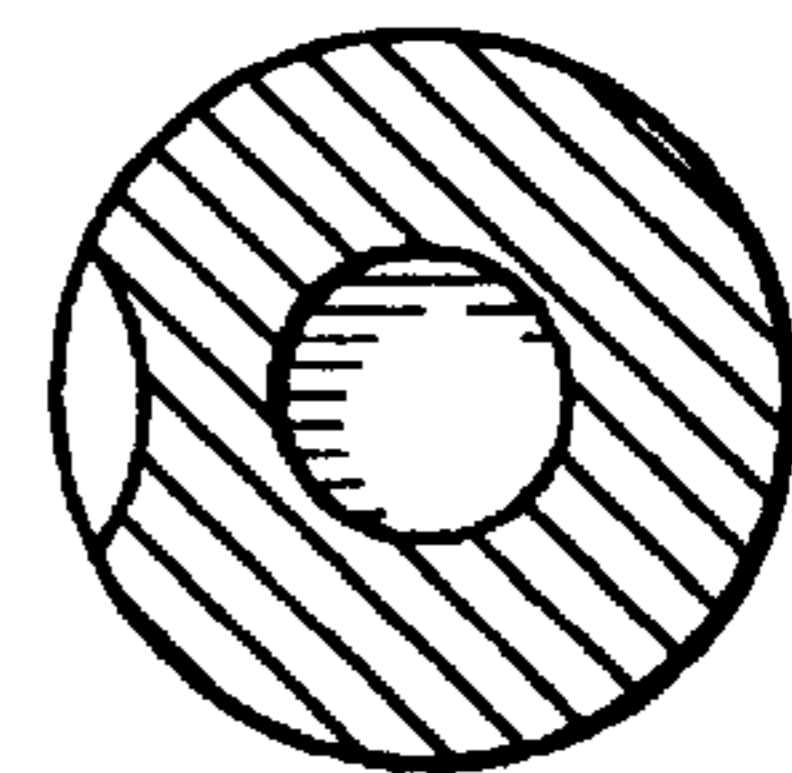
