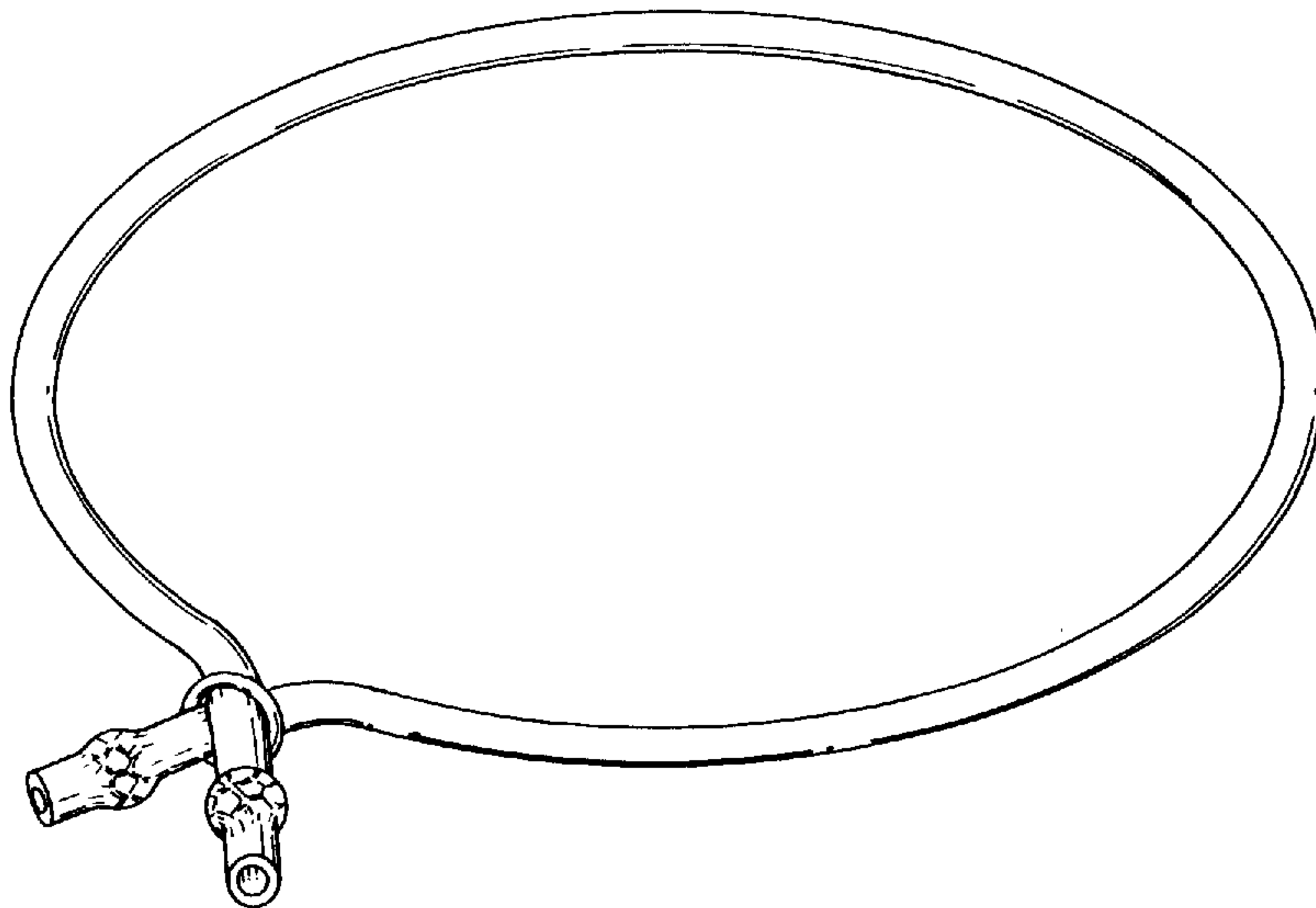
[57] **CLAIM**

The ornamental design for a container liner restraint, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a container liner restraint showing my new design;
FIG. 2 is a bottom plan view thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is a front elevational view thereof;
FIG. 5 is a rear elevational view thereof;
FIG. 6 is an elevational view of a left side thereof;
FIG. 7 is an elevational view of a right side thereof; and,
FIG. 8 is a detailed, partial elevational view of a left side, showing faceted surfaces along an enlarged portion of the tubing for the container liner restraint shown fragmented for clarity of illustration.

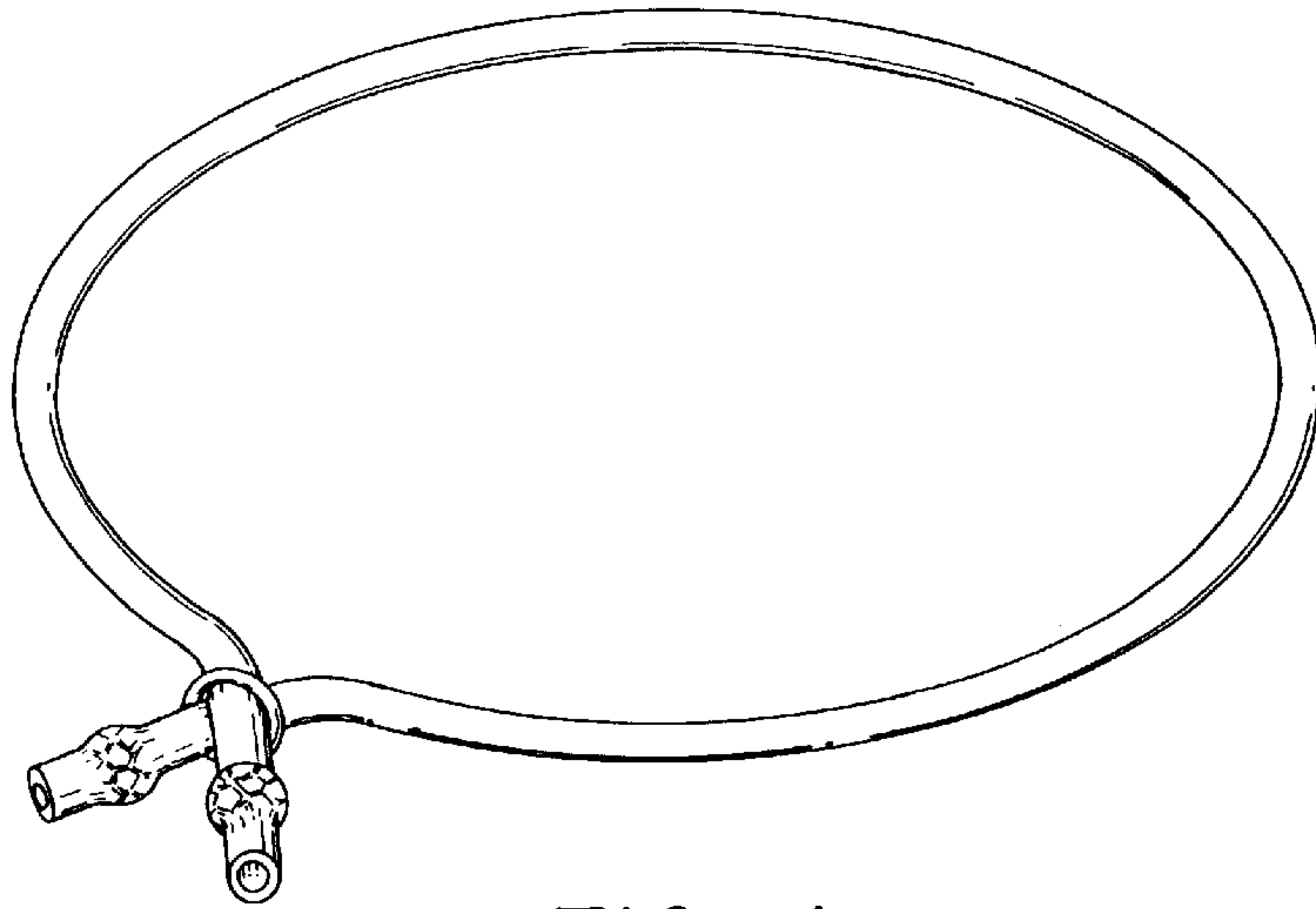

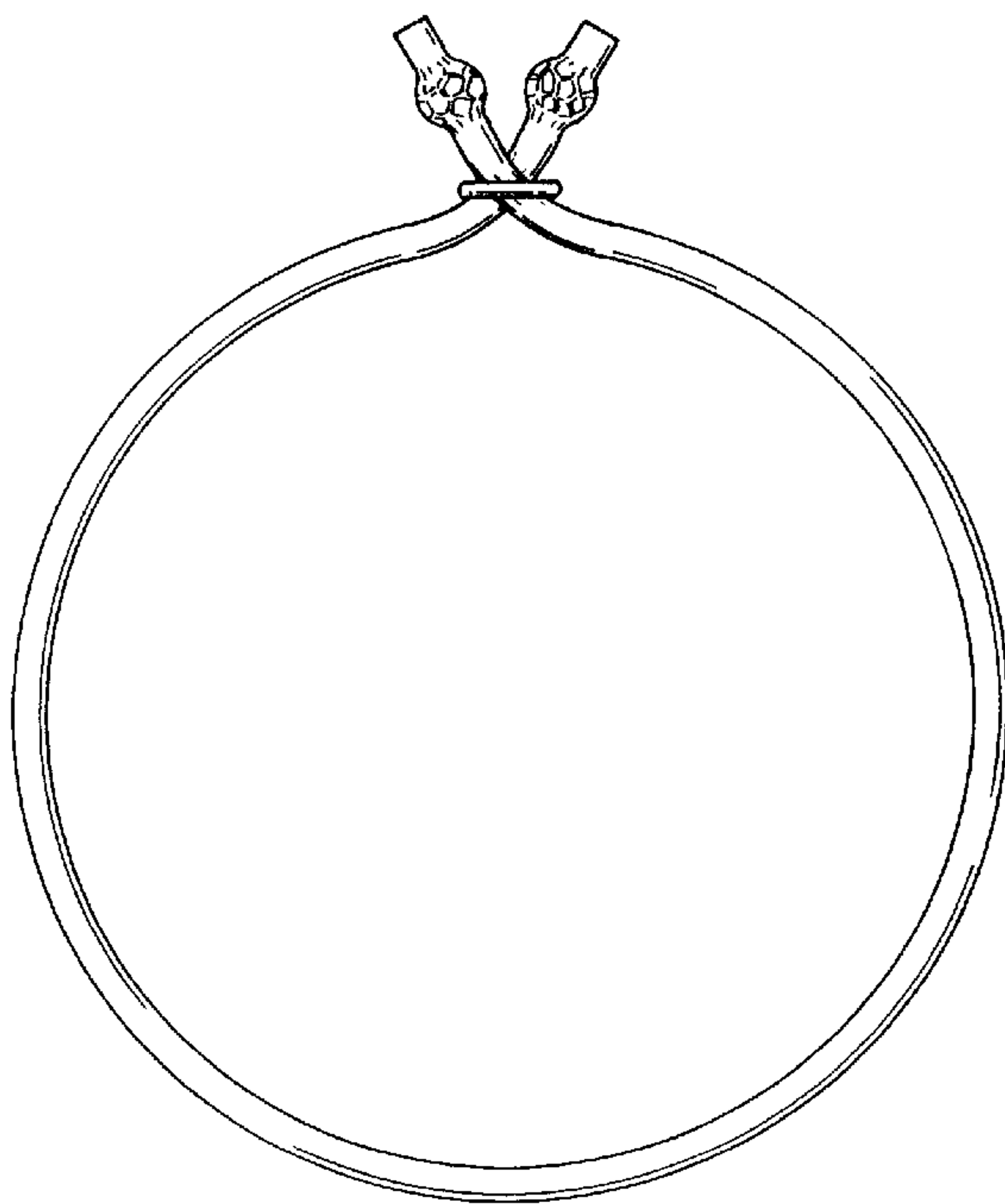

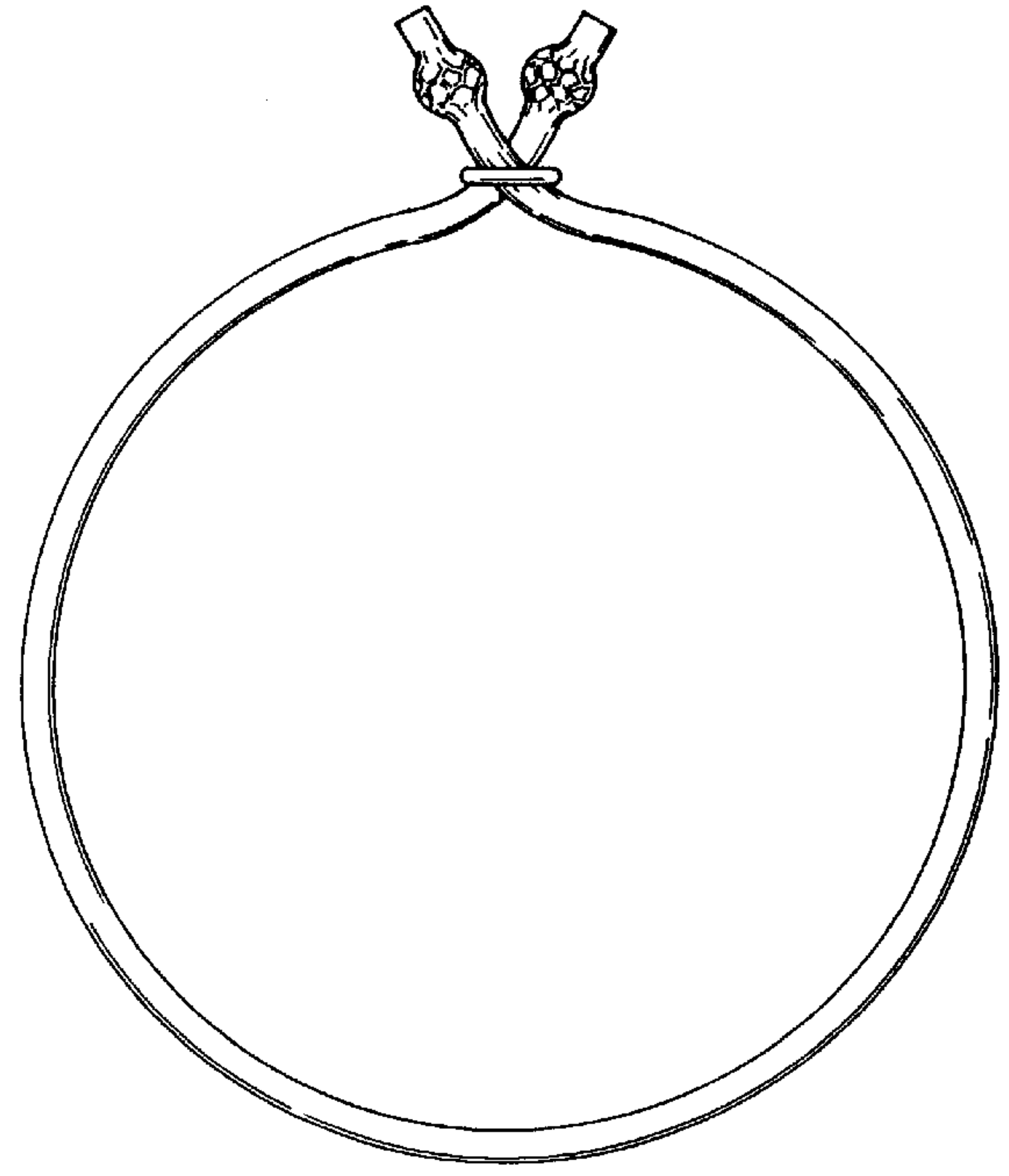

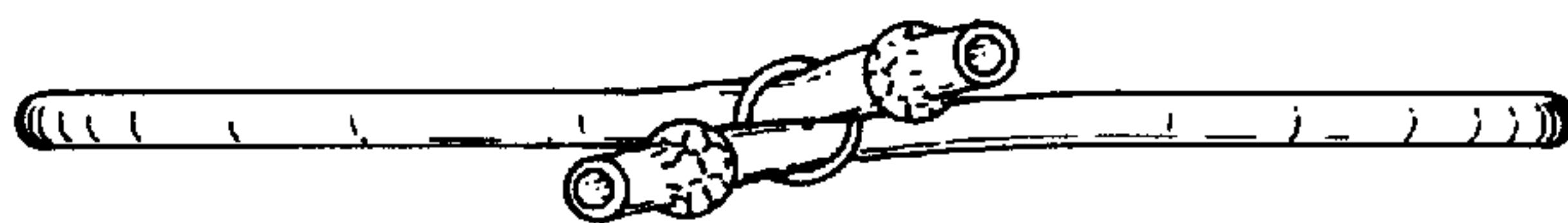

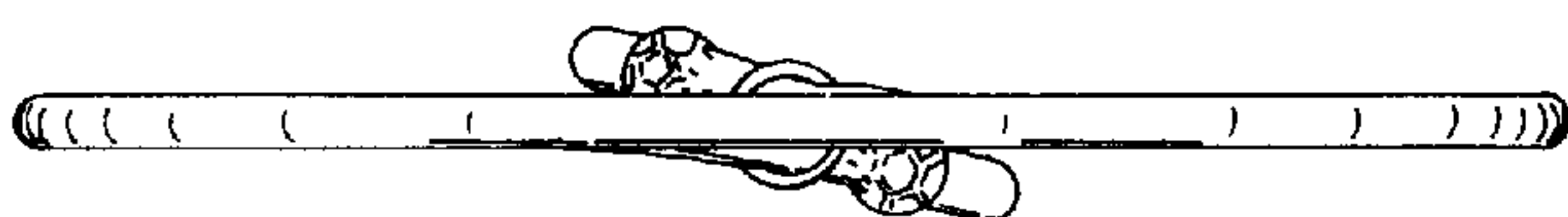

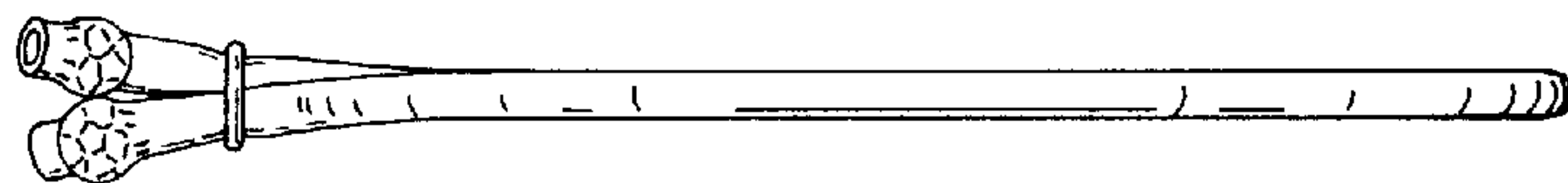

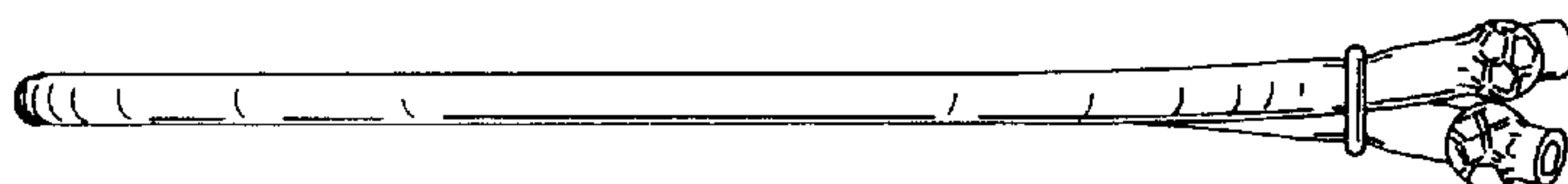

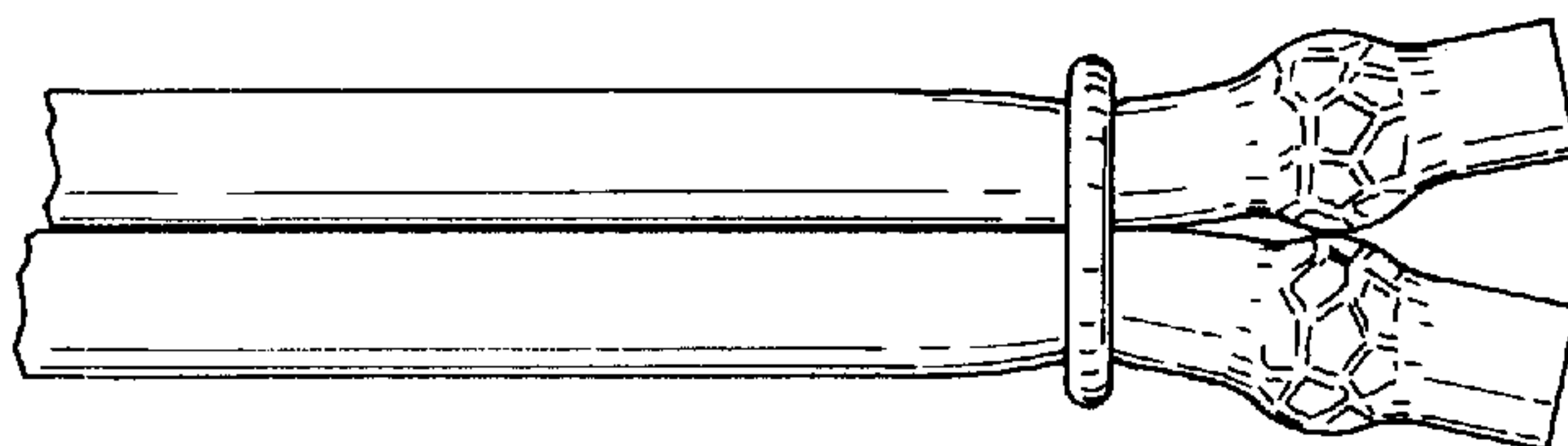
