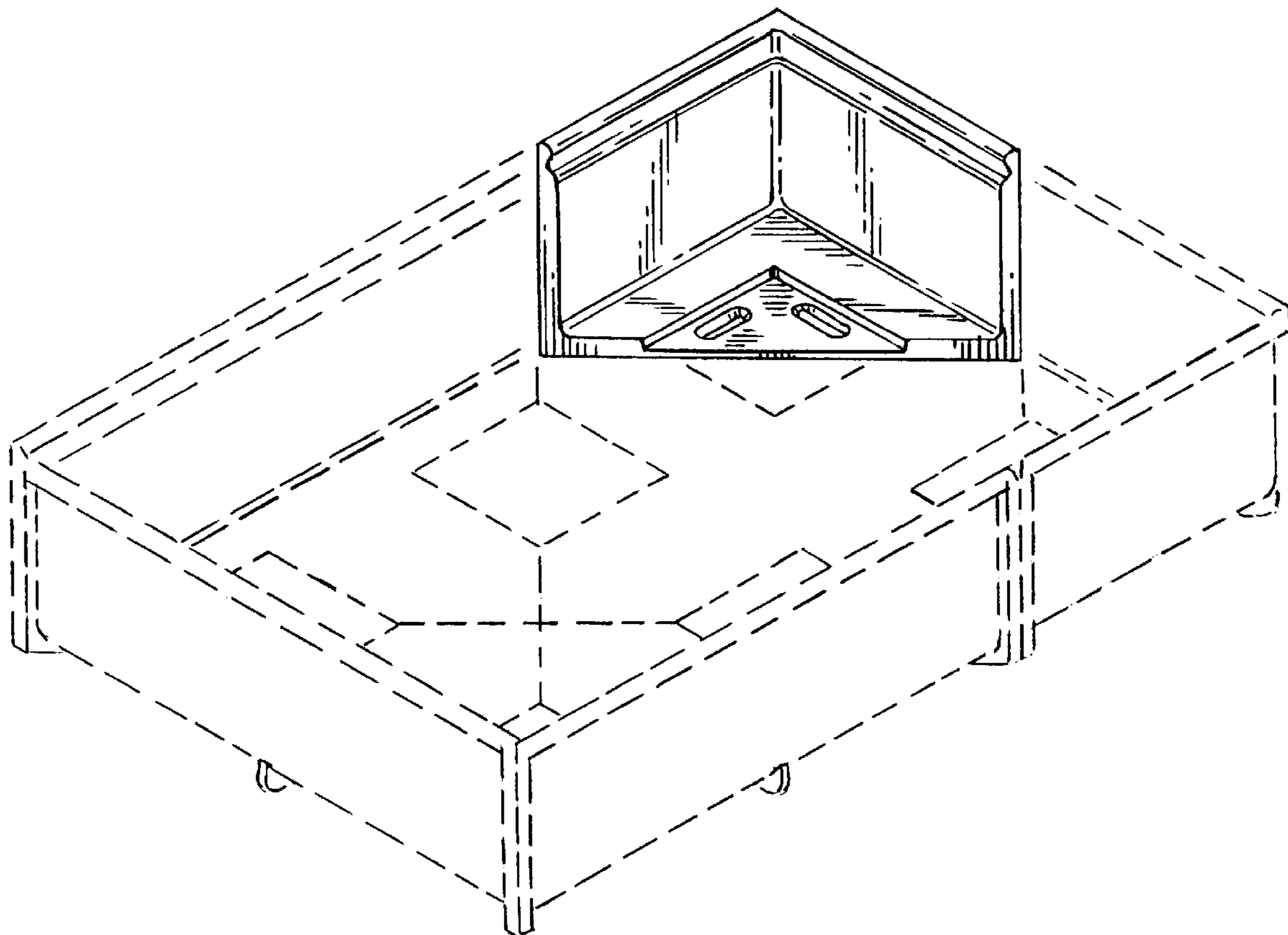
### [57] CLAIM

The ornamental design for a corner module for a drawer, as shown and described.

### DESCRIPTION

FIG. 1 is a top and front perspective view of a corner module for a drawer showing our new design; FIG. 2 is a top plan view thereof; FIG. 3 is a bottom plan view thereof; FIG. 4 is a rear elevation view thereof taken in the direction of arrow 4 in FIG. 2; FIG. 5 is a front elevation view thereof taken in the direction of arrow 5 in FIG. 2; FIG. 6 is a front elevation view thereof taken in the direction of arrow 6 in FIG. 2; FIG. 7 is a rear elevation view thereof taken in the direction of arrow 7 in FIG. 2; and, FIG. 8 is a top perspective view thereof with environmental structure shown in broken lines for purposes of illustration only and forming no part of the claimed design.

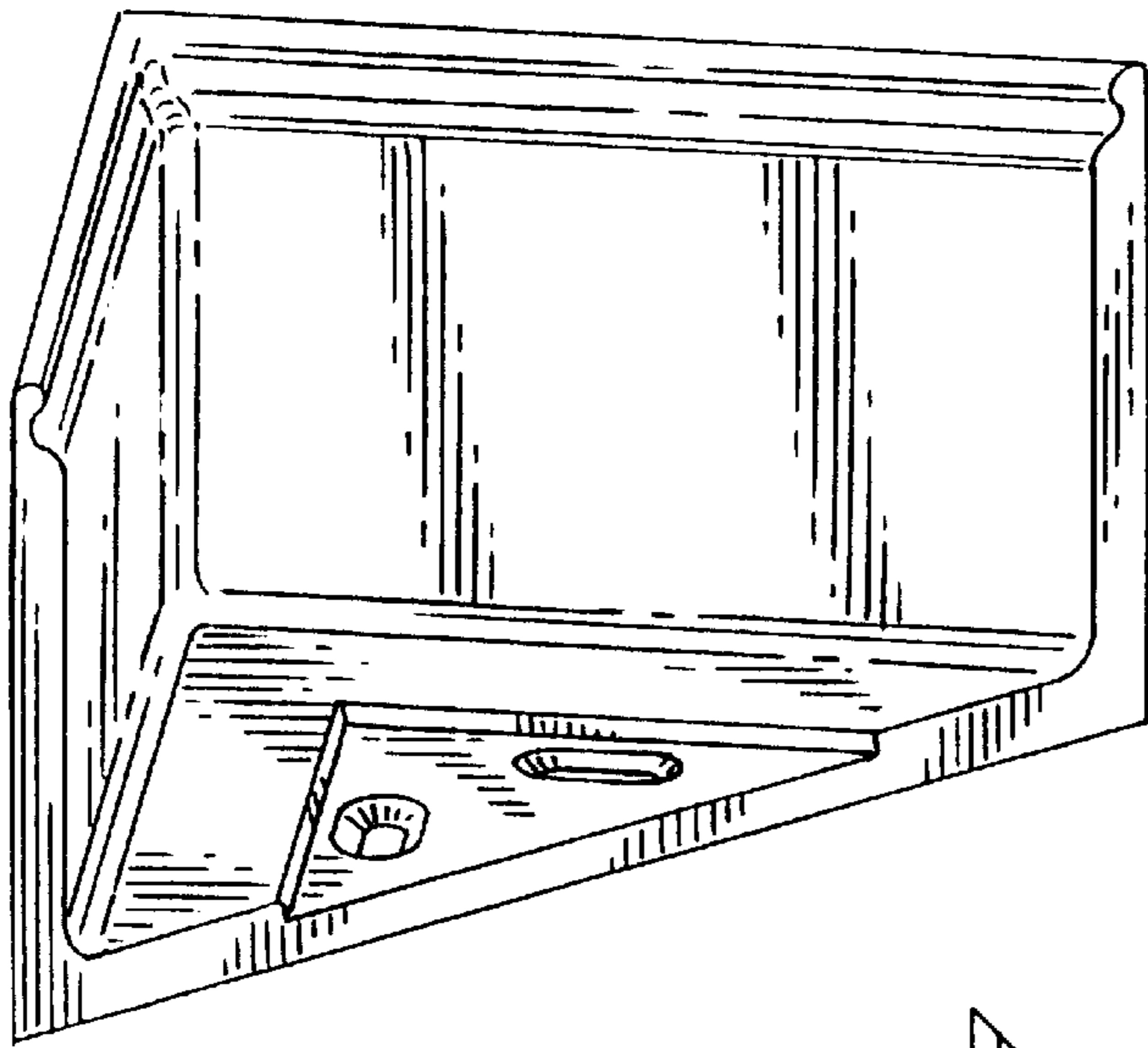

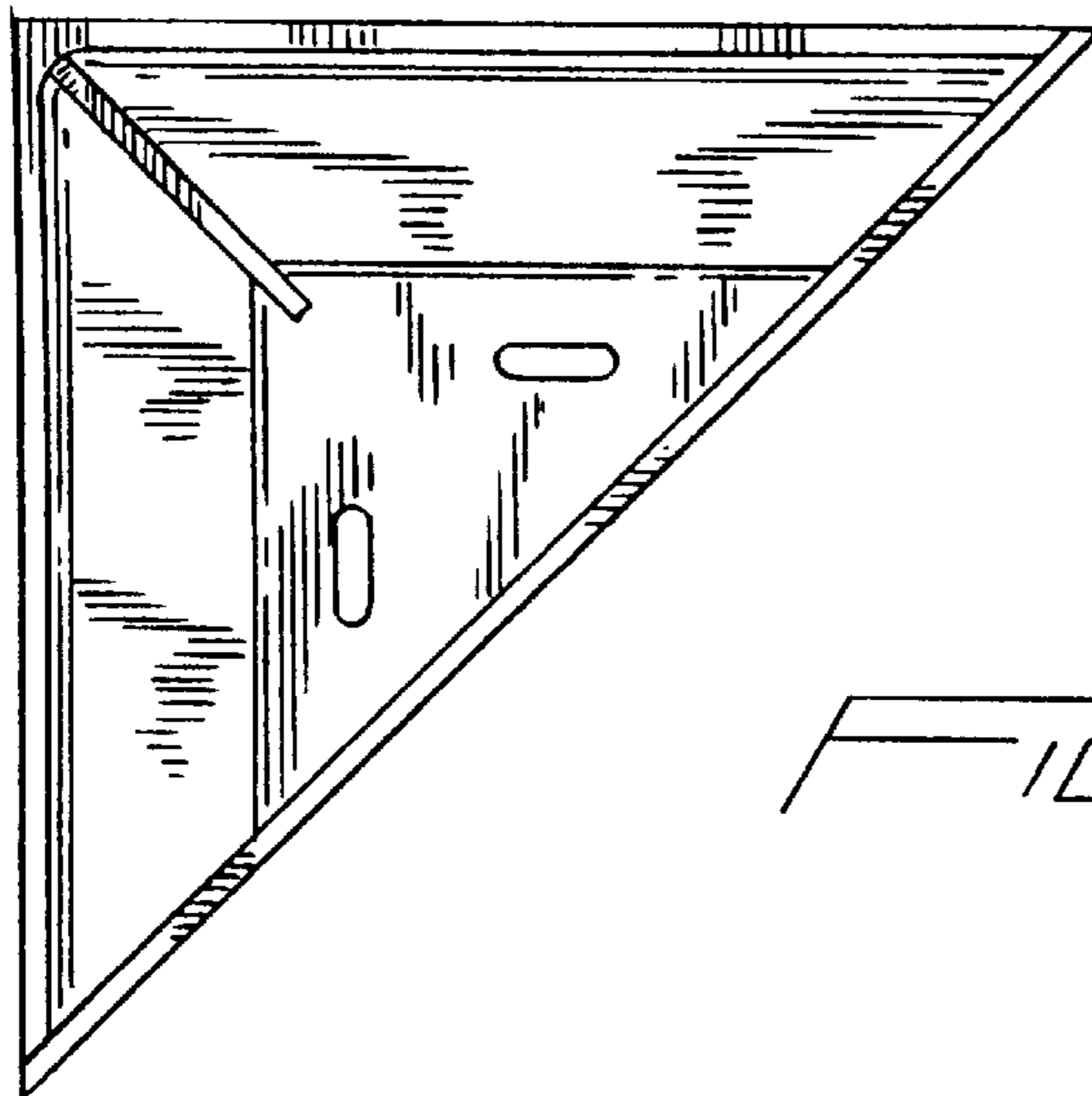
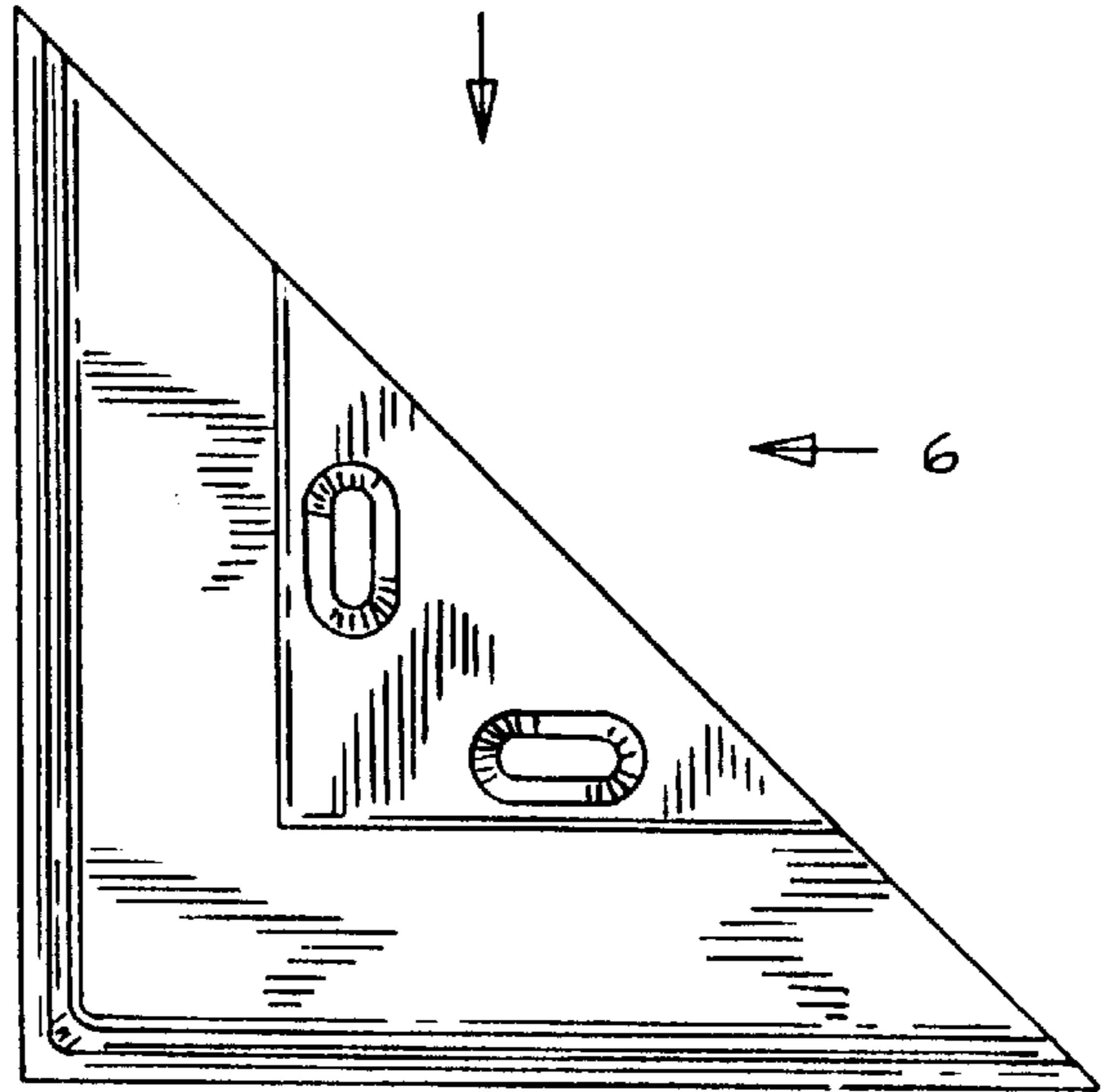
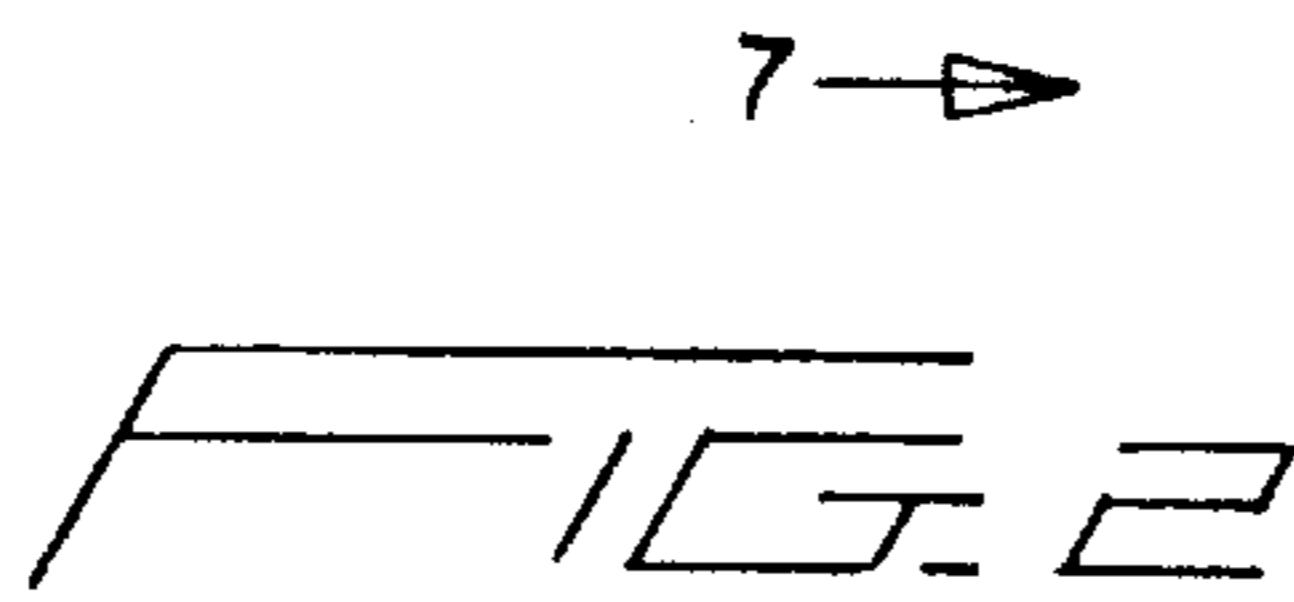

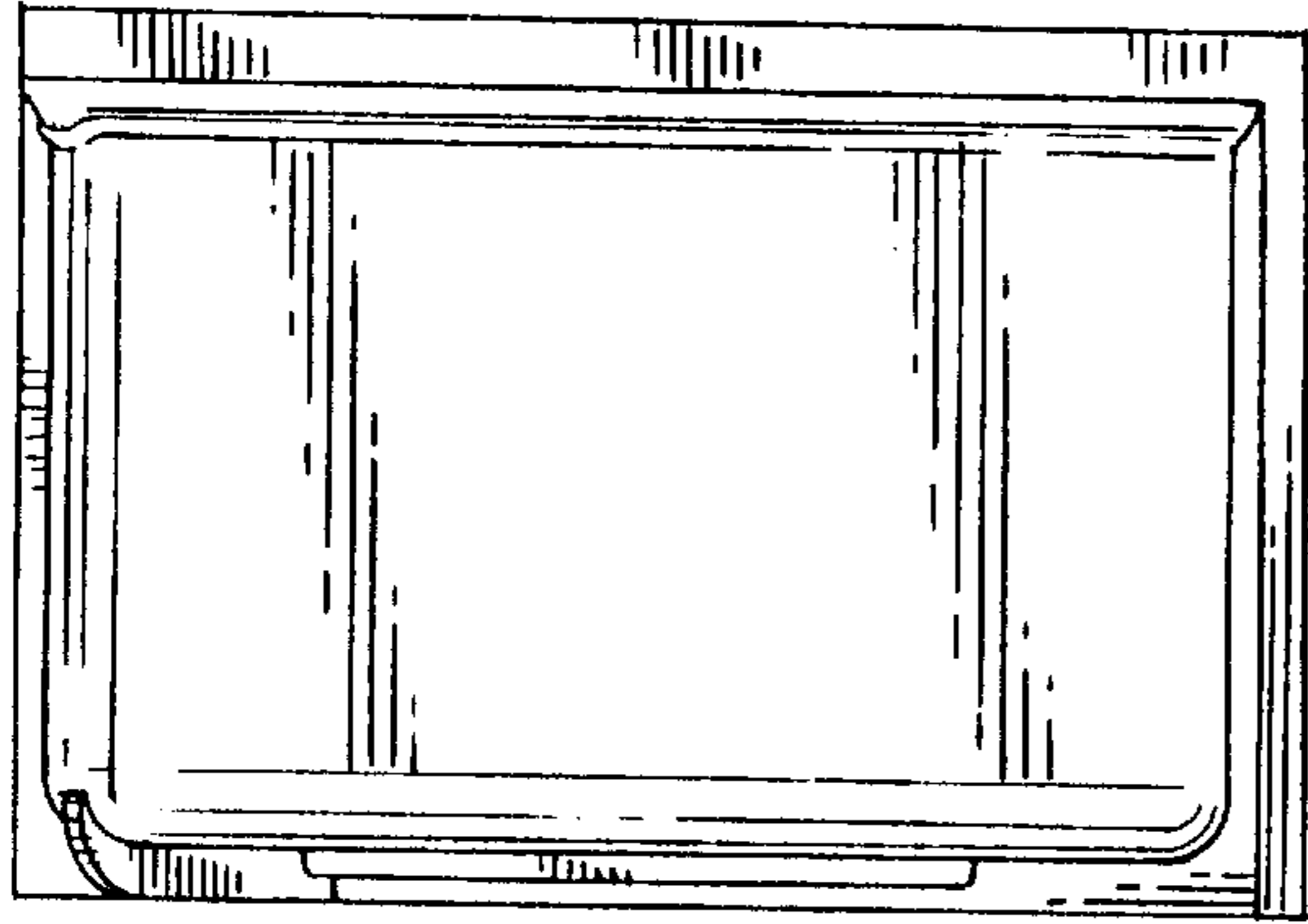

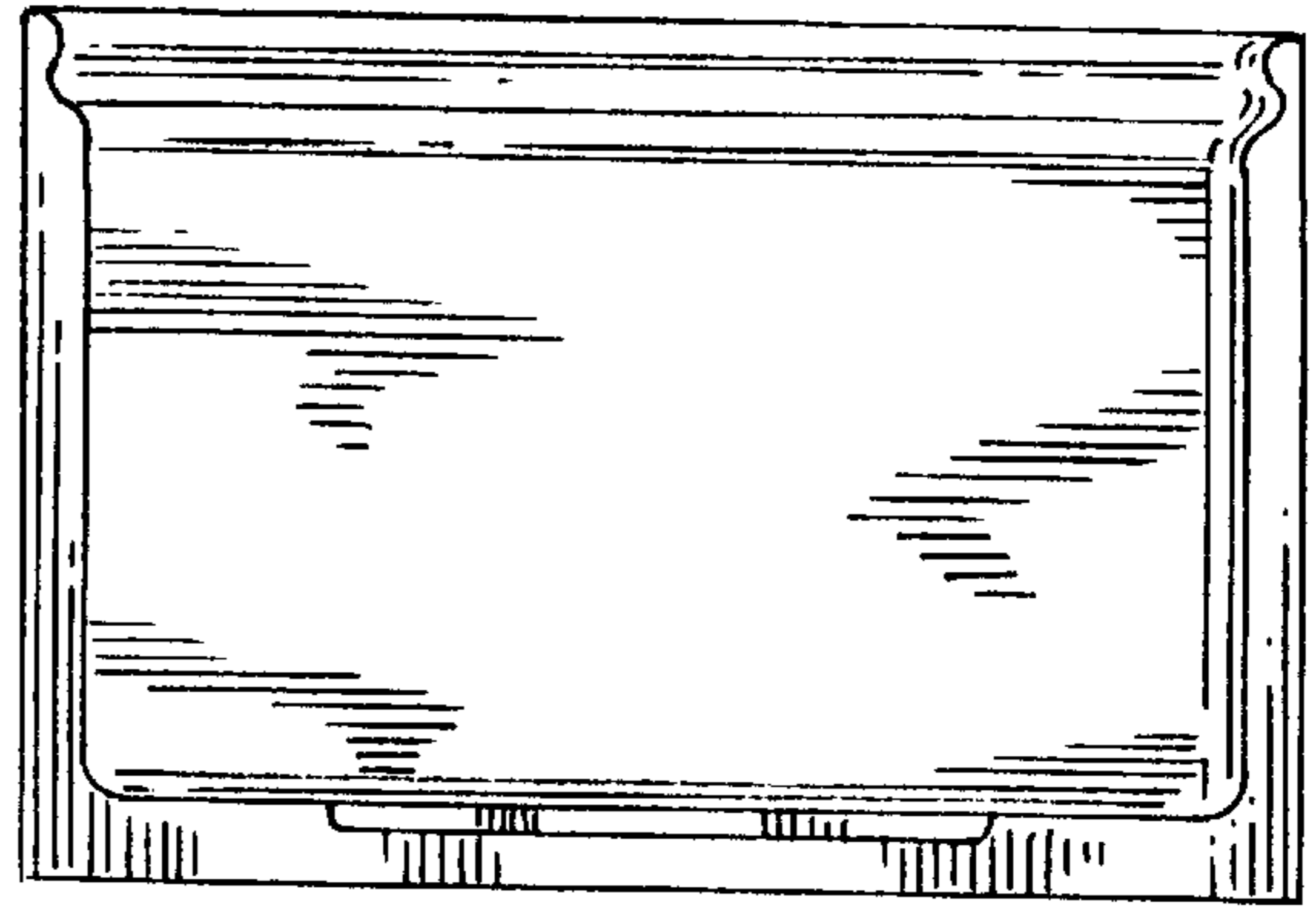

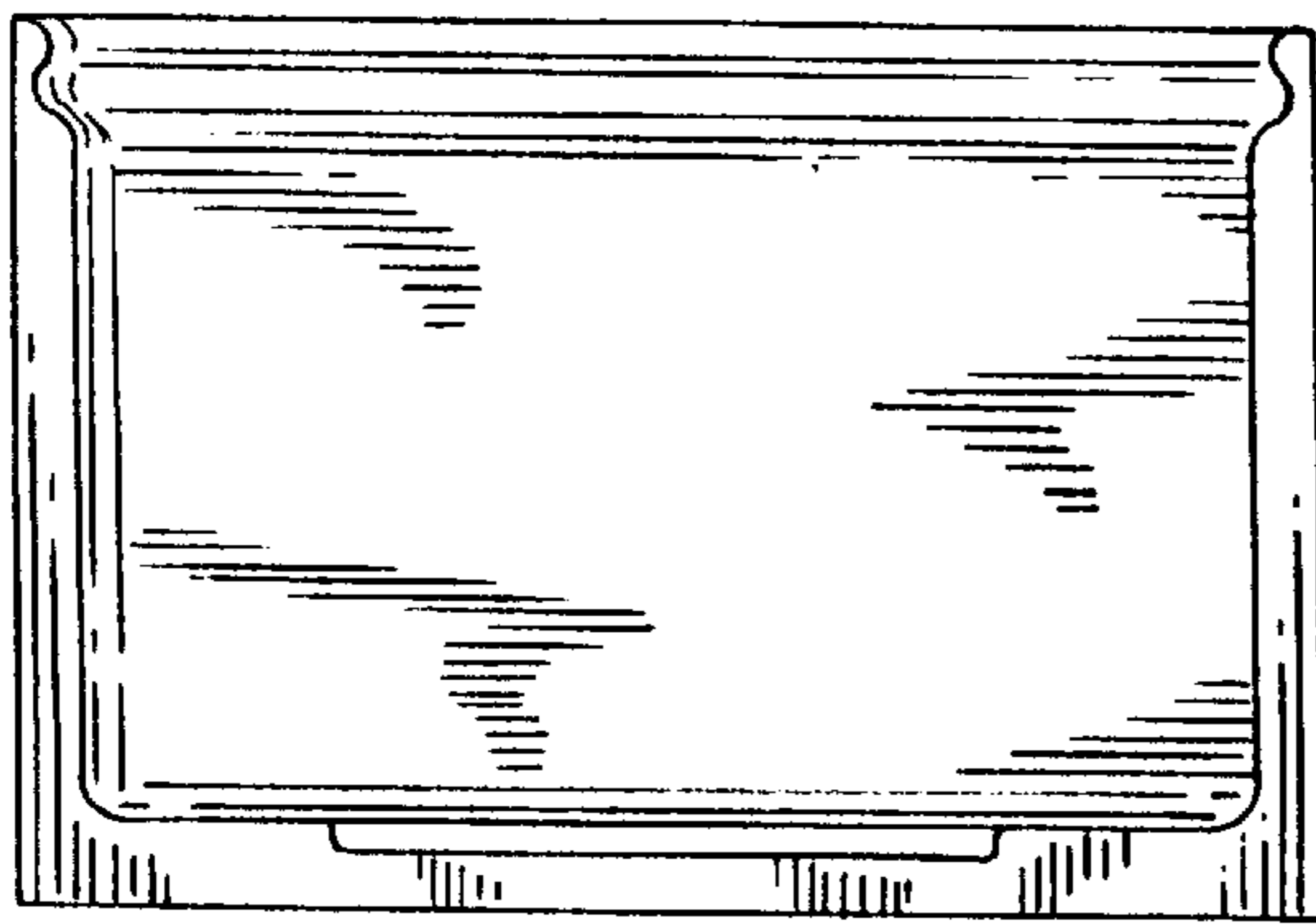

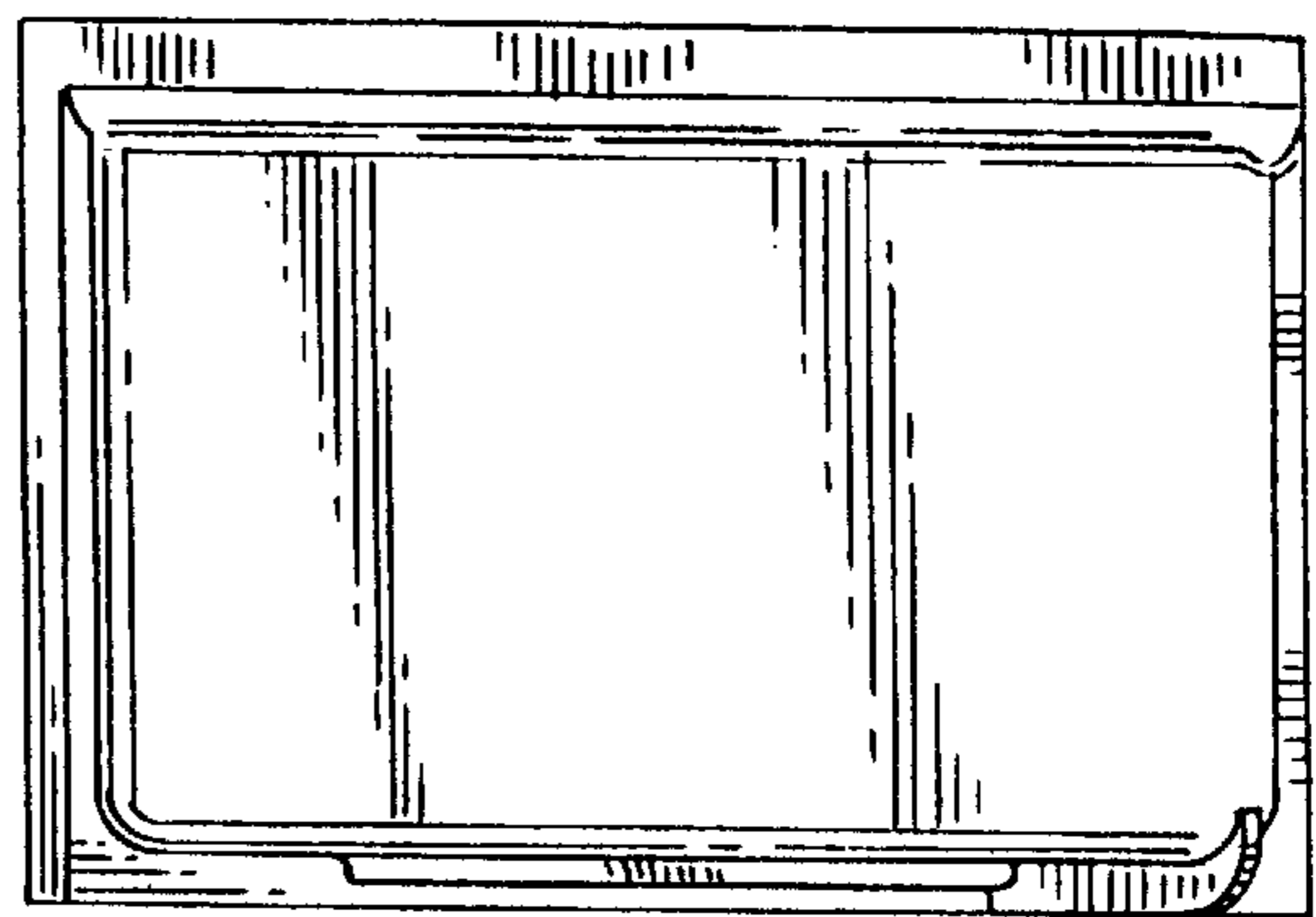

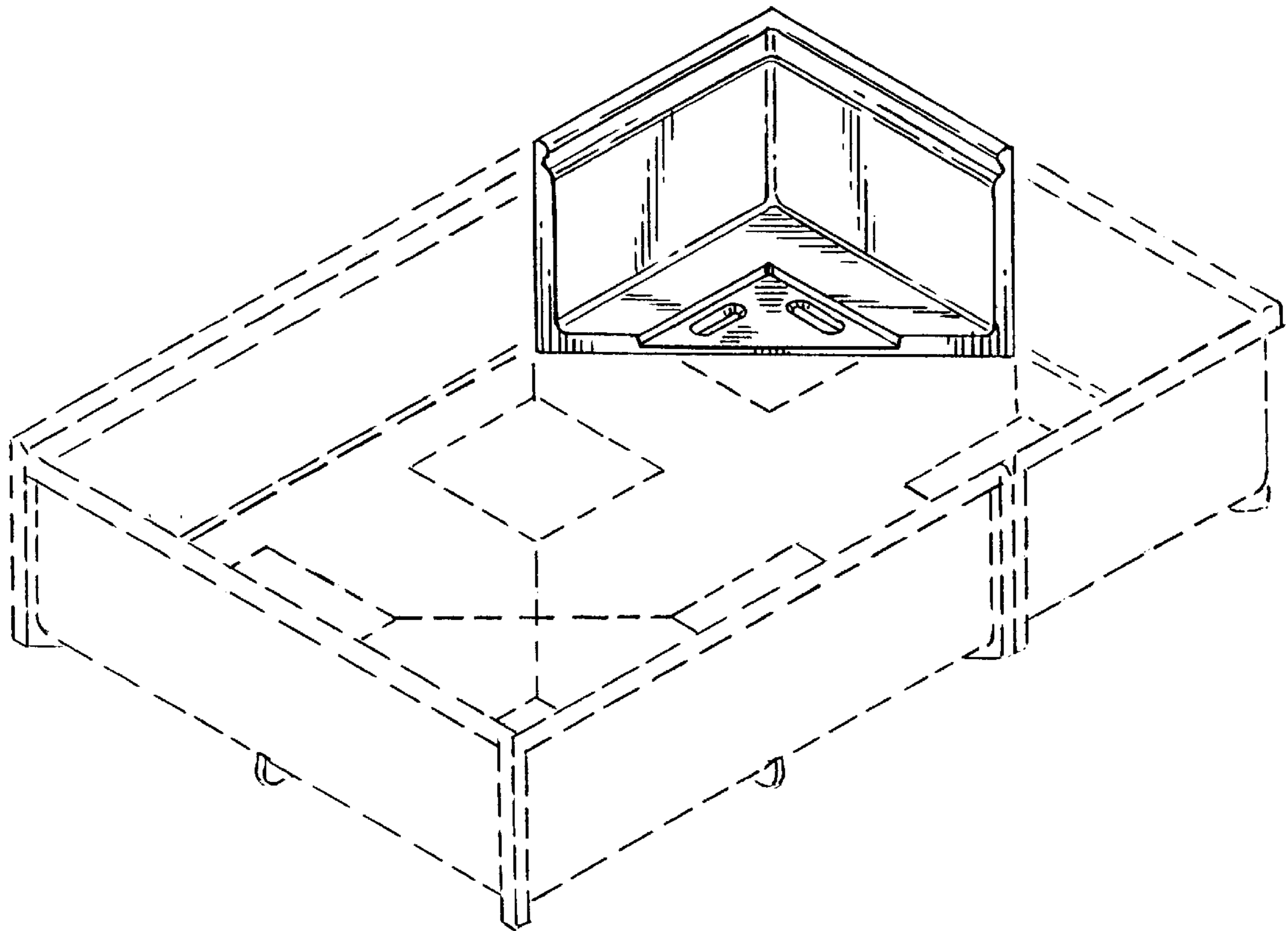
