The ornamental design for a window treatment accessory, as shown and described.

**DESCRIPTION**

FIG. 1 is an environmental perspective view of the claimed window treatment accessory; FIG. 2 is a top plan view thereof; FIG. 4 is a front view thereof; FIG. 5 is a rear view thereof; and, FIG. 6 is a left side view thereof (the right side view being a mirror image).

The broken line showing of a cut-away portion of a support rod in FIG. 1 and mounting holes in FIG. 3 are for illustrative purposes only and form no part of the claimed design.

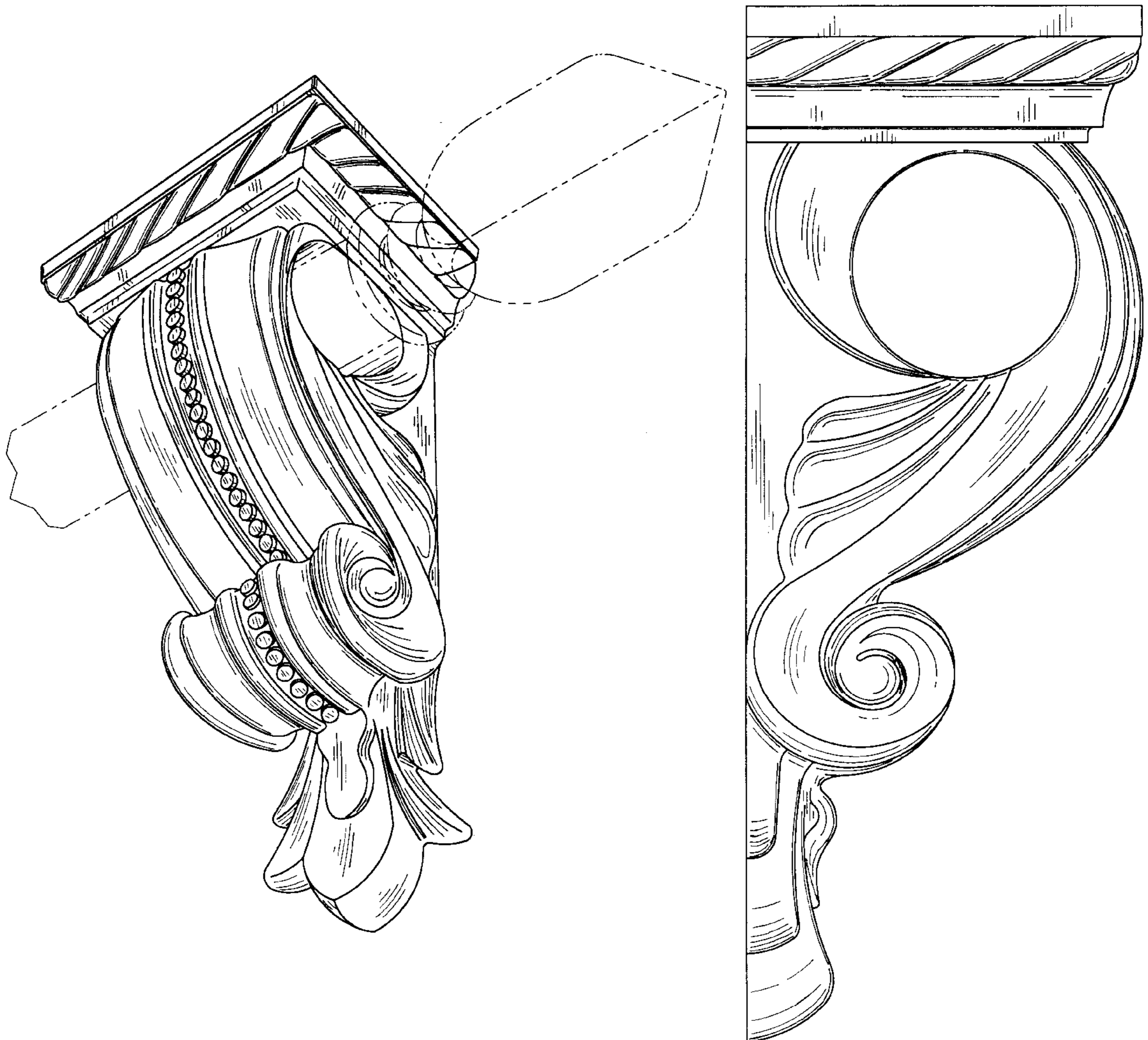

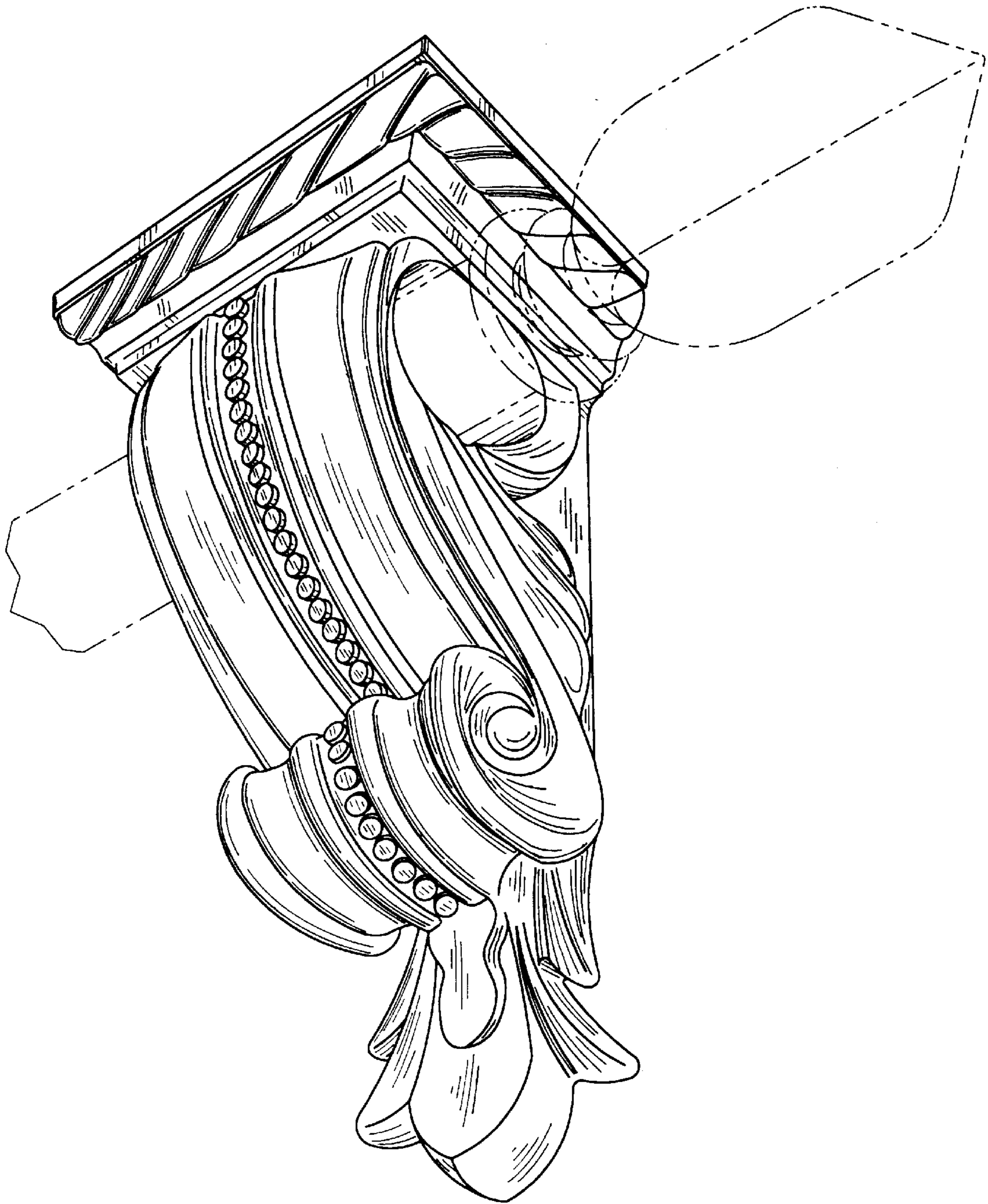

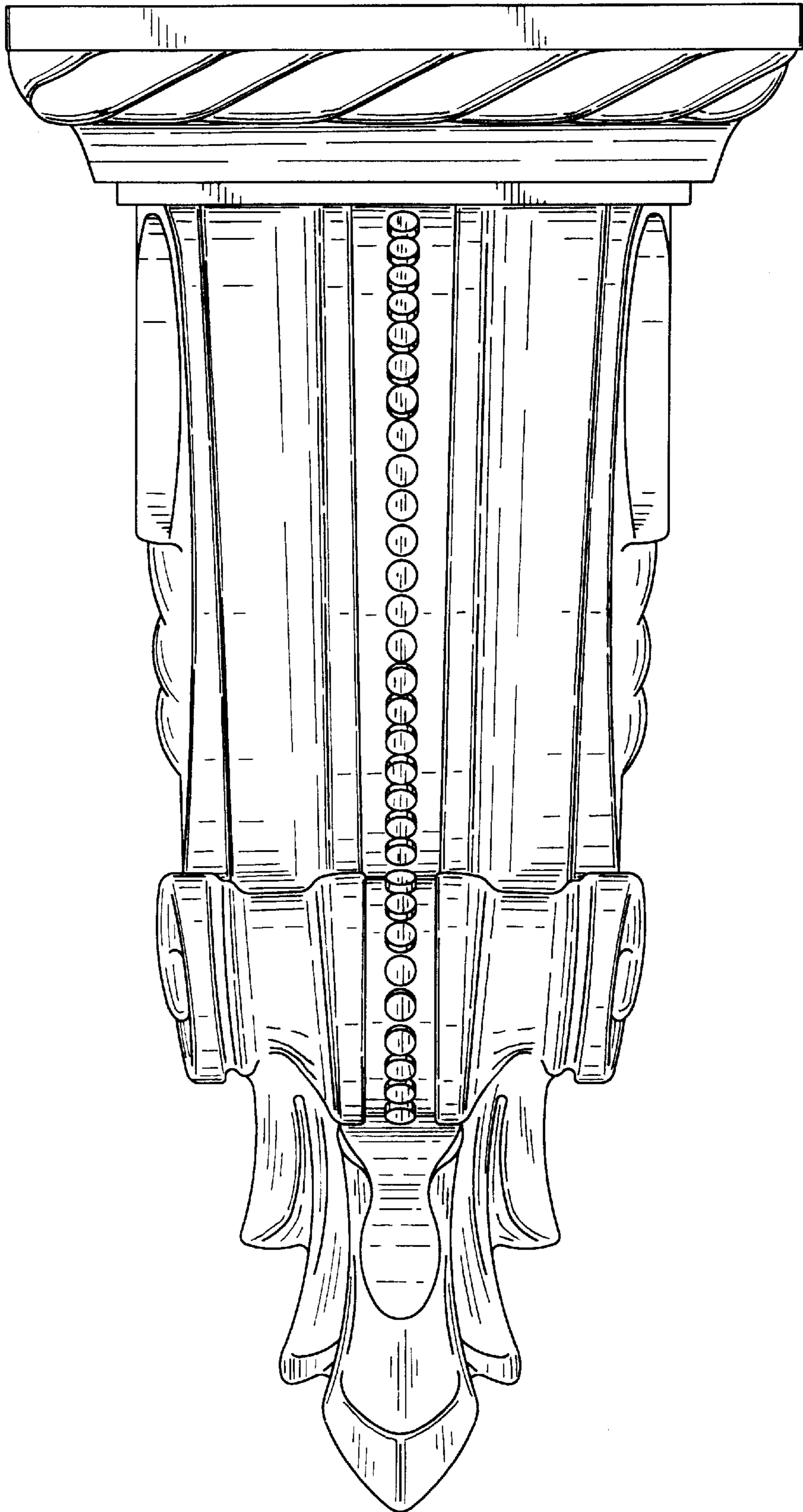

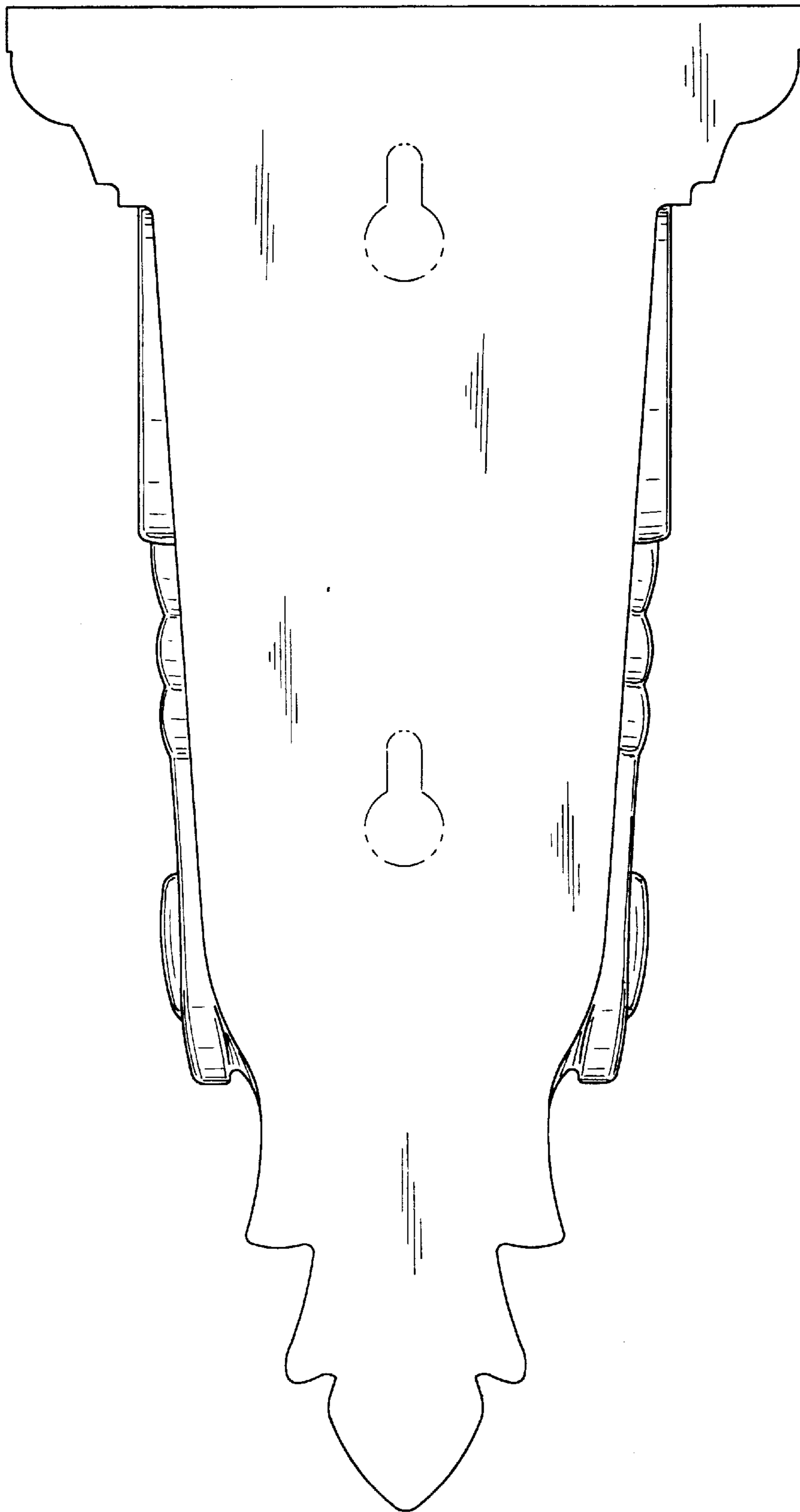

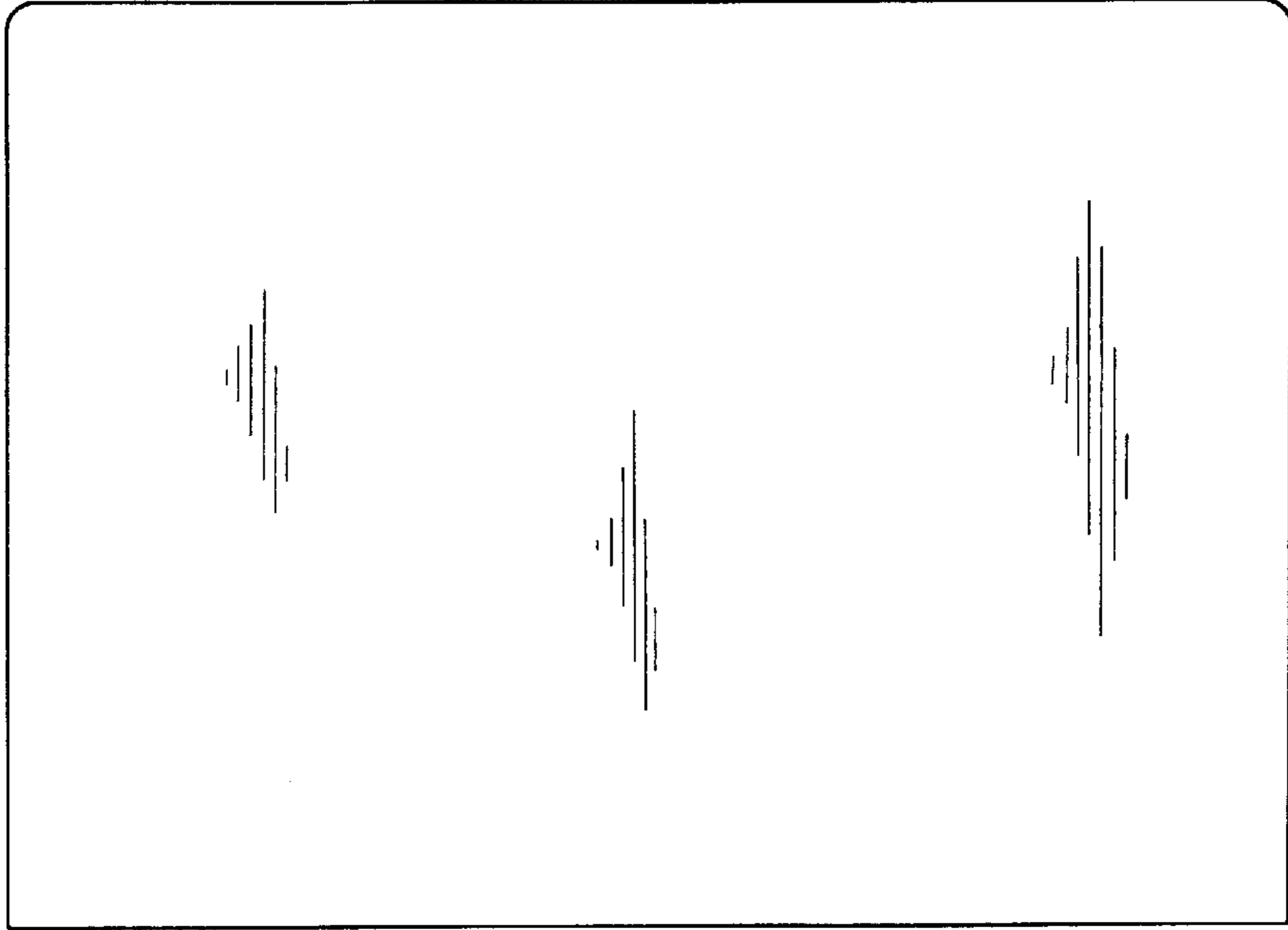

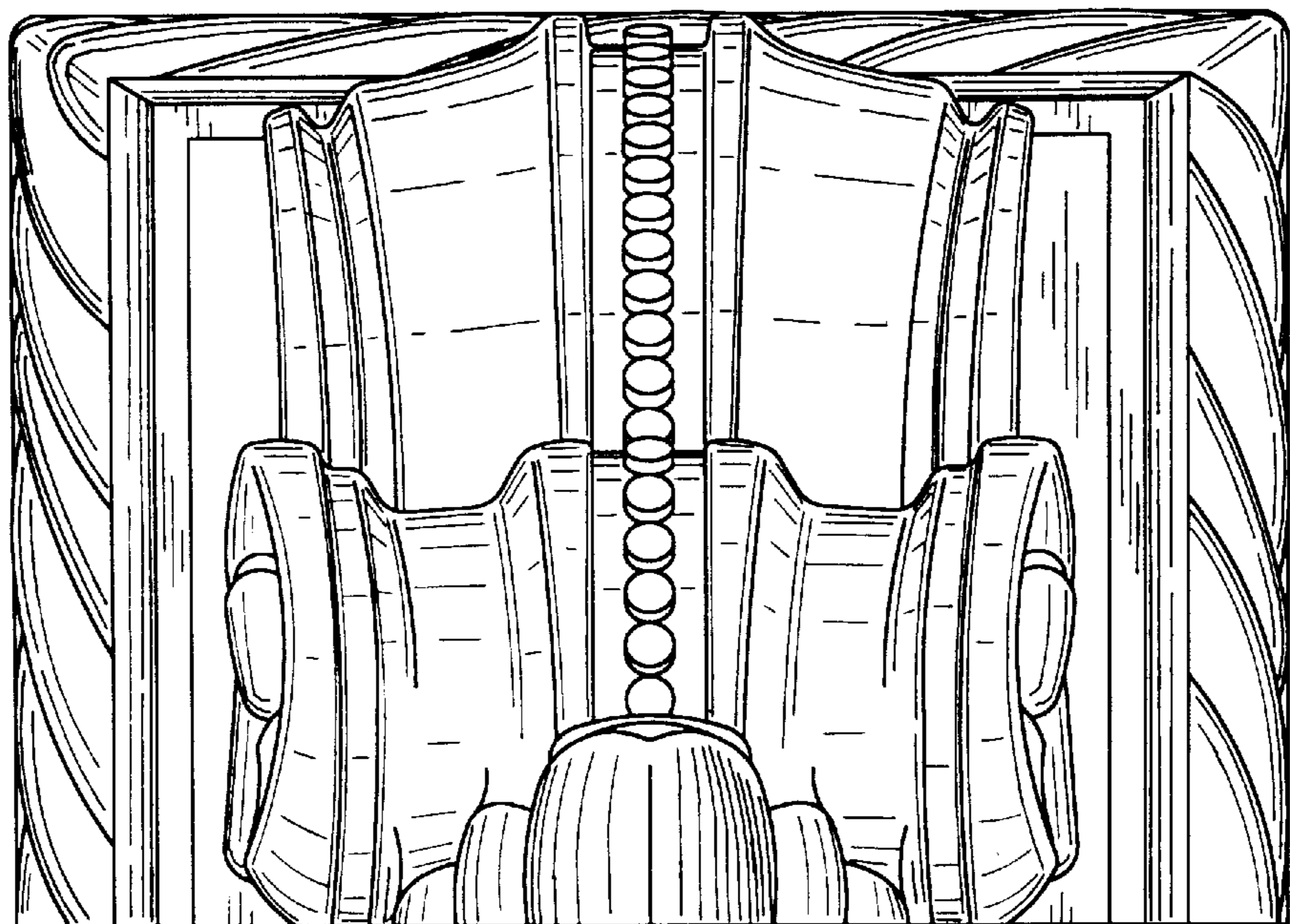
