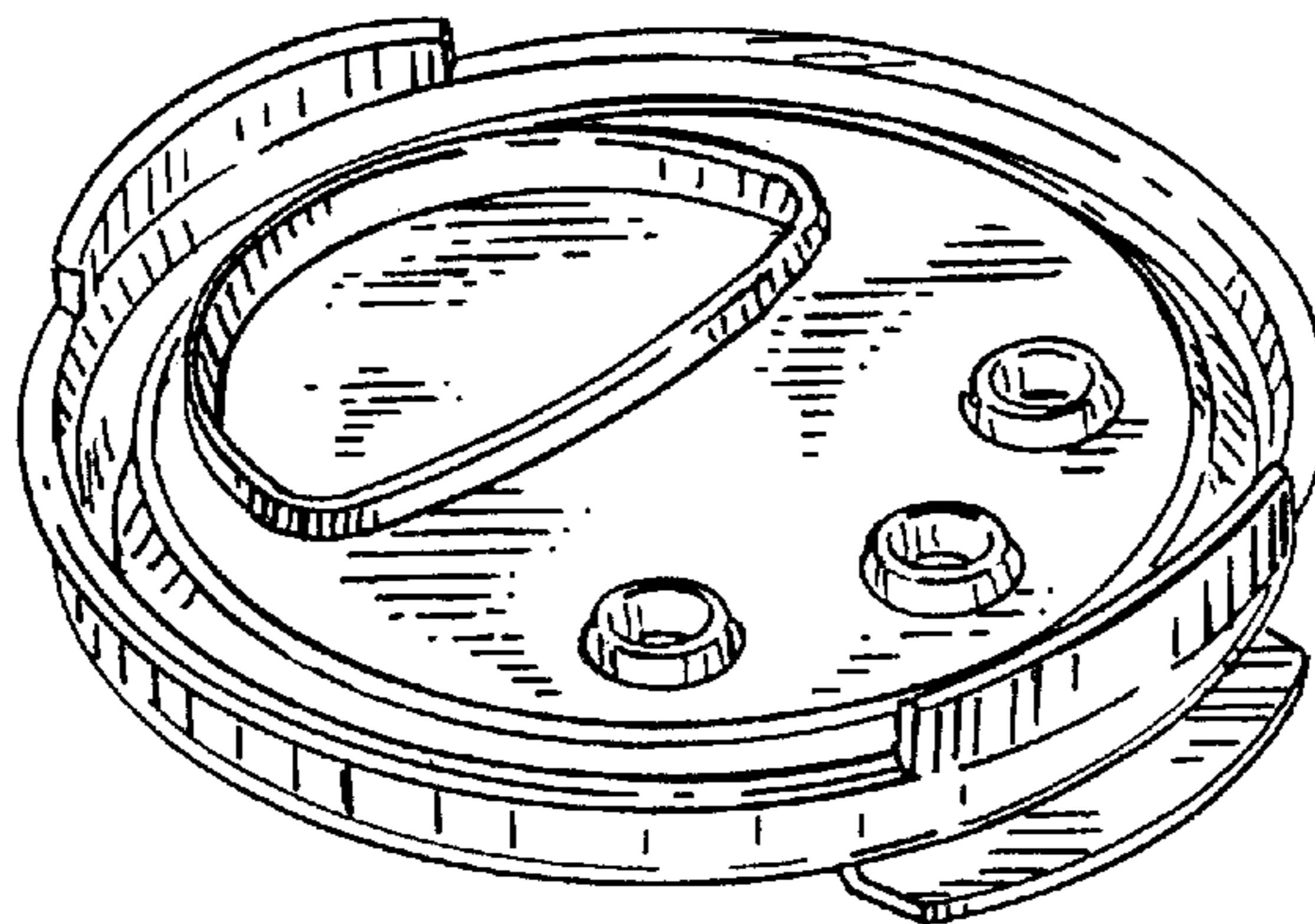
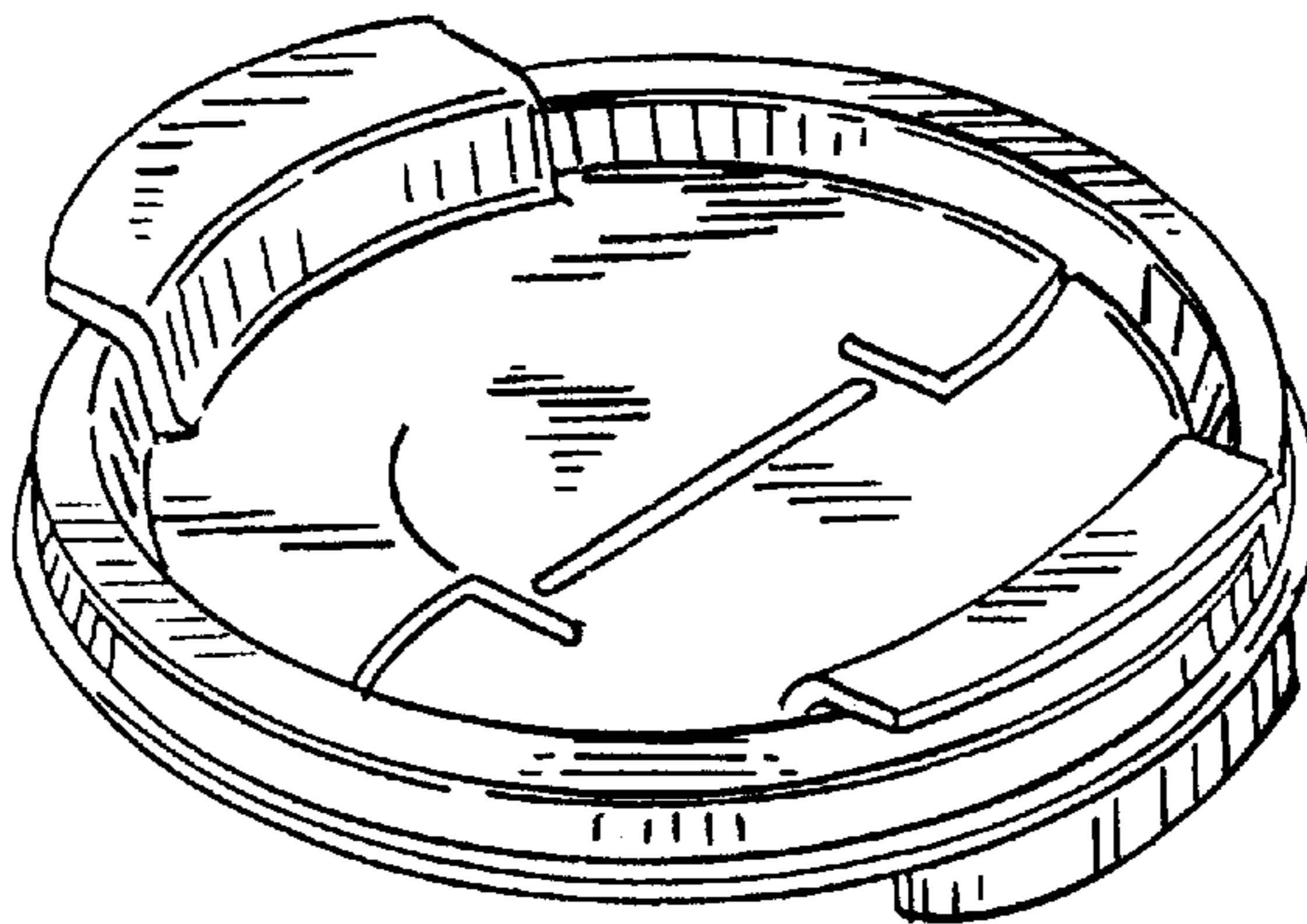

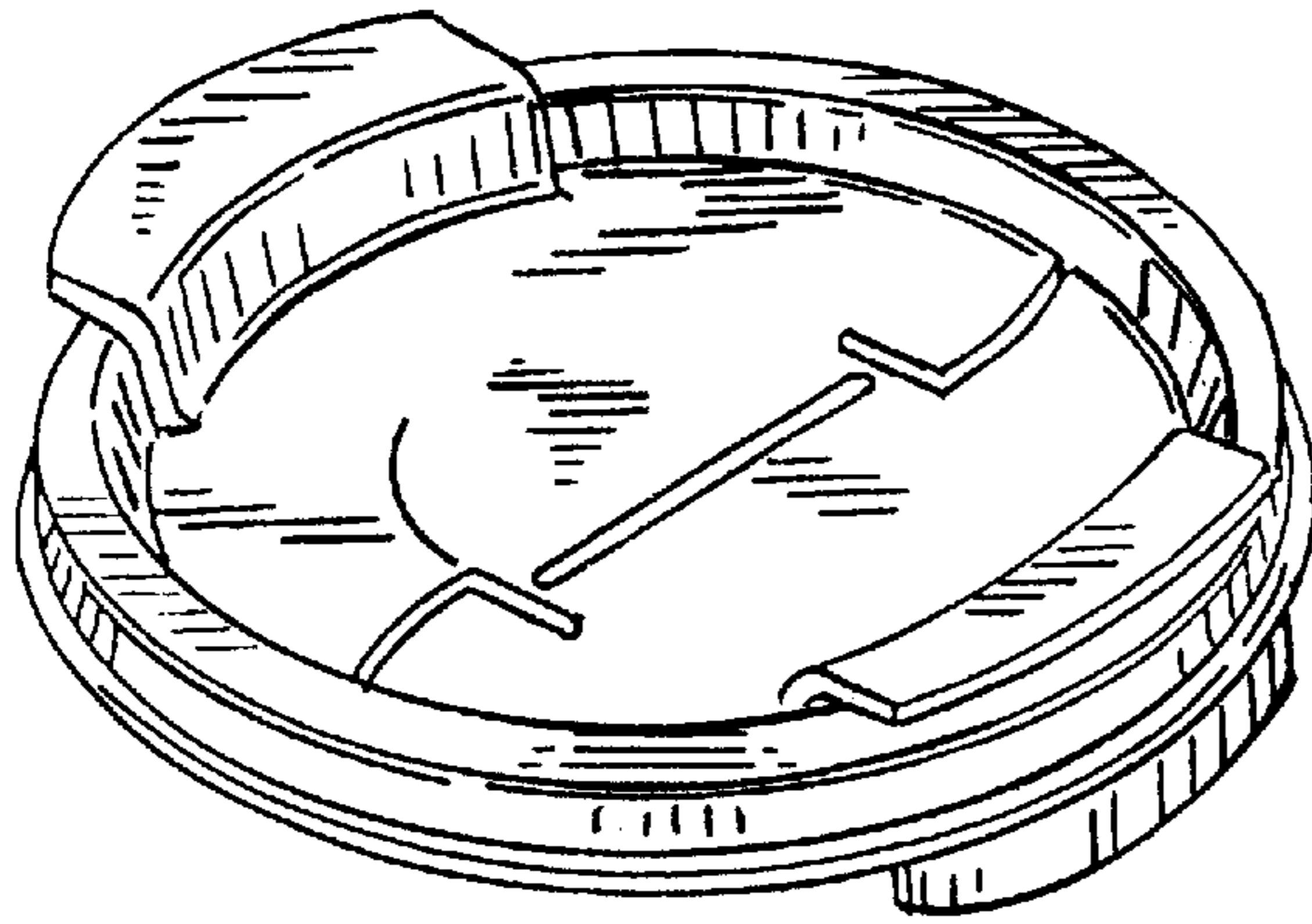
The ornamental design for a dual lid seal, as shown and described.

**DESCRIPTION**

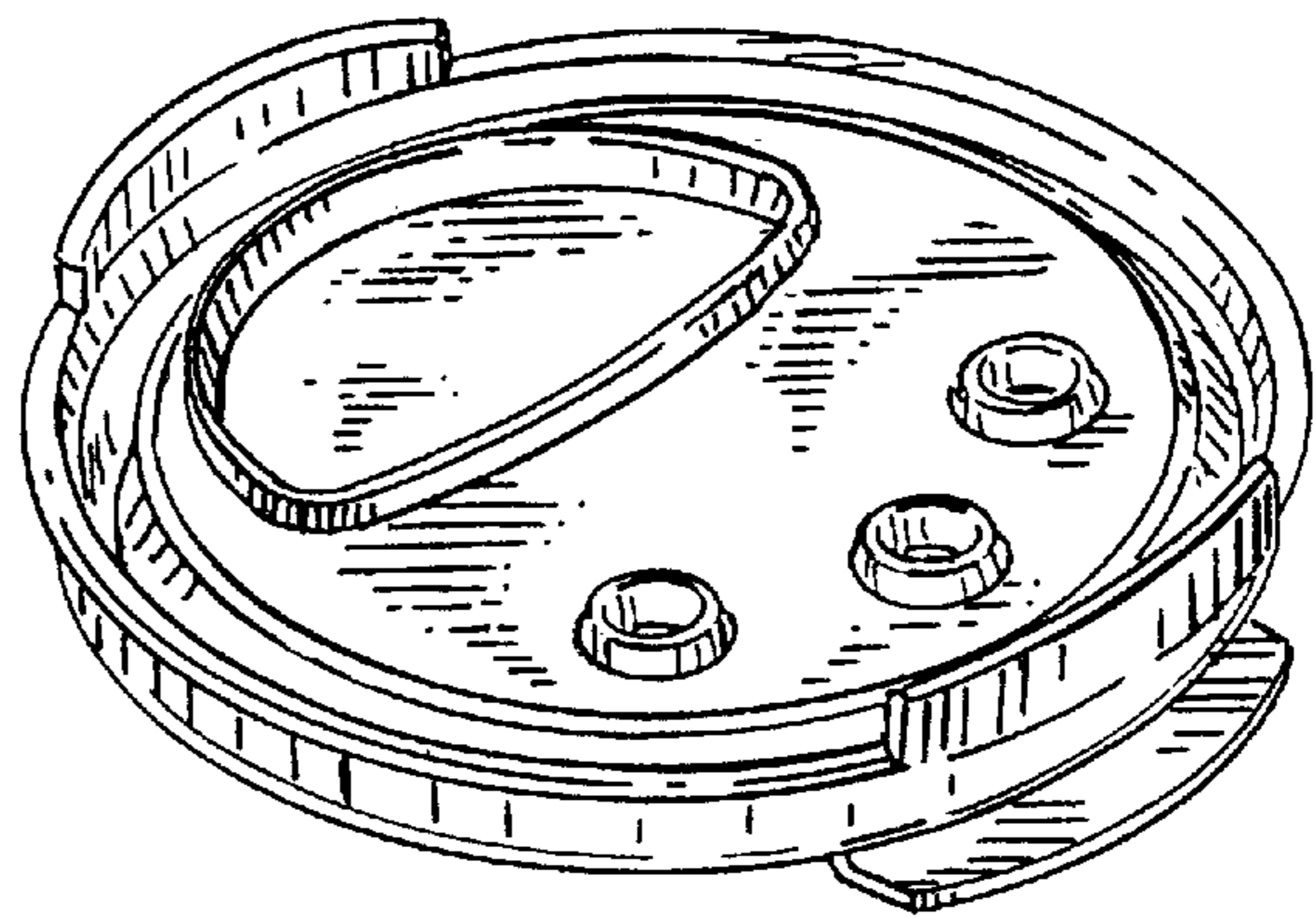
FIG. 1 is a top, end and front perspective view of a dual lid seal showing our new design;

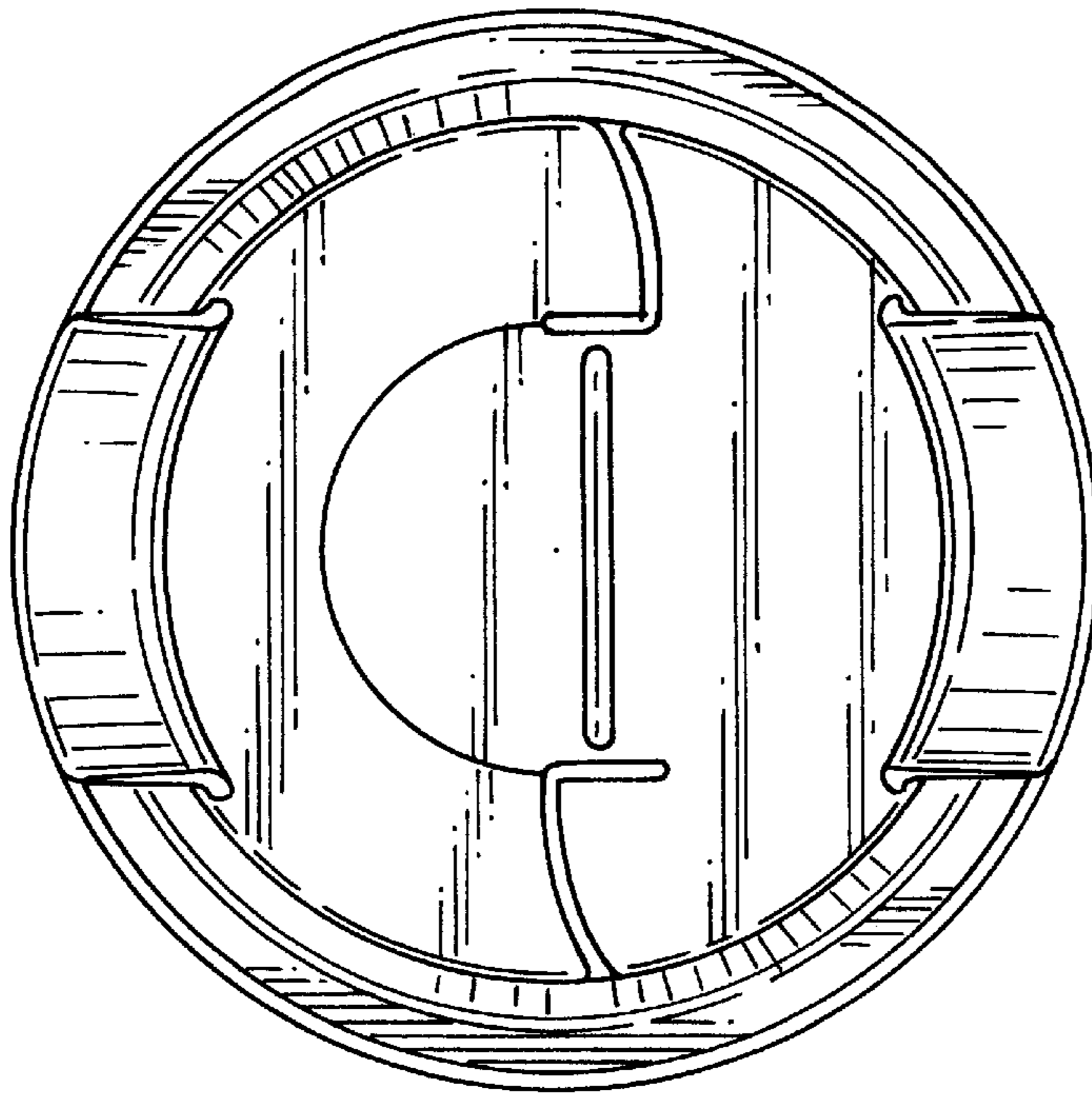

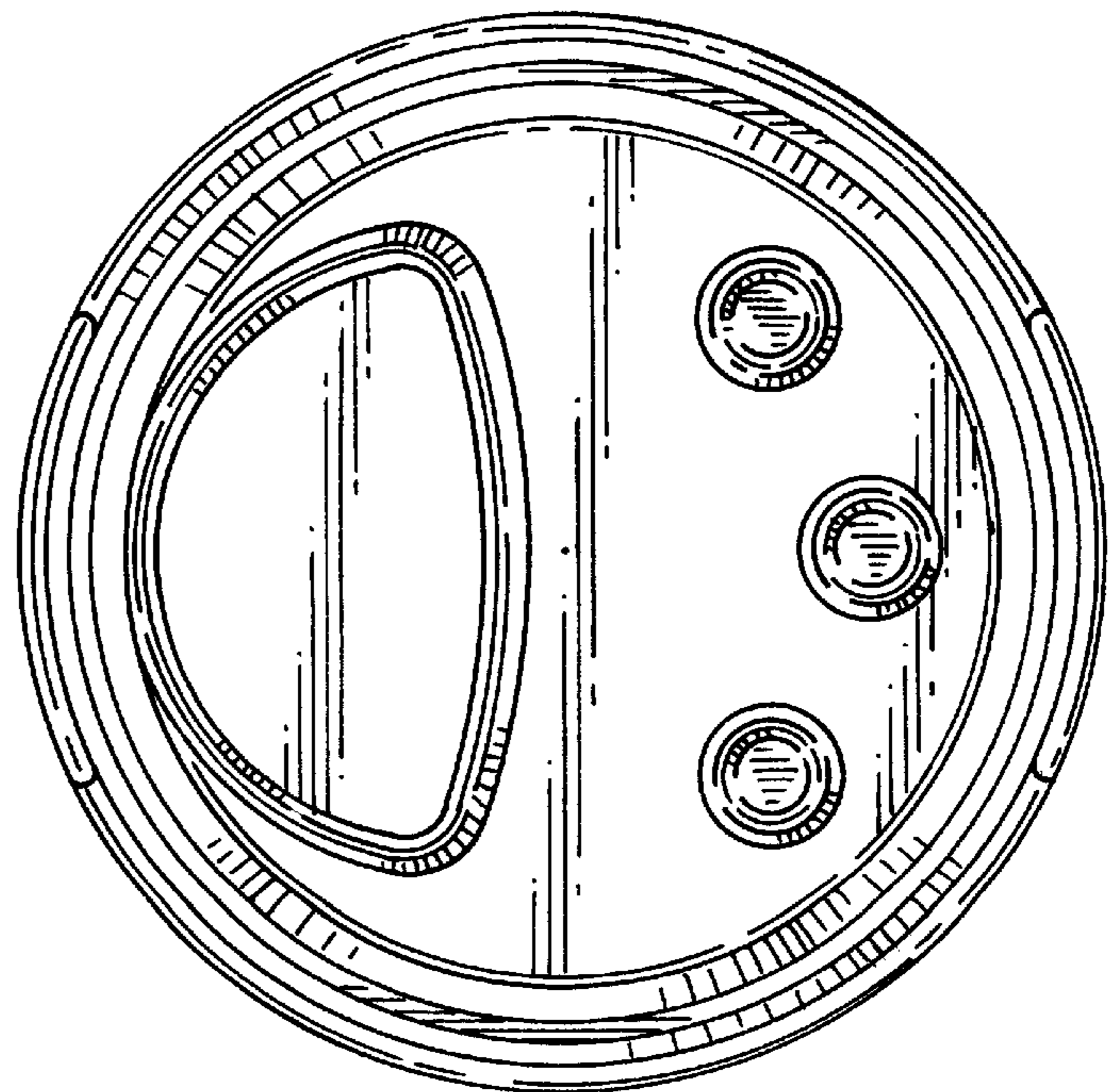

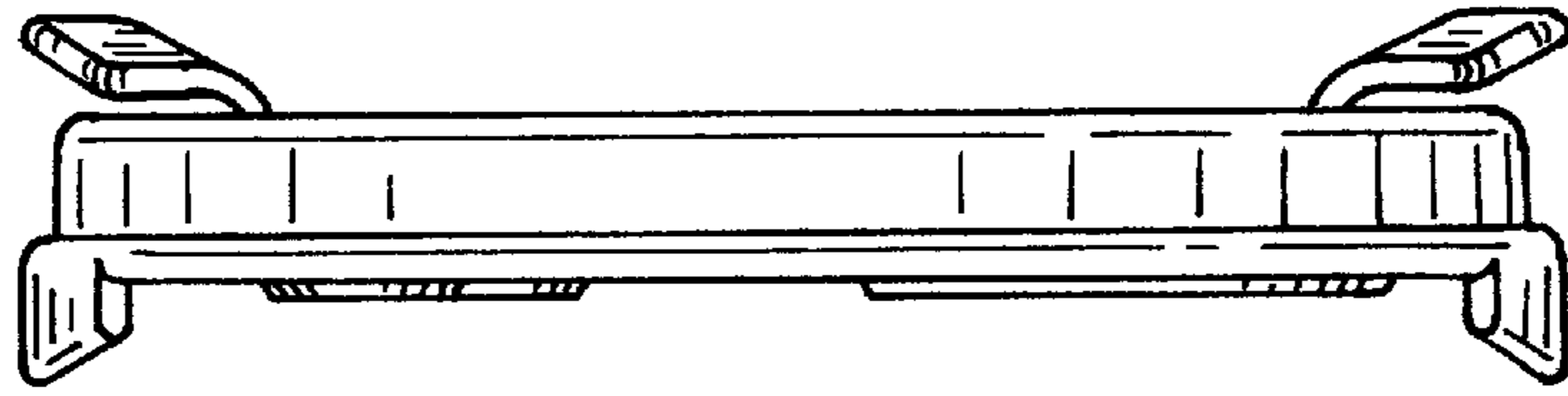

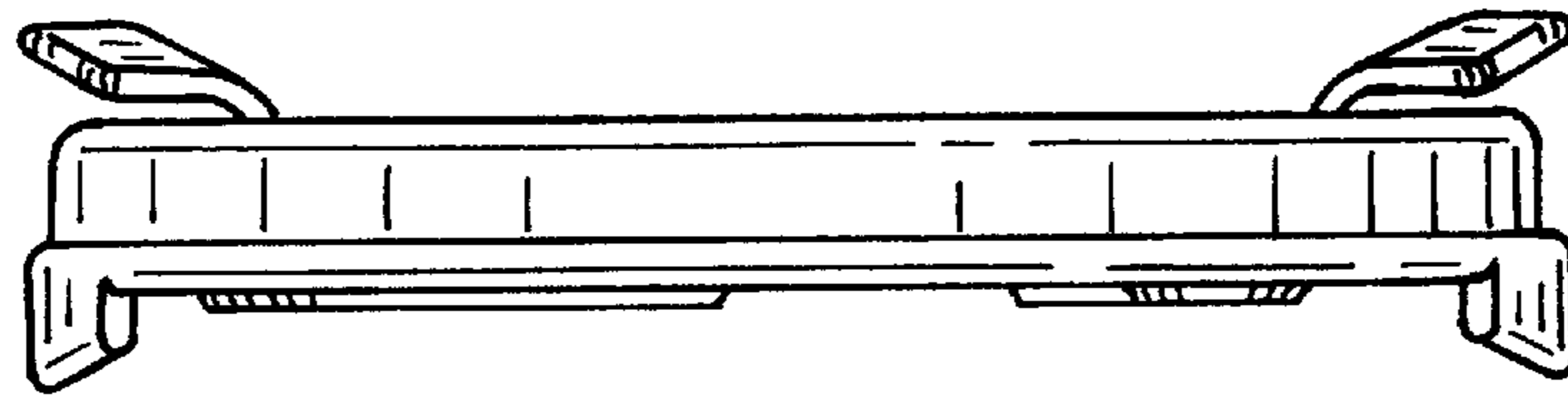

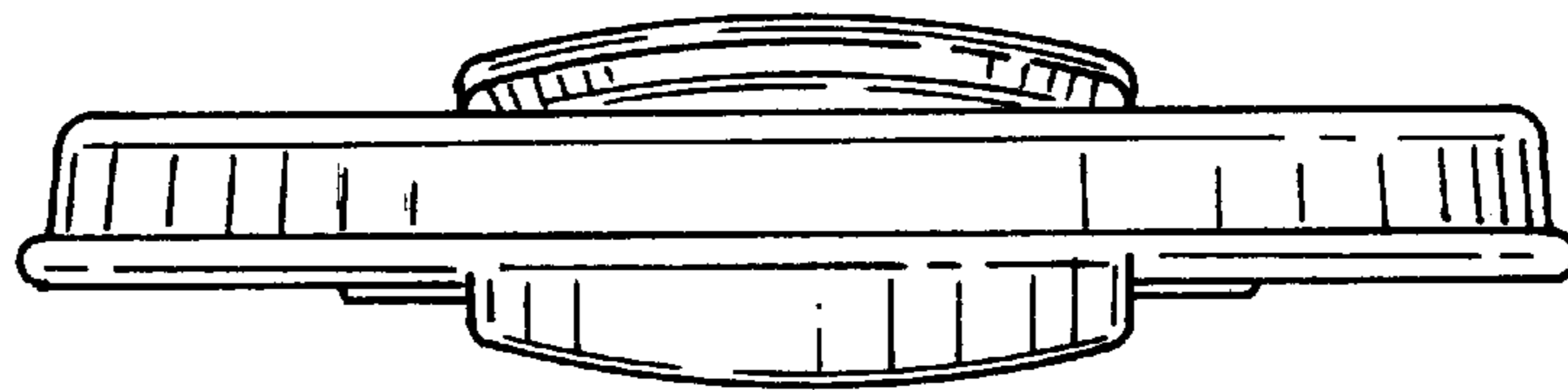

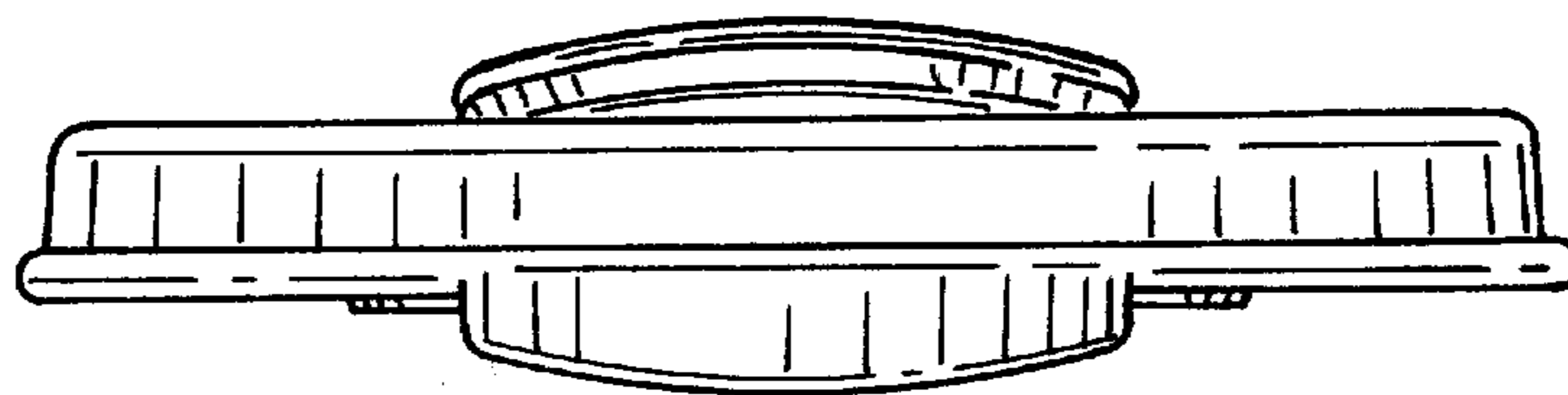
