[57] **CLAIM**

The ornamental design for telephone headset amplifier unit, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a telephone headset amplifier unit showing the present invention; FIG. 2 is a left side elevational view thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a right side elevational view thereof; FIG. 5 is a front elevational view thereof; FIG. 6 is a rear elevational view thereof; FIG. 7 is a bottom plan view thereof; and, FIG. 8 is the perspective view of FIG. 1 including a desktop telephone shown on top of the amplifier unit, the desktop telephone is shown in broken lines for illustrative purposes only and forms no part of the claimed design.

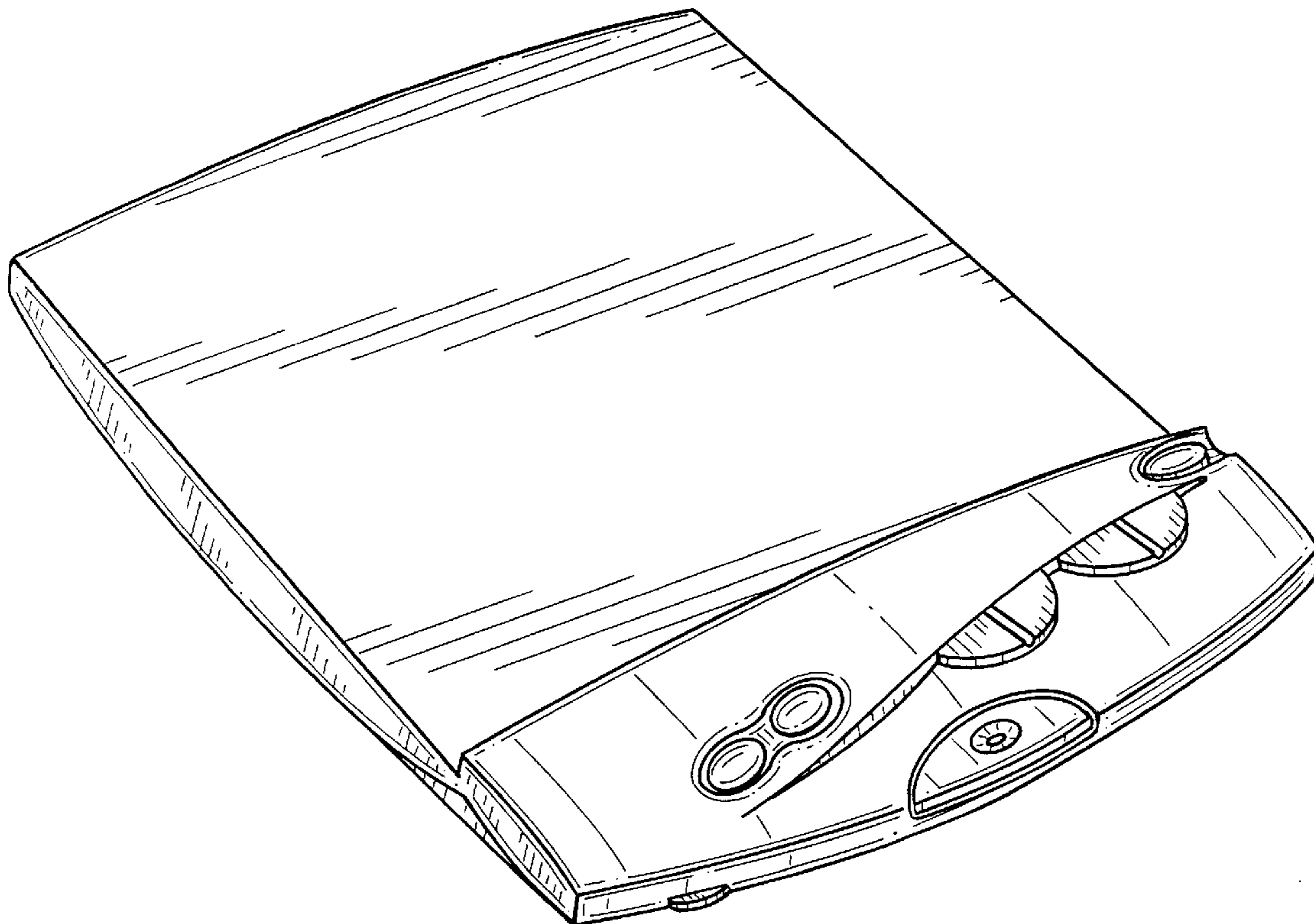

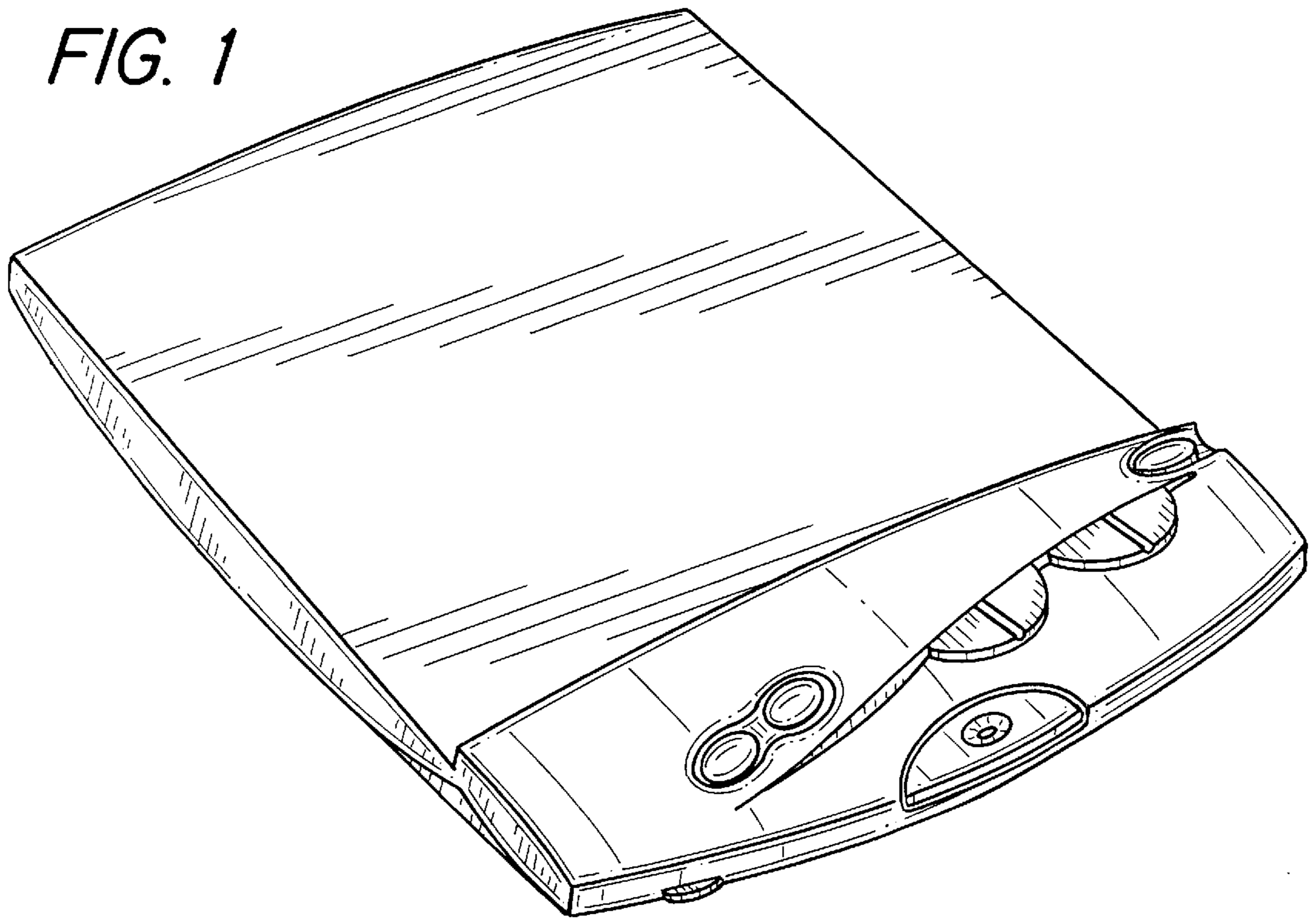

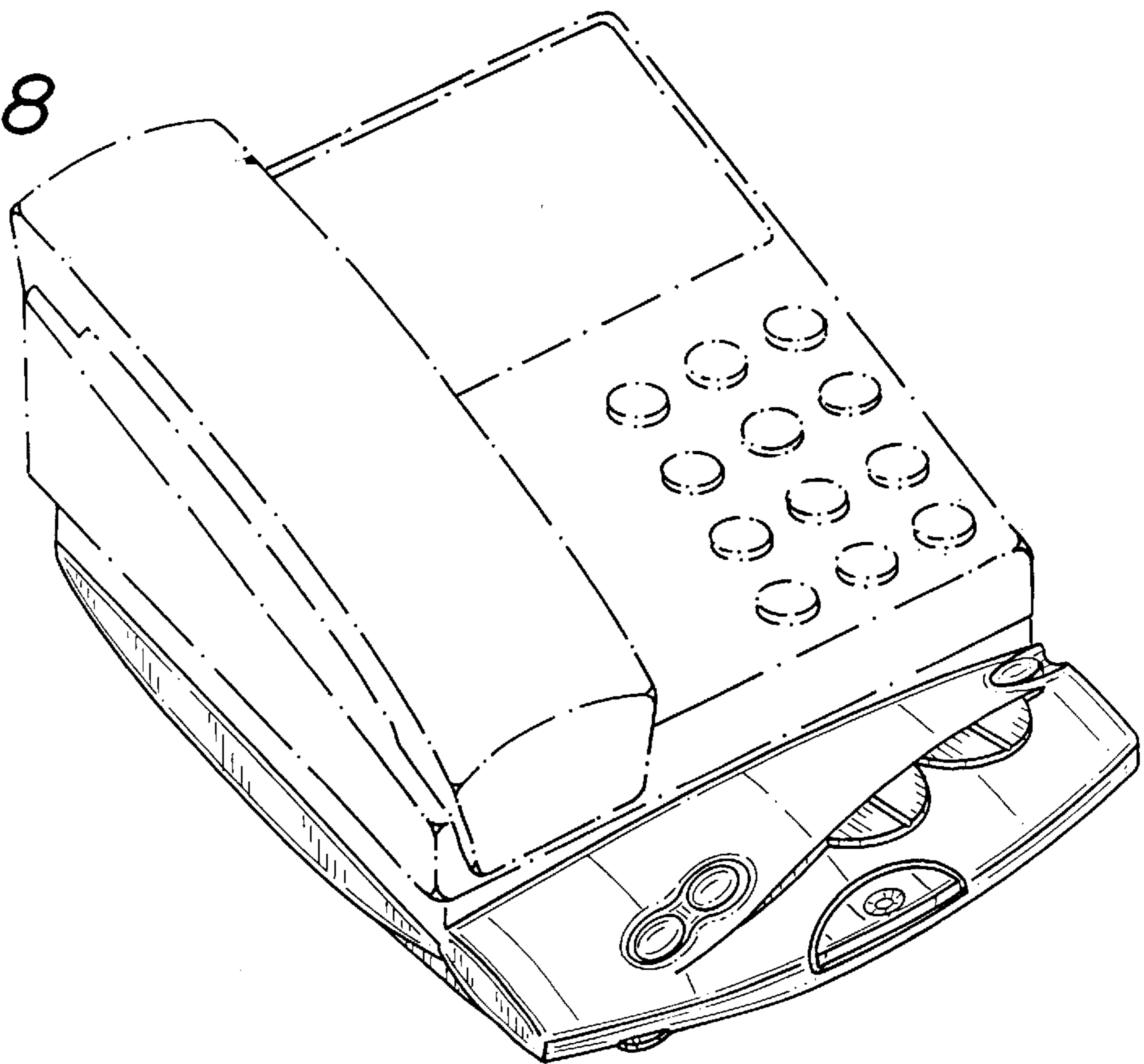

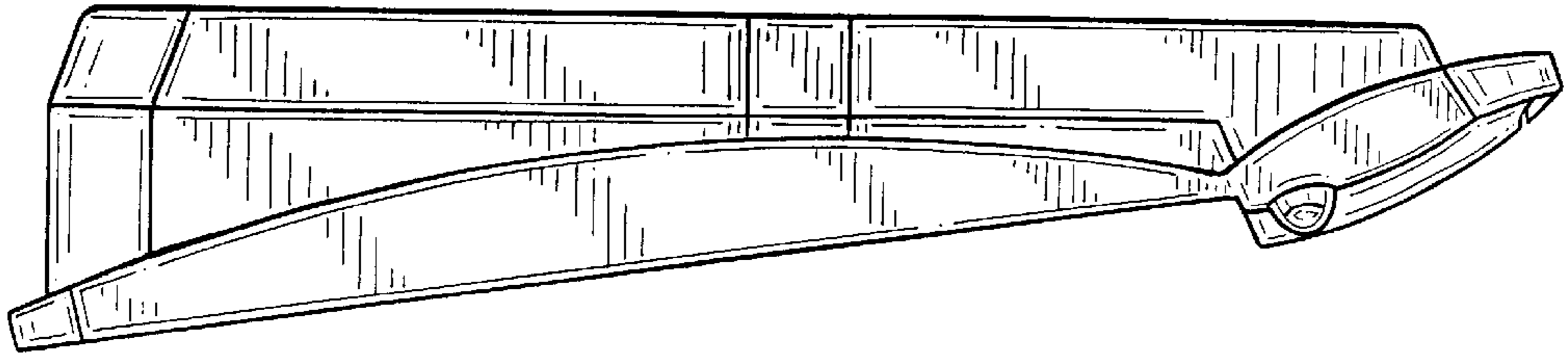

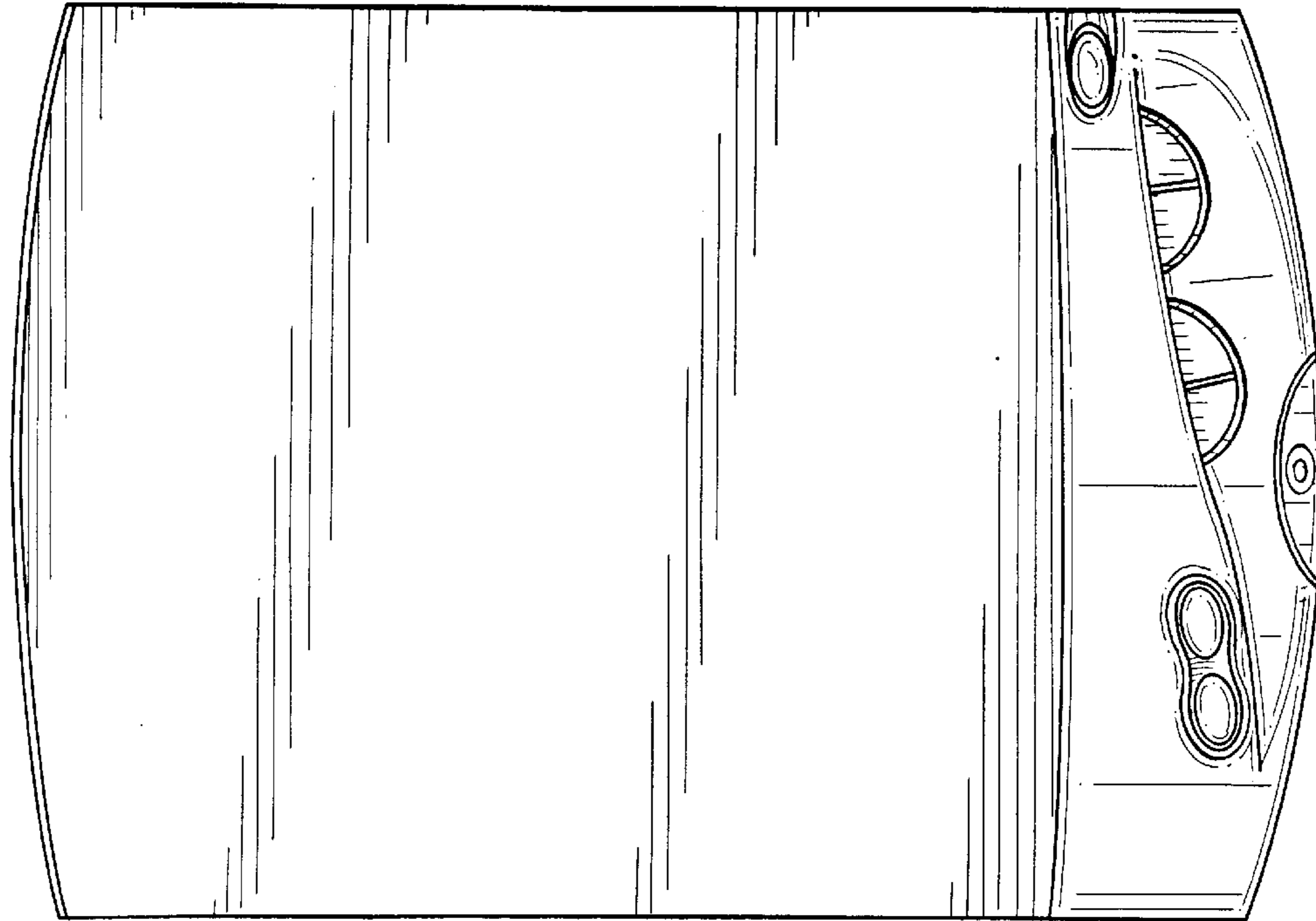

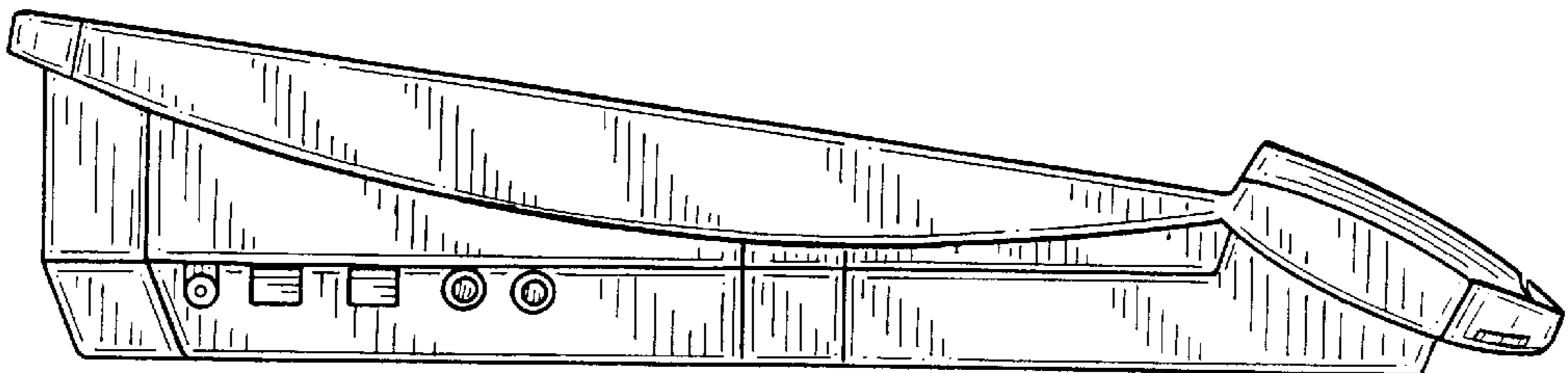

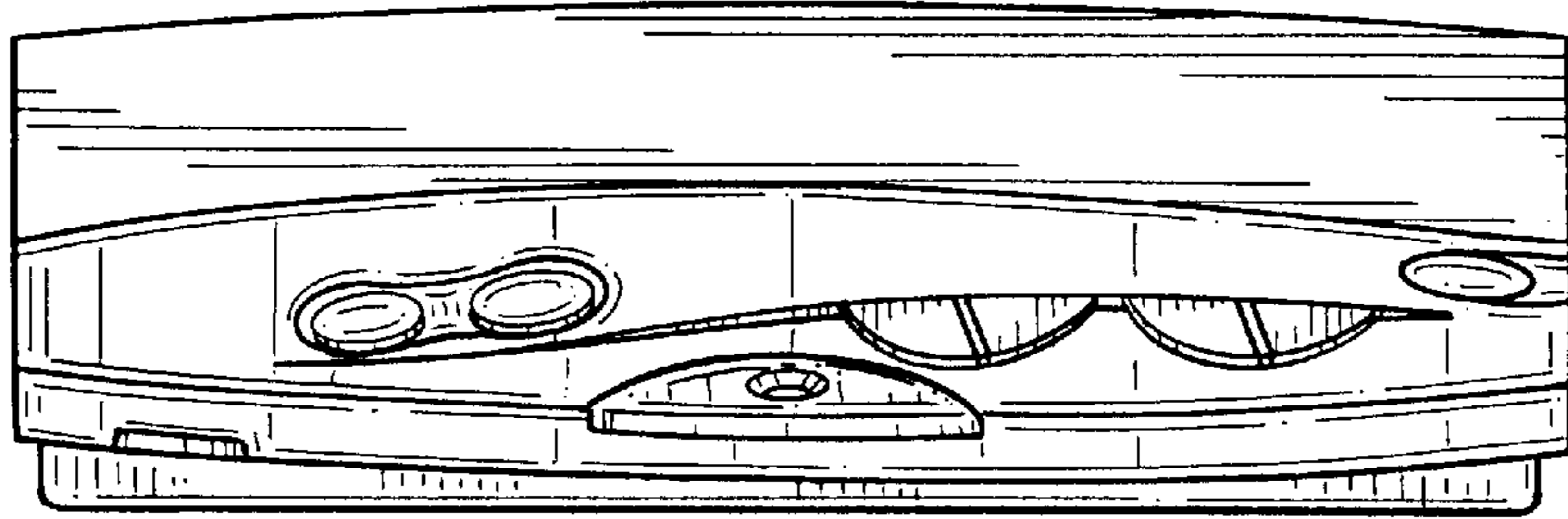
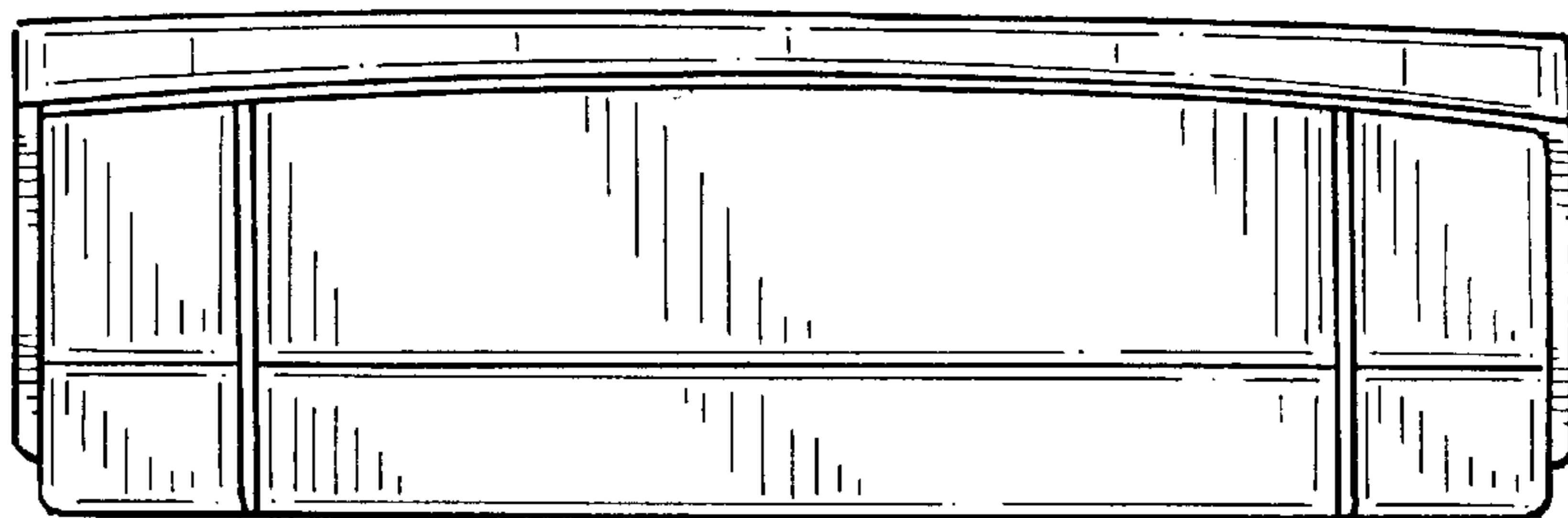

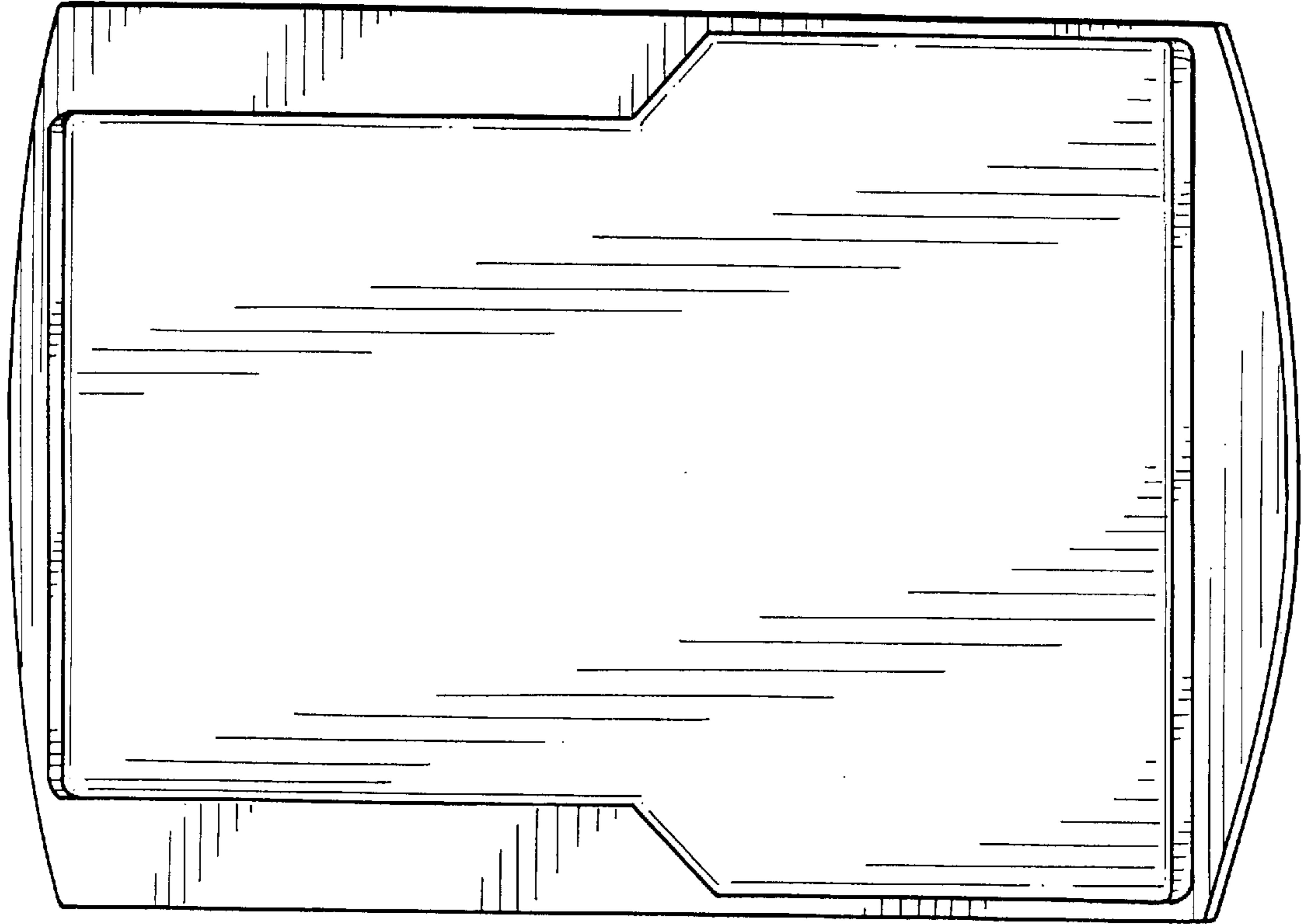
