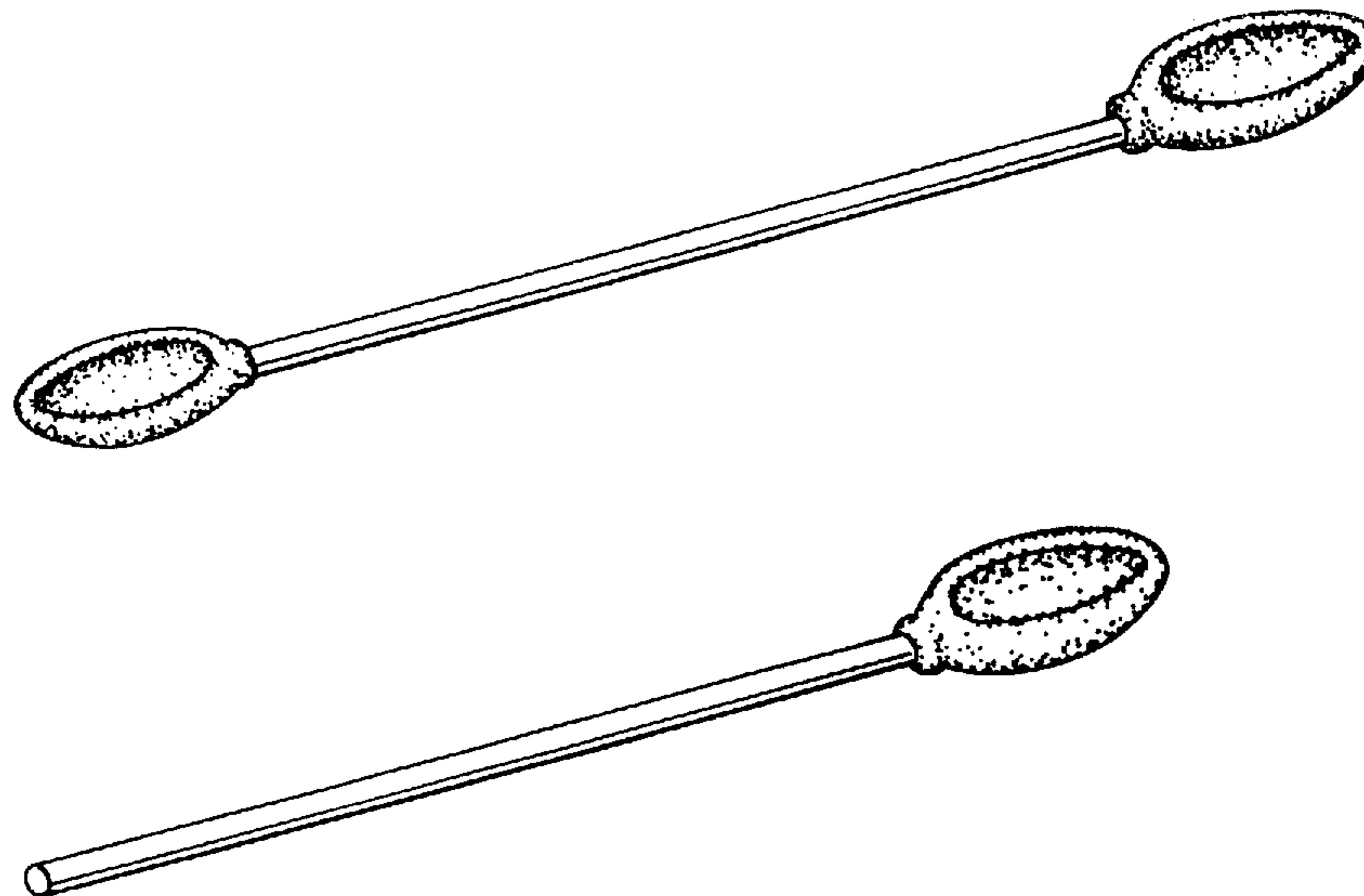
[57] CLAIM

The ornamental design for an absorbent swab, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an absorbent swab showing a first form of my new design;
FIG. 2 is a top view thereof;
FIG. 3 is a bottom view thereof;
FIG. 4 is a front view thereof with the rear view being a mirror image thereof;
FIG. 5 is a left side view thereof;
FIG. 6 is a right side view thereof; and,
FIG. 7 is a perspective view of a second form of my absorbent swab.

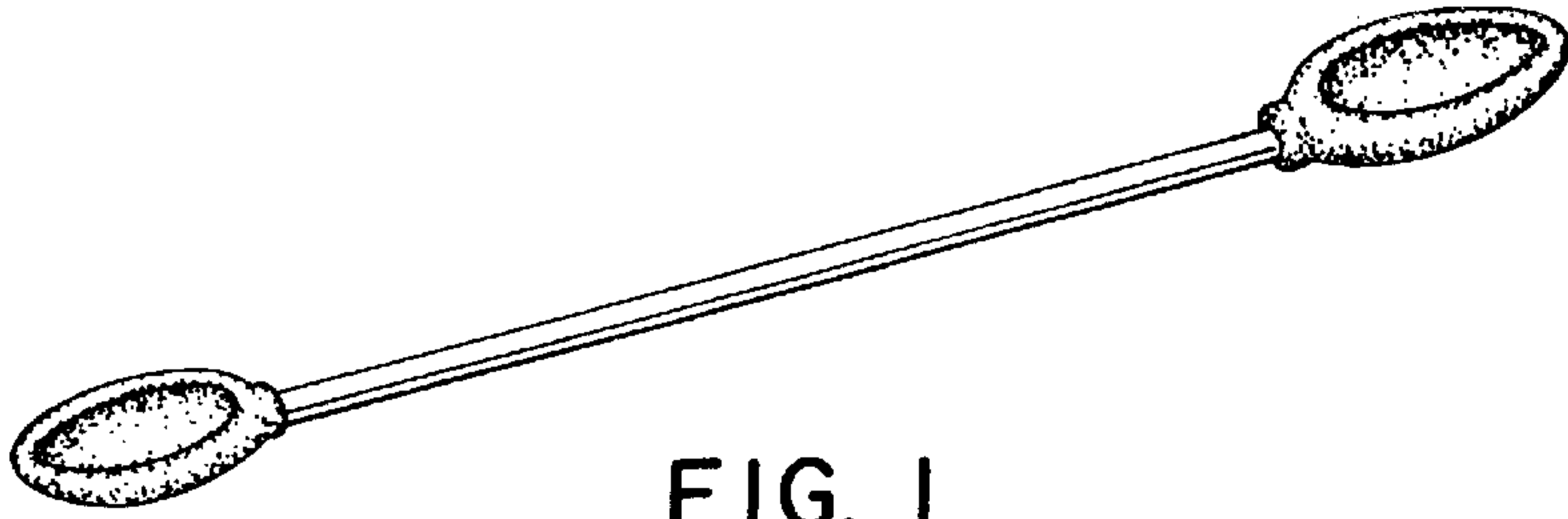

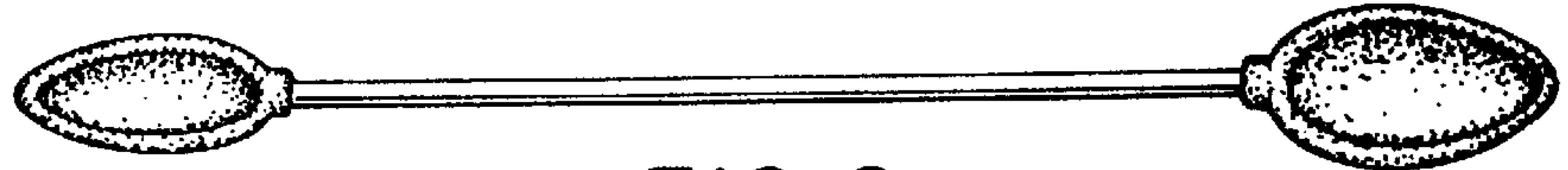

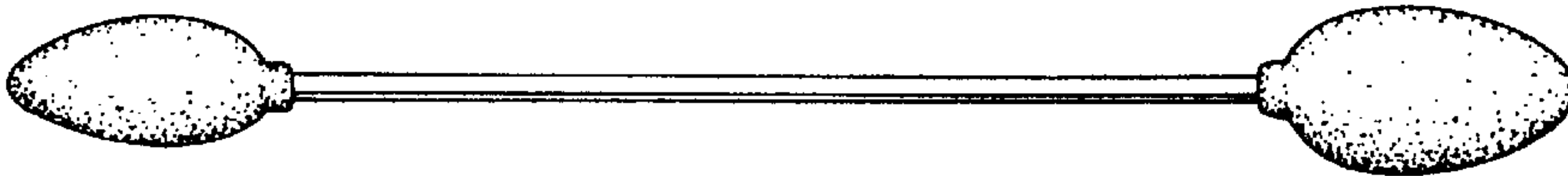

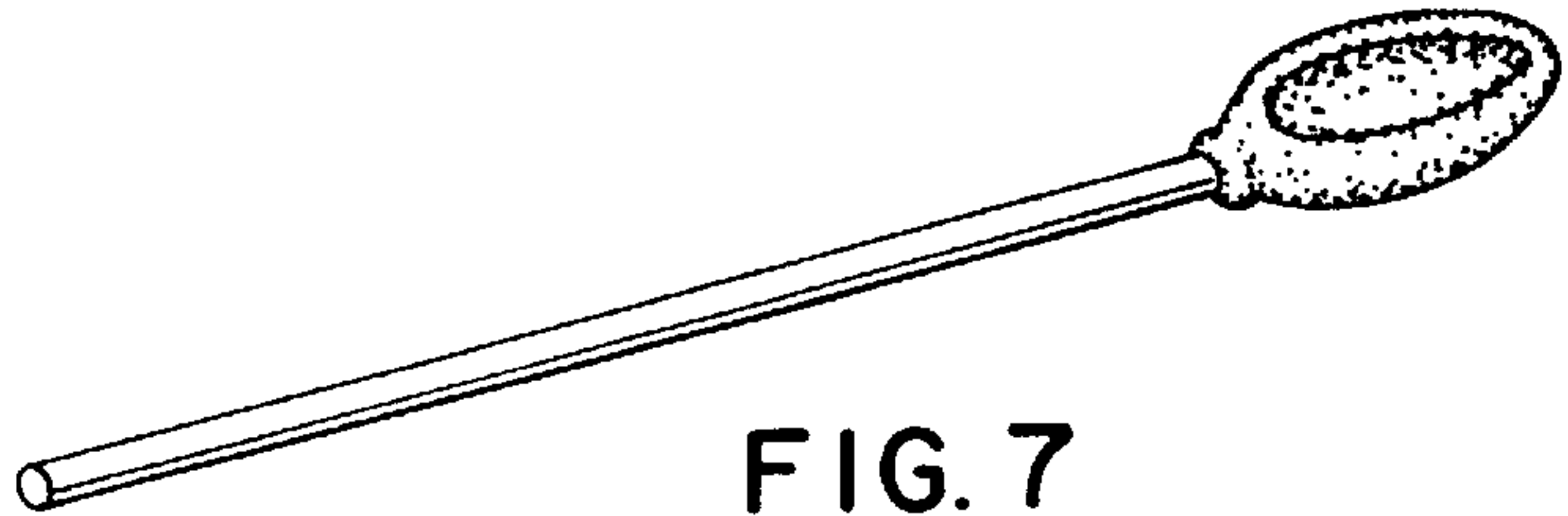
