[57] **CLAIM**

The ornamental design for a contoured arm seat, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the contoured arm seat showing my new design;

FIG. 2 is a right side elevational view, the left side being a mere image thereof;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a rear elevational view thereof;

FIG. 5 is a perspective view of a second embodiment of a contoured arm seat showing my new design in the form of a loveseat;

FIG. 6 is a left side elevational view of FIG. 5, the right side being a mere image thereof;

FIG. 7 is a front elevational view of FIG. 5;

FIG. 8 is a rear elevational view of FIG. 5;

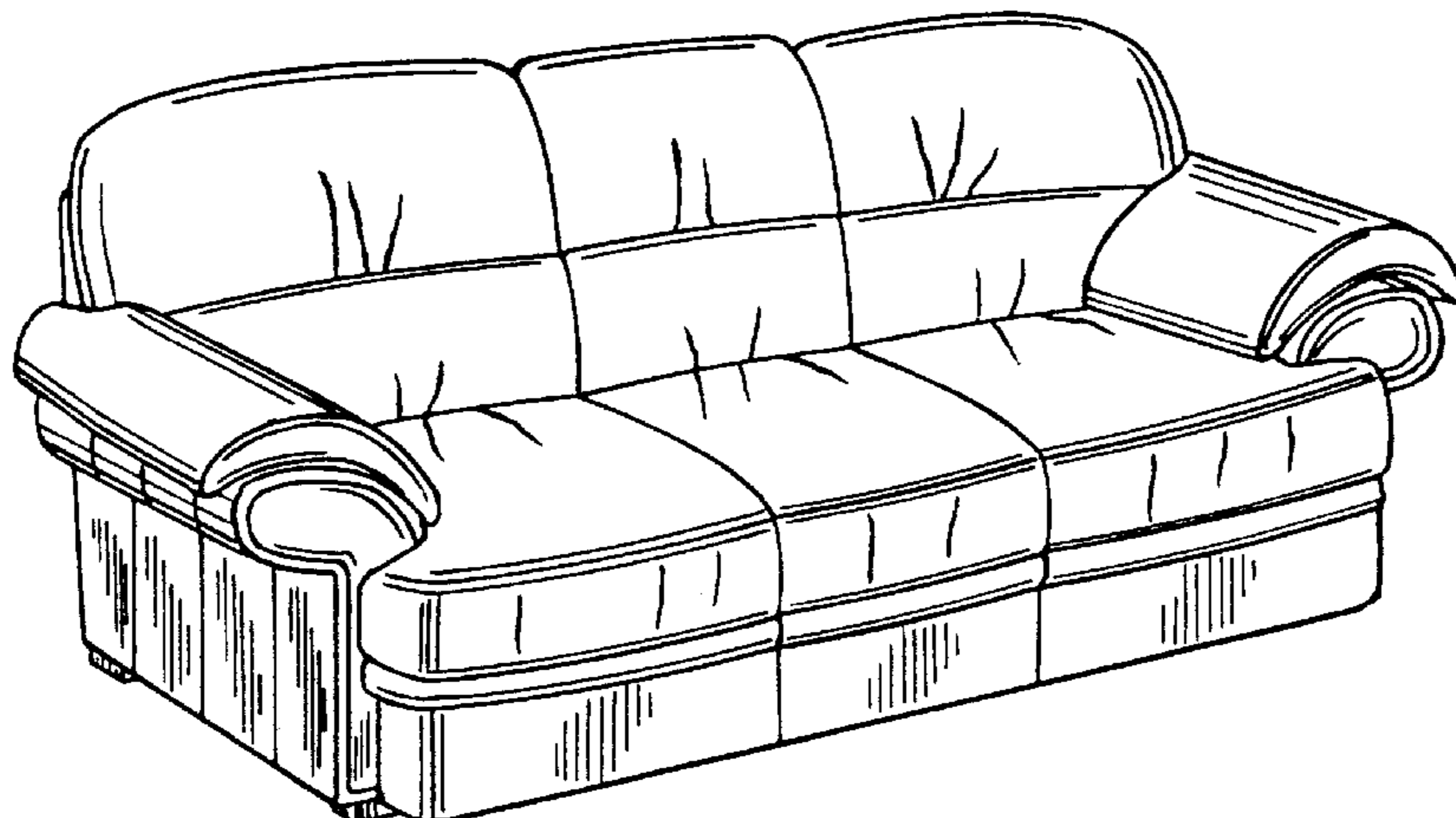
FIG. 9 is a perspective view of a third embodiment of a contoured arm seat showing my new design in the form of a chair;

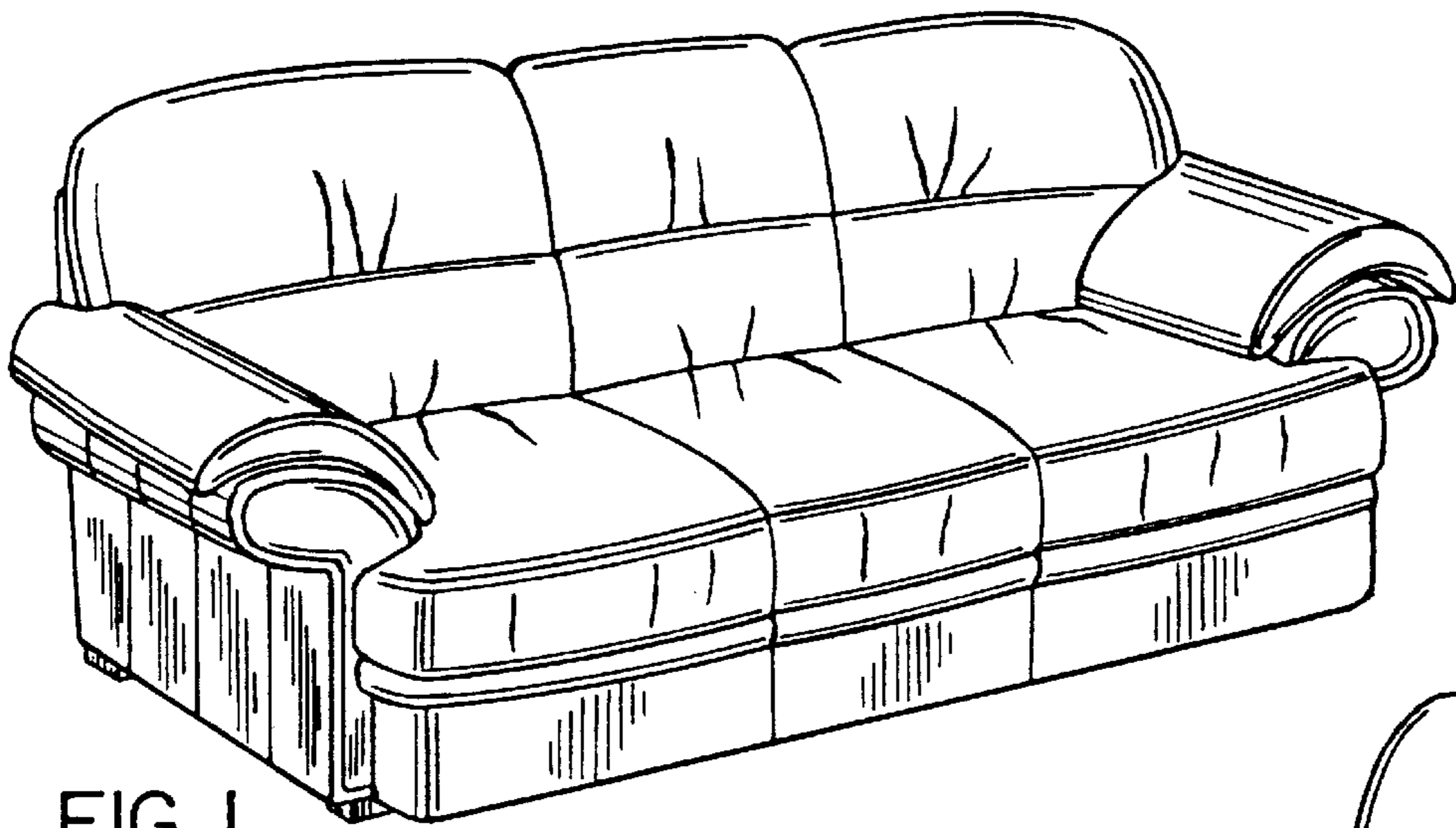

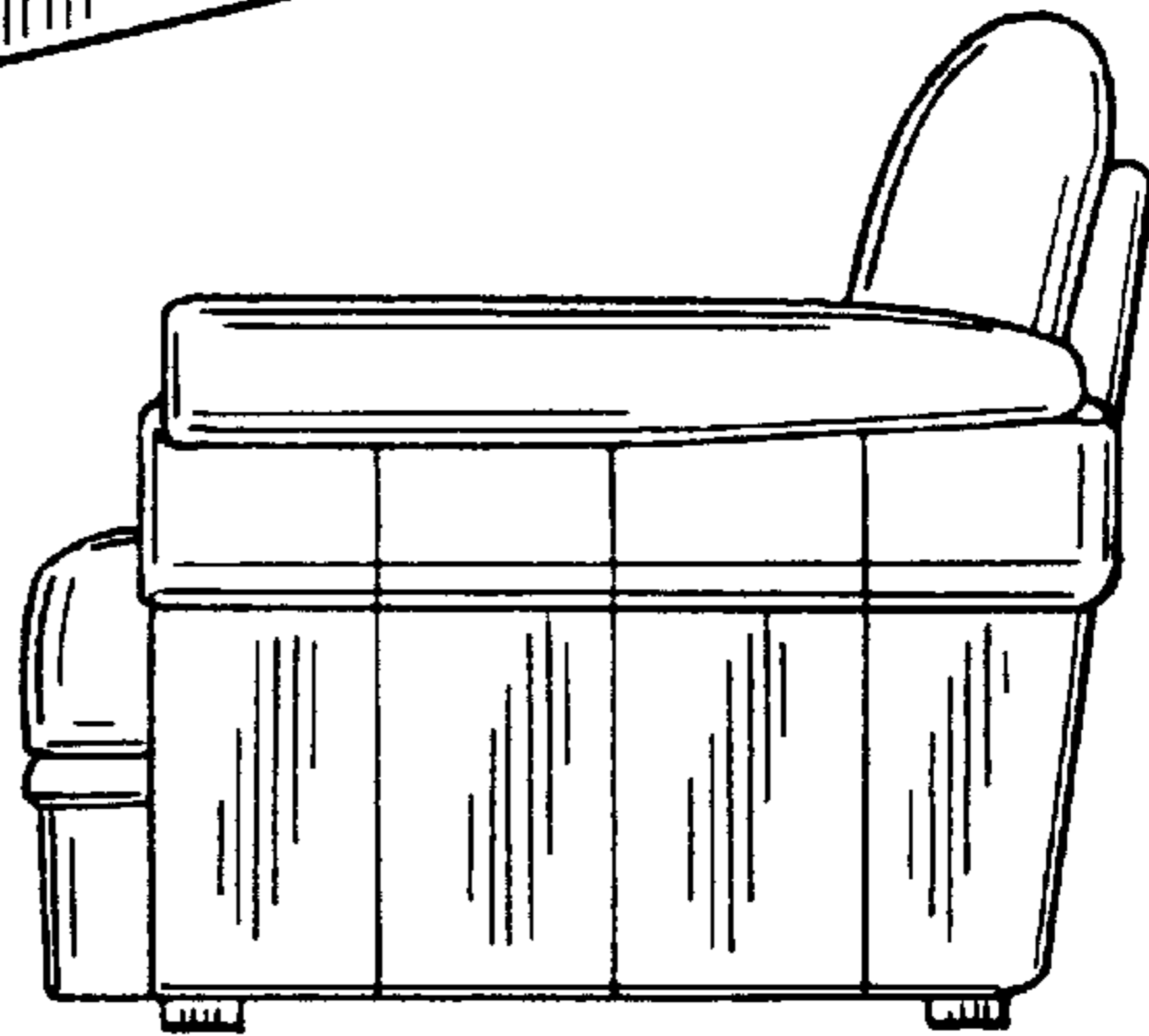

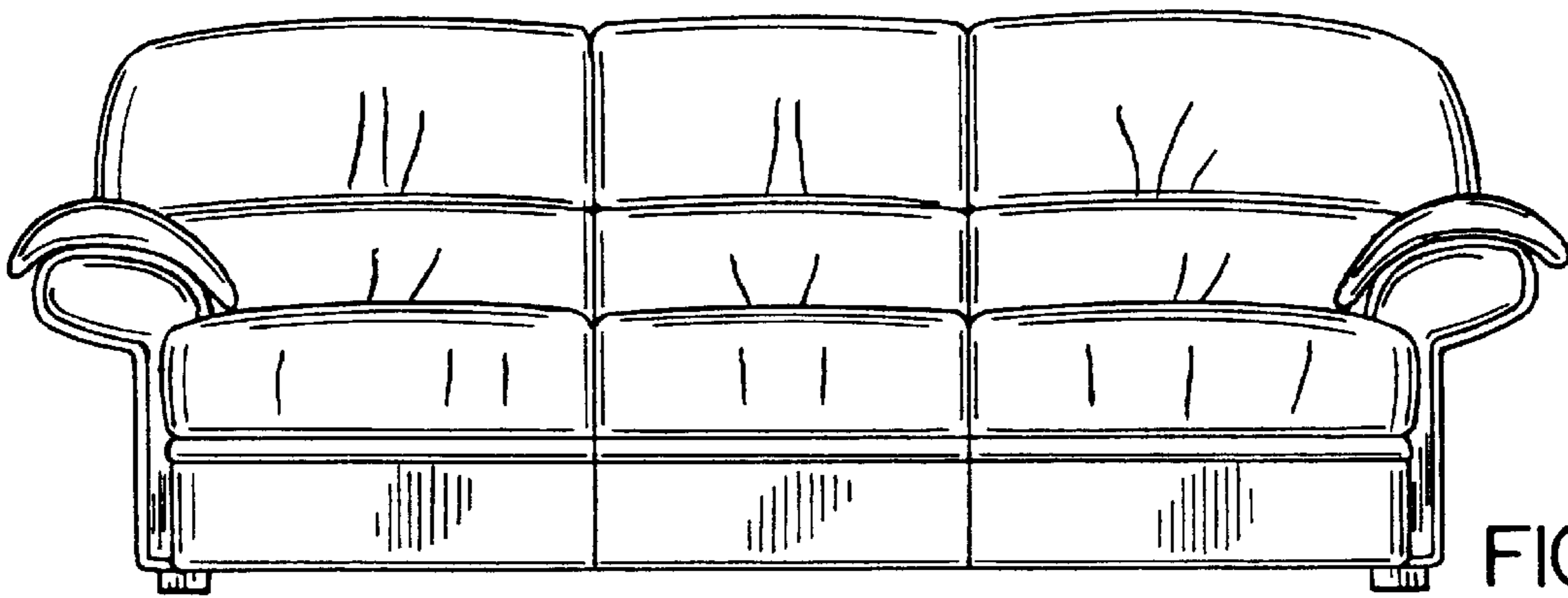

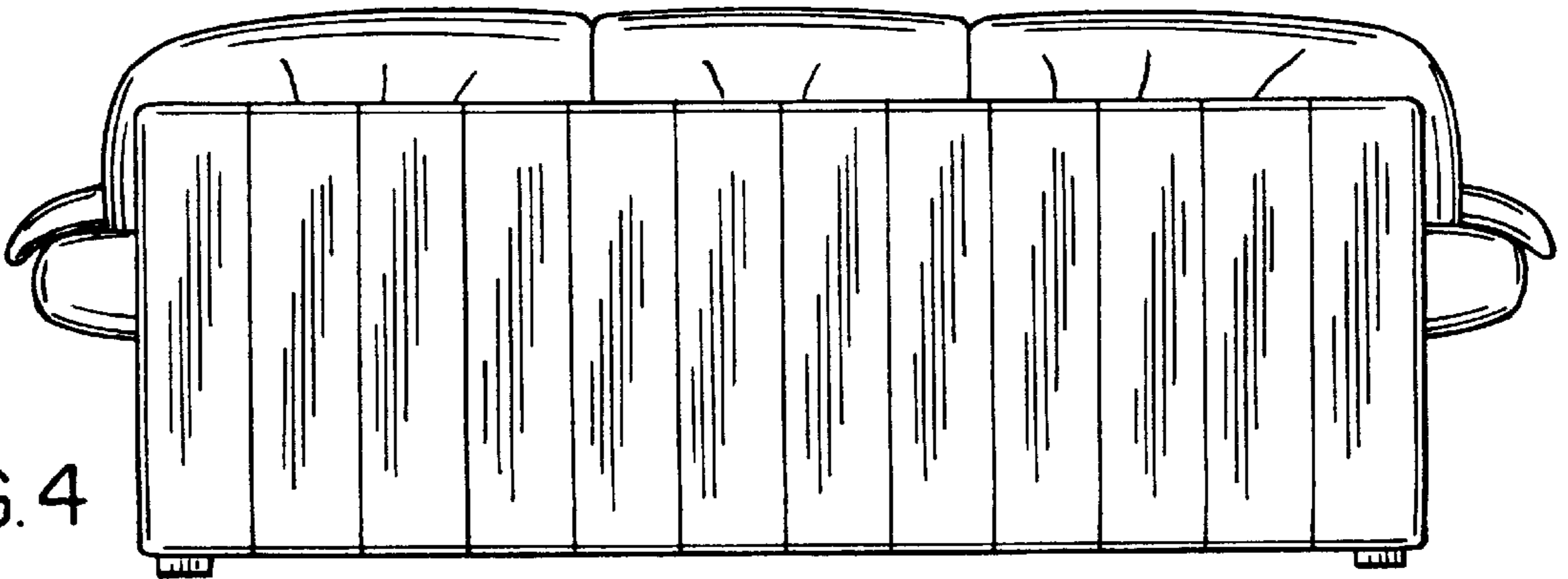

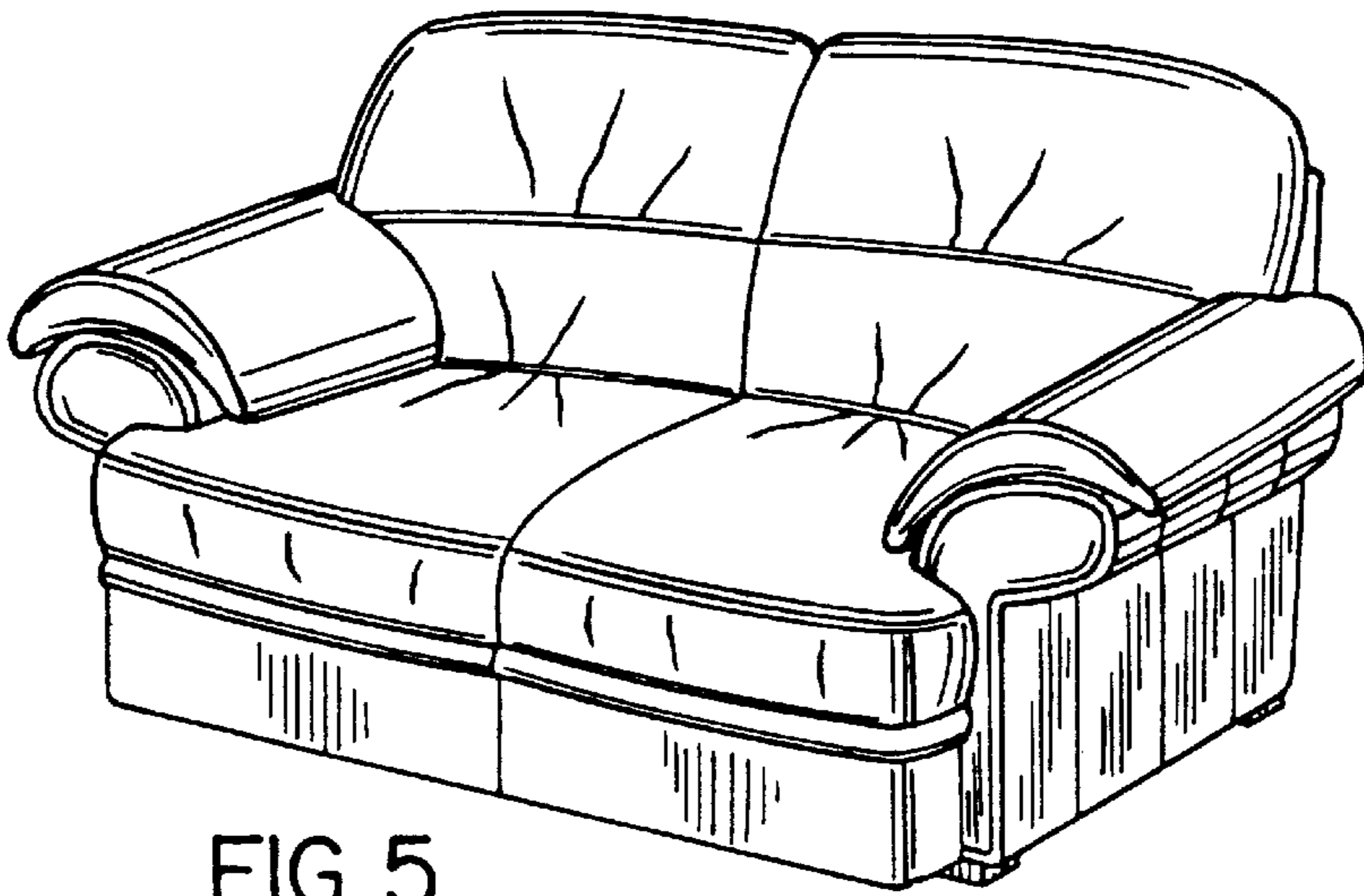

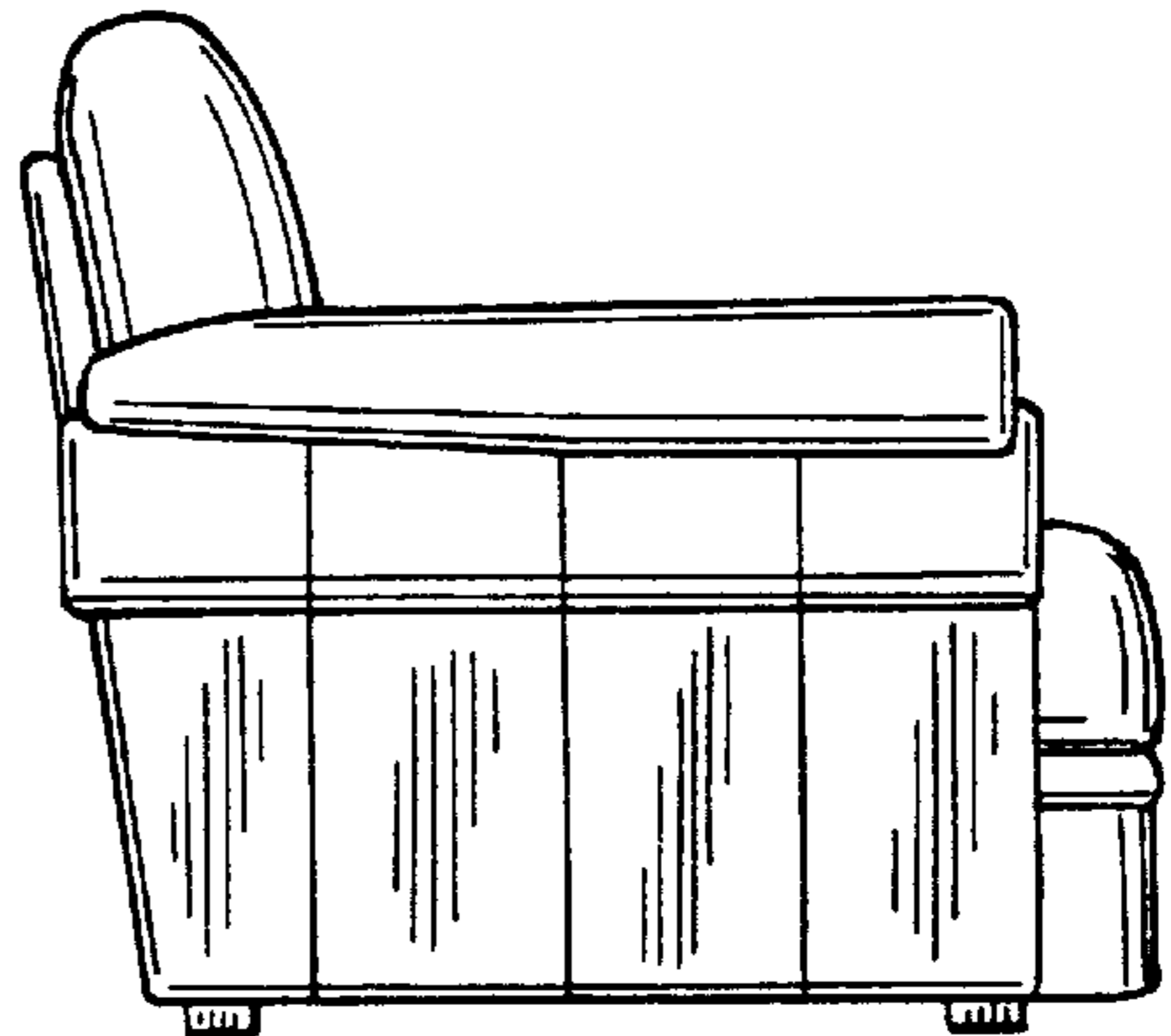

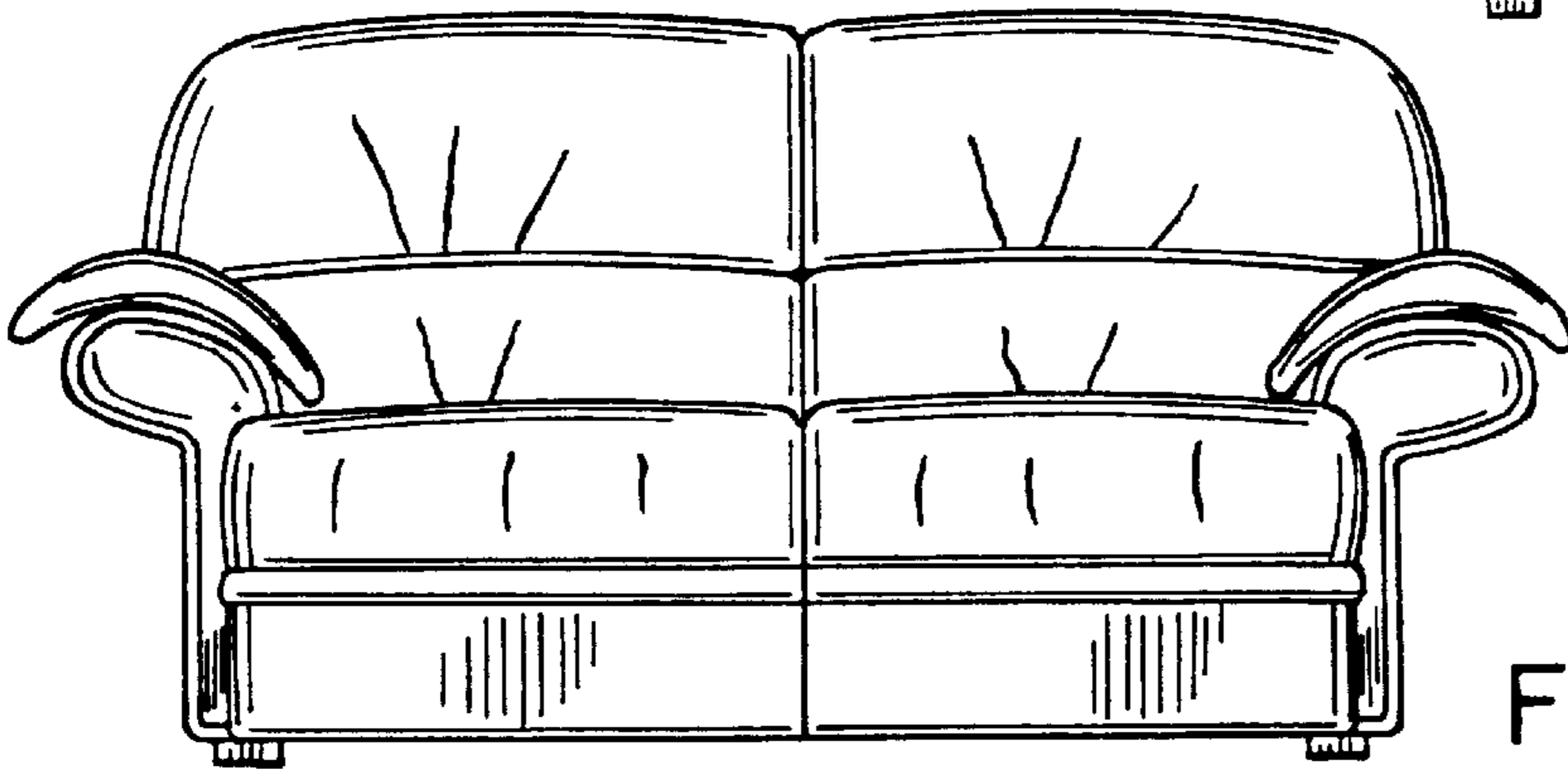

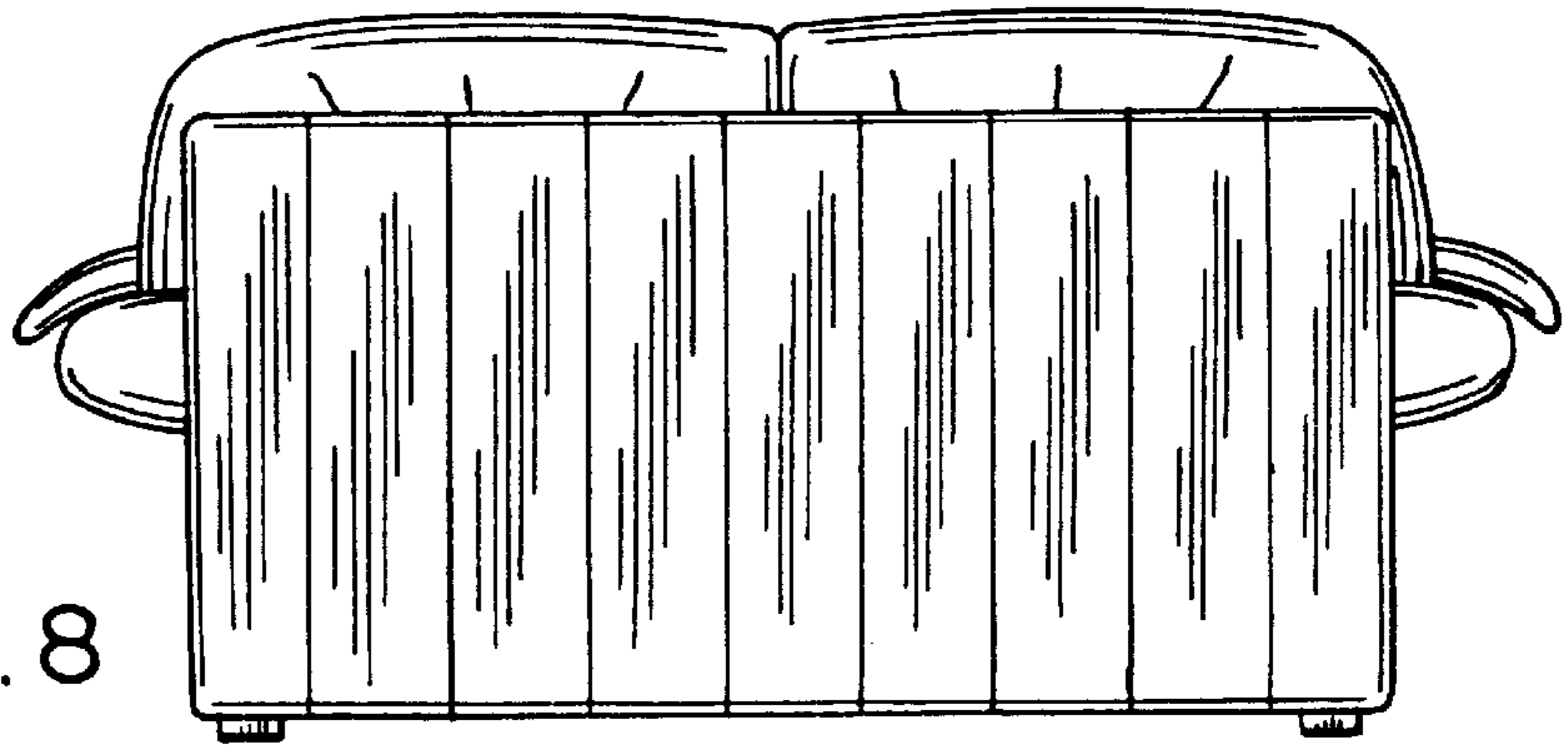

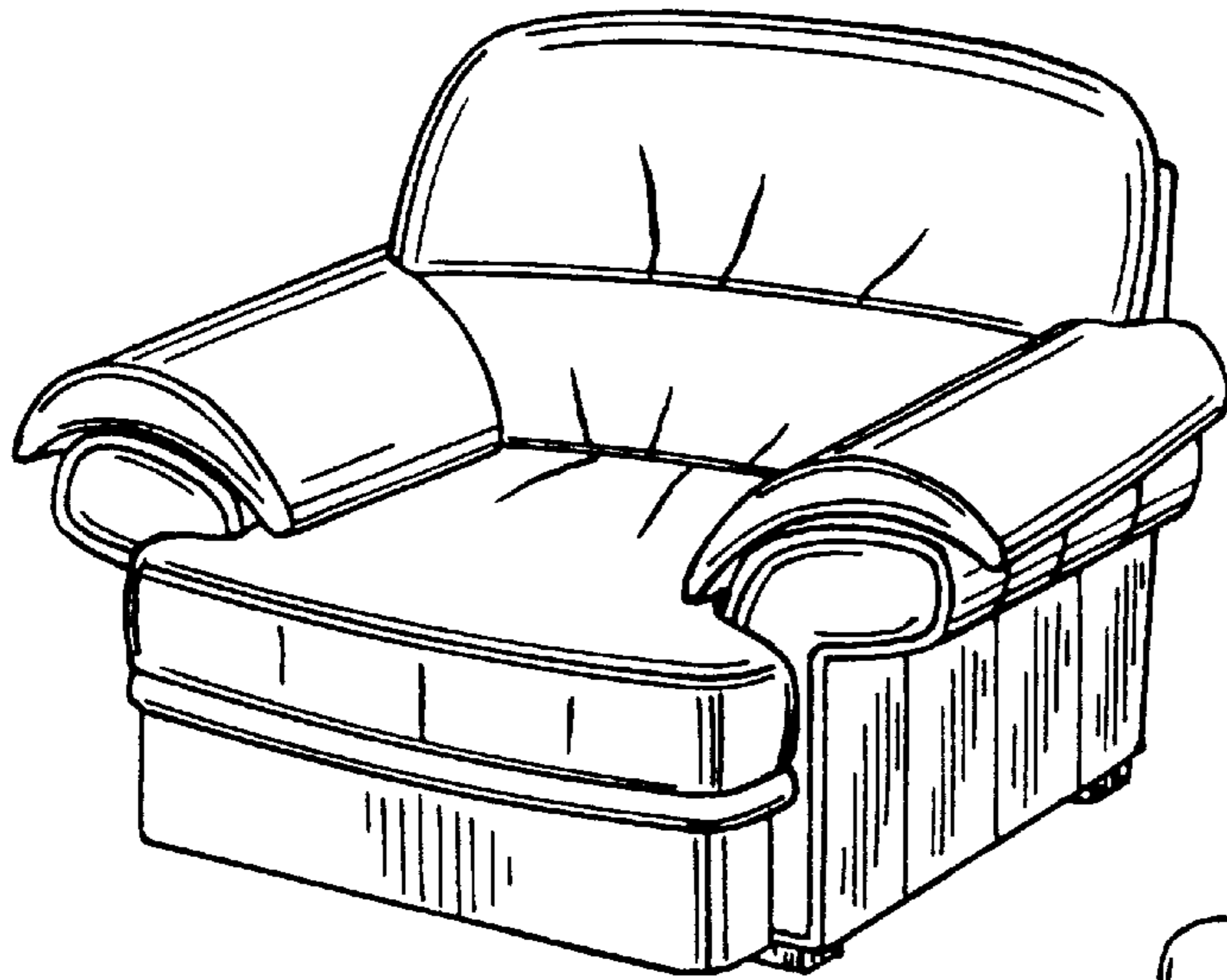

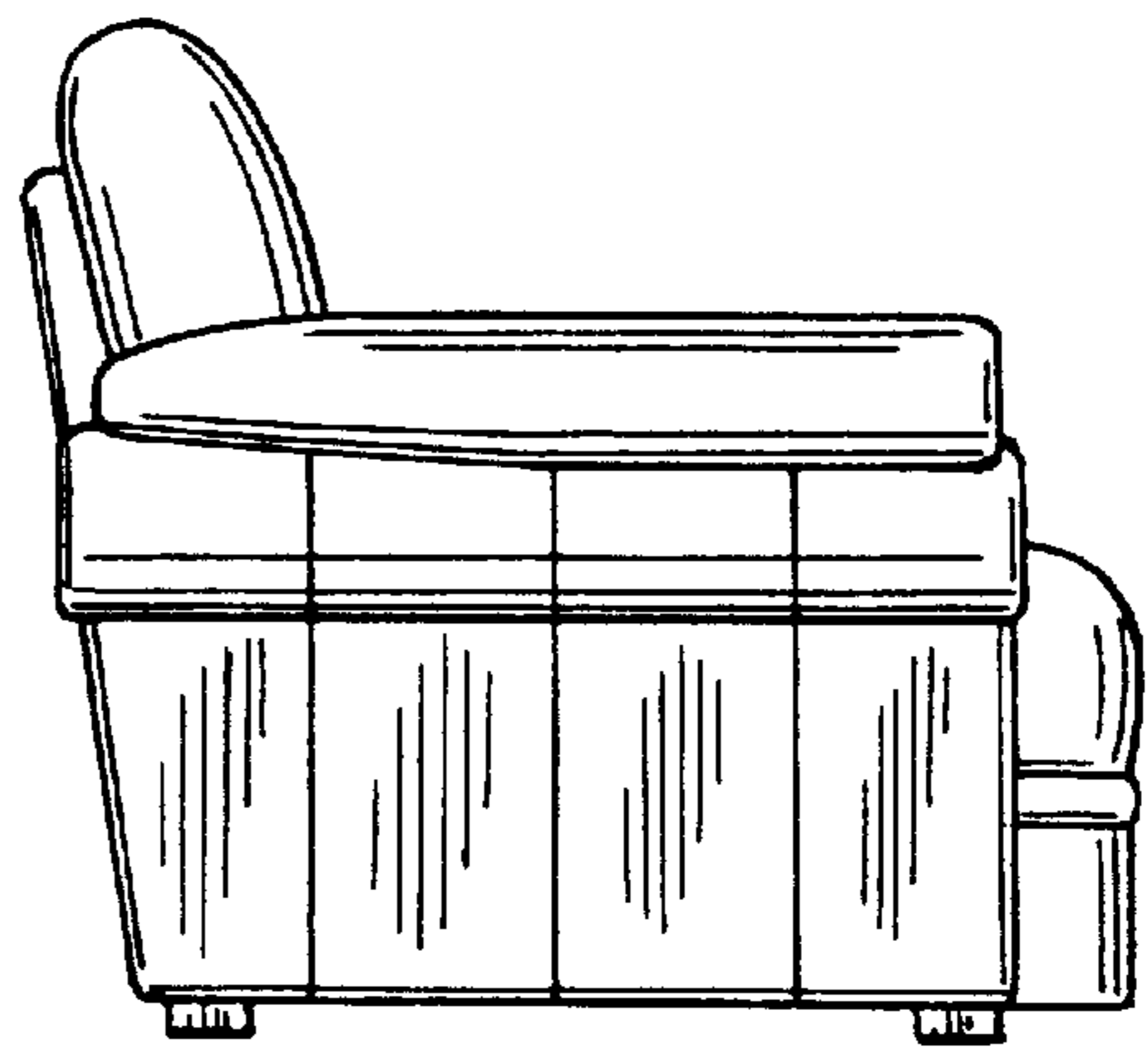

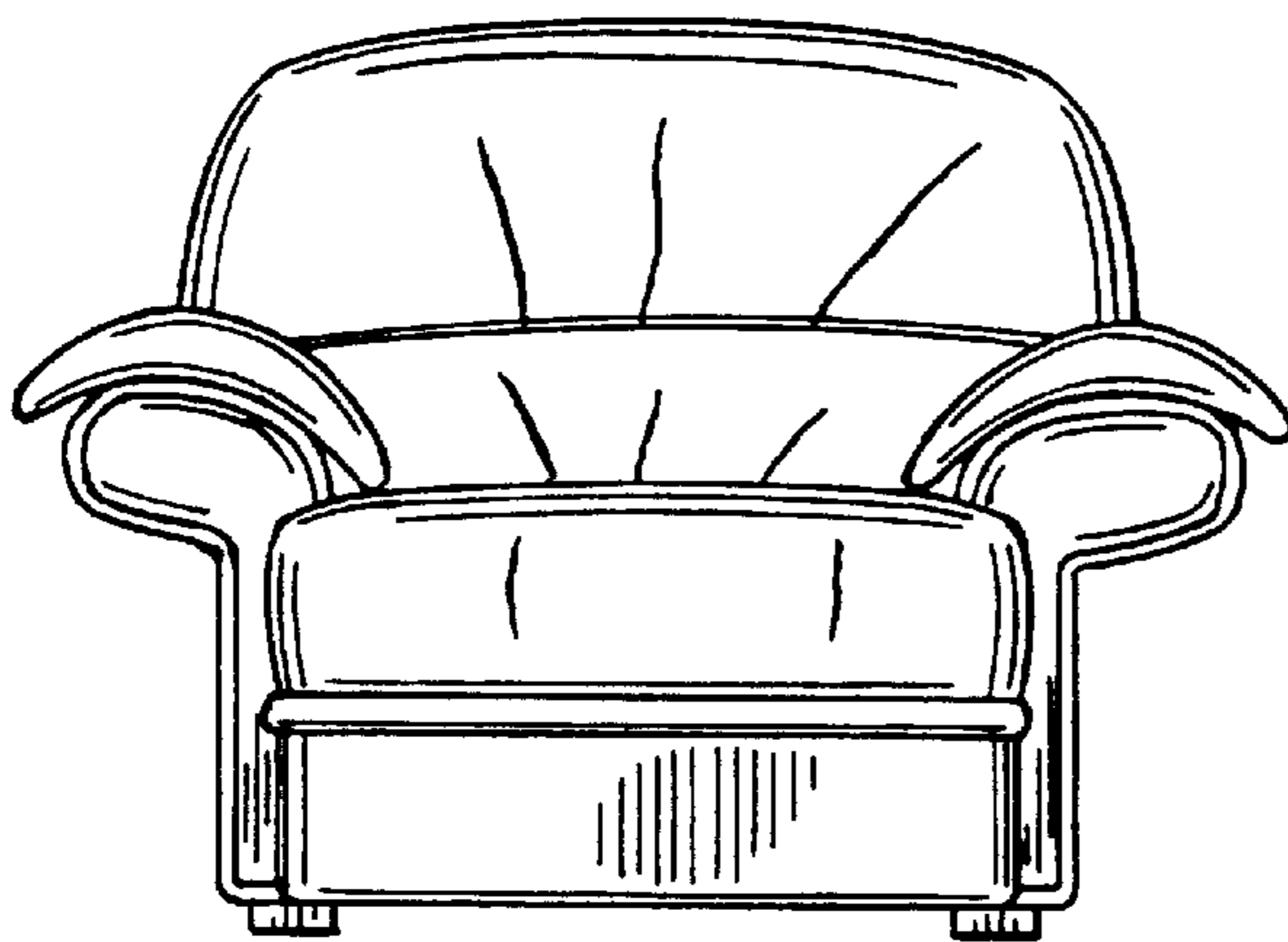

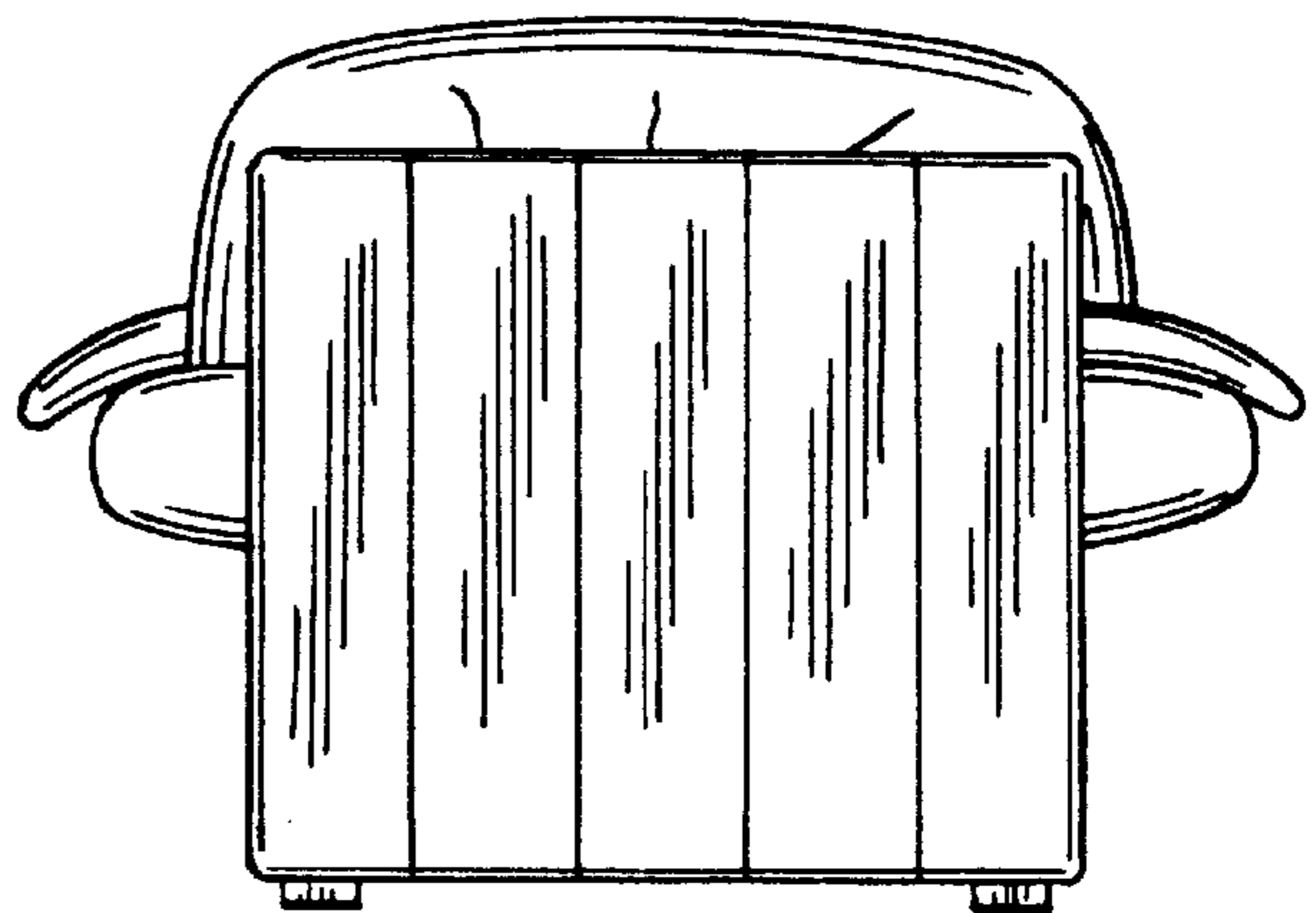

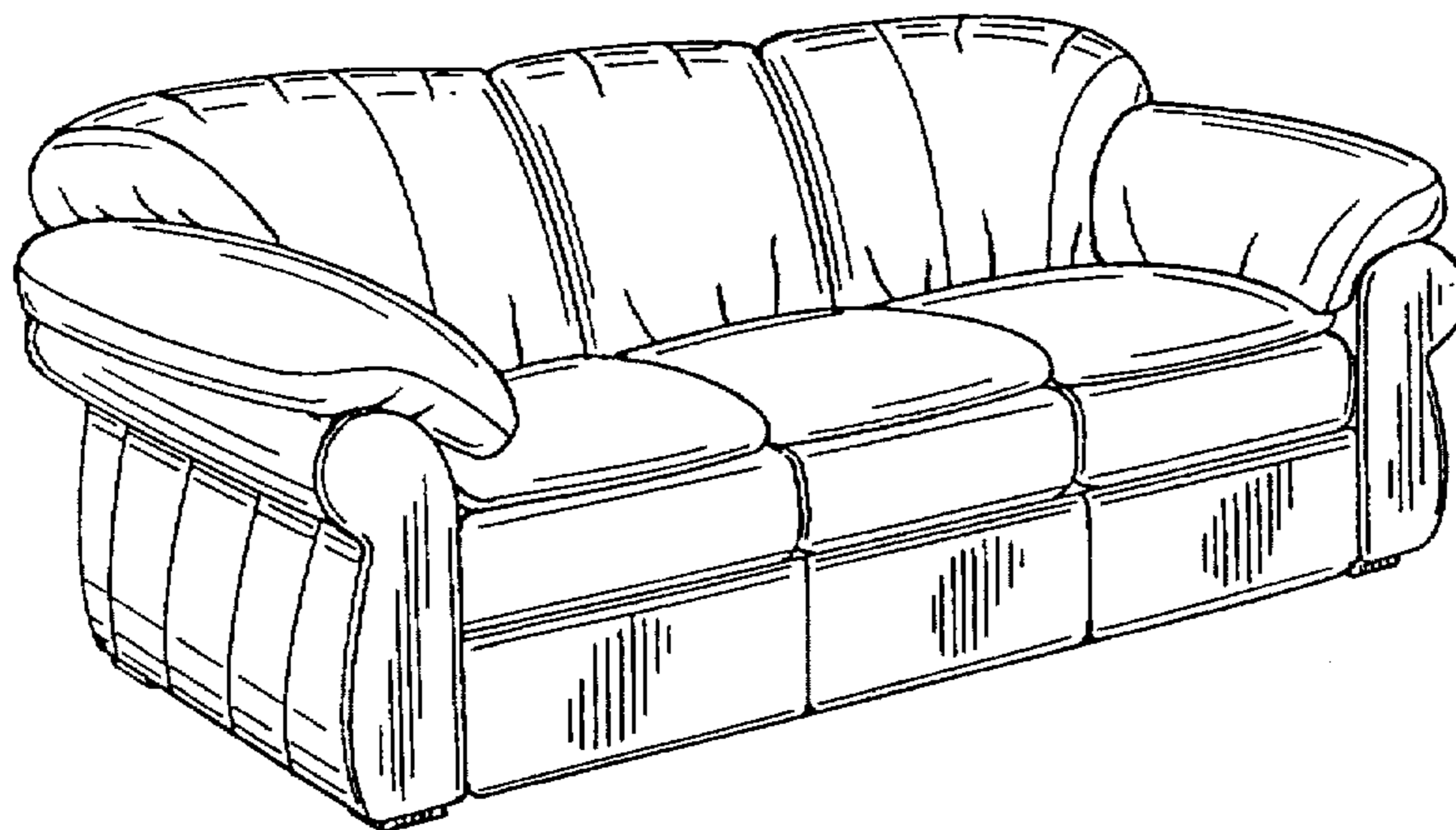

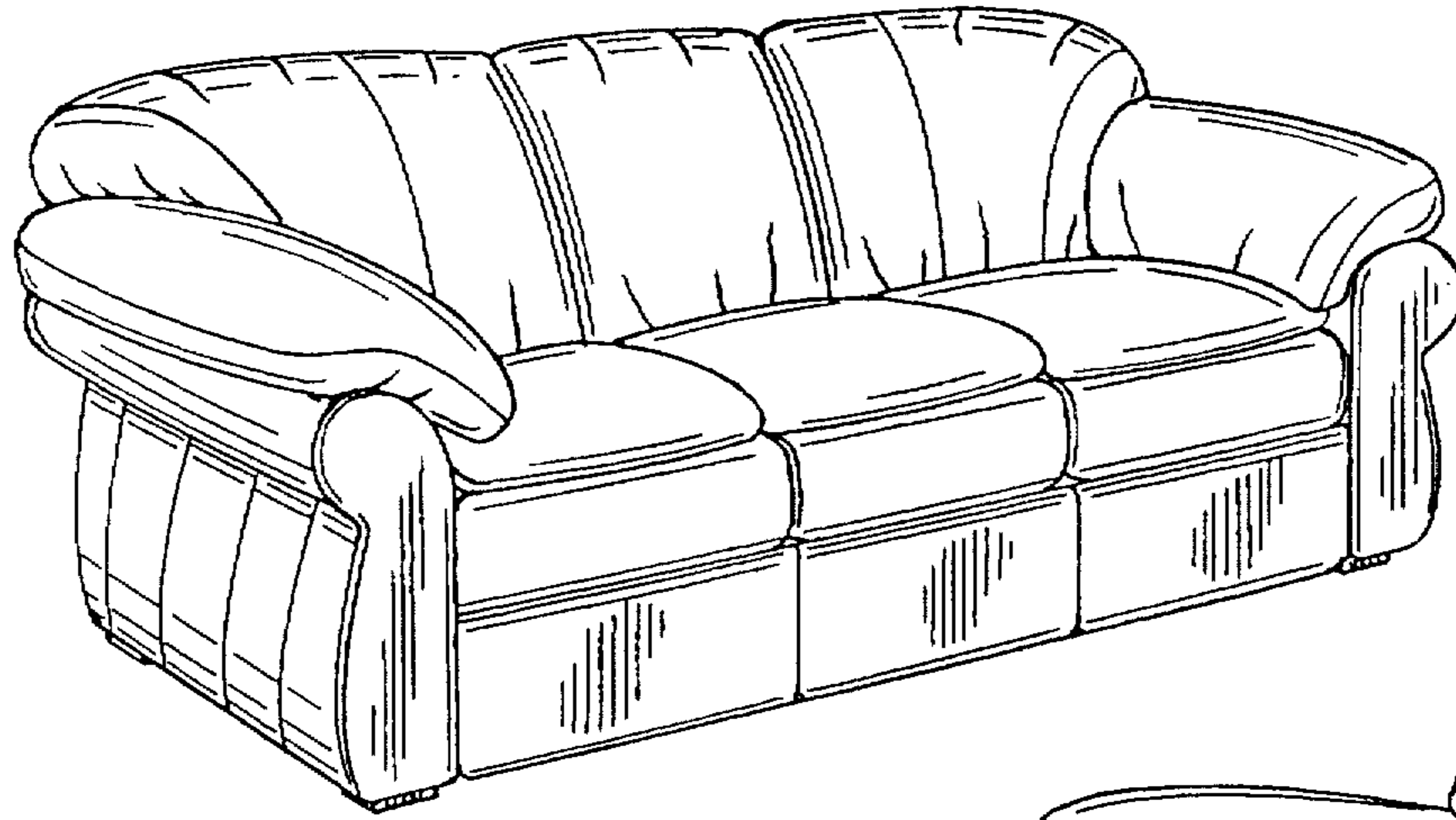

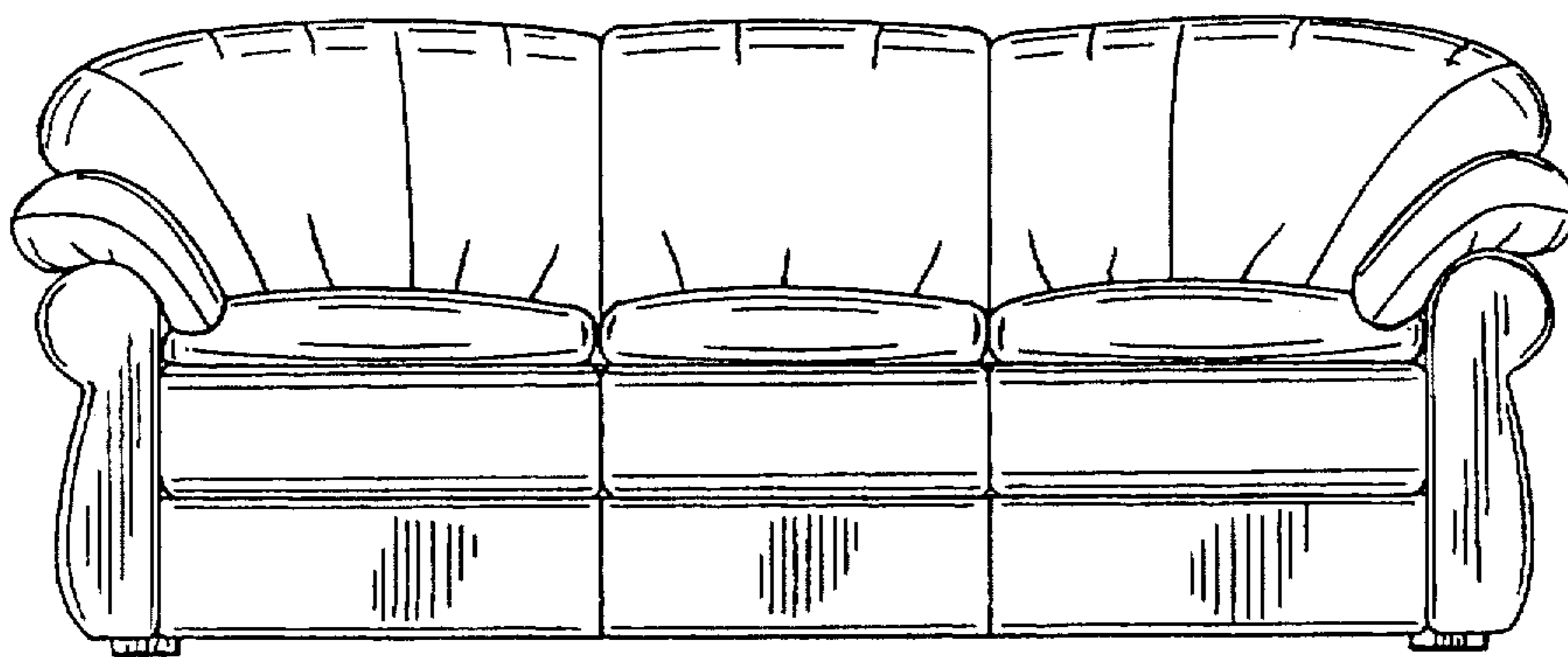

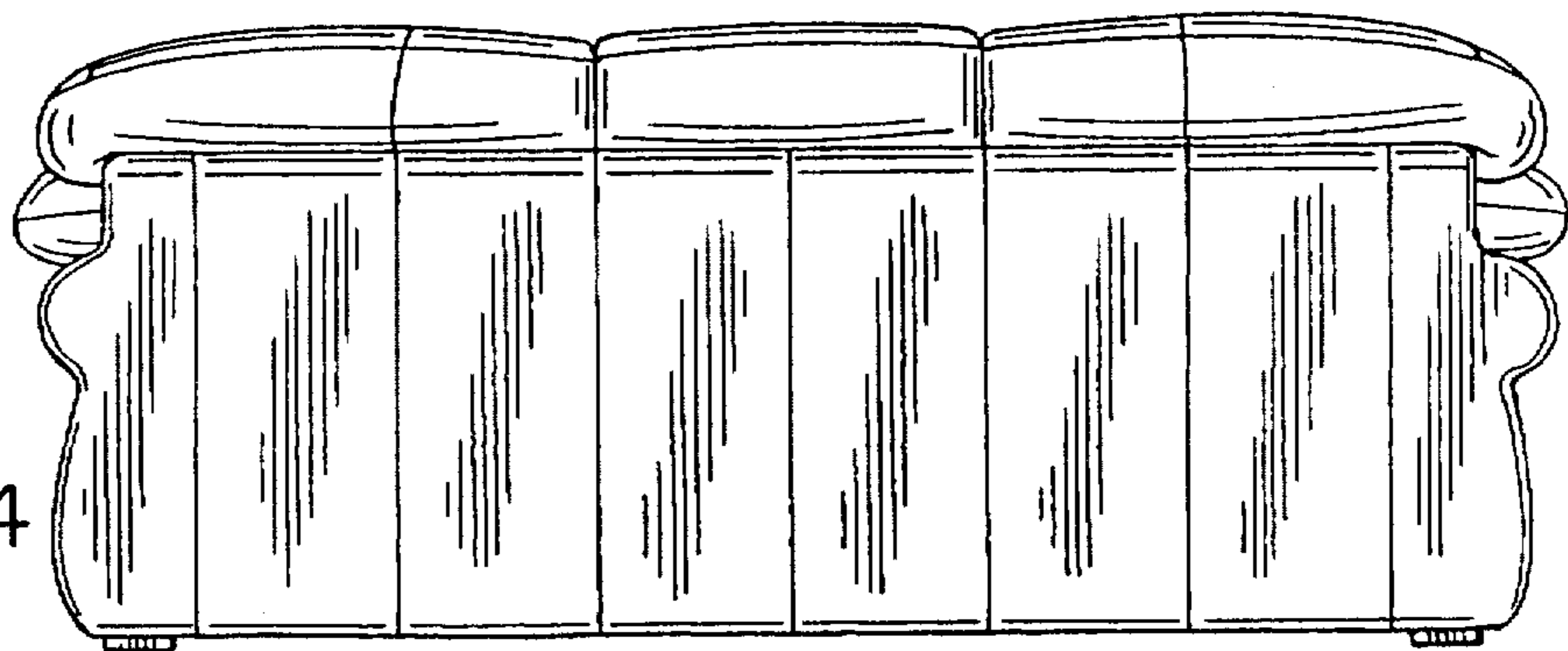

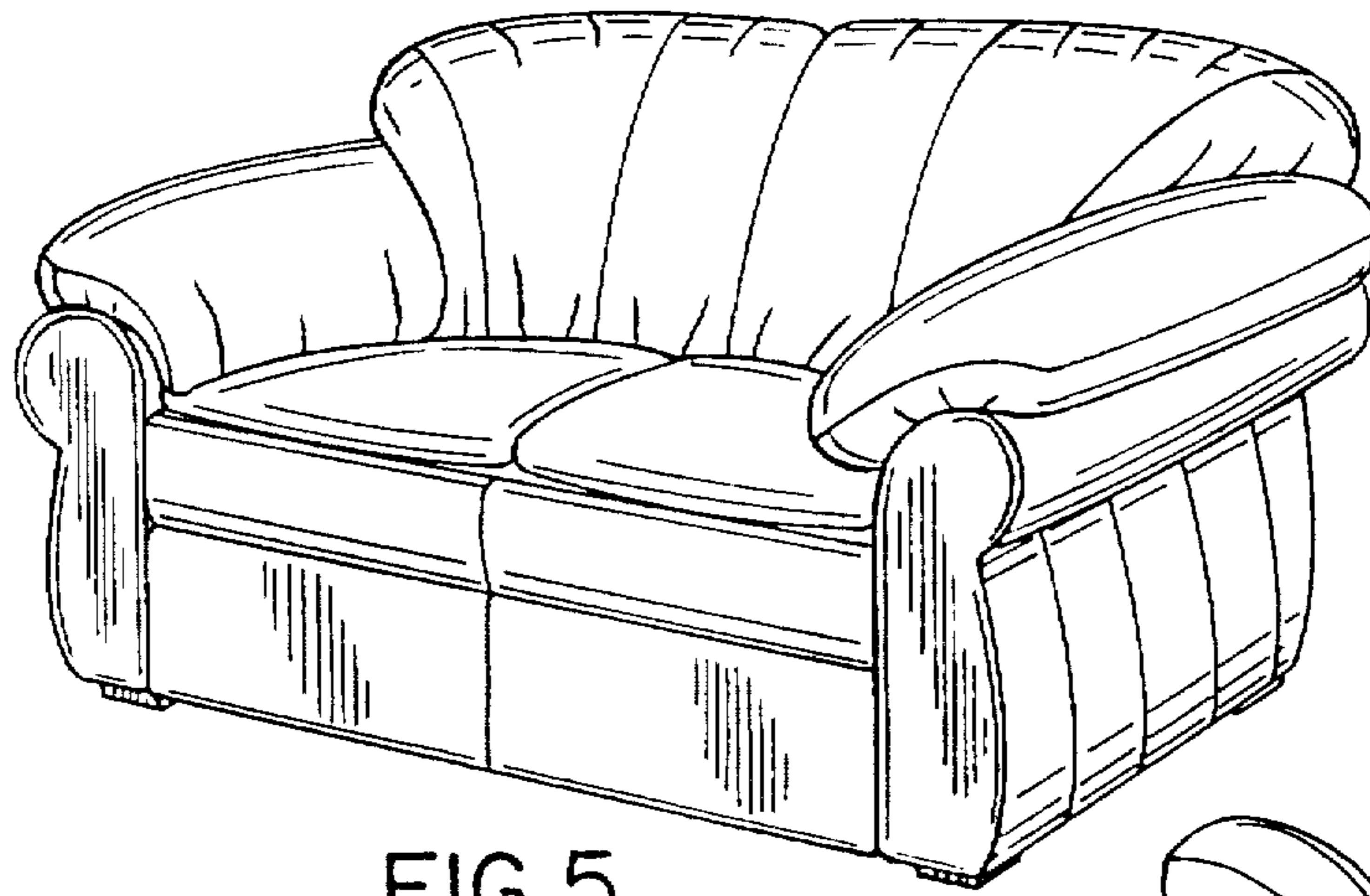

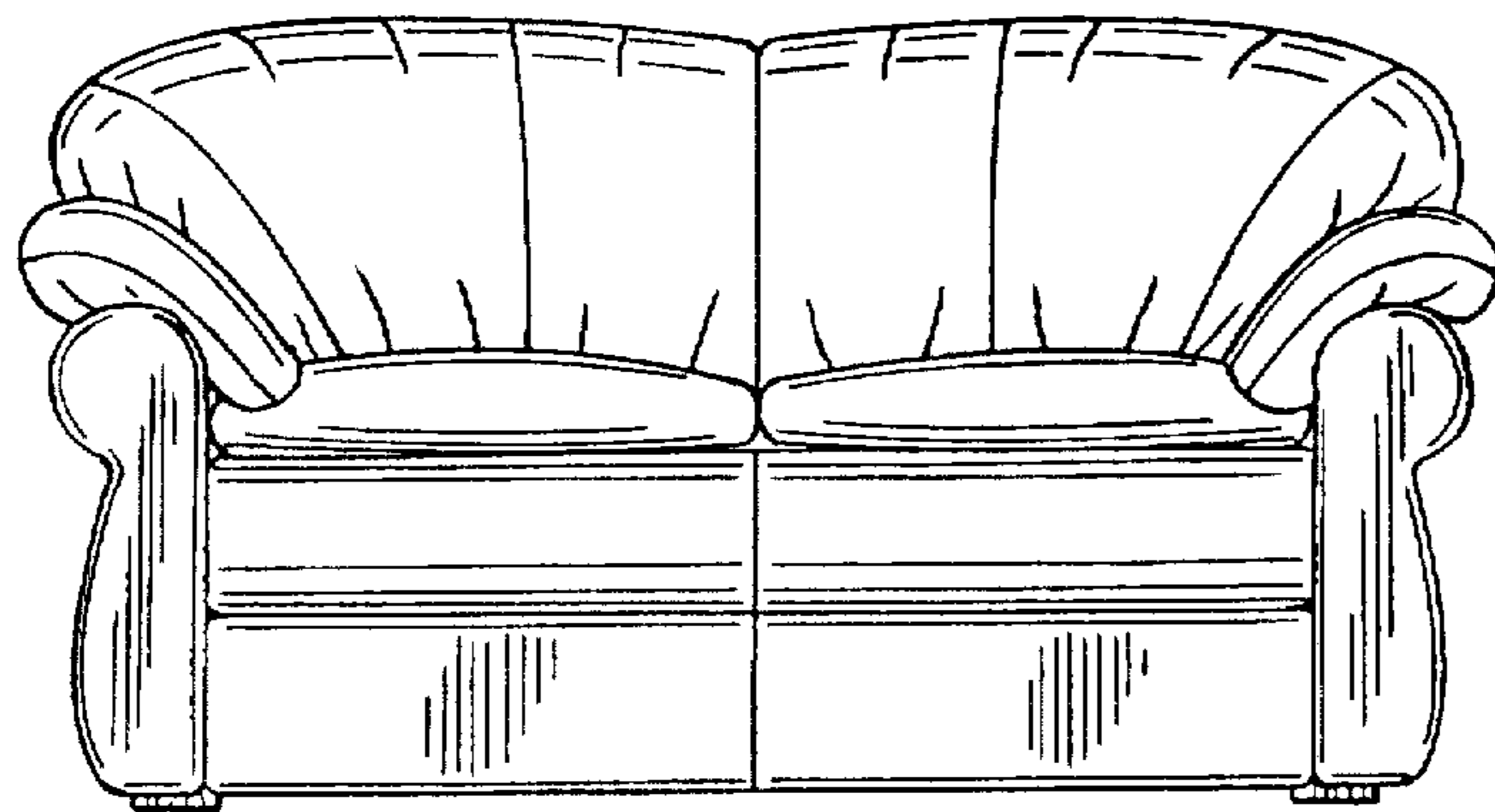

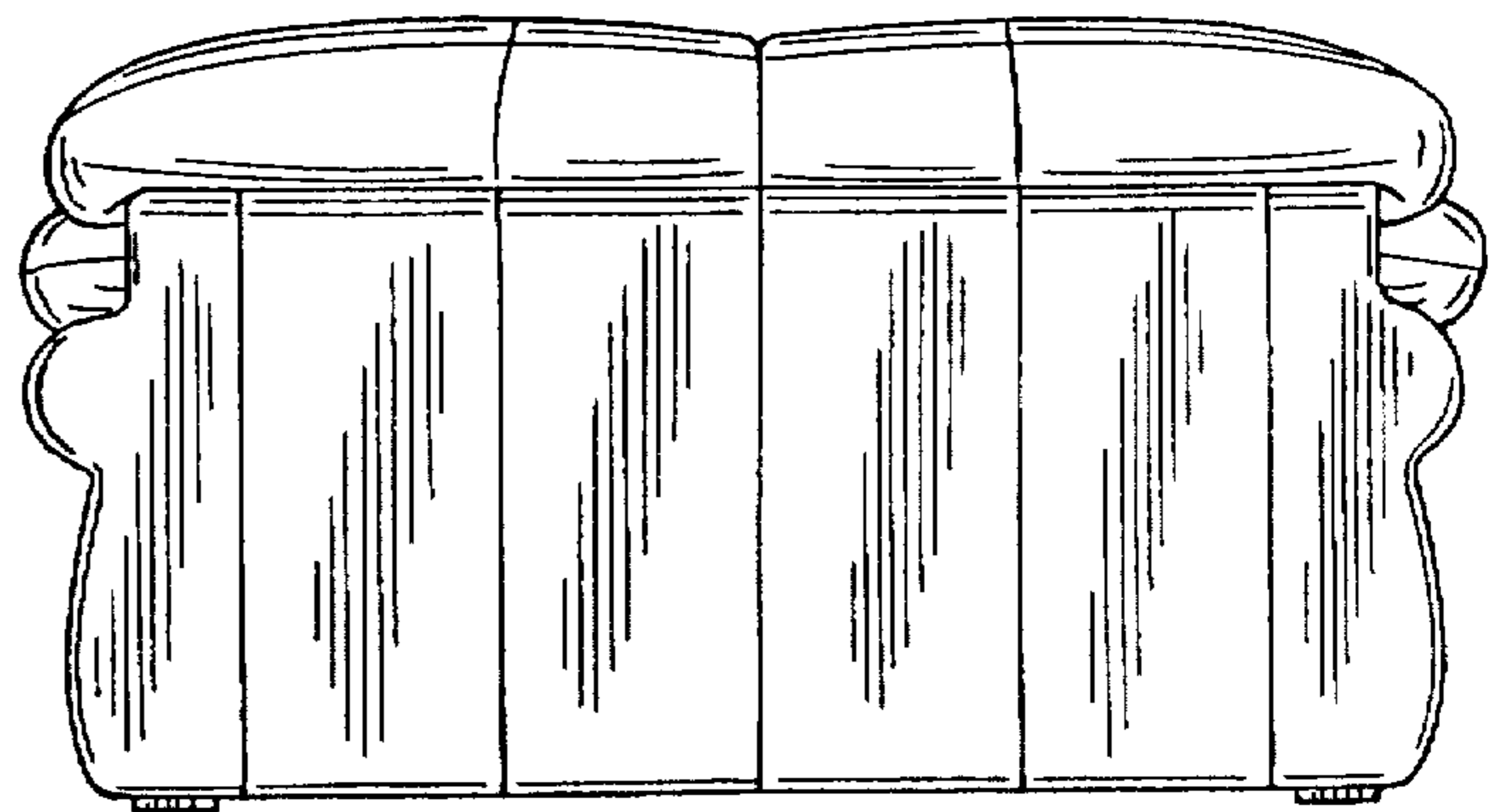

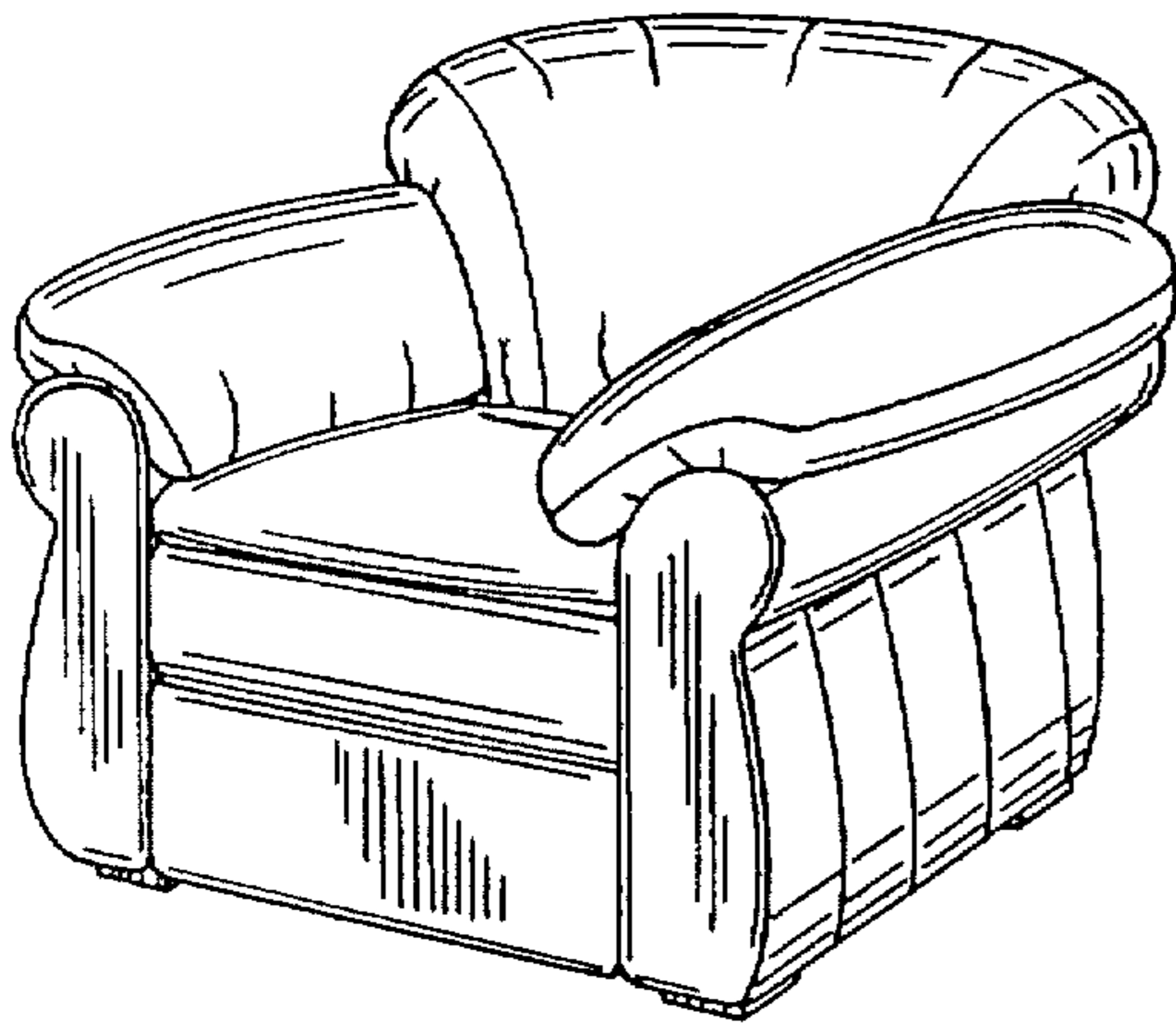

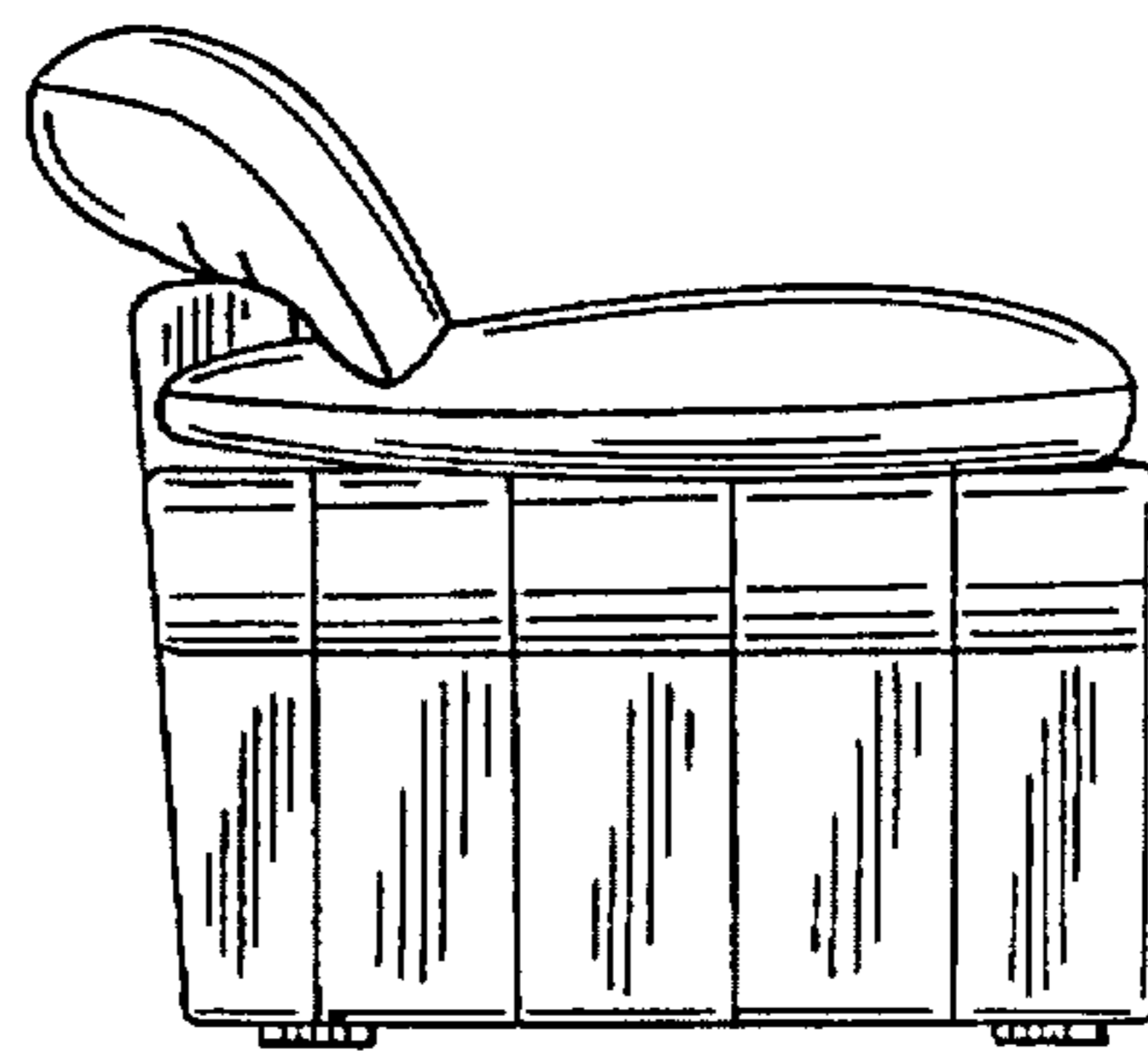

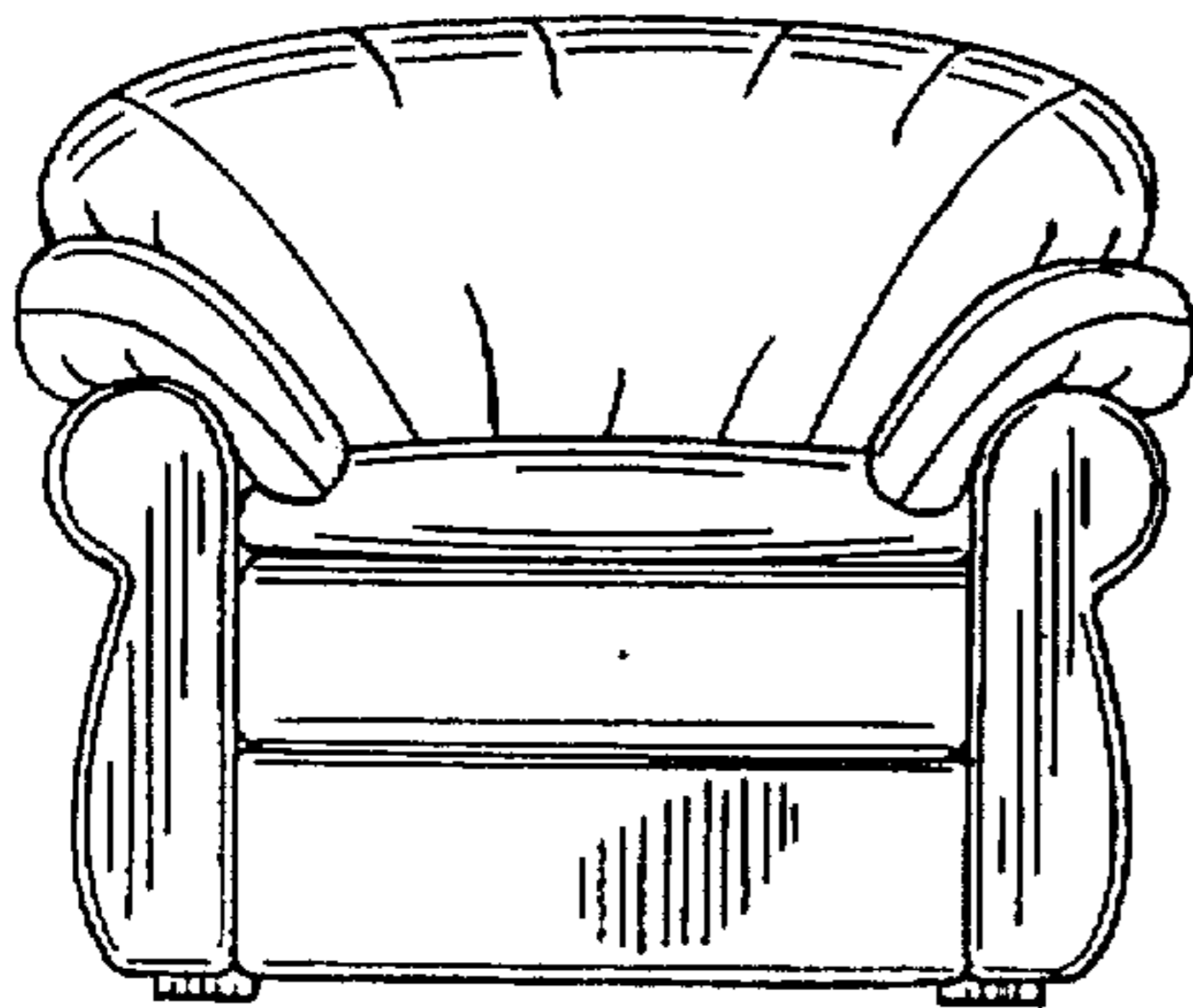

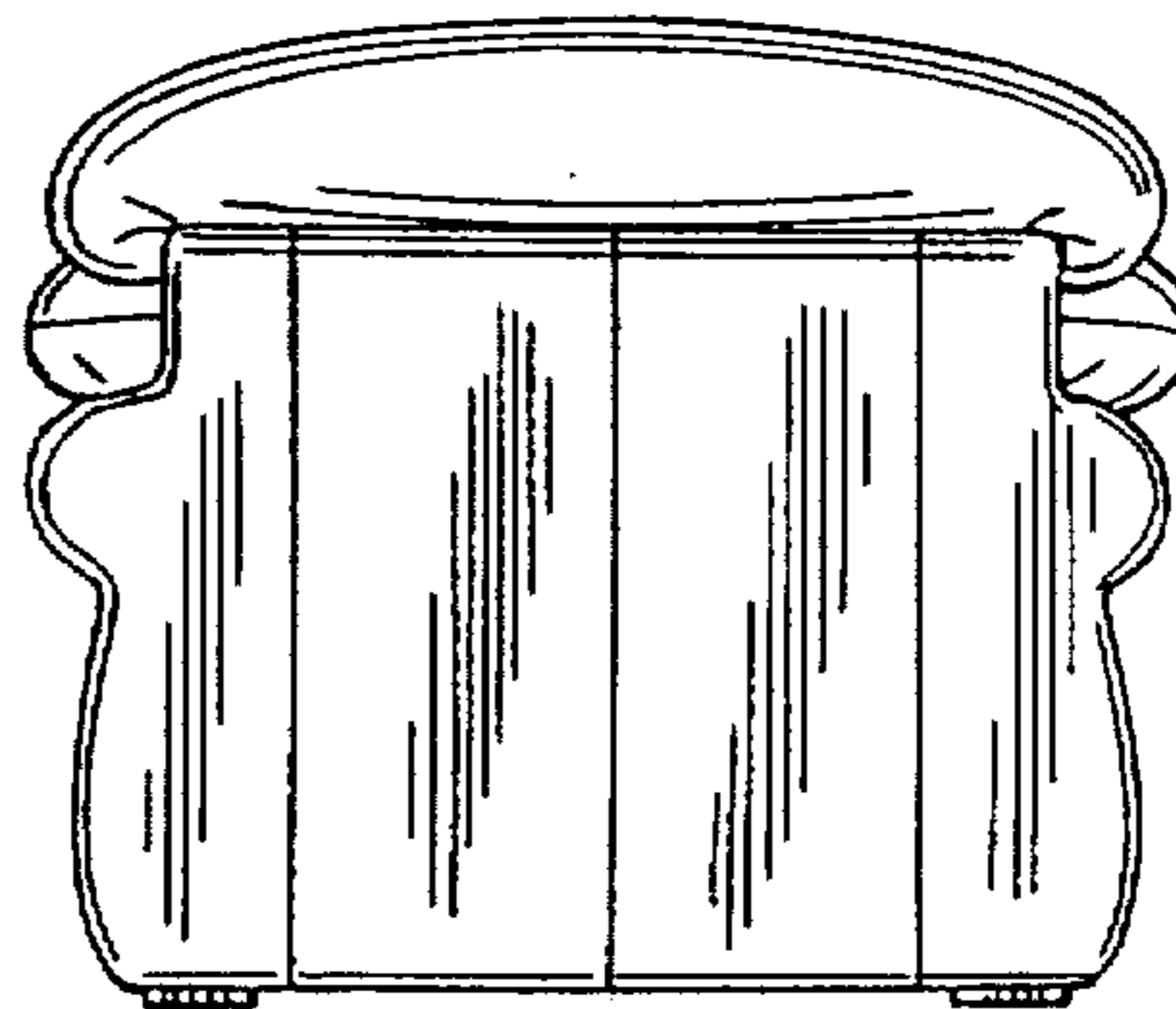
