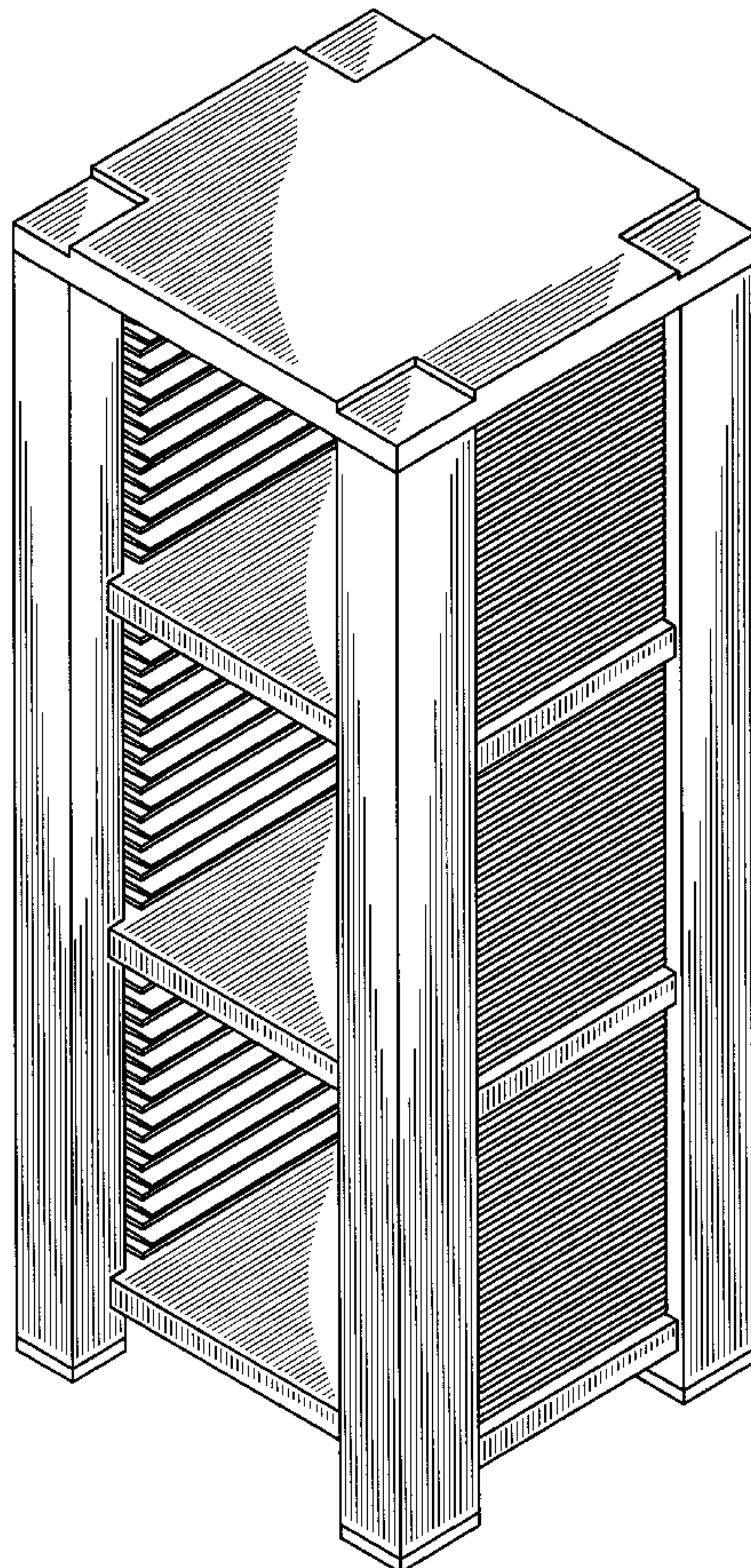
[57] **CLAIM**

The ornamental design for a “cd rack,” as shown and described.

DESCRIPTION

FIG. 1 is a front view of “a cd rack” showing my design; FIG. 2 is a rear view thereof; FIG. 3 is a left side elevational view thereof; FIG. 4 is a right side elevational view thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a bottom plan view thereof; FIG. 7 is a perspective view from front, above and right side thereof; and, FIG. 8 is a perspective view from rear, above and left side thereof.

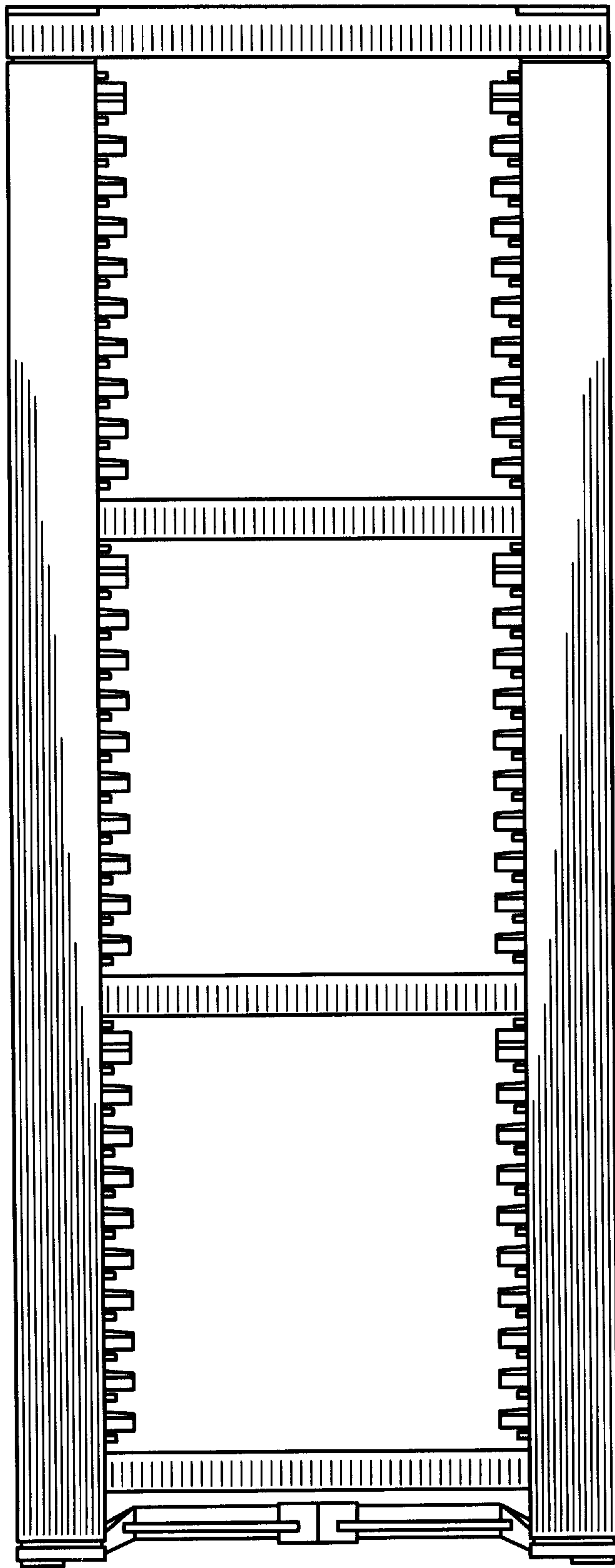

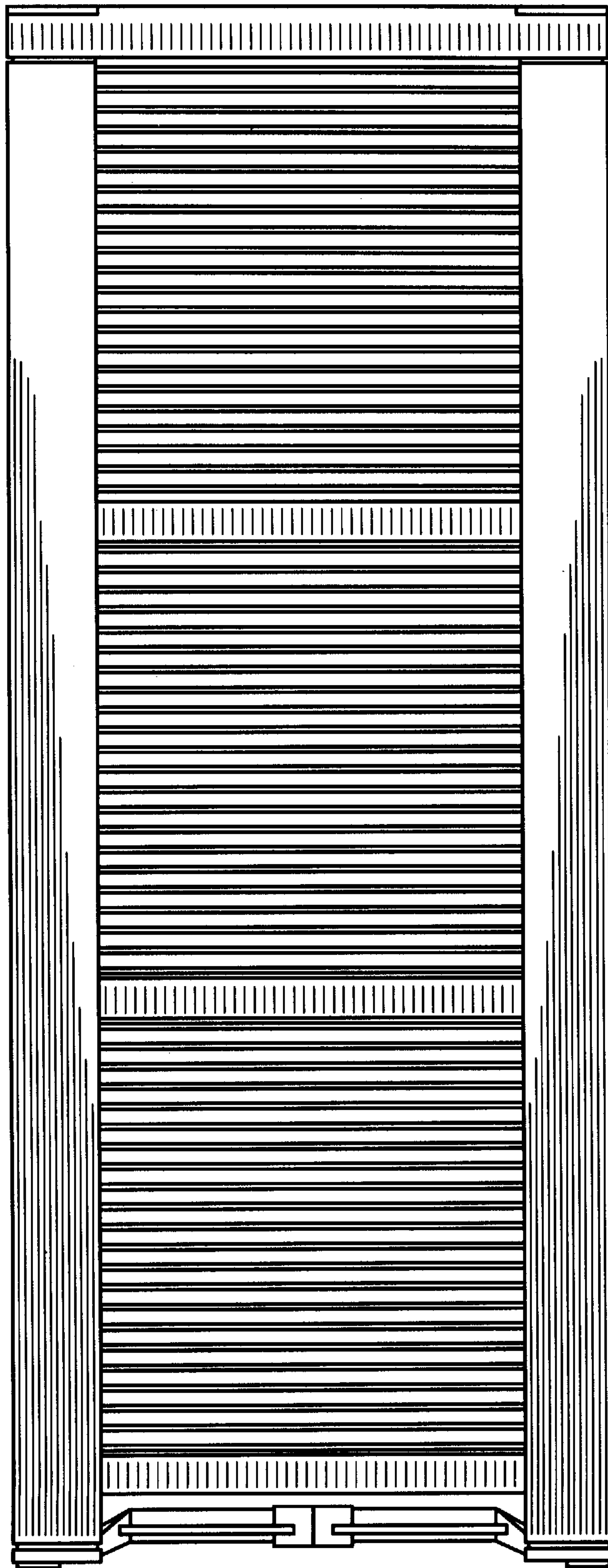

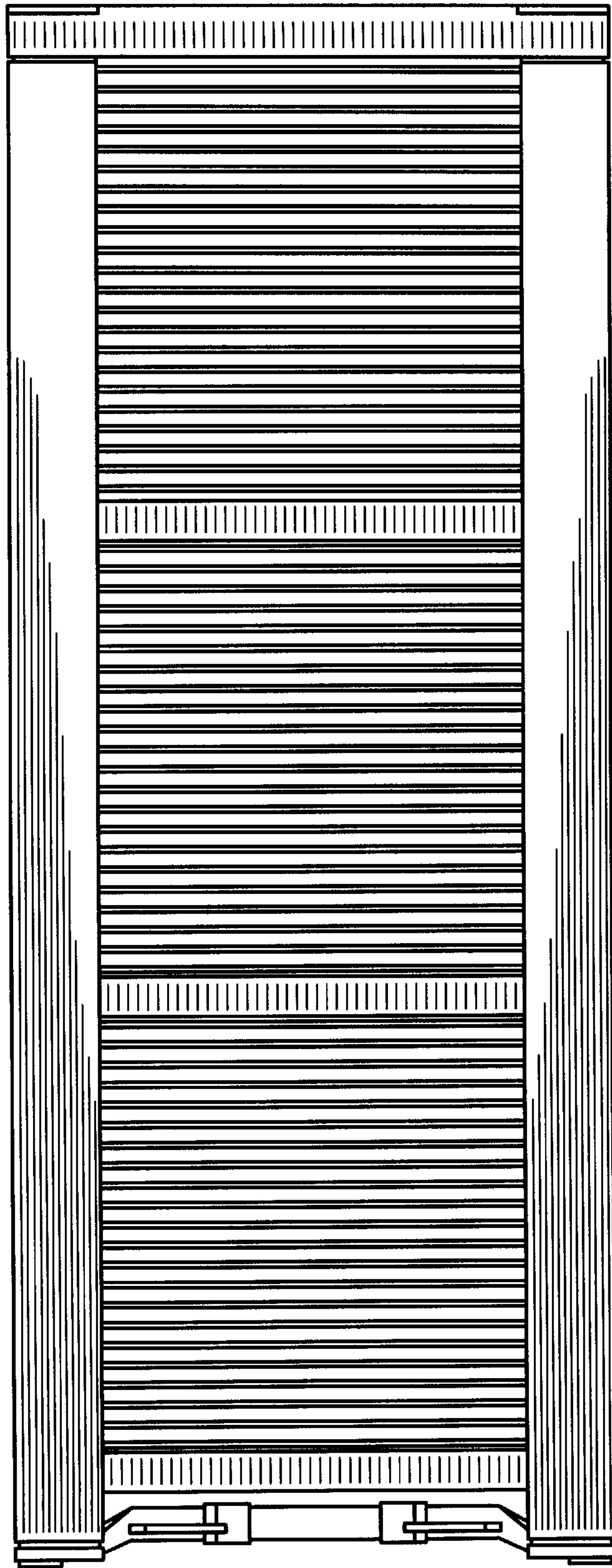

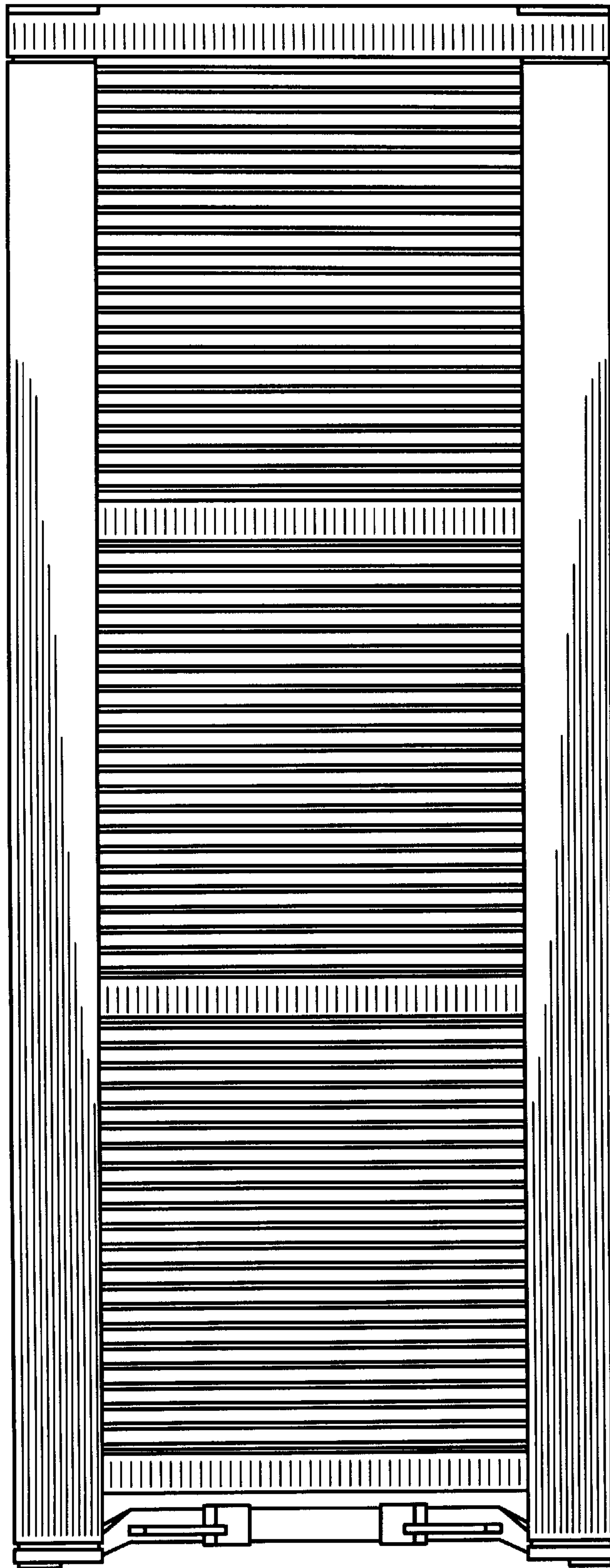

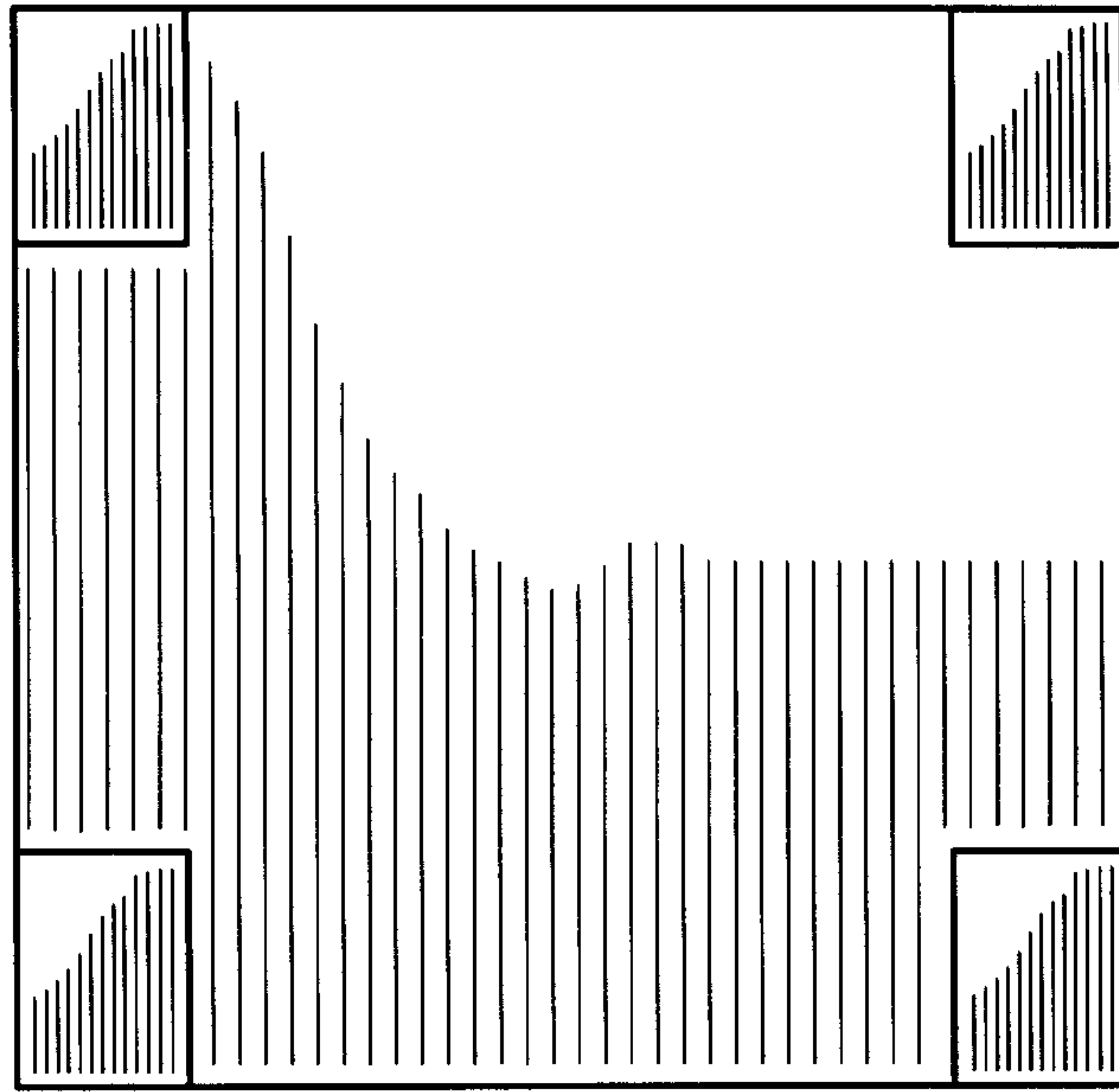

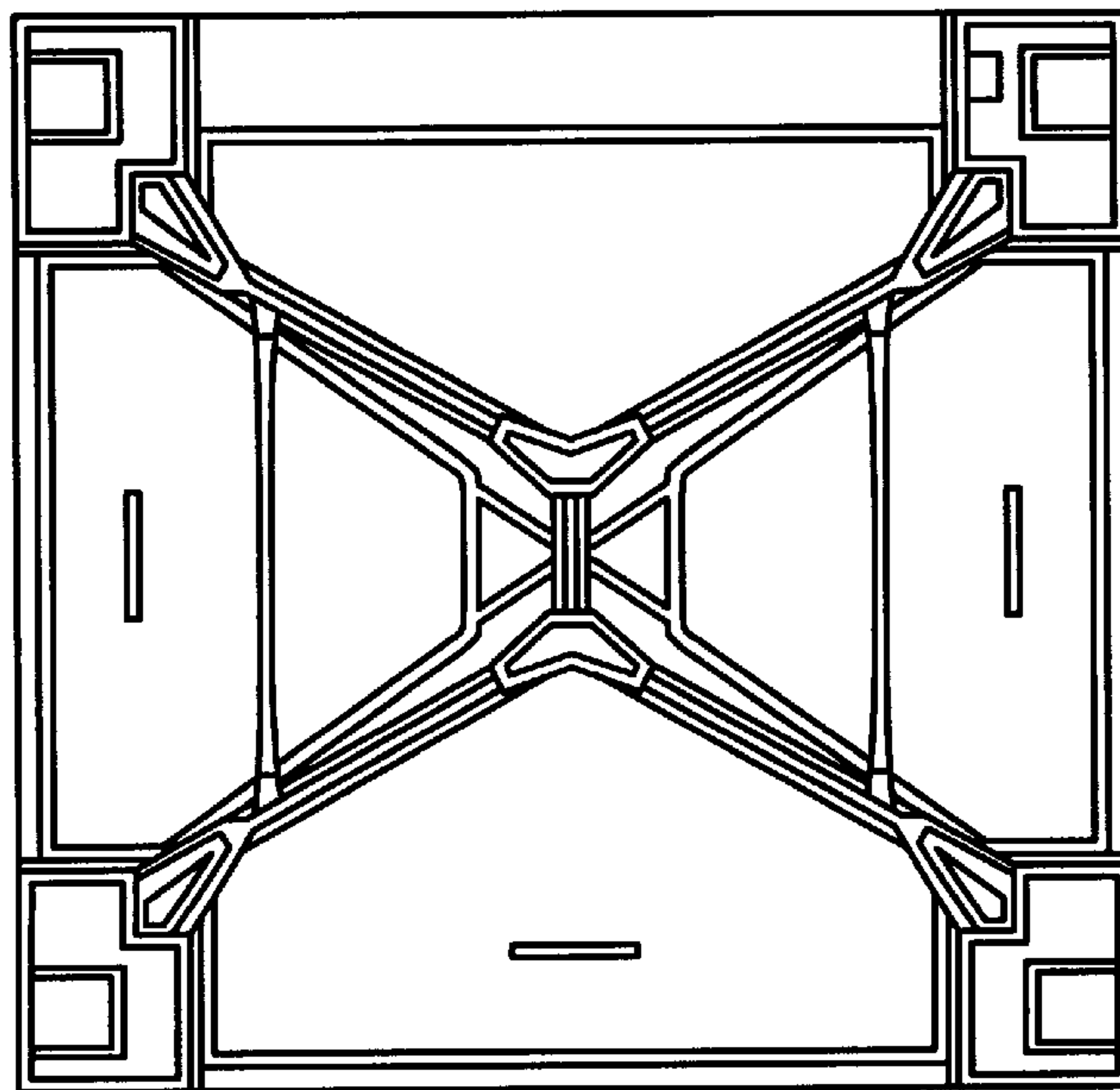

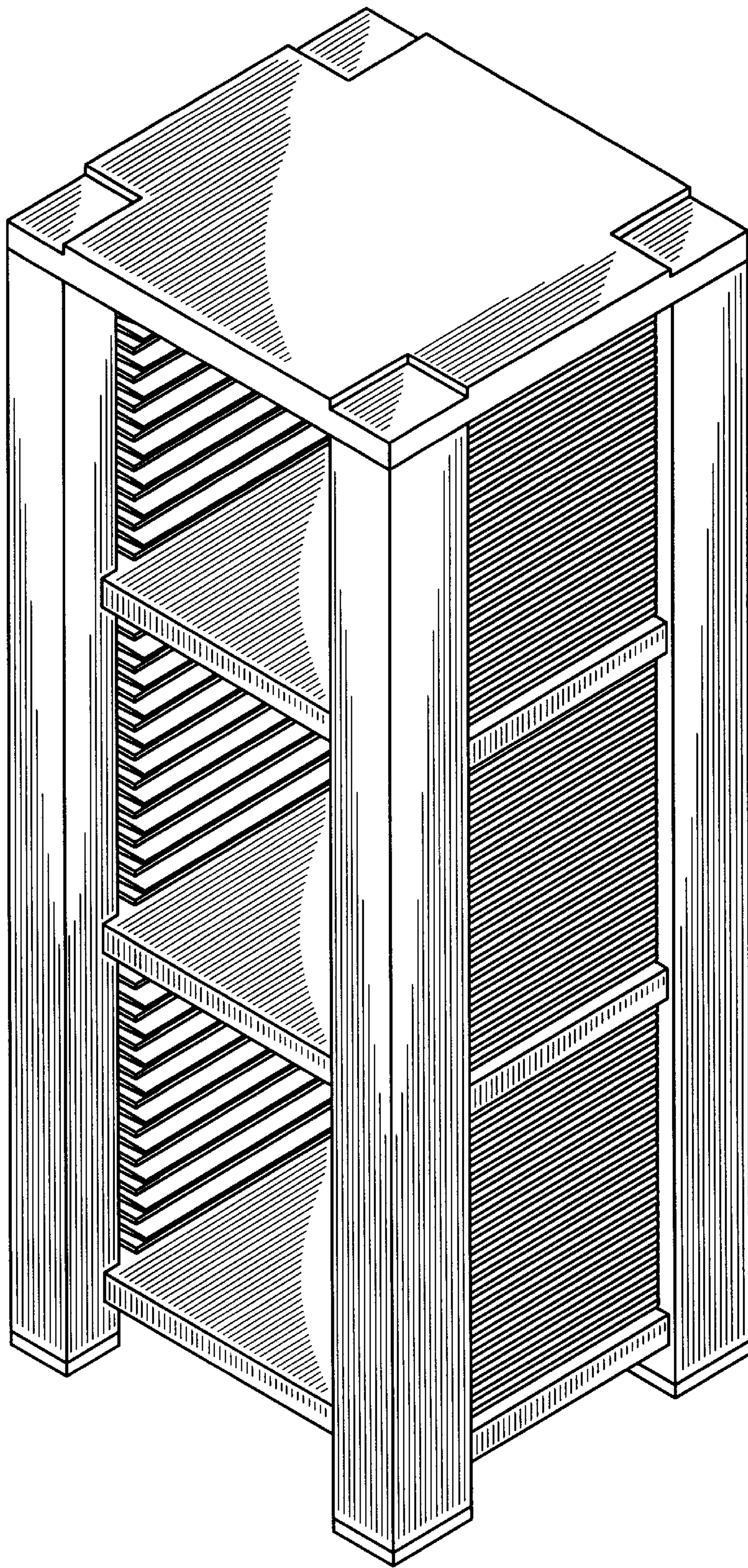

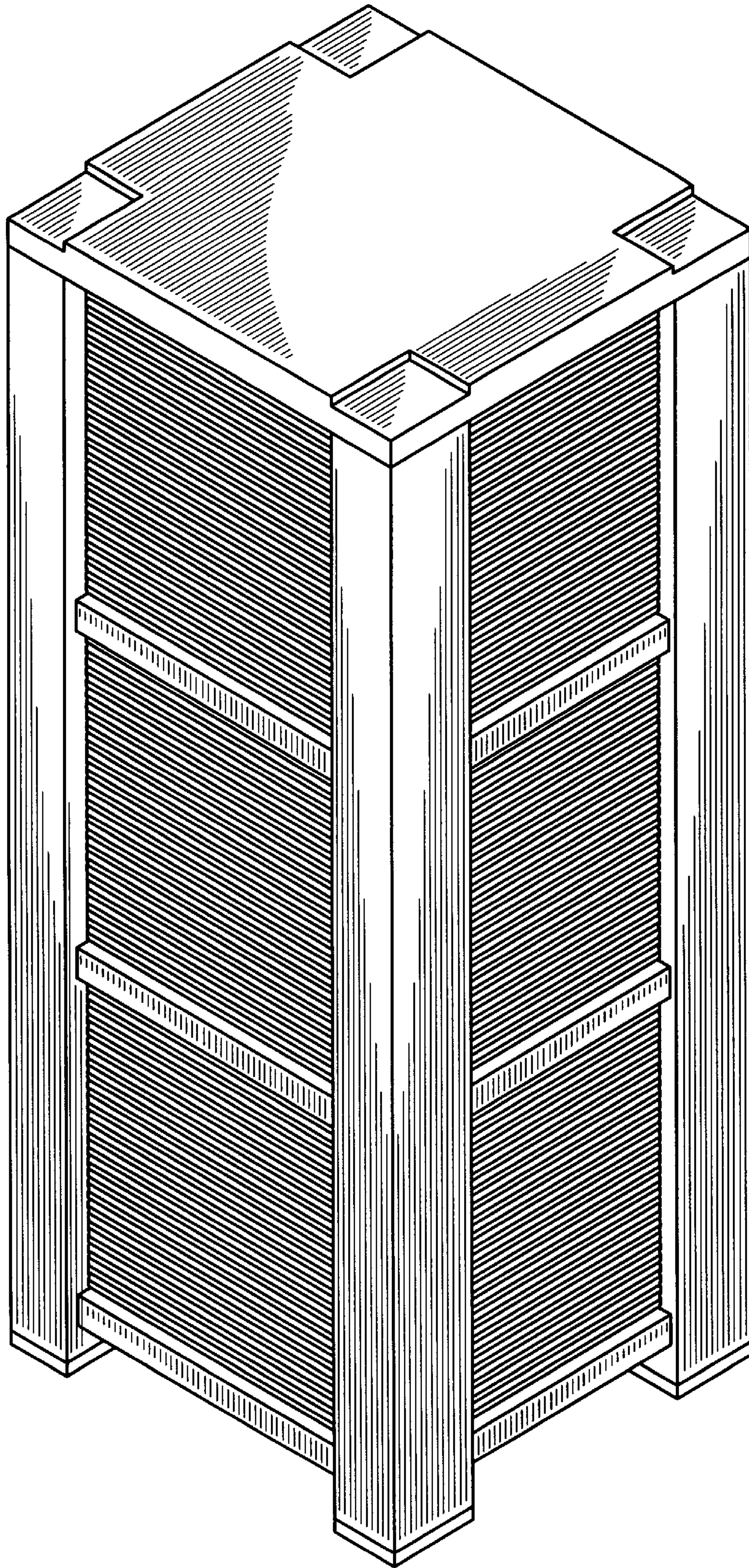
