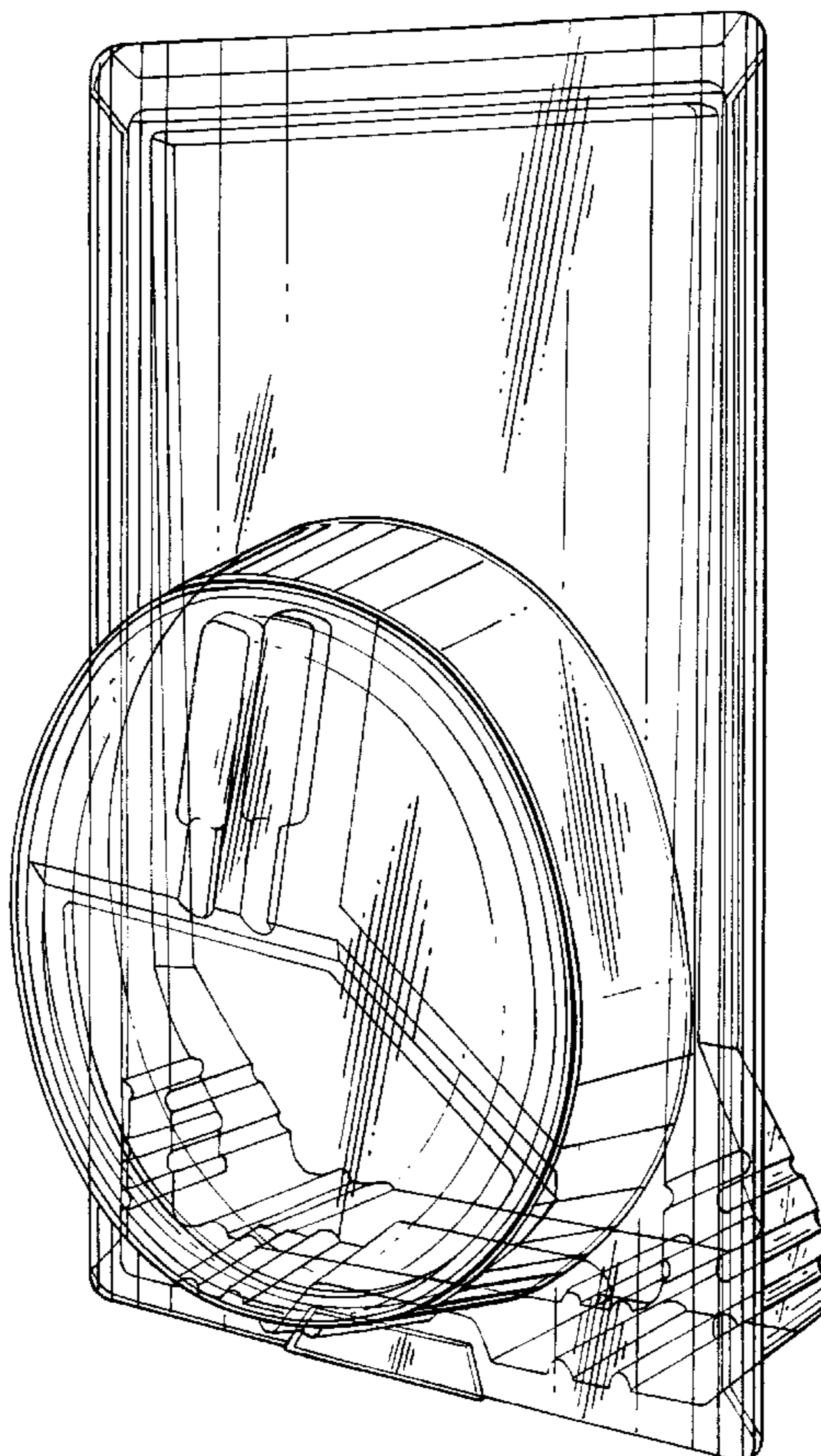
FIG. 1 is a top, front and right side perspective view of a package showing my new design;

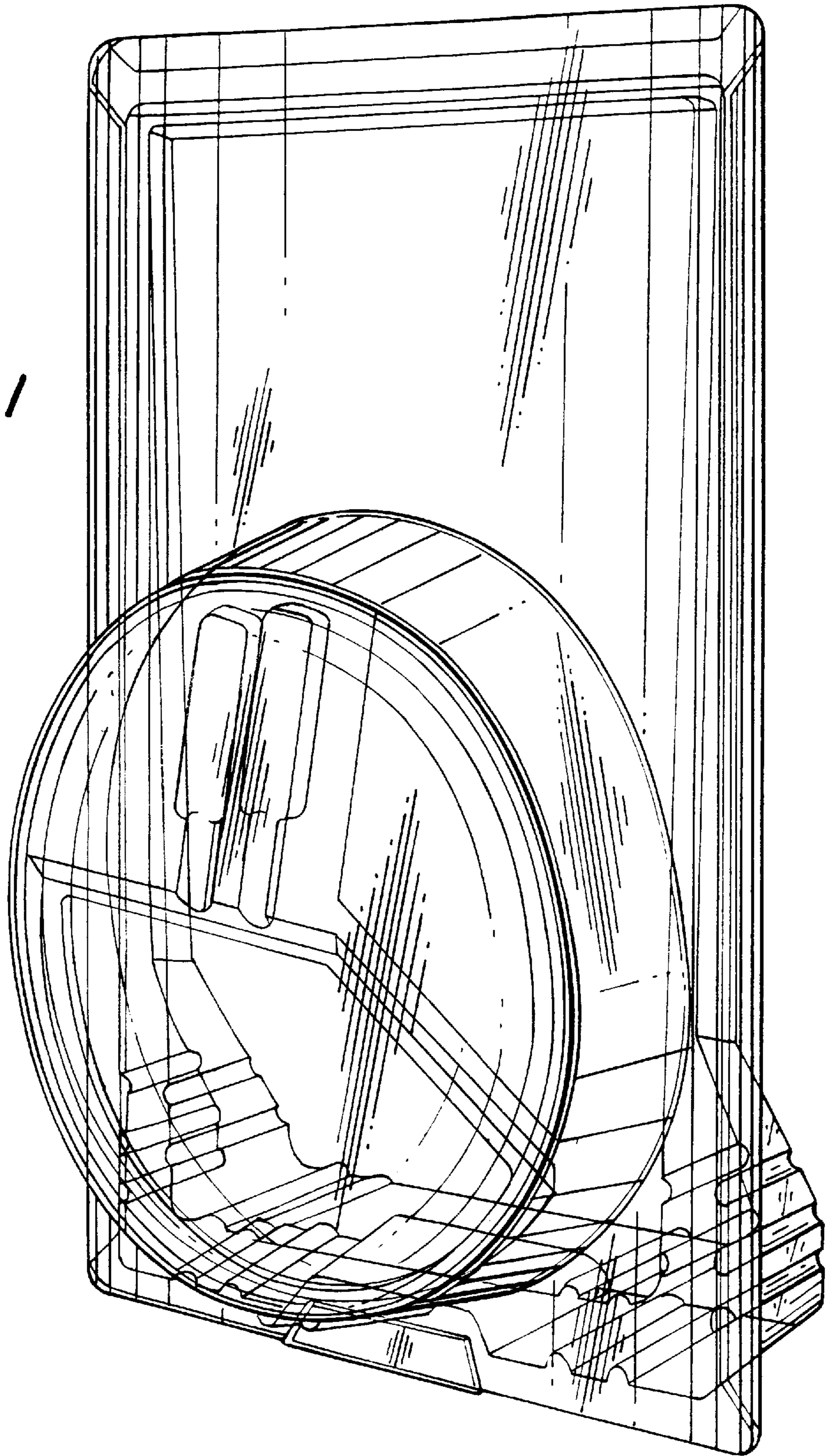
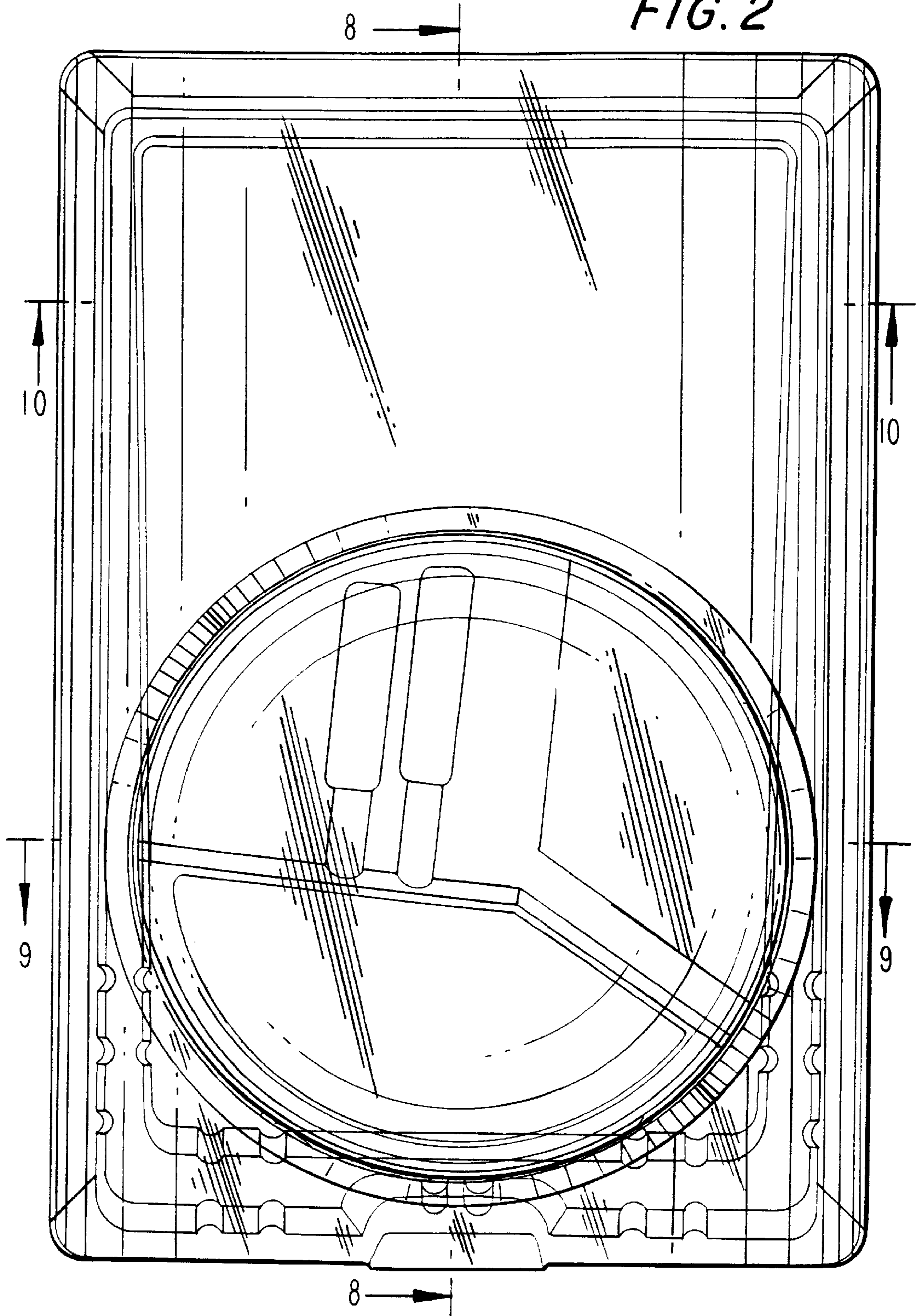
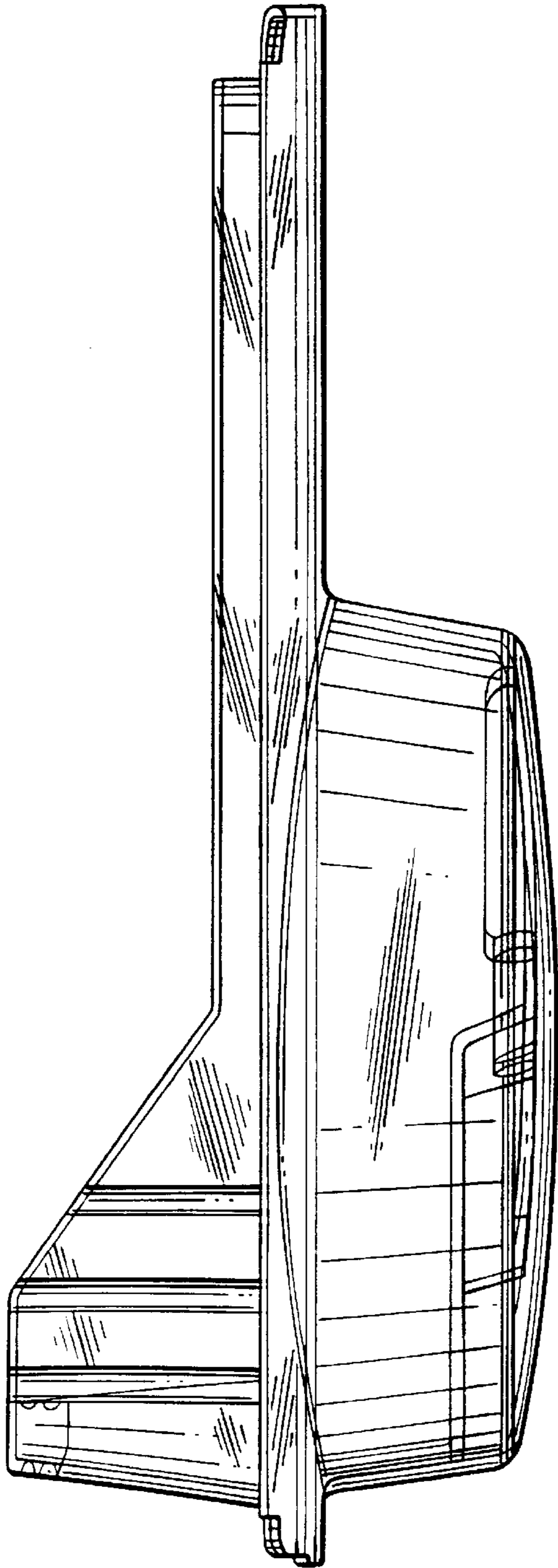


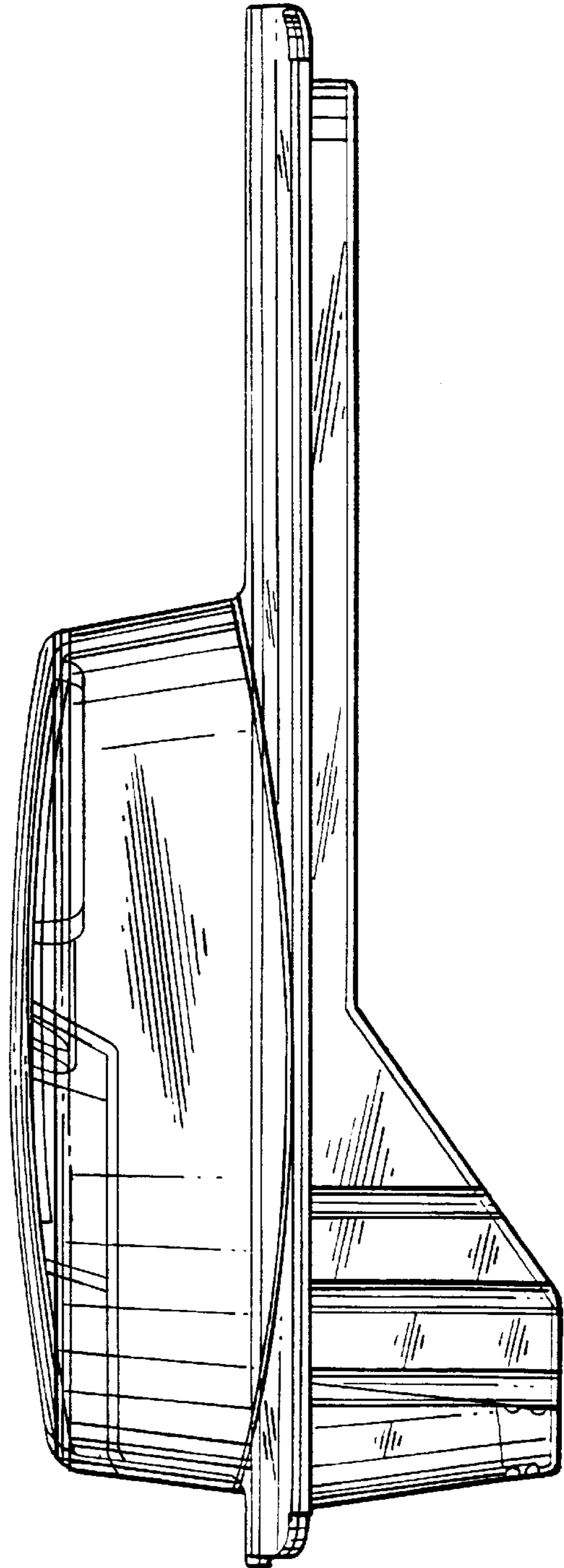

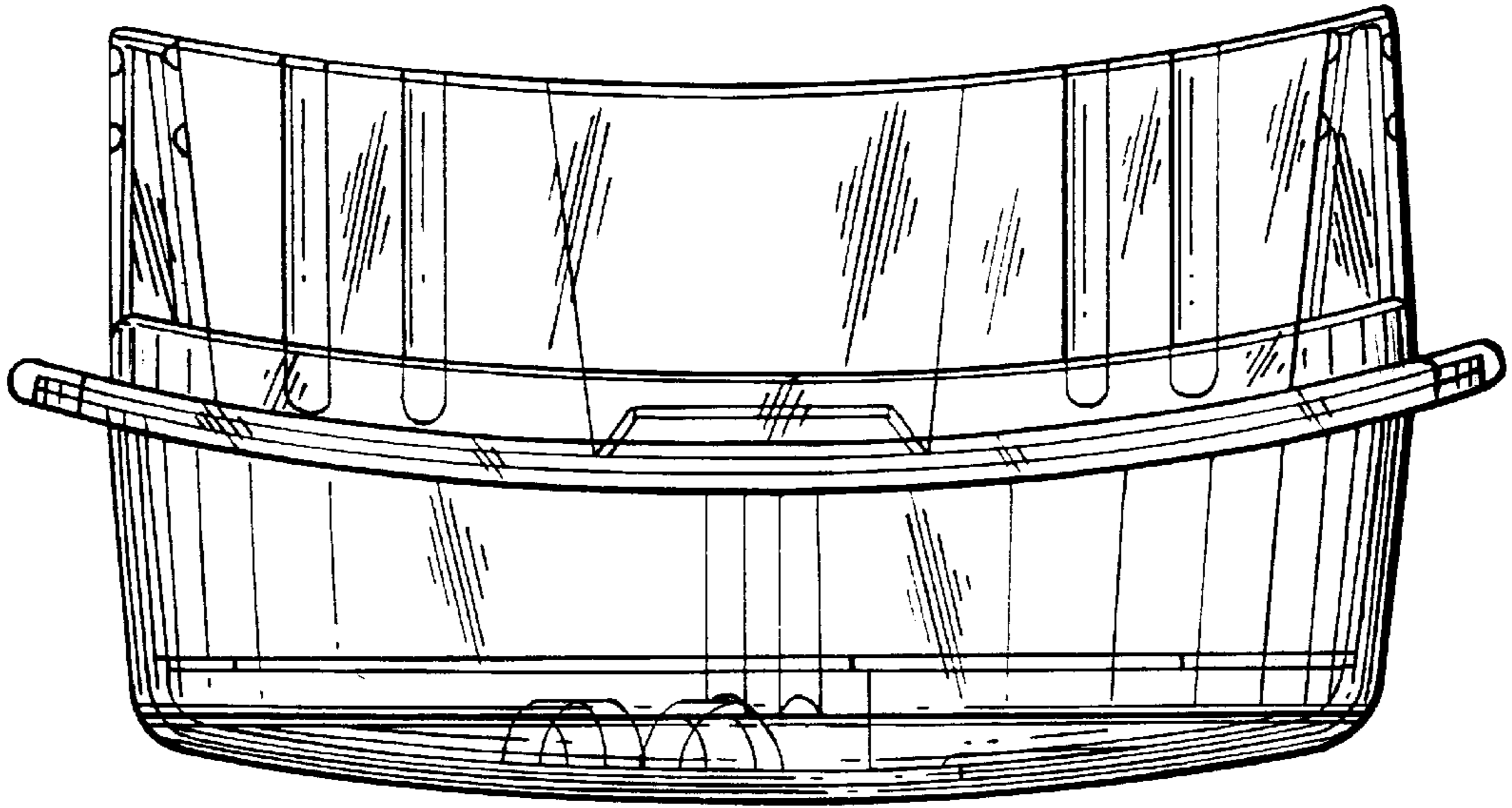

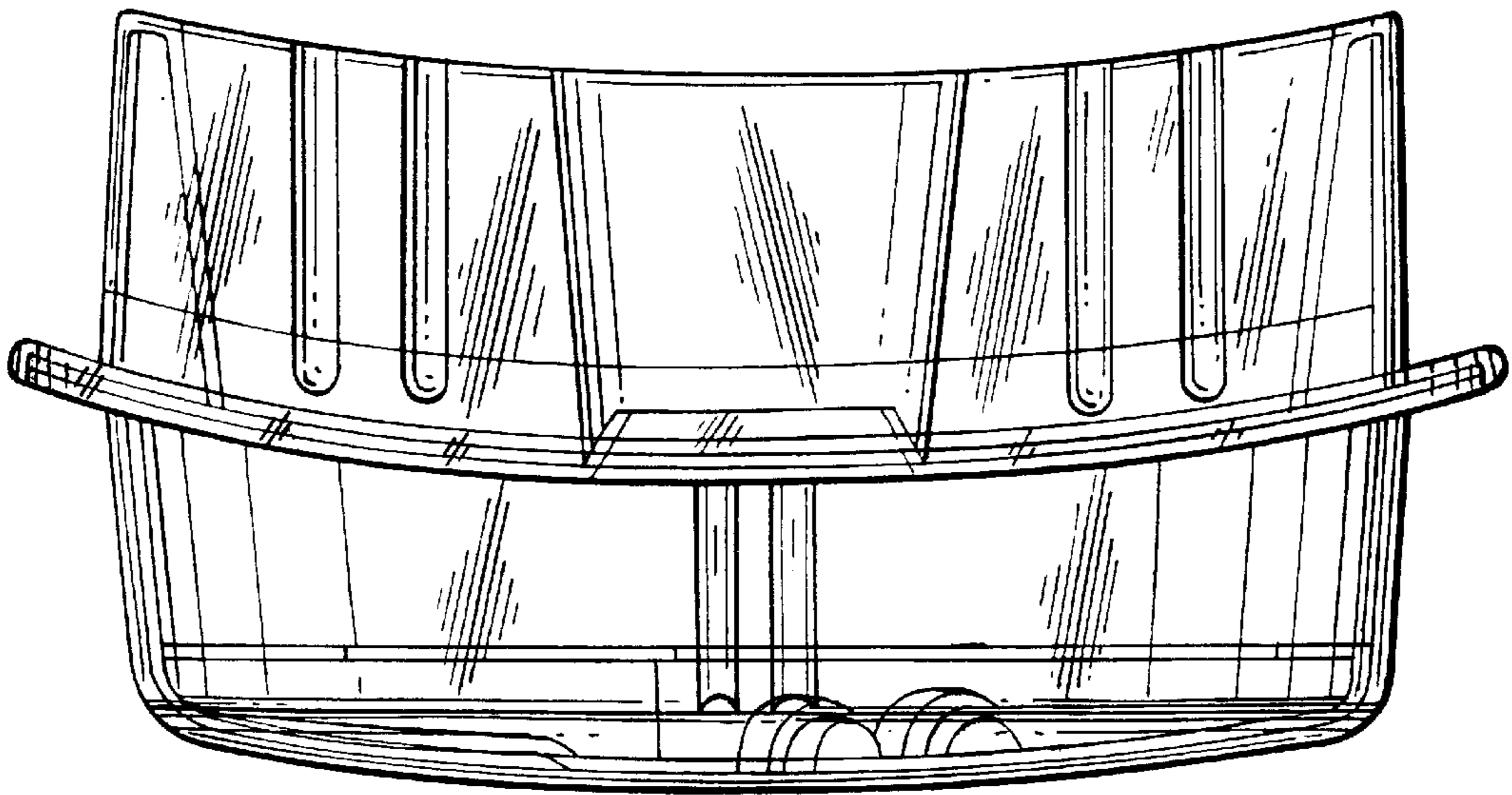

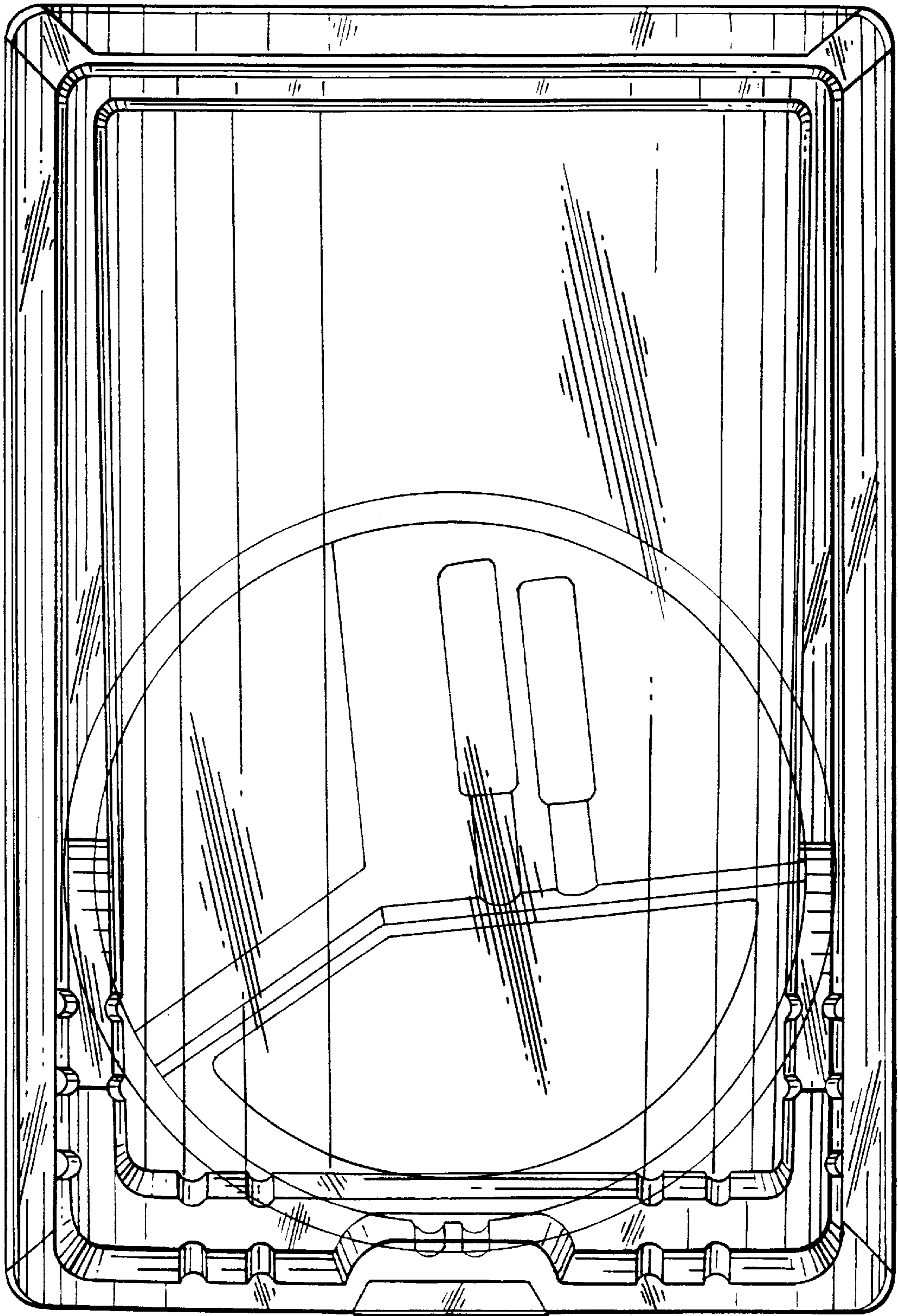

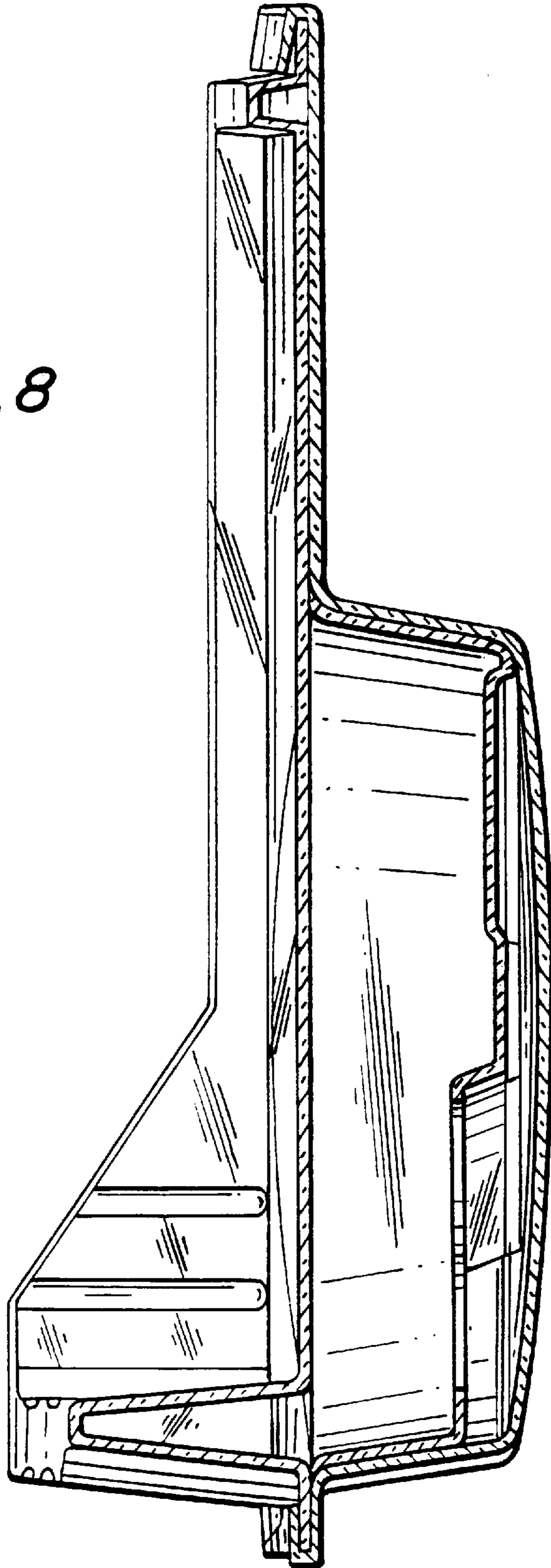

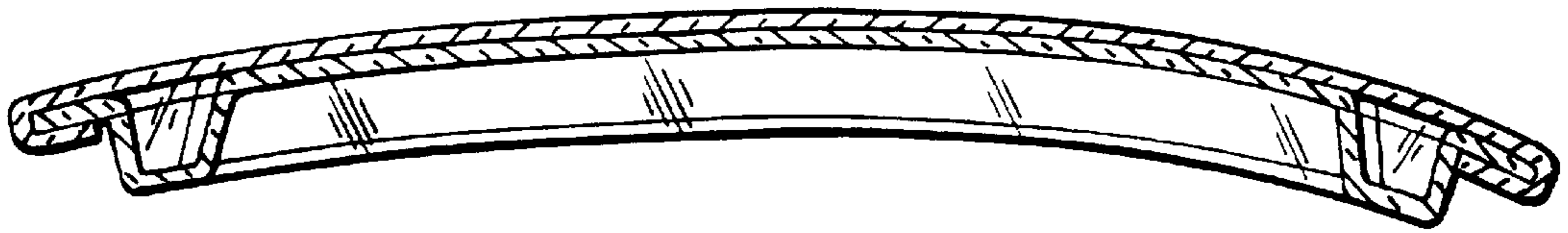
