DESCRIPTION

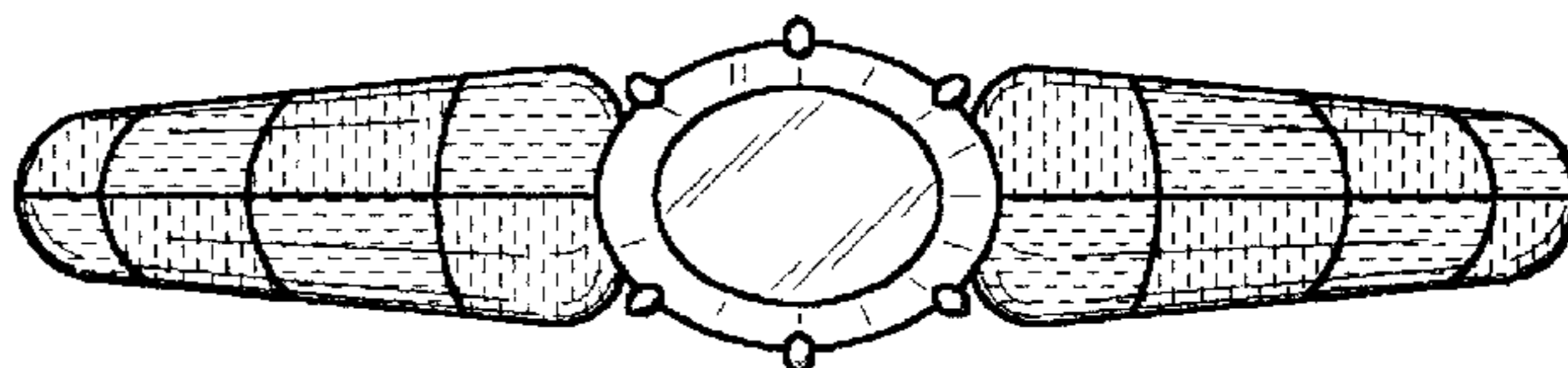
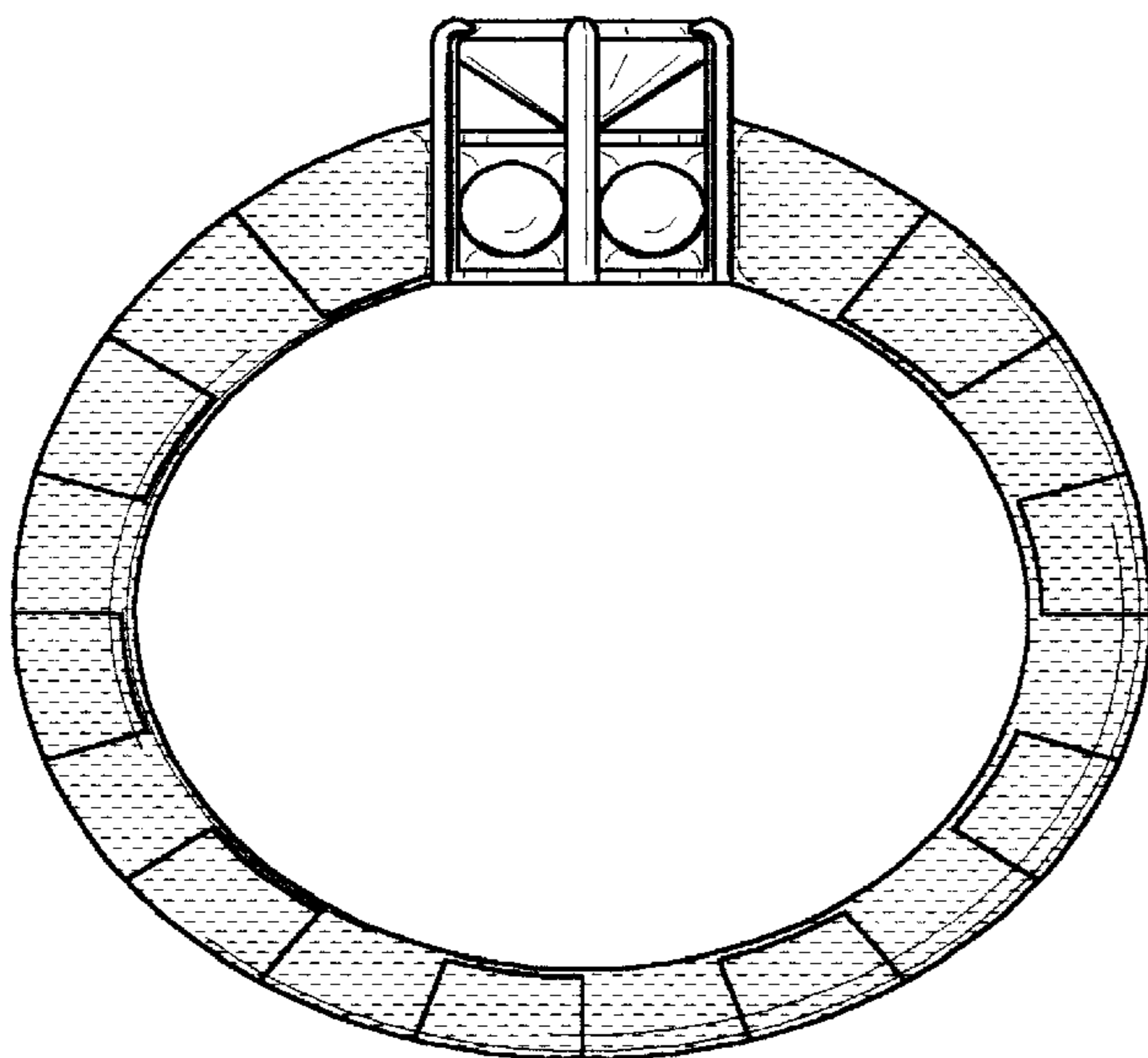
FIG. 1 is a front elevational view of the finger ring, the rear elevational view being a mirror image thereof;

FIG. 2 is a top plan view showing the finger ring of the present invention;

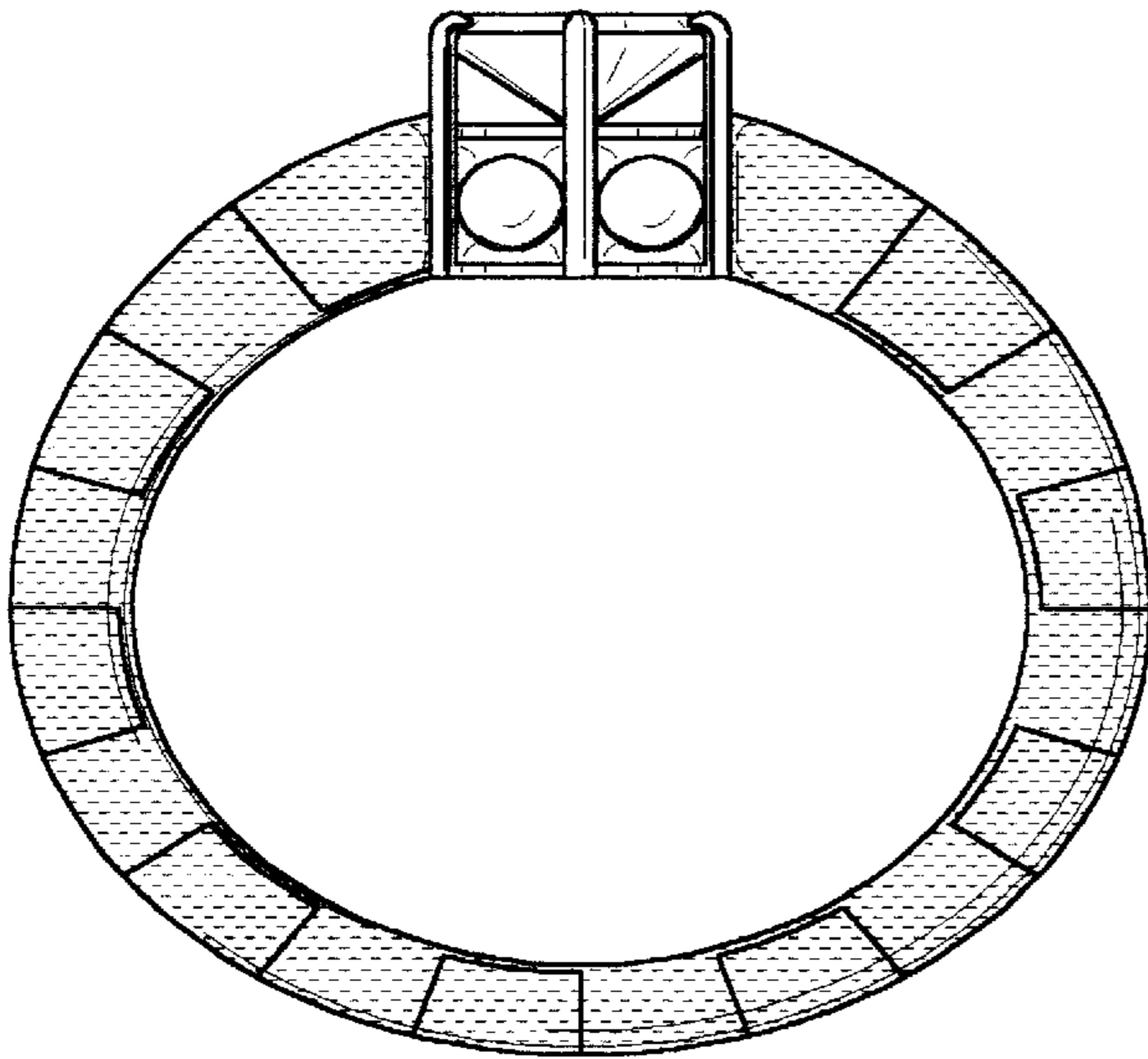

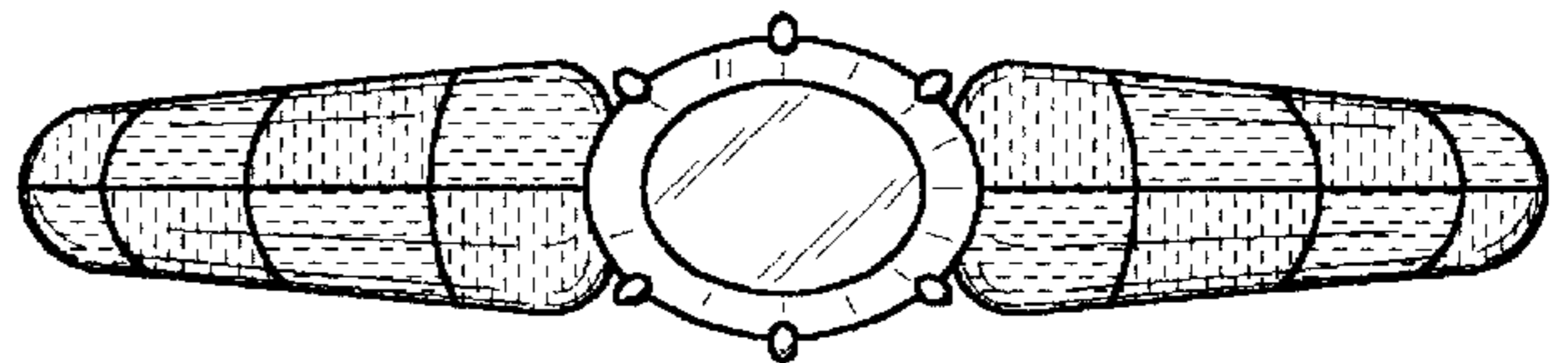

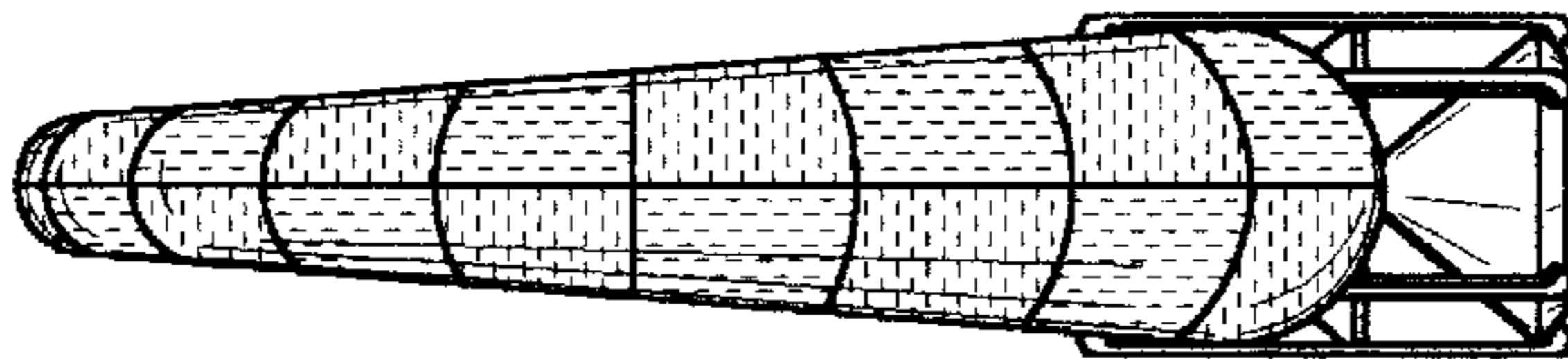

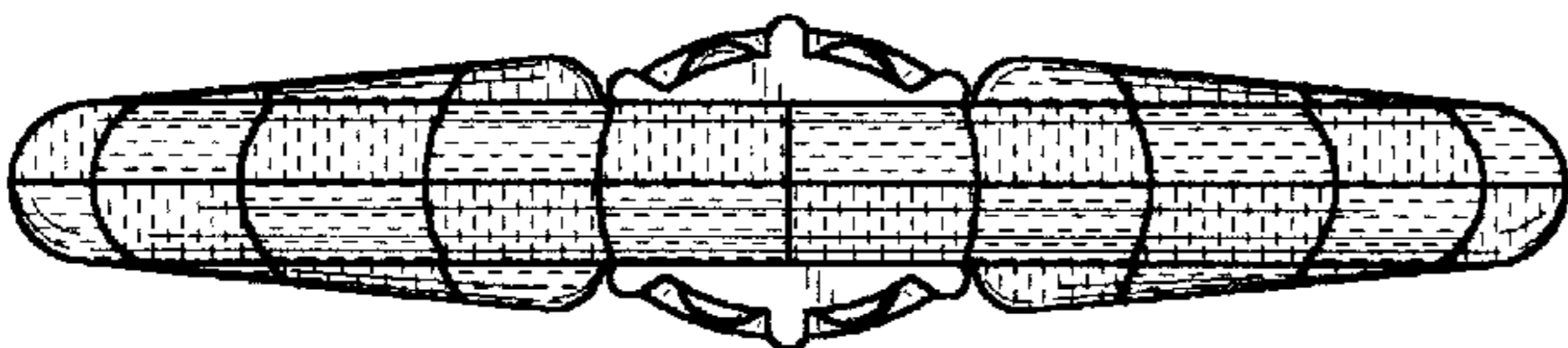
