The ornamental design for a pony tail cap, as shown and described.

### DESCRIPTION

FIG. 1 is a front perspective view of a pony tail cap showing my new design;  
FIG. 2 is a rear perspective view thereof;  
FIG. 3 is a front elevational view thereof;  
FIG. 4 is a rear elevational view thereof;  
FIG. 5 is a top plan view thereof;  
FIG. 6 is a bottom plan view thereof;  
FIG. 7 is a side elevational view of the left side thereof;  
FIG. 8 is a side elevational view of the right side thereof;  
FIG. 9 is a front perspective view of a second embodiment of a pony tail cap showing my new design;  
FIG. 10 is a rear perspective view of the pony tail cap of FIG. 9;  
FIG. 11 is a front elevational view of the pony tail cap of FIG. 9;  
FIG. 12 is a rear elevational view of the pony tail cap of FIG. 9;  
FIG. 13 is a top plan view of the pony tail cap of FIG. 9;  
FIG. 14 is a bottom plan view of the cap of FIG. 9;  
FIG. 15 is a side elevational view of the left side of the pony tail cap of FIG. 9; and,  
FIG. 16 is a side elevational view of the right side of the pony tail cap of FIG. 9.

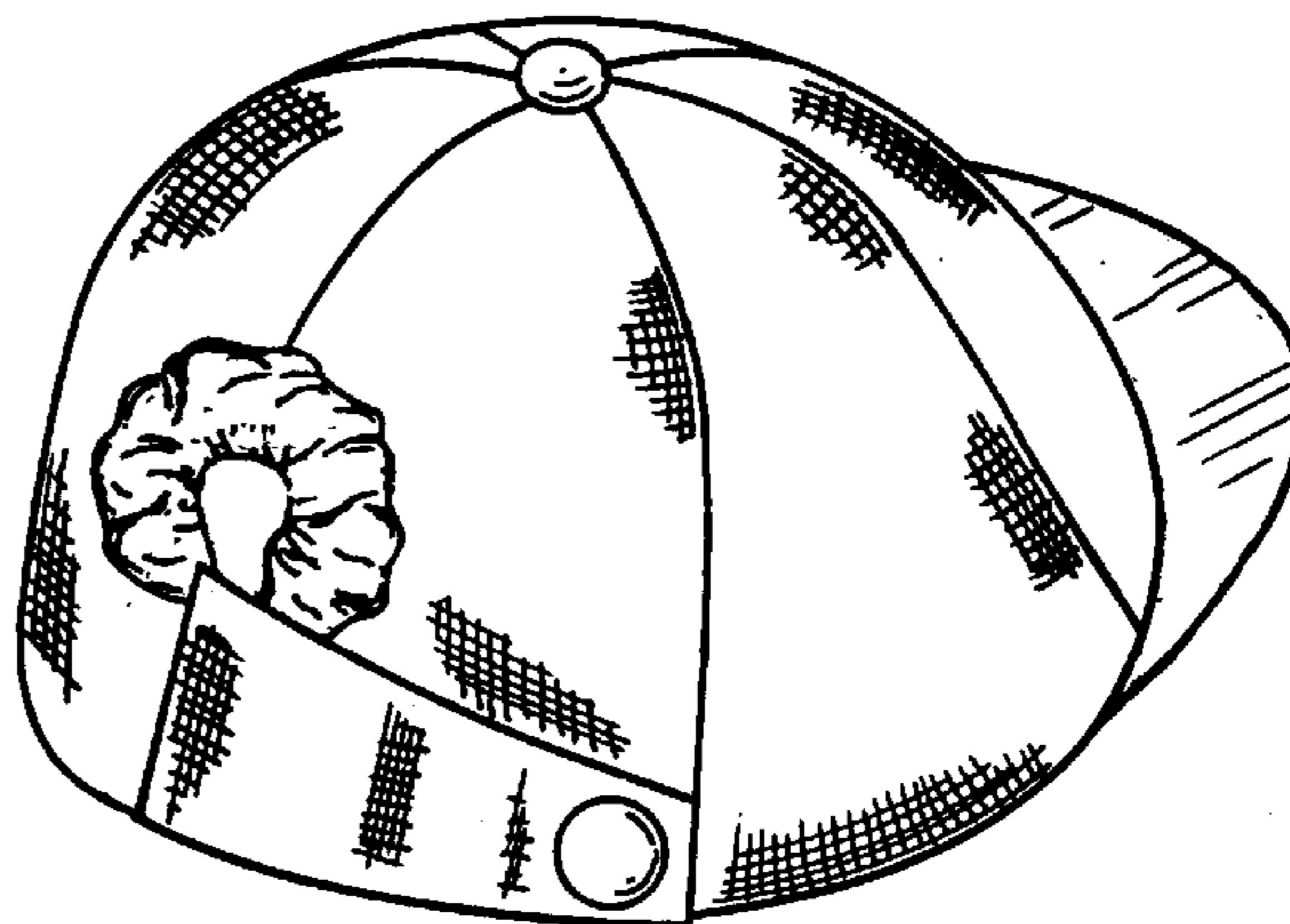
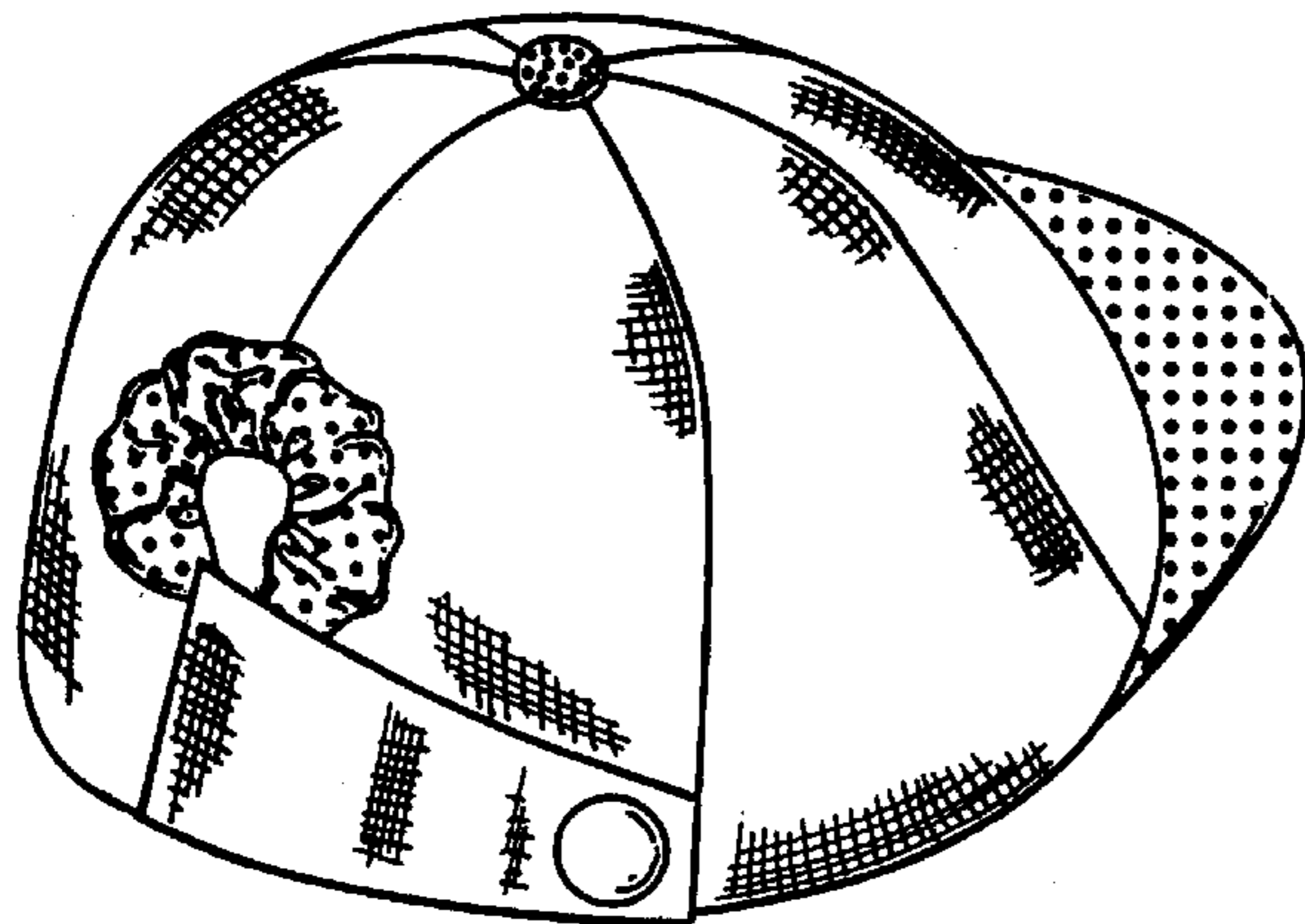

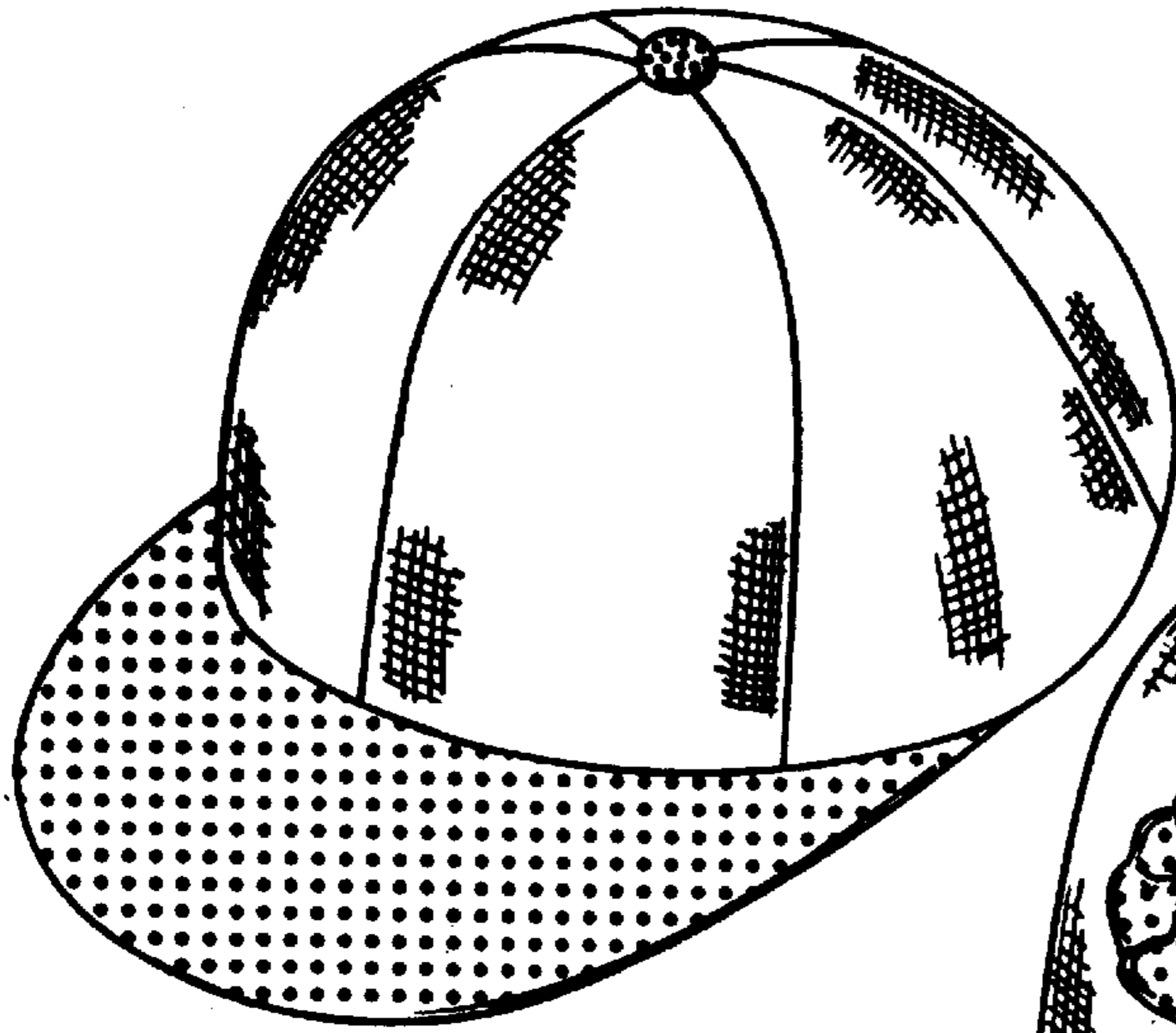

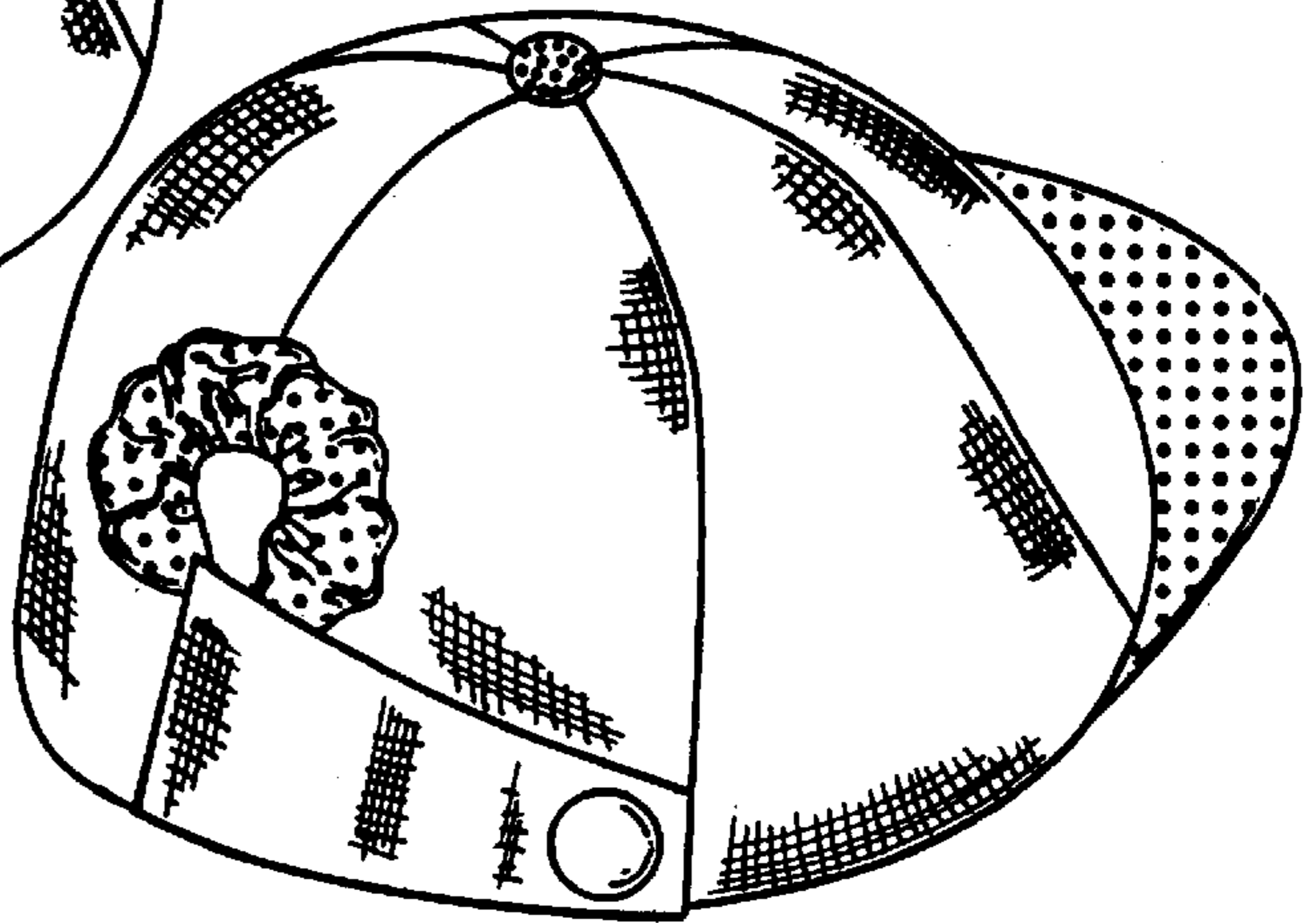

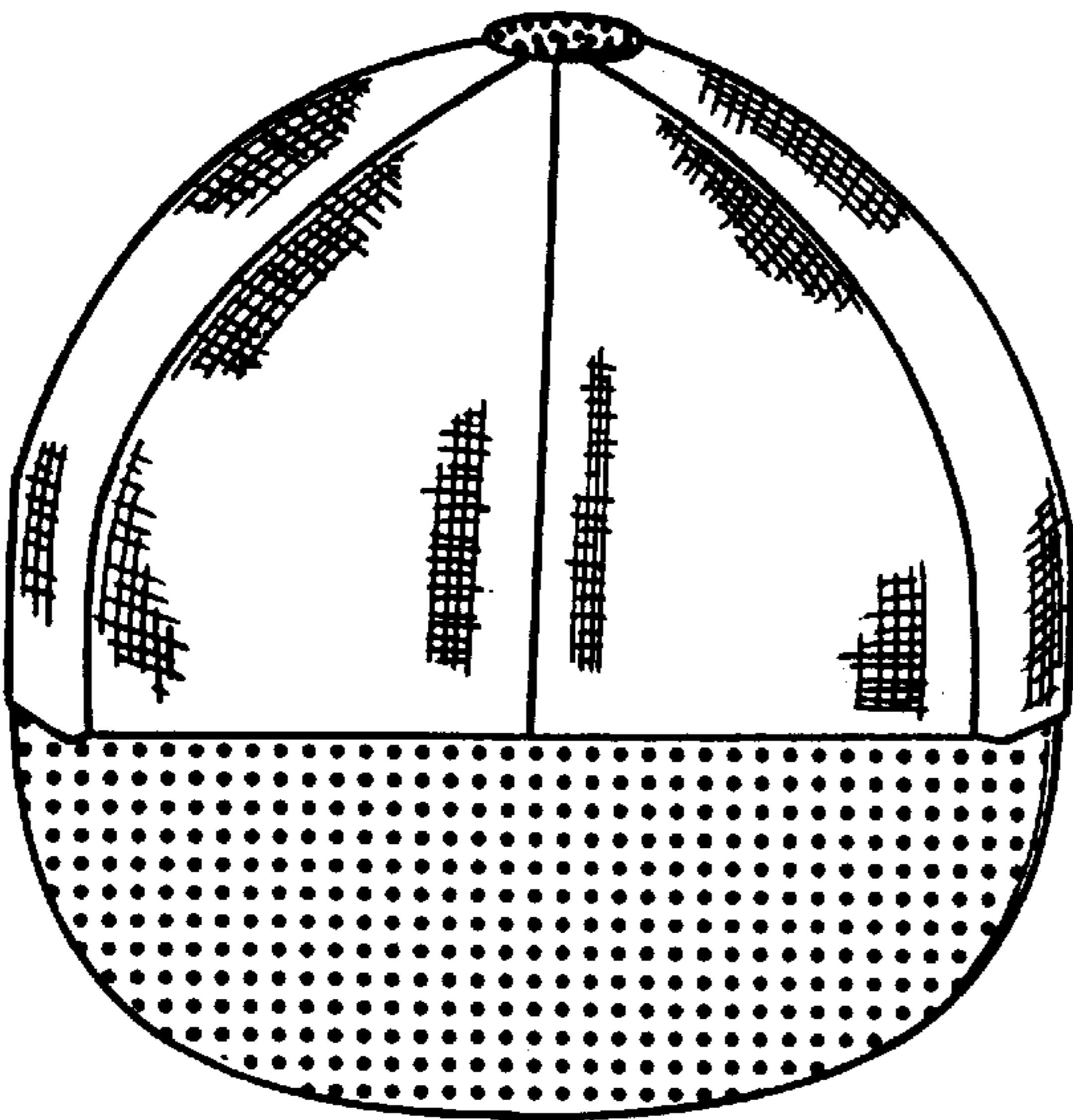




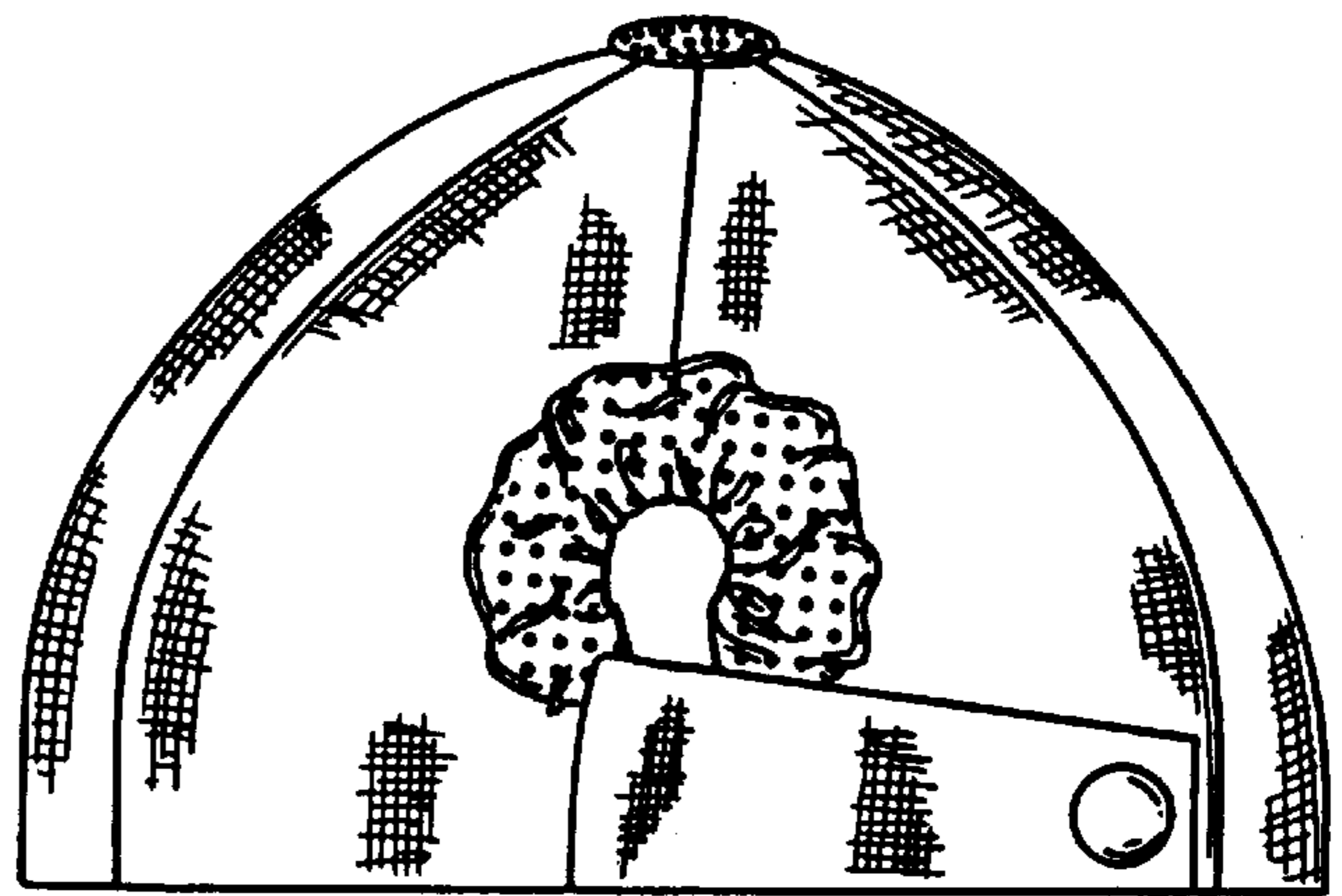

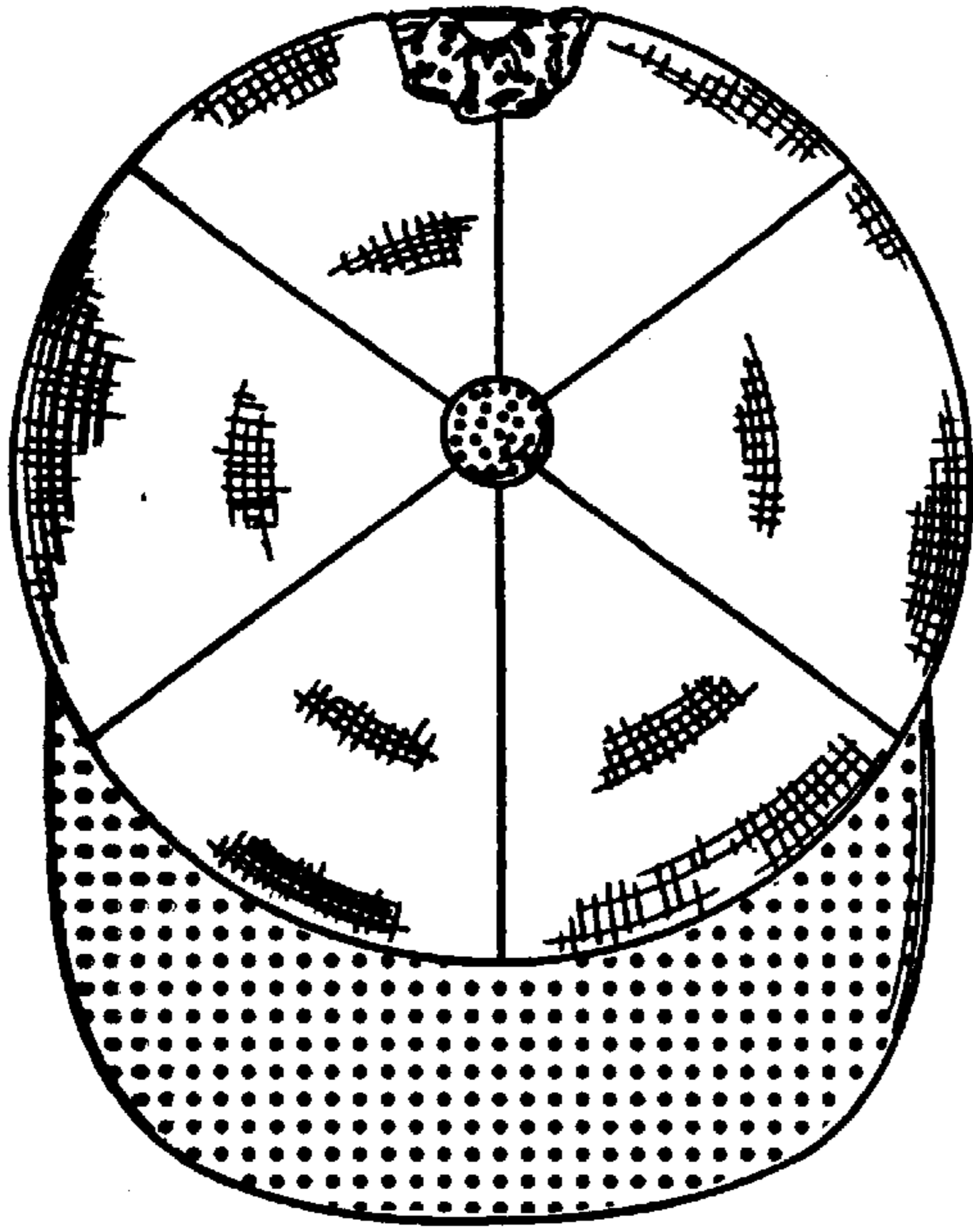

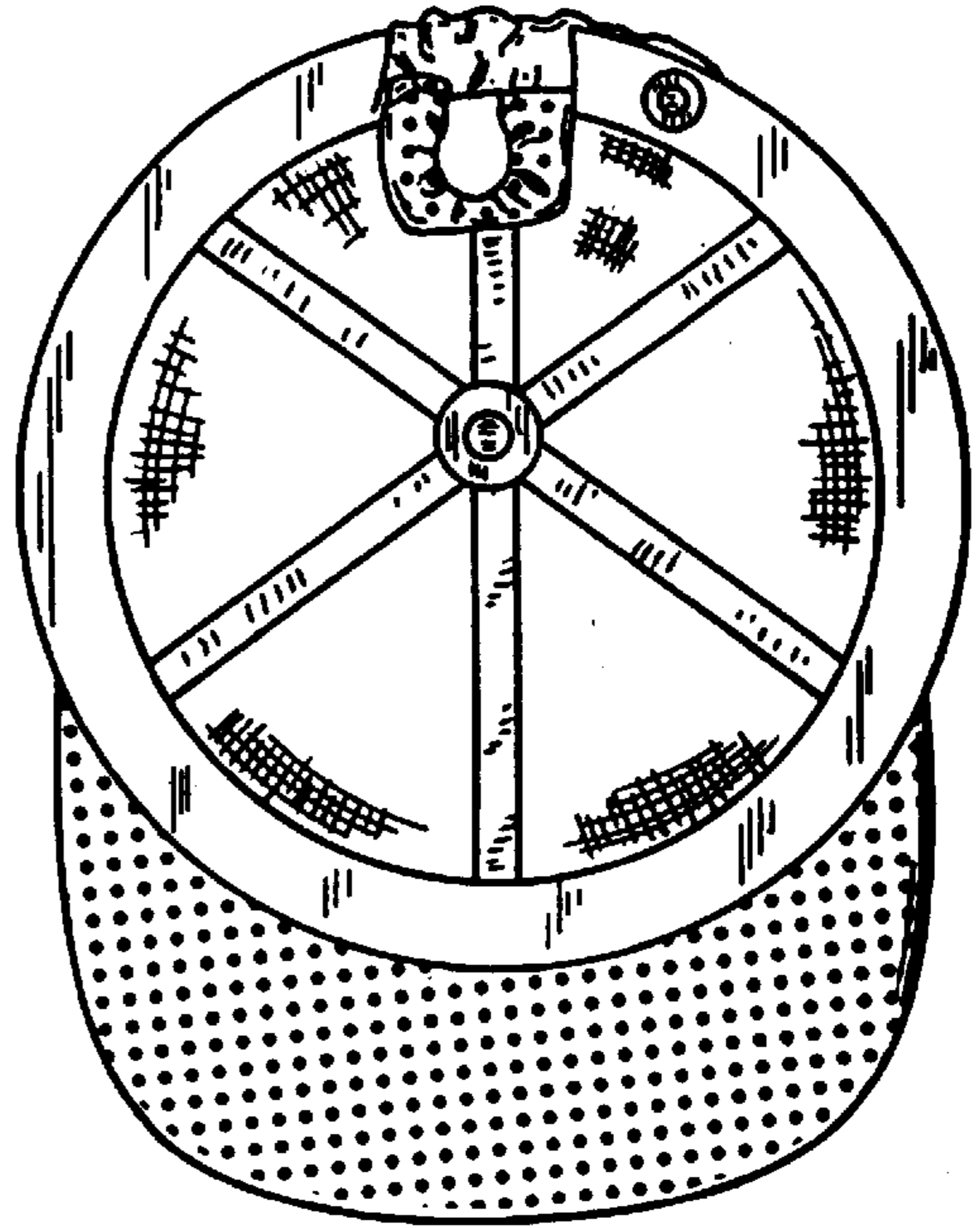

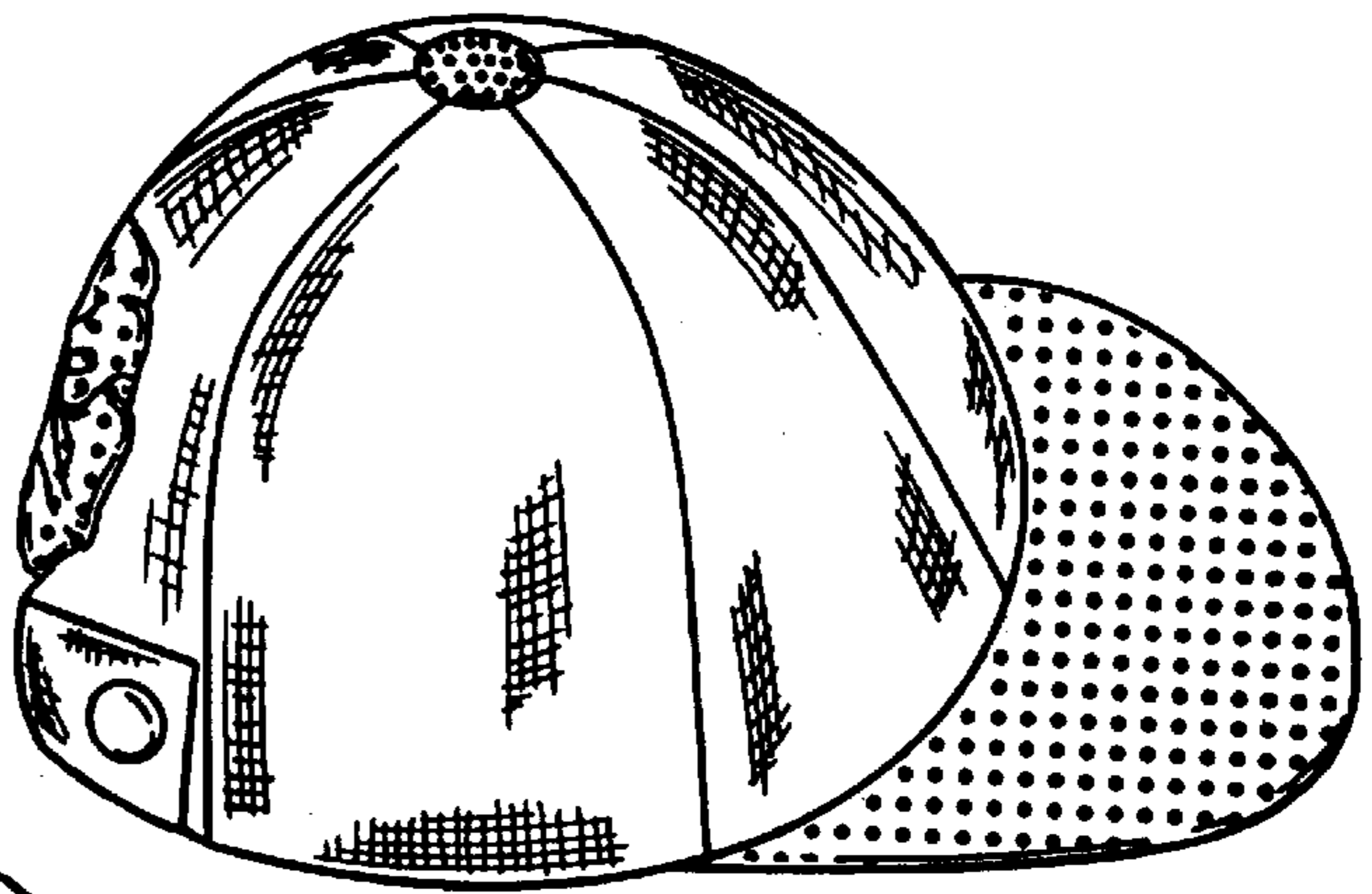

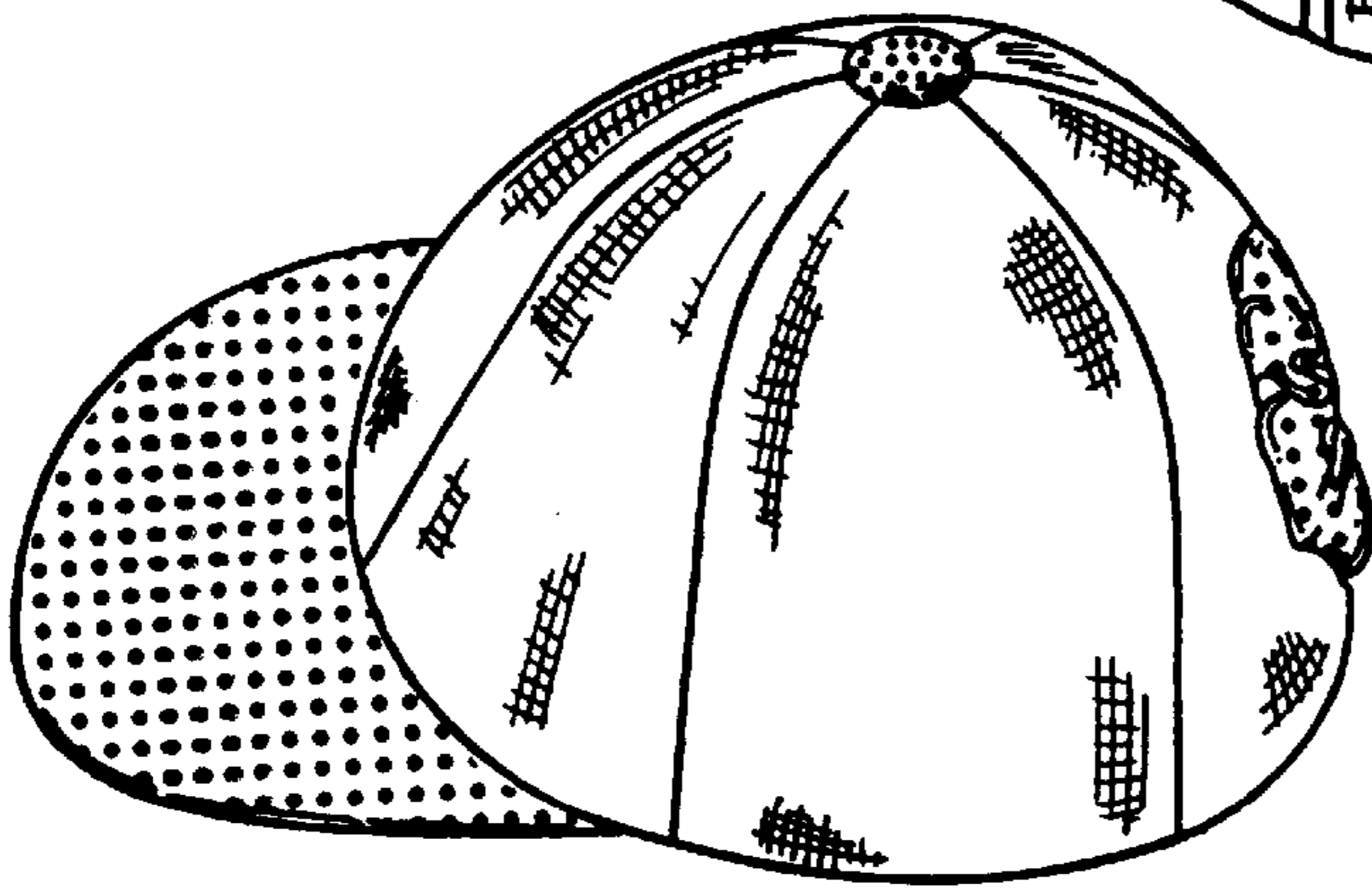

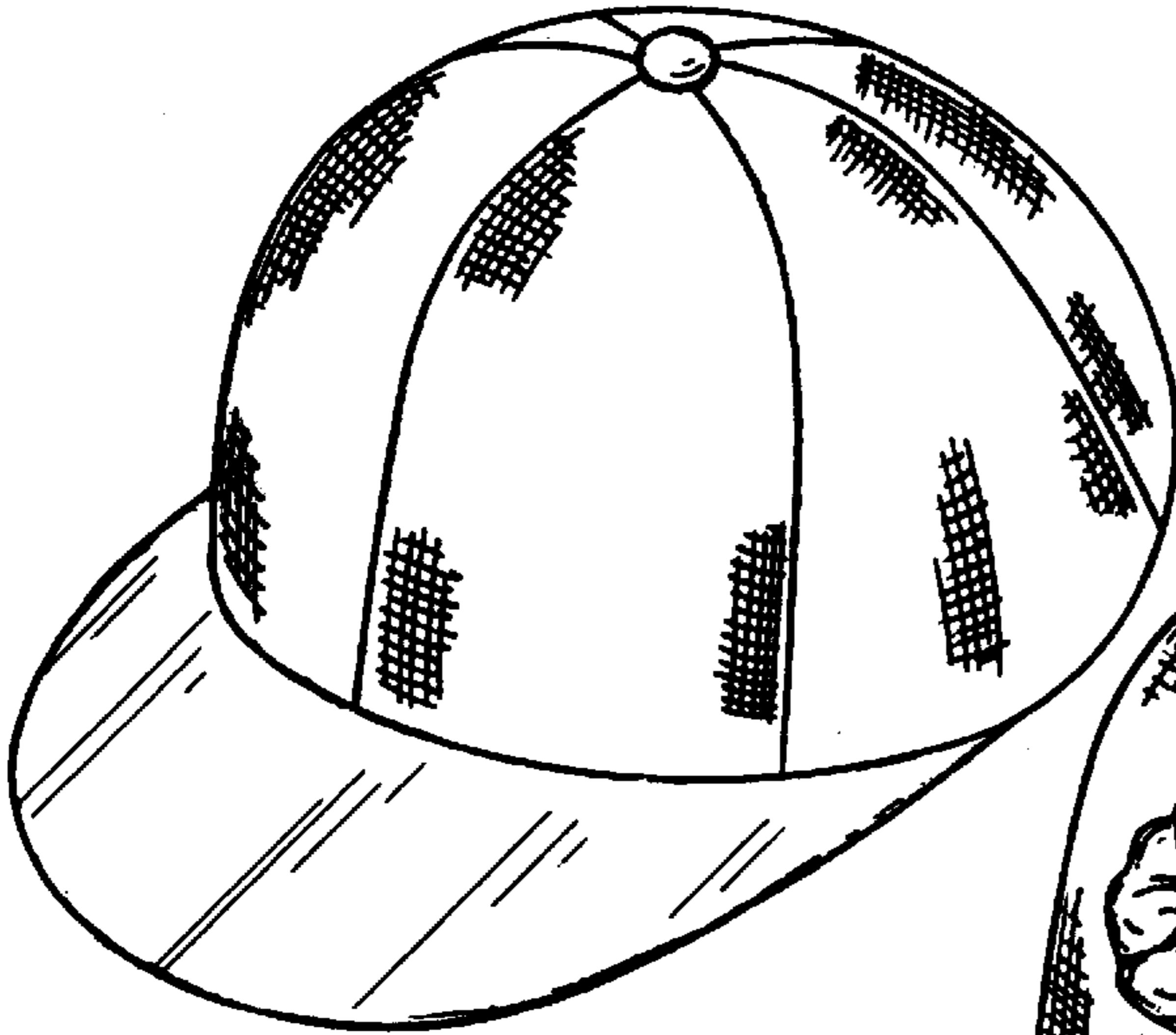

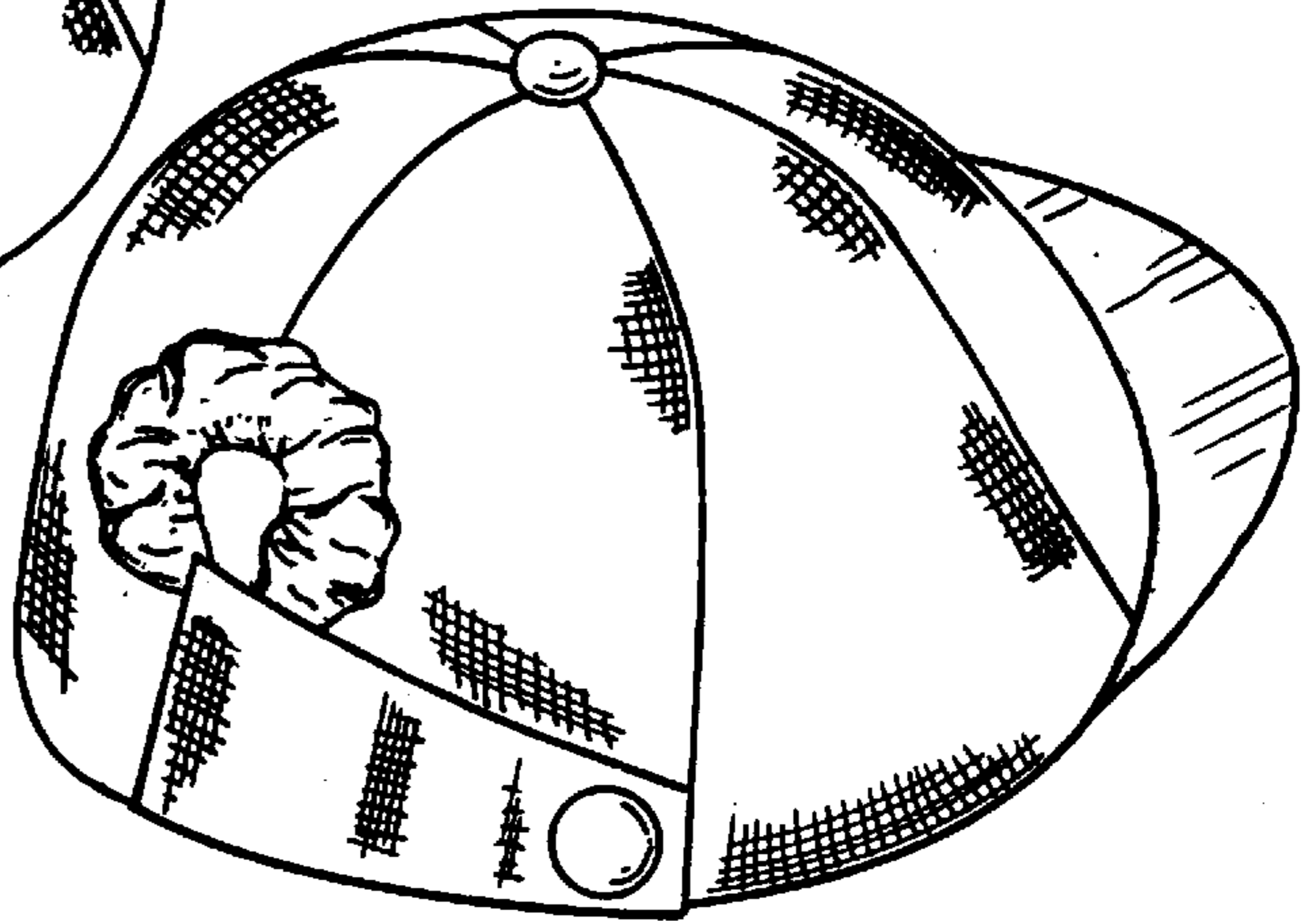

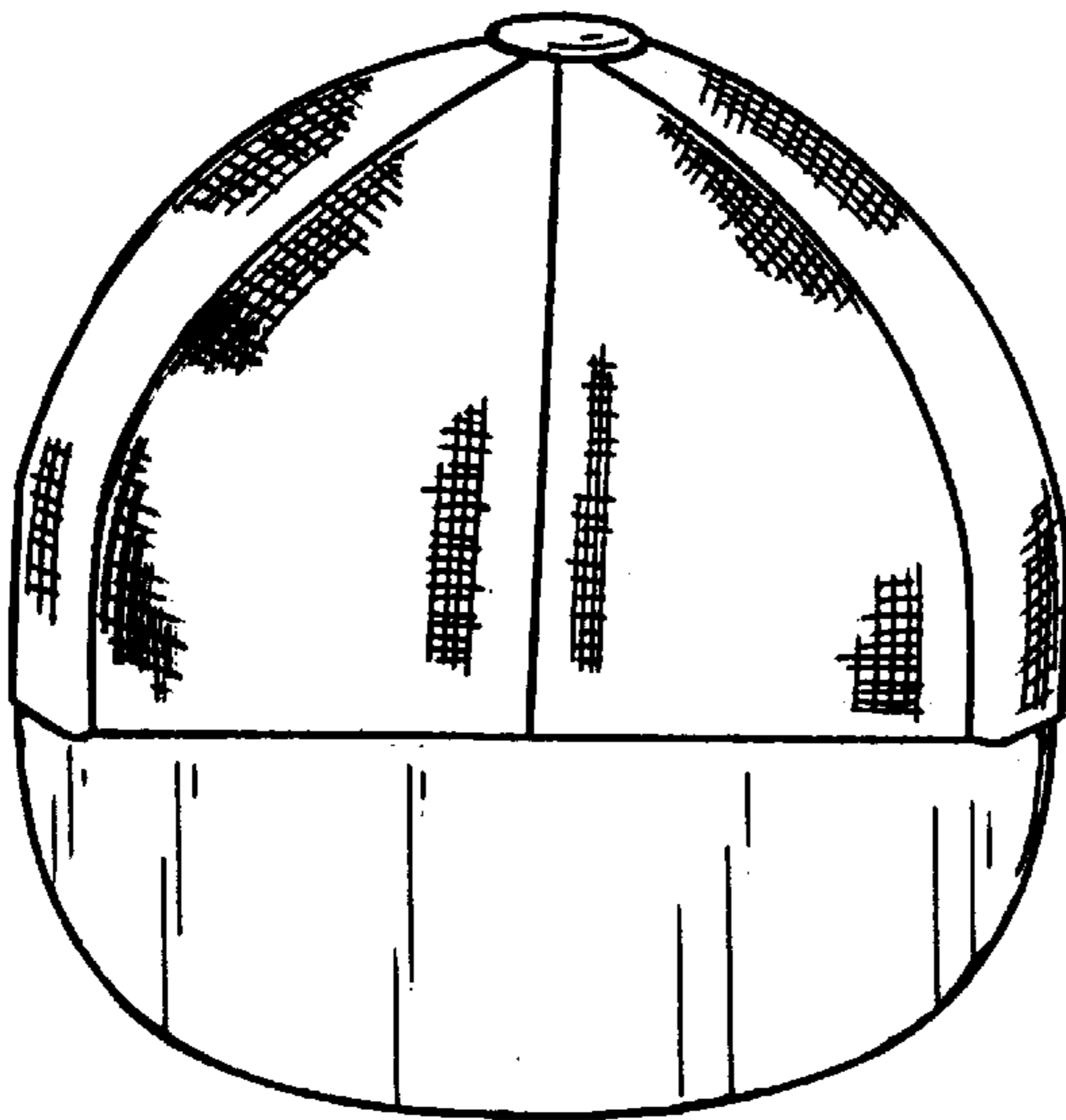

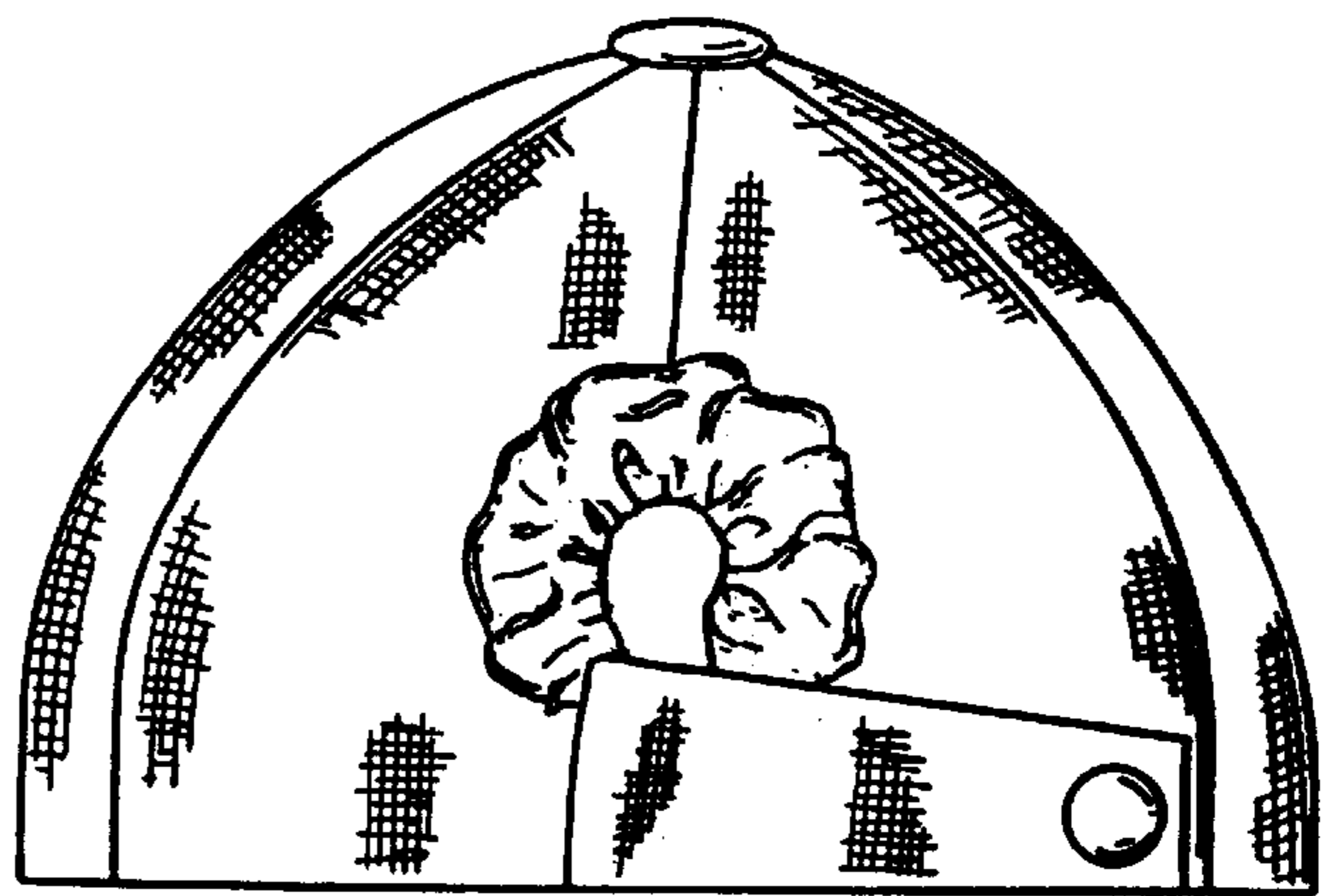

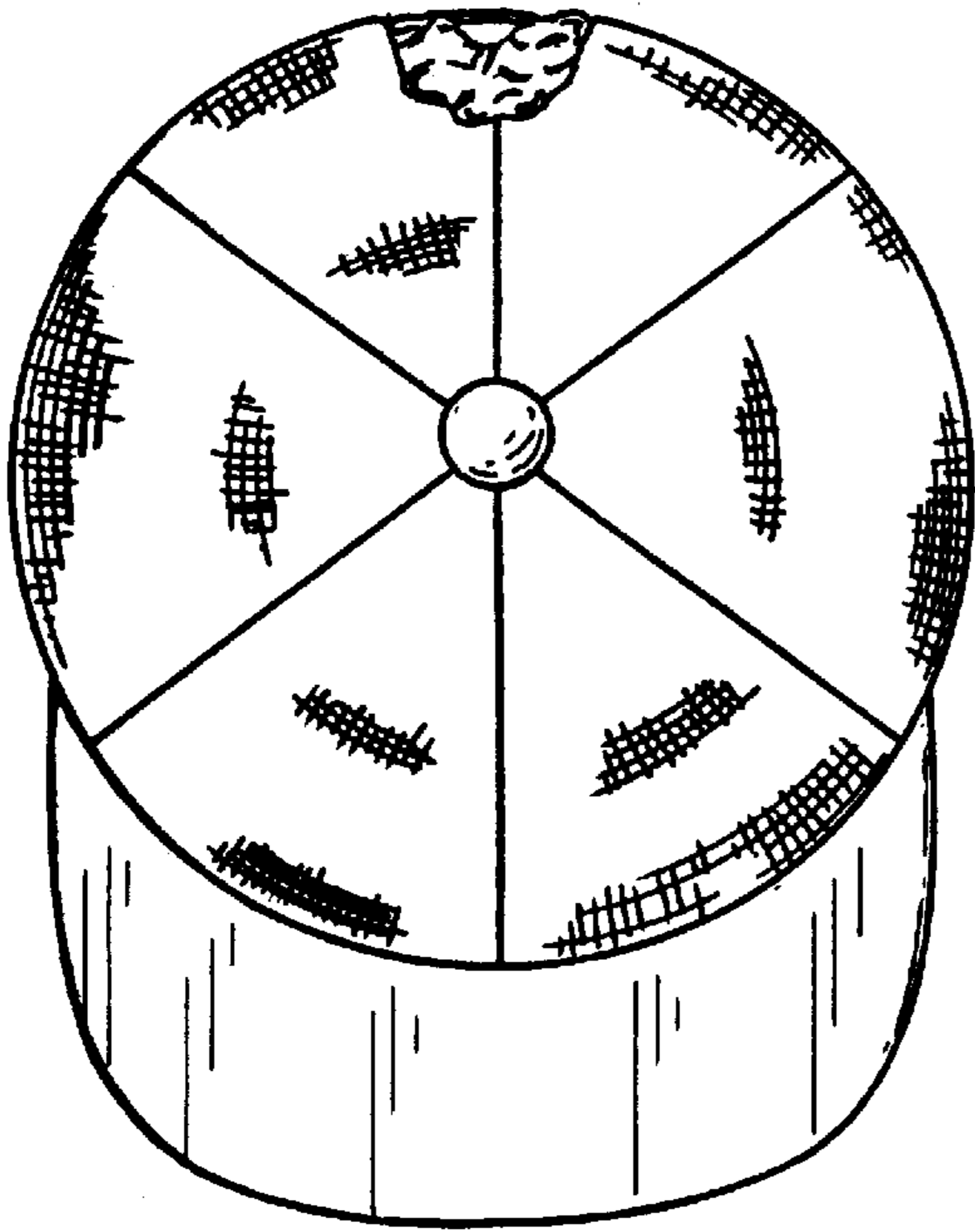

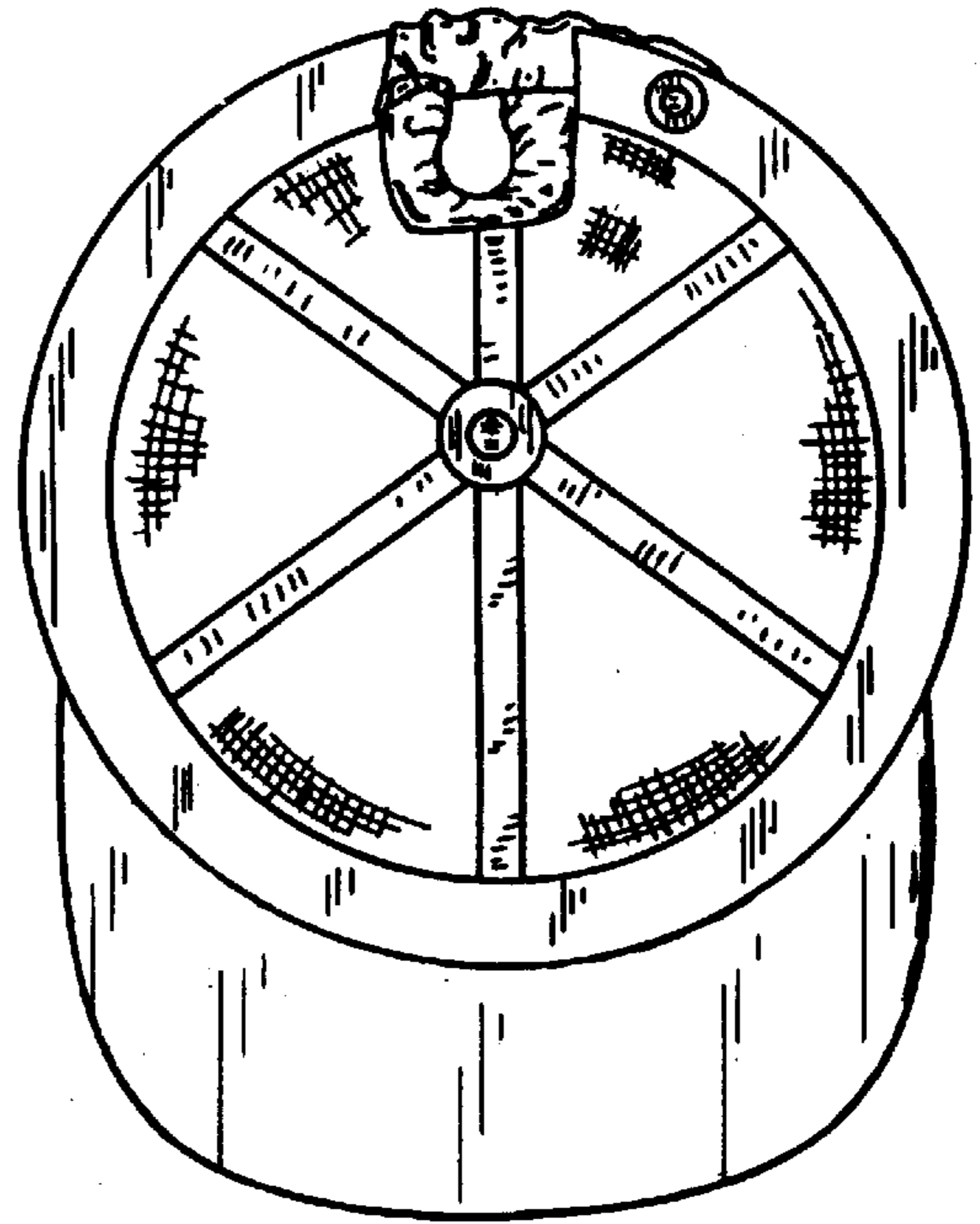

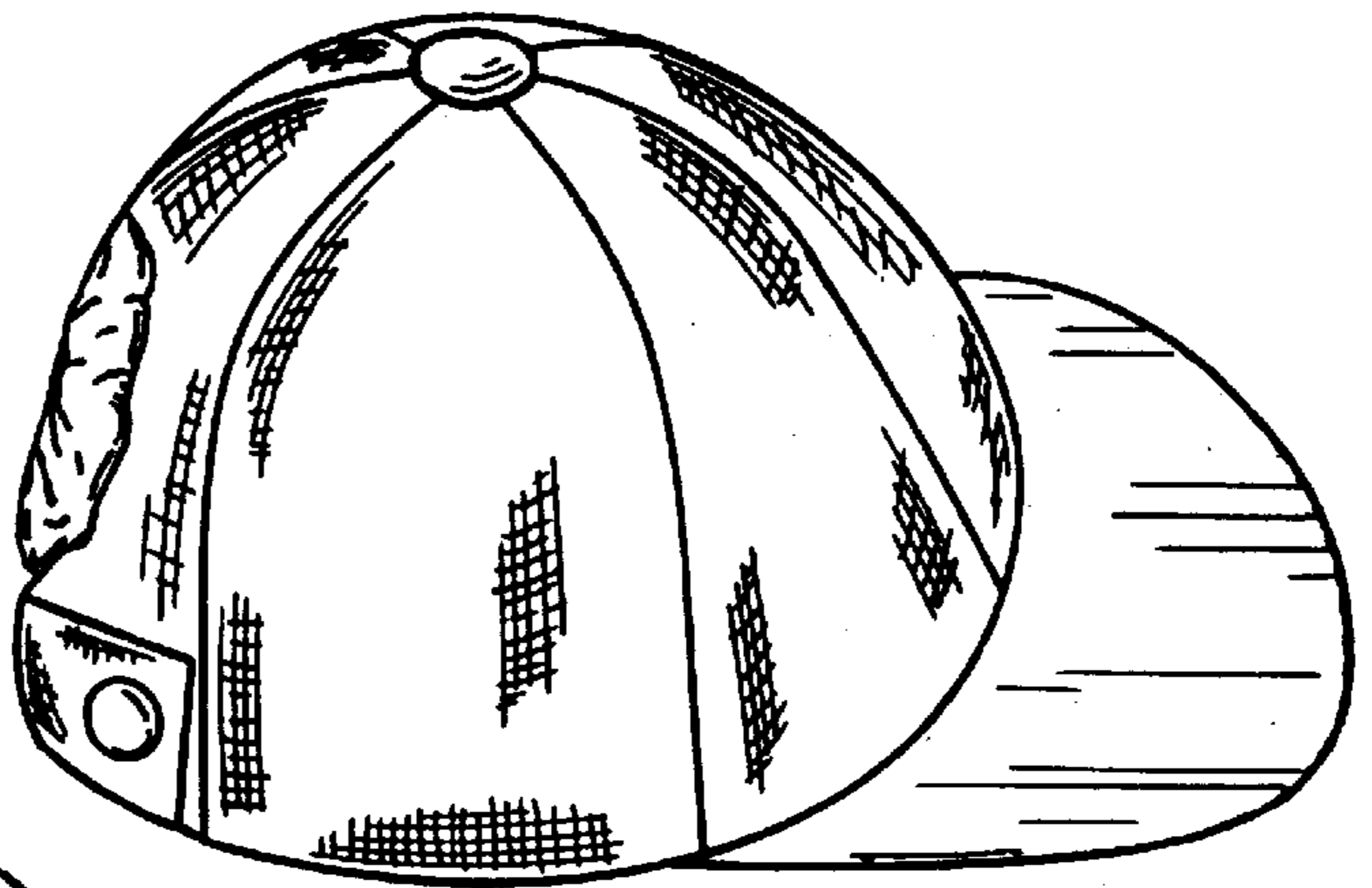

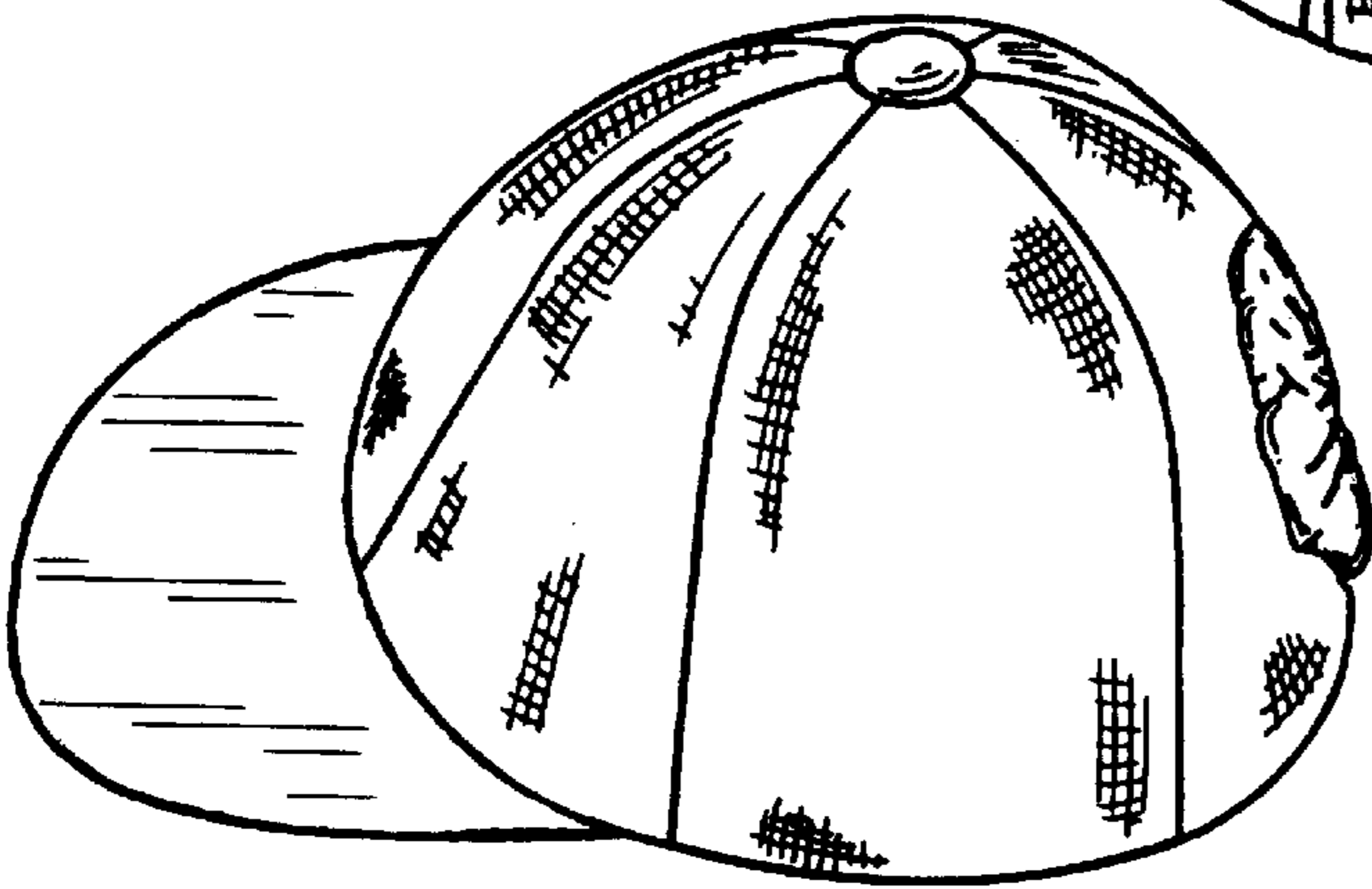
