### DESCRIPTION

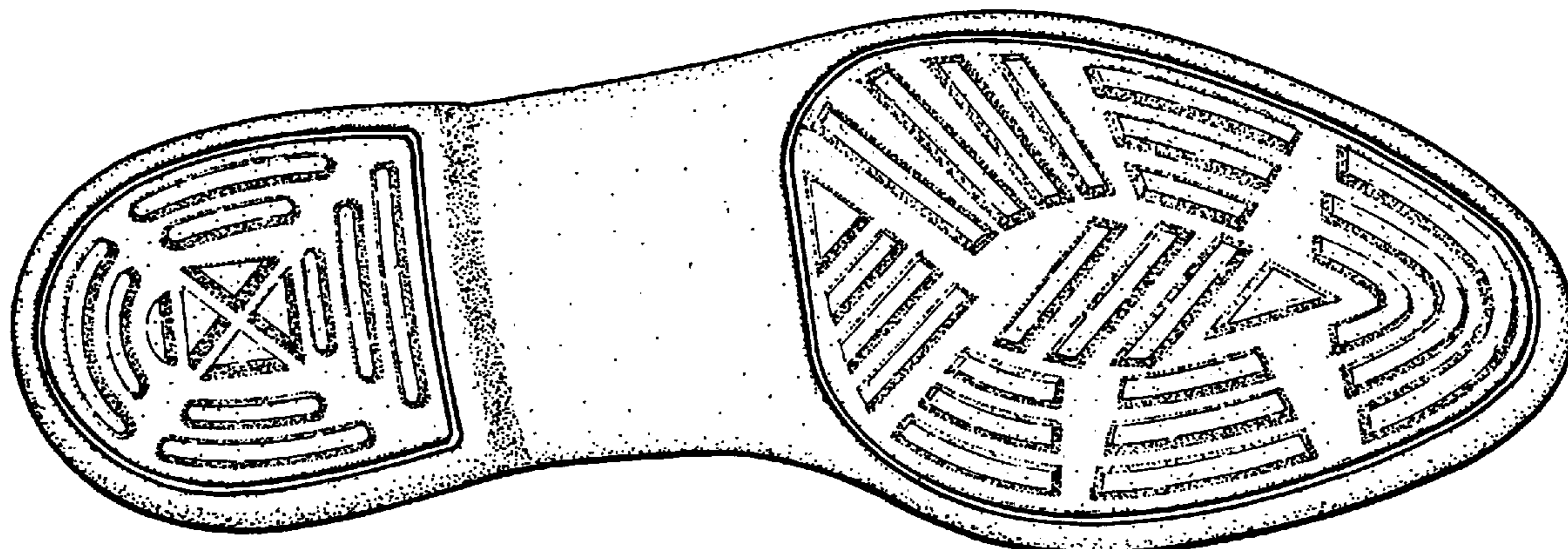
FIG. 1 is a bottom plan view of a shoe sole showing my new design;

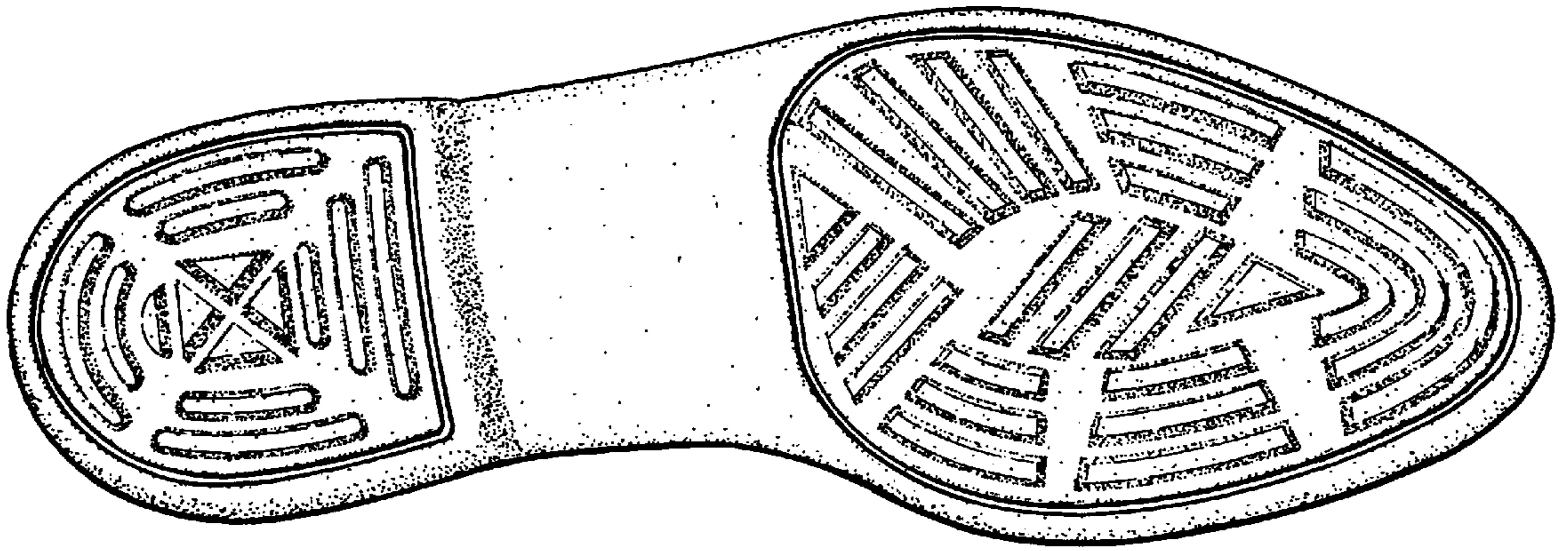

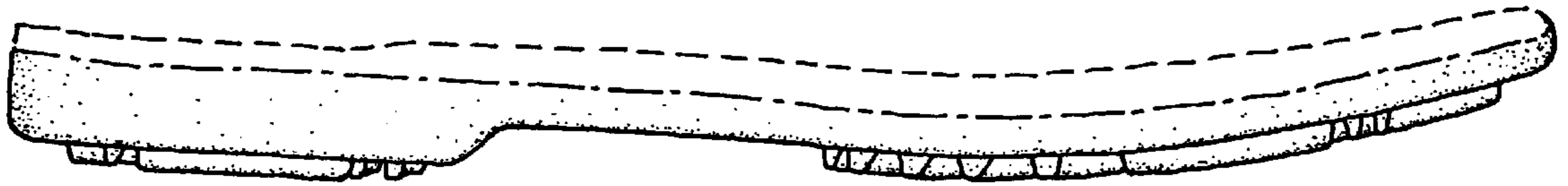

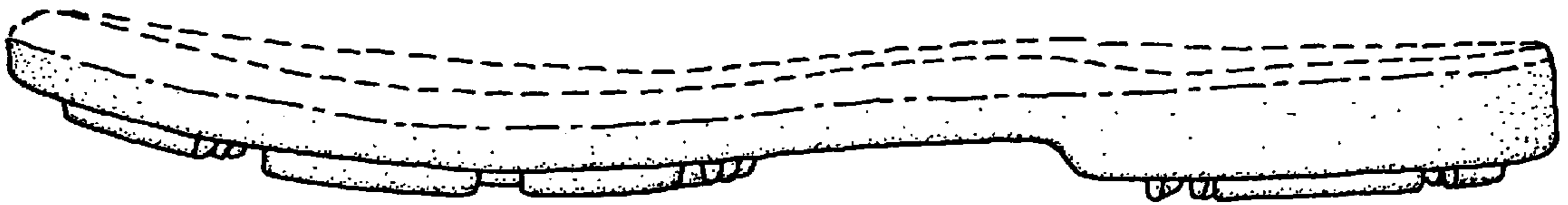

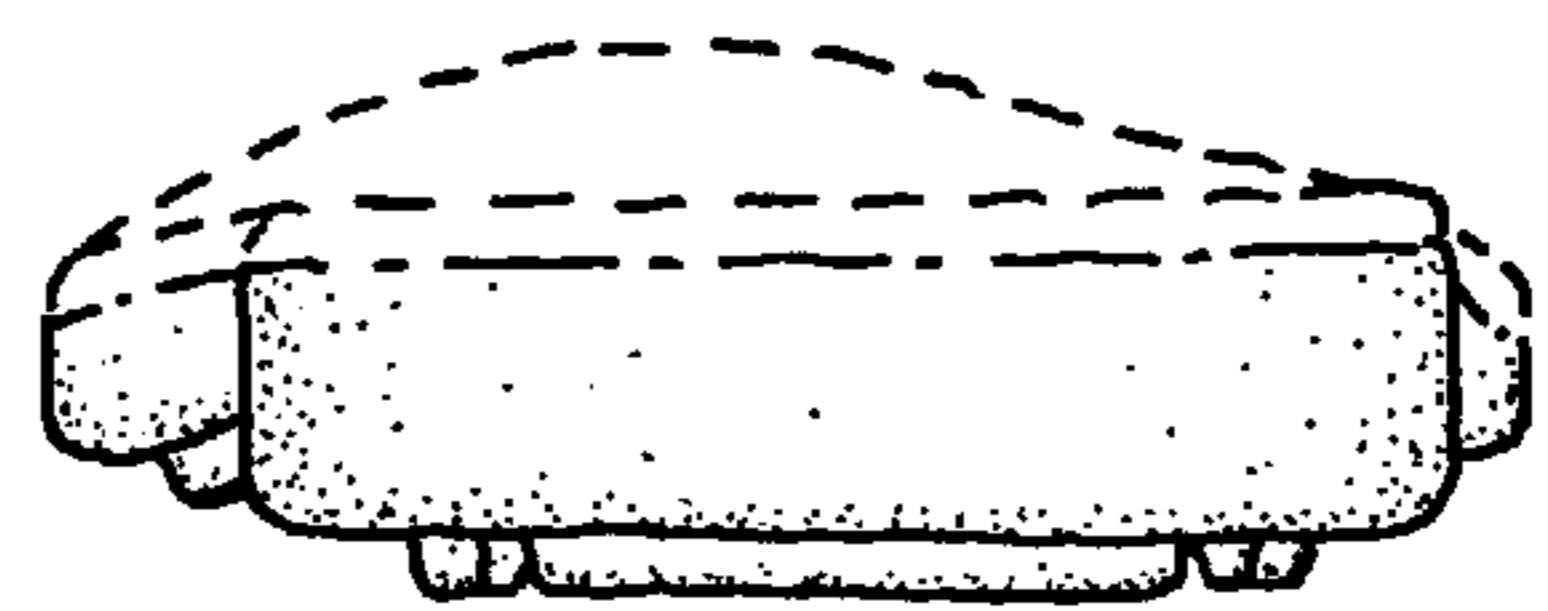
