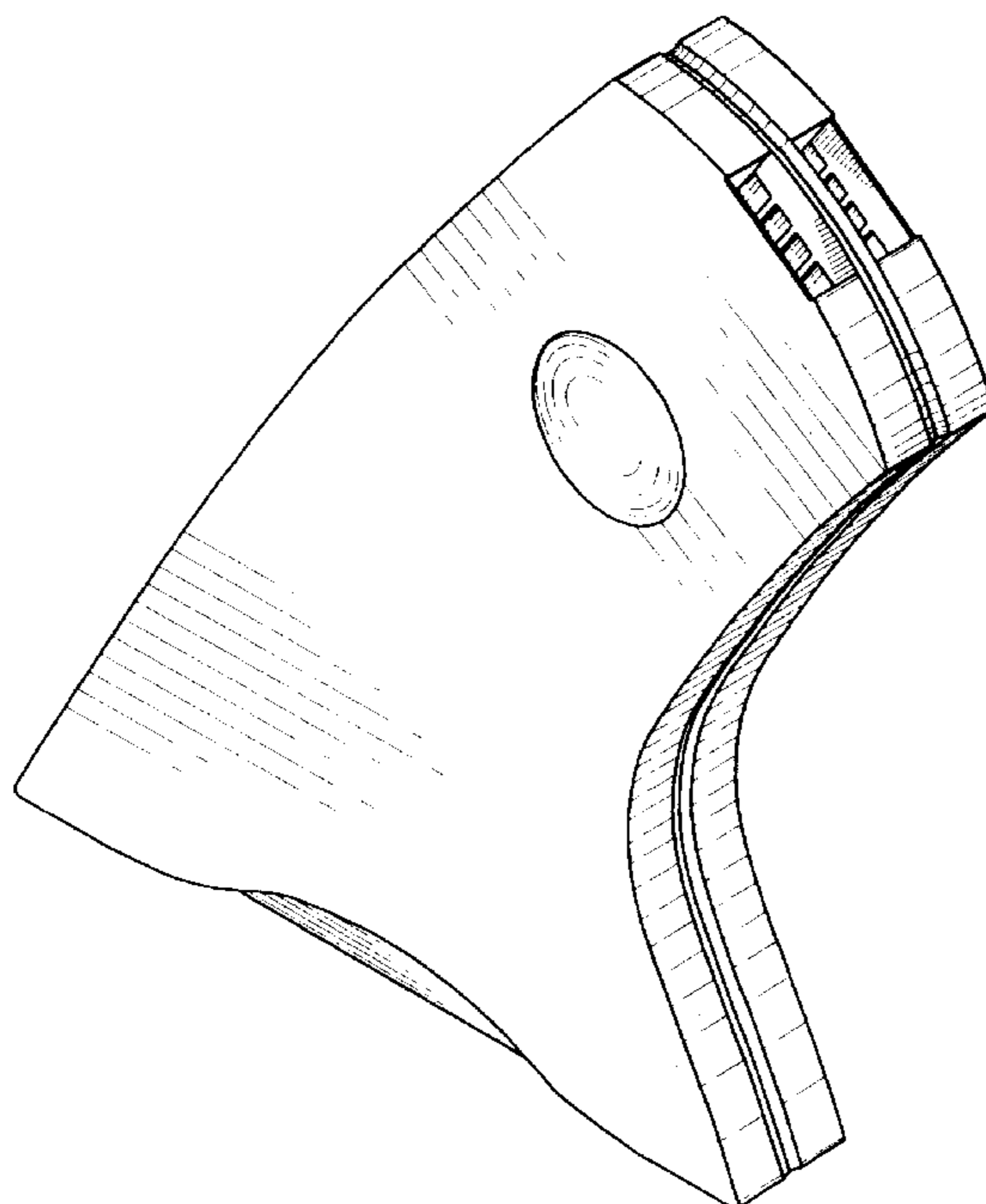
[57] **CLAIM**

The ornamental design for a countertop knife block, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a countertop knife block showing our new design; FIG. 2 is a top plan view of the countertop knife block; FIG. 3 is a left side elevational view of the countertop knife block, the right side elevational view being a mirror image thereof; FIG. 4 is a bottom plan view of the countertop knife block; FIG. 5 is a rear elevational view of the countertop knife block; and, FIG. 6 is a front elevational view of the countertop knife block.

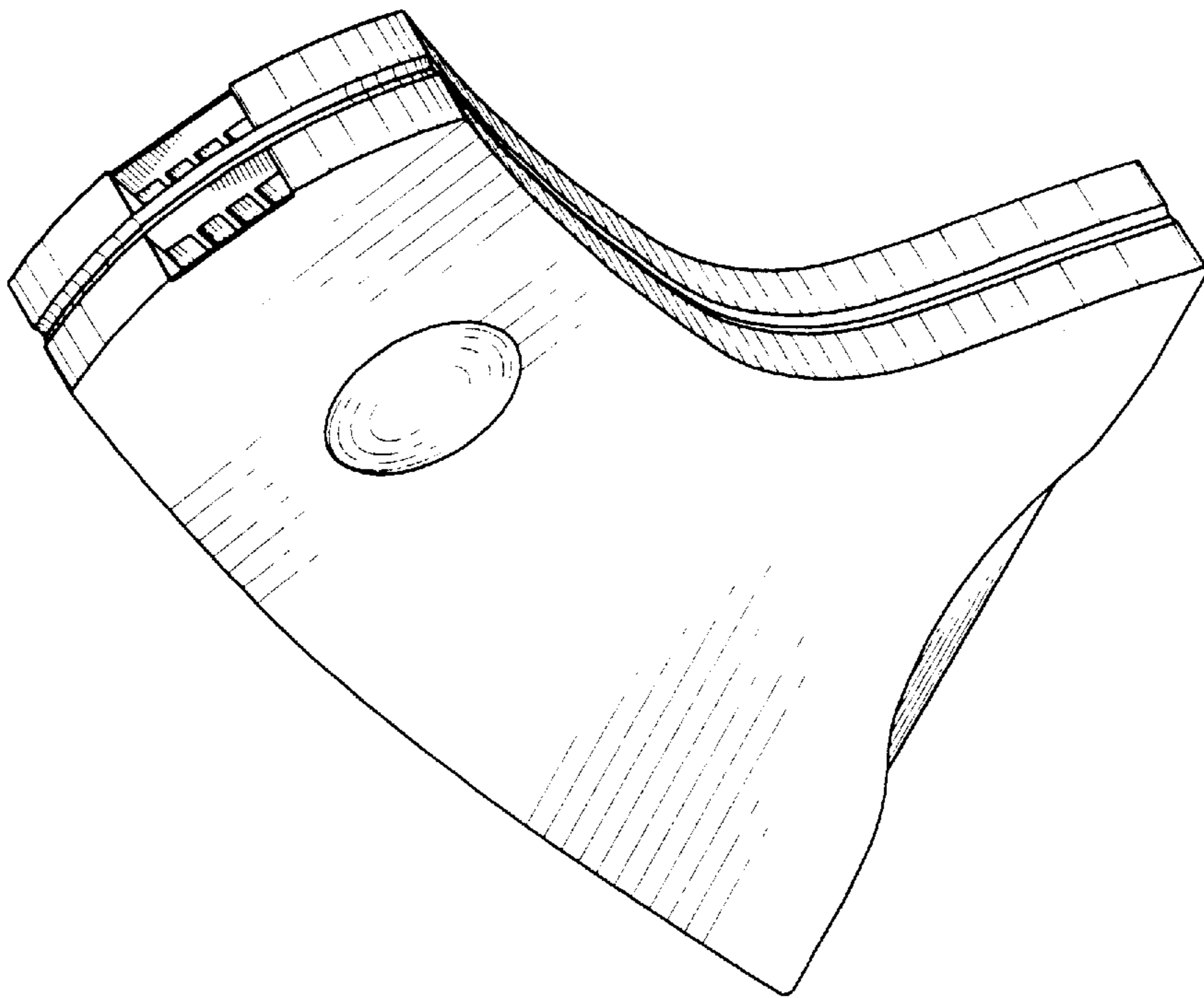

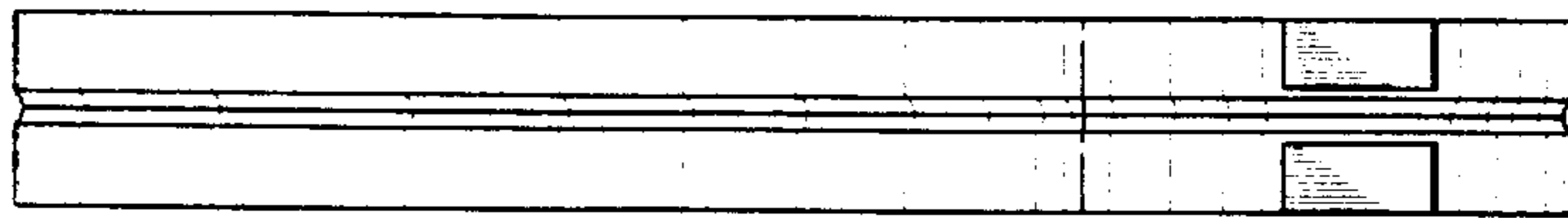

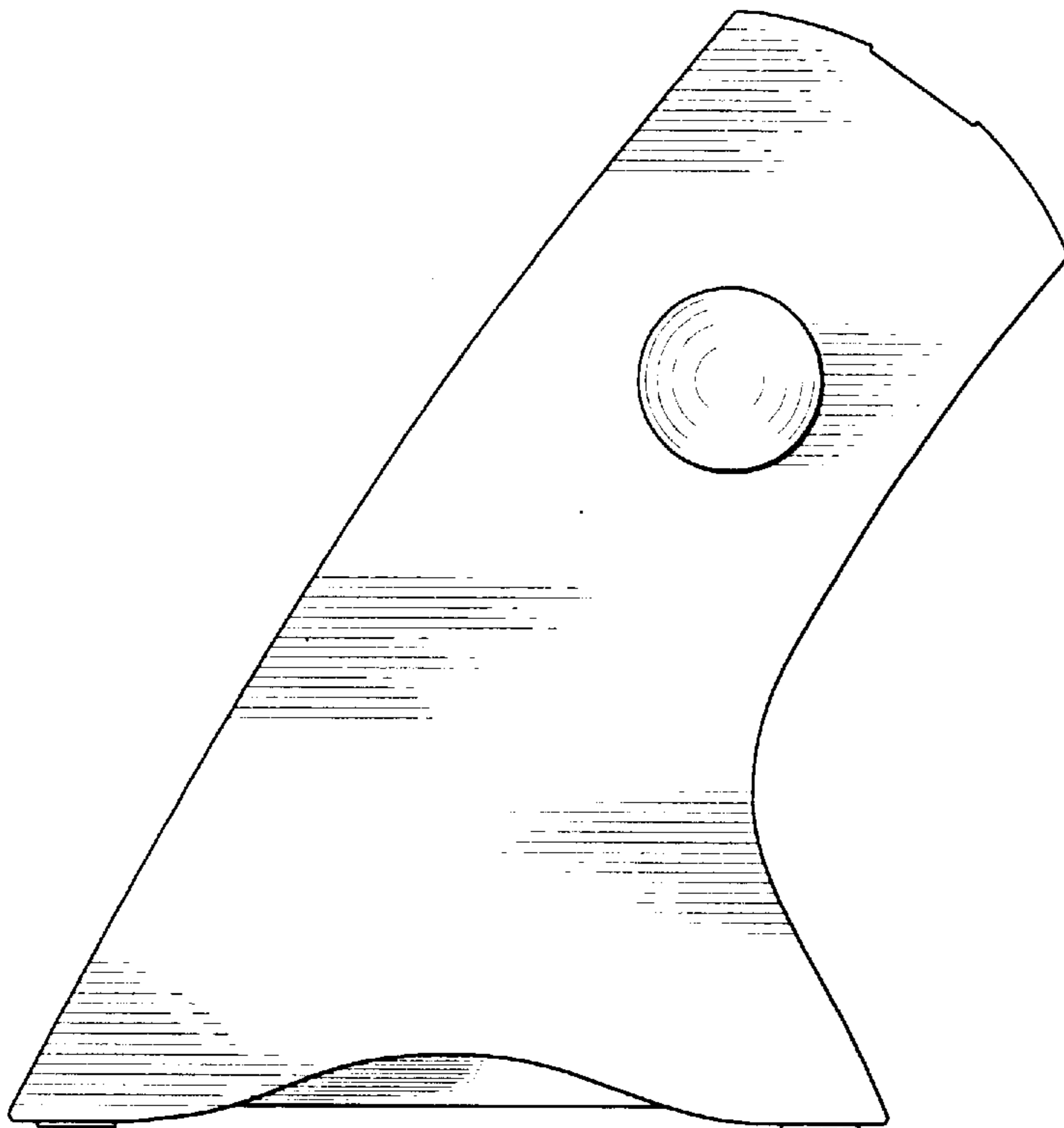

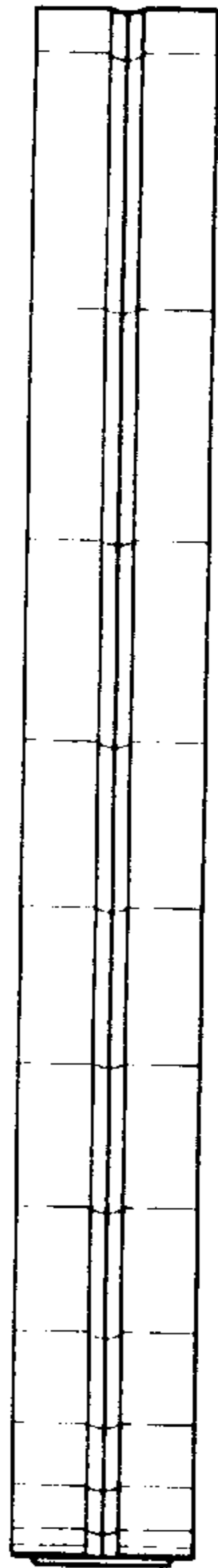
