[57] **CLAIM**

The ornamental design for a purse spray, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the design for a purse spray according to the invention;

FIG. 2 is a side view of the design for a purse spray according to the invention, the opposite side view being a mirror image thereof;

FIG. 3 is a rear view of the design for a purse spray according to the invention;

FIG. 4 is a front view of the design for a purse spray according to the invention;

FIG. 5 is an overhead view of the design for a purse spray according to the invention;

FIG. 6 is an underside view of the design for a purse spray according to the invention;

FIG. 7 is a bottom half view of the design for a purse spray according to the invention;

FIG. 8 is a perspective view of a second embodiment of a purse spray according to the invention;

FIG. 9 is a side view of a second embodiment of a purse spray according to the invention, the opposite side view being a mirror image thereof;

FIG. 10 is a rear view of a second embodiment of a purse spray according to the invention;

FIG. 11 is a front view of a second embodiment of a purse spray according to the invention;

FIG. 12 is an overhead view of a second embodiment of a purse spray according to the invention;

FIG. 13 is an underside view of a second embodiment of a purse spray according to the invention; and,

FIG. 14 is a bottom half view of a second embodiment of a purse spray according to the invention.

The bottom surface of the upper cap portion of the purse spray forms no part of the claimed design.

The broken lines shown in FIGS. 7 and 14 represent environmental structure and define the bounds of the claimed design and form no part thereof.

The broken lines defining the peripheral boundary of the second embodiment of the claimed design (FIGS. 8–14) form no part thereof.




























