[57] **CLAIM**

The ornamental design for a reverse taper ribbed closure, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the reverse taper ribbed closure of the subject invention;

FIG. 2 is a side view of the reverse taper ribbed closure of FIG. 1, the opposite side being identical;

FIG. 3 is a top plan view of the reverse taper ribbed closure of FIG. 1;

FIG. 4 is a bottom plan view of the reverse taper ribbed closure of FIG. 1;

FIG. 5 is a perspective view of another embodiment of the reverse taper ribbed closure of the subject invention having a tamper evident band;

FIG. 6 is a side view of the reverse taper ribbed closure of FIG. 5;

FIG. 7 is a top plan view of the reverse taper ribbed closure of FIG. 5; and,

FIG. 8 is a bottom plan view of the reverse taper ribbed closure of FIG. 5.

The broken line showing of the interior of the closure is for illustrative purposes only and forms no part of the claimed design.

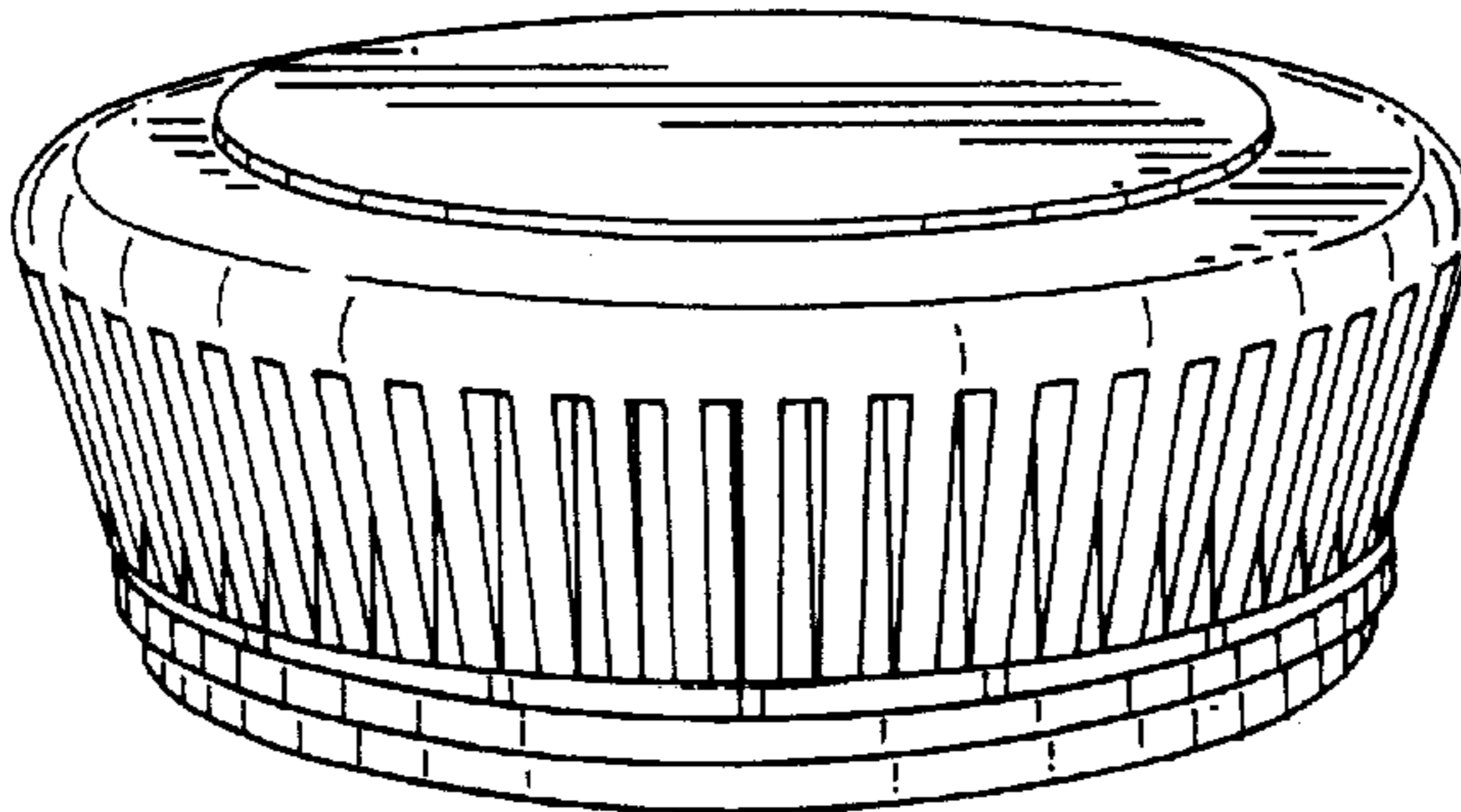
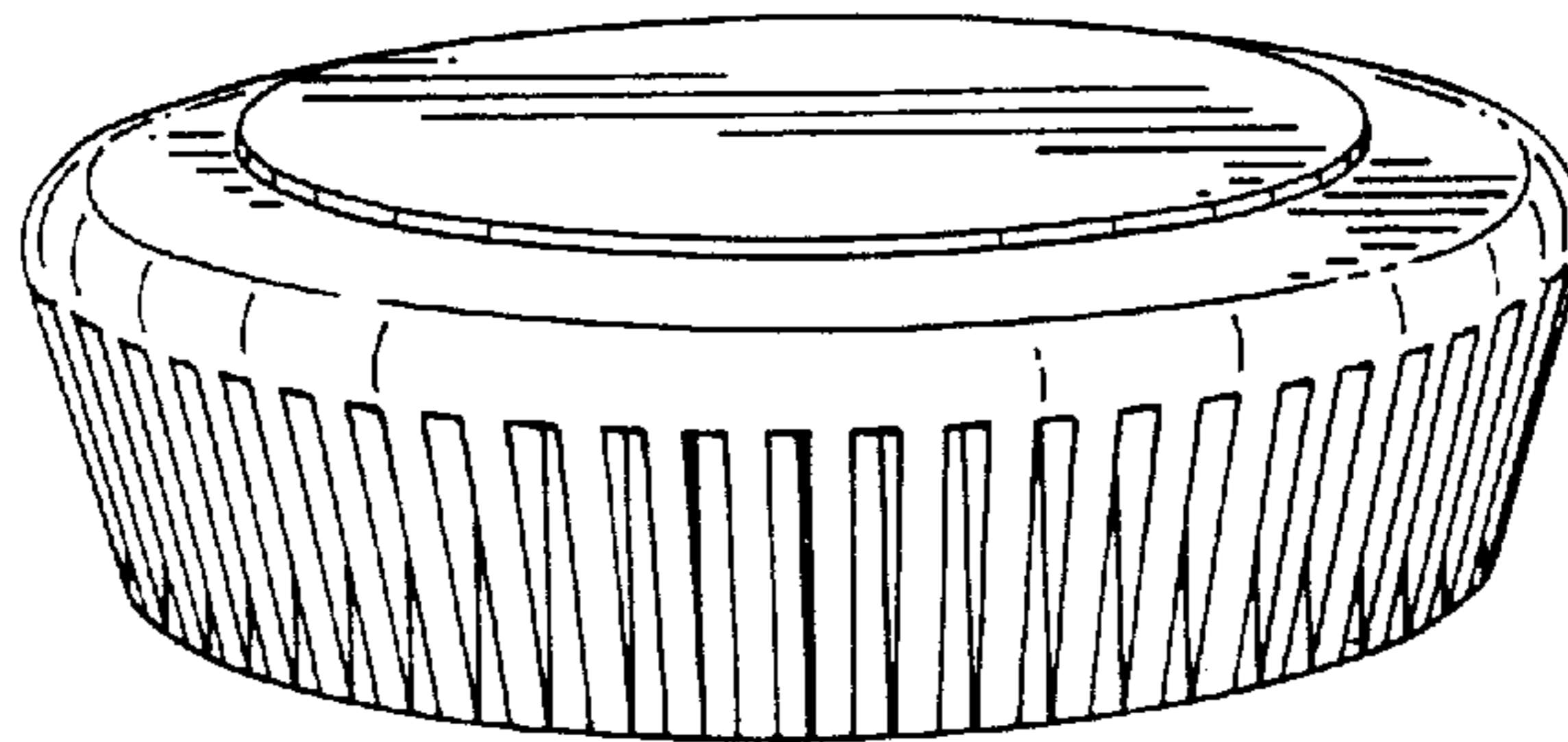

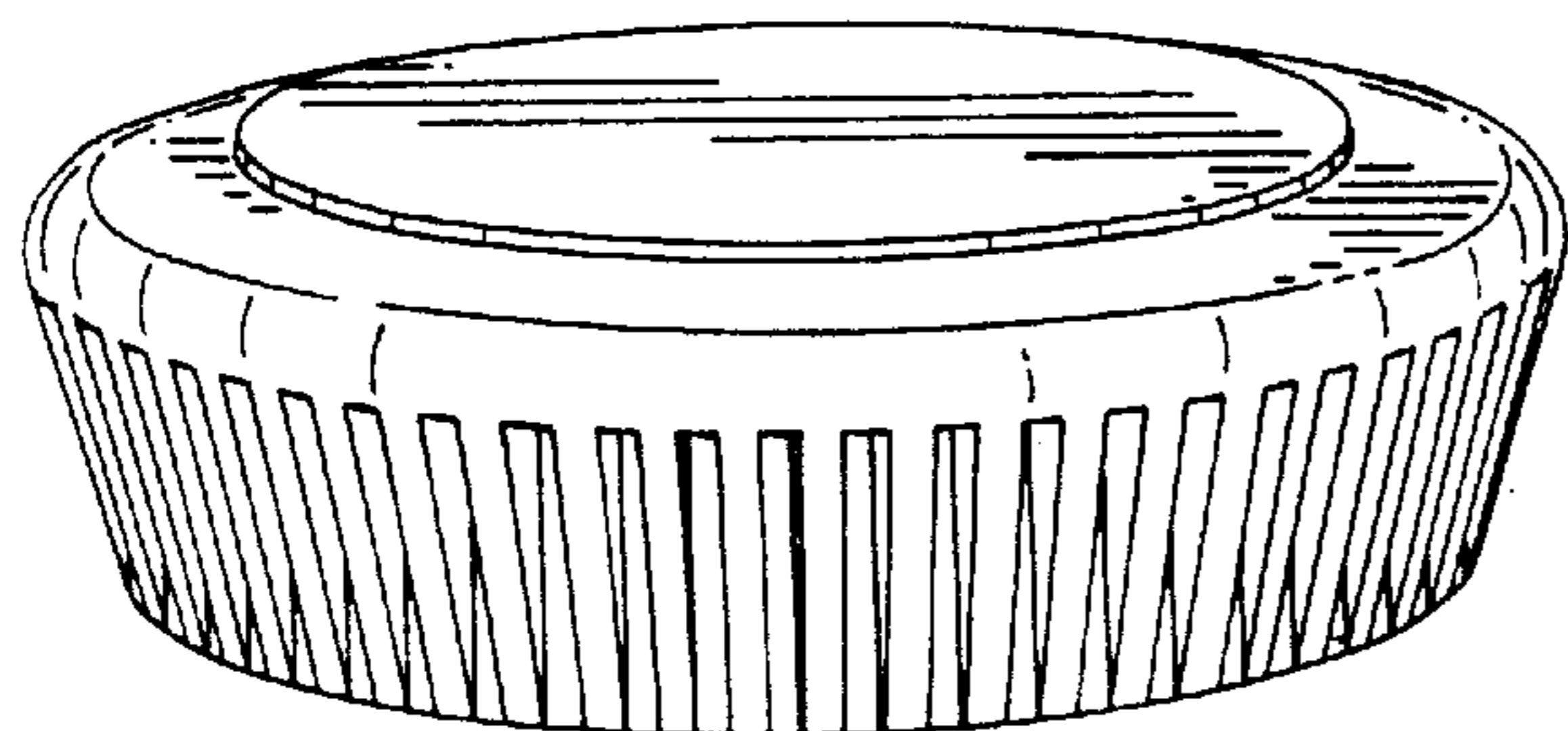

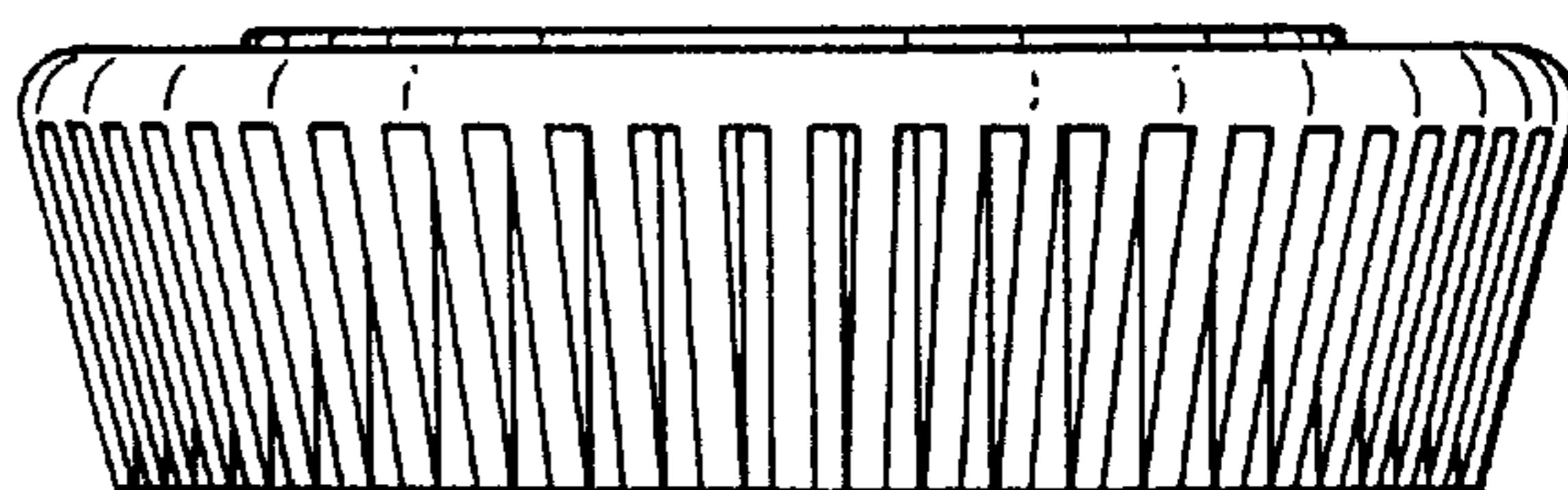

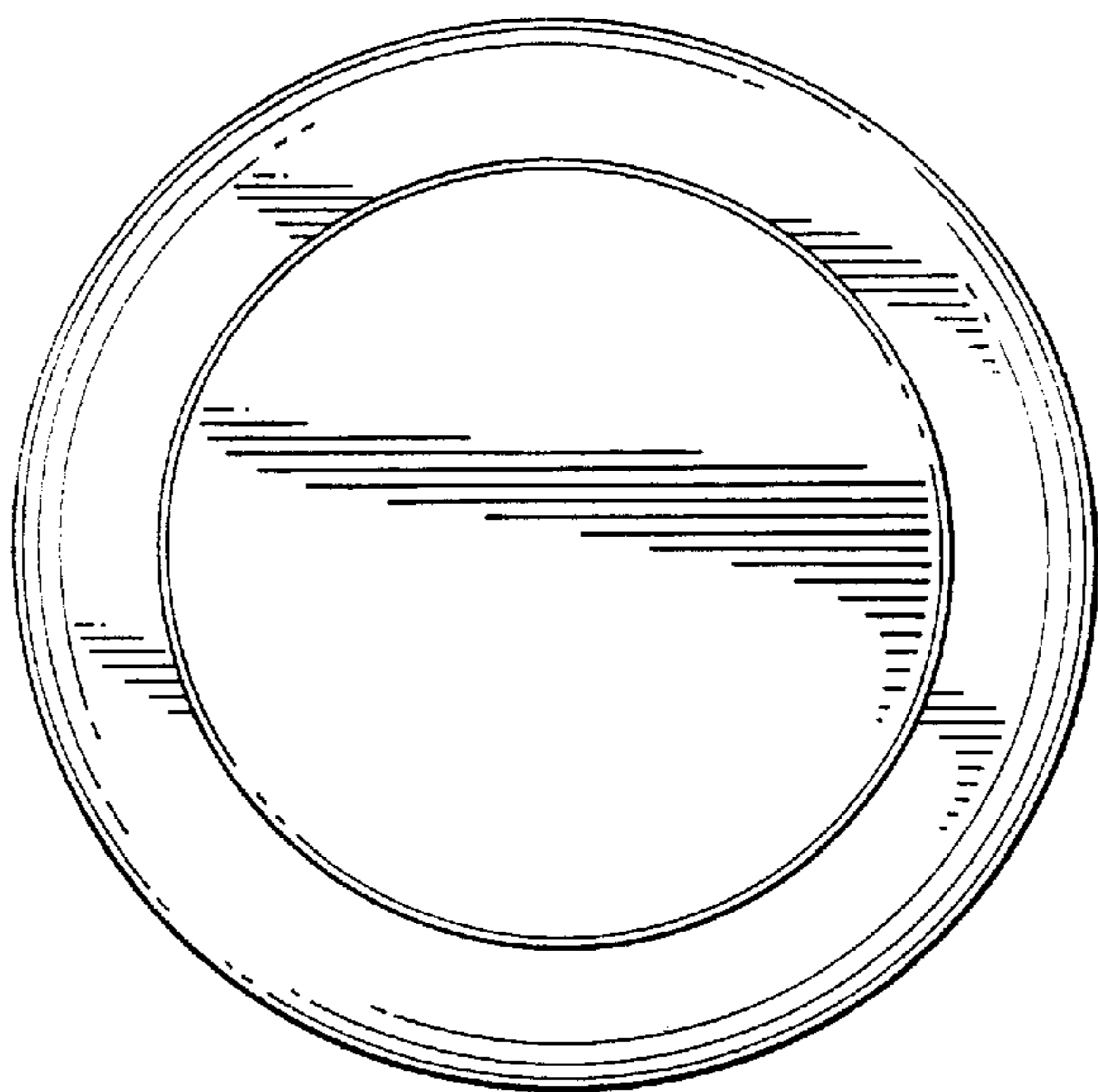

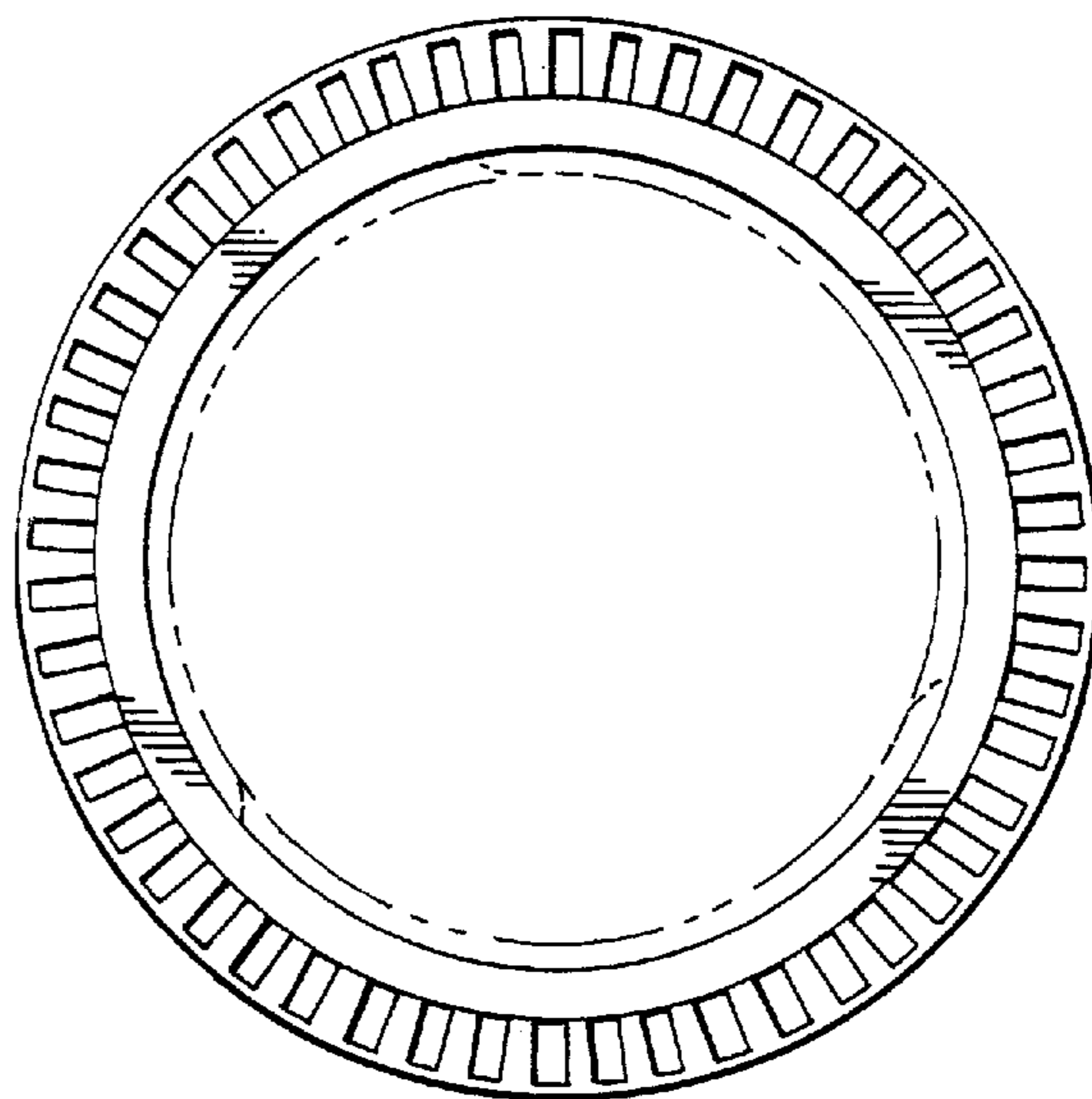

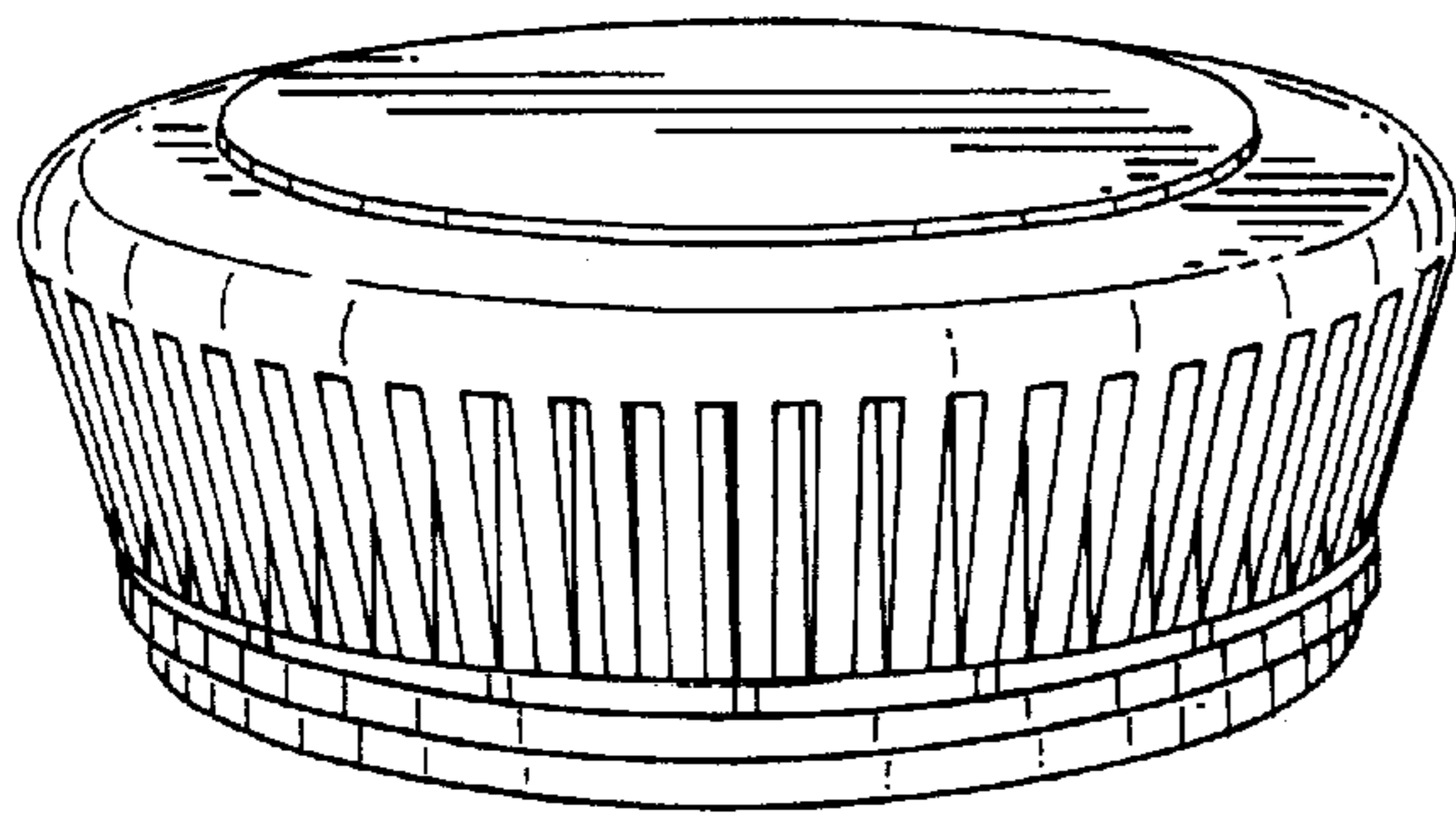

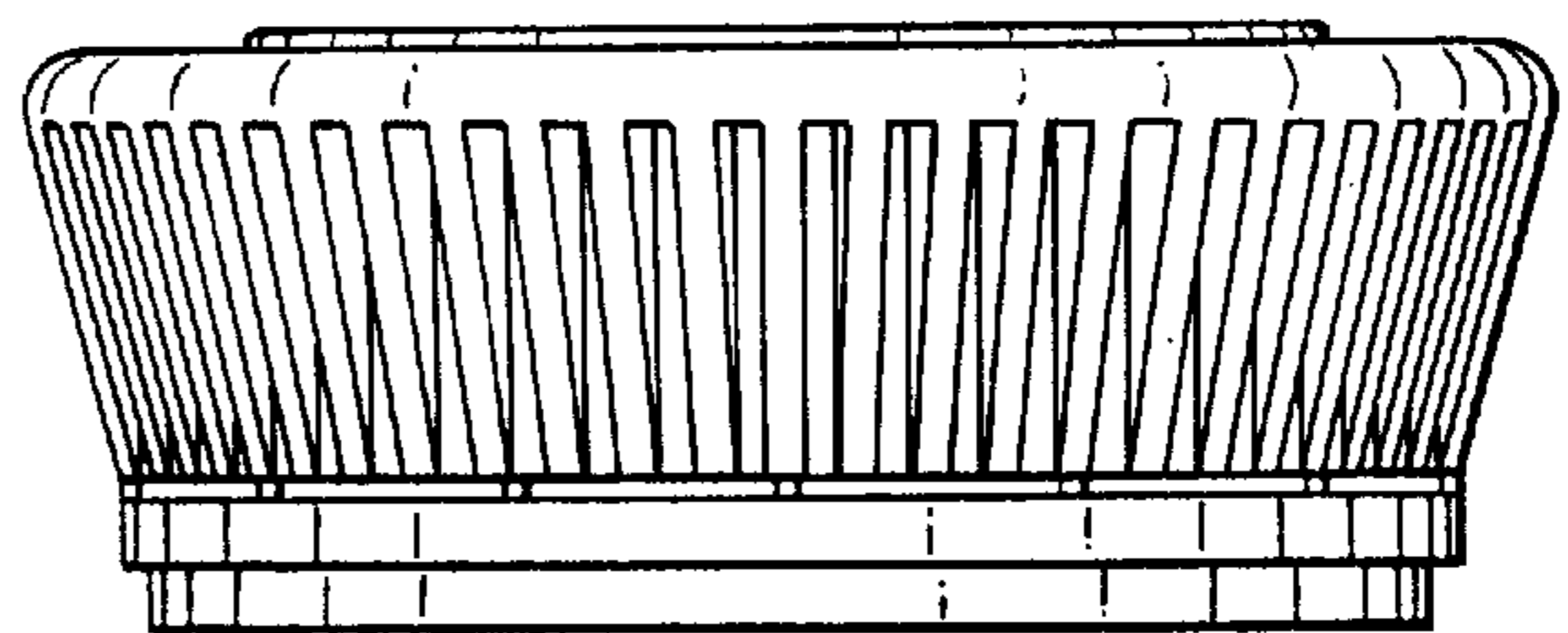

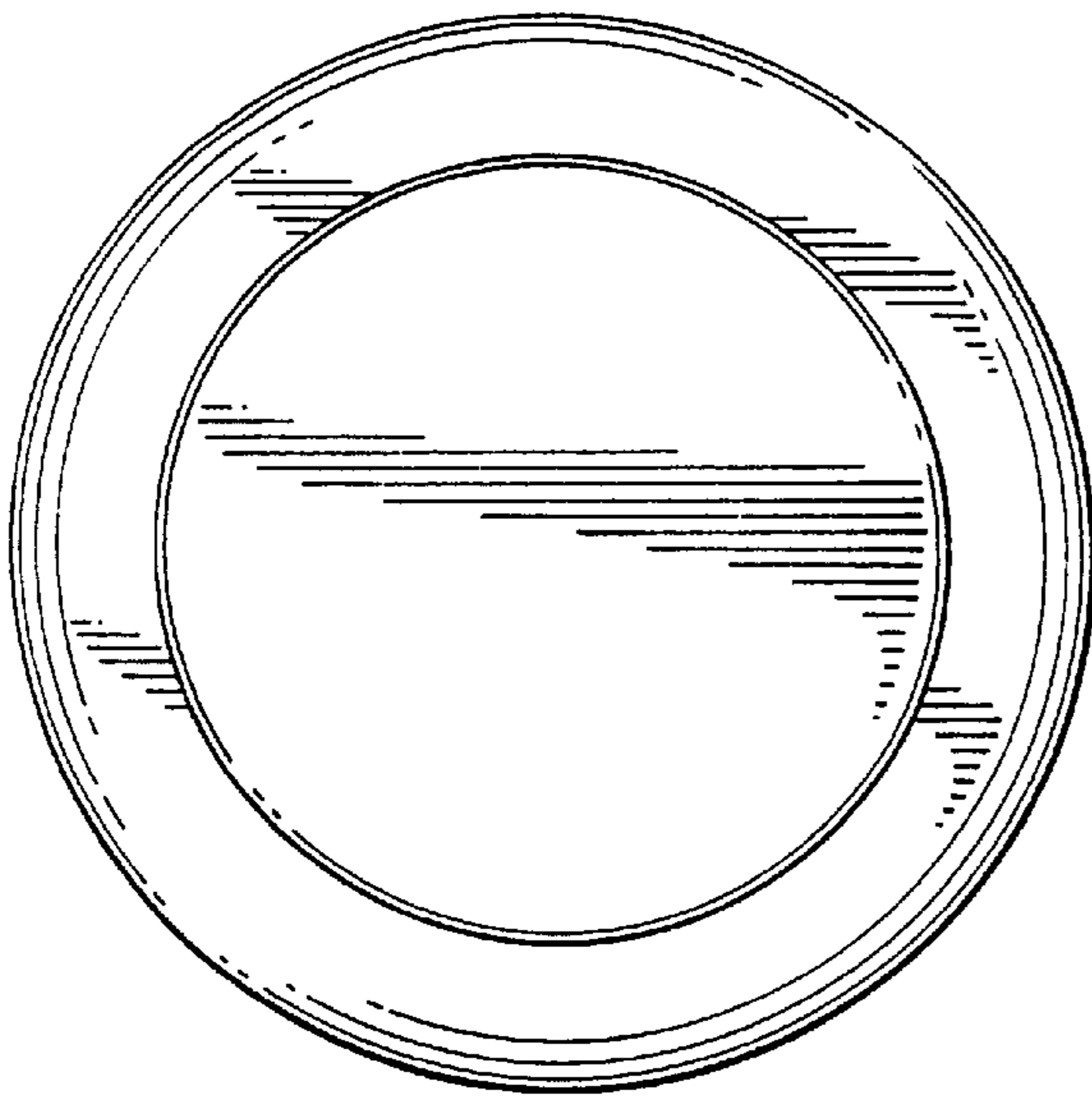
