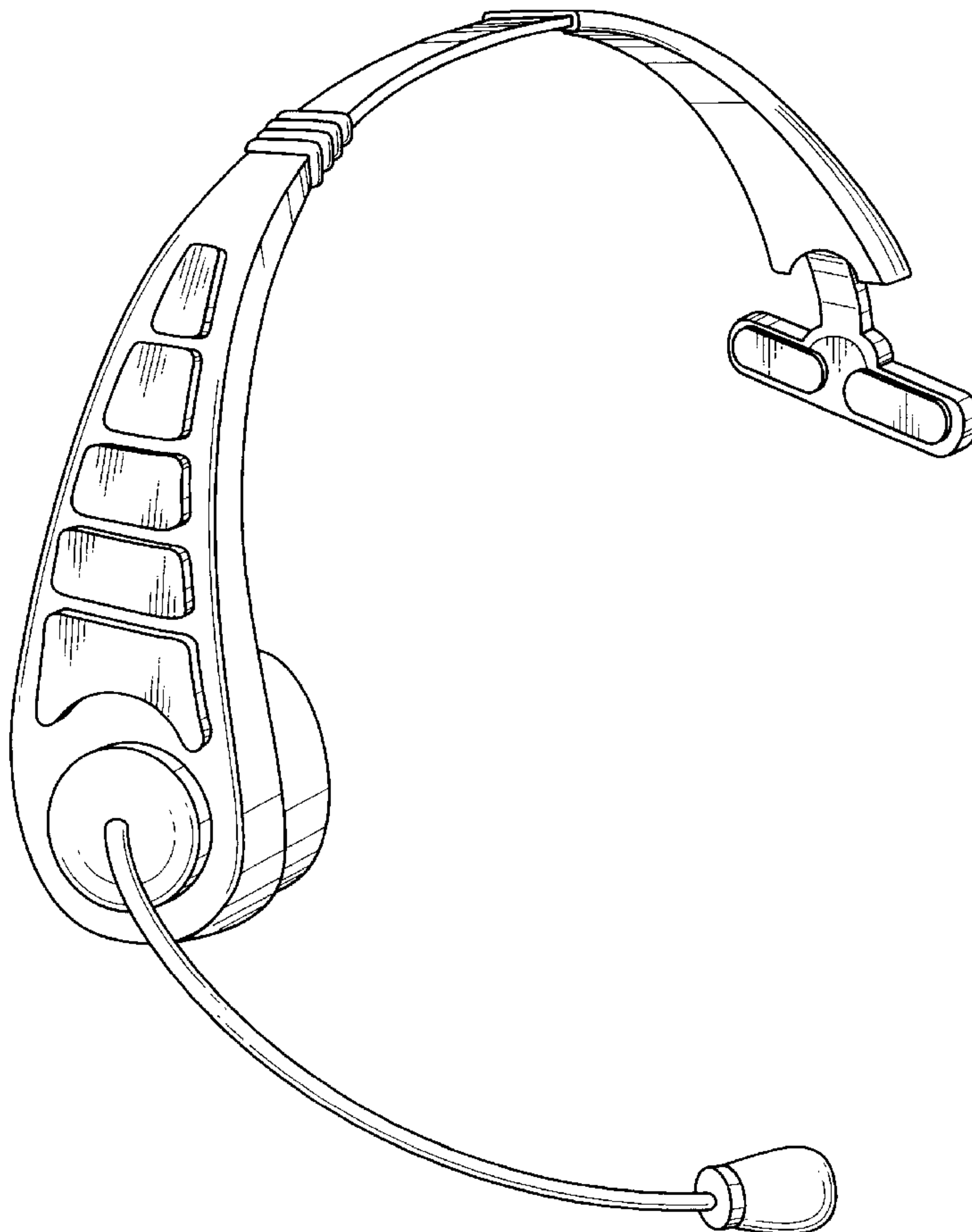
[57] **CLAIM**

The ornamental design for a cordless headset telephone, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the cordless headset telephone showing my new design, the broken line showing of a base unit is for illustrative purposes only and forms no part of the claimed design;
FIG. 2 is perspective view thereof in an in use position;
FIG. 3 is a front view thereof;

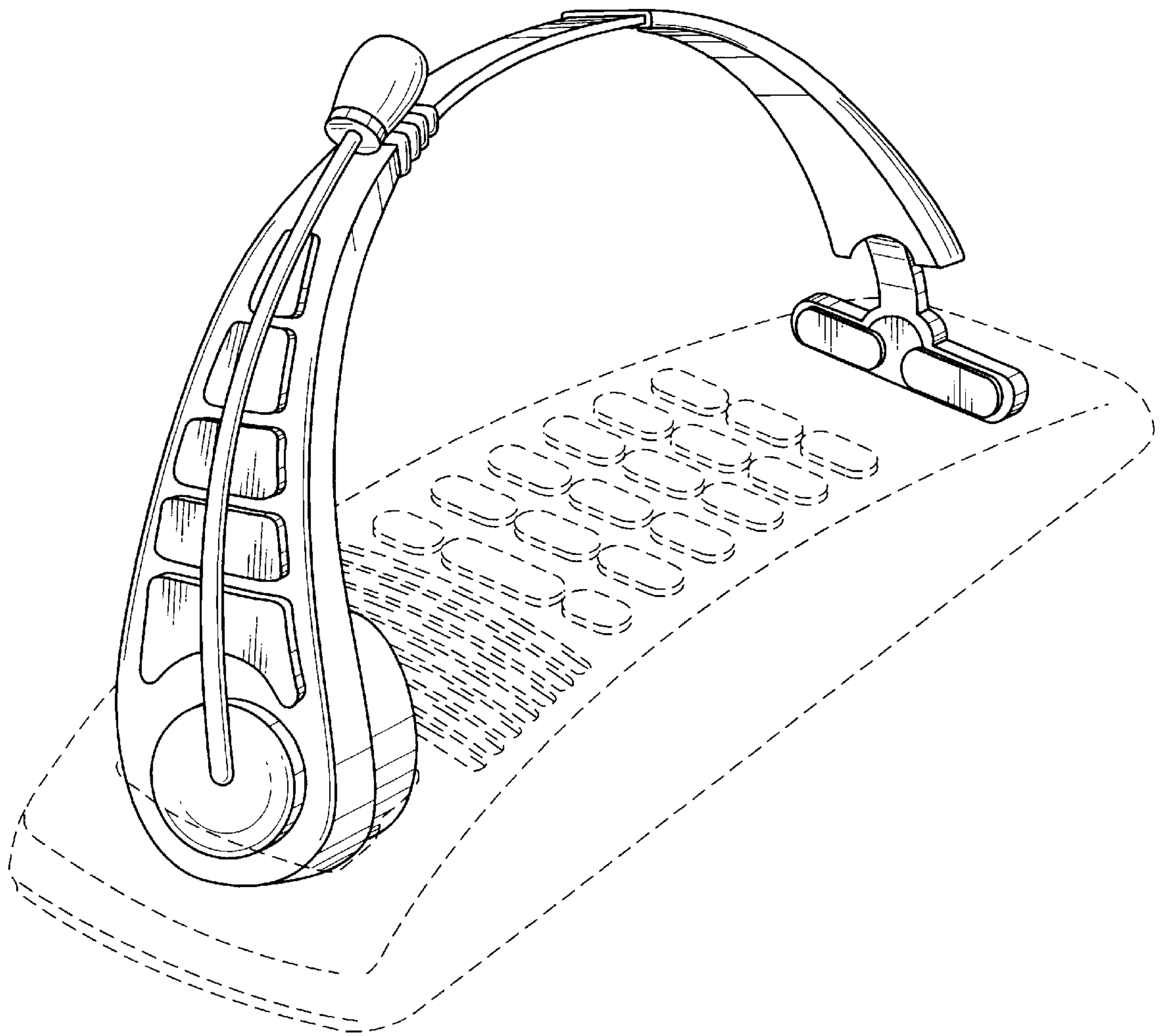

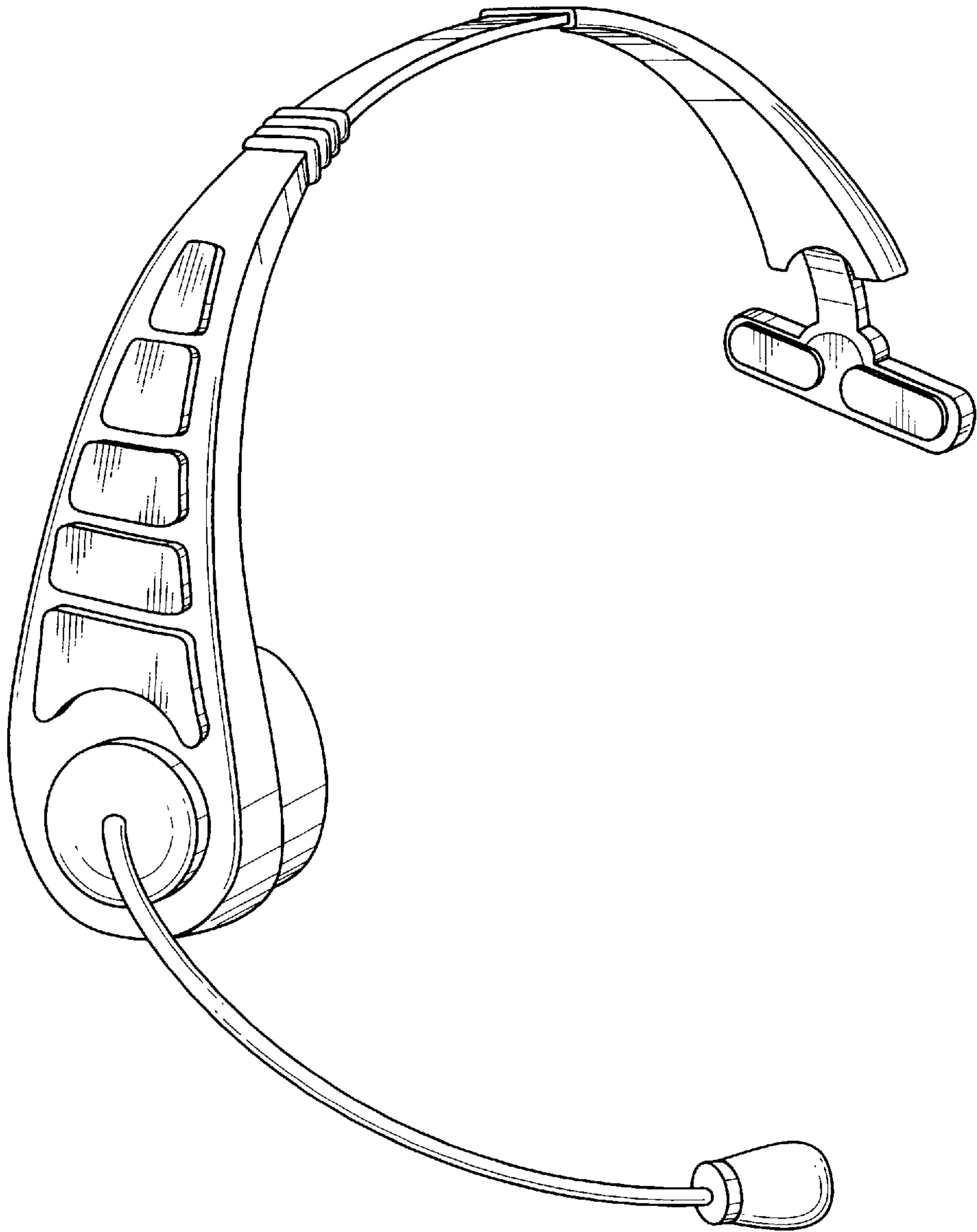

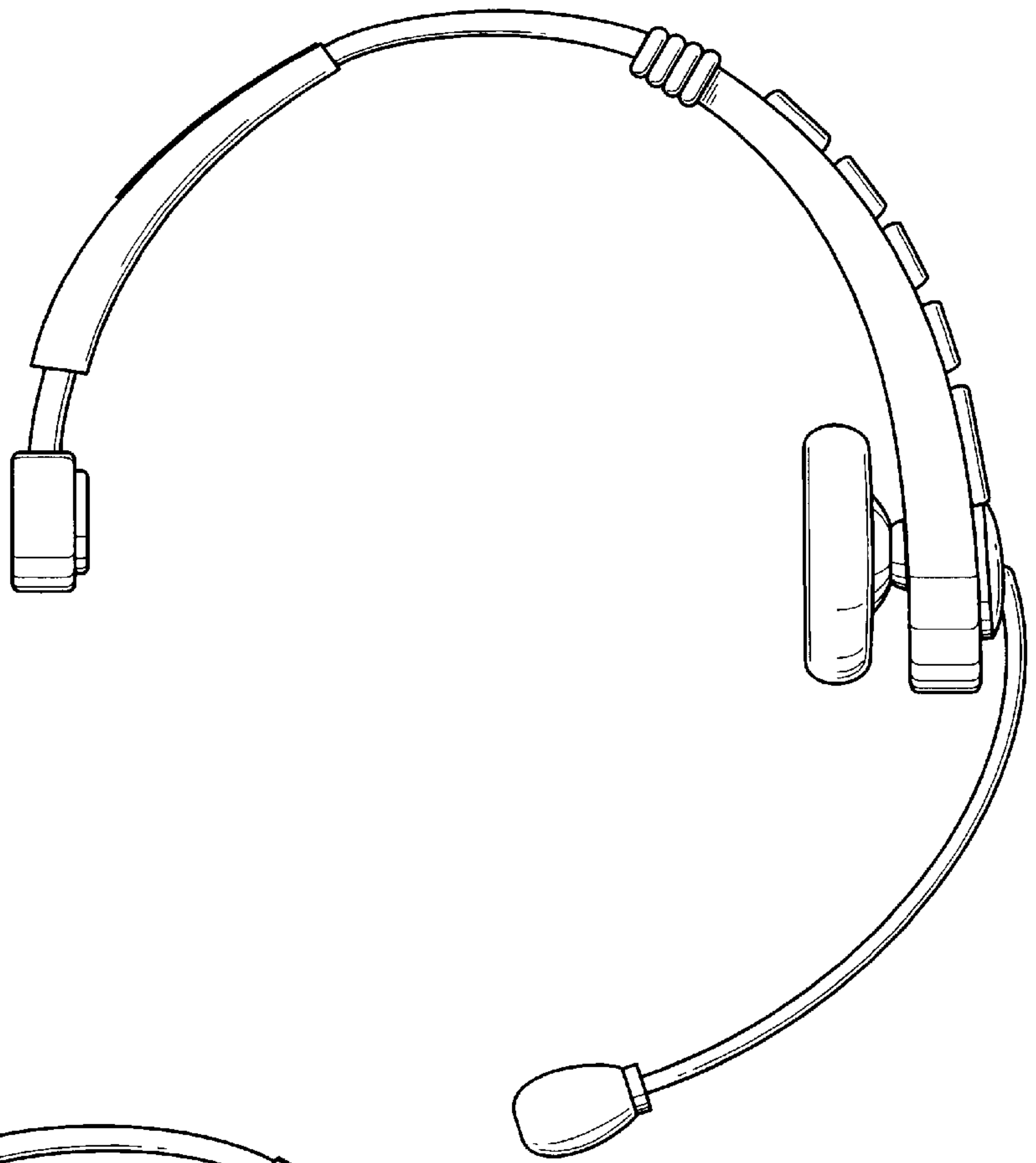
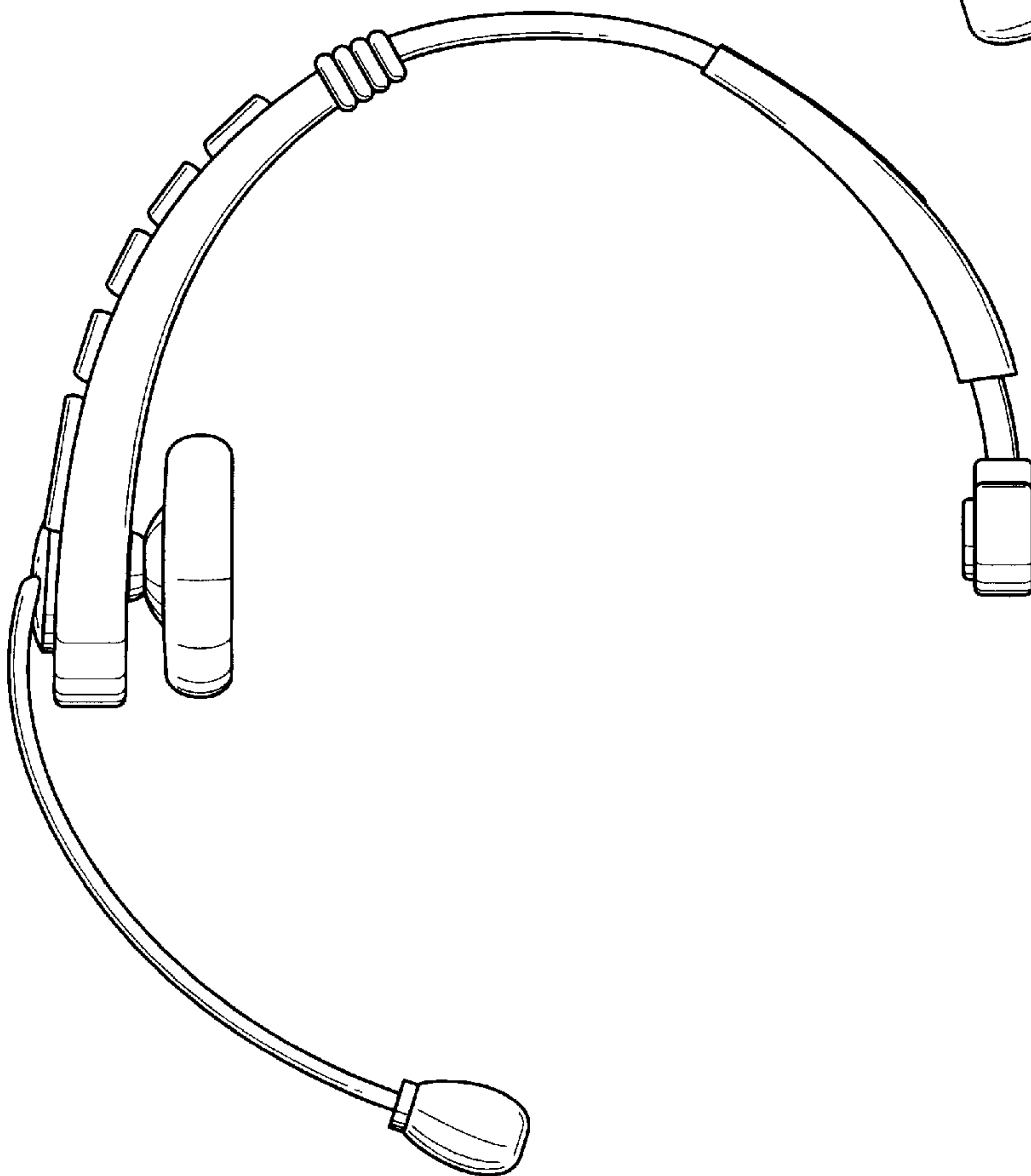

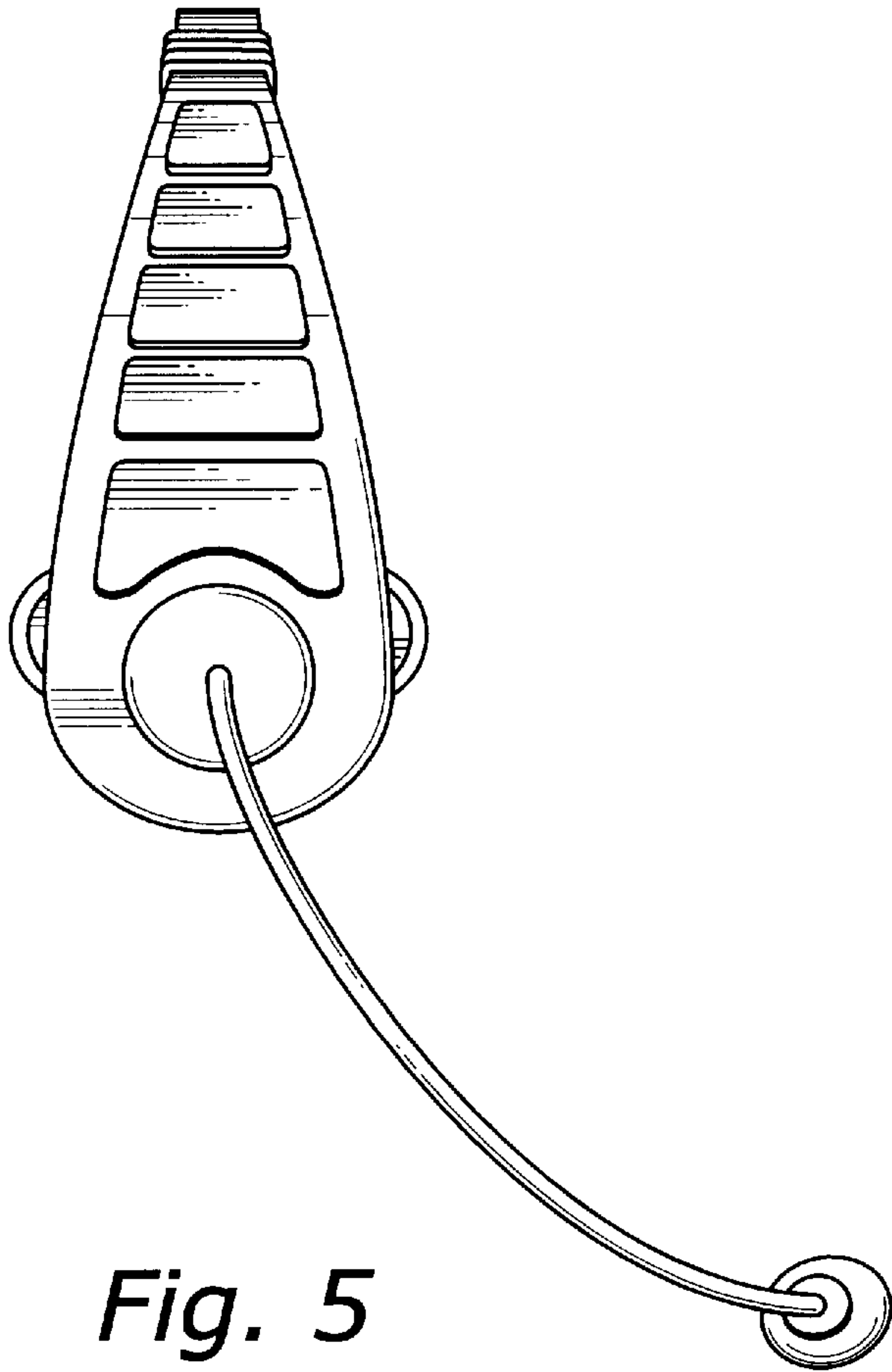

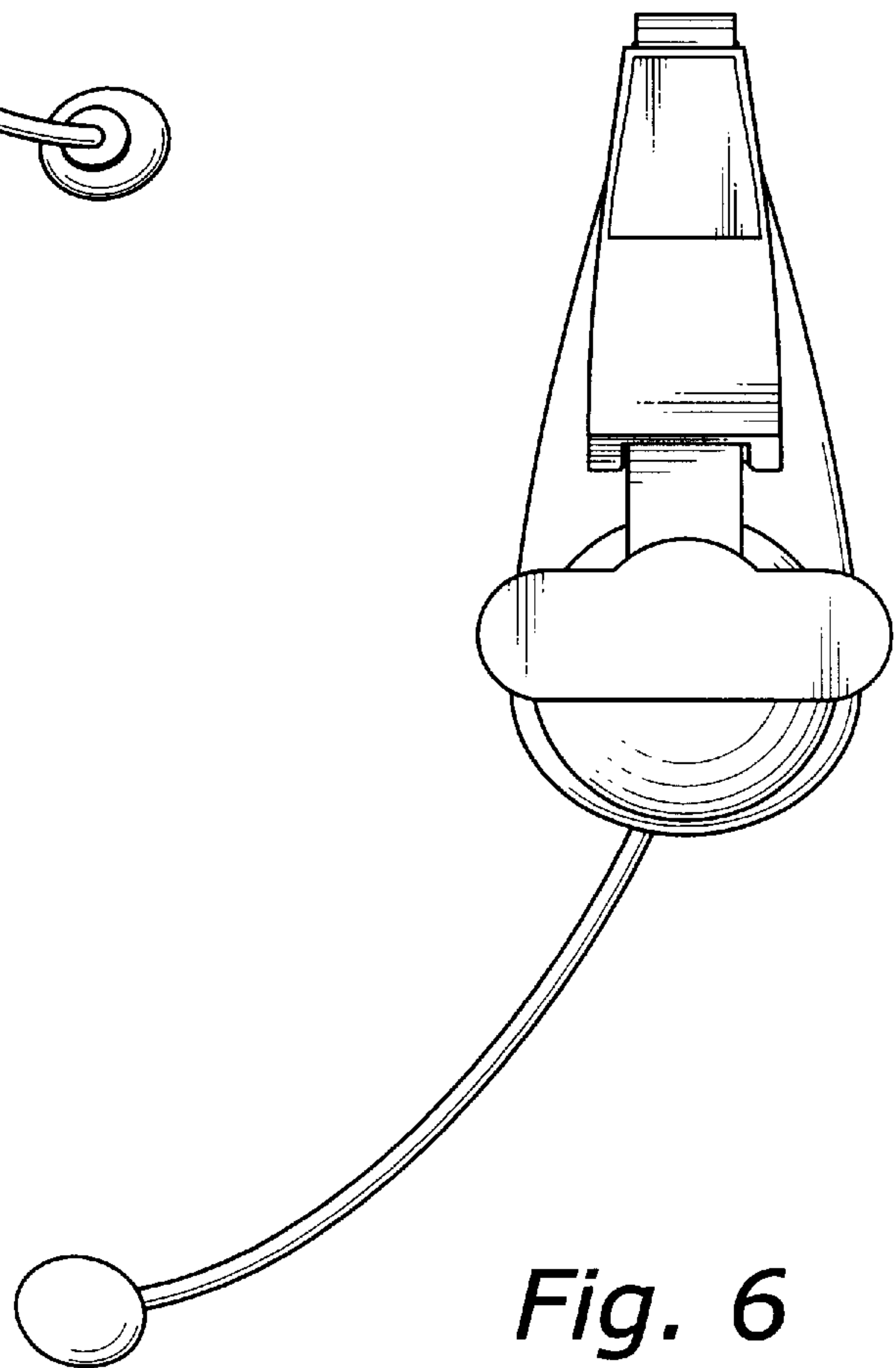

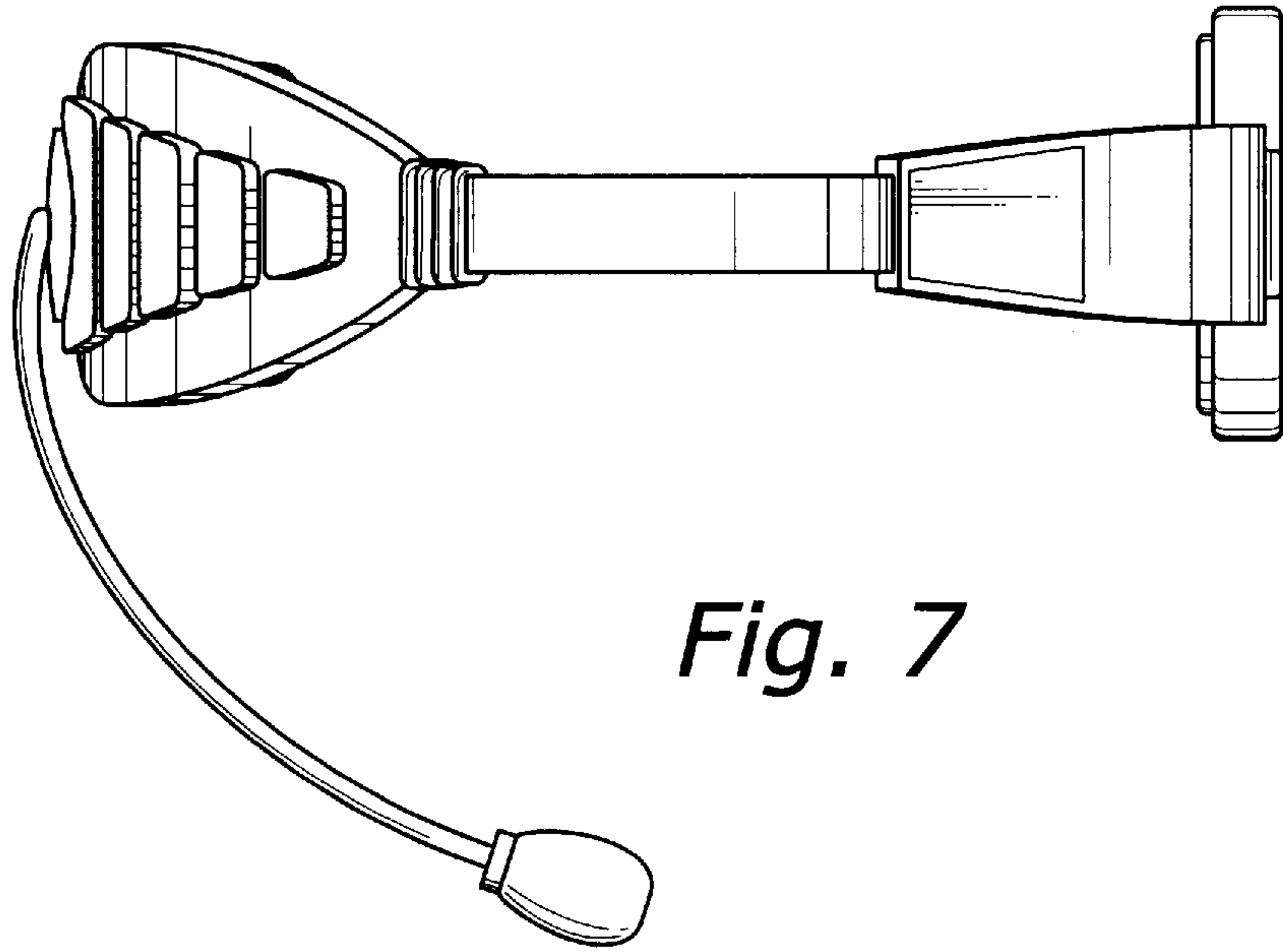

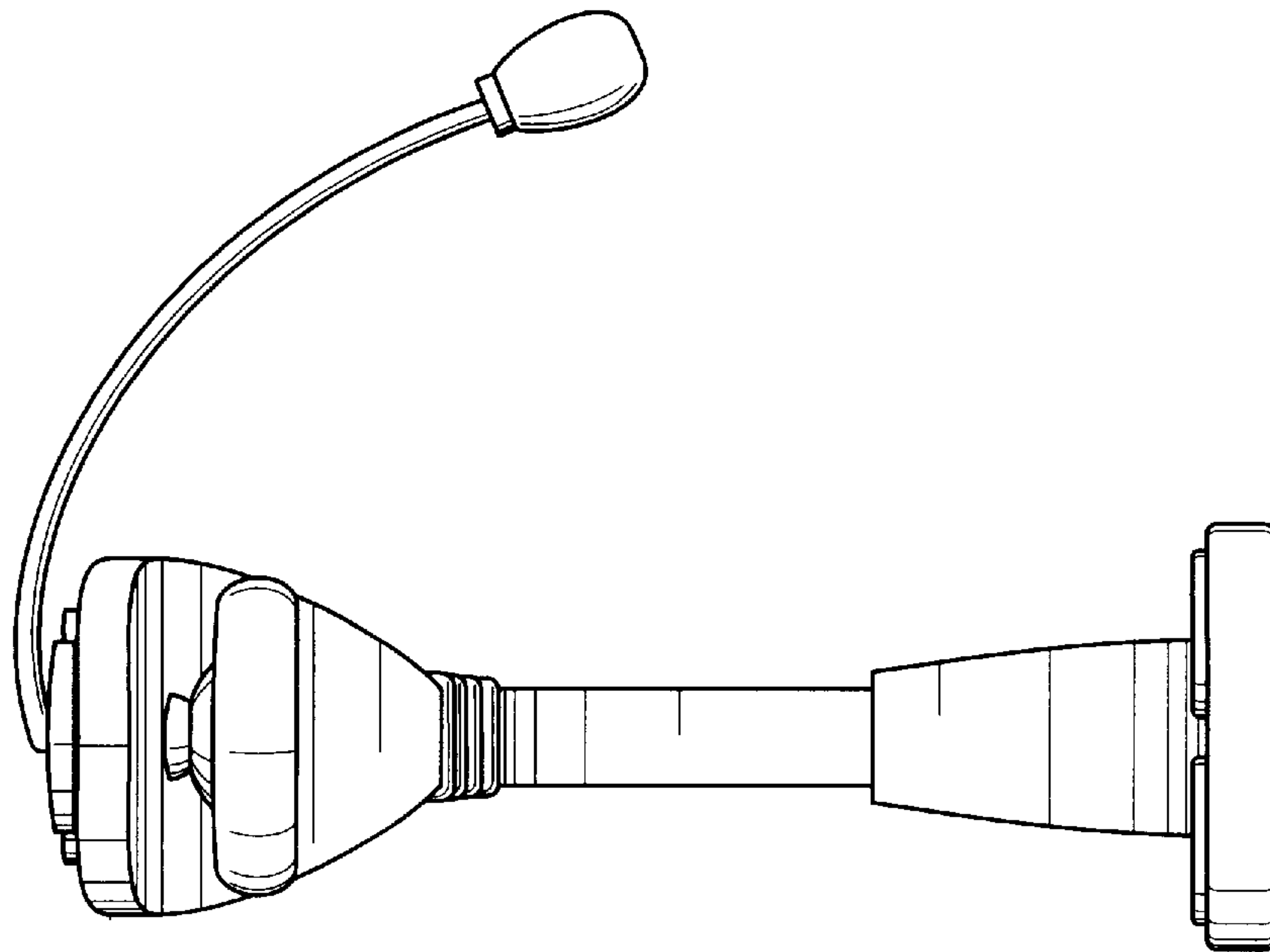
