The ornamental design for a electro-erosive wire cutting machine, as shown and described.

DESCRIPTION

FIG. 1 is a front left-hand perspective view of the closed electro-erosive wire cutting machine showing our new design;

FIG. 2 is a front left-hand perspective view of the open electro-erosive wire cutting machine of FIG. 1;

FIG. 3 is a front right-hand perspective view of the closed electro-erosive wire cutting machine of FIG. 1;

FIG. 4 is a back left-hand perspective view of the closed electro-erosive wire cutting machine of FIG. 1;

FIG. 5 is a back right-hand perspective view of the closed electro-erosive wire cutting machine of FIG. 1;

FIG. 6 is a plan view of the closed electro-erosive wire cutting machine of FIG. 1;

FIG. 7 is a plan right side view of the closed electro-erosive wiring cutting machine of FIG. 1;

FIG. 8 is a plan back view of the closed electro-erosive wire cutting machine of FIG. 1;

FIG. 9 is a plan left side view of the closed electro-erosive wire cutting machine of FIG. 1; and

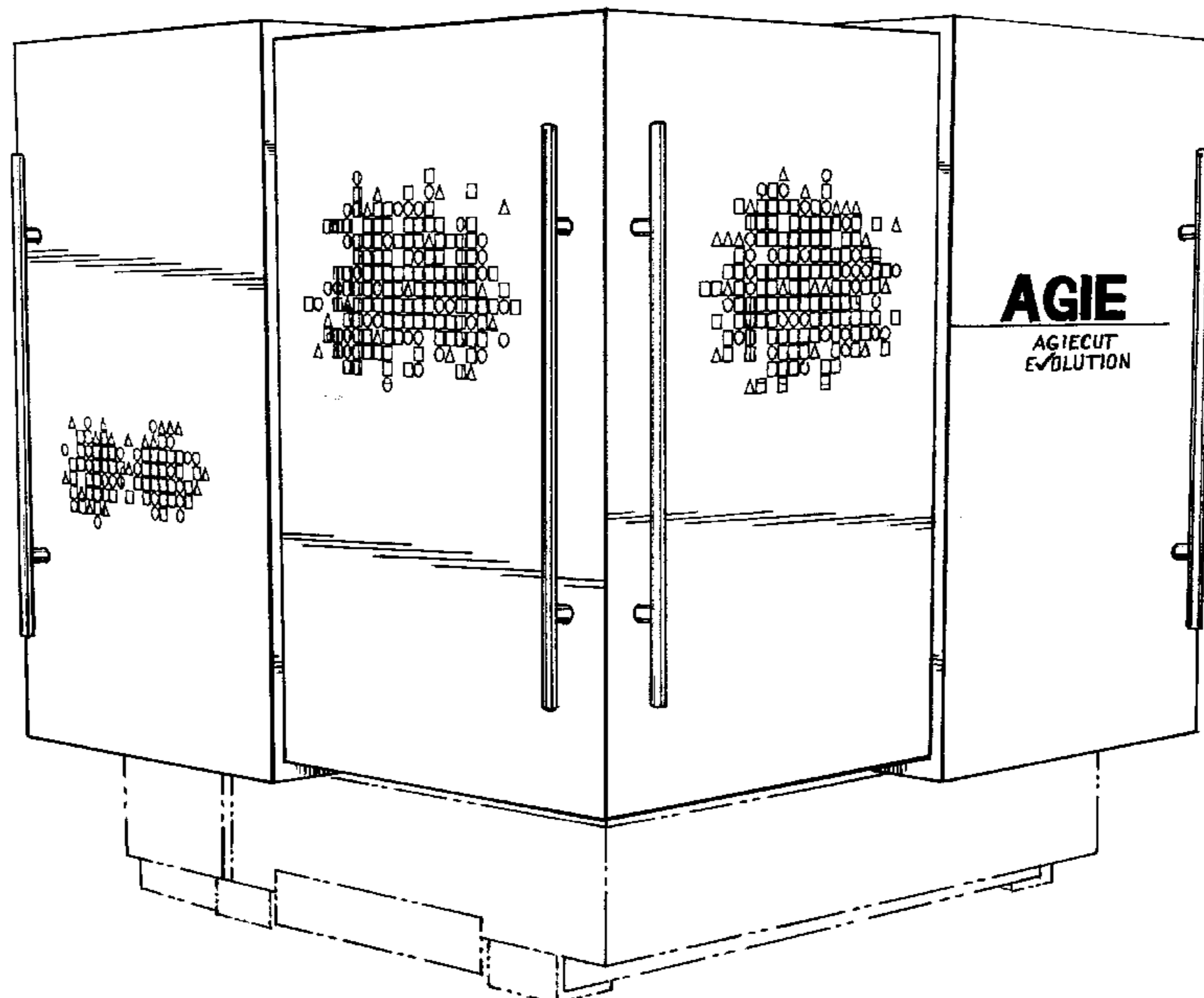
FIG. 10 is a plan front view of the open electro-erosive wire cutting machine of FIG. 1;

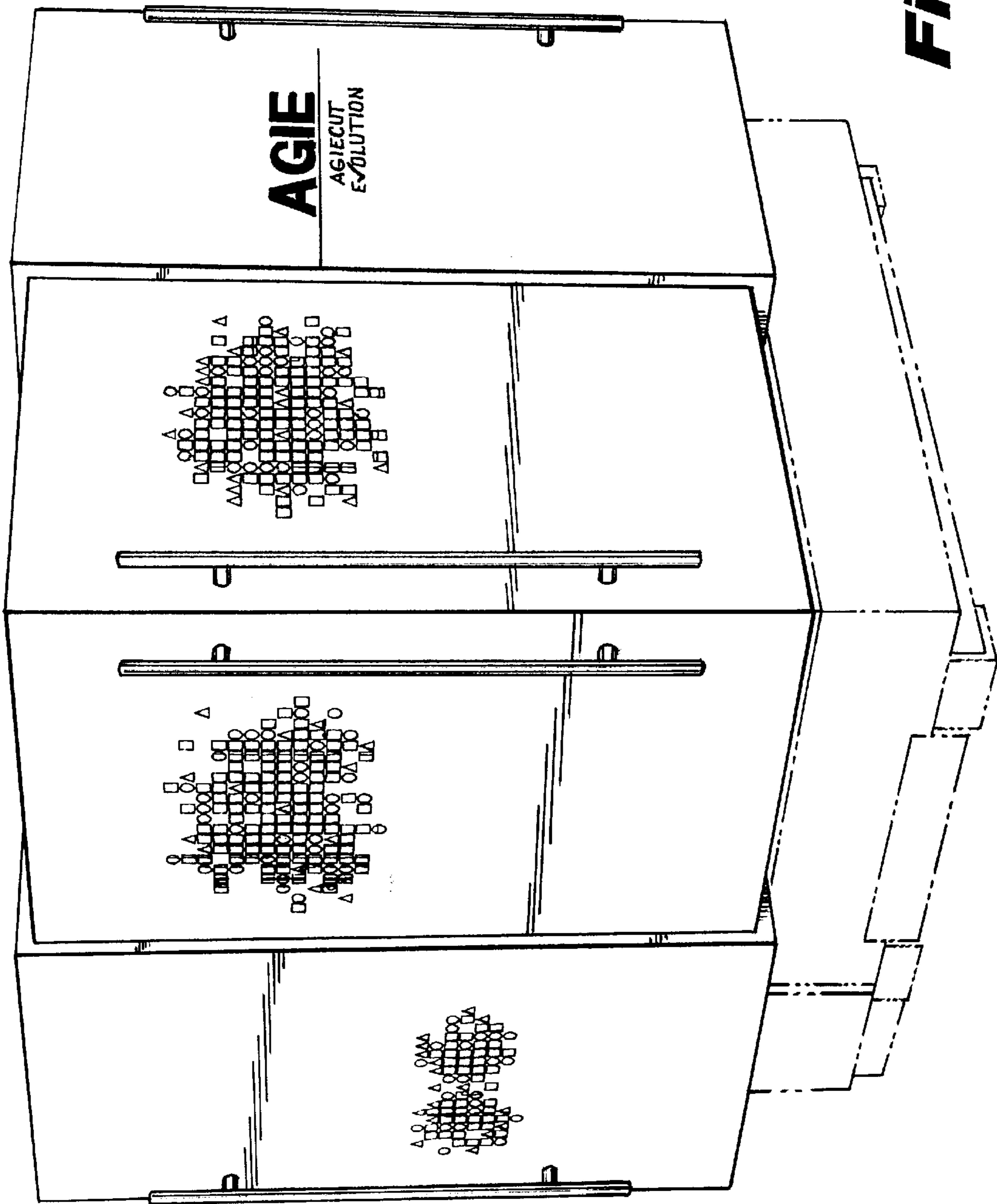

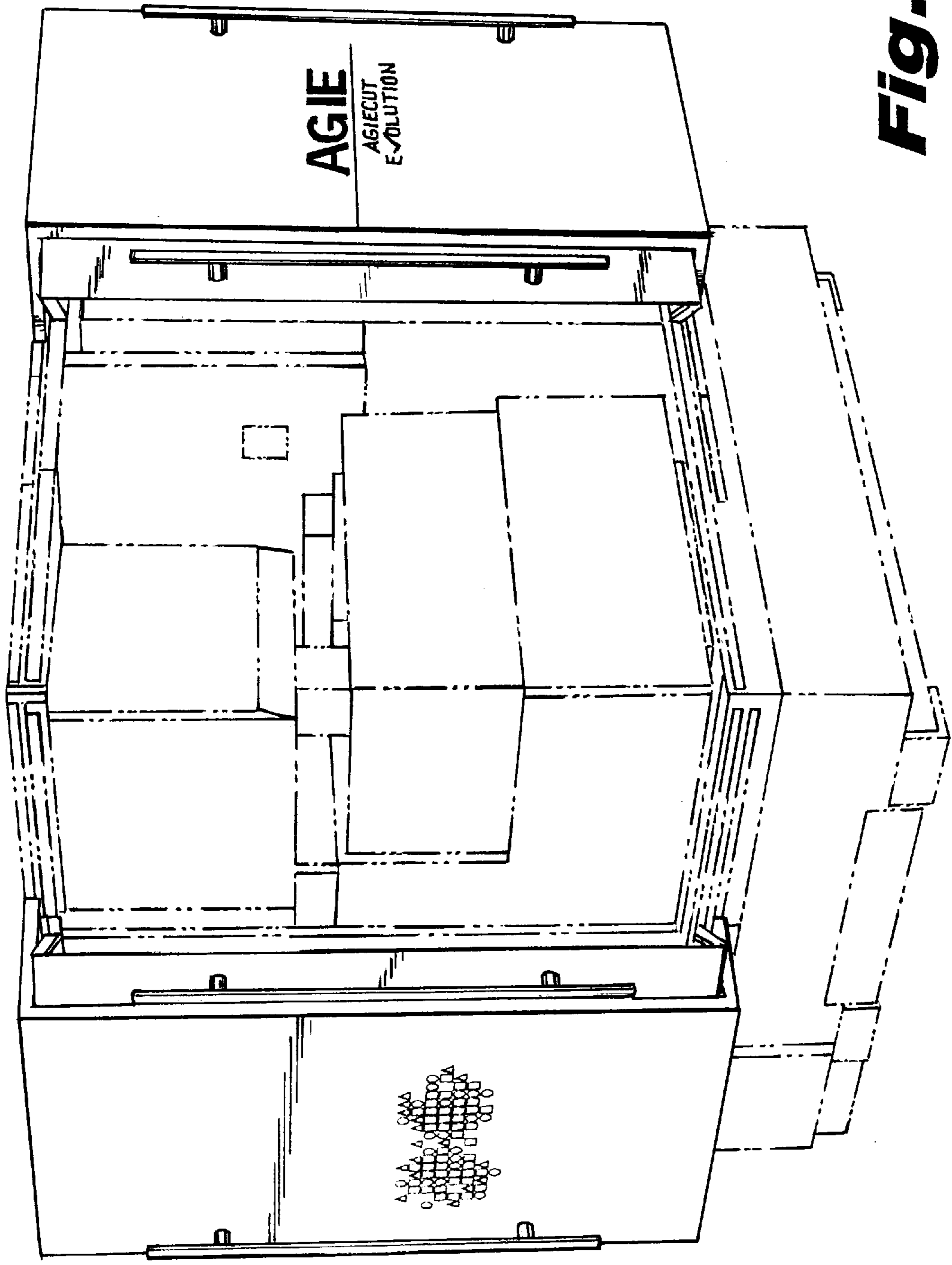

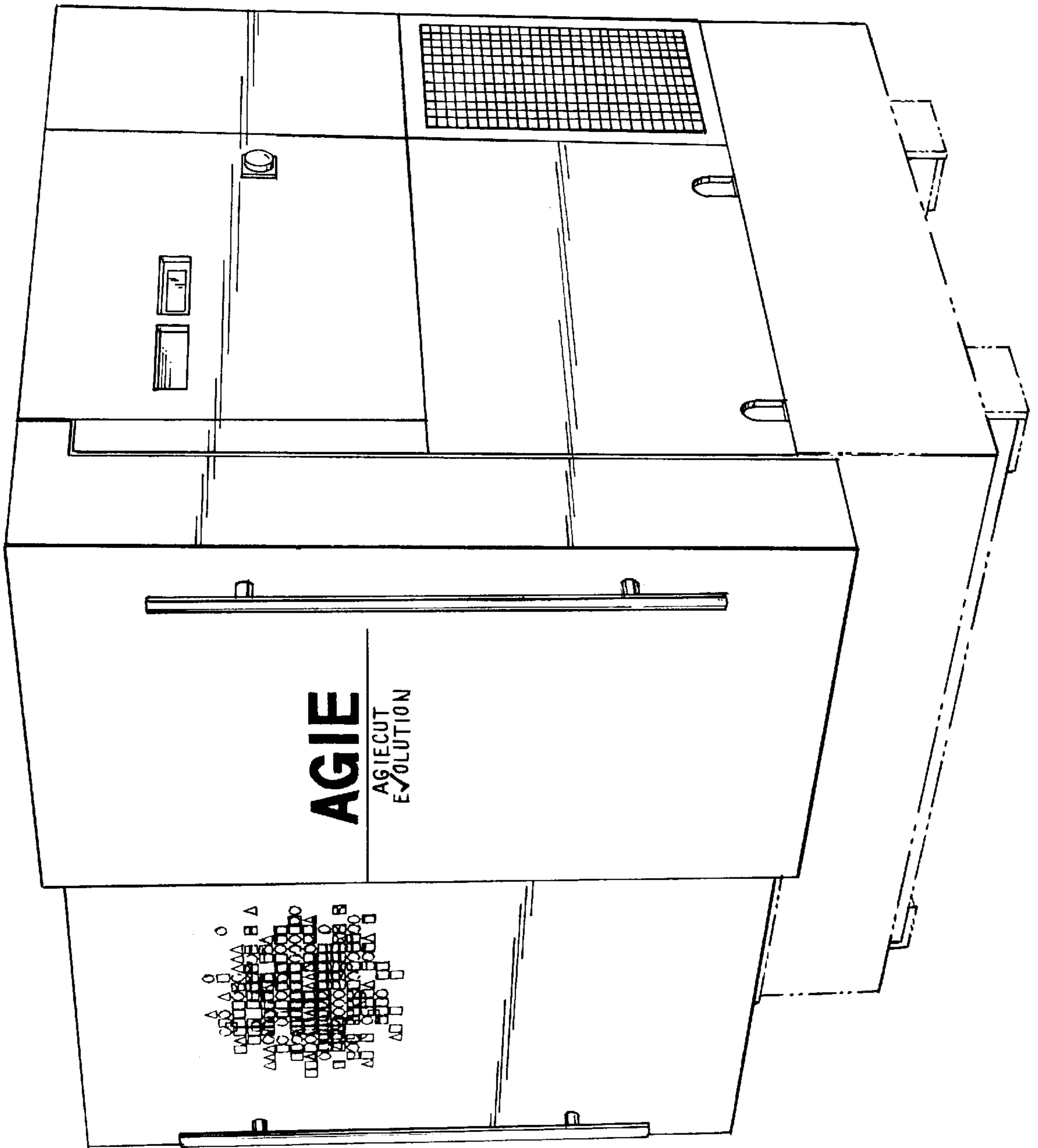

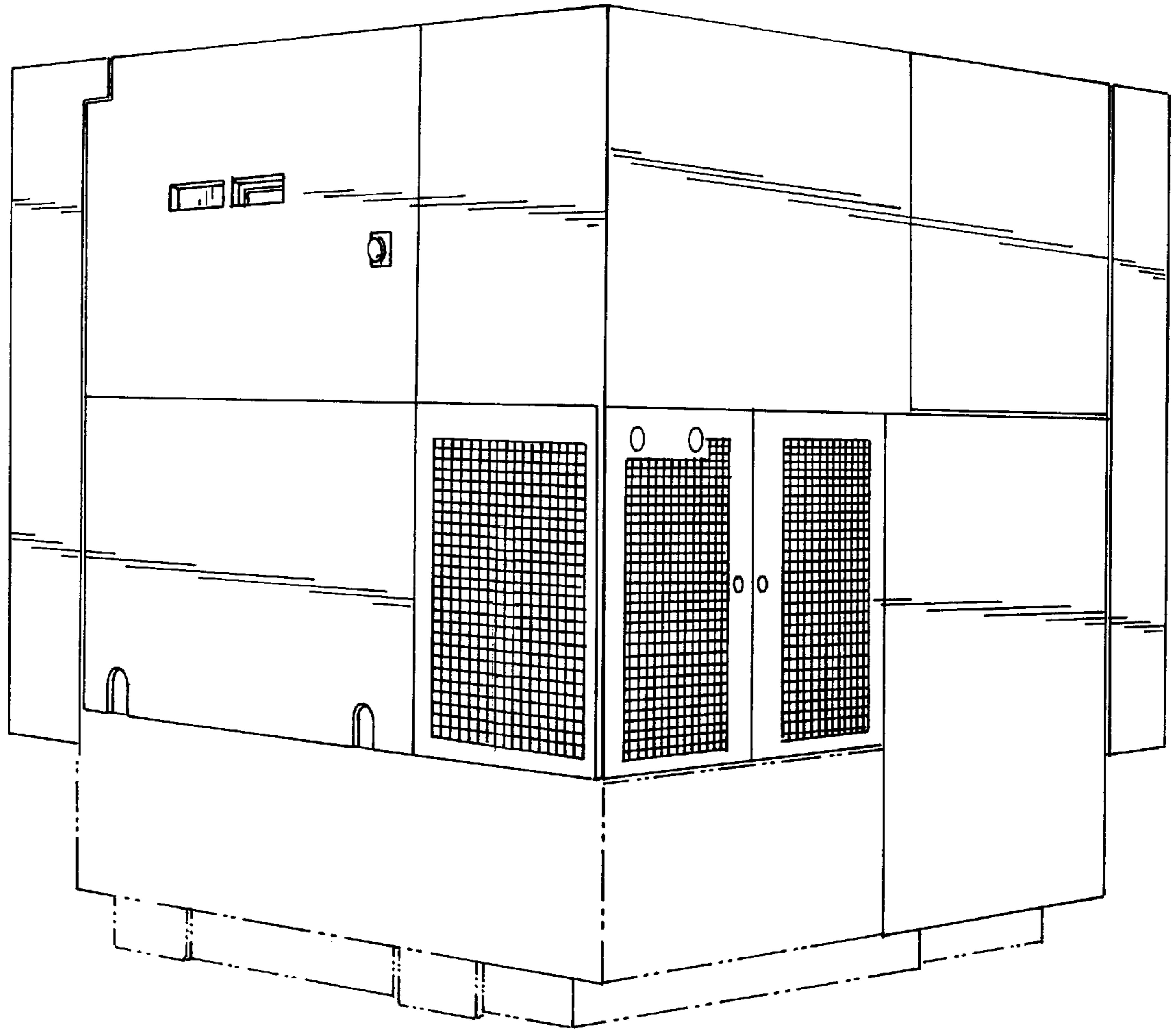

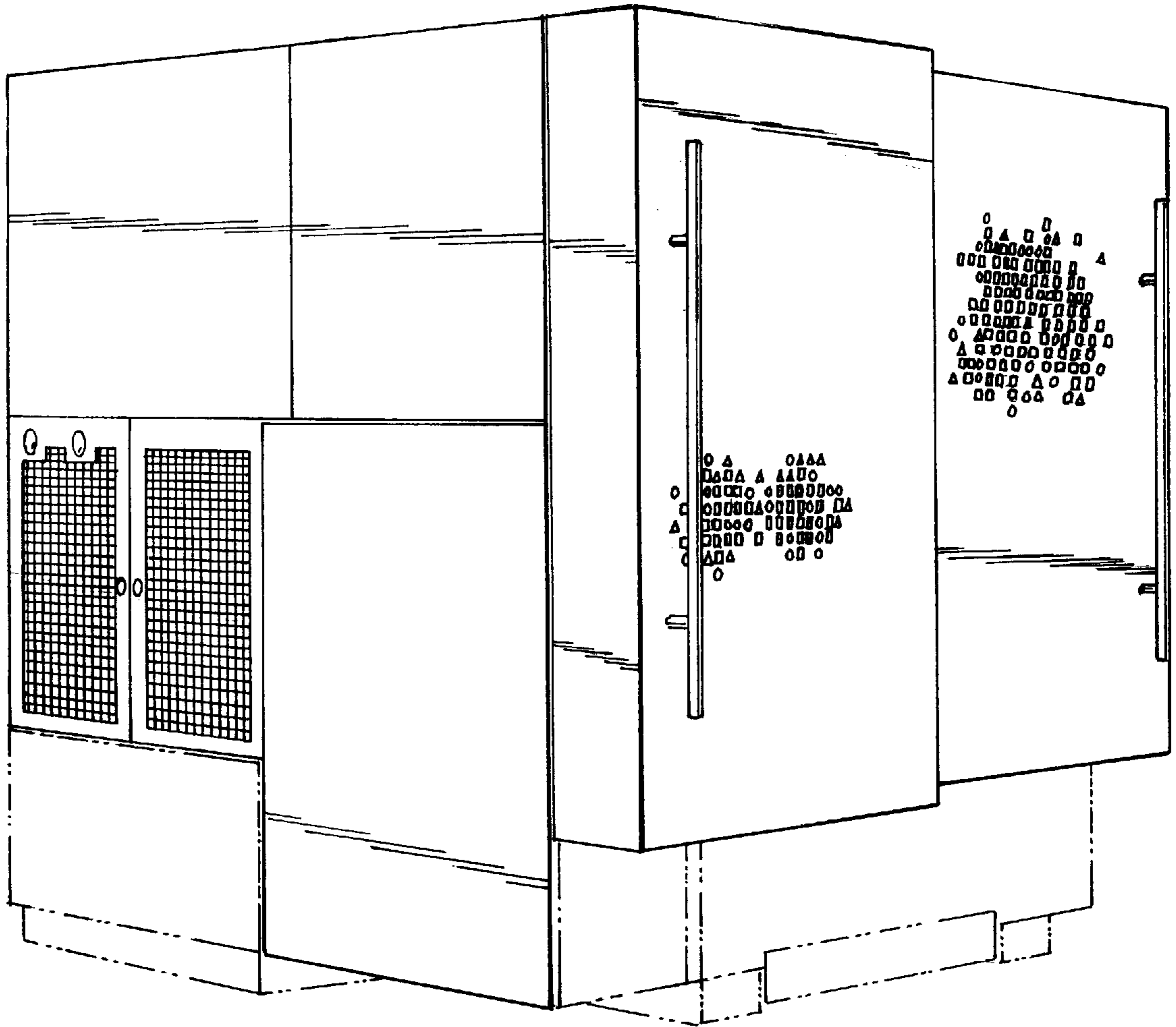

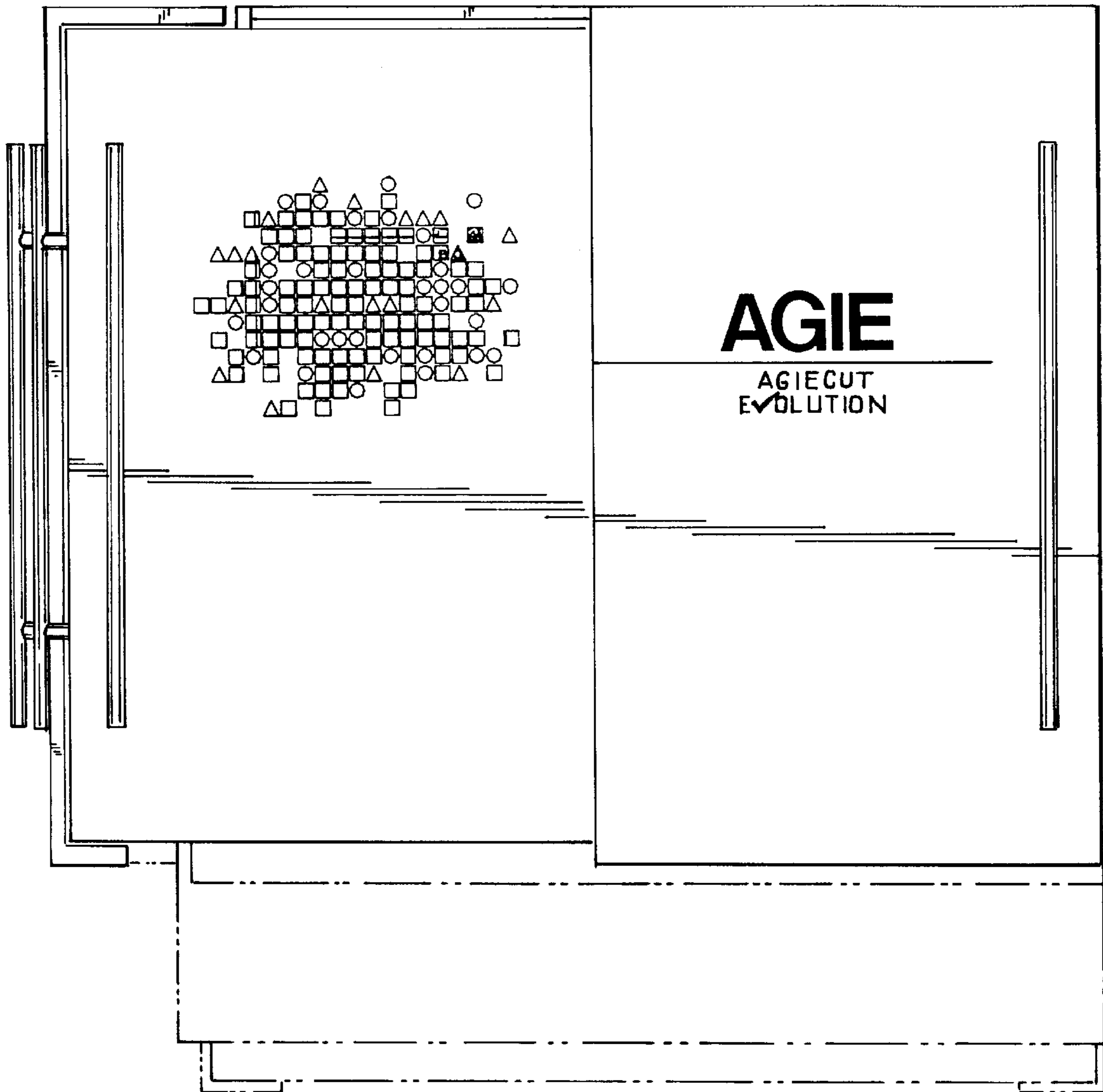

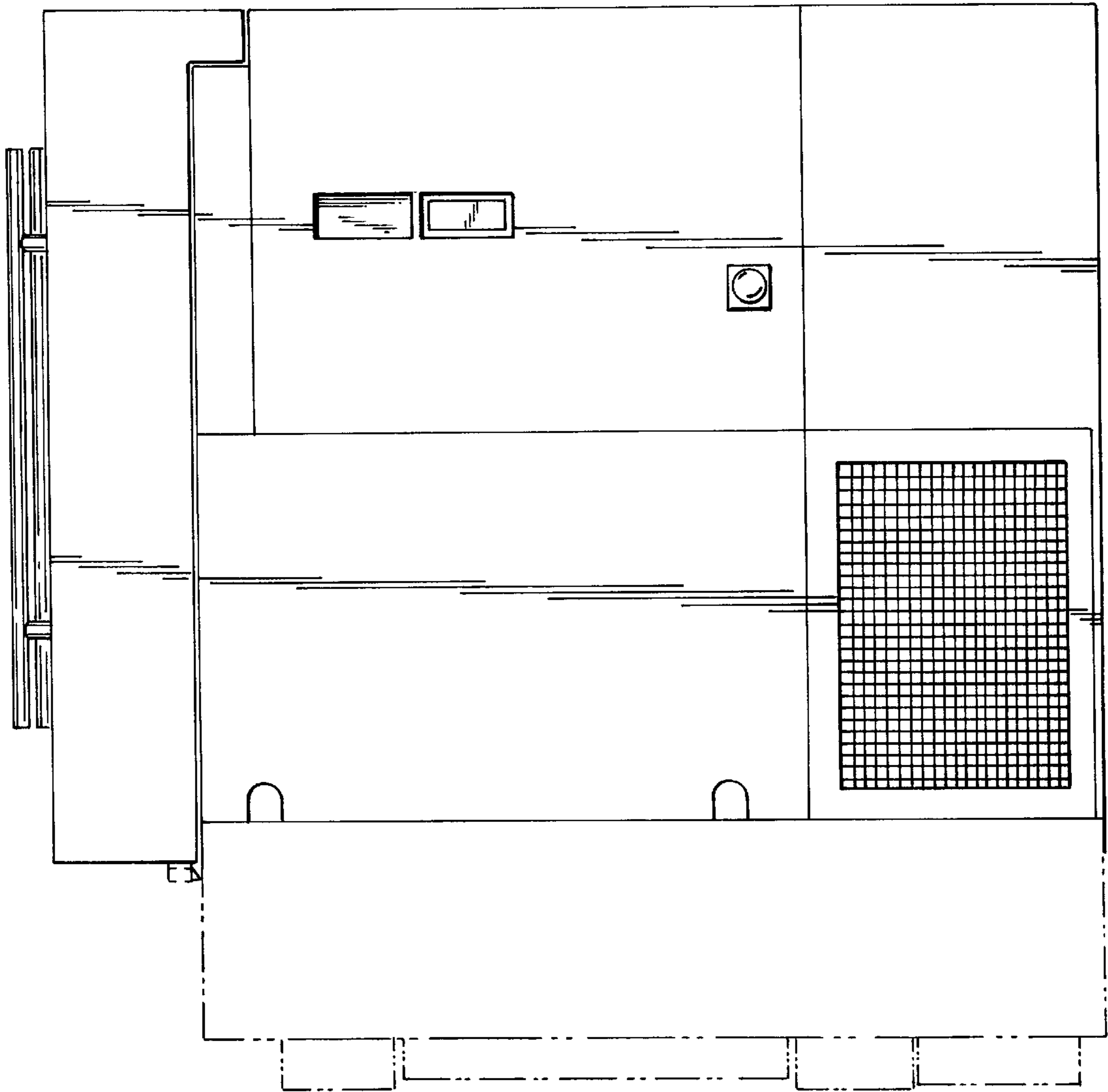

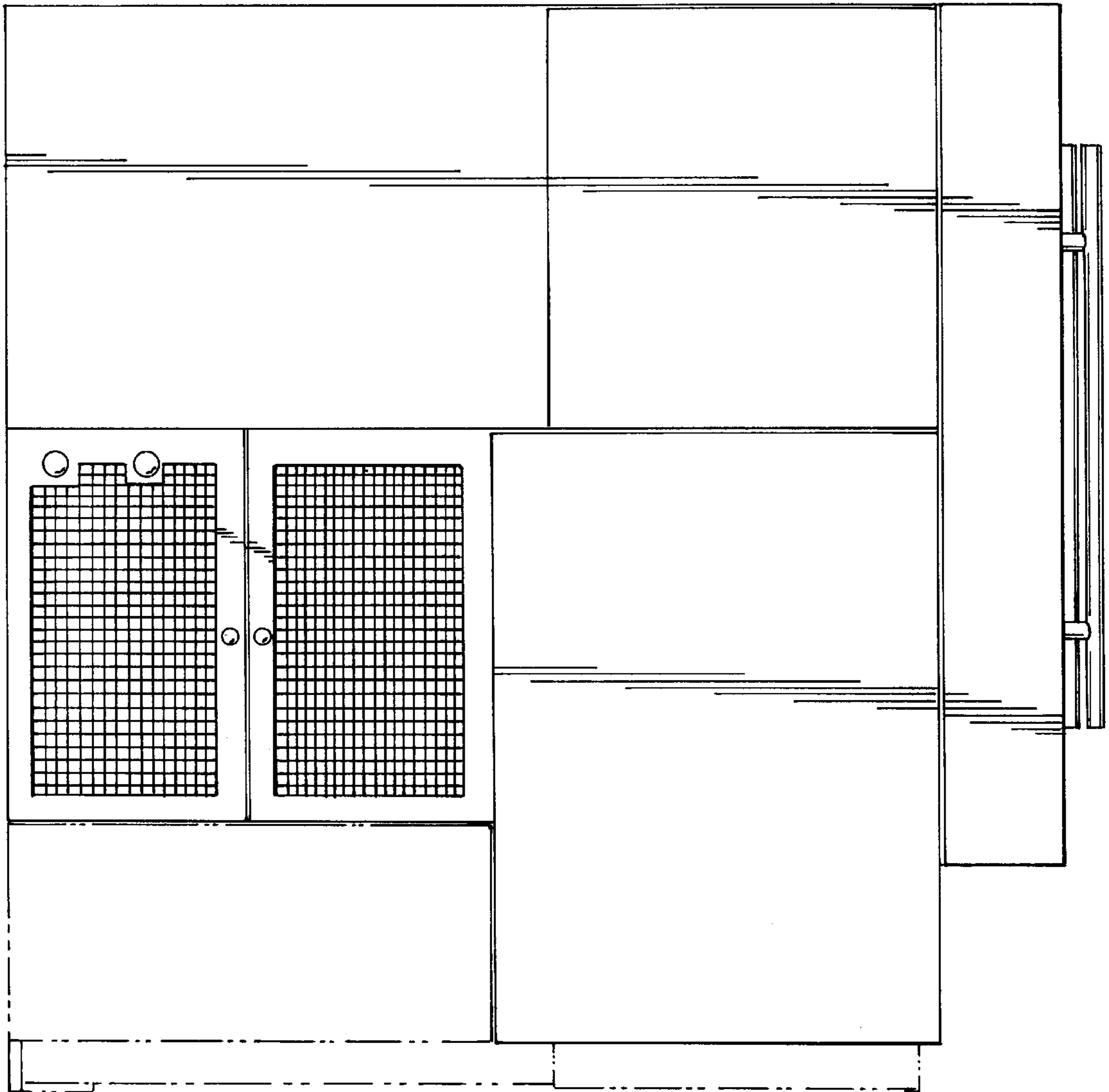

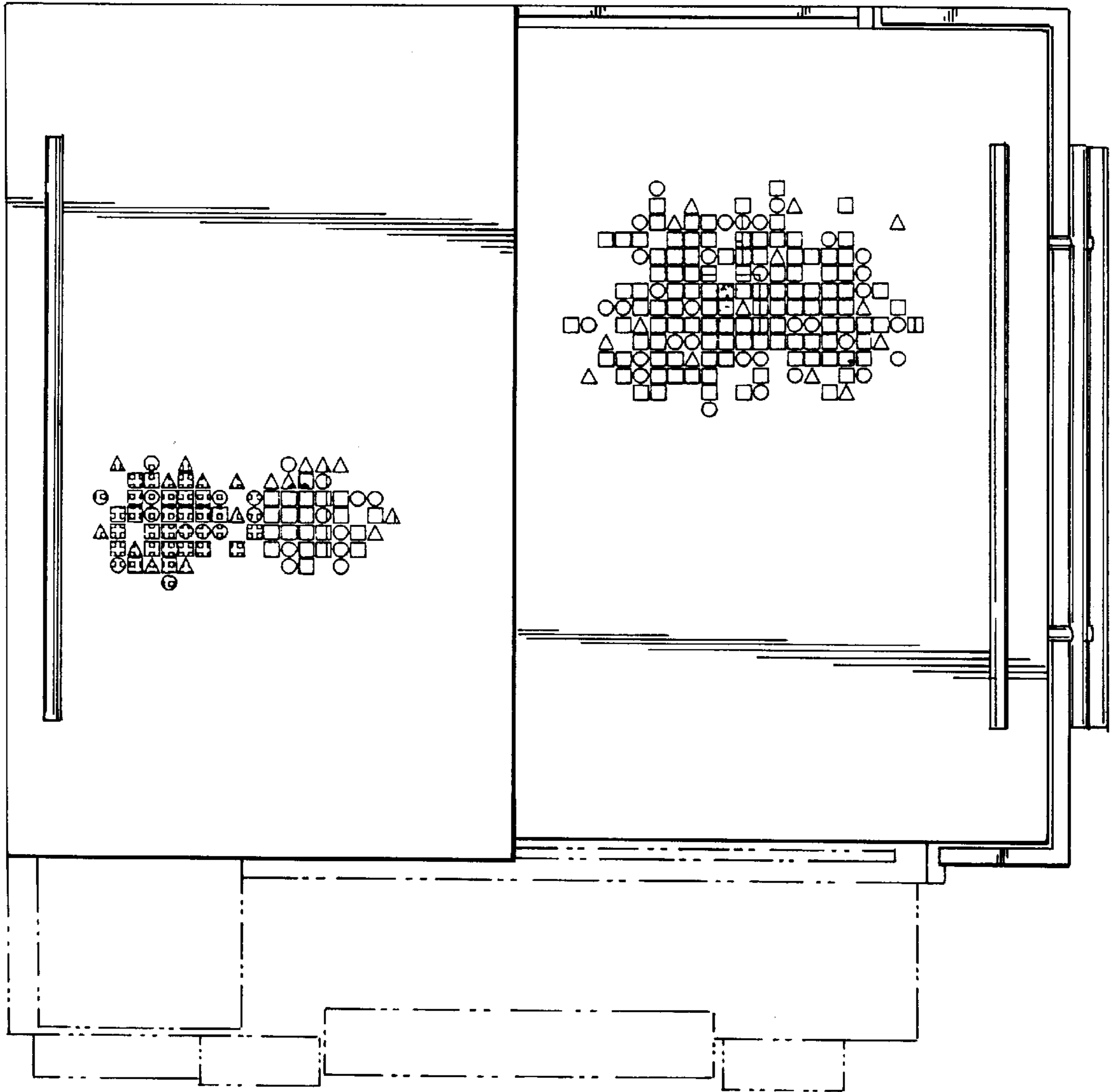

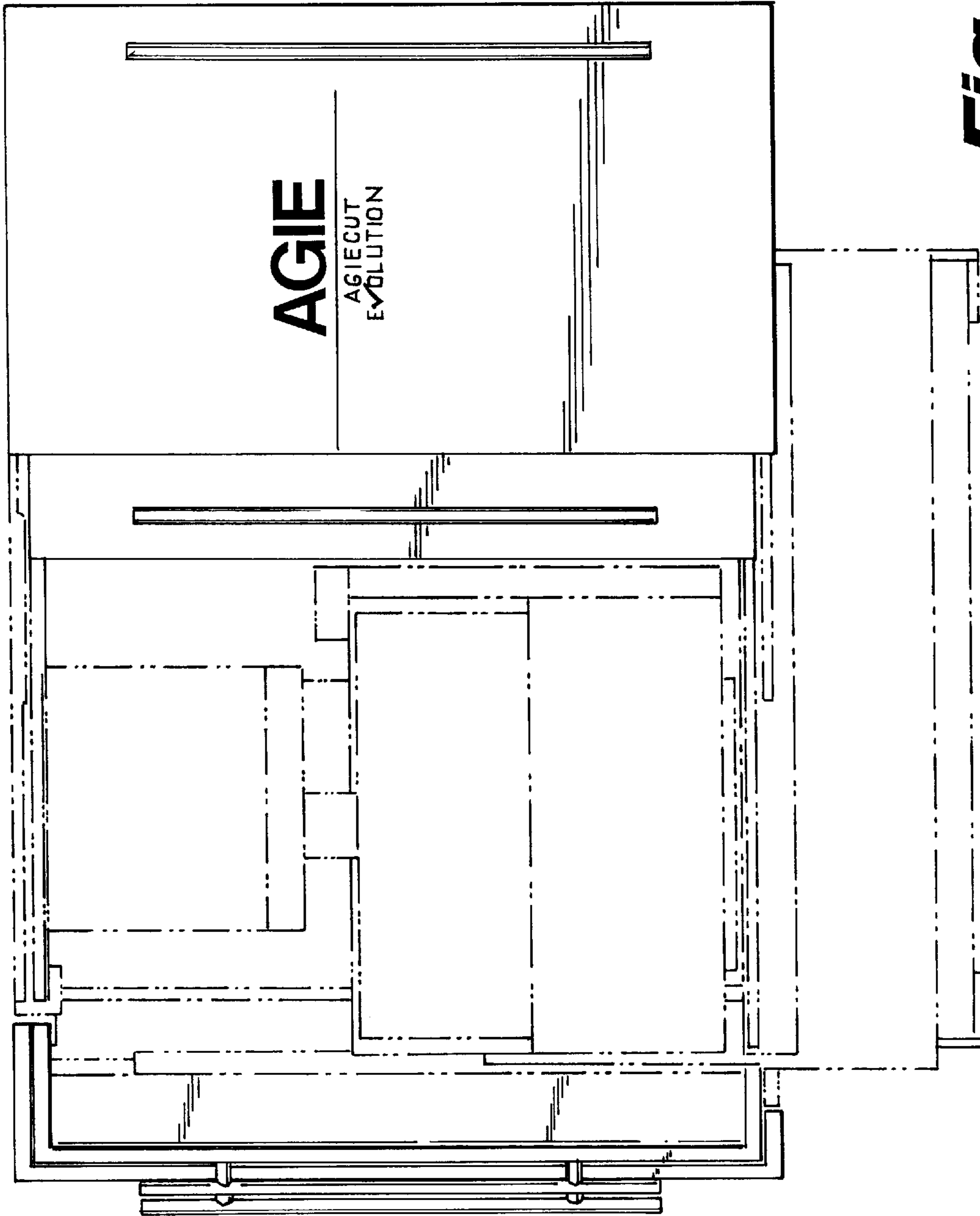

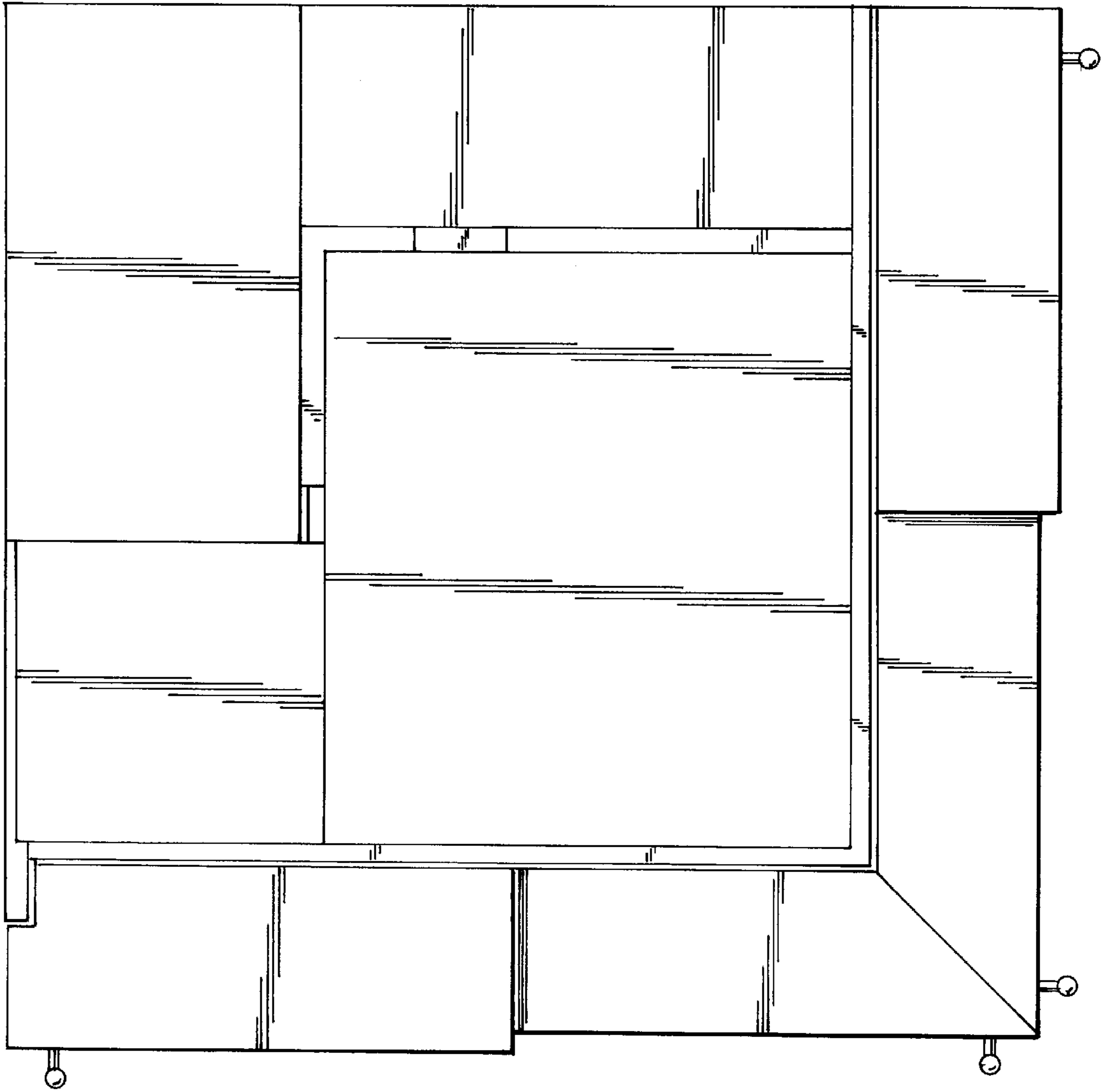
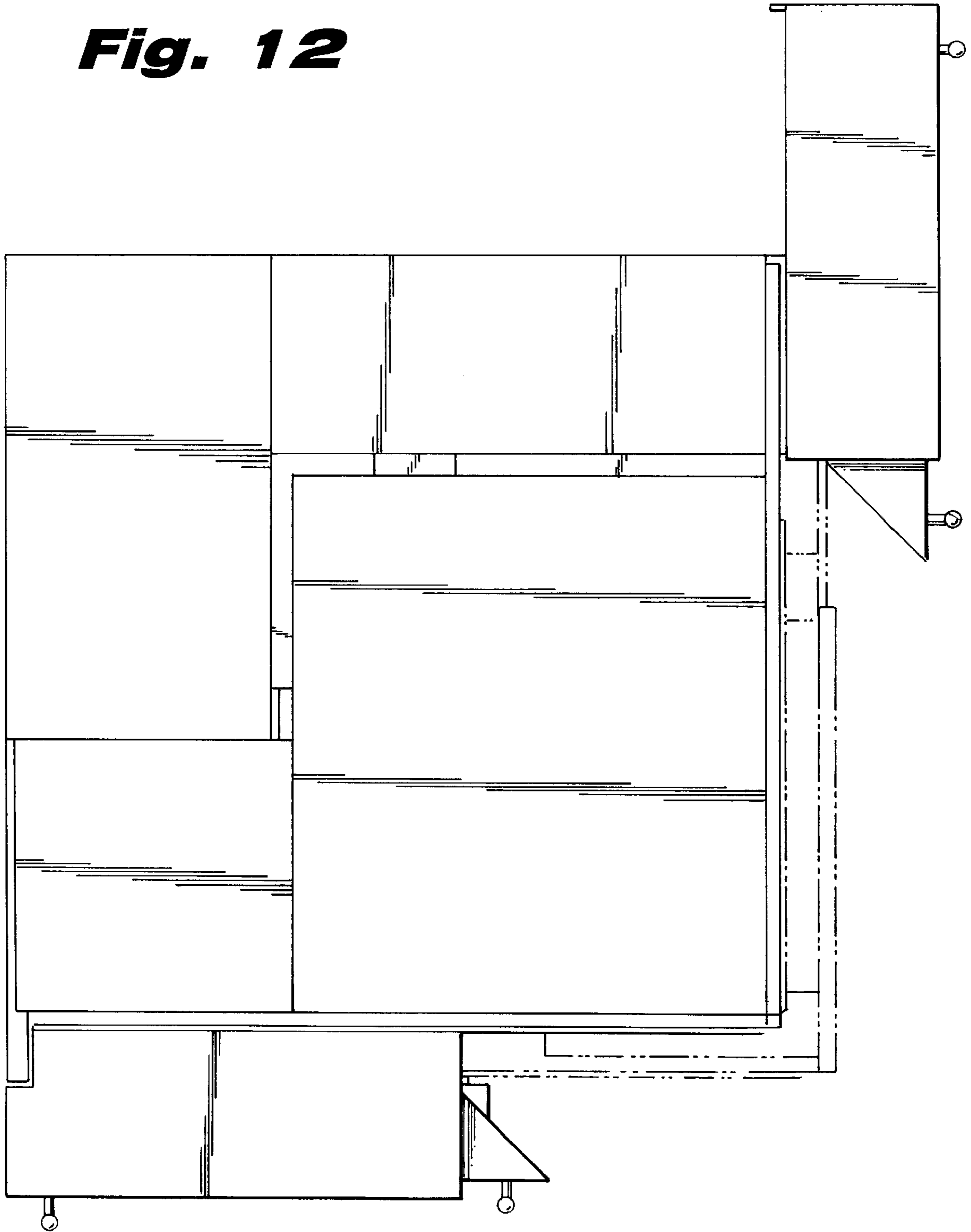

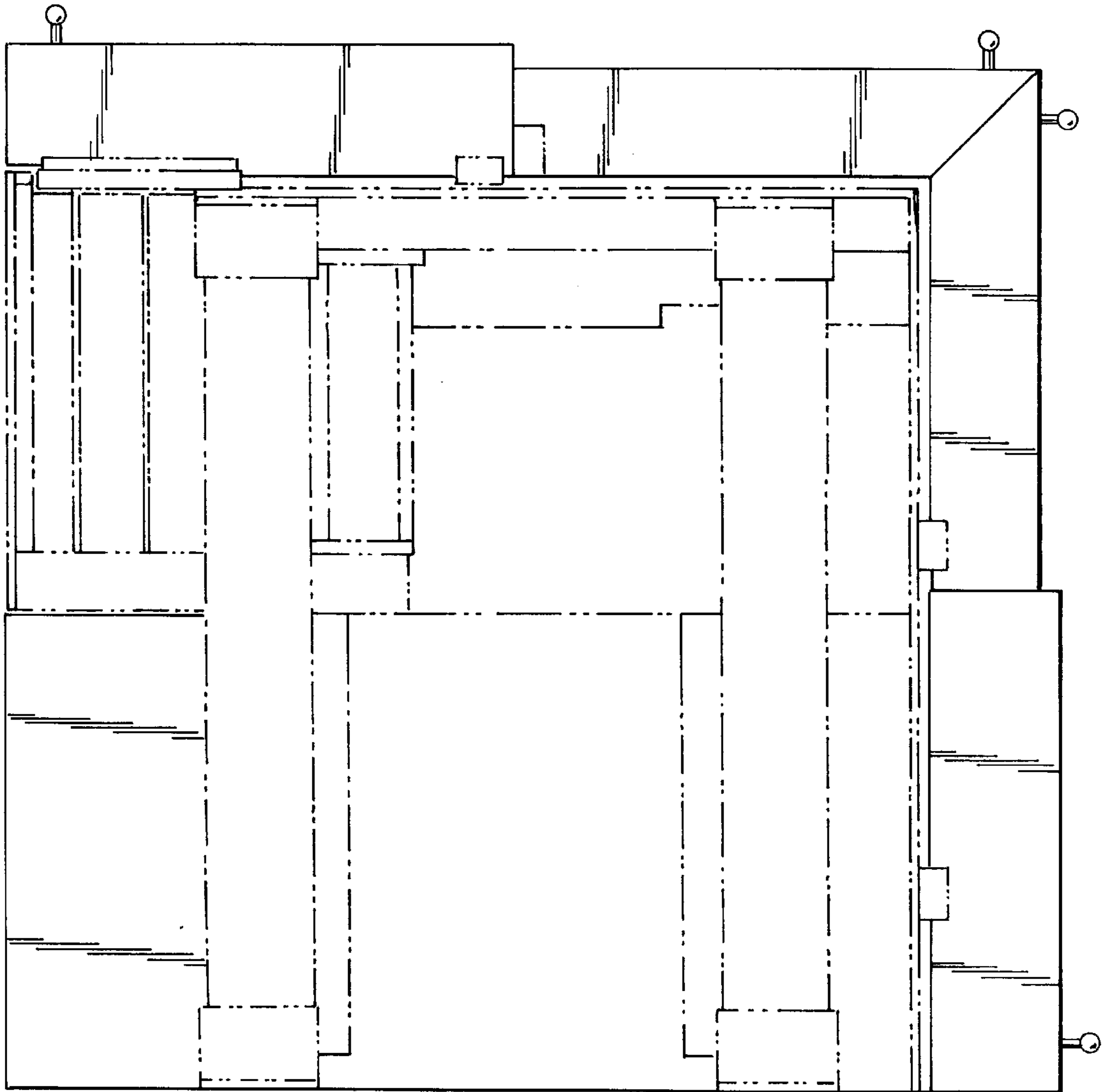
