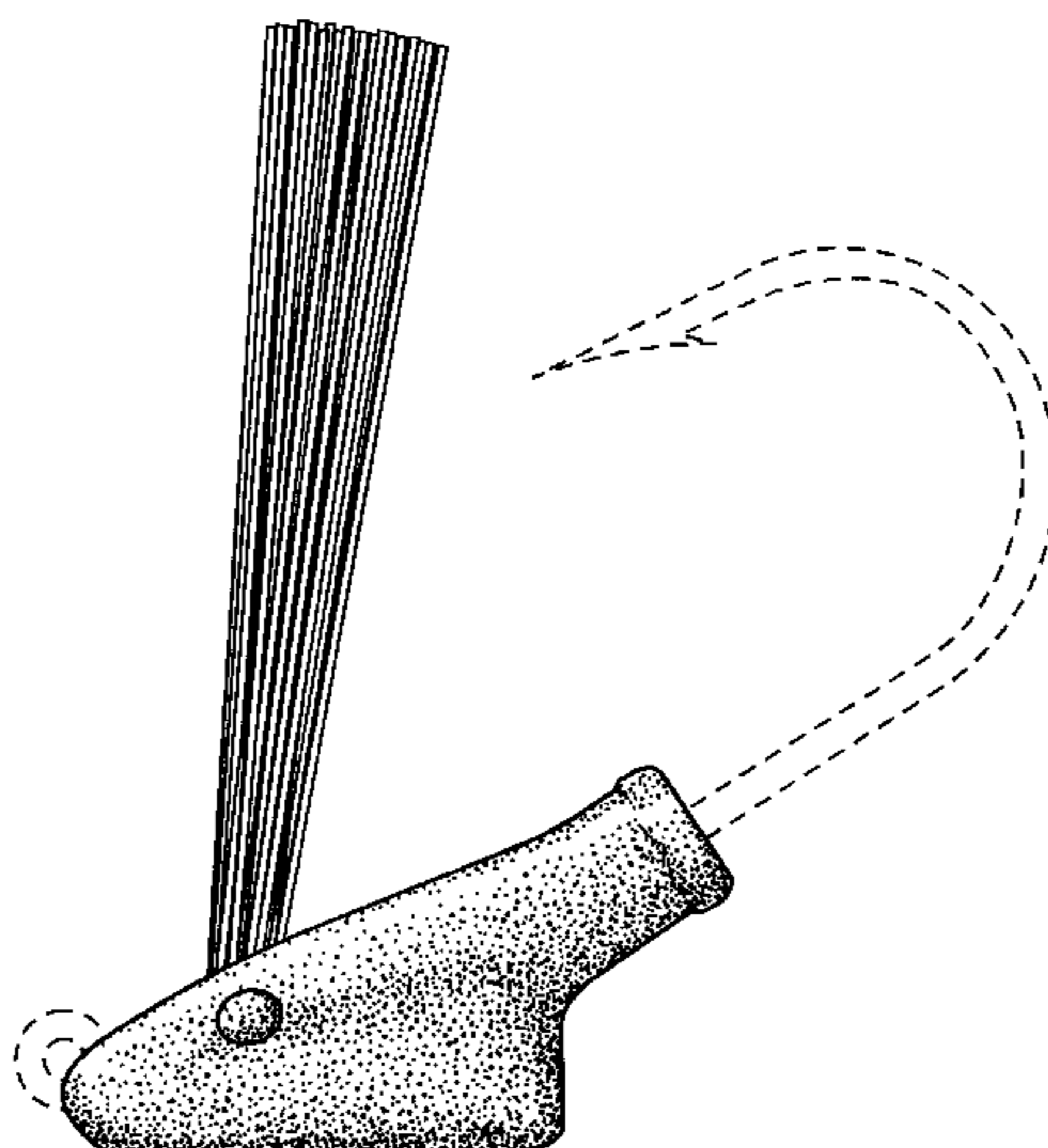
[57] **CLAIM**

The ornamental design for a fishing lure, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a fishing lure, showing my new design;
FIG. 2 is a bottom plan view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a front elevational view thereof;
FIG. 5 is a side elevational view, the opposite side being a mirror image thereof;
FIG. 6 is a top plan view of a second embodiment;
FIG. 7 is a bottom plan view thereof;
FIG. 8 is a rear elevational view thereof;
FIG. 9 is a front elevational view thereof; and,
FIG. 10 is a side elevational view, the opposite side being a mirror image thereof.
The broken line showing of environment in FIGS. 1-10 is for illustrative purposes only and forms no part of the claimed design.

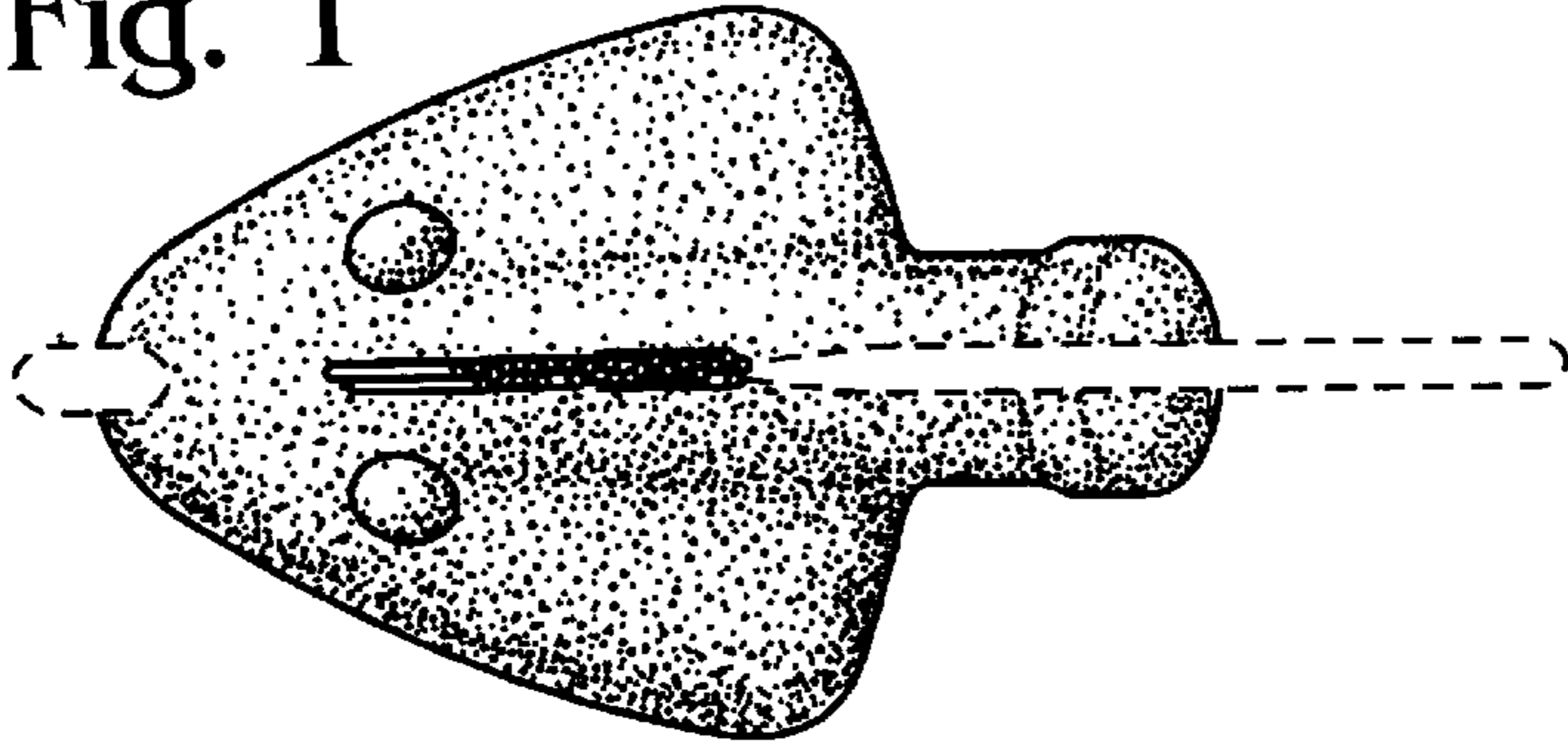

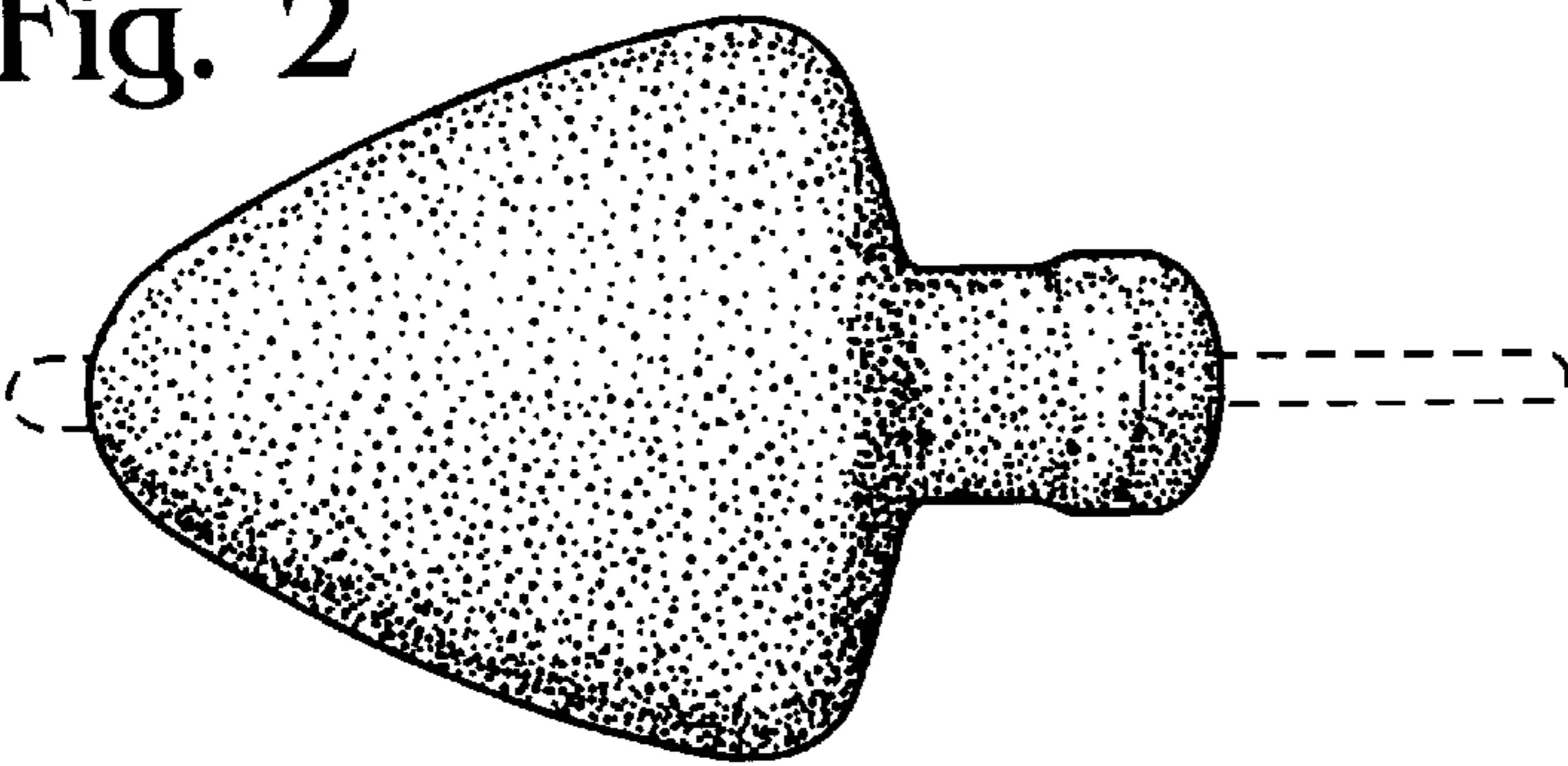

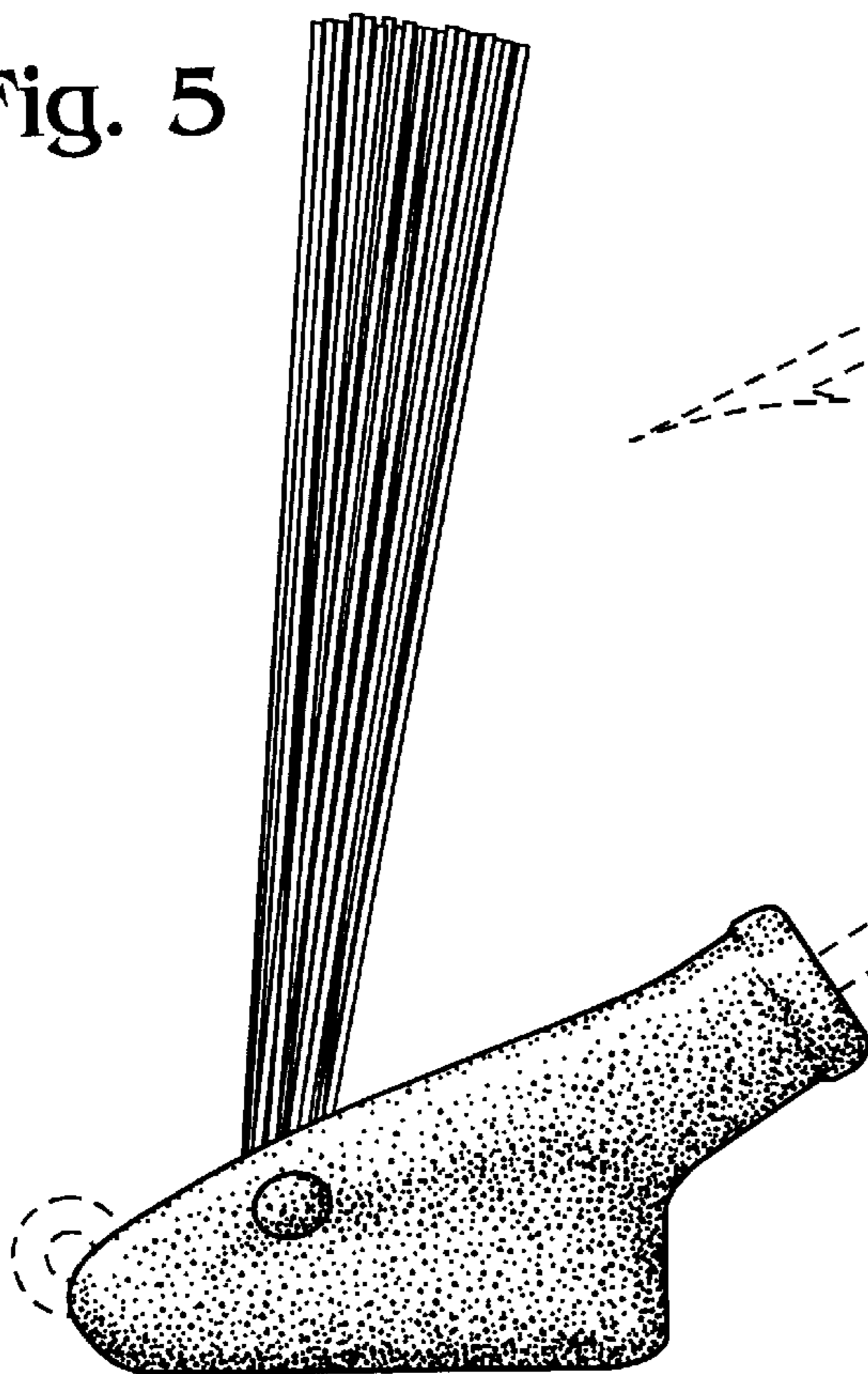

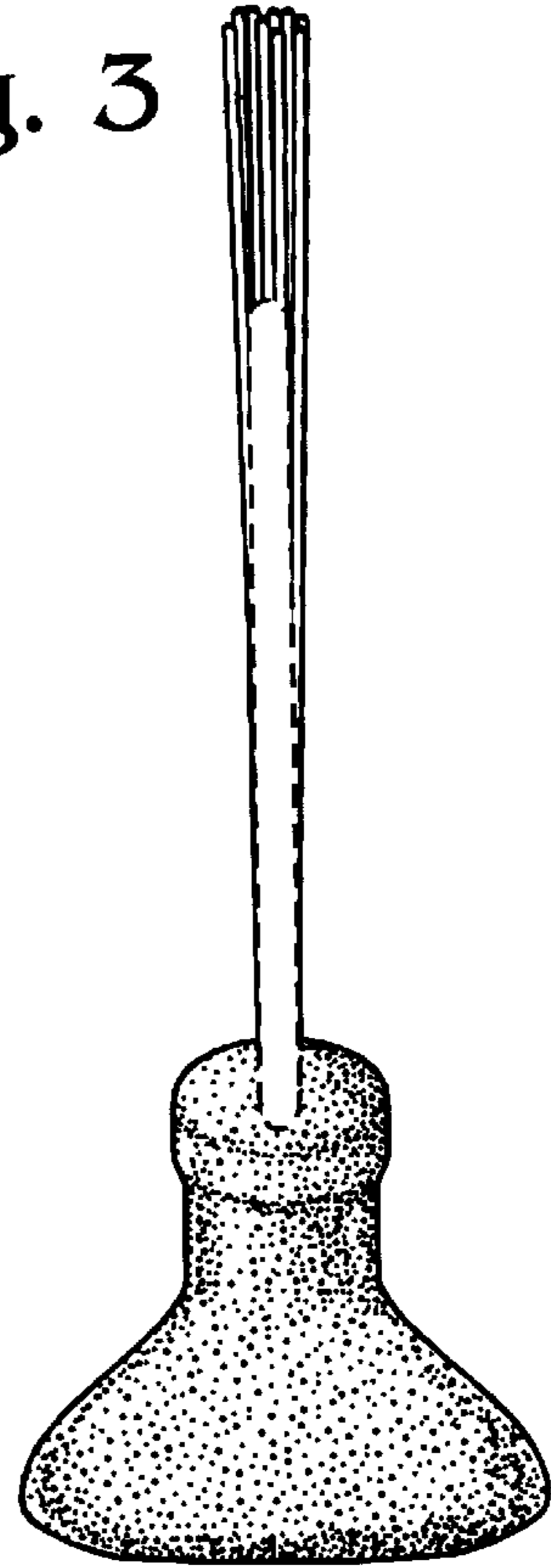

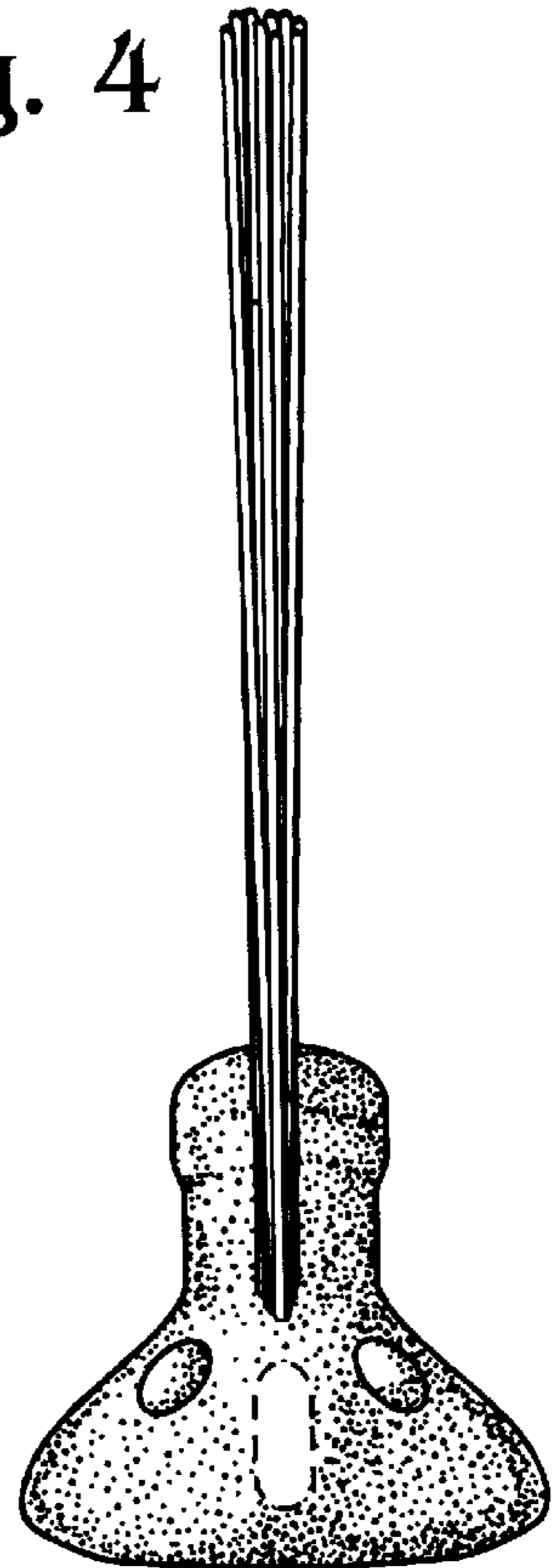

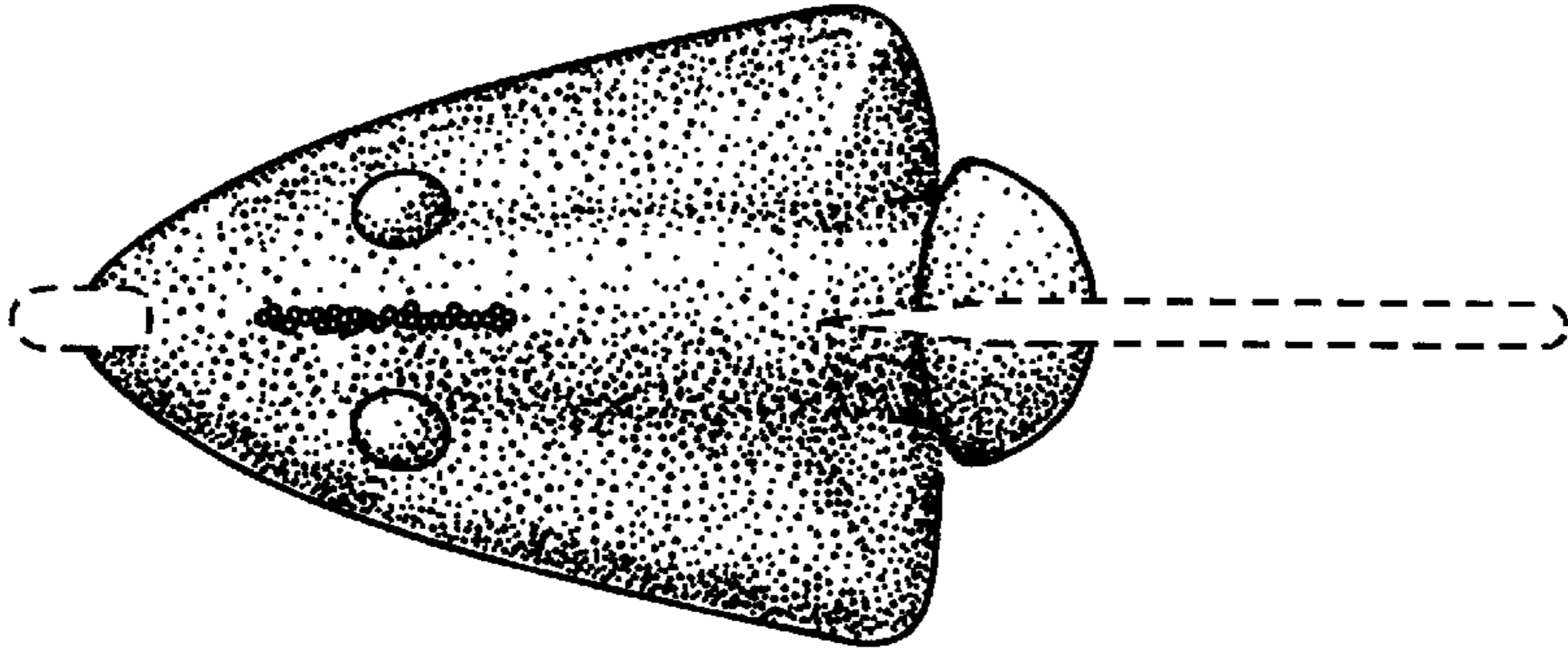

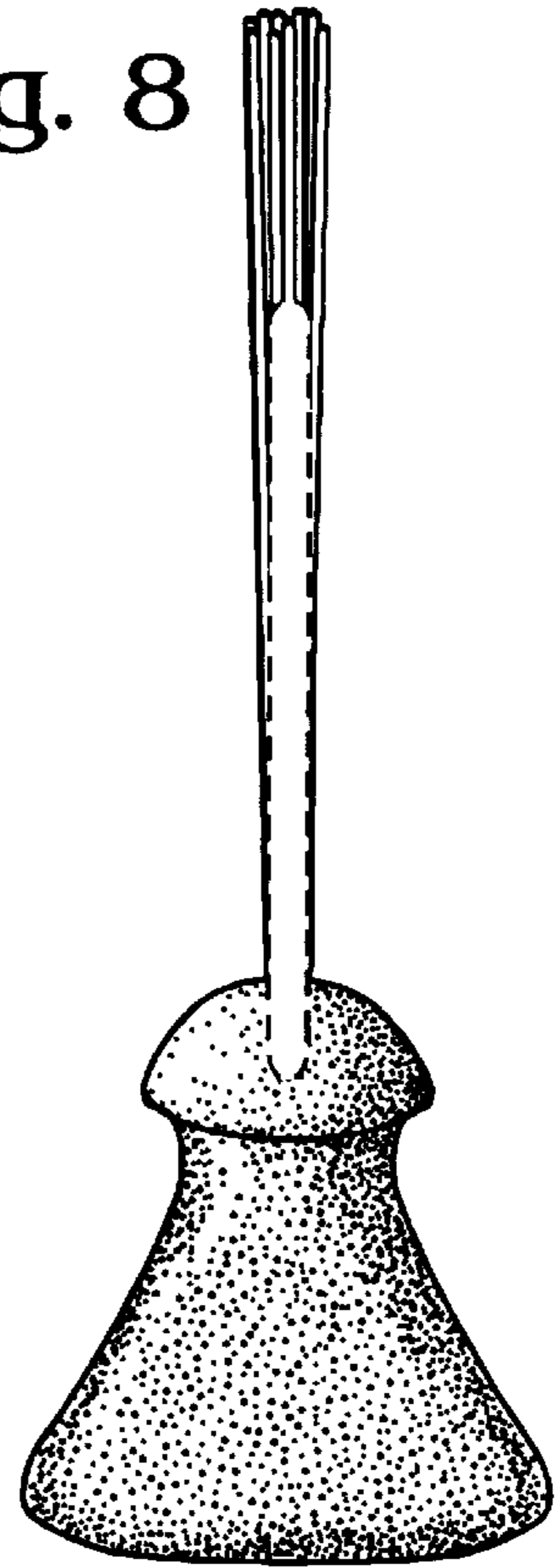

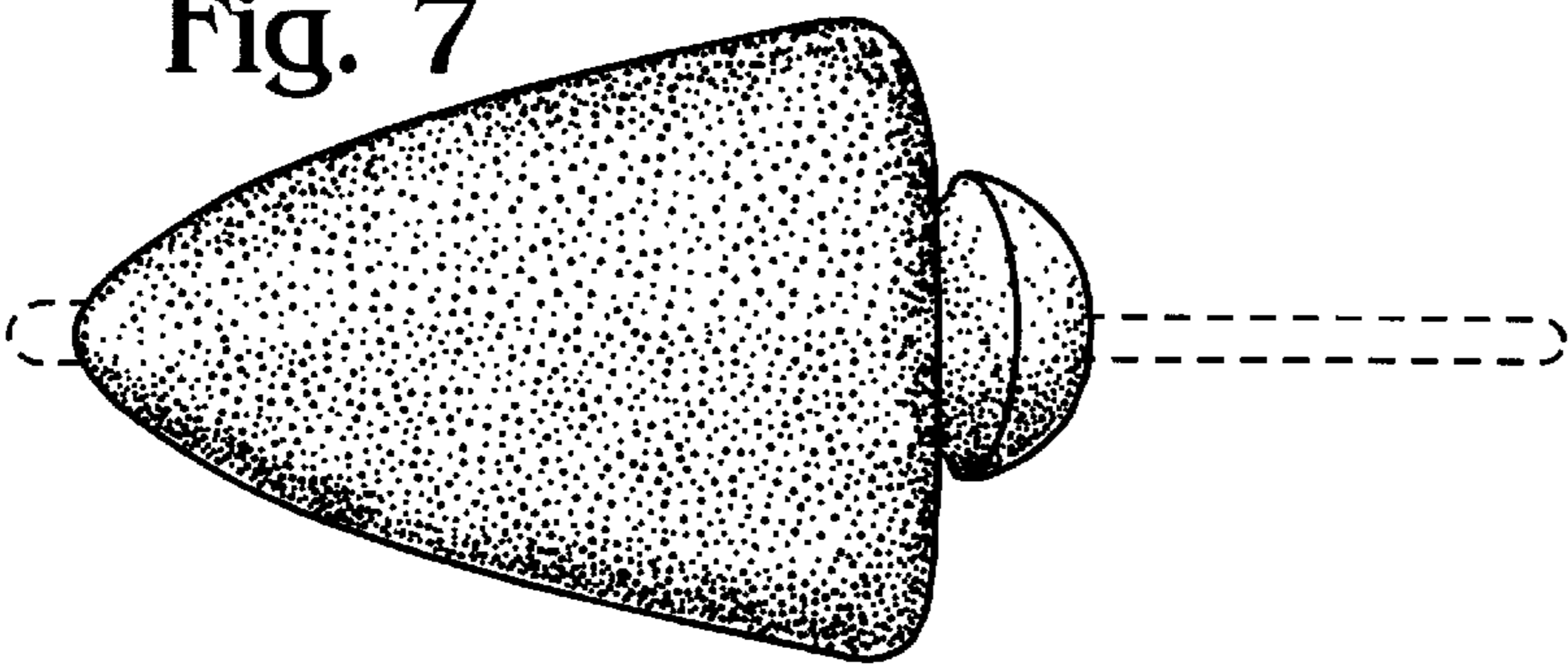

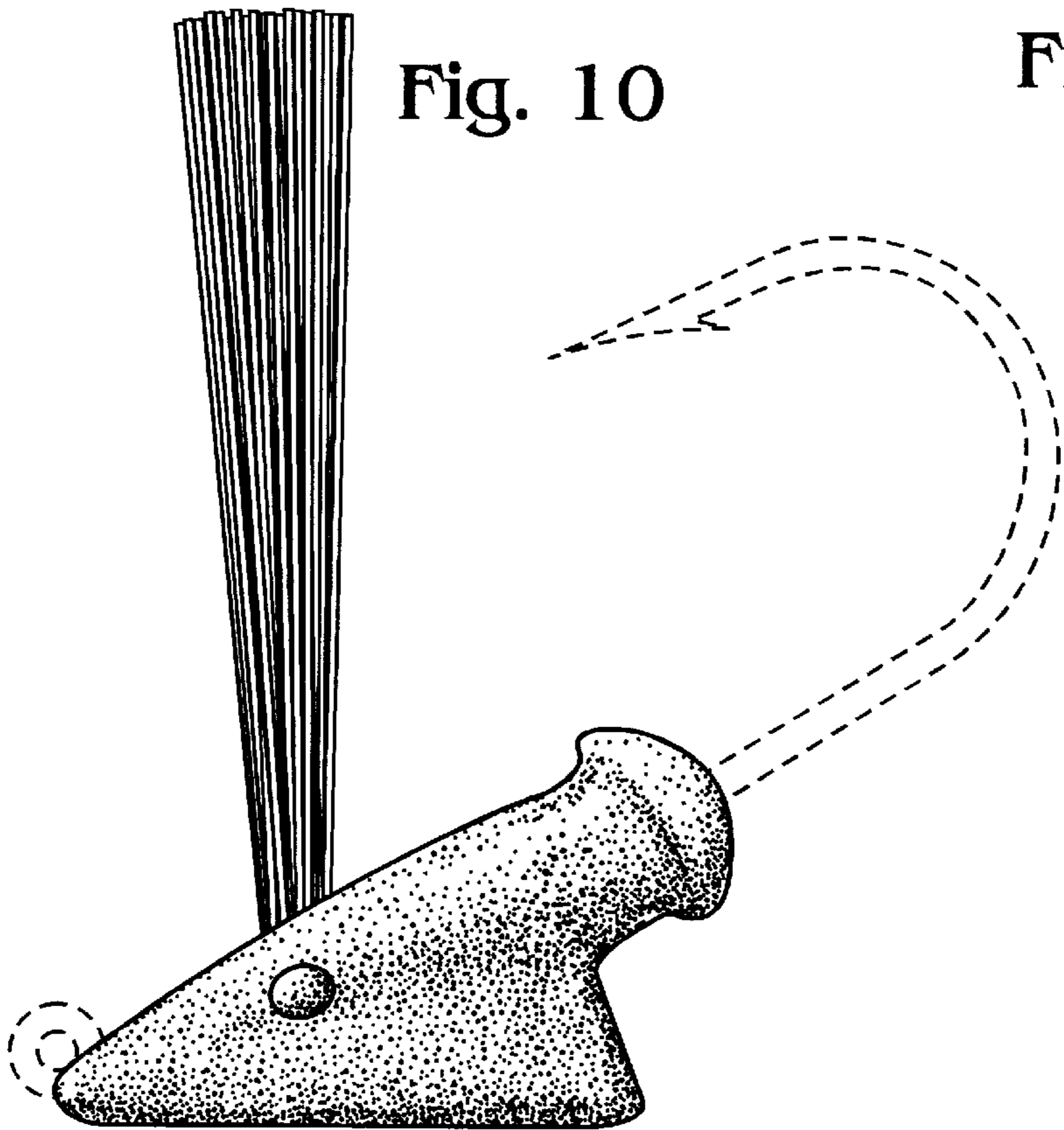
