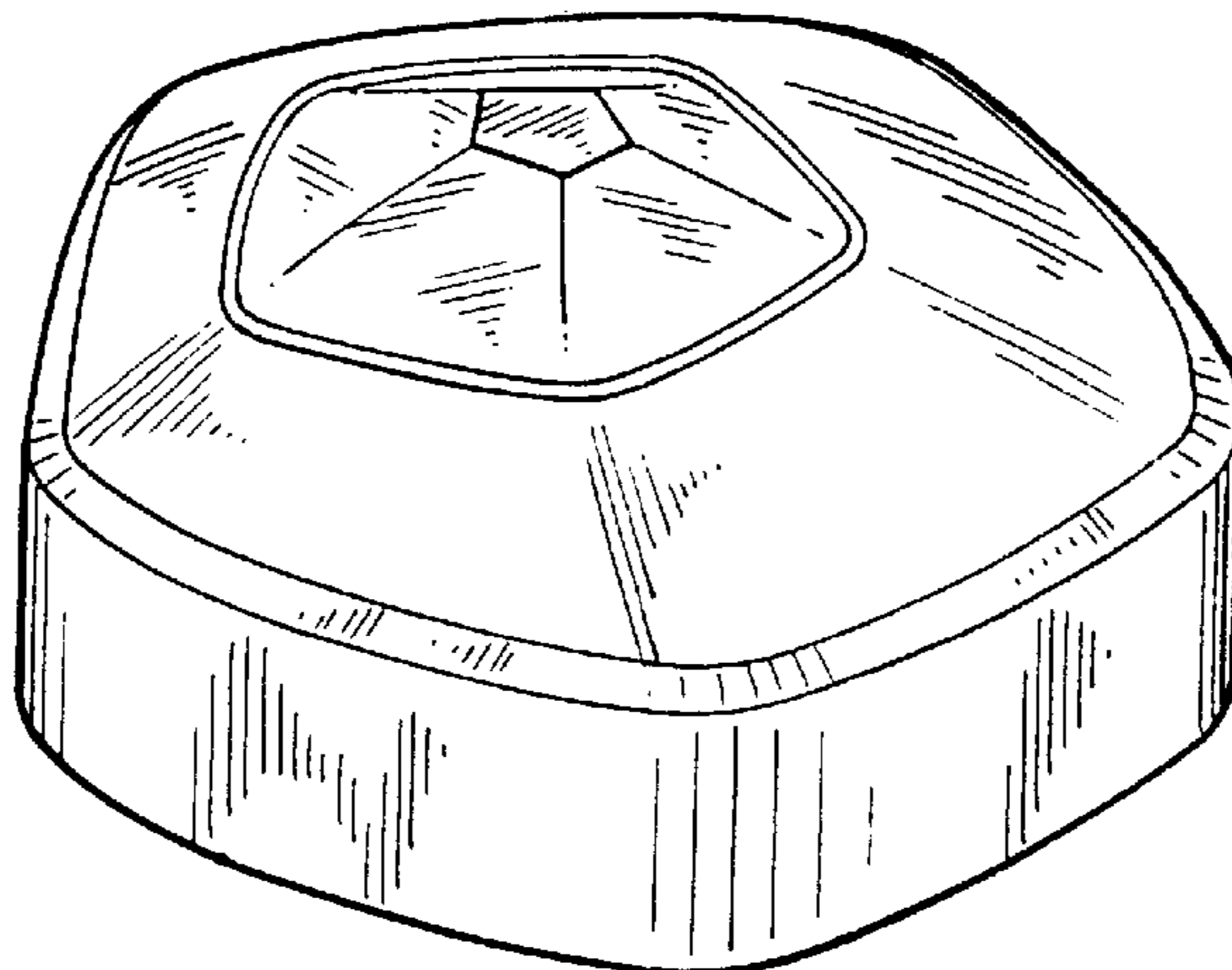
[57] **CLAIM**

The ornamental design for a pharmaceutical tablet, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view from one end, one side and above the pharmaceutical tablet;
FIG. 2 is a view from below the pharmaceutical tablet;
FIG. 3 is a view of the other side of the pharmaceutical tablet; and,
FIG. 4 is a view of the other end of the pharmaceutical tablet.

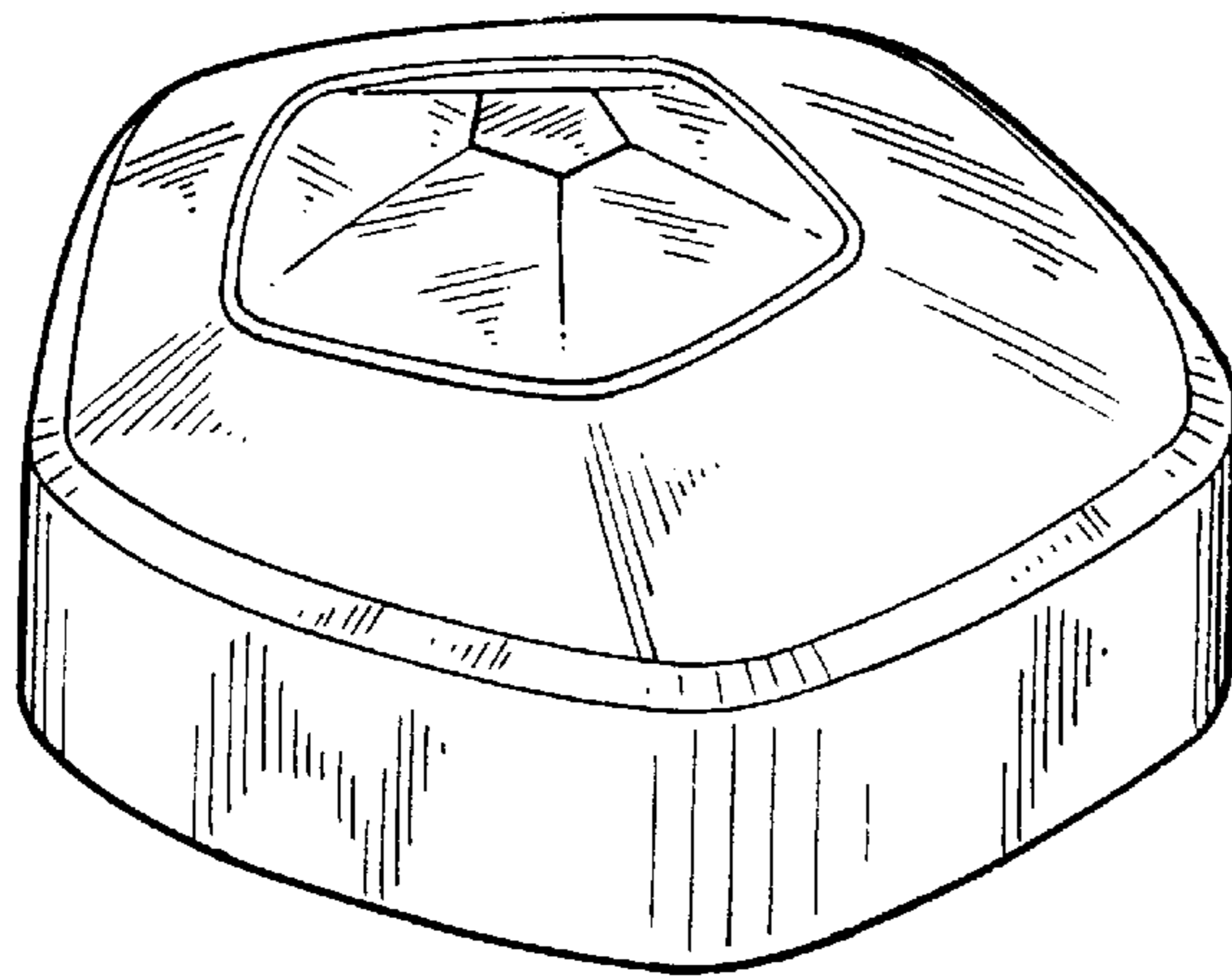

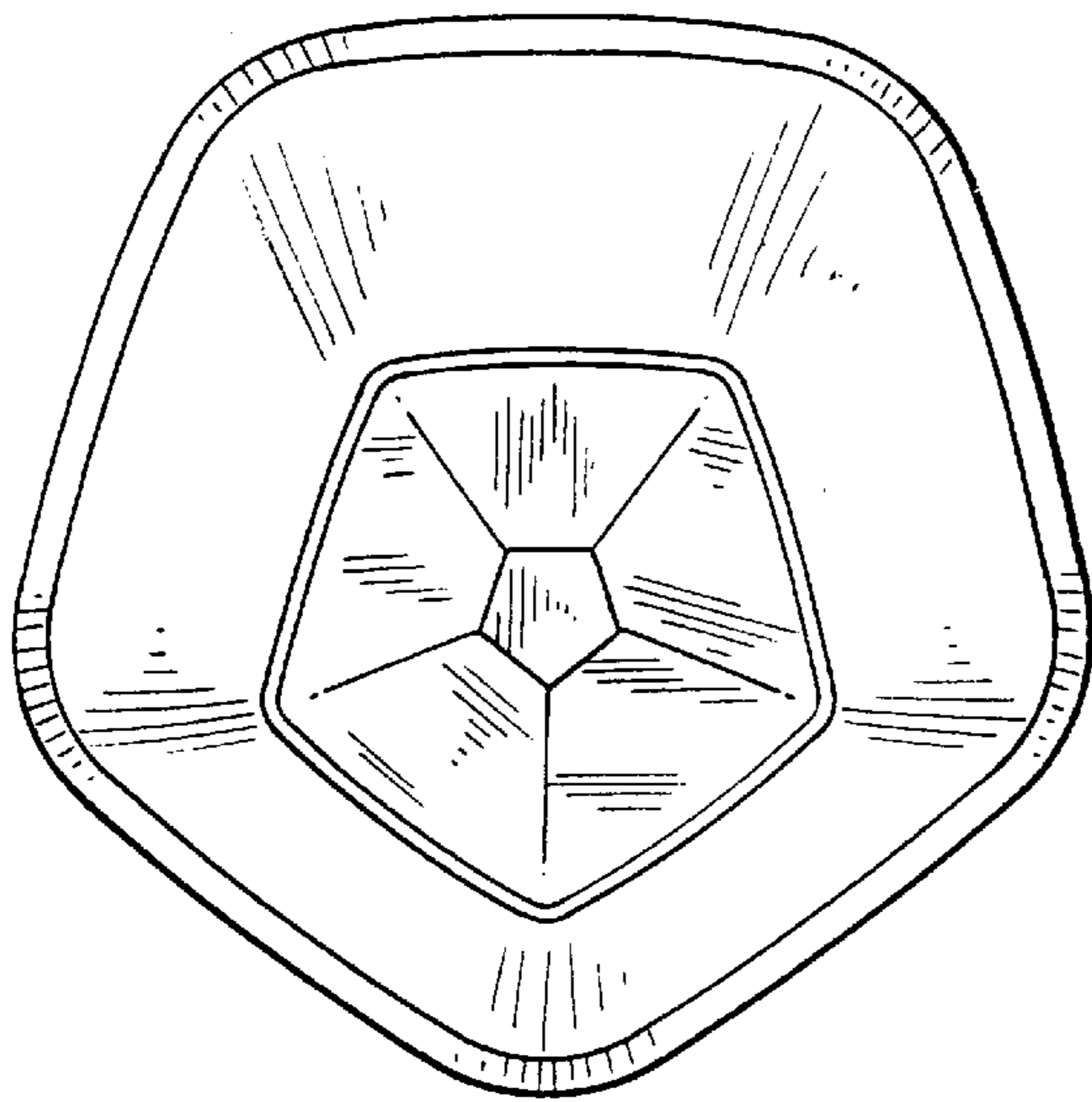

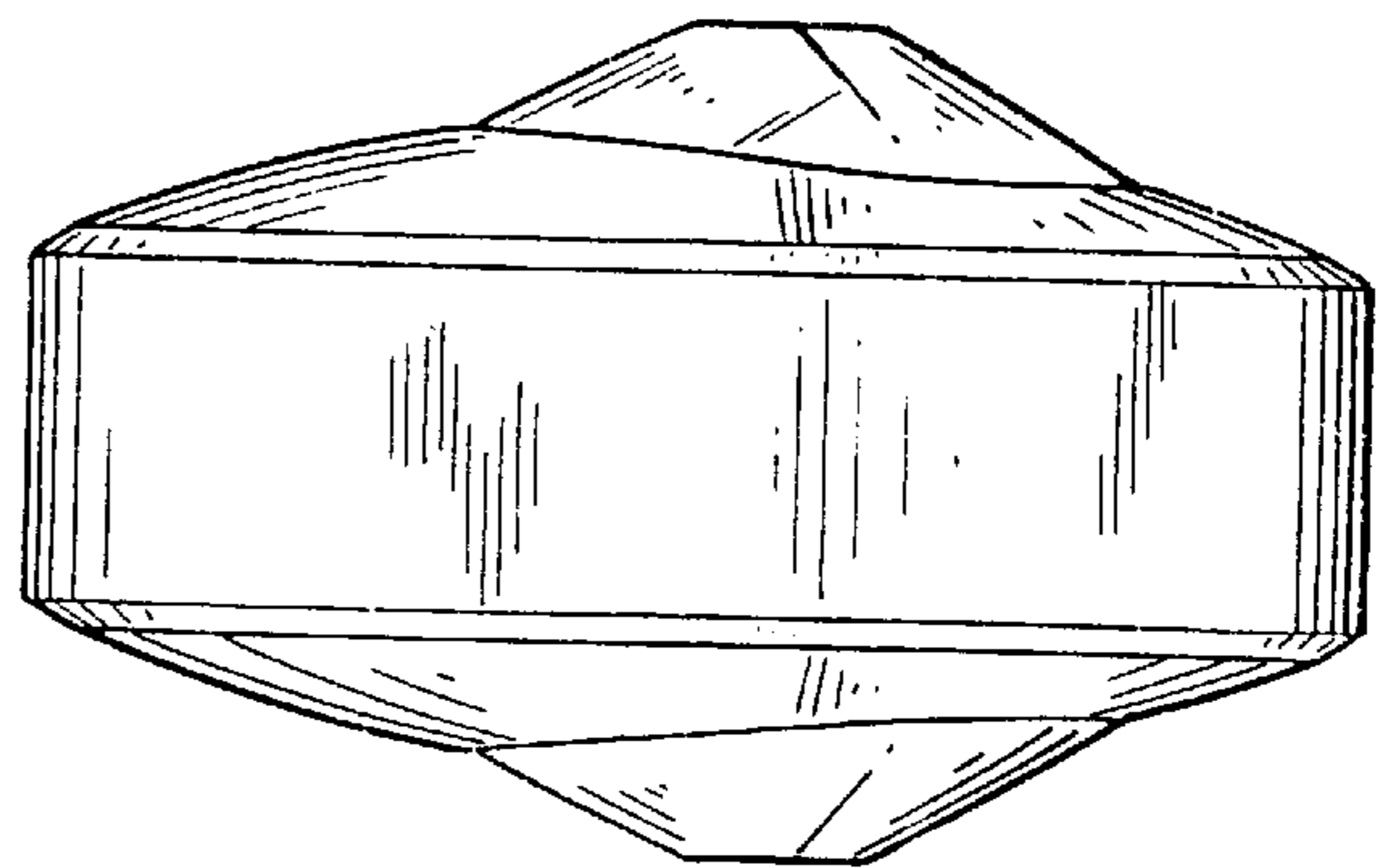

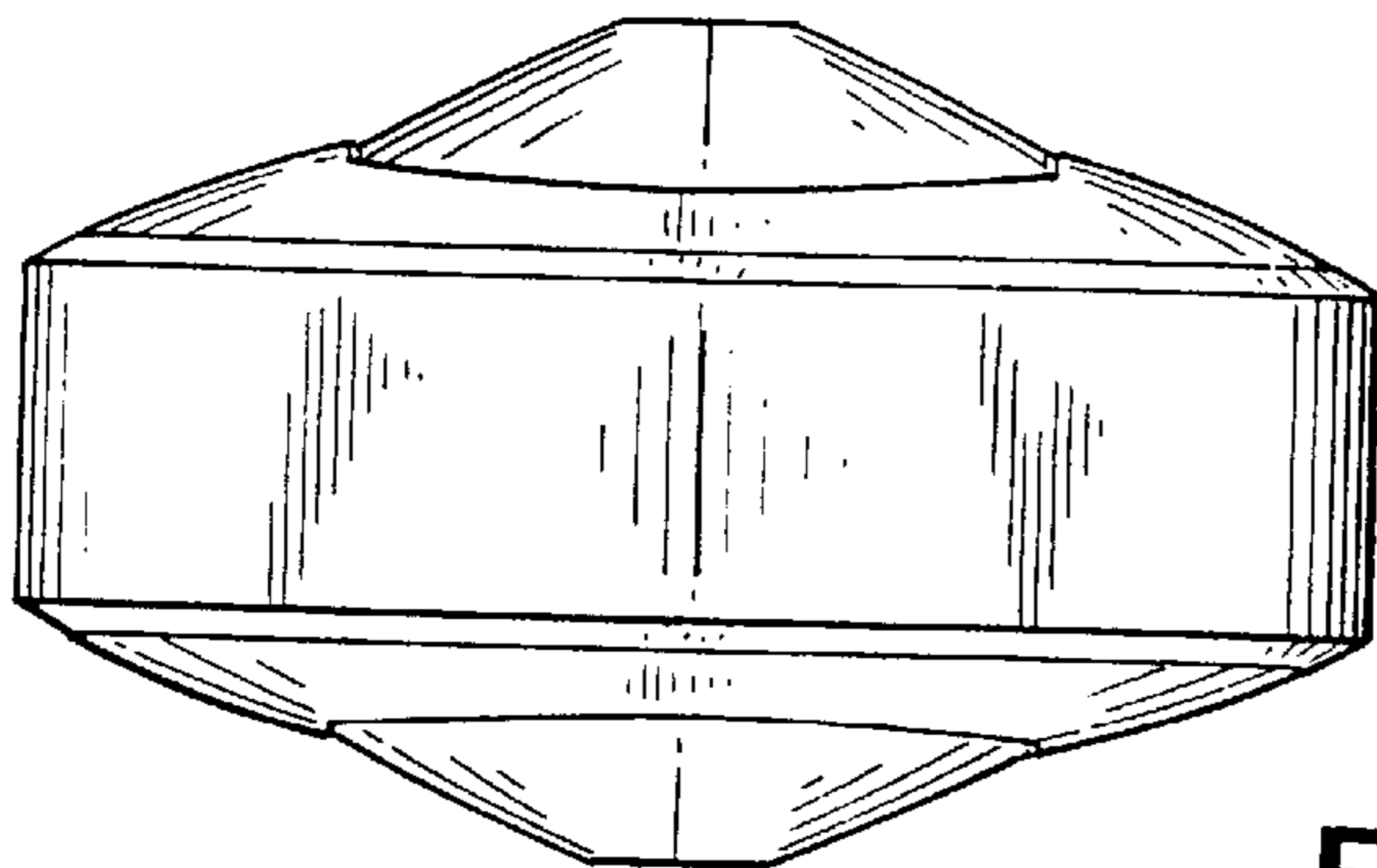
