[57] **CLAIM**

The ornamental design for a bioenergy channelizer insert
pattern for clothing, as shown and described.

DESCRIPTION

FIG. 1 is a plan view of a bioenergy channelizer insert
pattern for clothing on a right sole, showing my new design;
FIG. 2 is a plan view thereof, on a left sole; and,
FIG. 3 is an enlarged view thereof.

The bioenergy channelizer pattern shown in the Figures is
not to be limited by the placement or orientation on the sole
of footwear.

The broken line showing the soles of footwear are for
illustrative purposes only and forms part of the claimed
design.

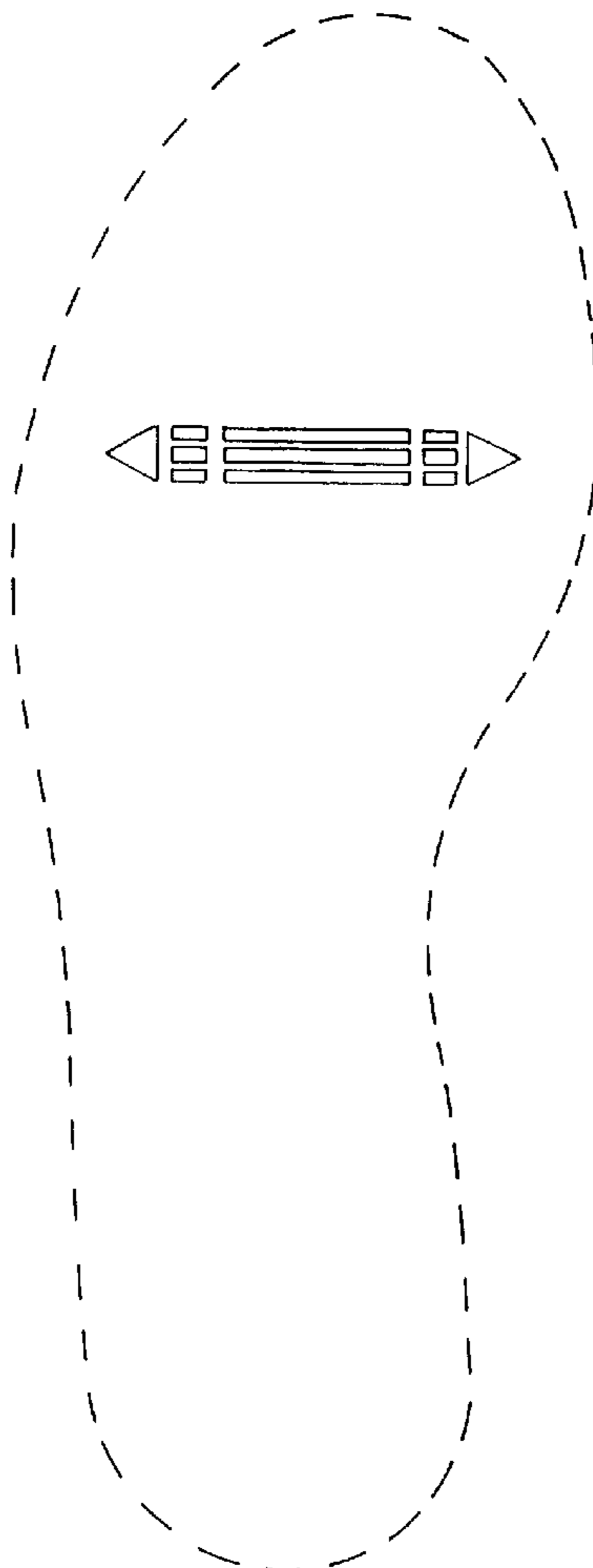

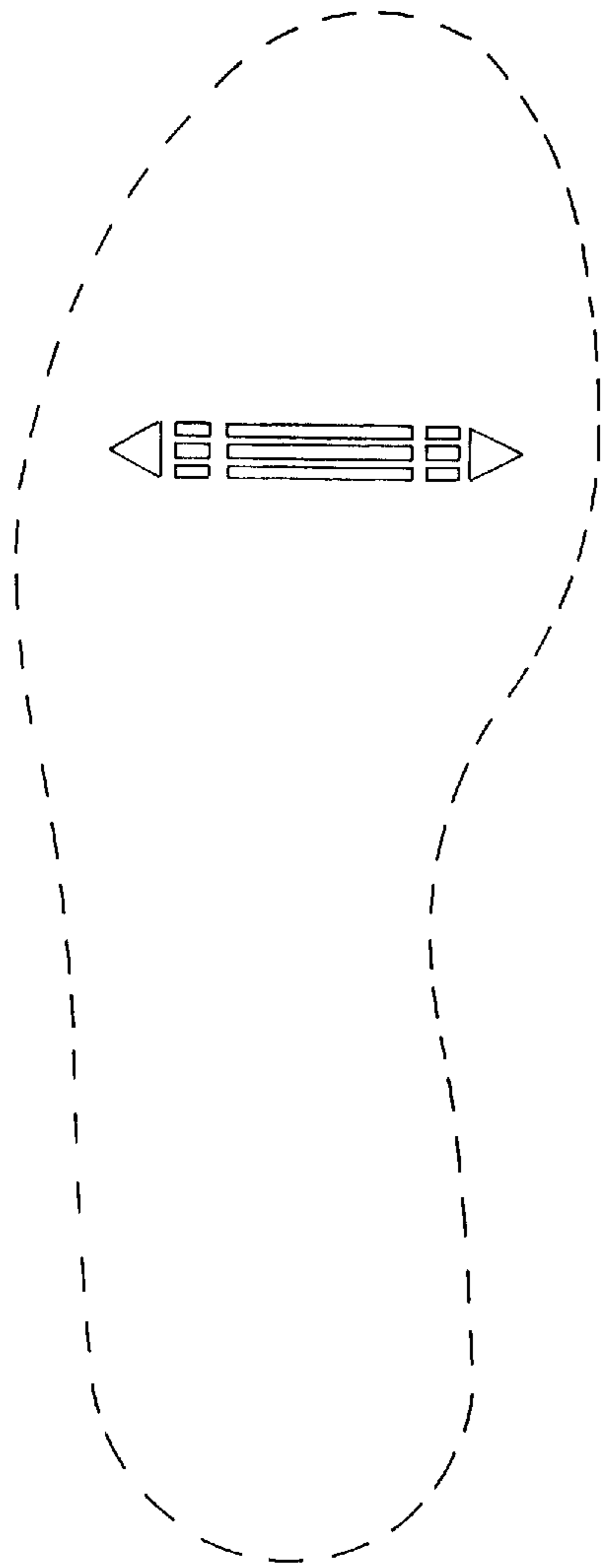

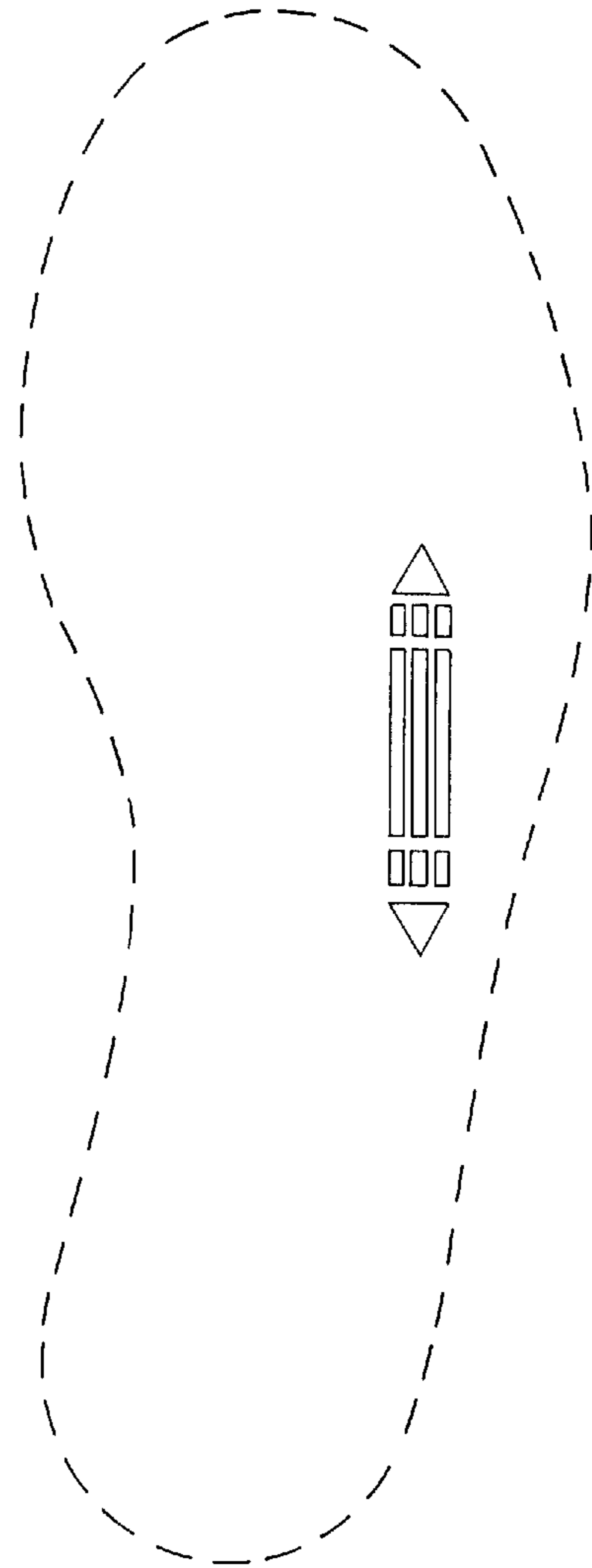
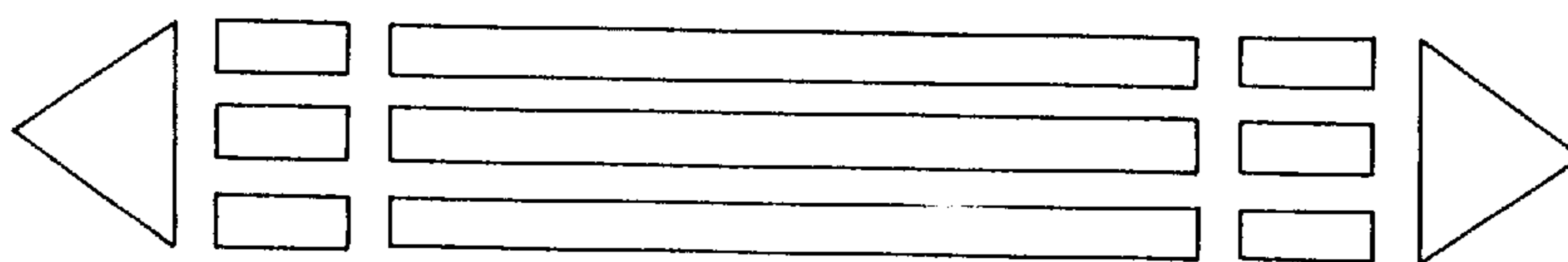
