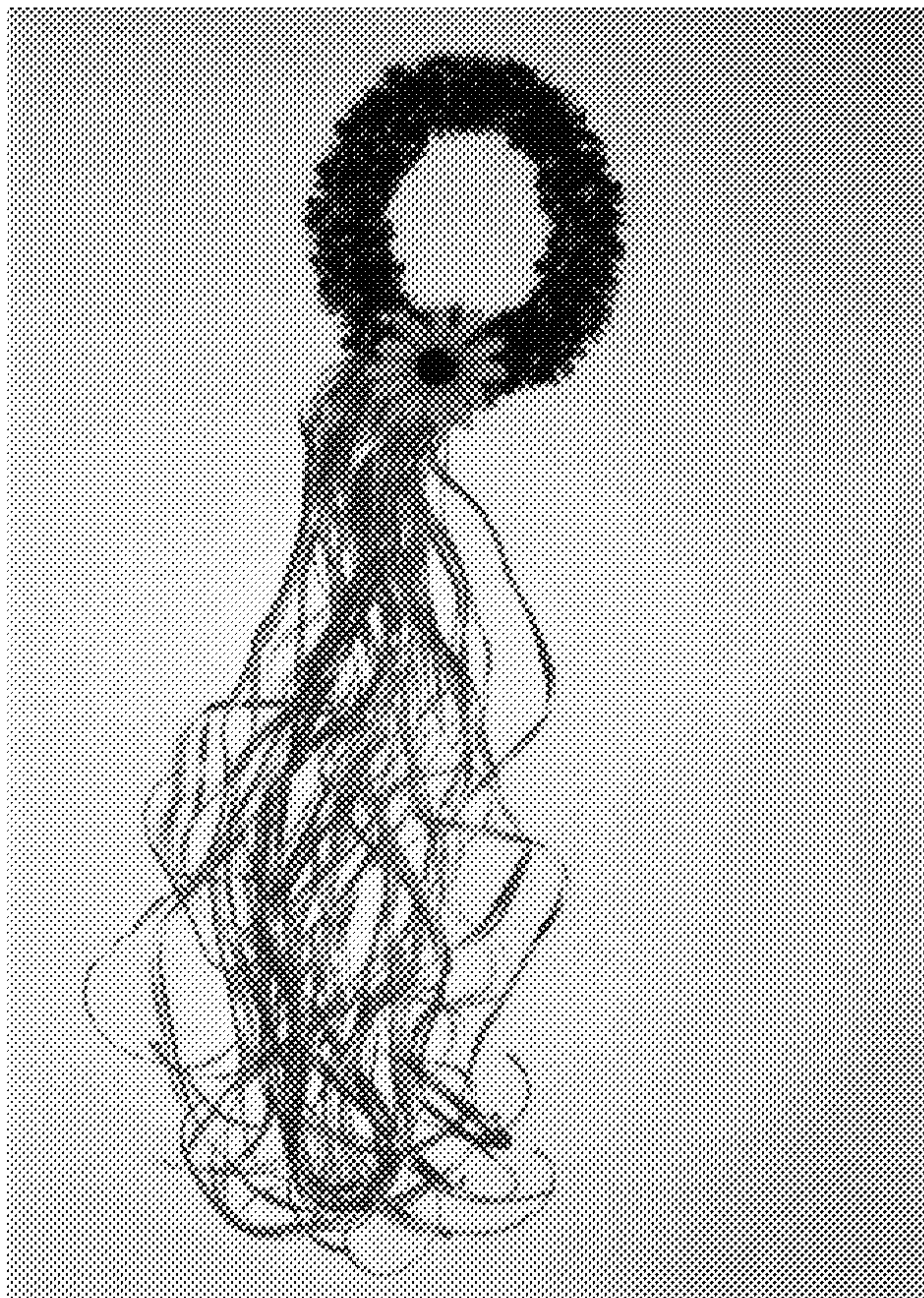
[57] **CLAIM**

The ornamental design for a princess halo head ring, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a princess halo head ring showing my new design;
 FIG. 2 is a bottom plan view thereof;
 FIG. 3 is a front elevational view thereof;
 FIG. 4 is a rear elevational view thereof;
 FIG. 5 is a side elevational view thereof, the opposite side is a mirror image;
 FIG. 6 is a top plan view of a second embodiment of a princess halo head ring showing my new design;
 FIG. 7 is a bottom plan view thereof;
 FIG. 8 is a front elevational view thereof;
 FIG. 9 is a rear elevational view thereof; and,
 FIG. 10 is a side elevational view thereof, the opposite side is a mirror image.

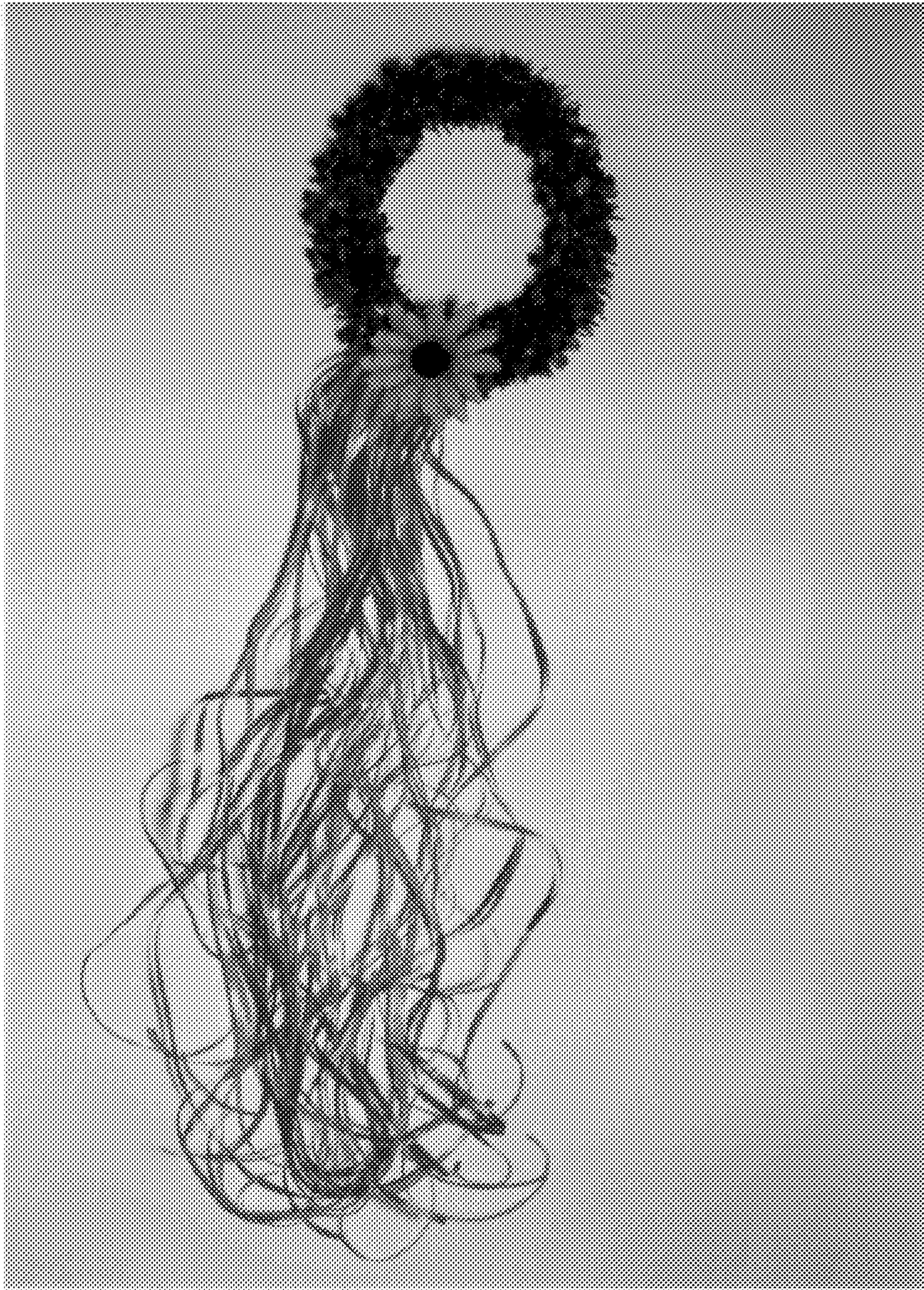

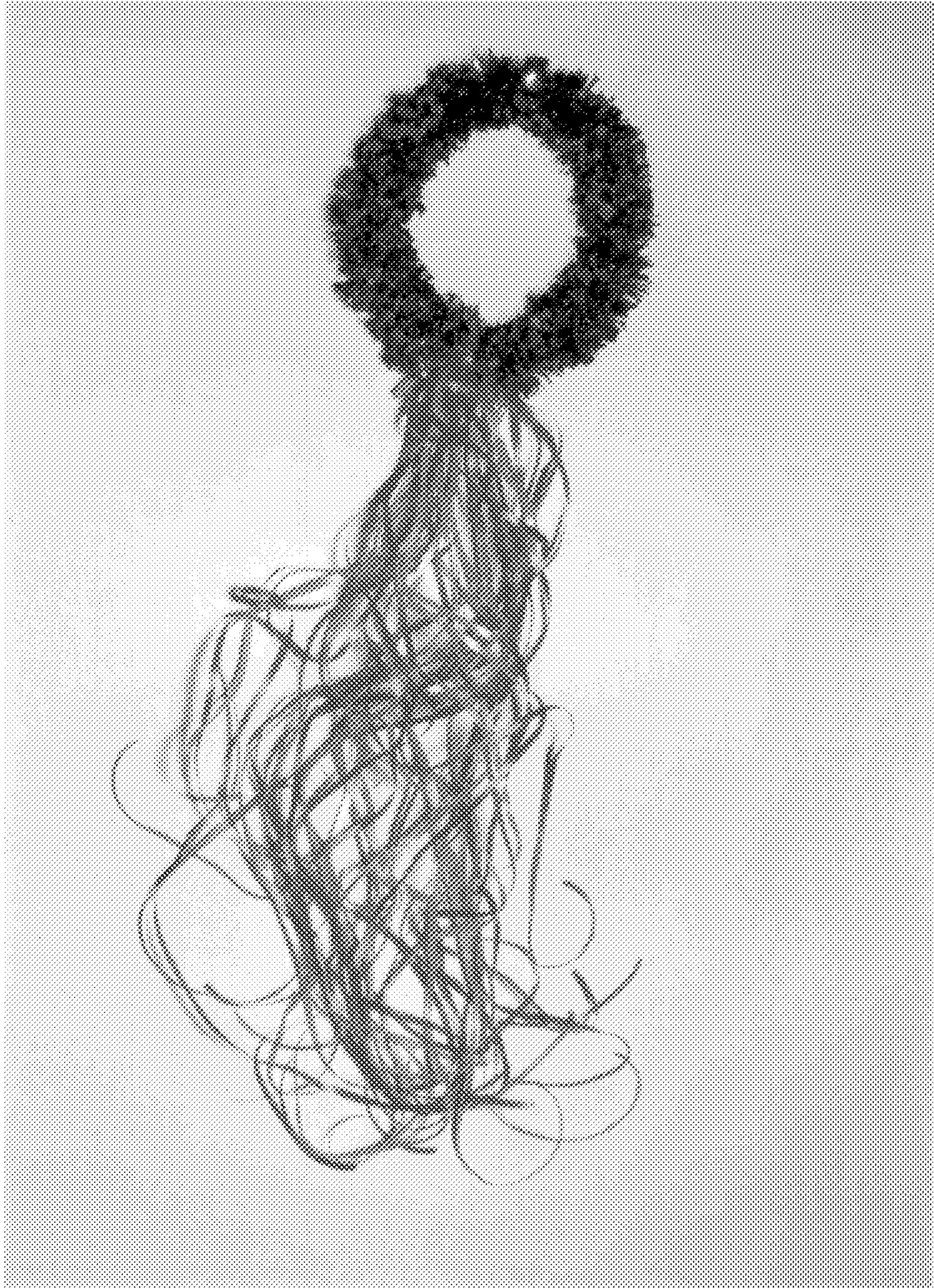

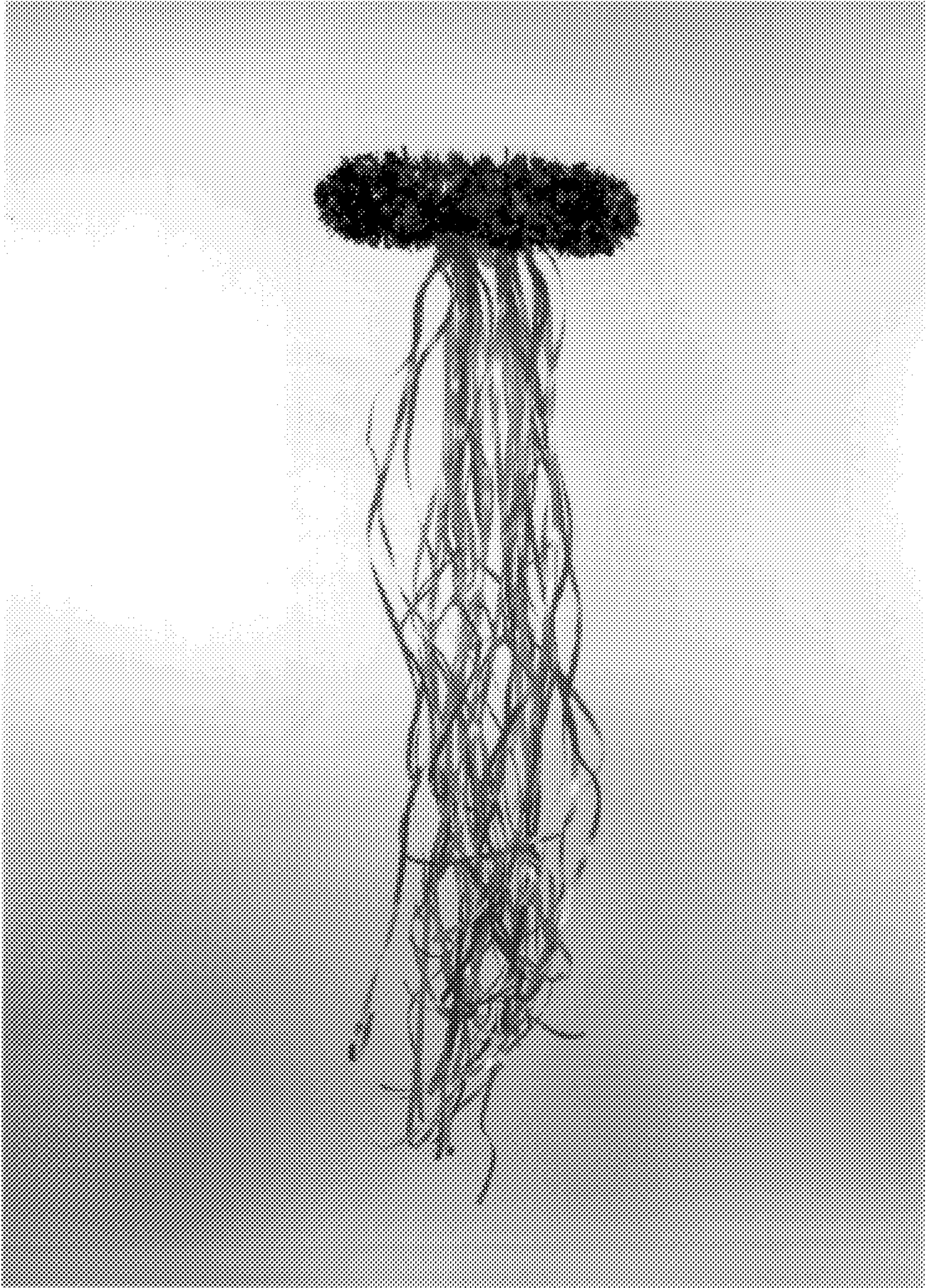

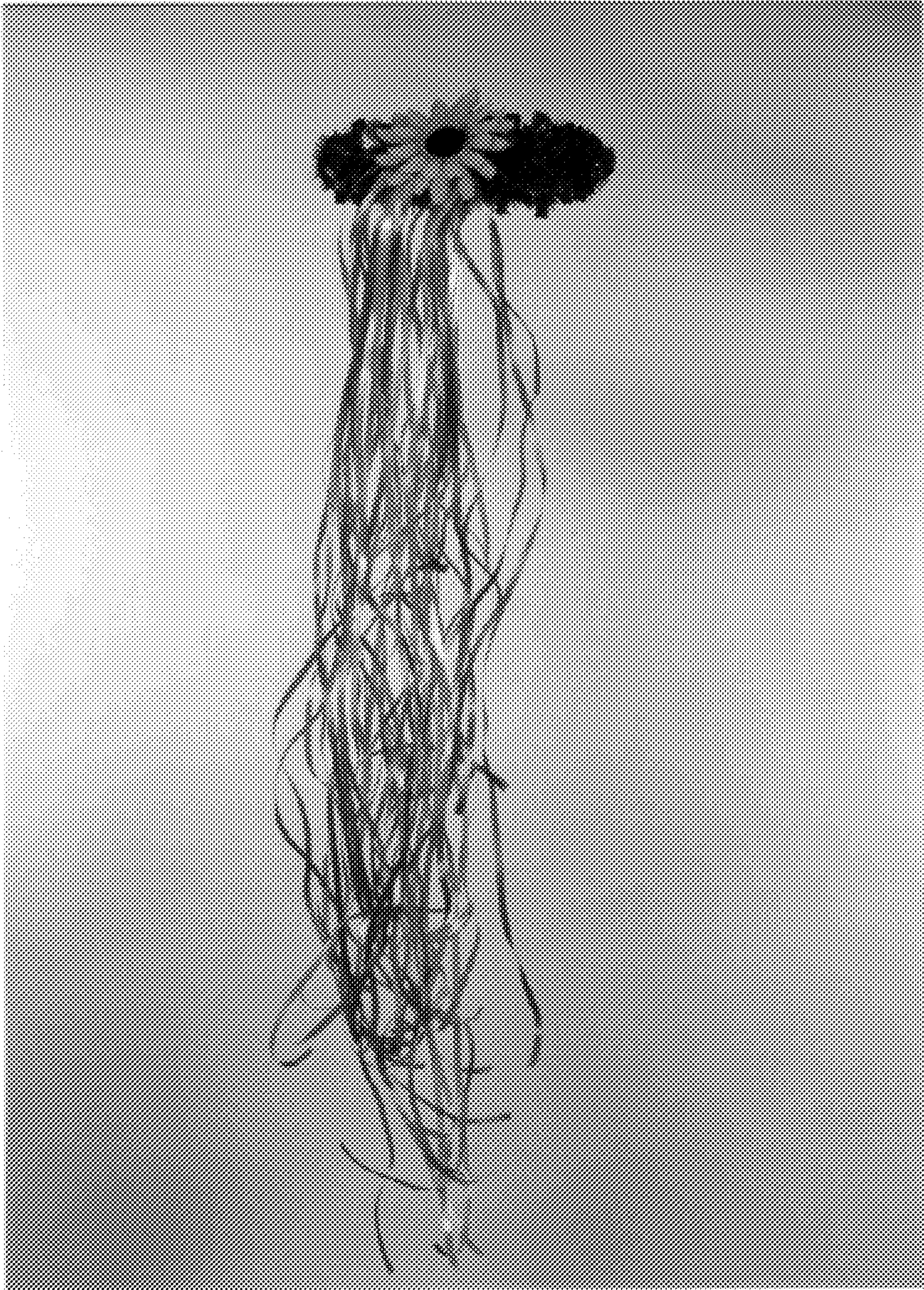

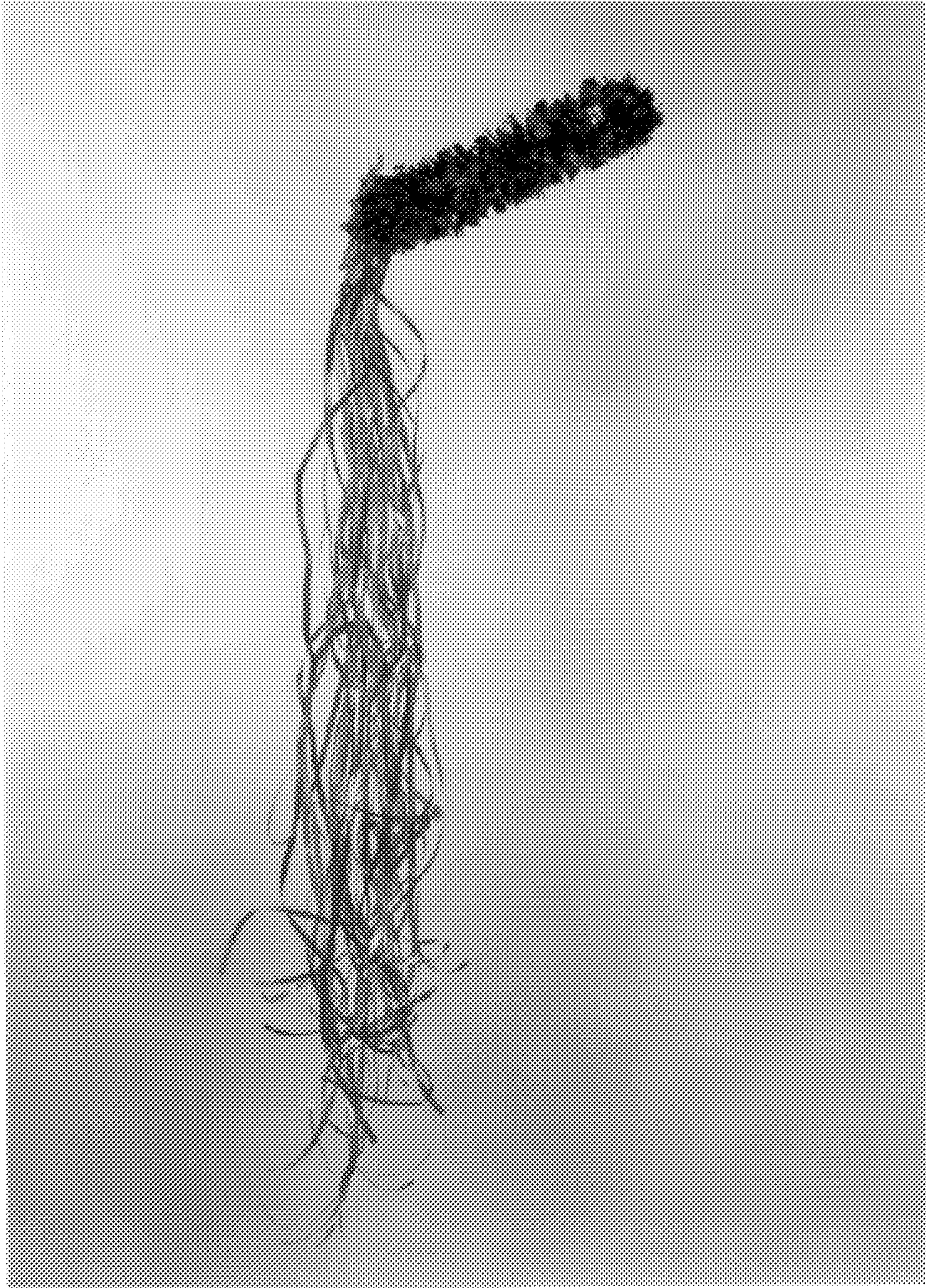

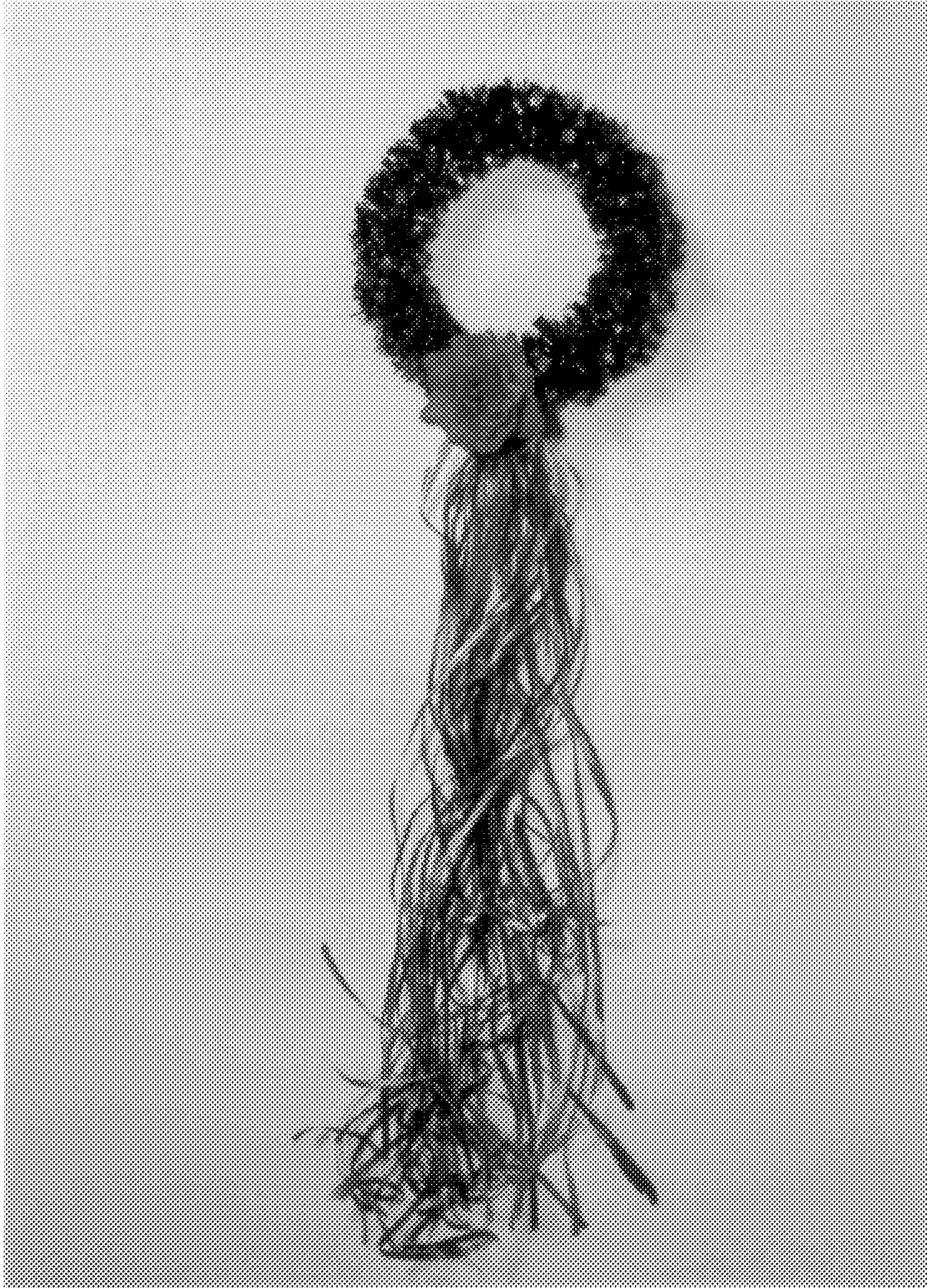

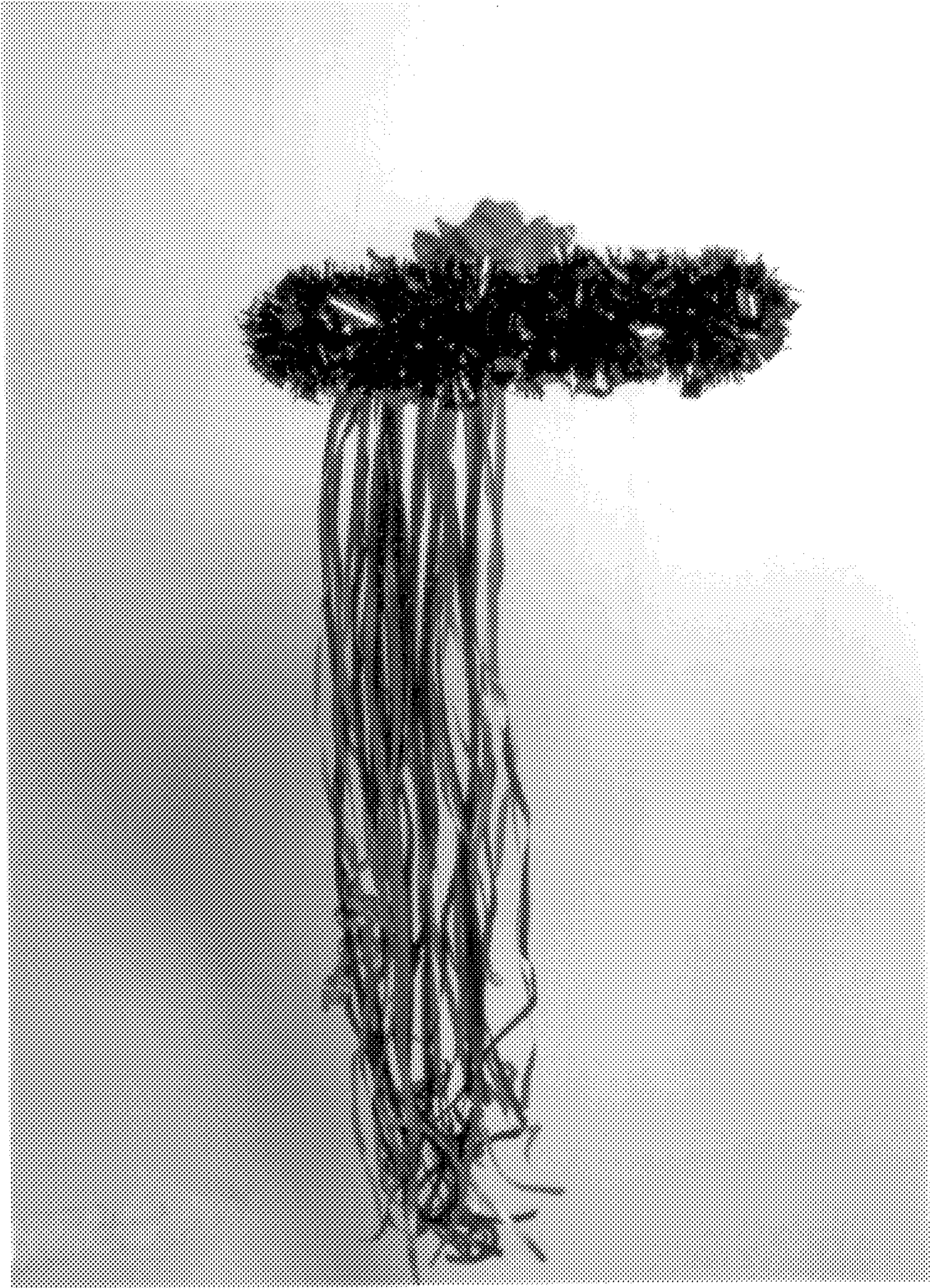

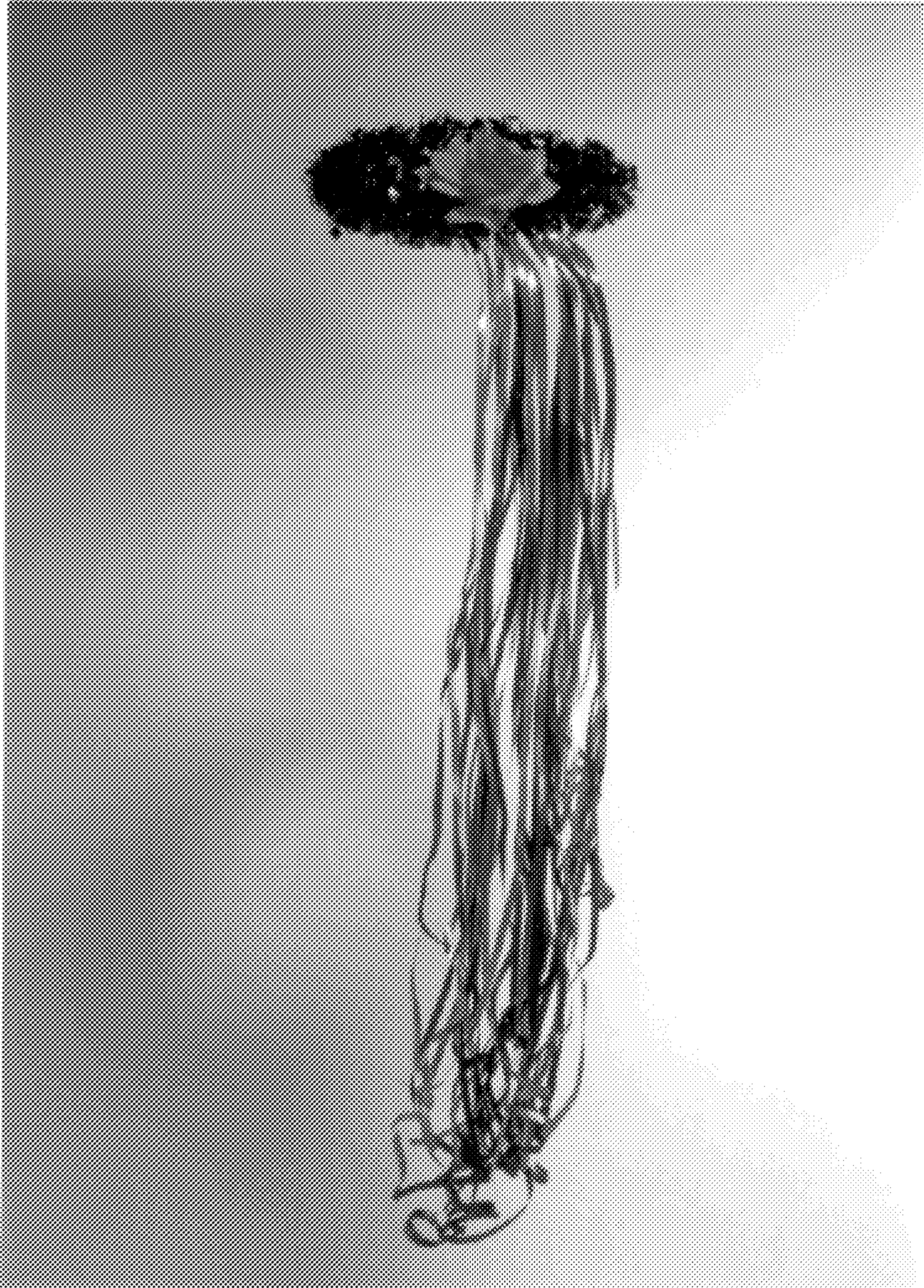

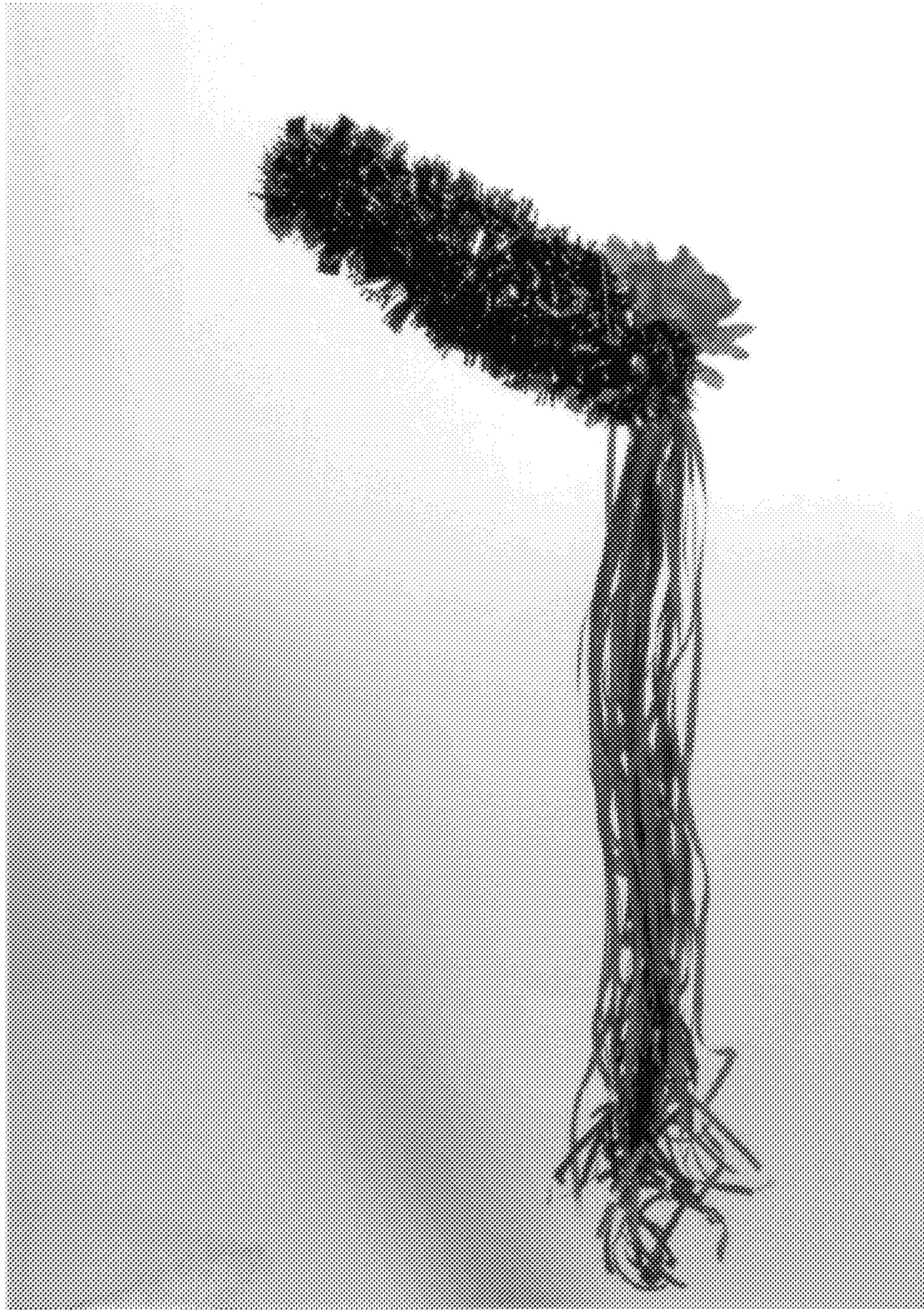
