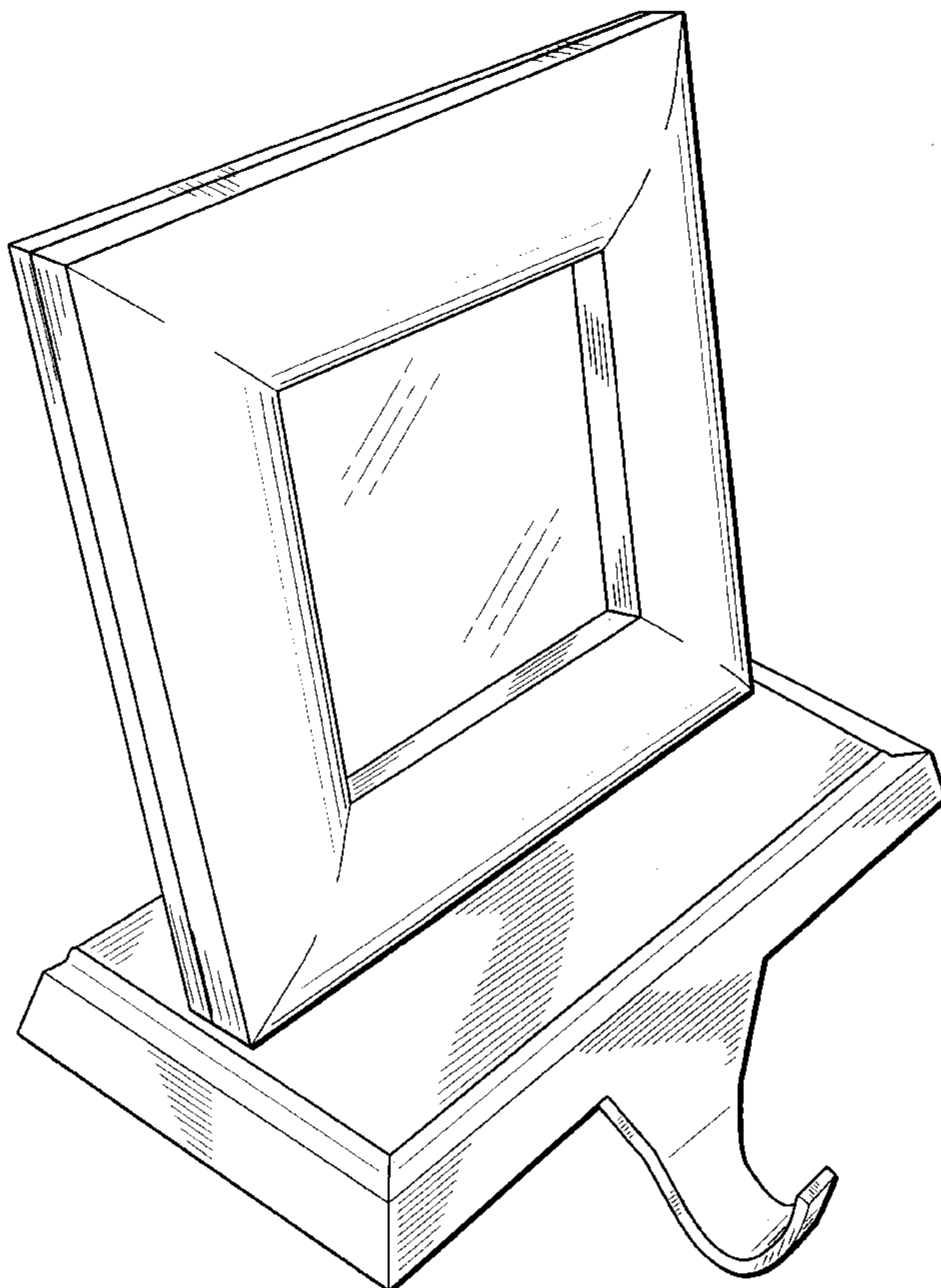
[57] **CLAIM**

DESCRIPTION

FIG. 1 a perspective view of the design according to the invention;
FIG. 2 is a front view of the design of FIG. 1;
FIG. 3 is a right side view of the design of FIG. 1, the left side being a mirror image thereof;
FIG. 4 is a back view of the design of FIG. 1;
FIG. 5 is a top view of the design of FIG. 1; and,

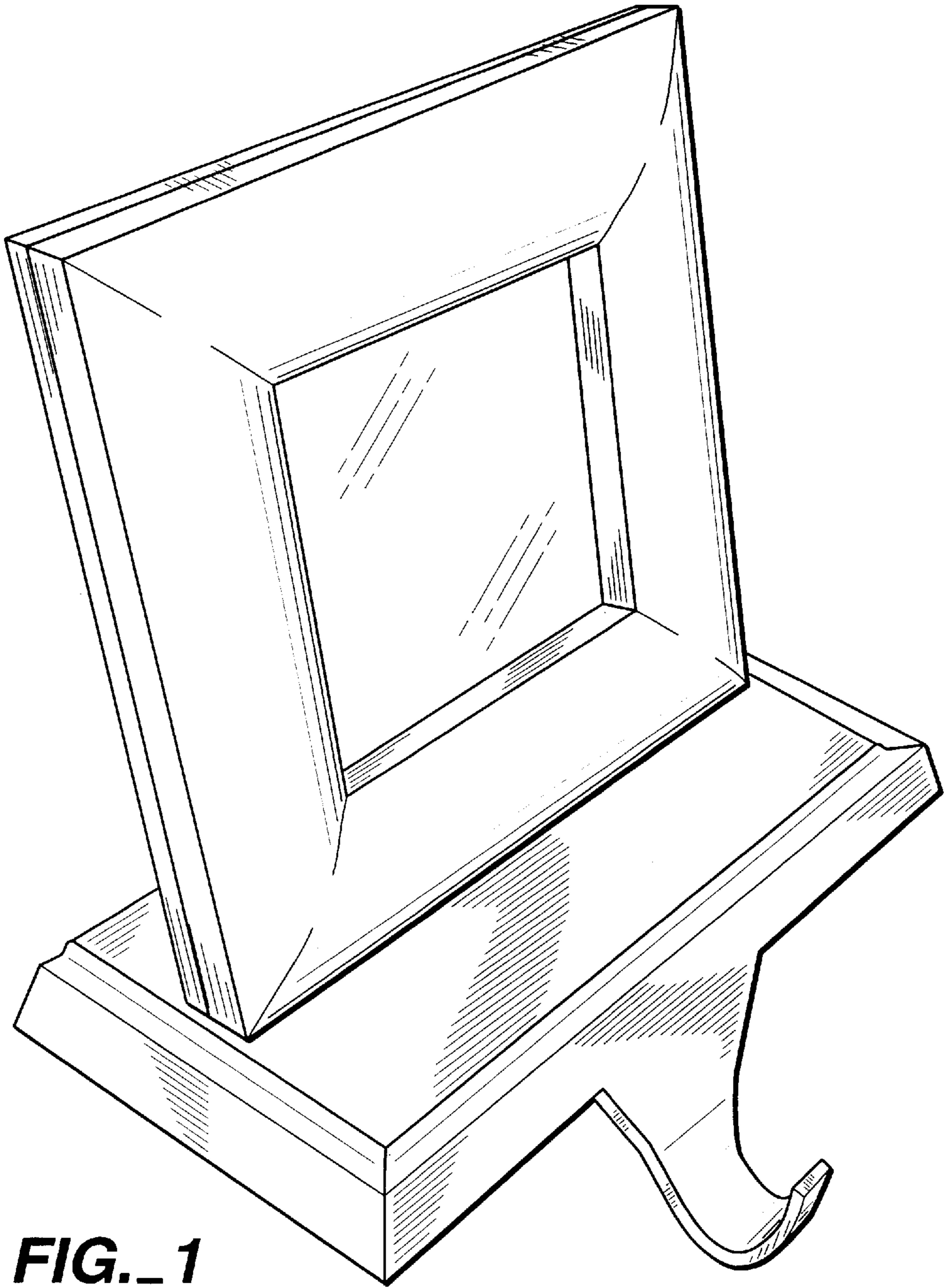

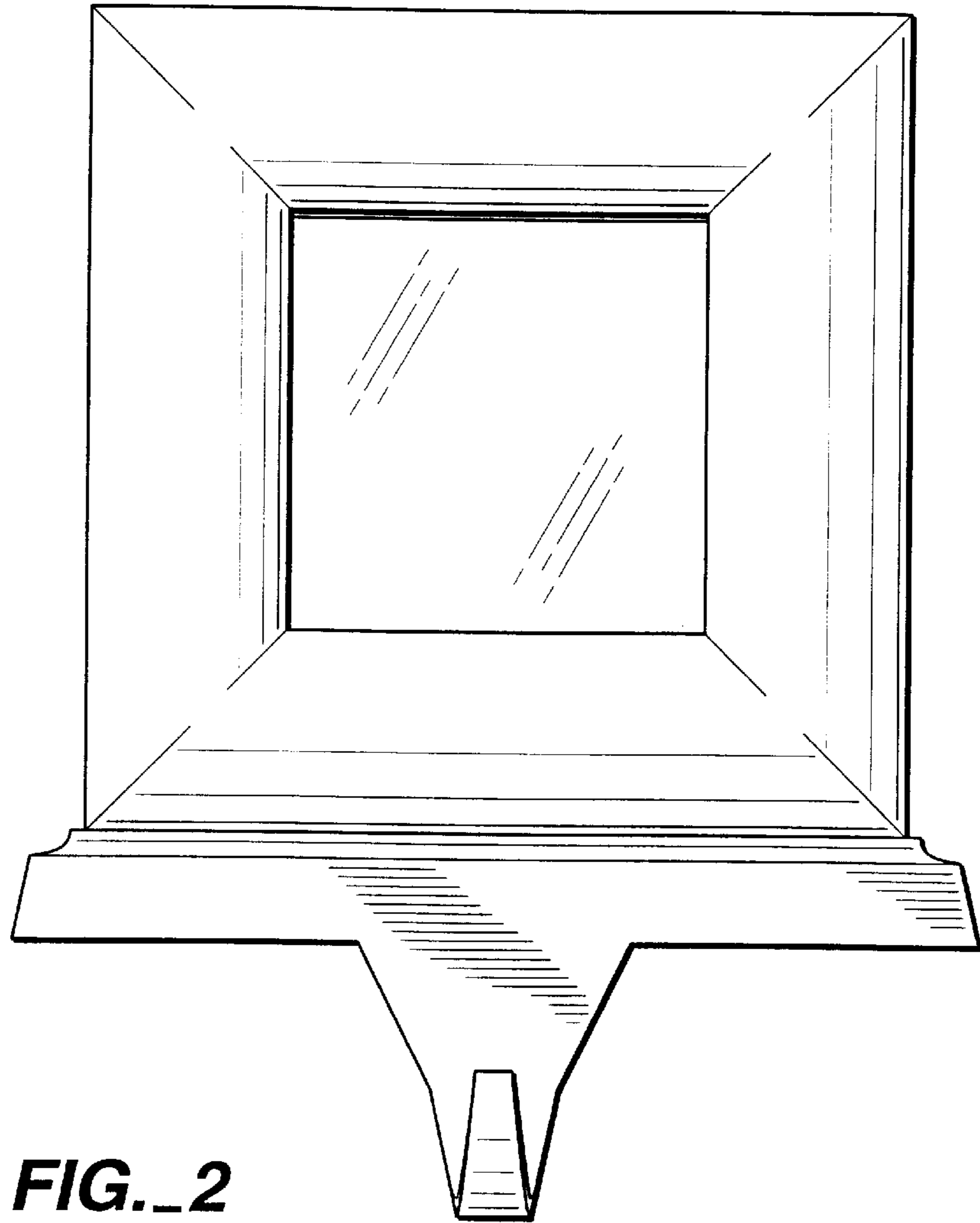

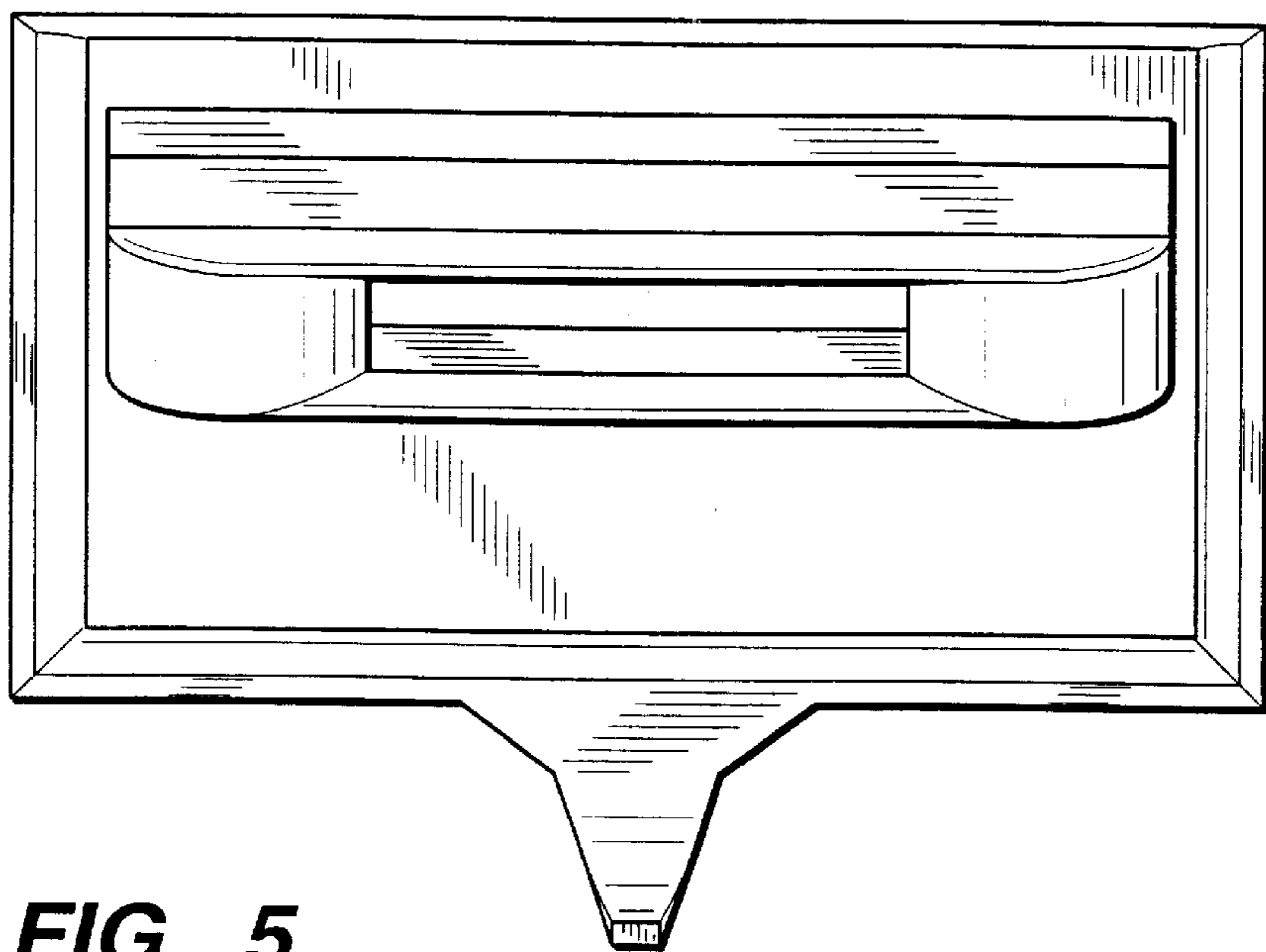
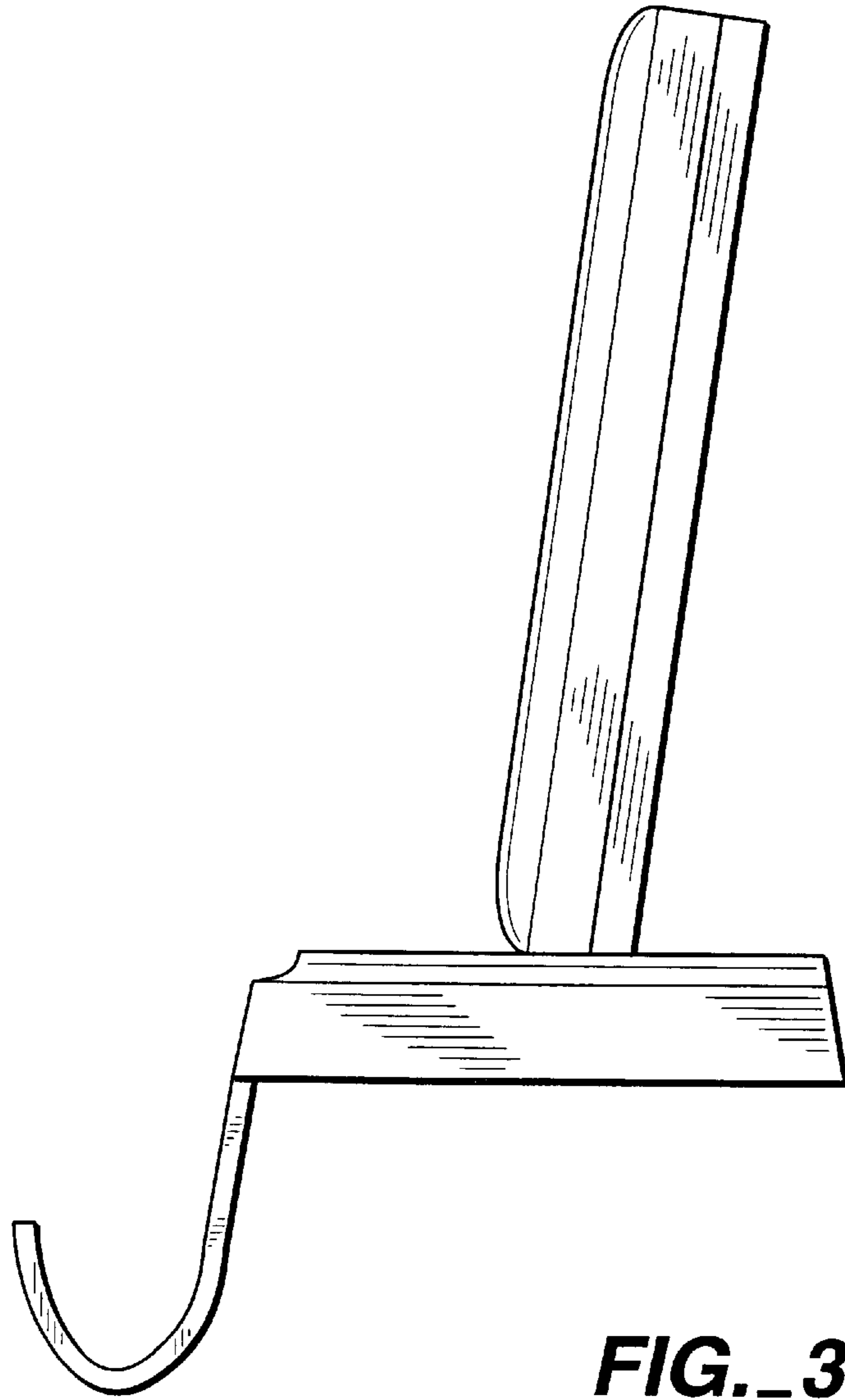

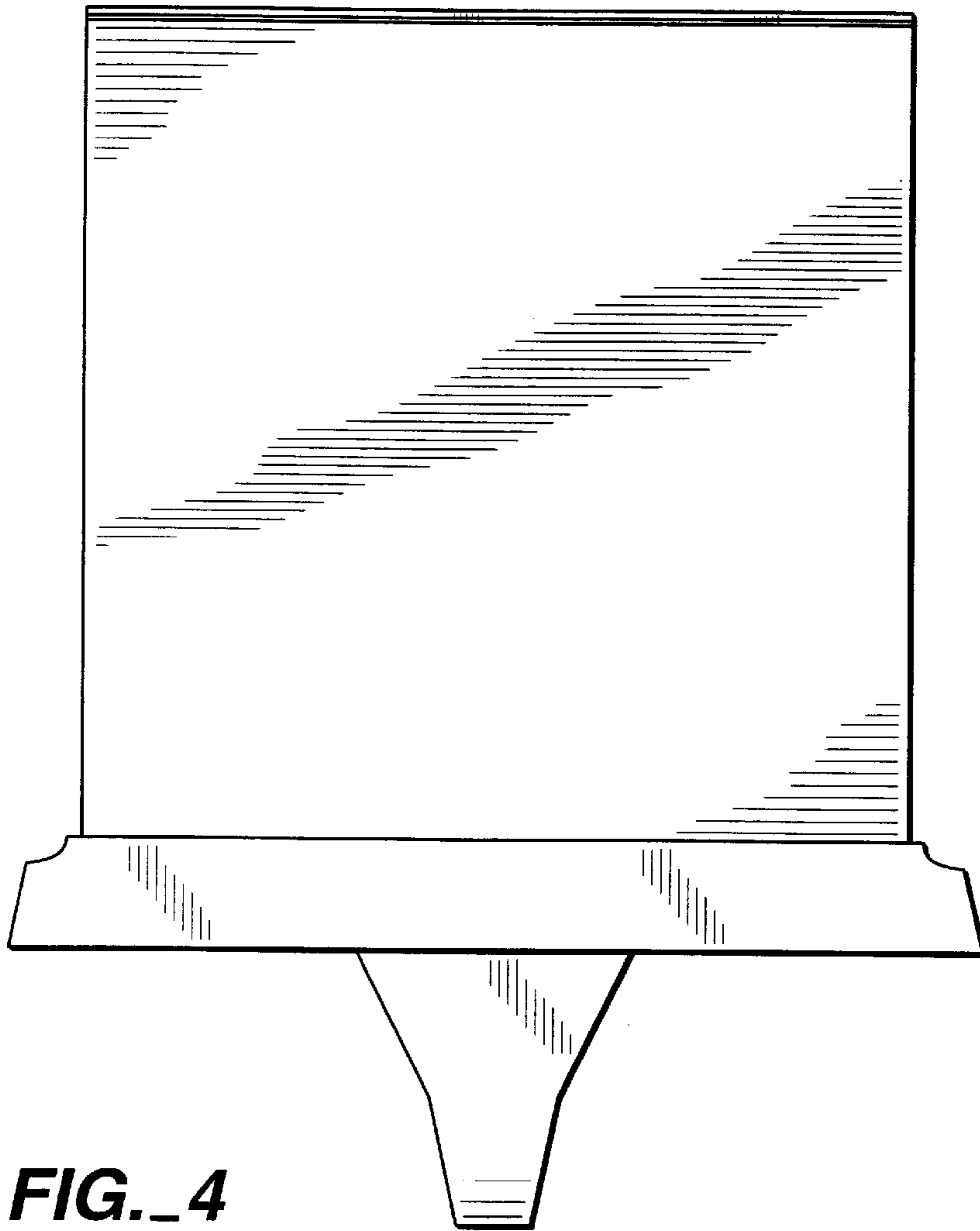

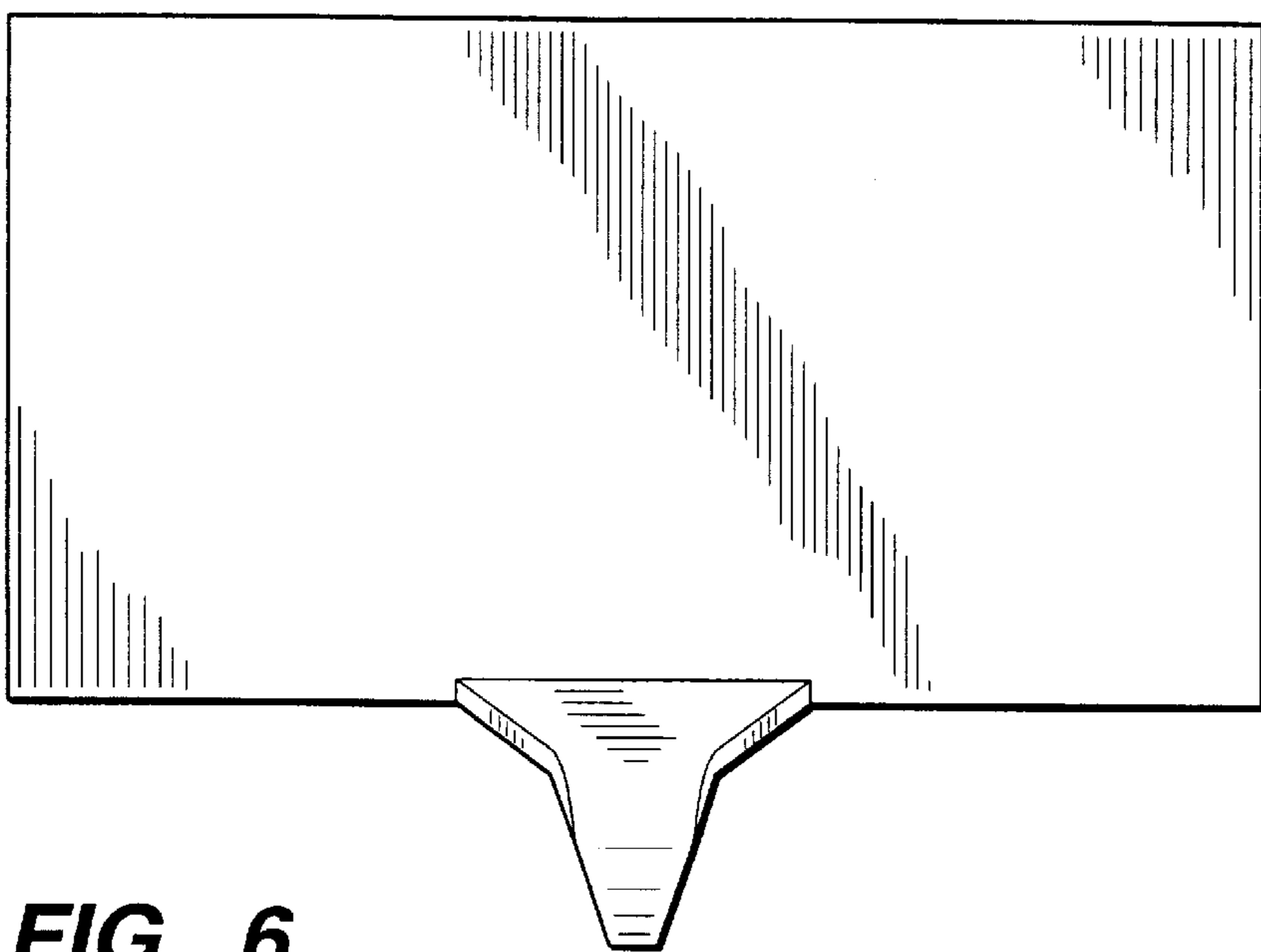
