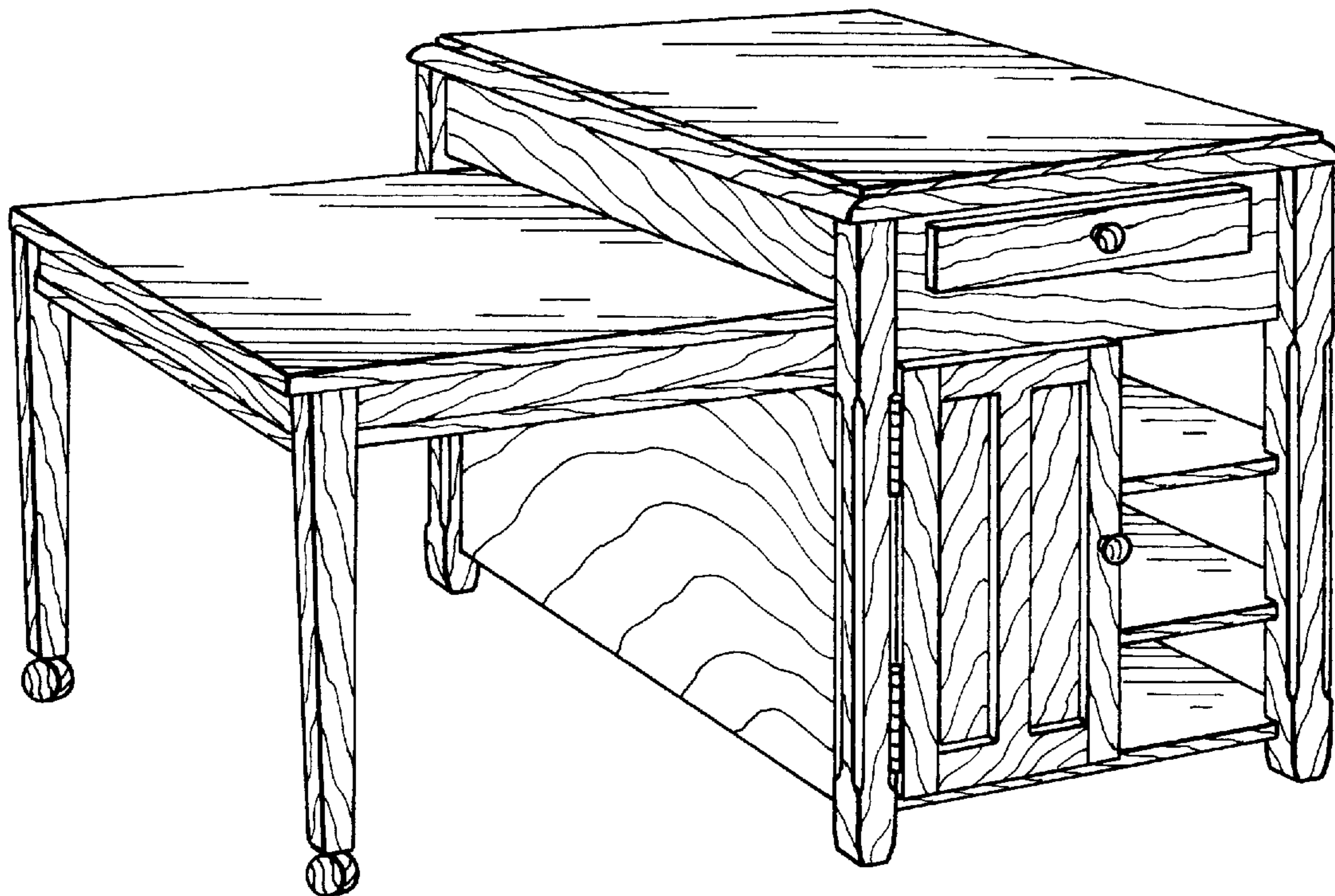
[57] **CLAIM**

The ornamental design for a combined extendible table and kitchen island, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a combined extendible table and kitchen island showing my new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a left end elevational view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a right end elevational view thereof; and, FIG. 6 is a top plan view thereof.

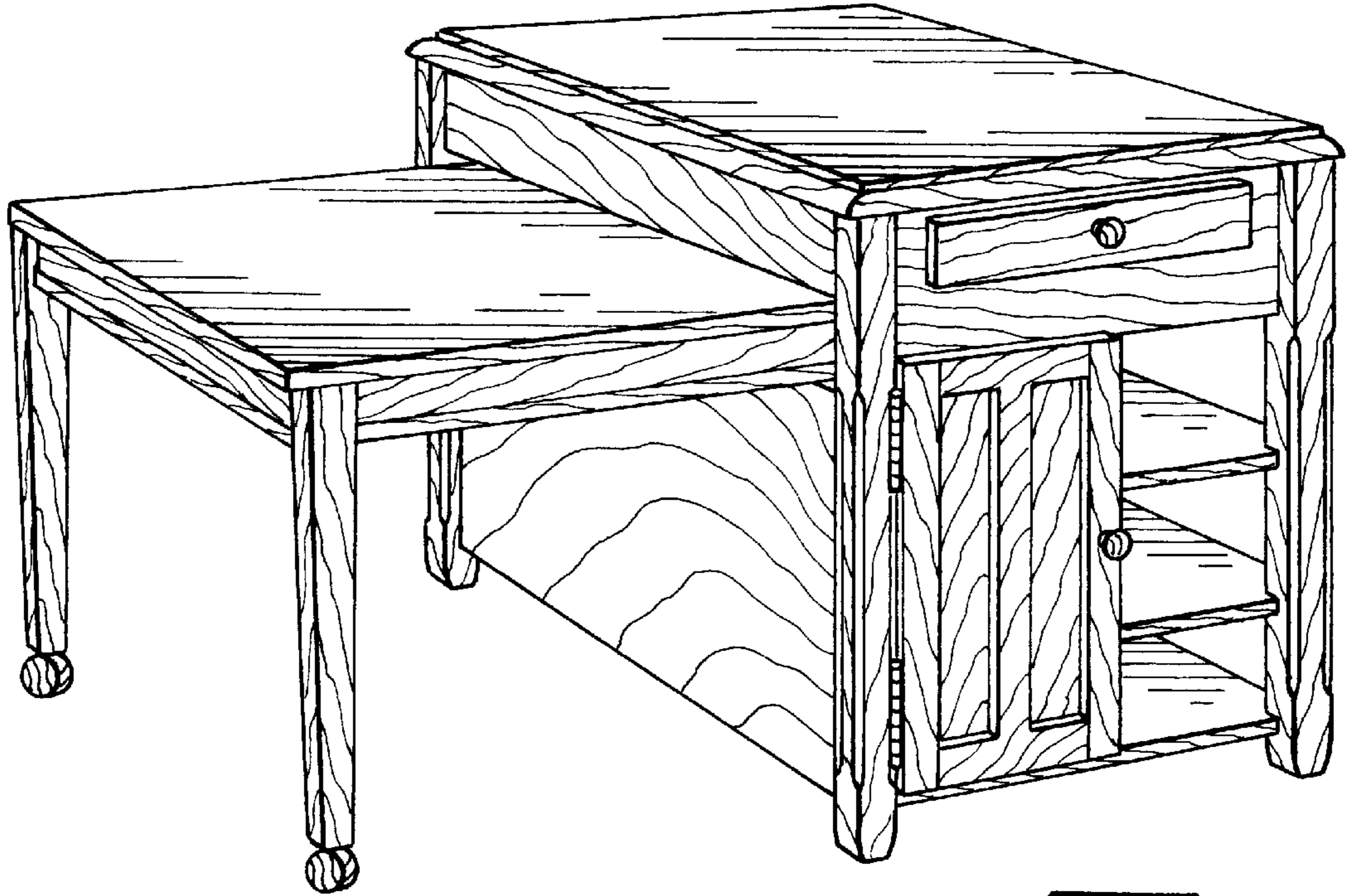

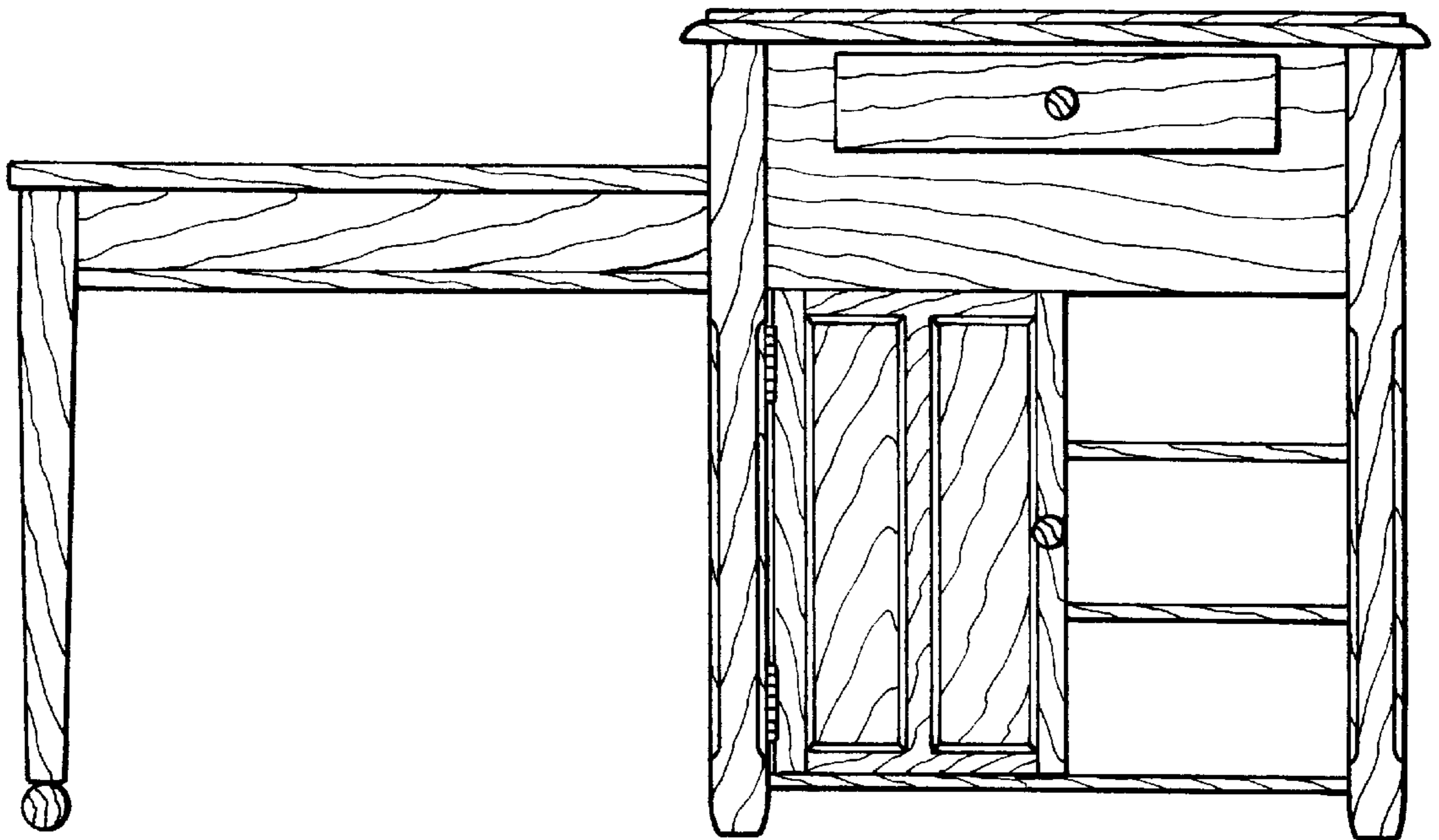

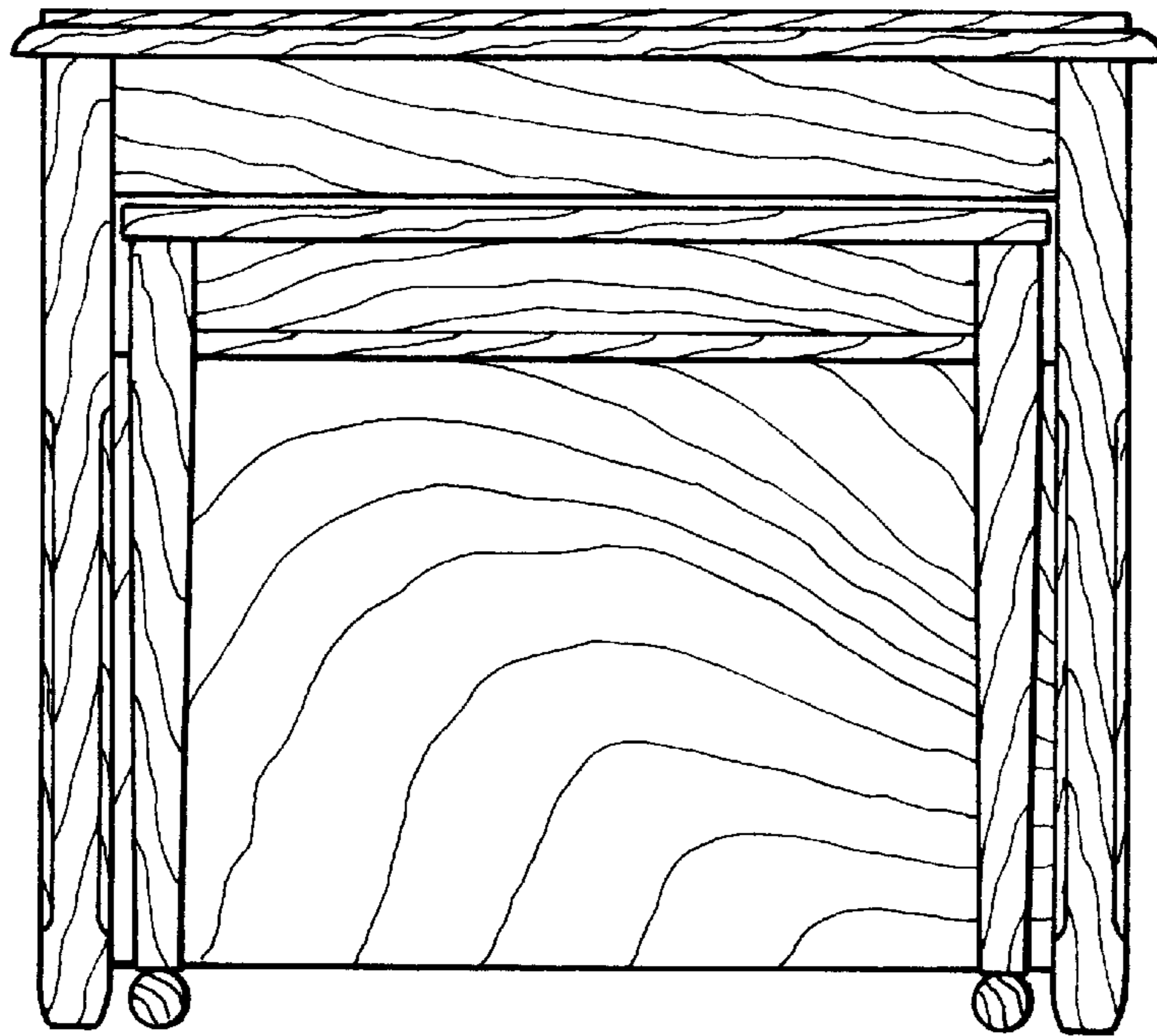

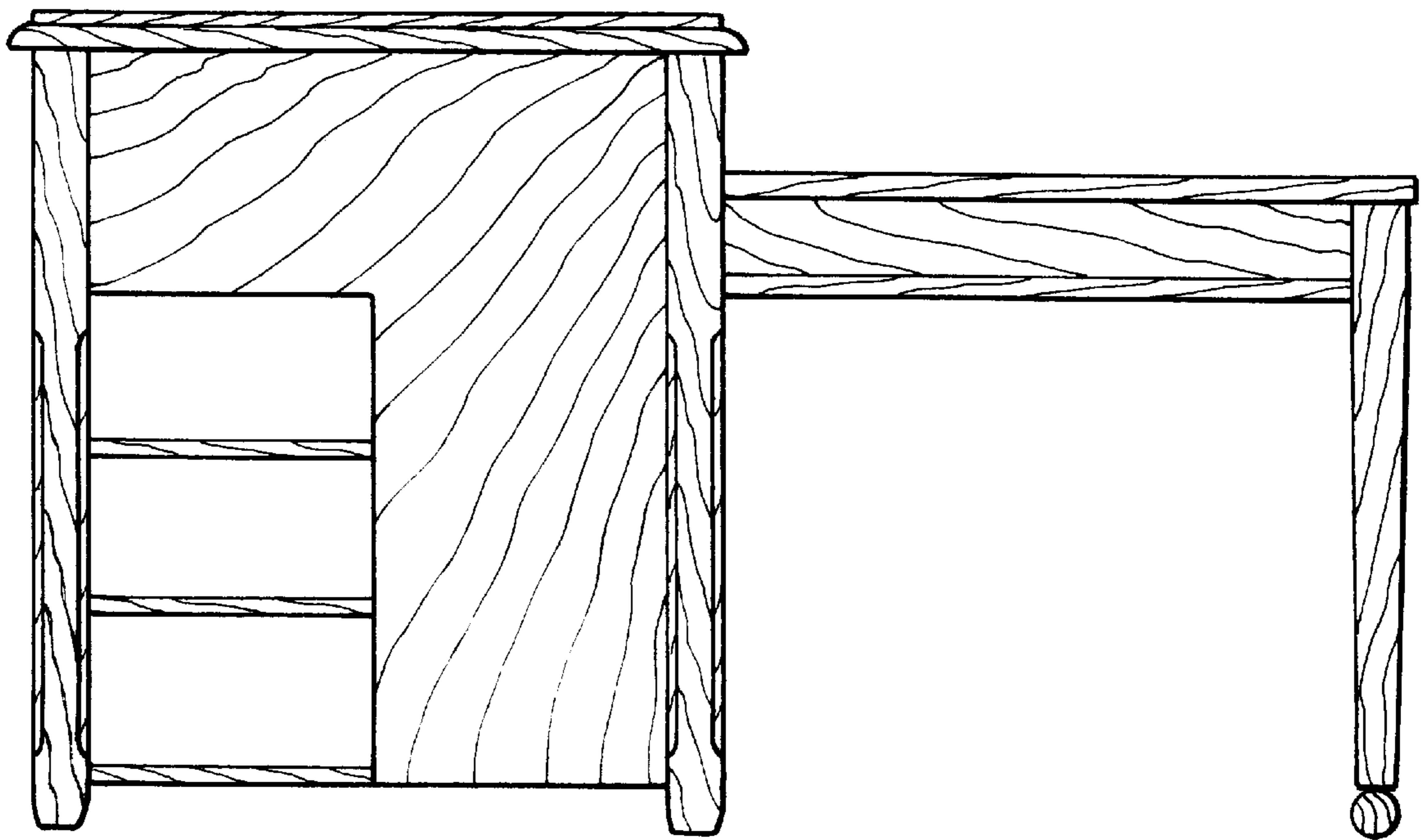
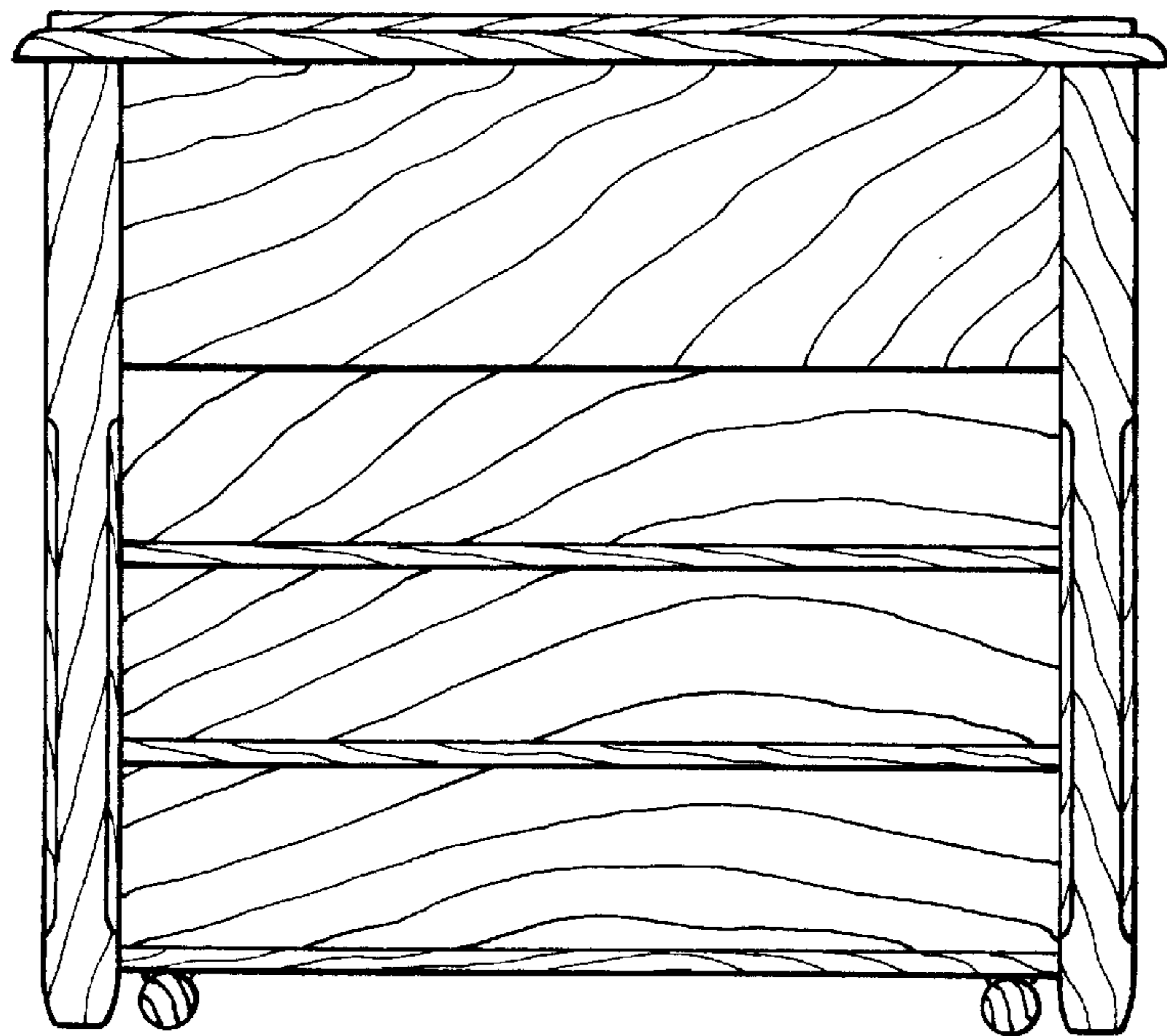
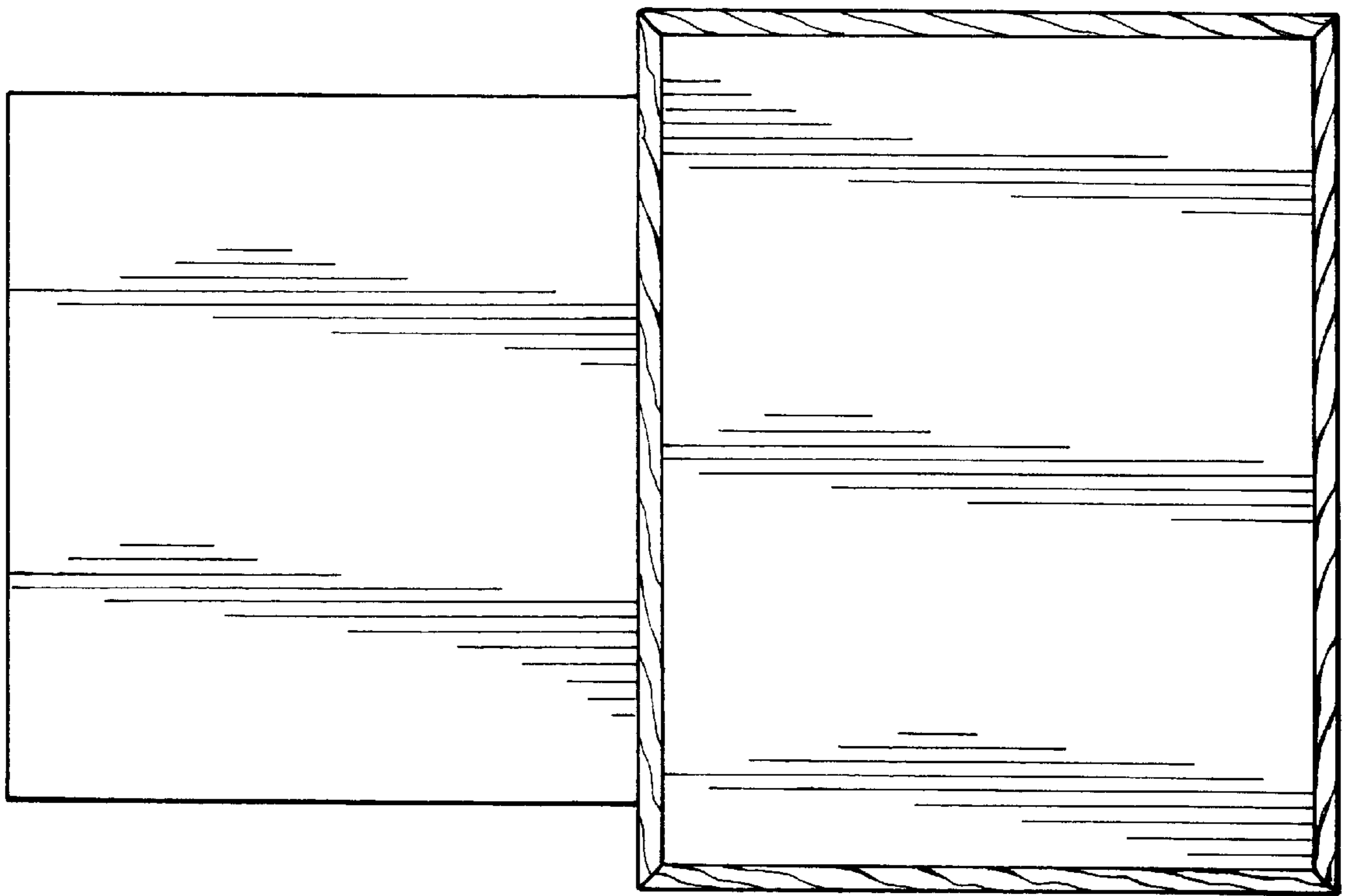
