[57] CLAIM

The ornamental design for a hand-held telephone, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a hand-held telephone with the cover on showing my new design; FIG. 2 is a front elevational view thereof with the cover off; FIG. 3 is a left-side view thereof with the cover on; FIG. 4 is a left-side view thereof with the cover off; FIG. 5 is a right-side view thereof with the cover on; FIG. 6 is a right-side view thereof with the cover off; FIG. 7 is a rear elevational view thereof with the cover on; FIG. 8 is a rear elevational view thereof with the cover off; FIG. 9 is a top plan view thereof with the cover on; FIG. 10 is a top plan view thereof with the cover off; FIG. 11 is a bottom plan view thereof with the cover on; and, FIG. 12 is a bottom plan view thereof with the cover off. The cover has been omitted from FIGS. 2, 4, 6, 8, 10, and 12 for convenience of illustration.

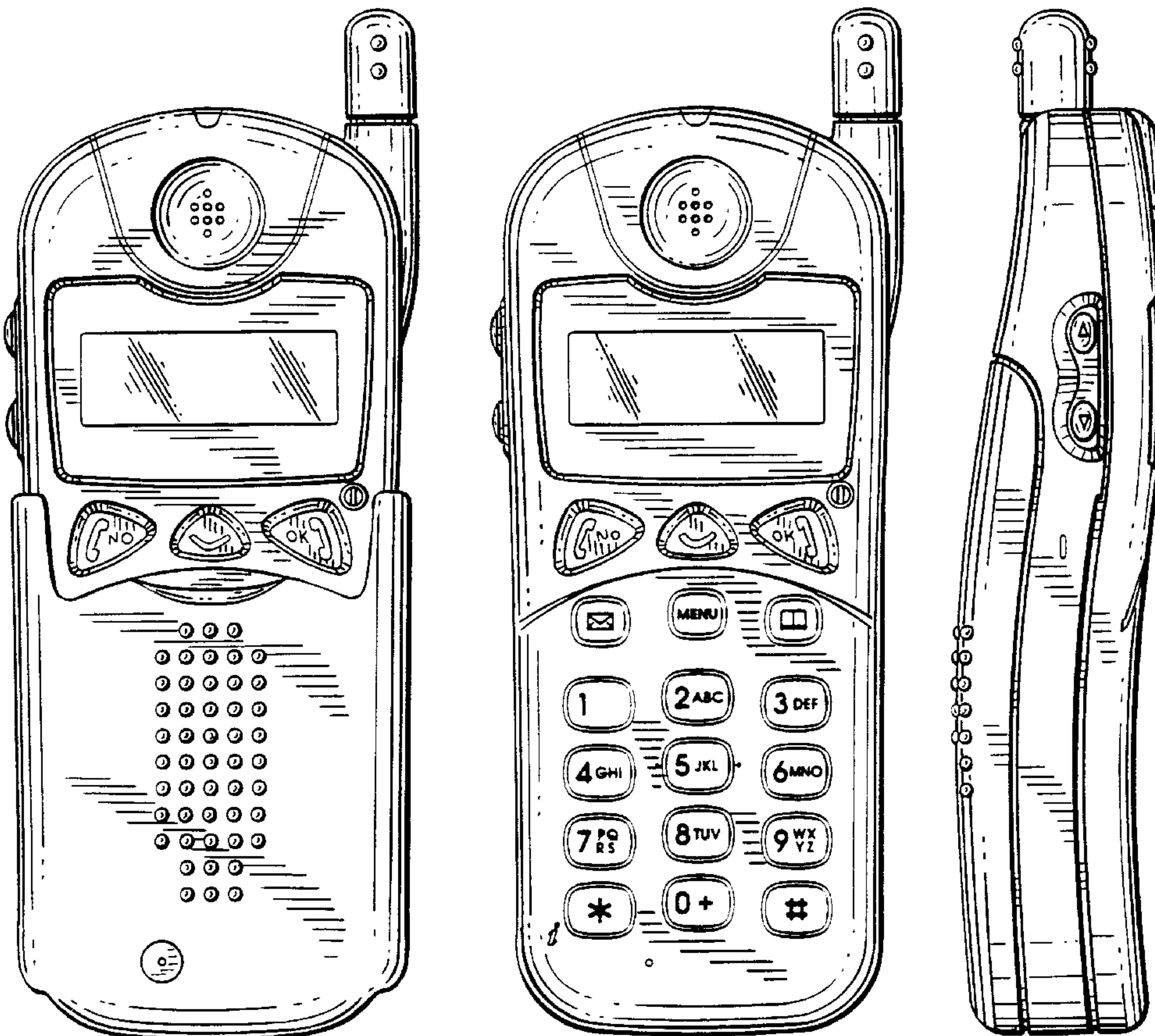

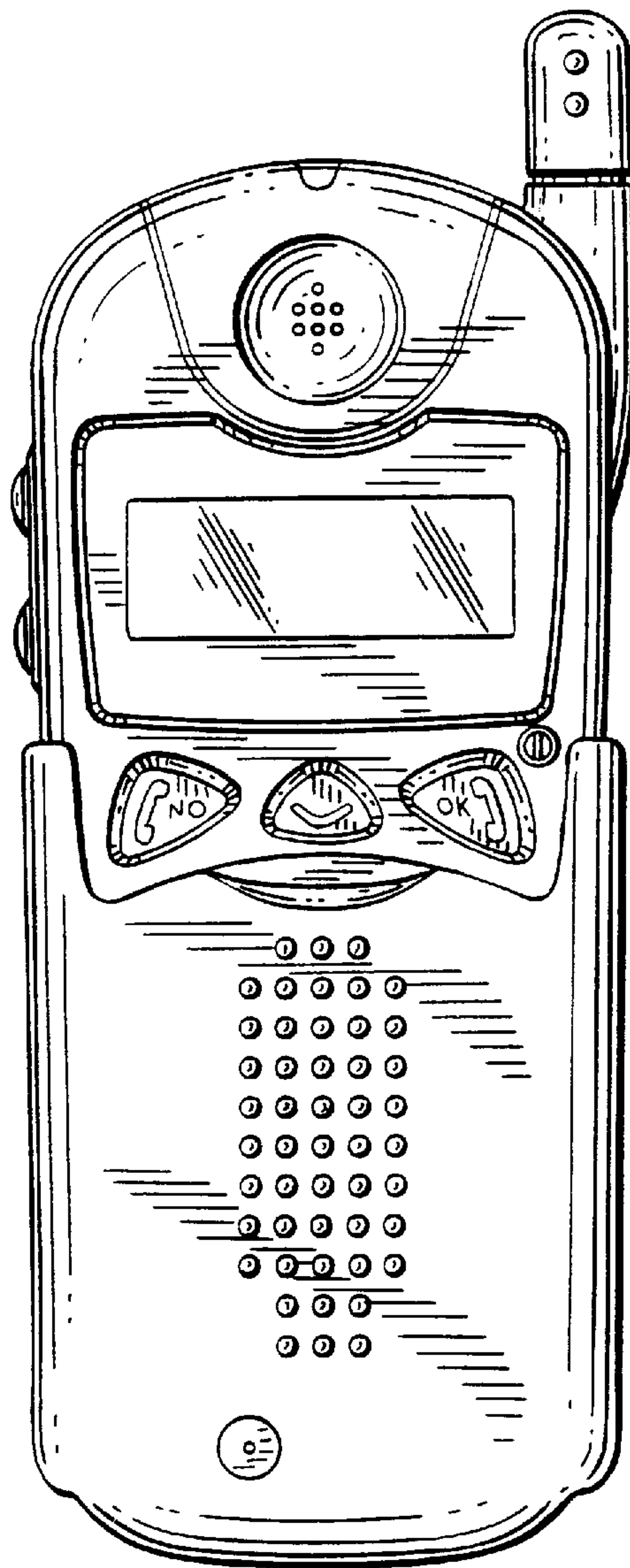

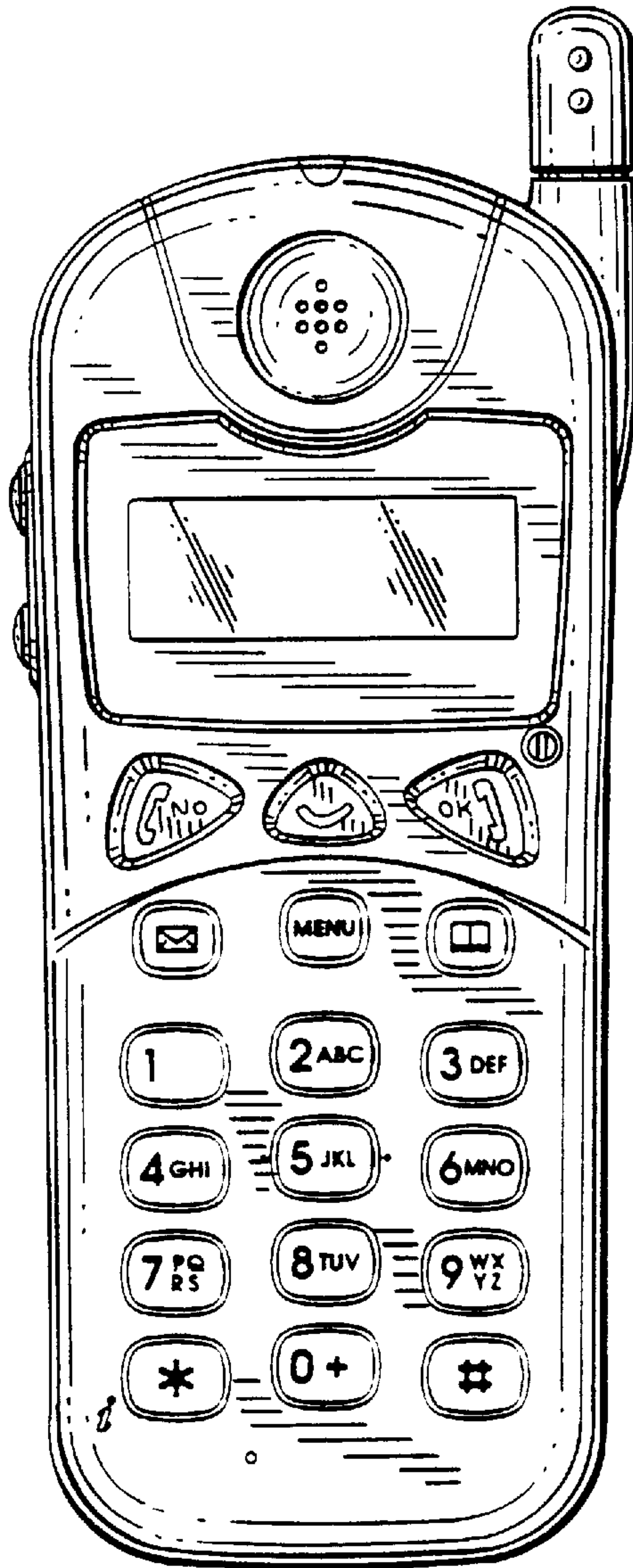

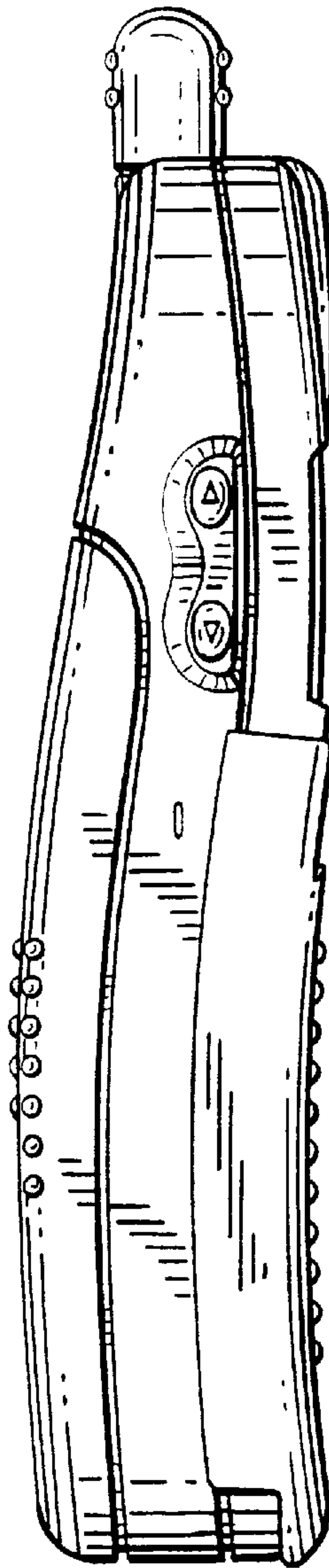

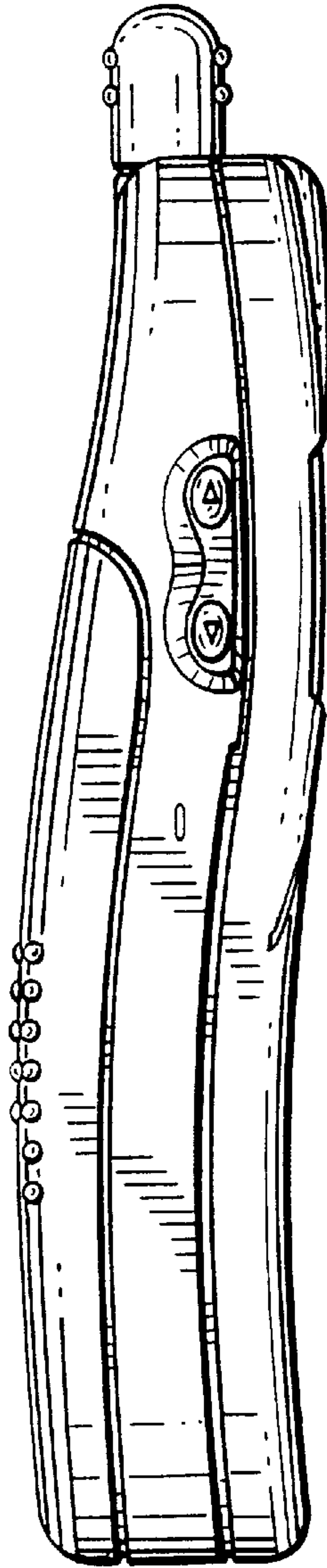

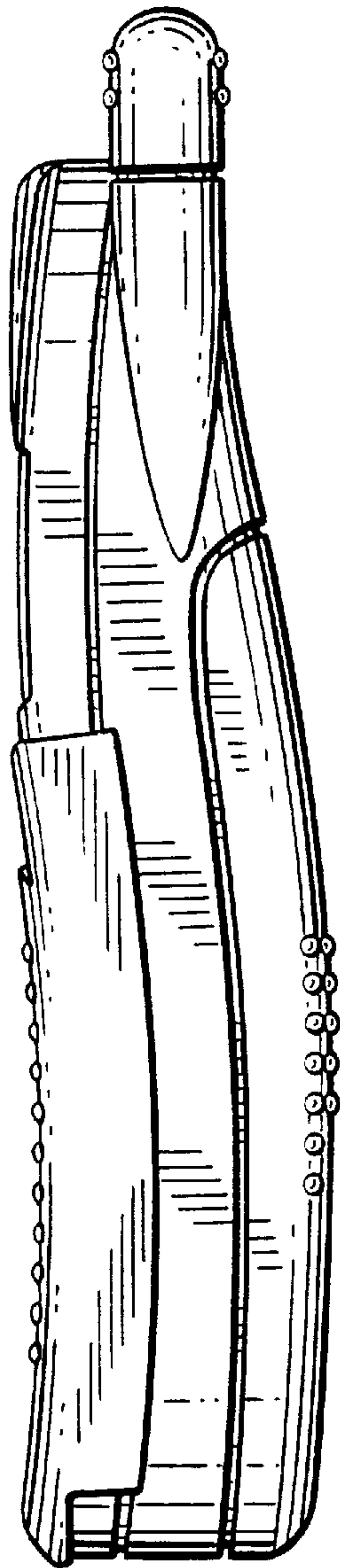

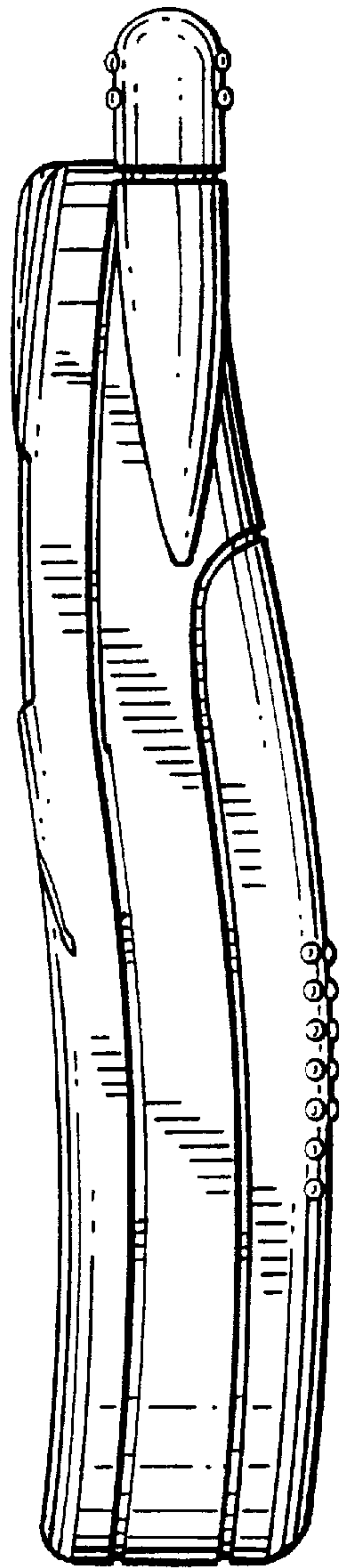

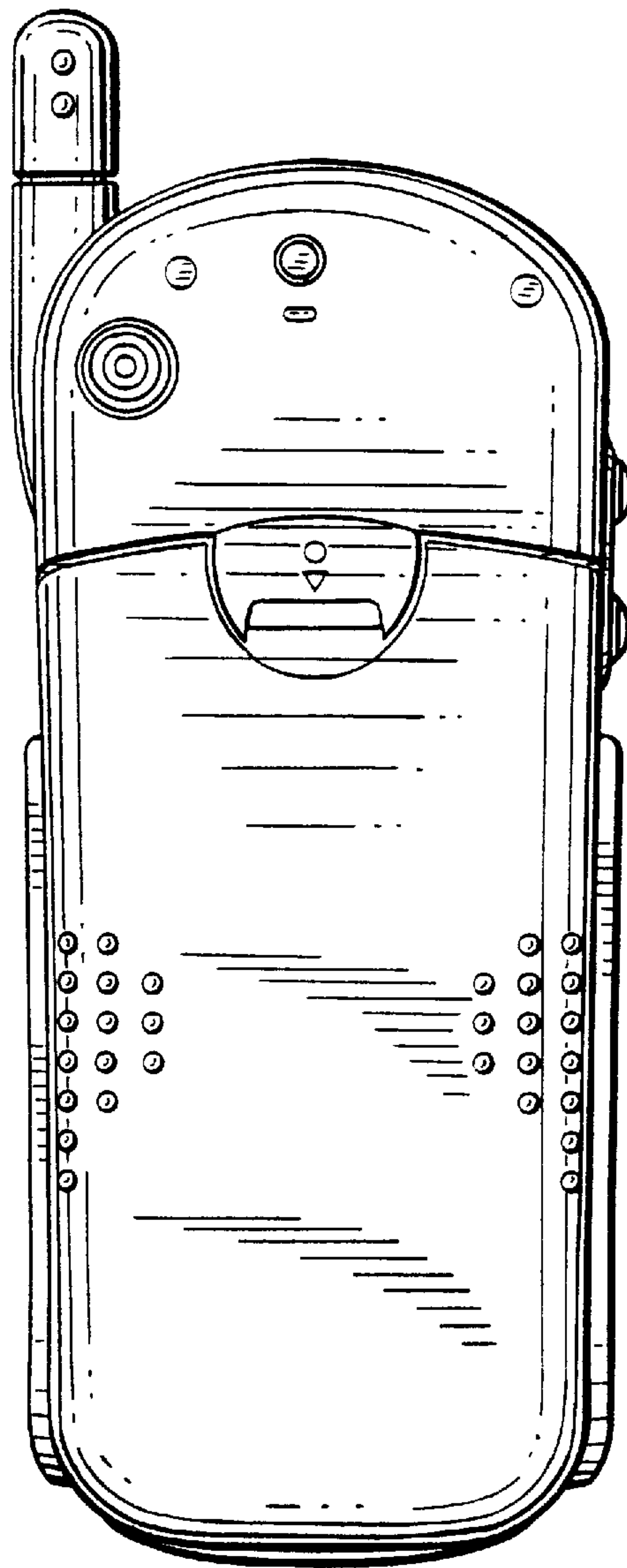

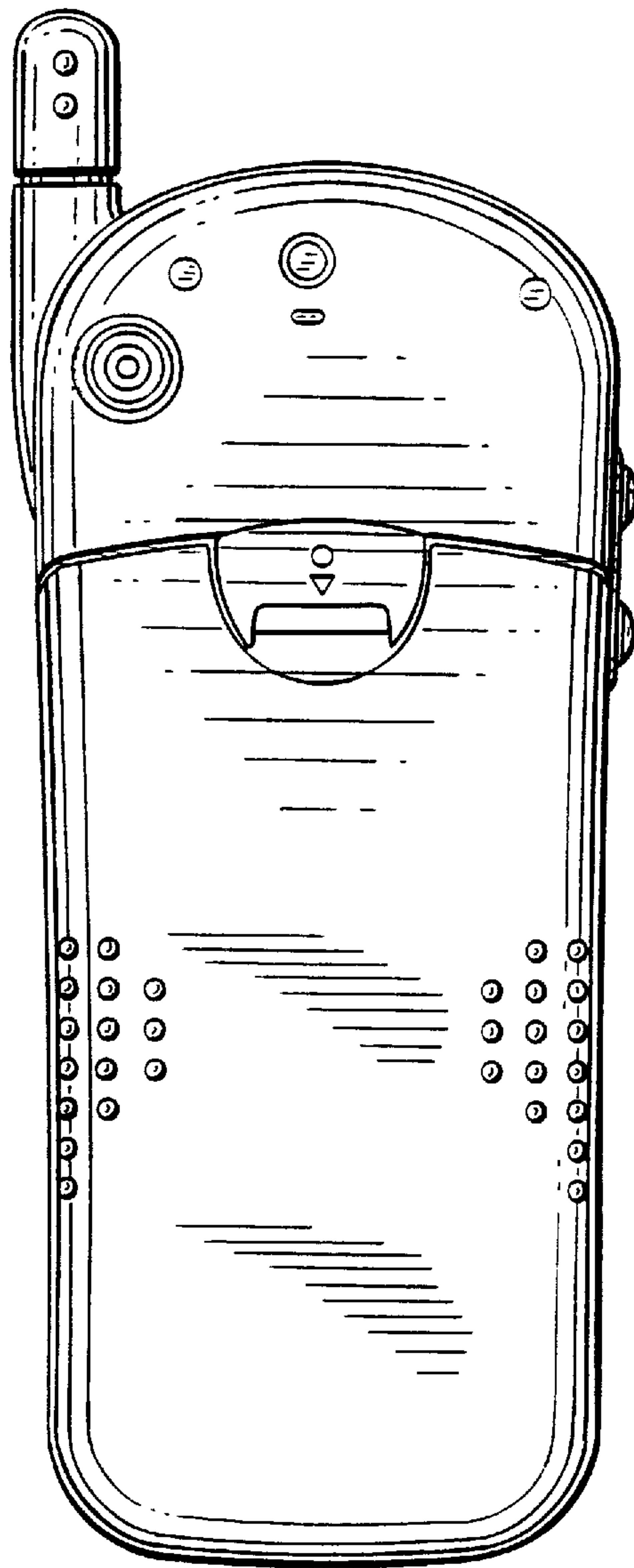

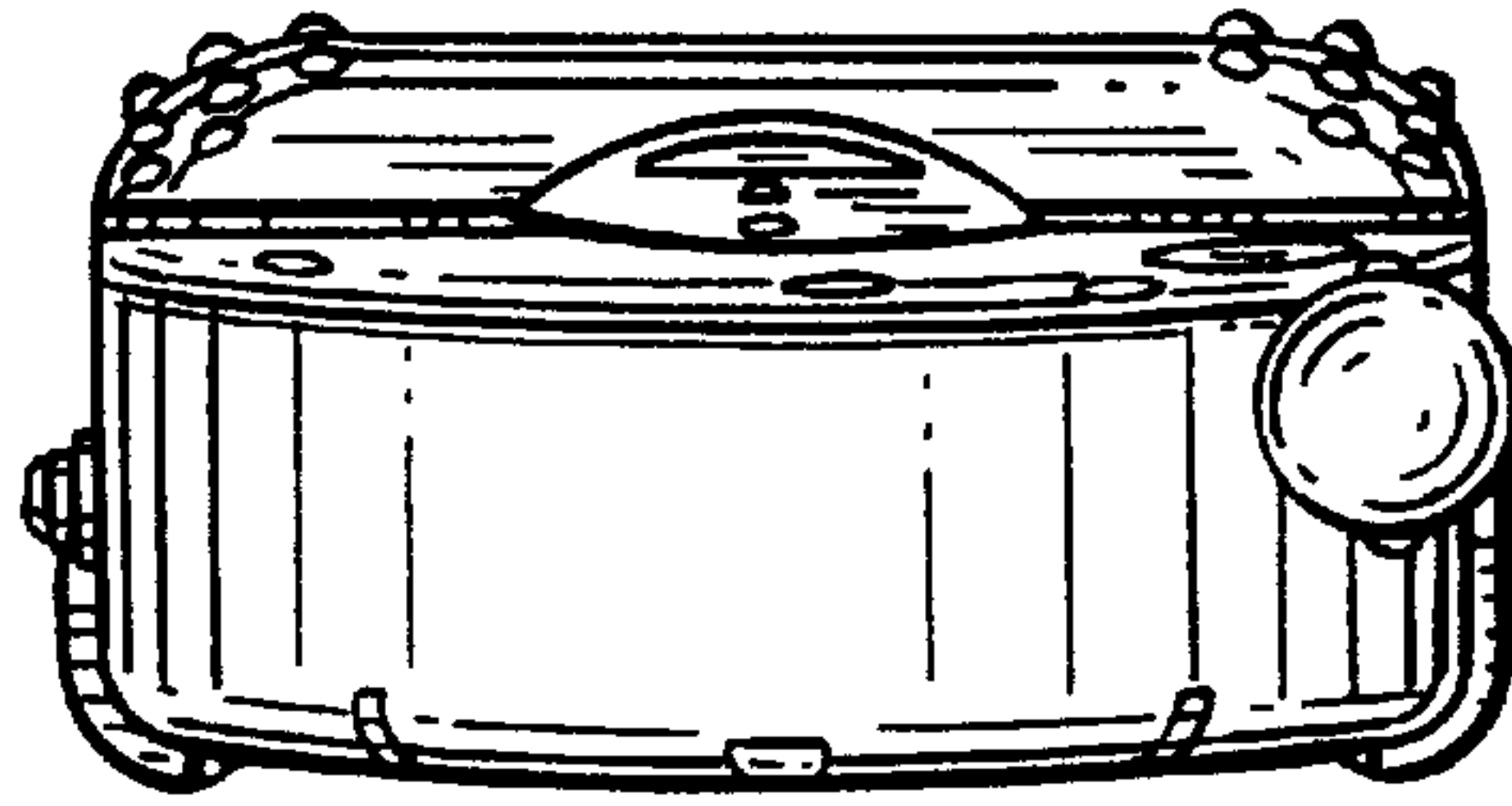

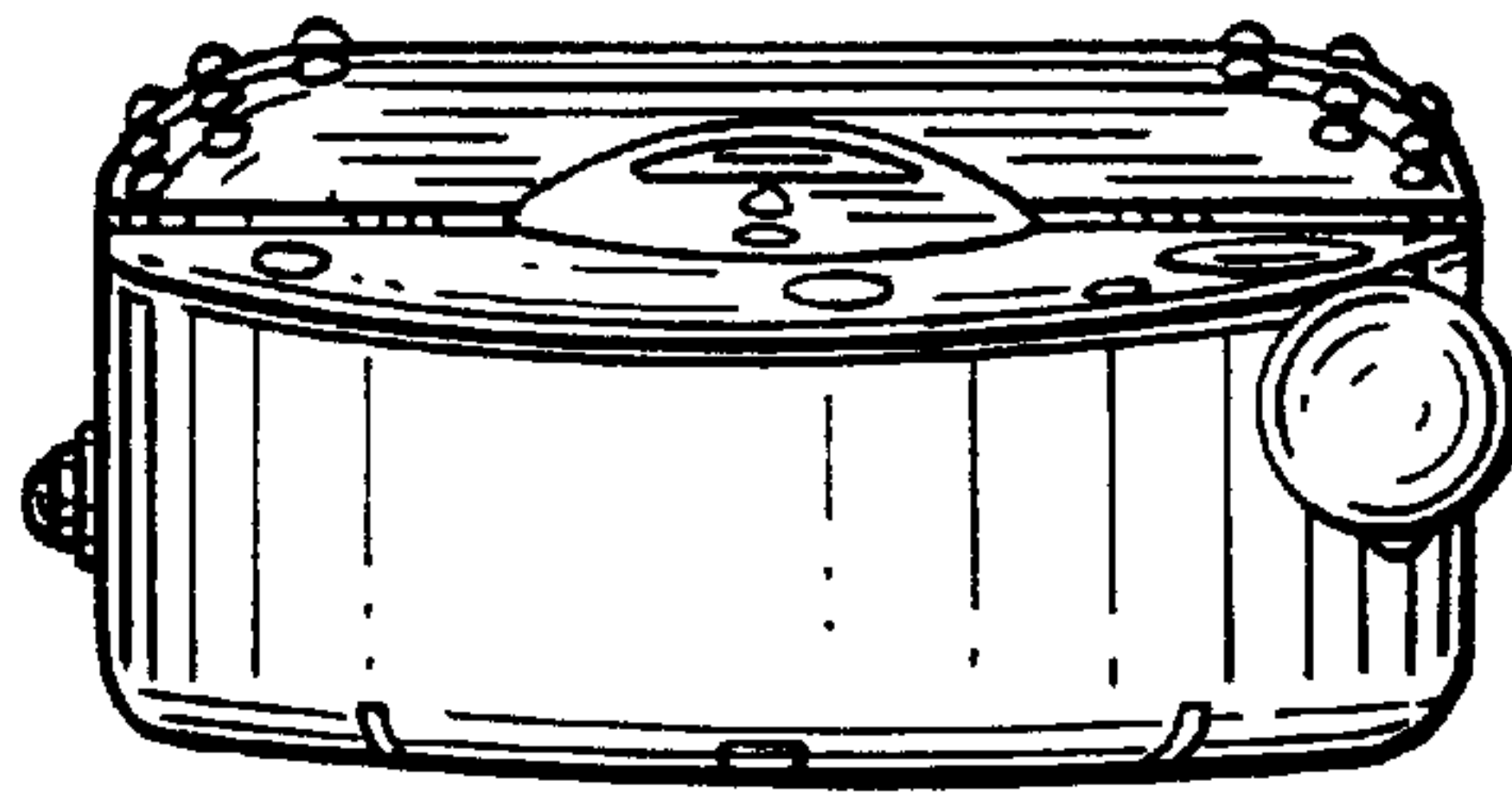

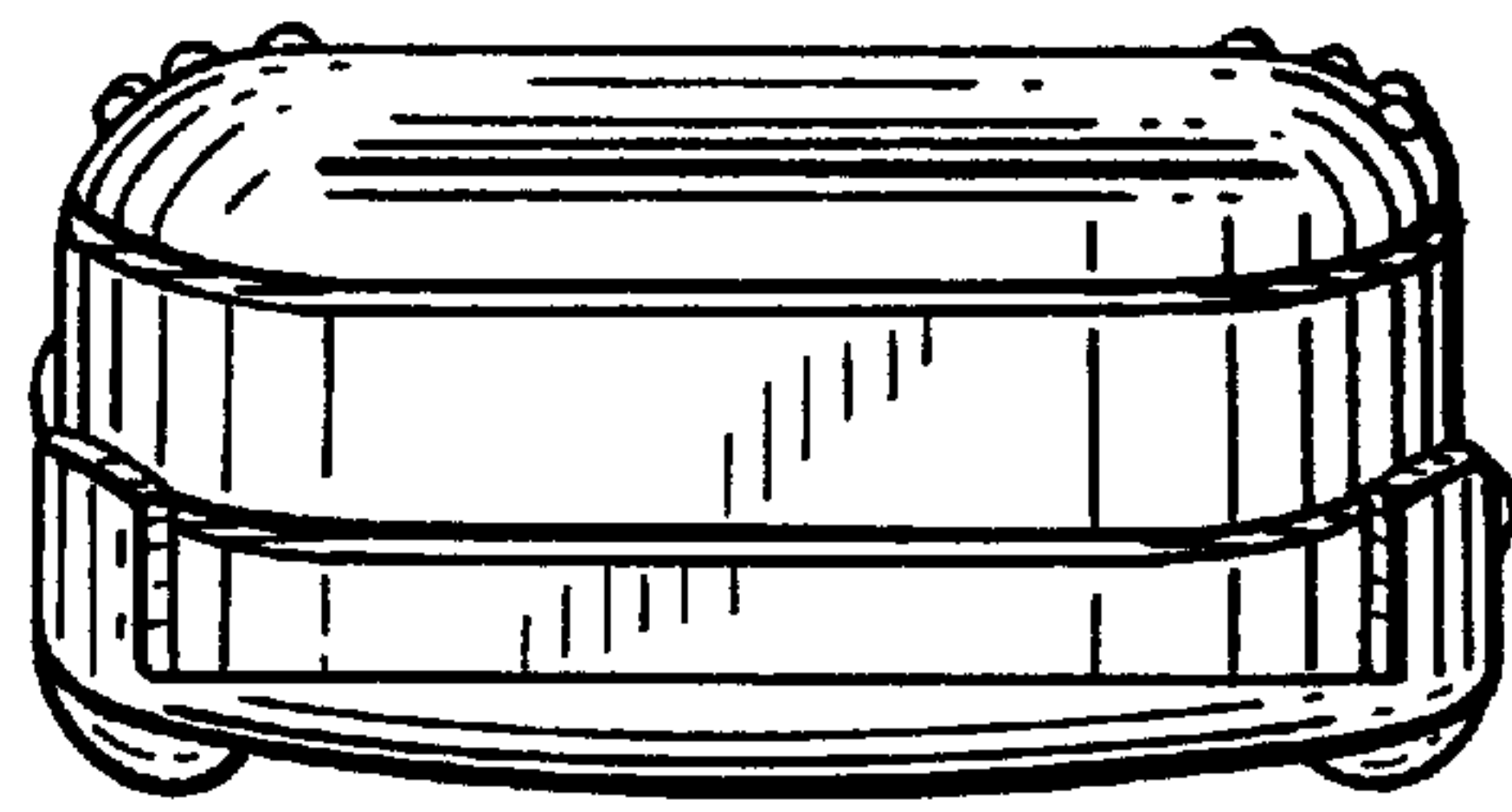
