FIG. 3 is rear view, taken from the right side, of the automobile according to my novel design;


FIG. 4 is a perspective left side view, taken from the side, of the automobile according to my novel design;













FIG. 3 is rear view, taken from the right side, of the automobile according to my novel design;


FIG. 4 is a perspective left side view, taken from the side, of the automobile according to my novel design;














